FIG. 7 is a bottom plan view of the kiosk illustrated in FIG. 1.

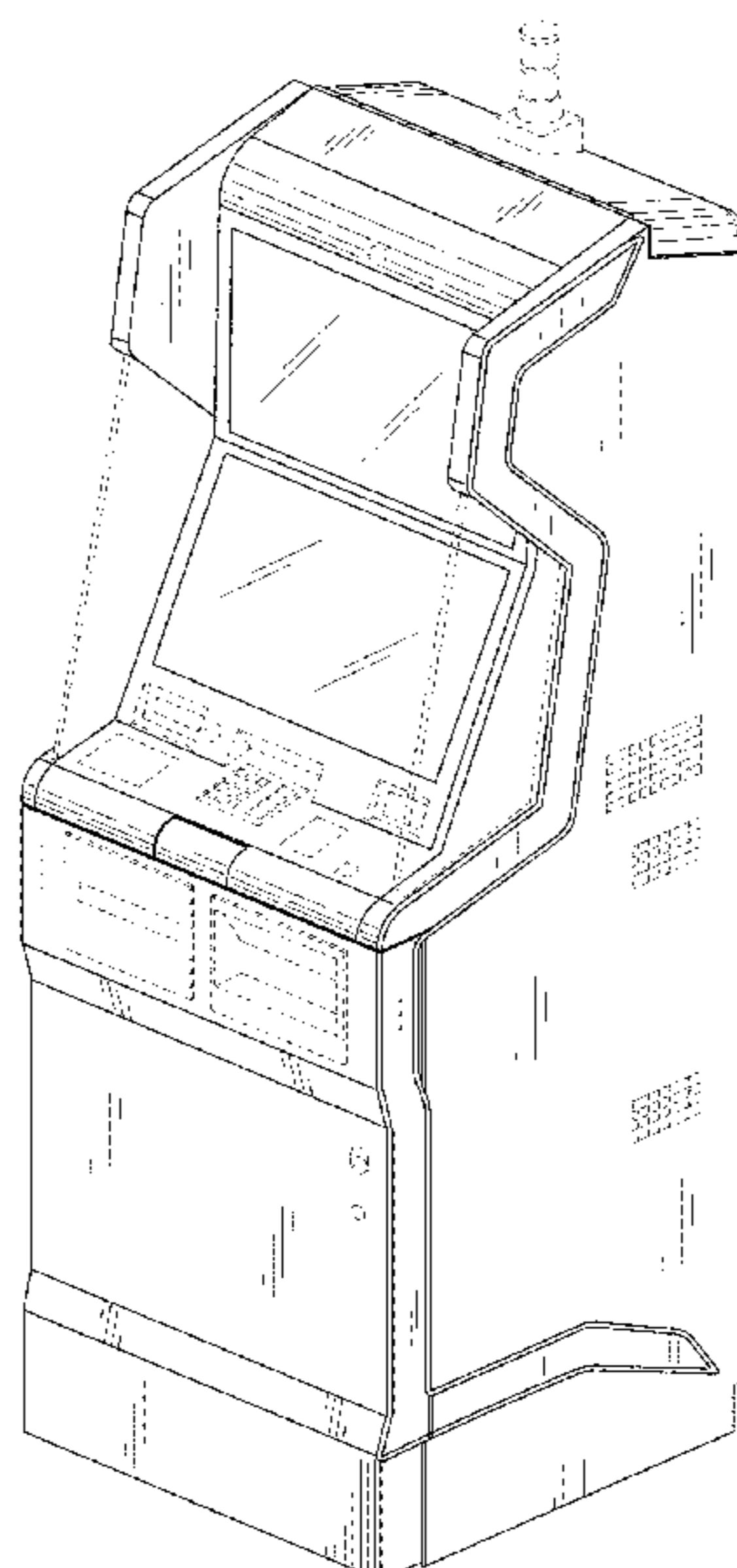

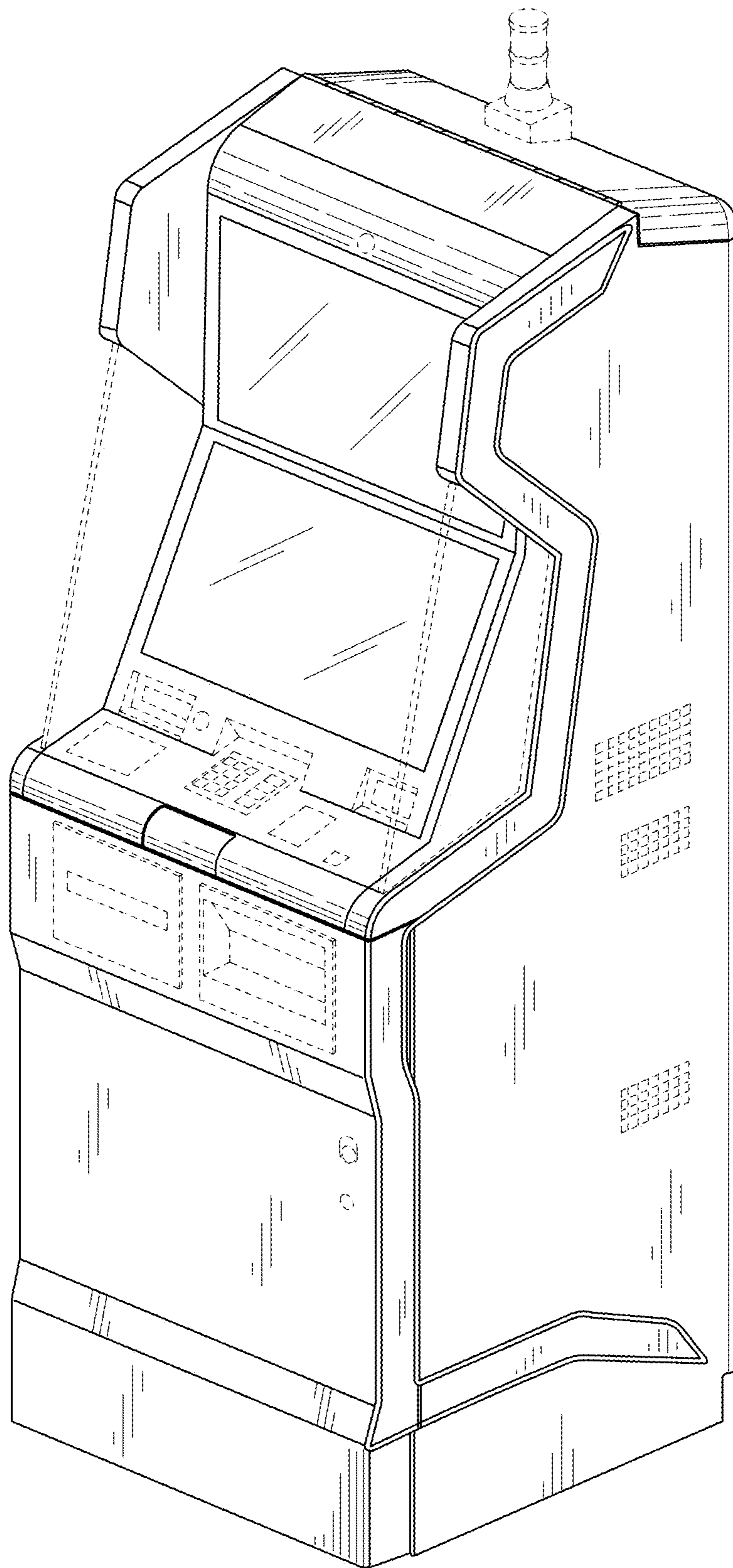

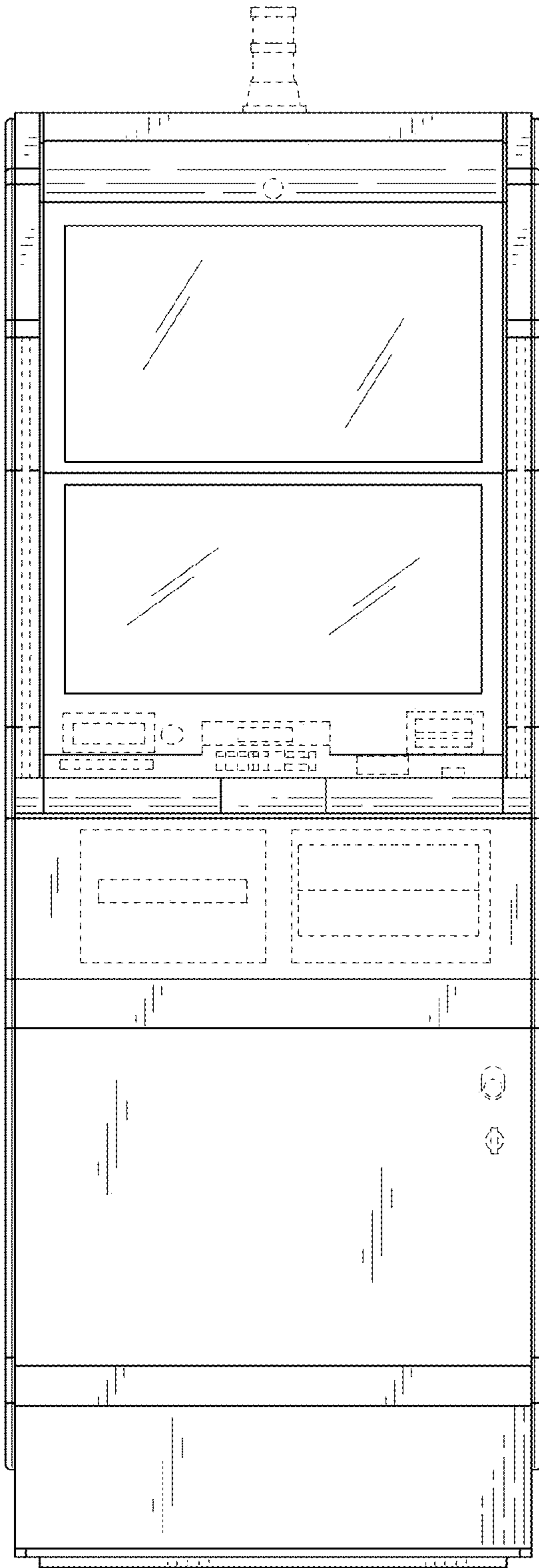

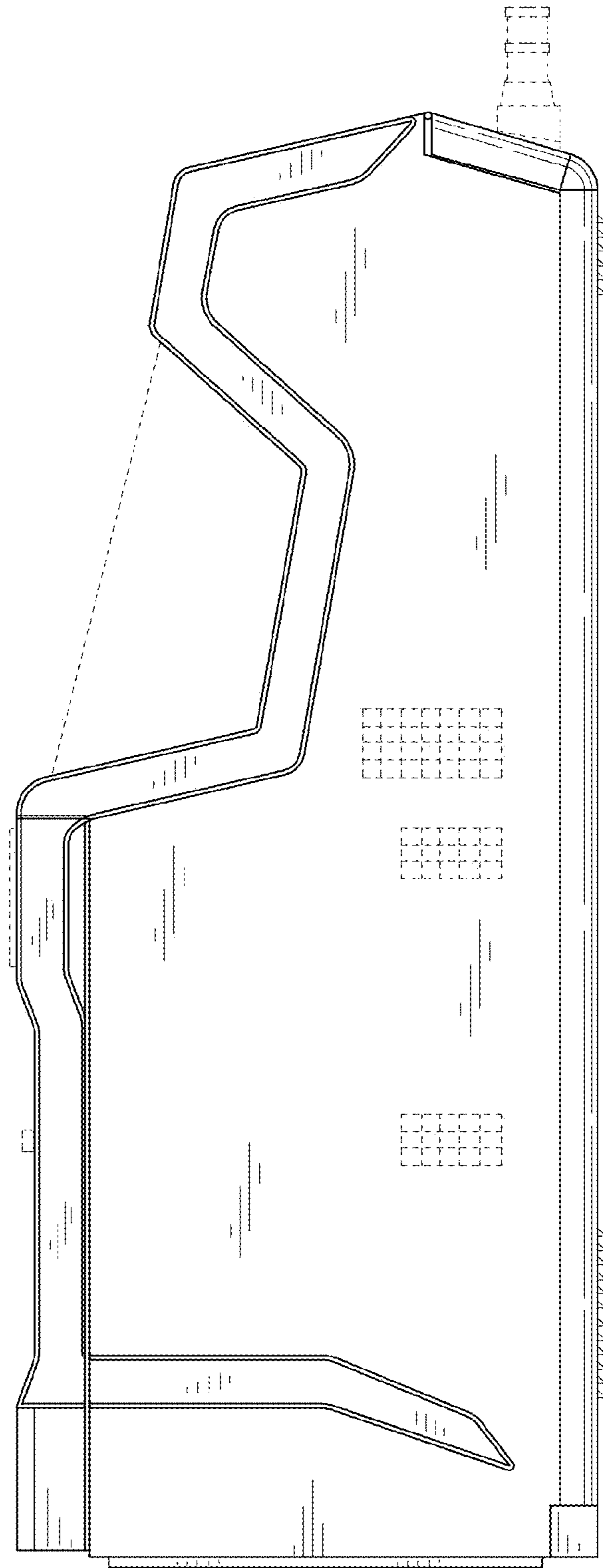

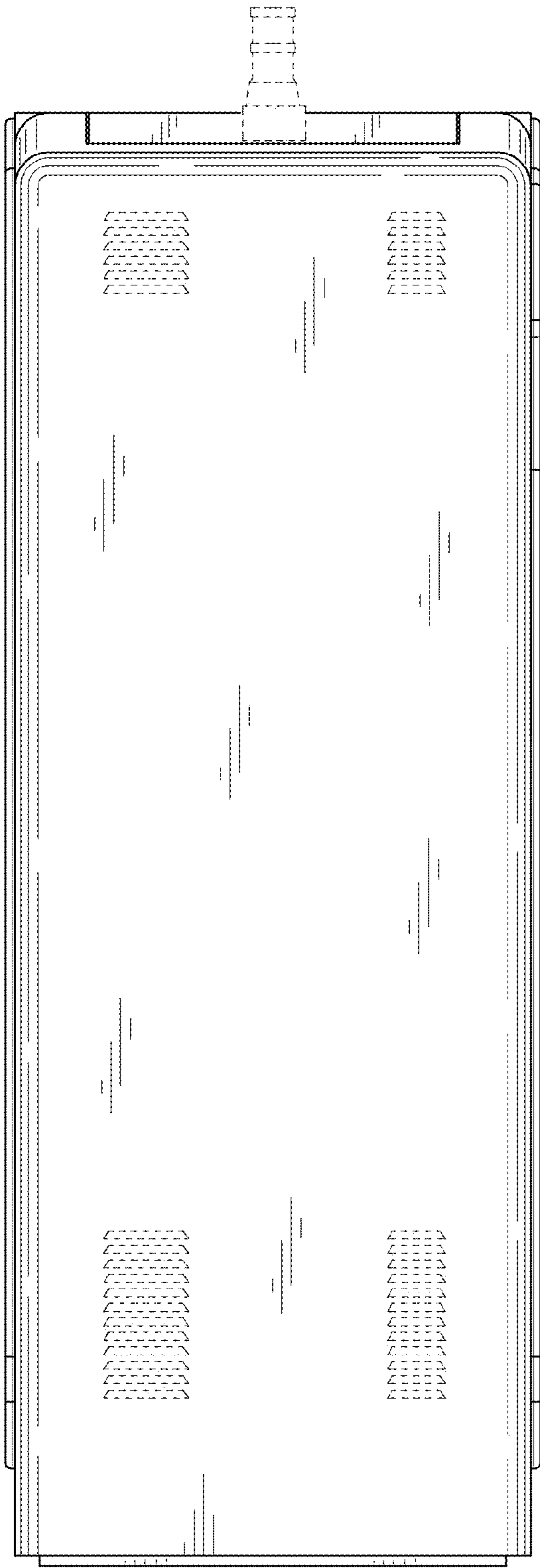

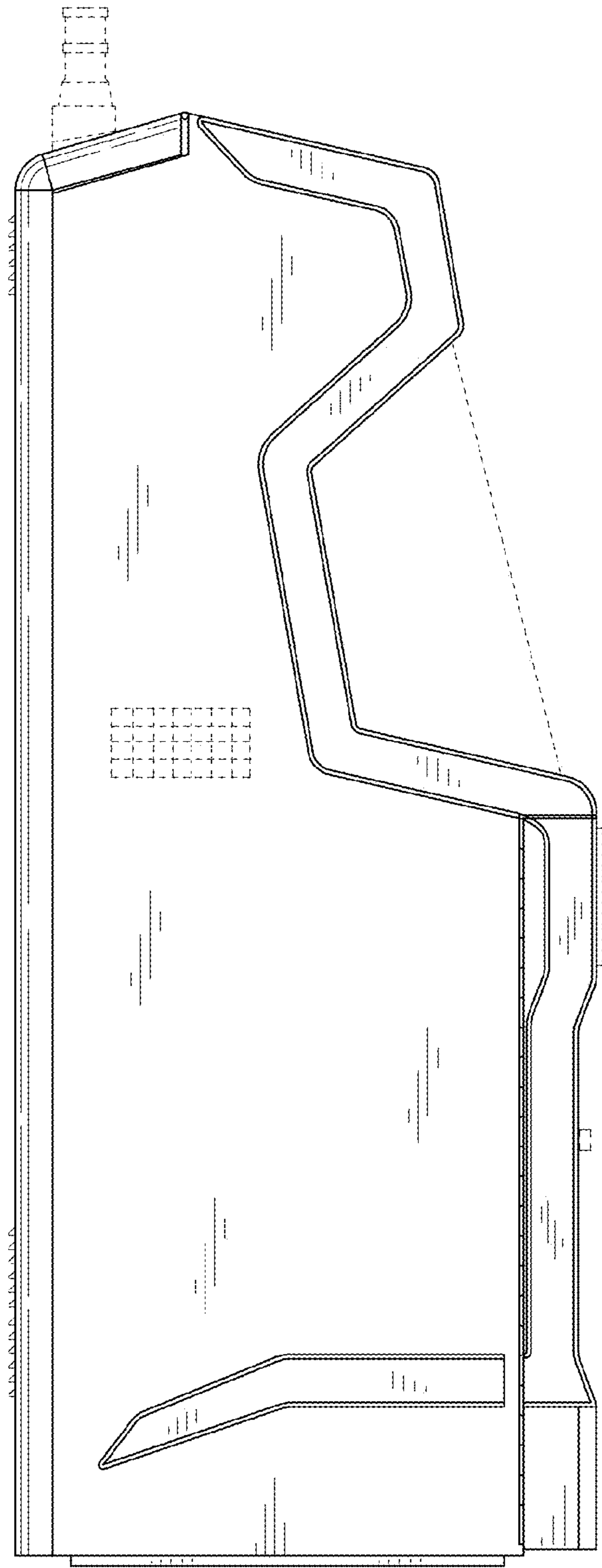

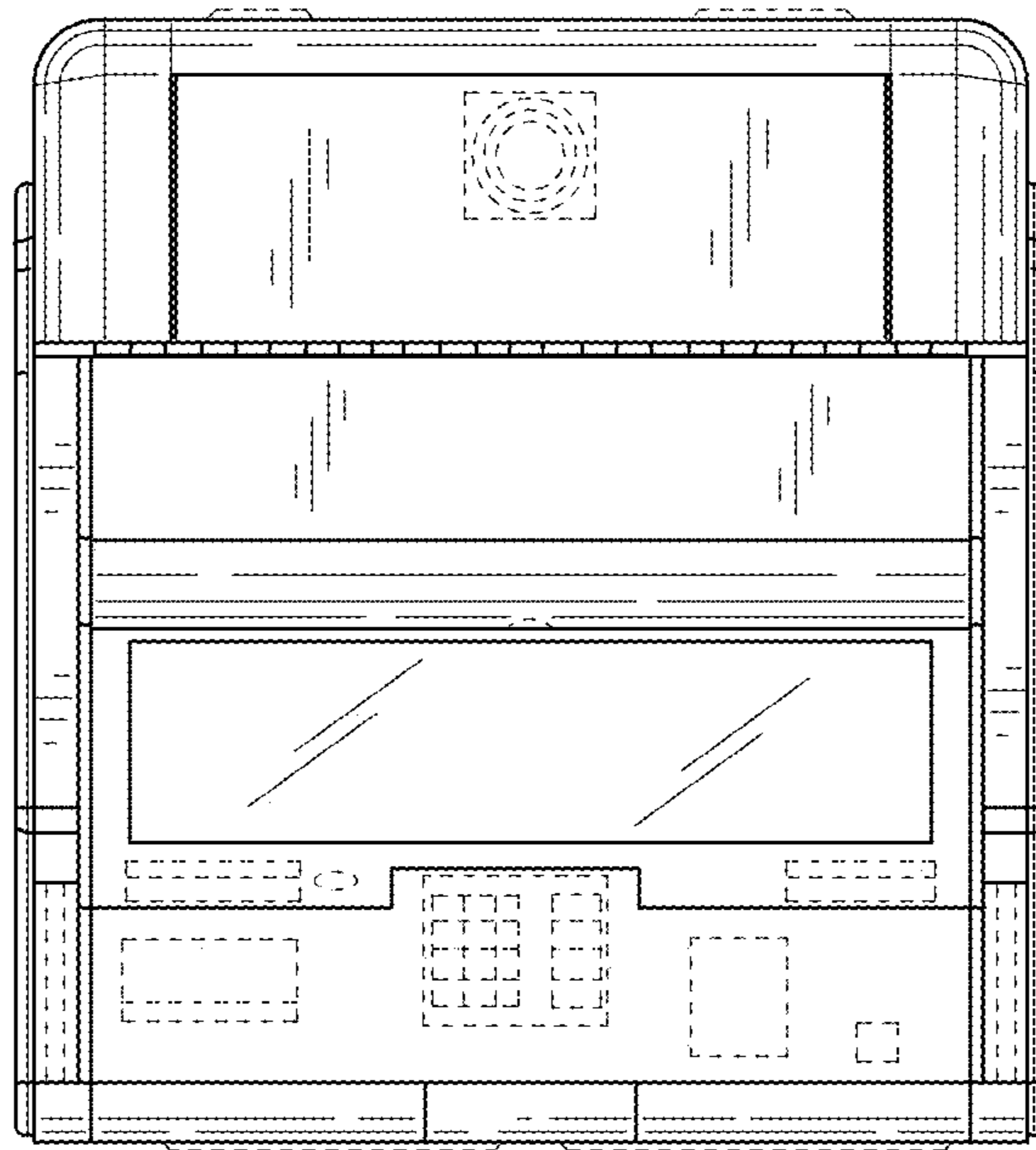

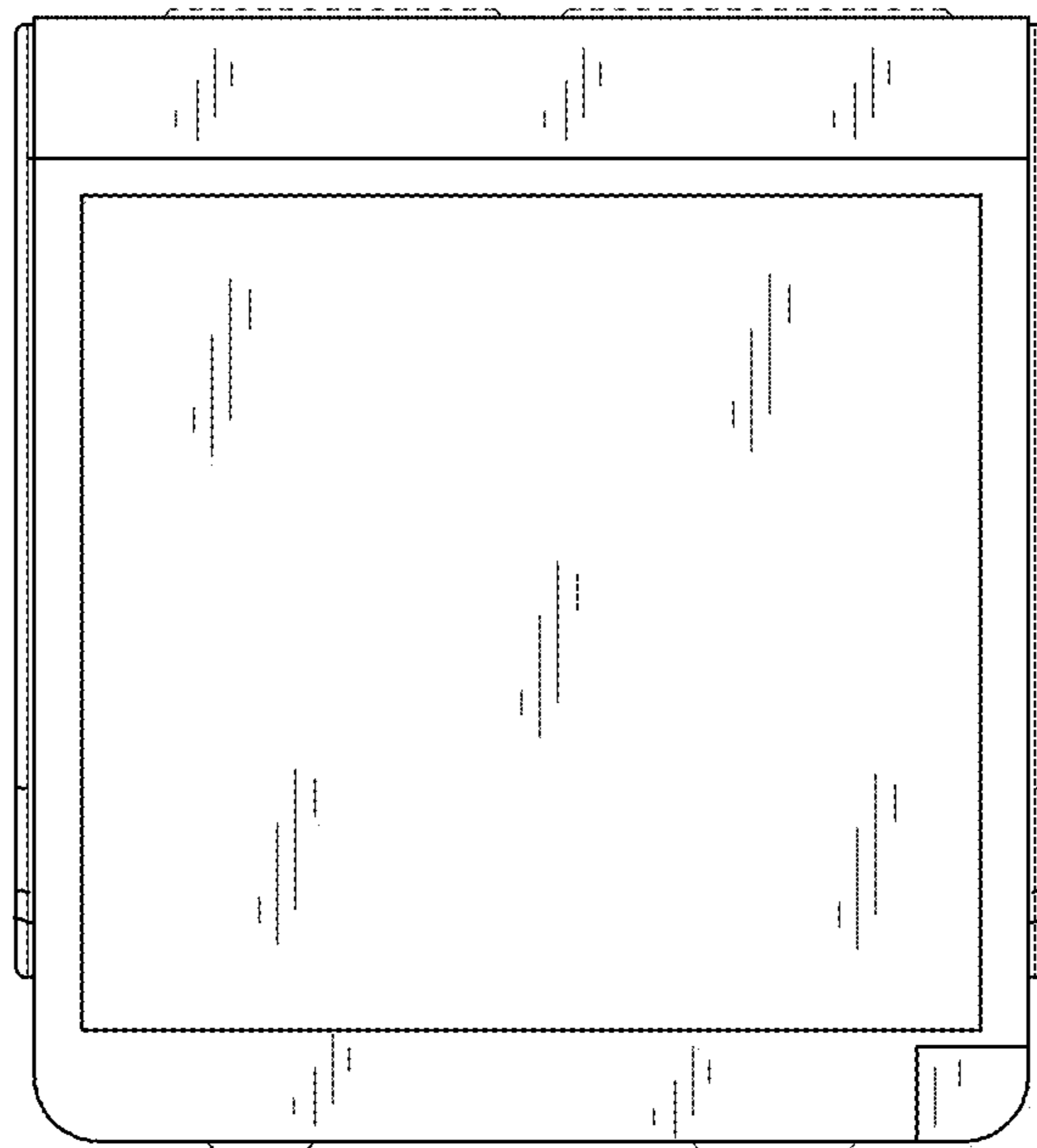
