The ornamental design for a display screen with printer icon, as shown and described.

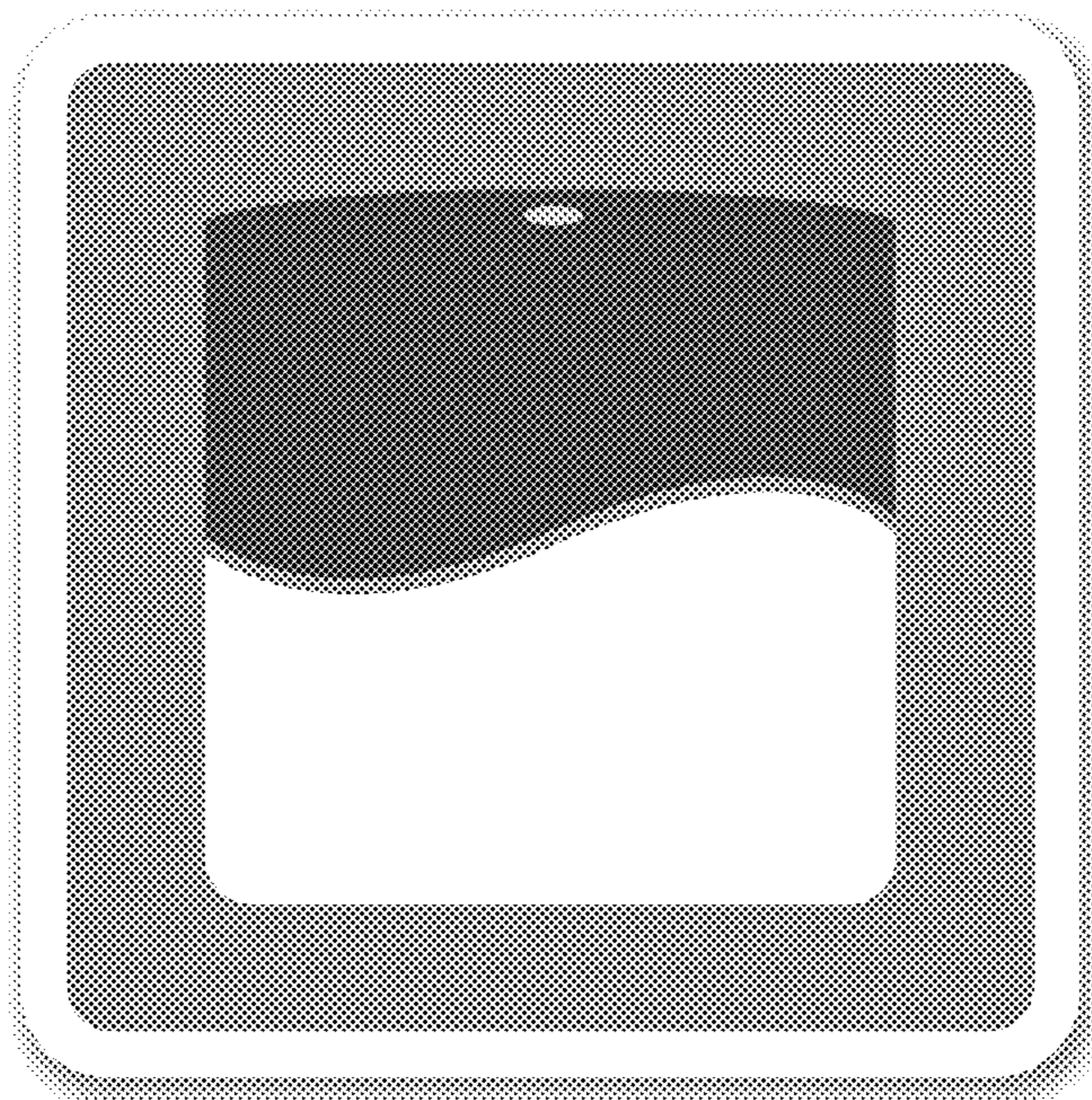
DESCRIPTION

FIG. 1 is a front view of a display screen with printer icon showing the new design enlarged and without broken lines for clarity of illustration; and,

FIG. 2 is a front view of a display screen with printer icon showing the new design.

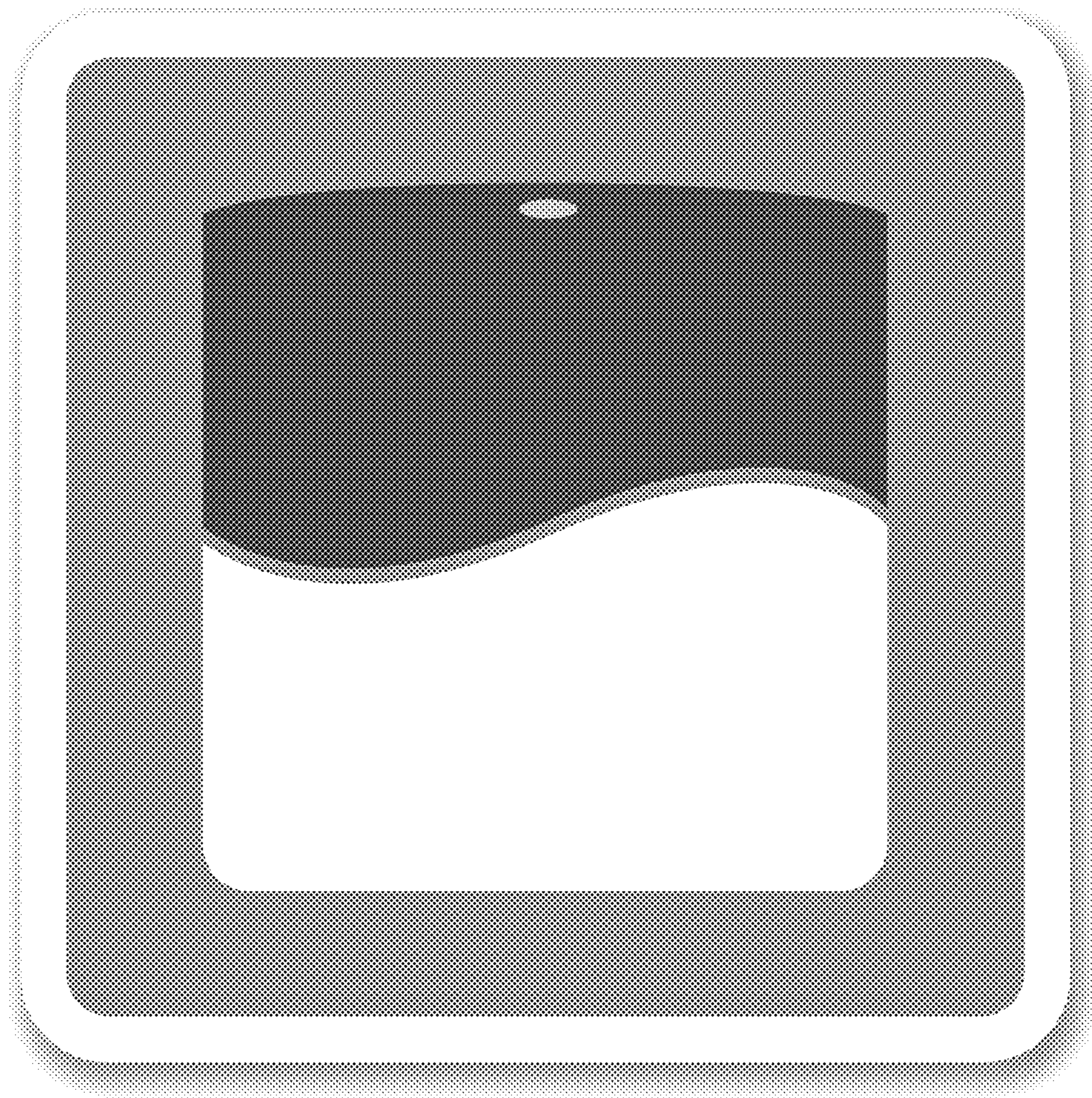

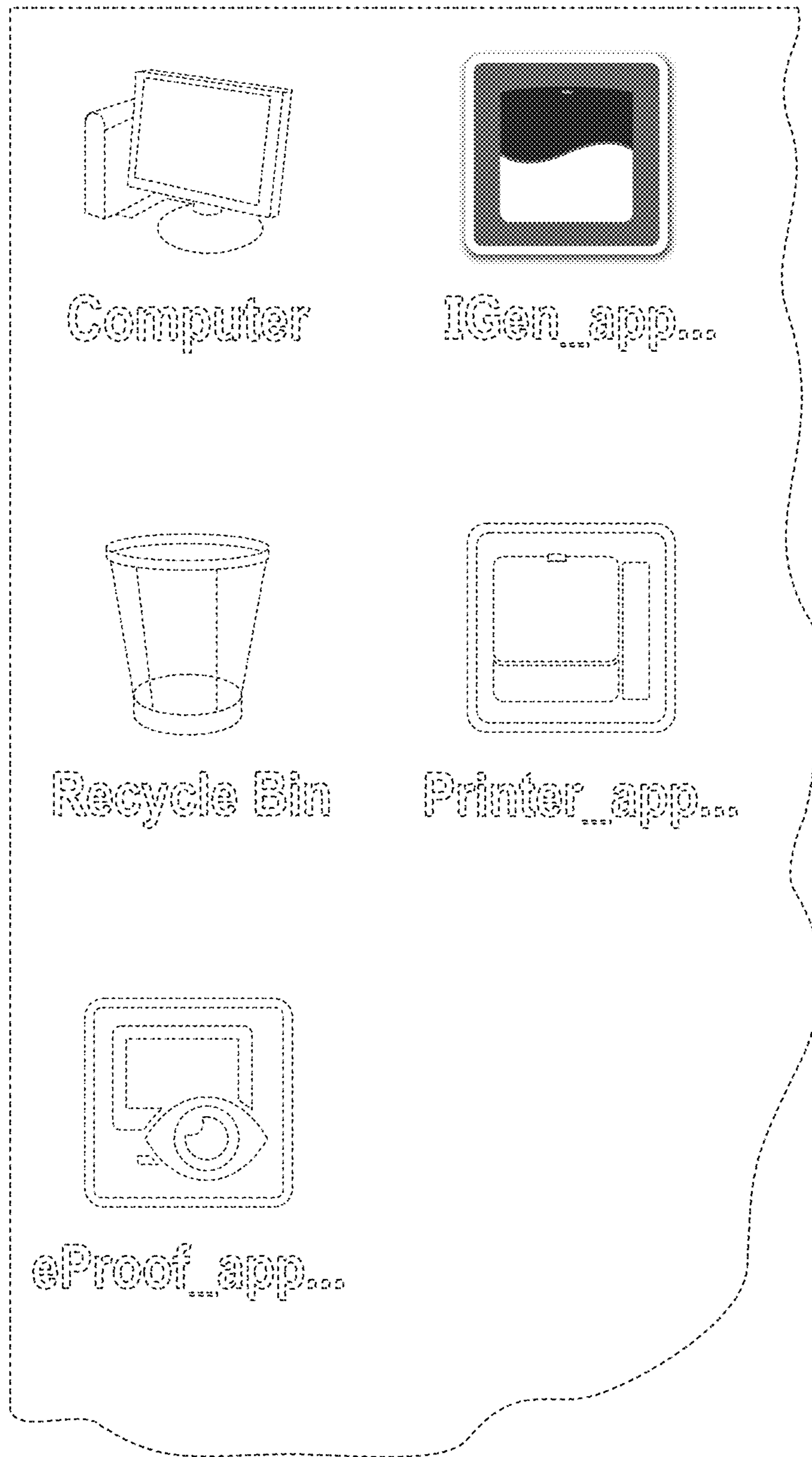
