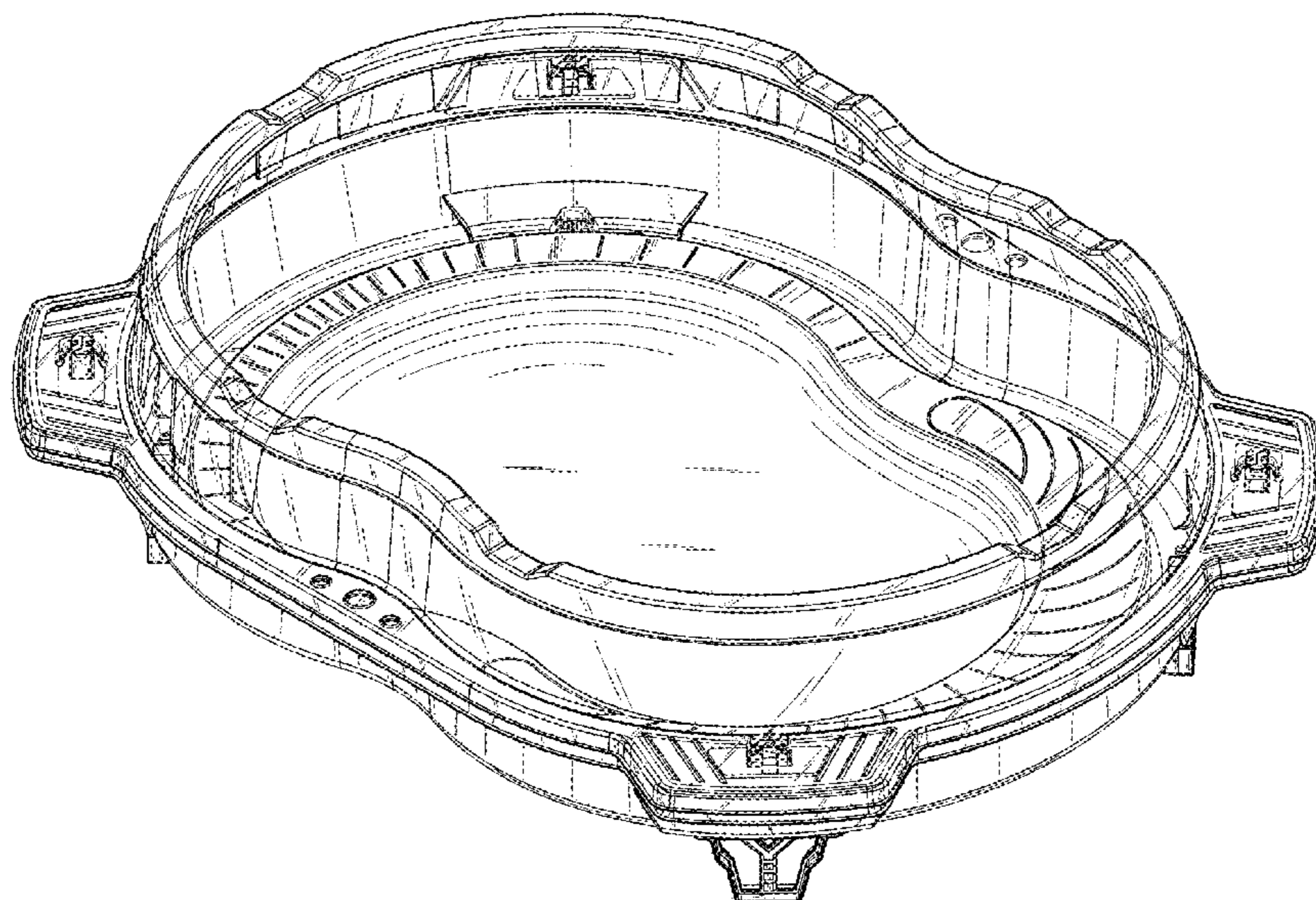
(57) **CLAIM**

The ornamental design for a playing surface for spinning top toy, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of the playing surface for spinning top toy;  
FIG. 2 is a rear elevational view thereof;  
FIG. 3 is a left-side elevational view thereof;  
FIG. 4 is a right-side elevational view thereof;  
FIG. 5 is a top plan view thereof;  
FIG. 6 is a bottom plan view thereof;  
FIG. 7 is a front, right-side, top perspective view thereof;  
FIG. 8 is a rear, left-side, bottom perspective view thereof;  
FIG. 9 is a Front, right-side and top disassembled perspective view, showing a state separating into clips, cover, base and legs;  
FIG. 10 is a rear, left-side, bottom disassembled perspective view, showing a state of being separated into clips, cover, base, and legs;  
FIG. 11 is a perspective view of only one of the clips;  
FIG. 12 is a another perspective view of the clip;  
FIG. 13 is a perspective view of only one of the legs; and,  
FIG. 14 is a another perspective view of only the leg.

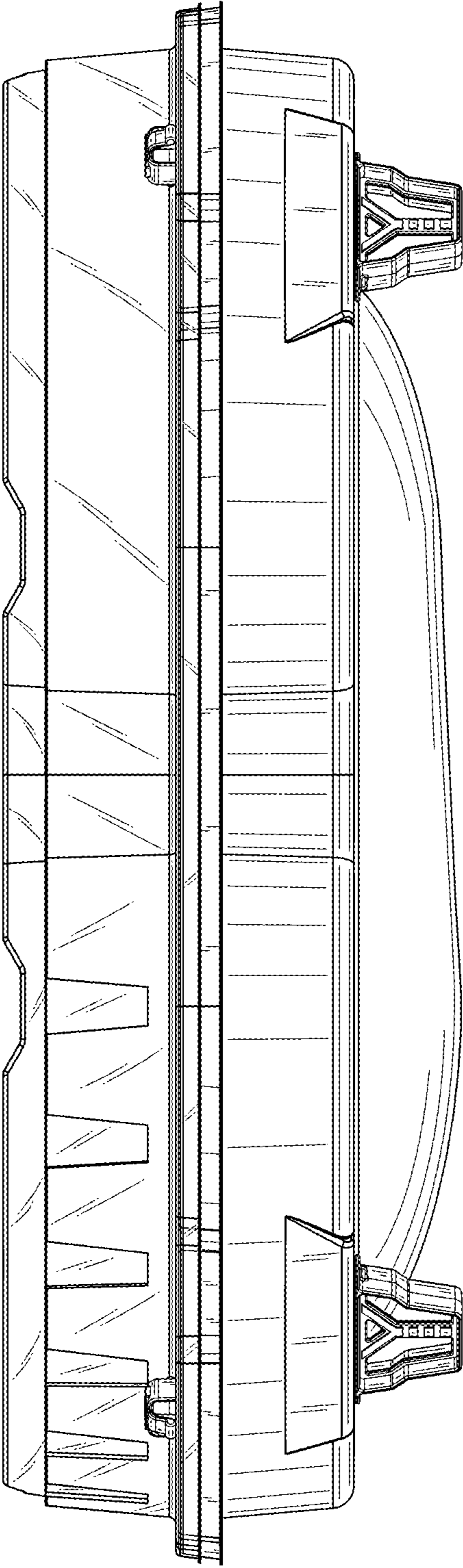

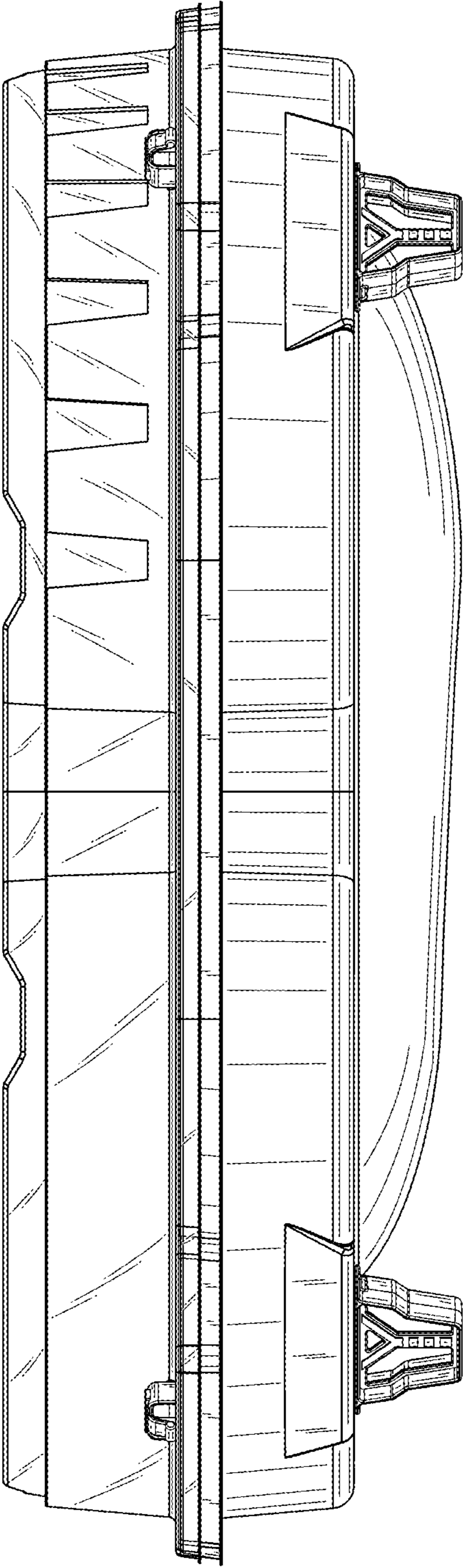

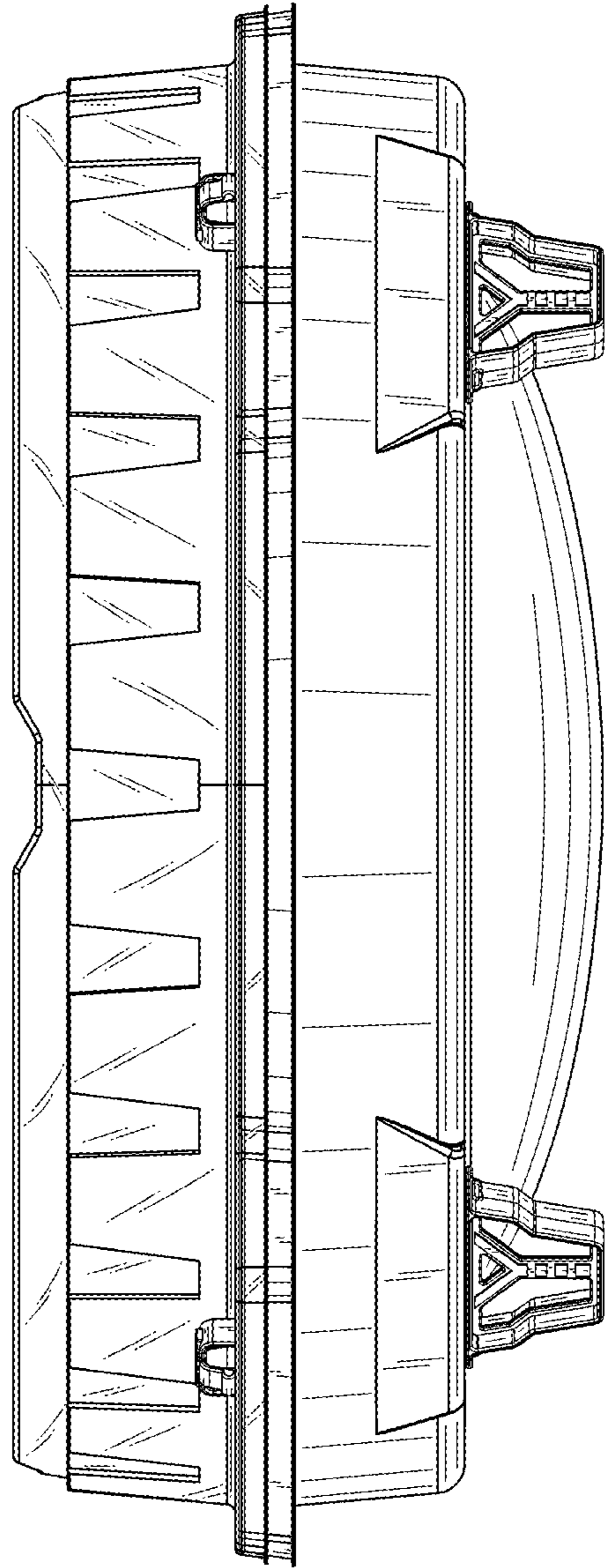

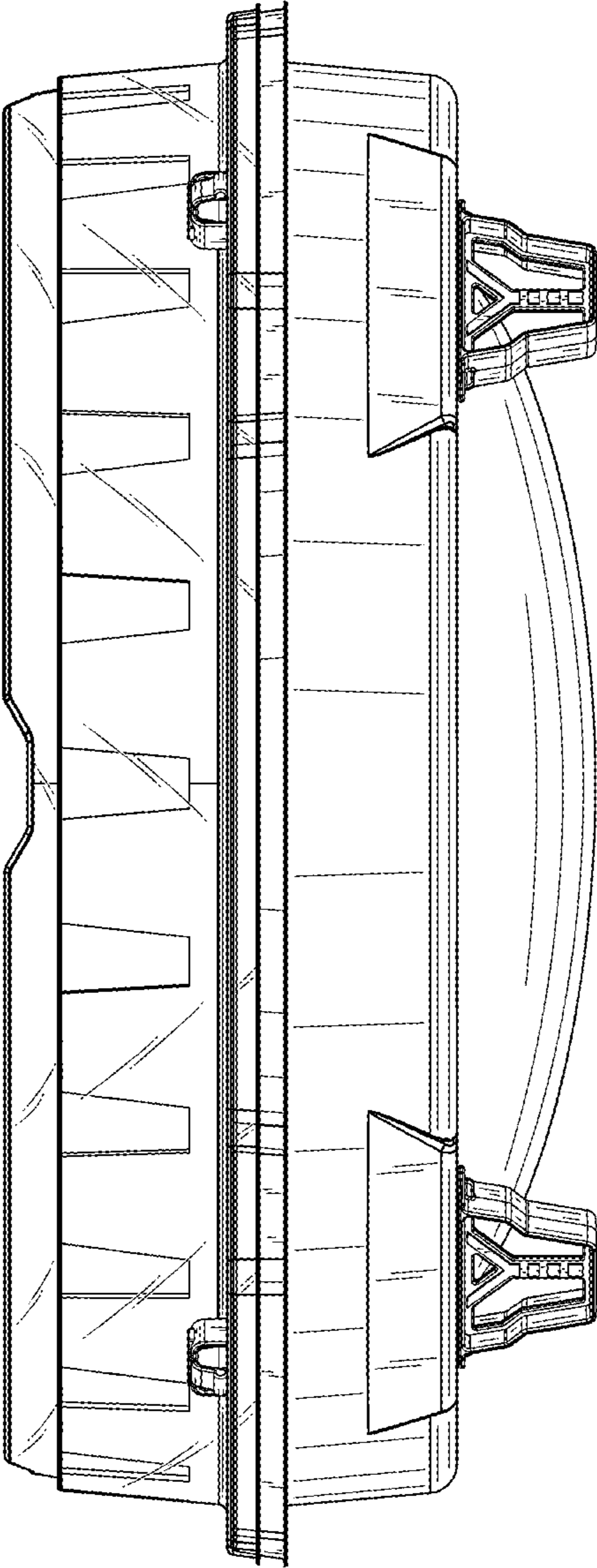

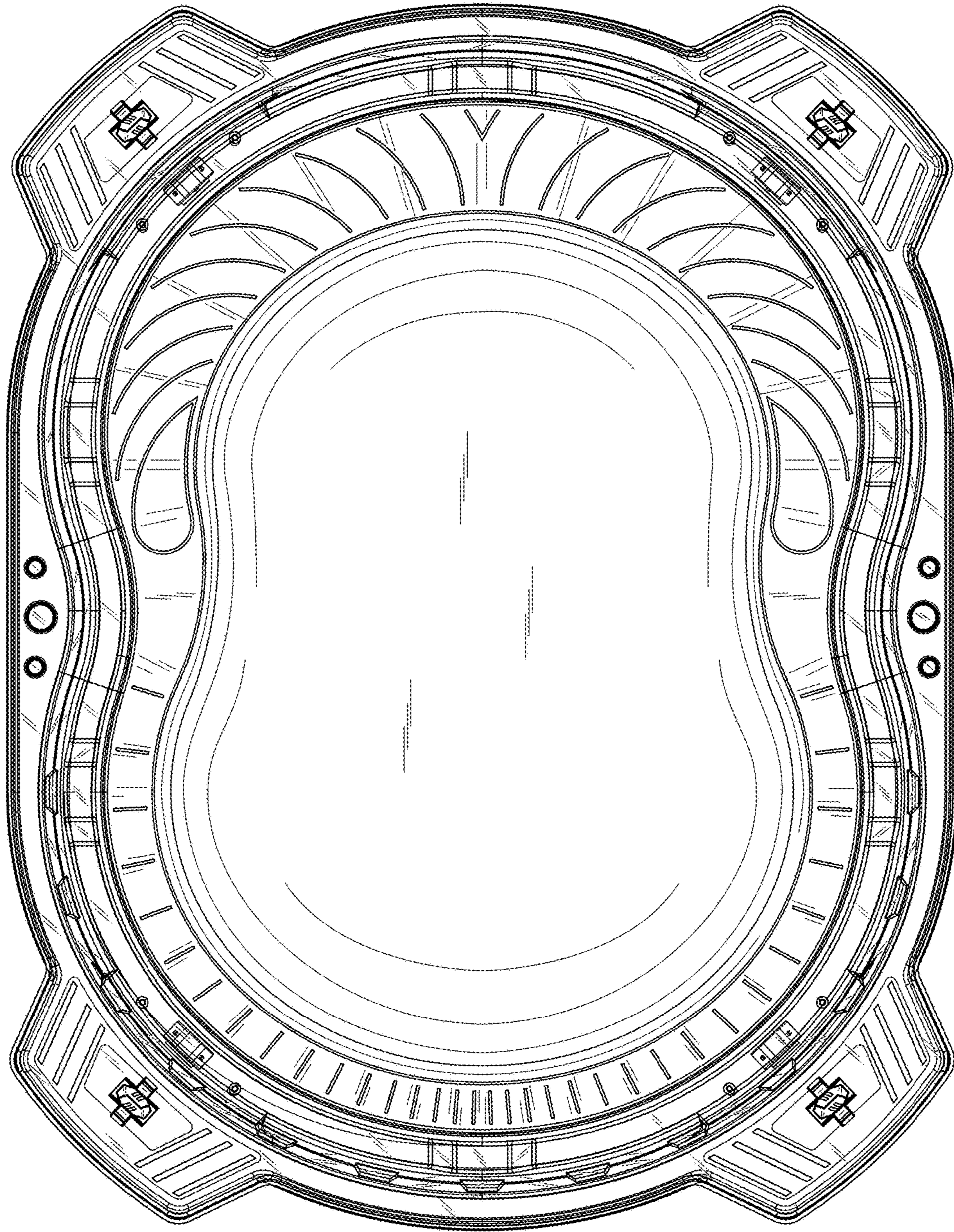

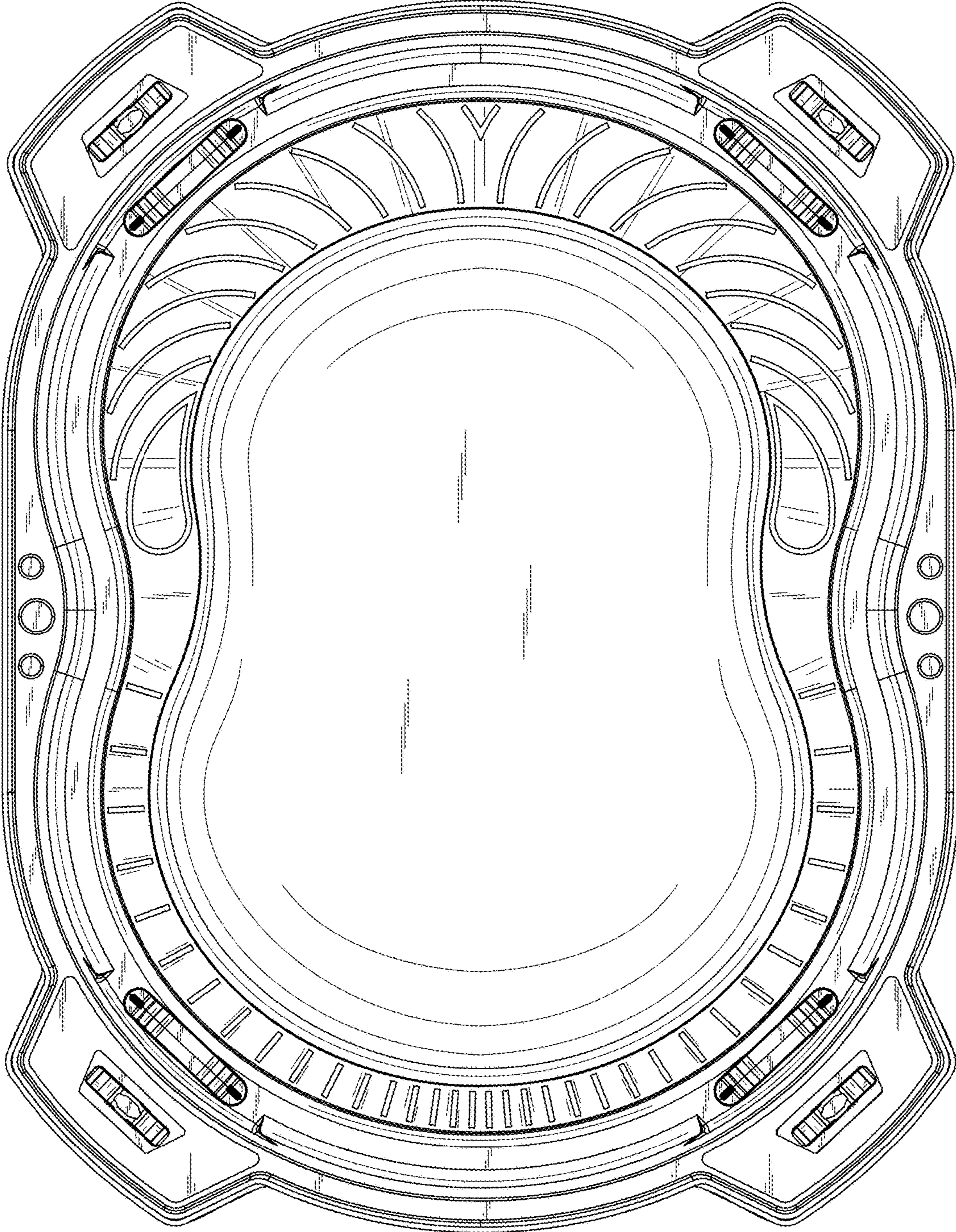

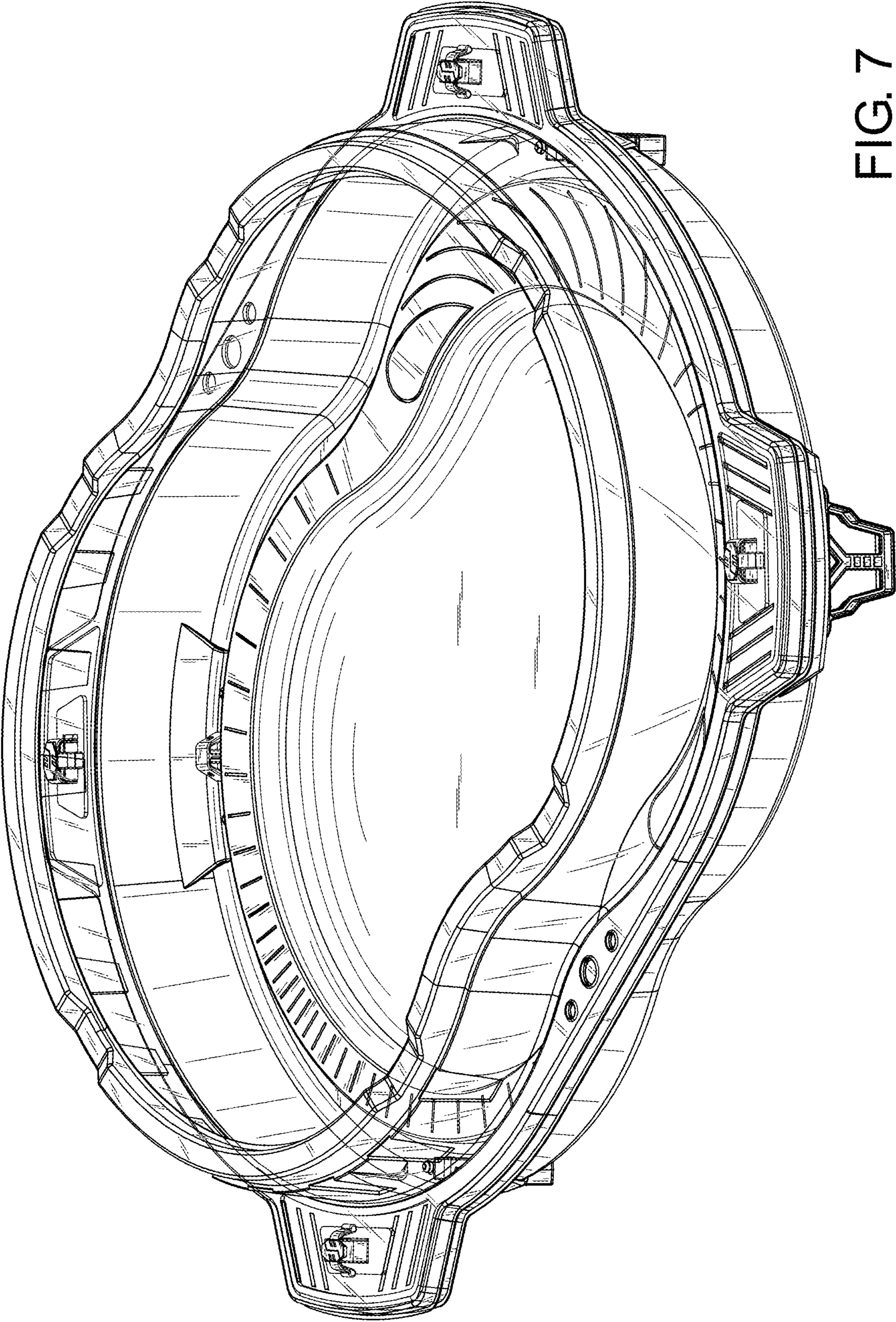

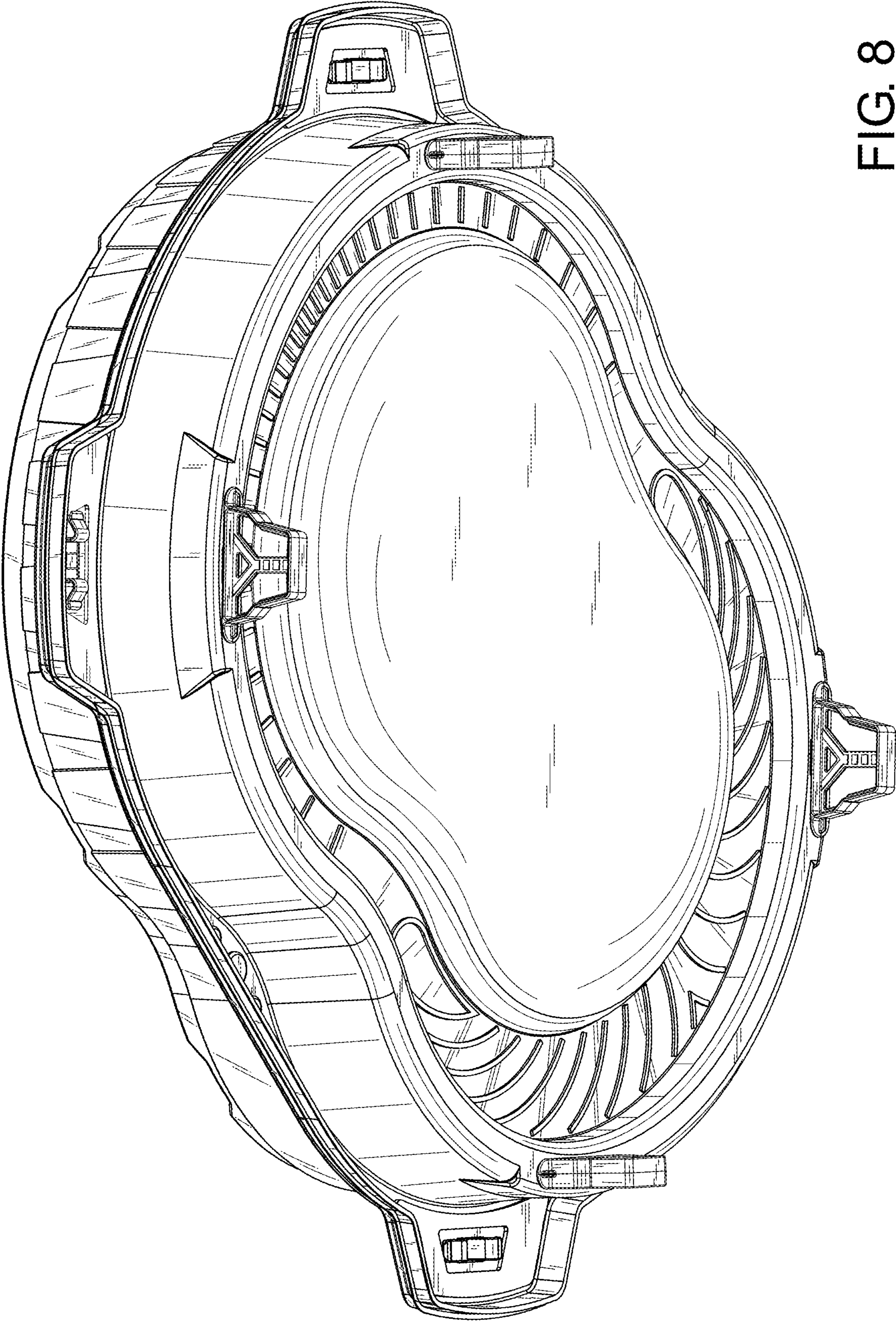

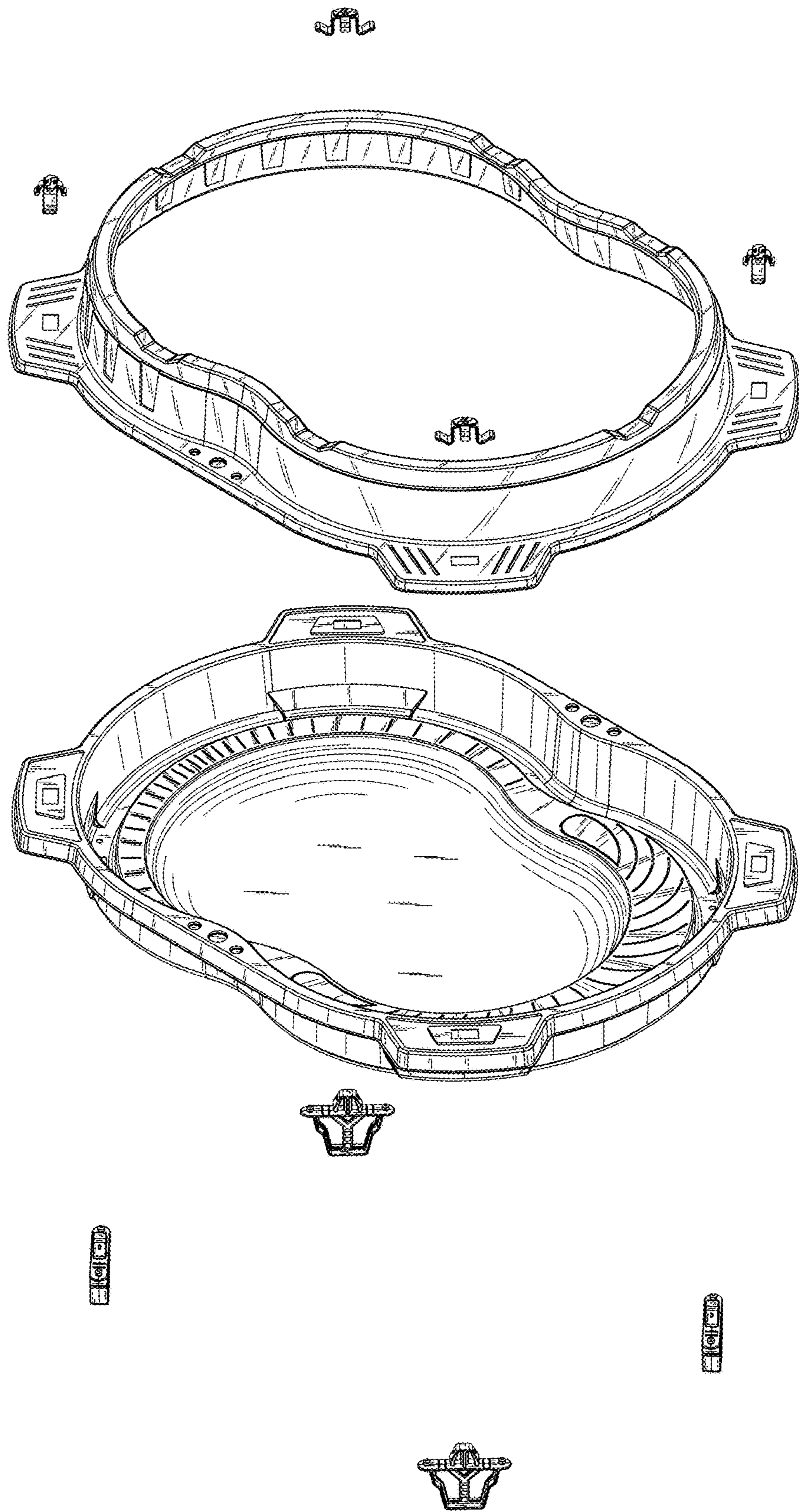

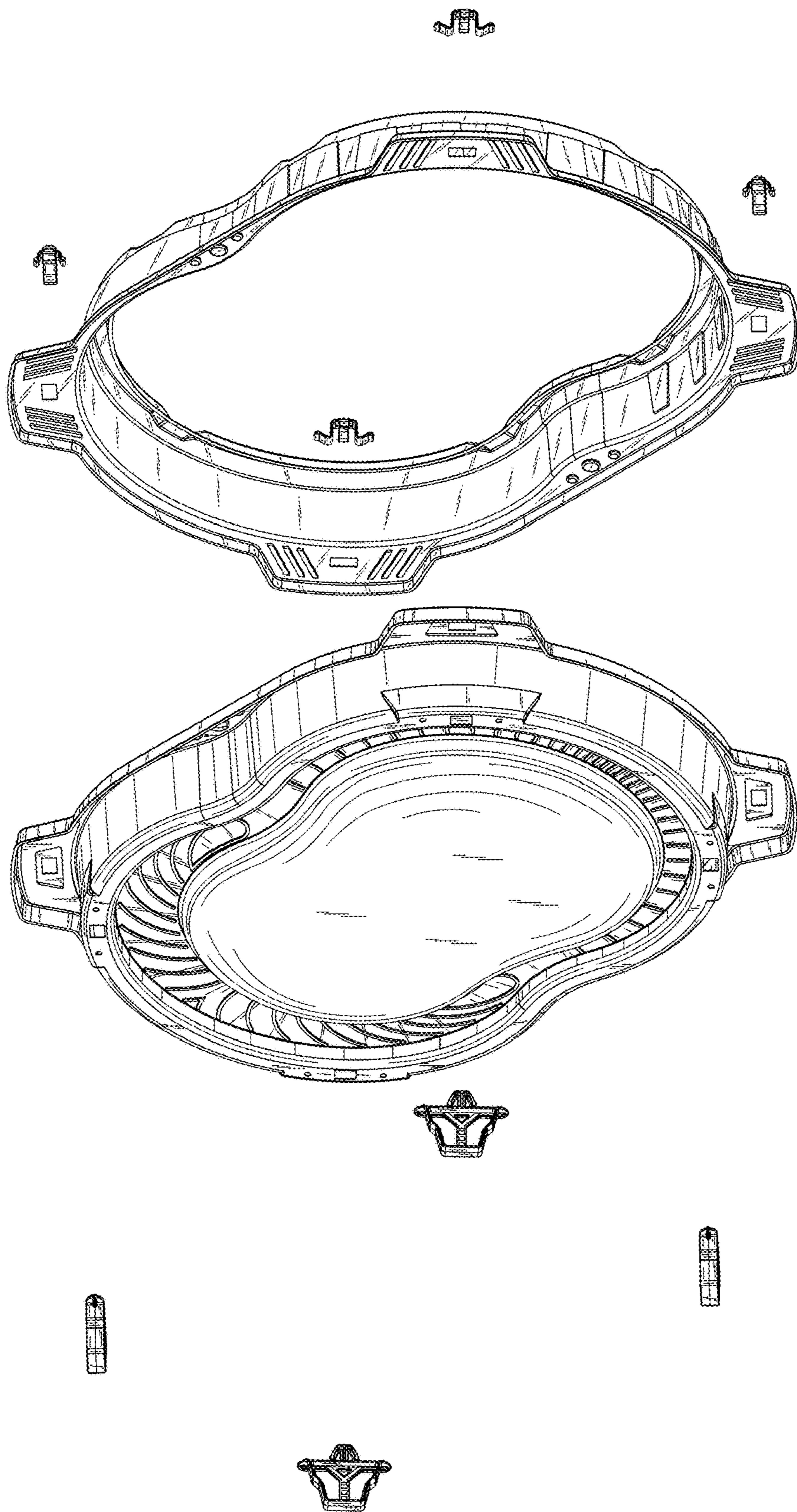

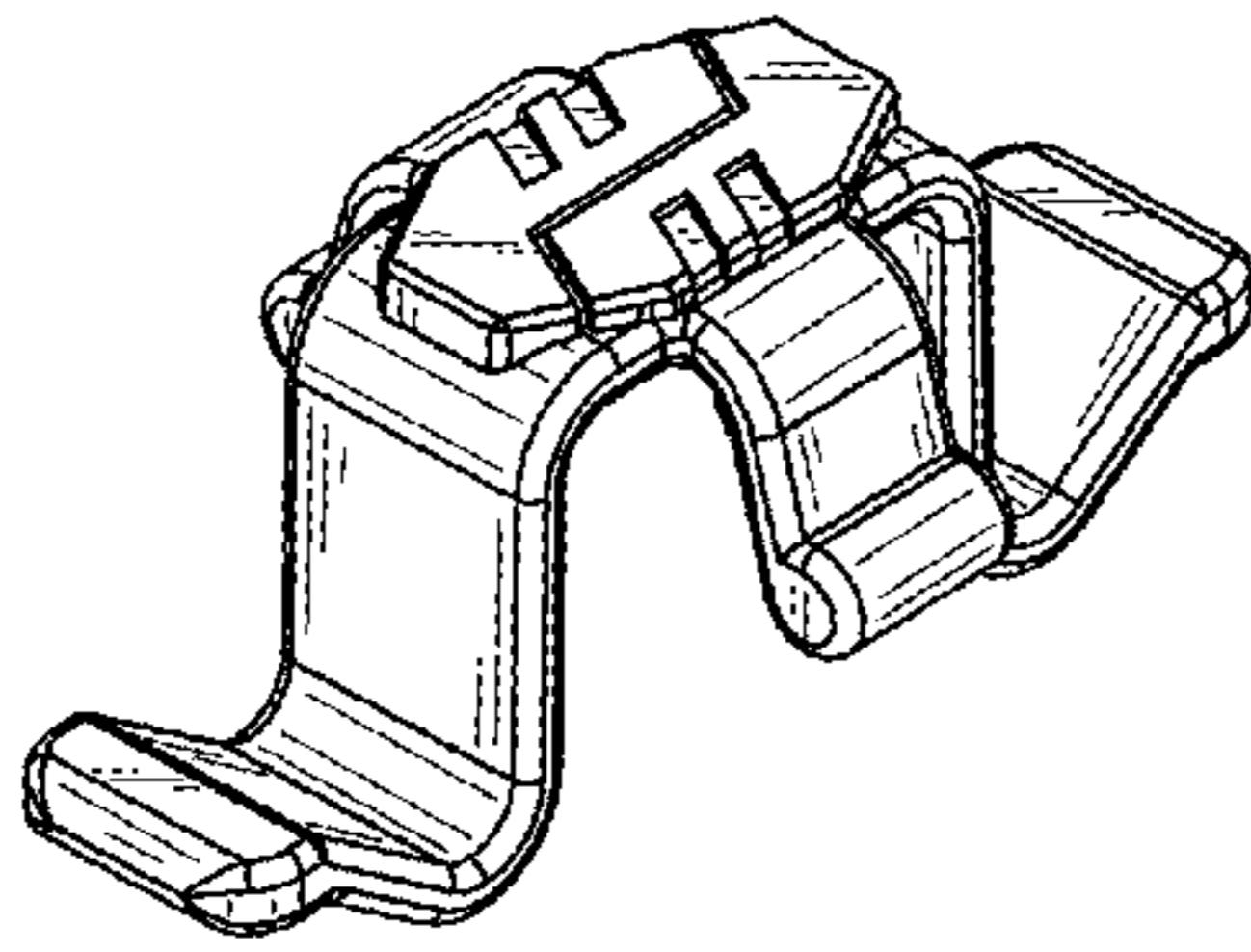

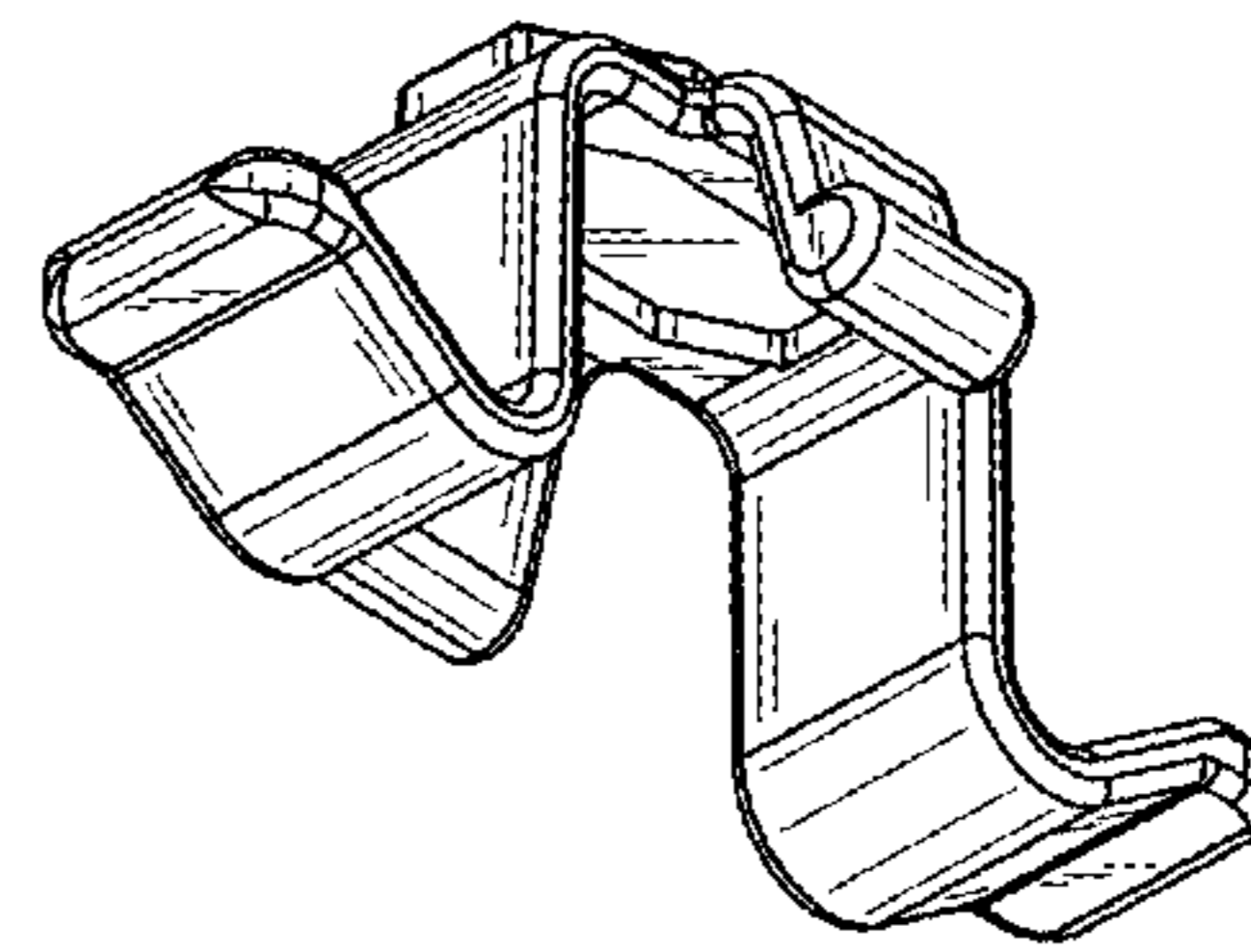

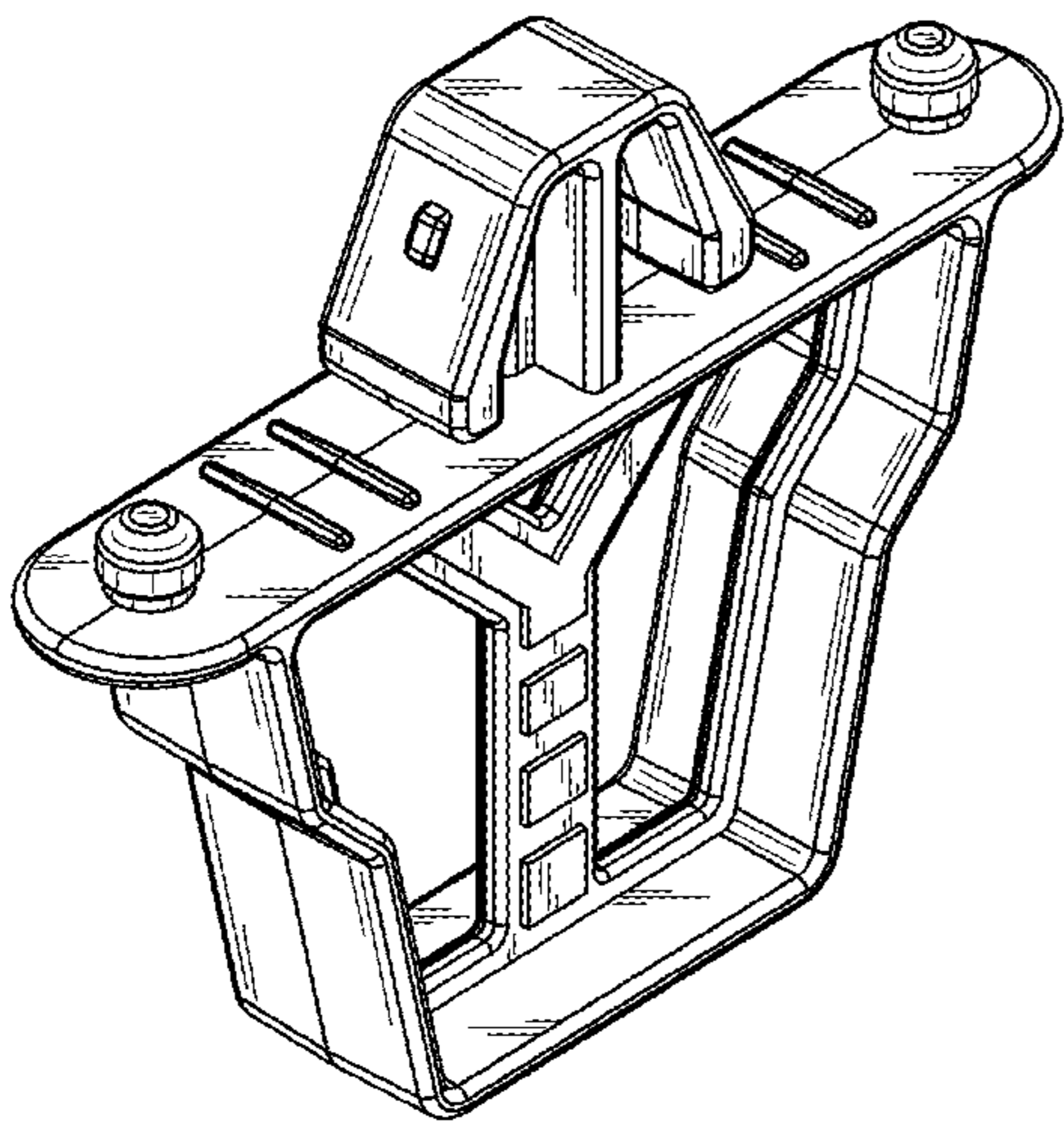
