DESCRIPTION

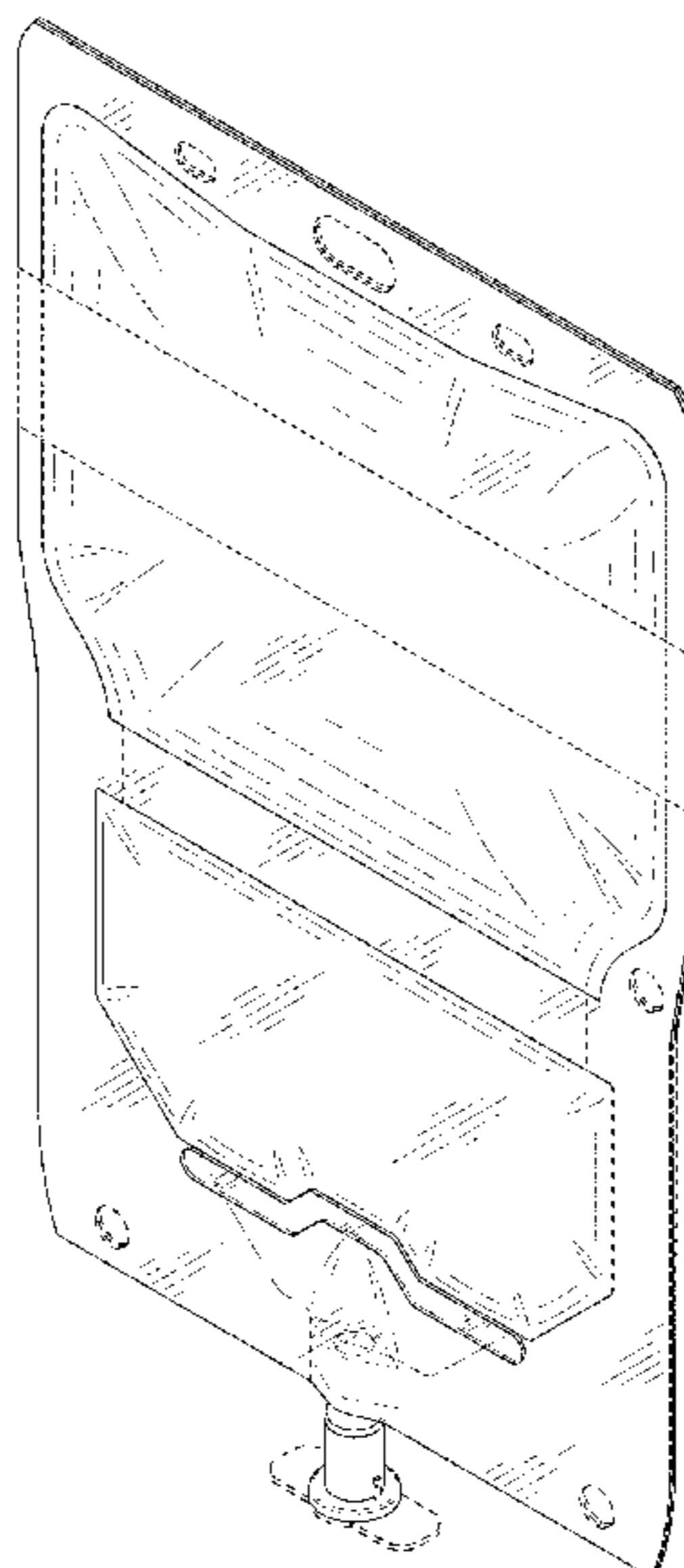
FIG. 1 is a top, front, left side perspective view of one embodiment of the dual chamber flexible container showing our new design;

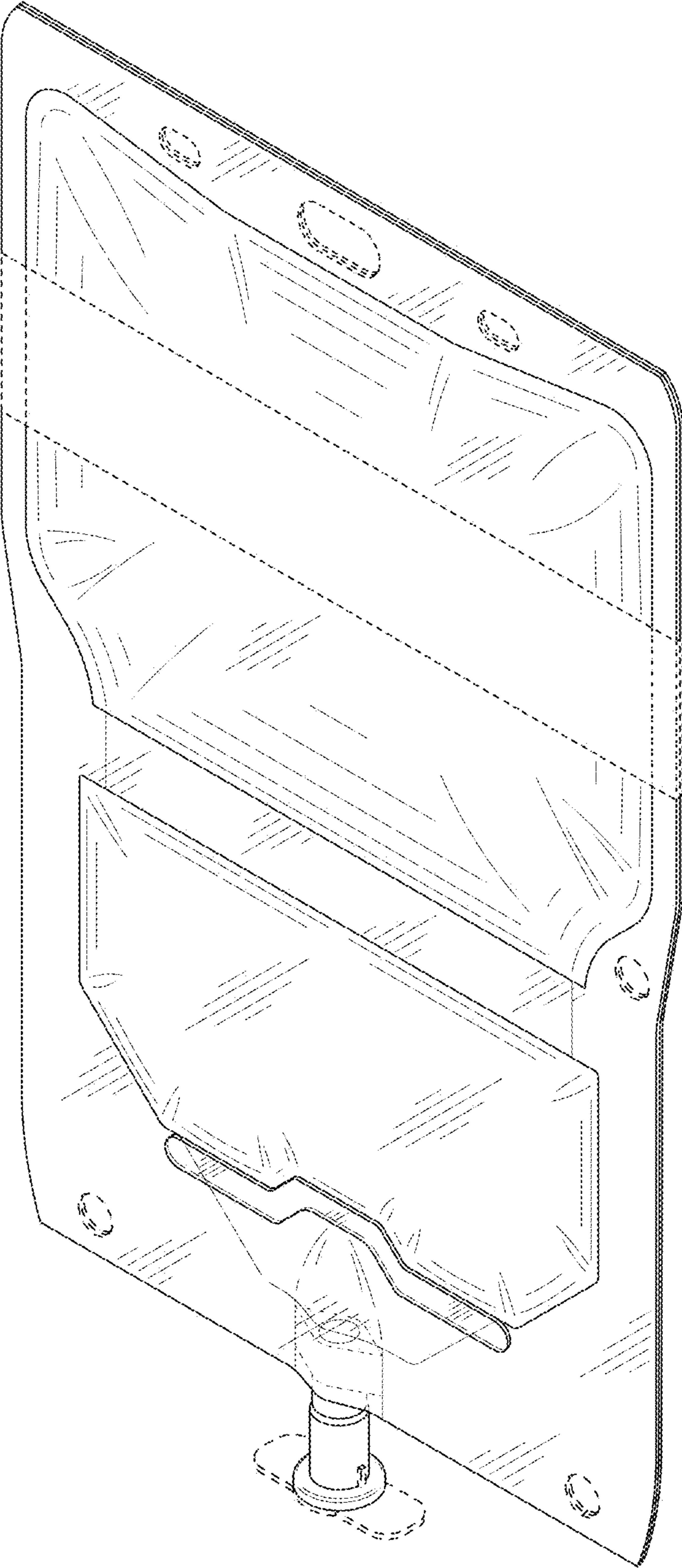

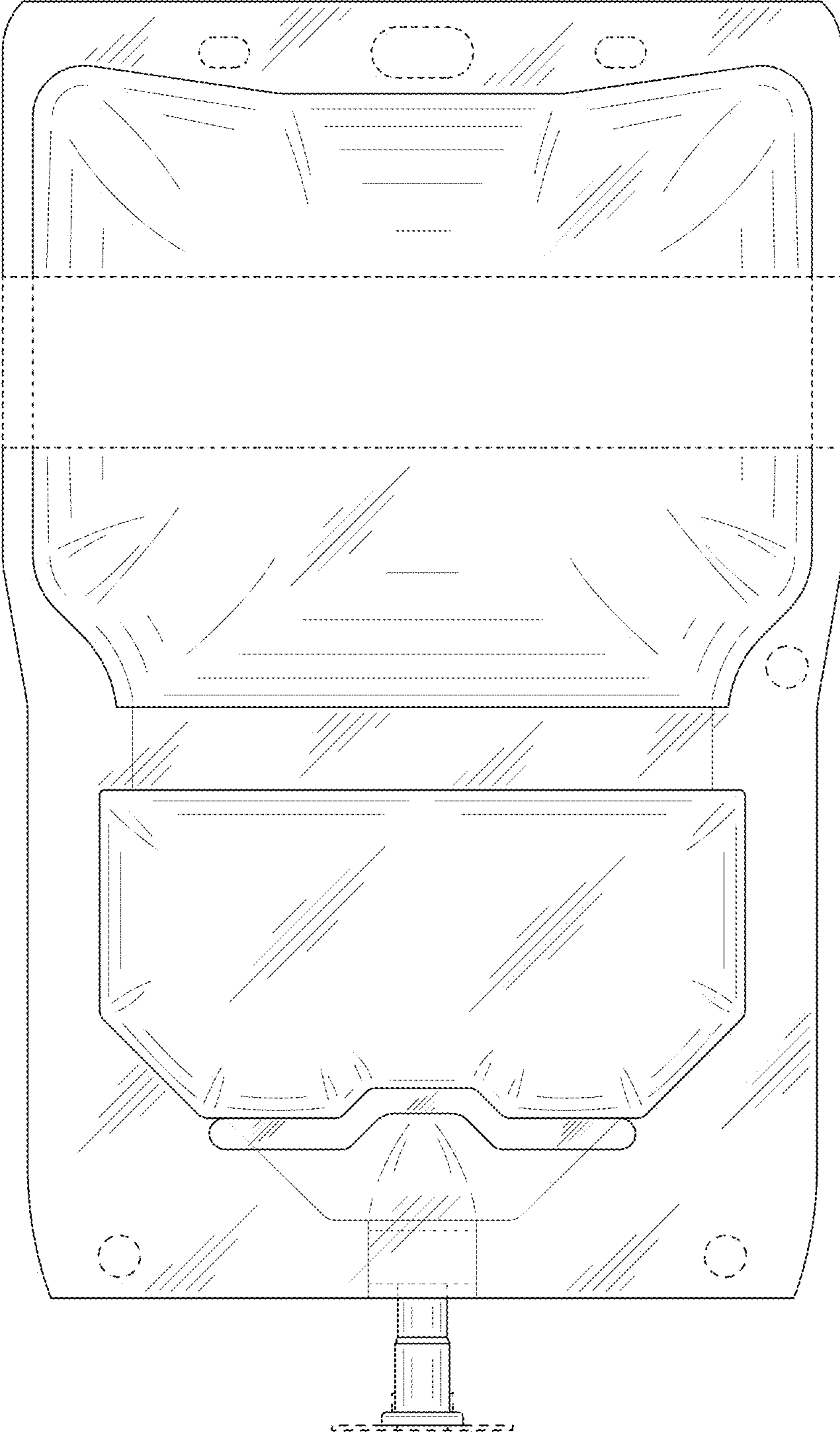

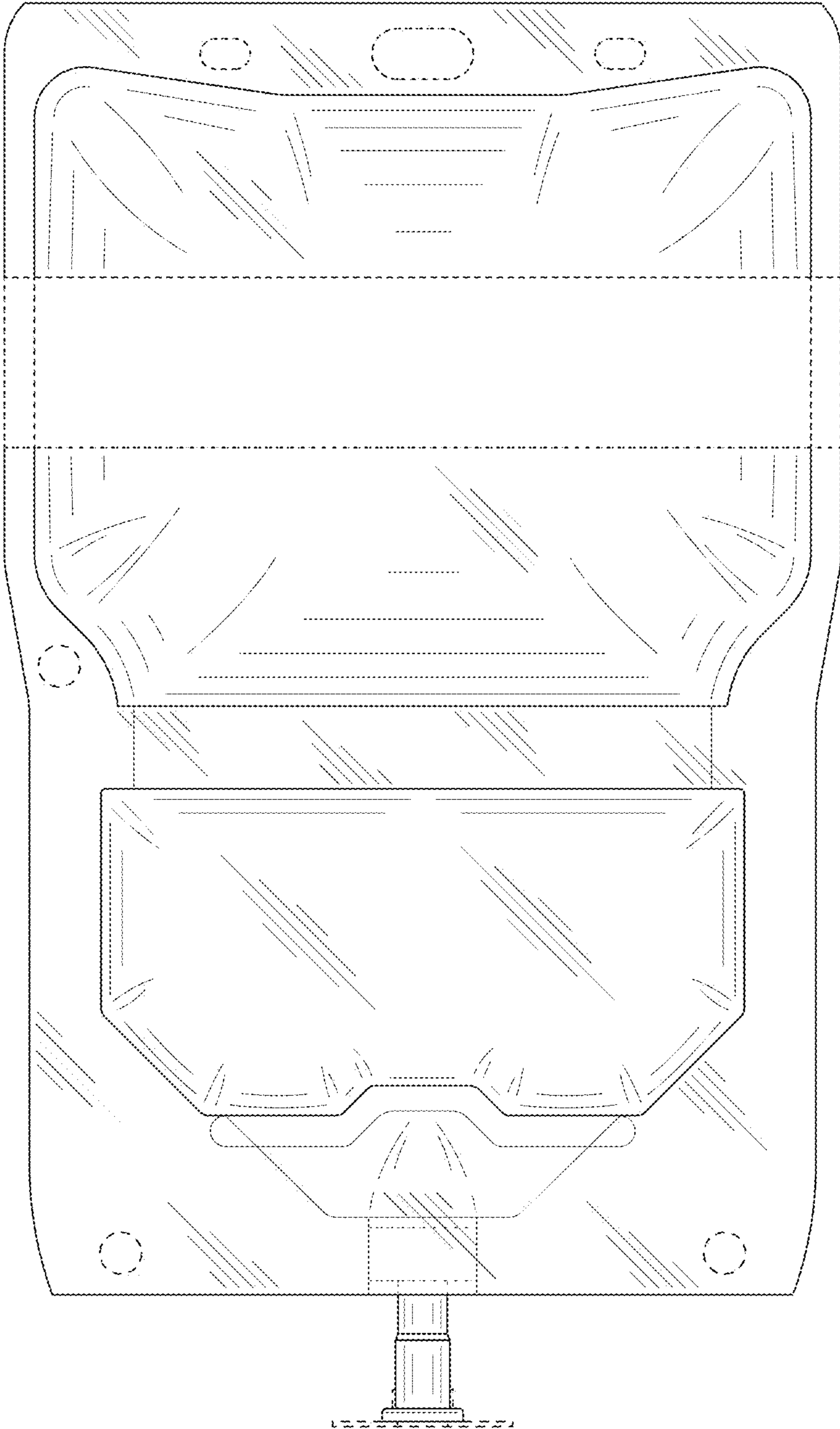

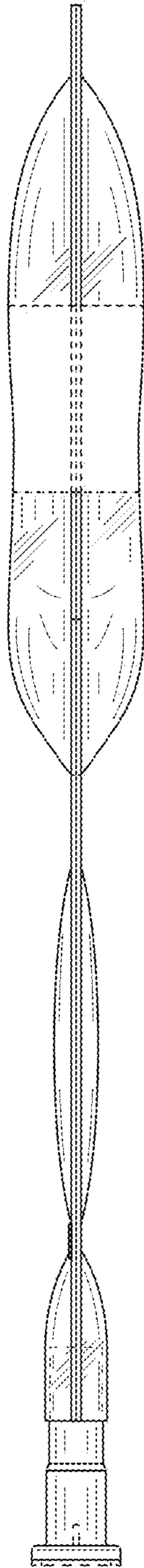

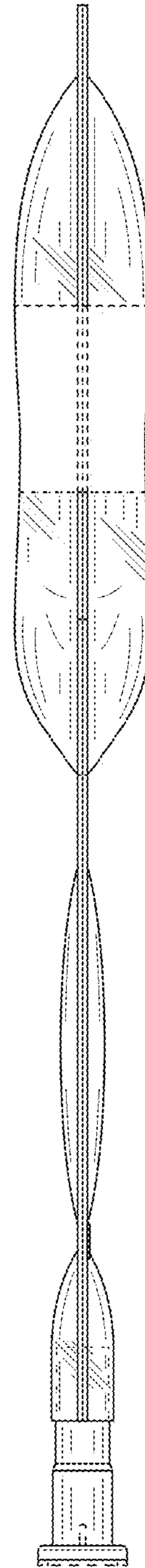

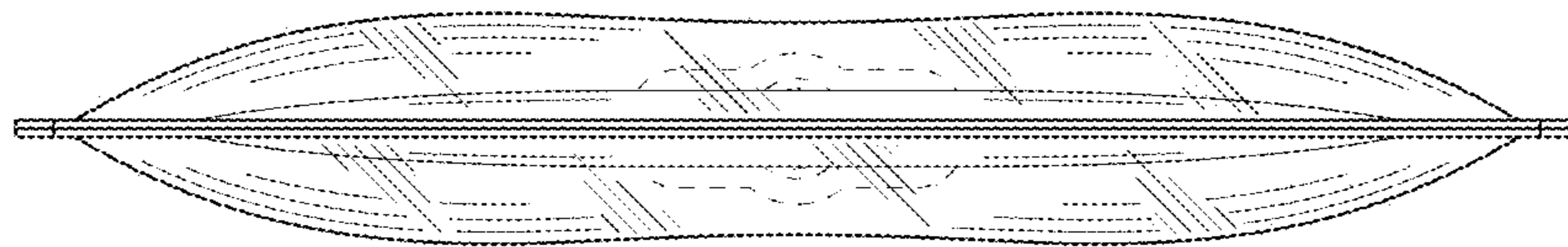

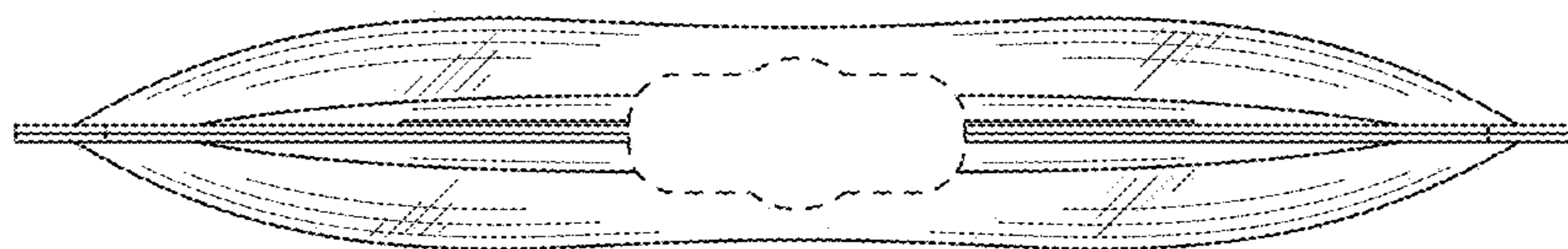
