(57) **CLAIM**

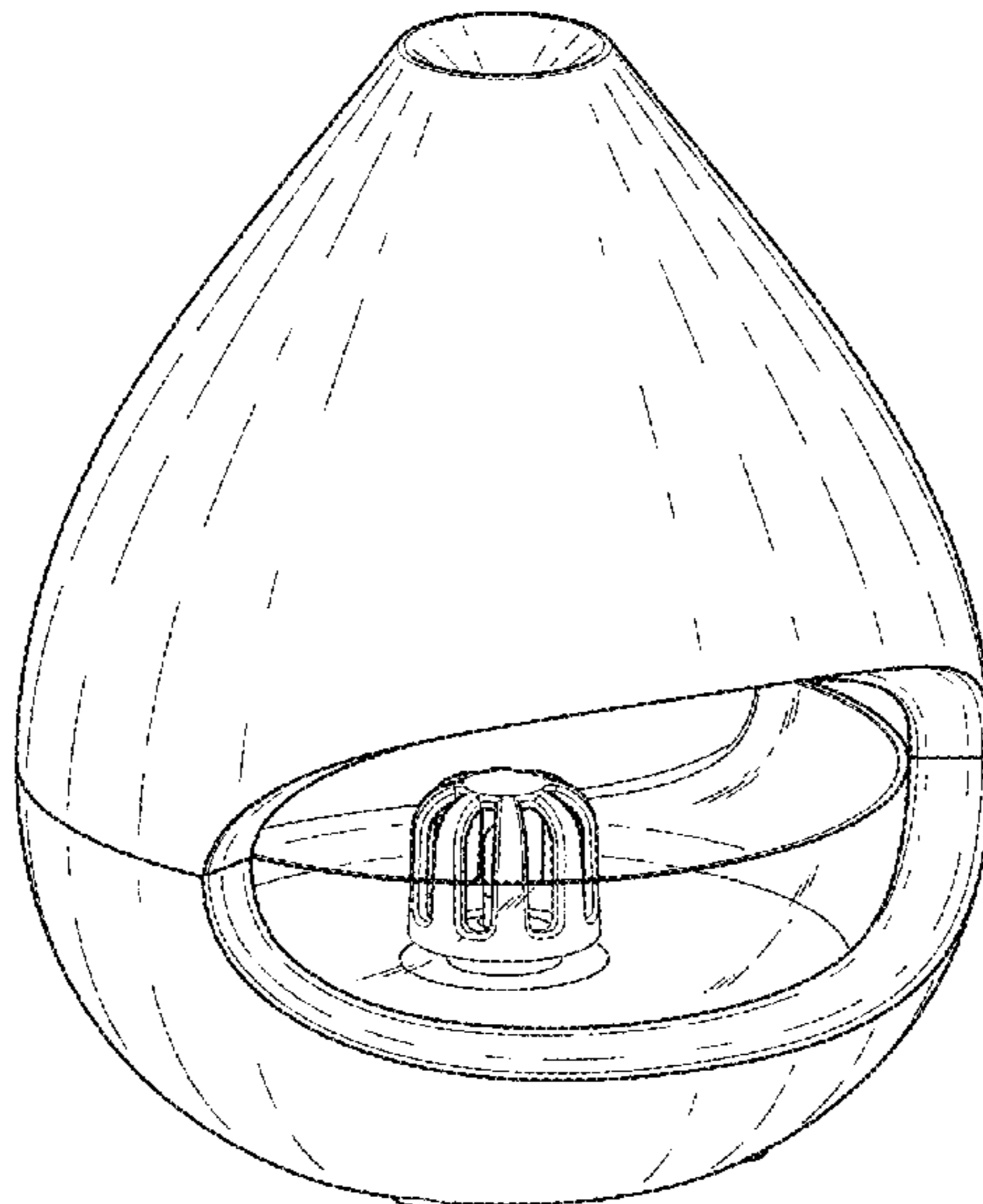
The ornamental design for a combined salt lamp and oil diffuser, as shown and described.

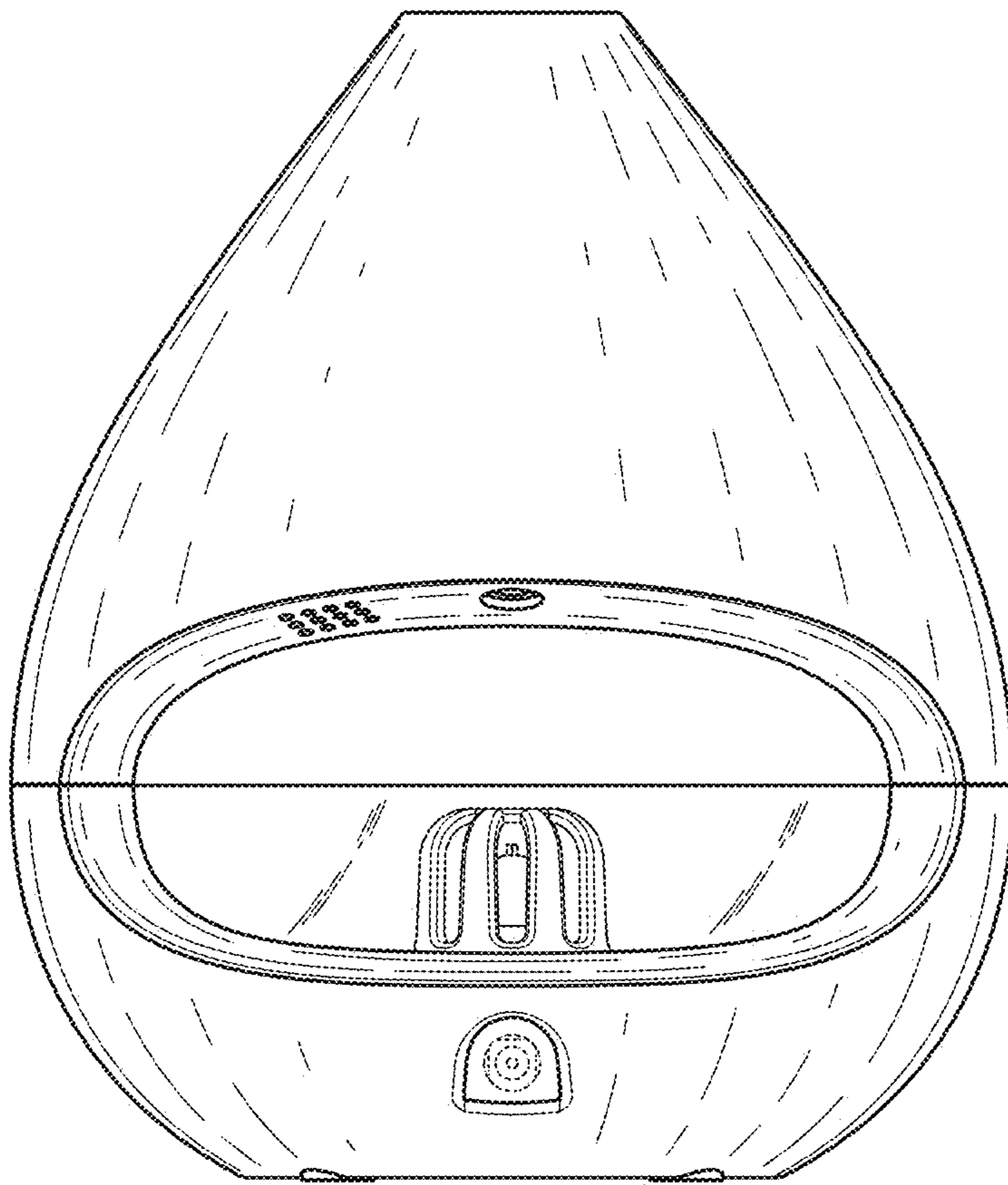

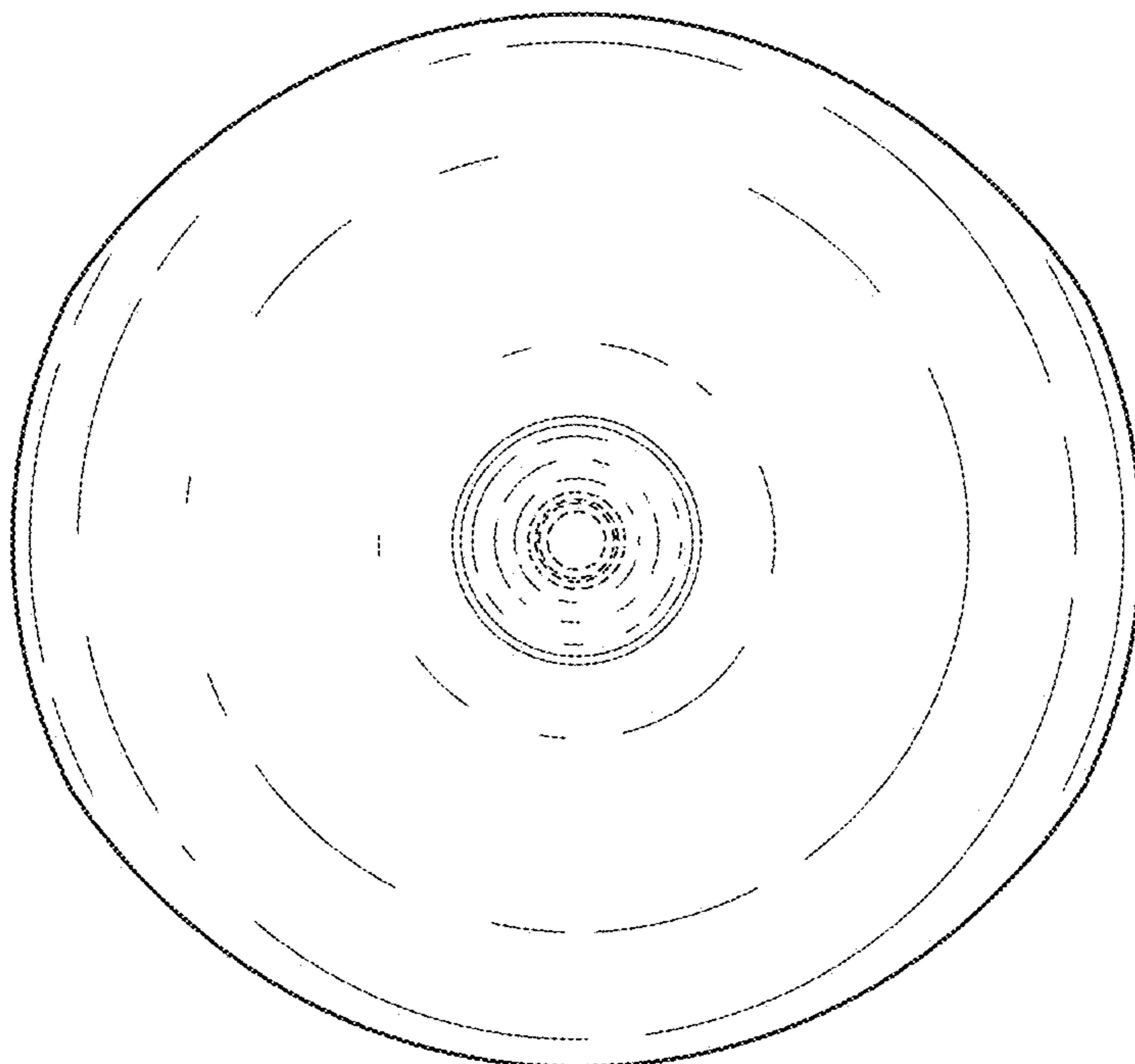

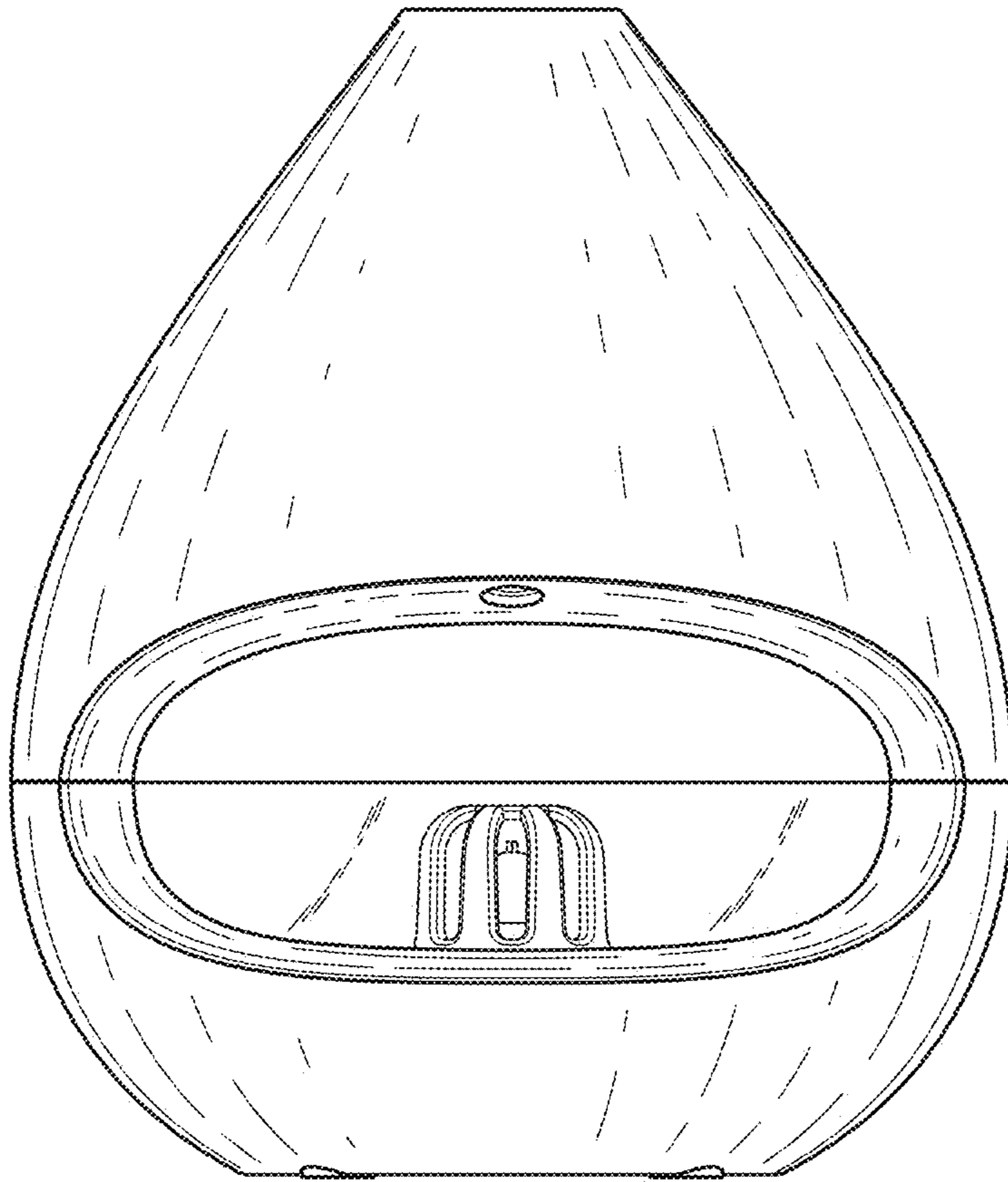

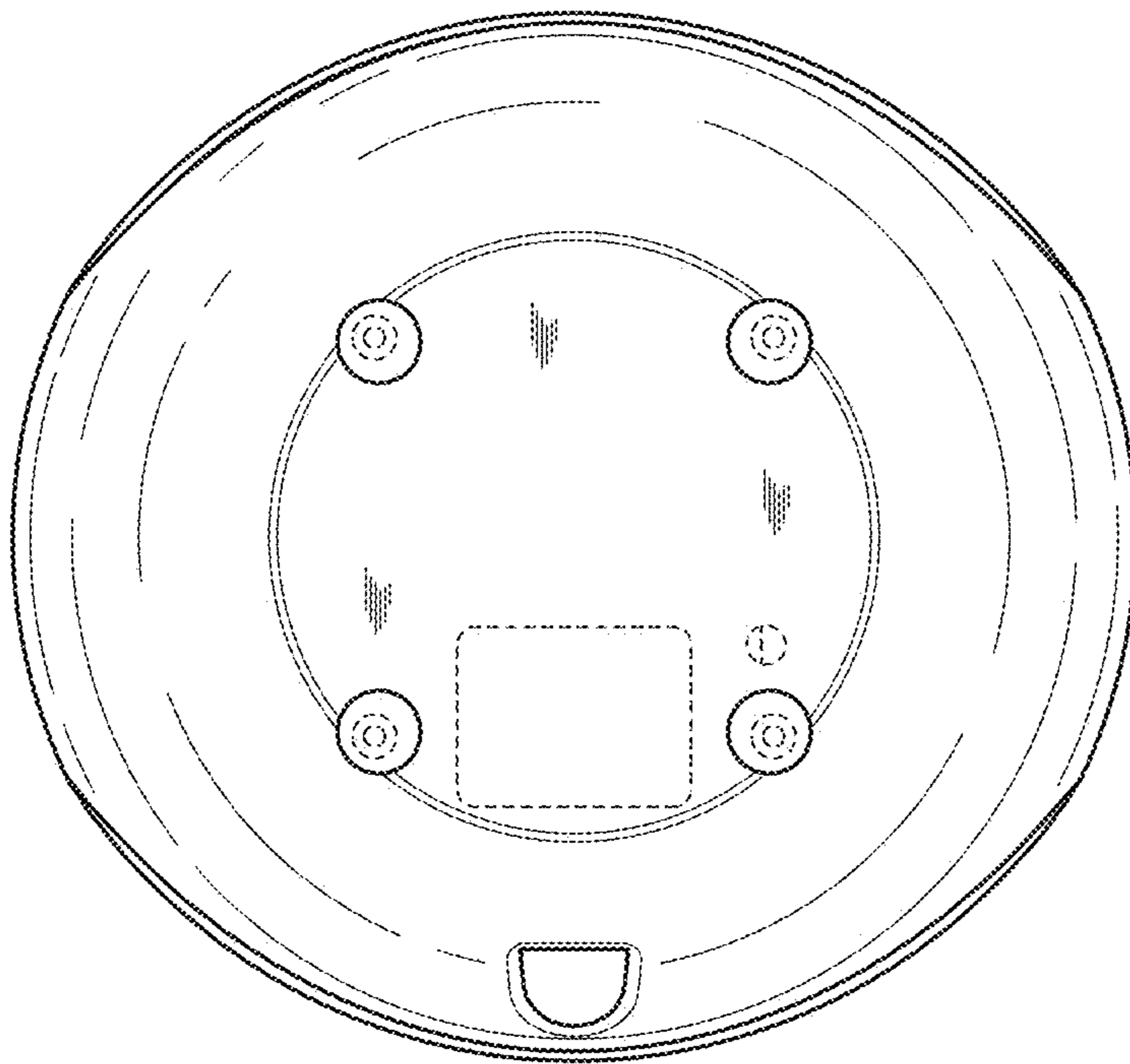

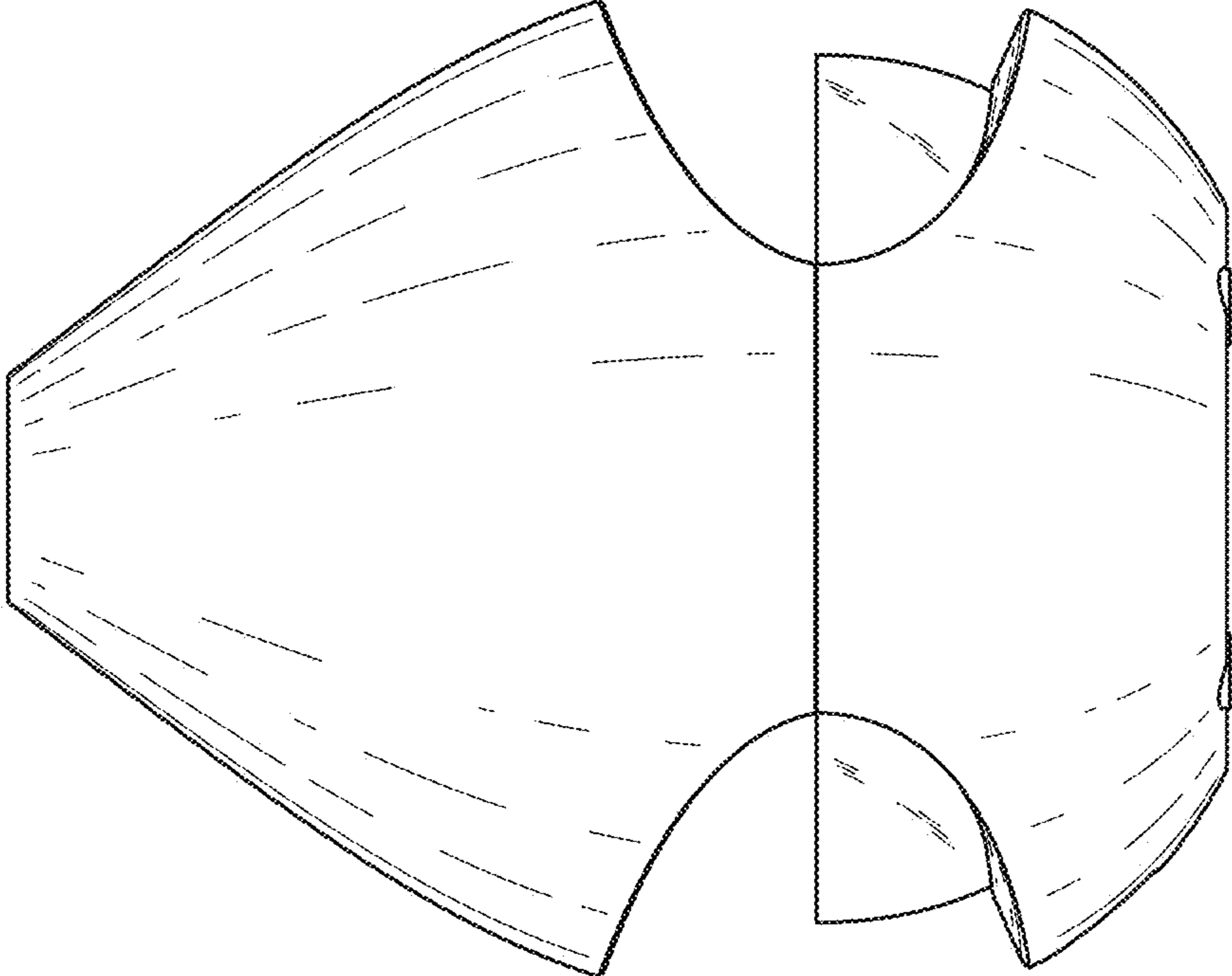

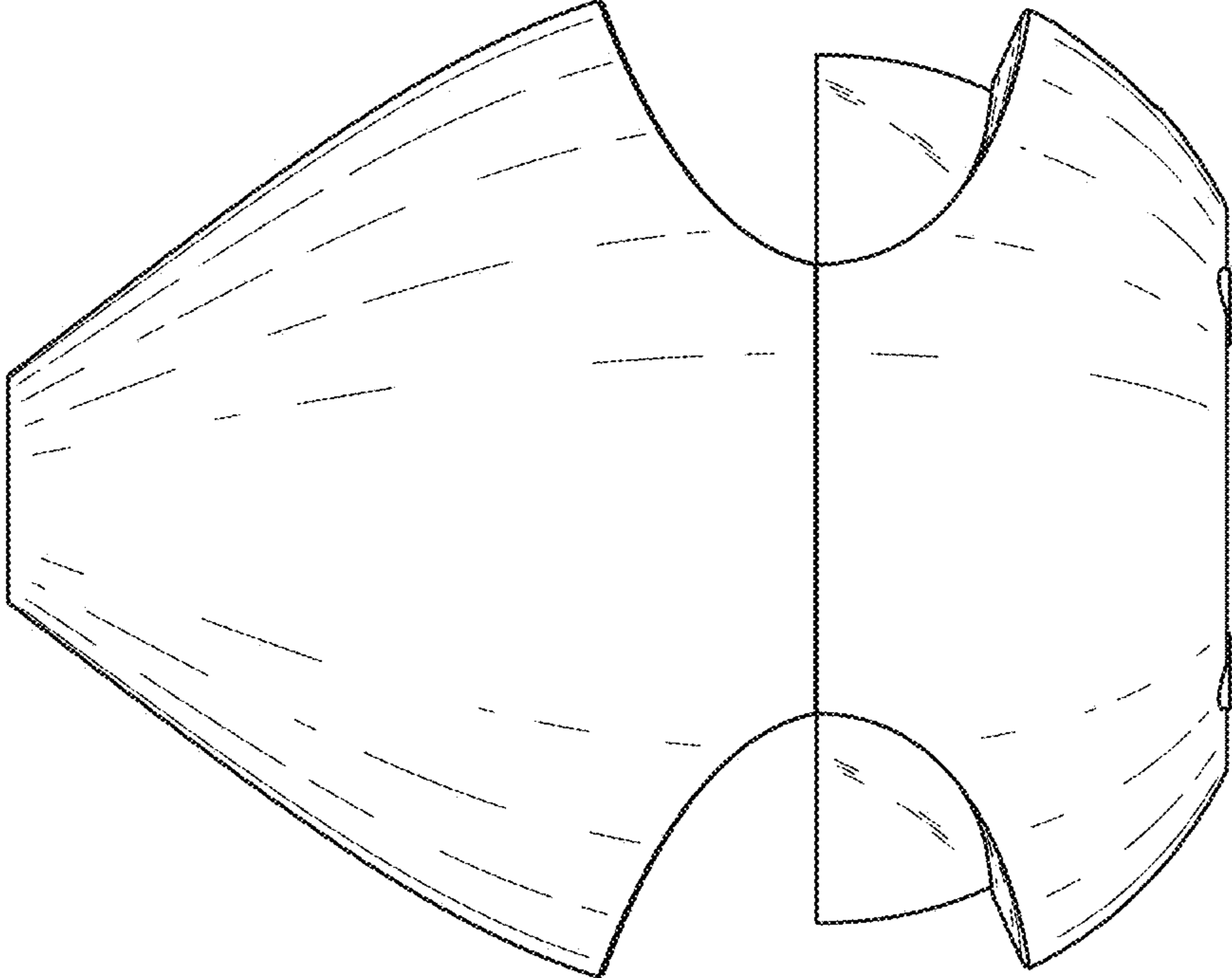

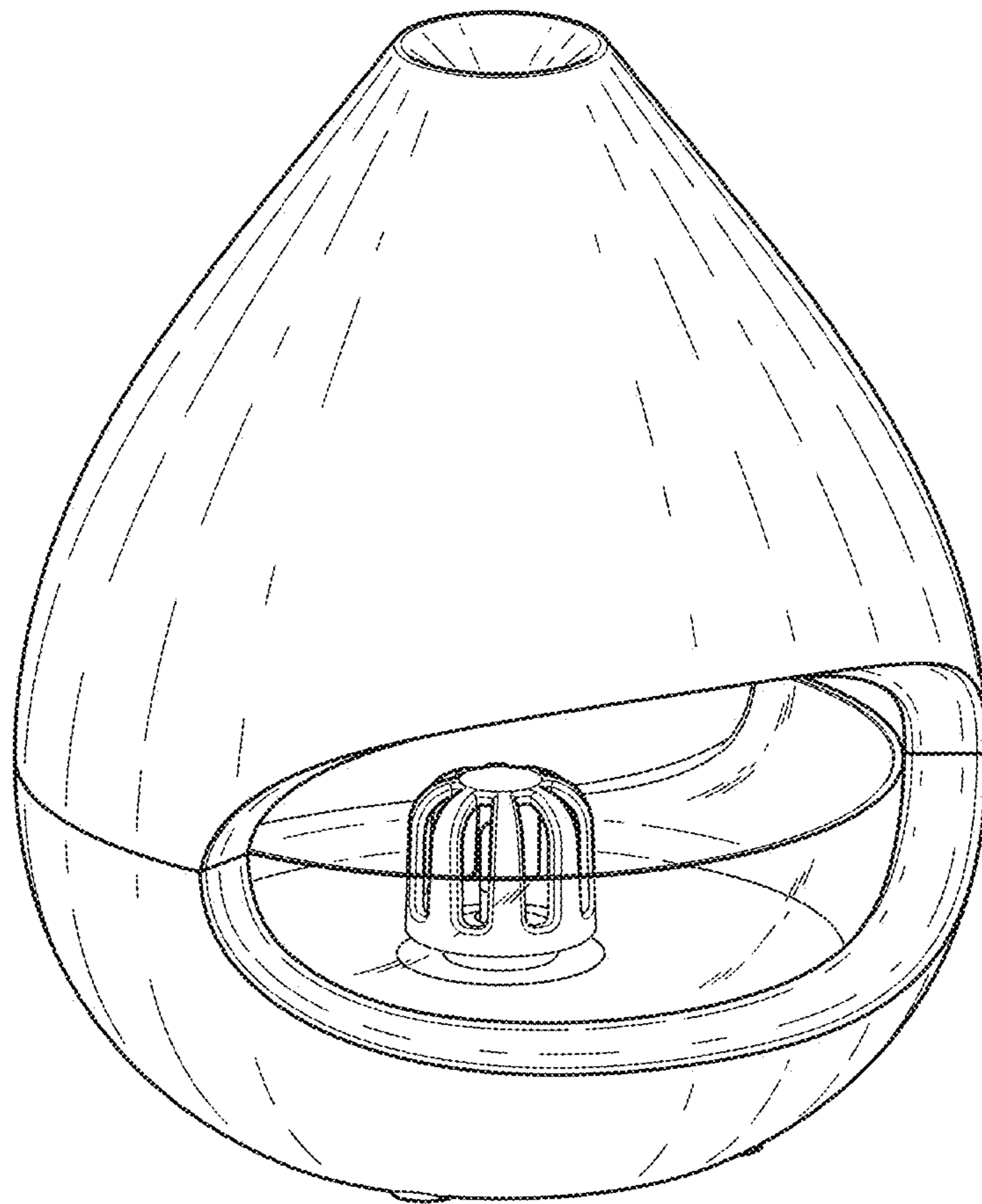
