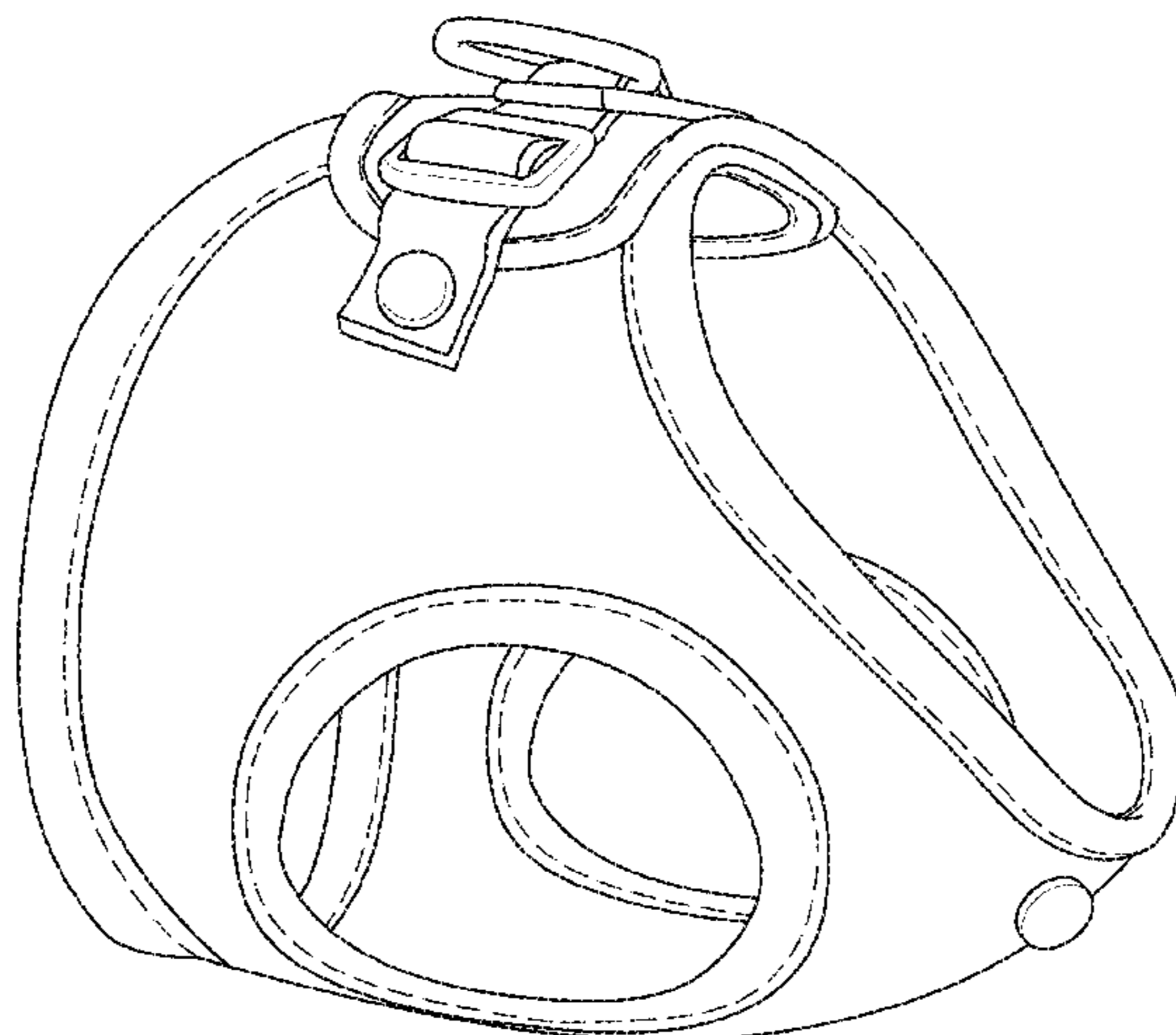
(57) **CLAIM**

The ornamental design for a dog harness having interchangeable accessories, as shown.

**DESCRIPTION**

FIG. 1 is a top, front, right perspective view of a dog harness having interchangeable accessories;  
FIG. 2 is right-side elevation view thereof;  
FIG. 3 is a left-side elevation view thereof;  
FIG. 4 is a front elevation view thereof;  
FIG. 5 is a rear elevation view thereof;  
FIG. 6 is a top plan view of the dog harness of FIG. 1, shown in a first configuration for use;  
FIG. 7 is a bottom plan view of the dog harness of FIG. 1;  
FIG. 8 is a front elevation view of the dog harness of FIG. 1, shown in a second configuration for use; and,  
FIG. 9 is a front elevation view of the dog harness of FIG. 1, shown in a second configuration for use.  
The broken lines showing accessories in FIGS. 6, 8, and 9 depict environmental subject matter only and form no part of the claimed design. The broken lines on the harness depict stitching and form no part of the claimed design.

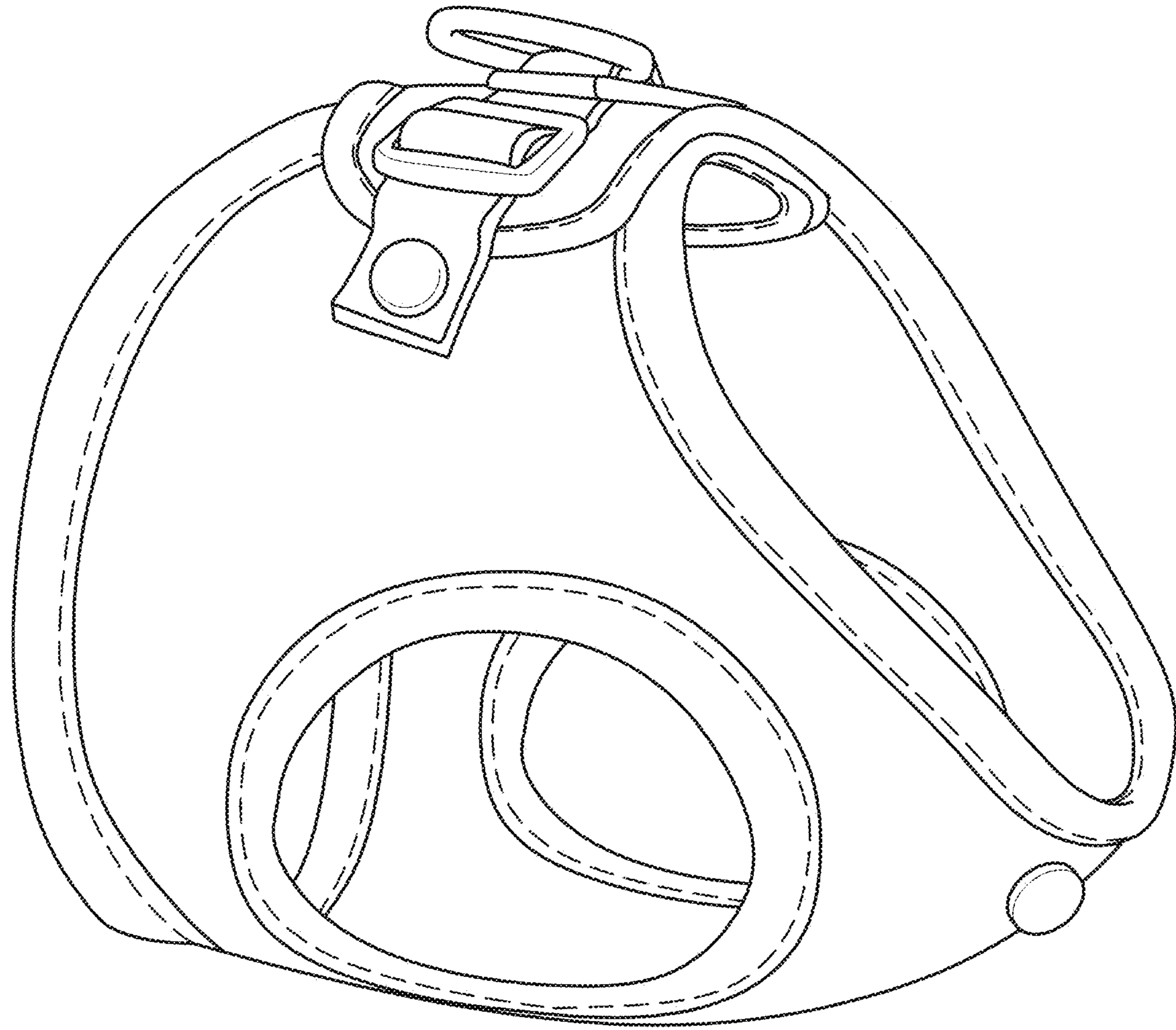

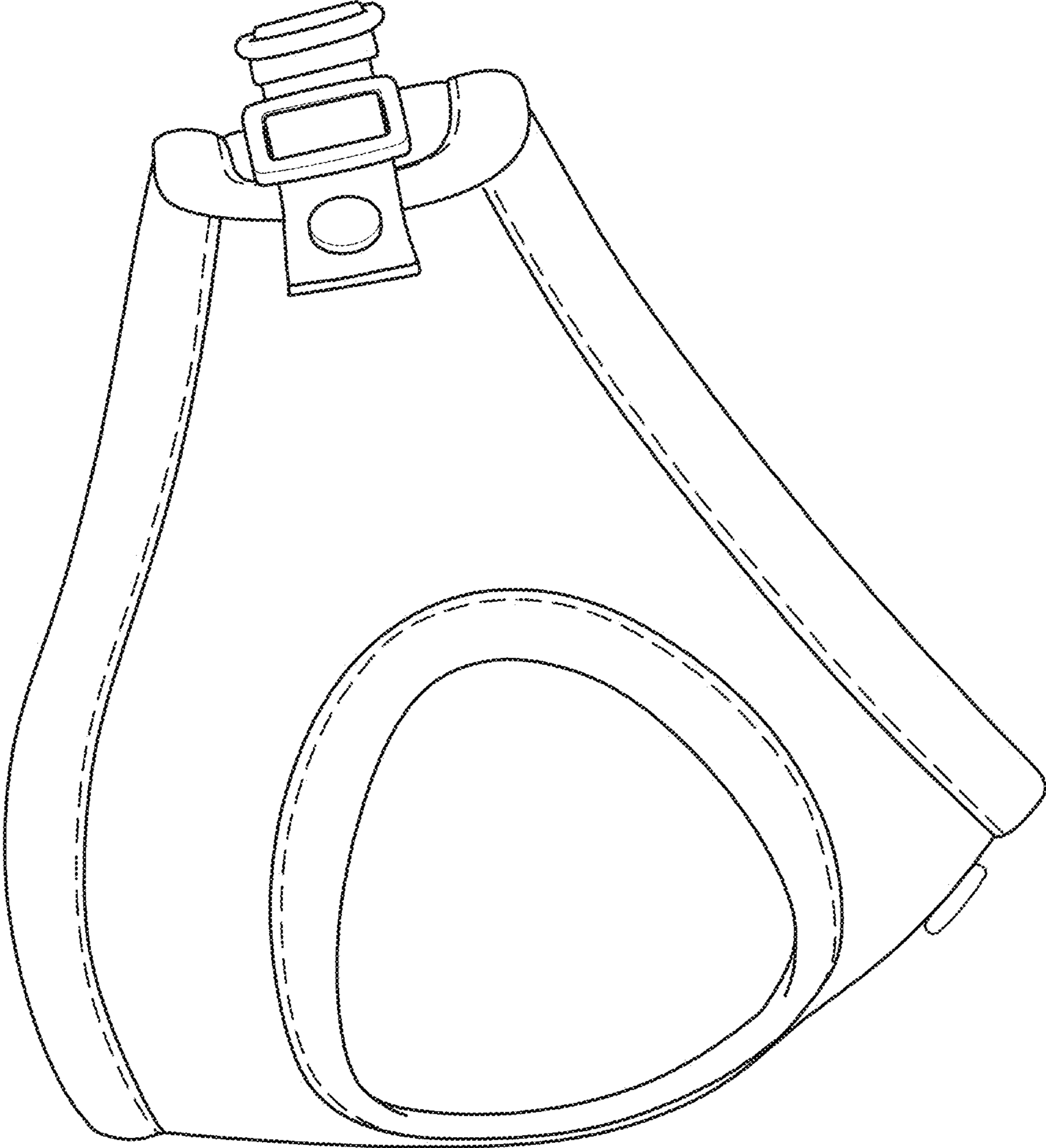

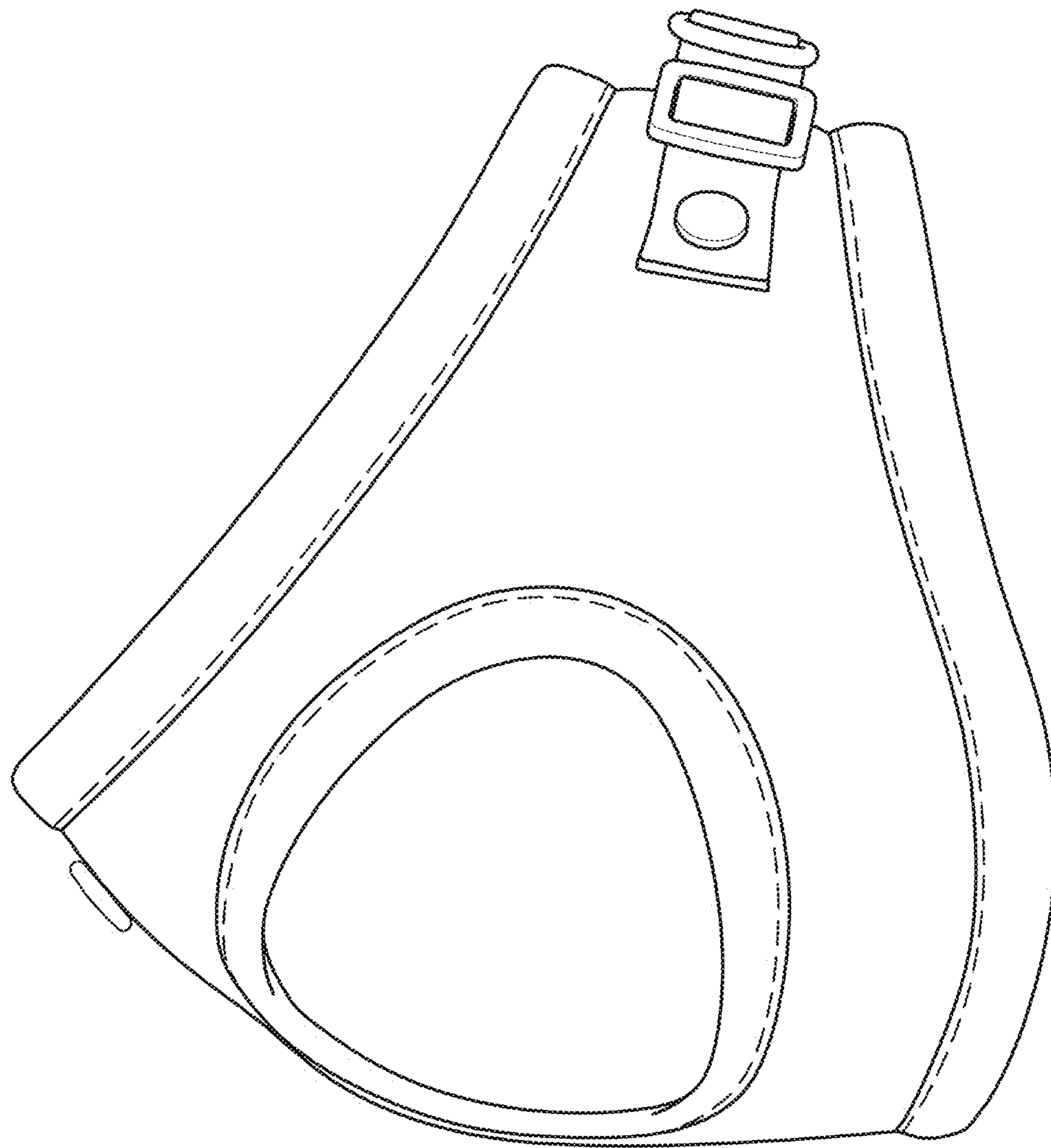

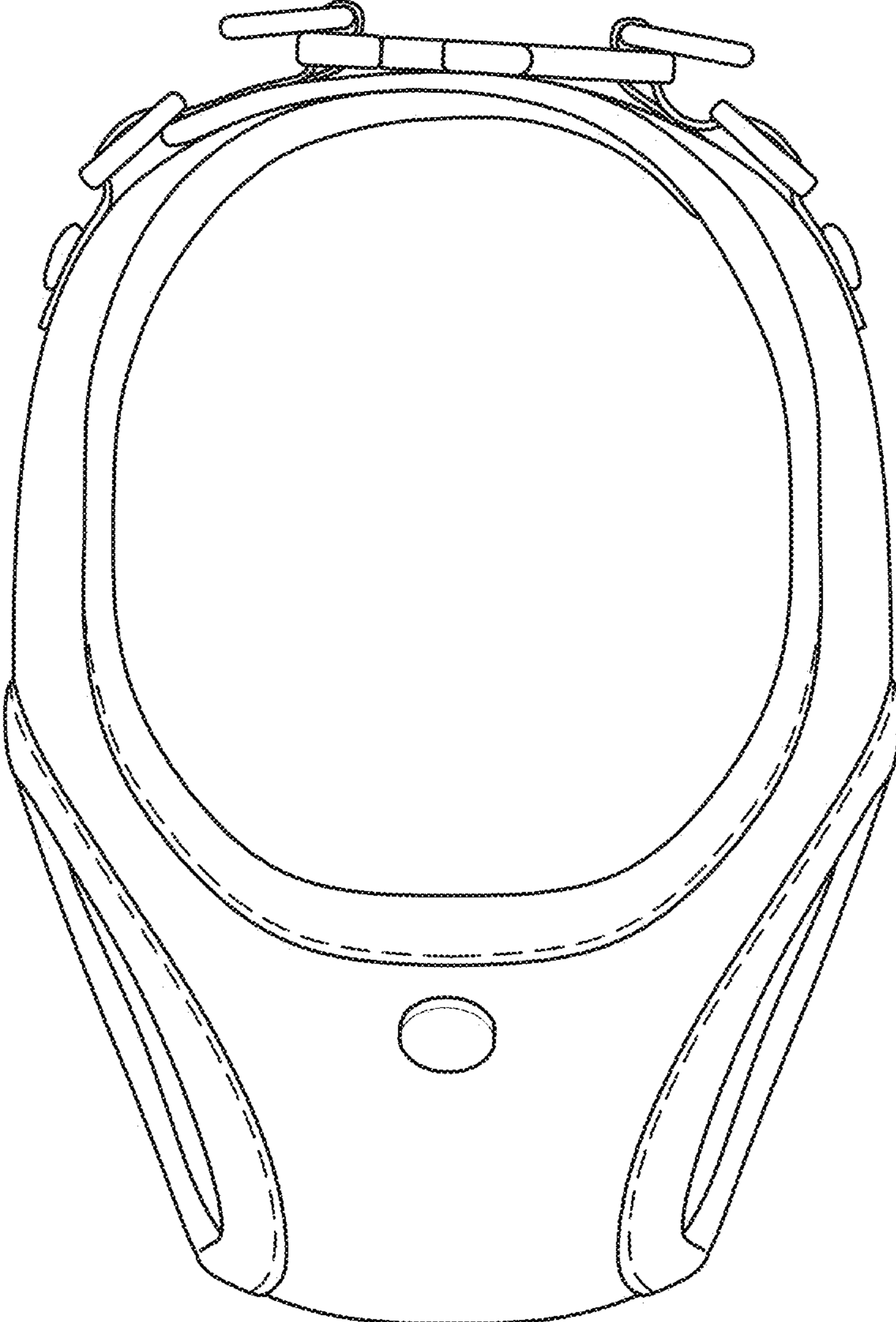

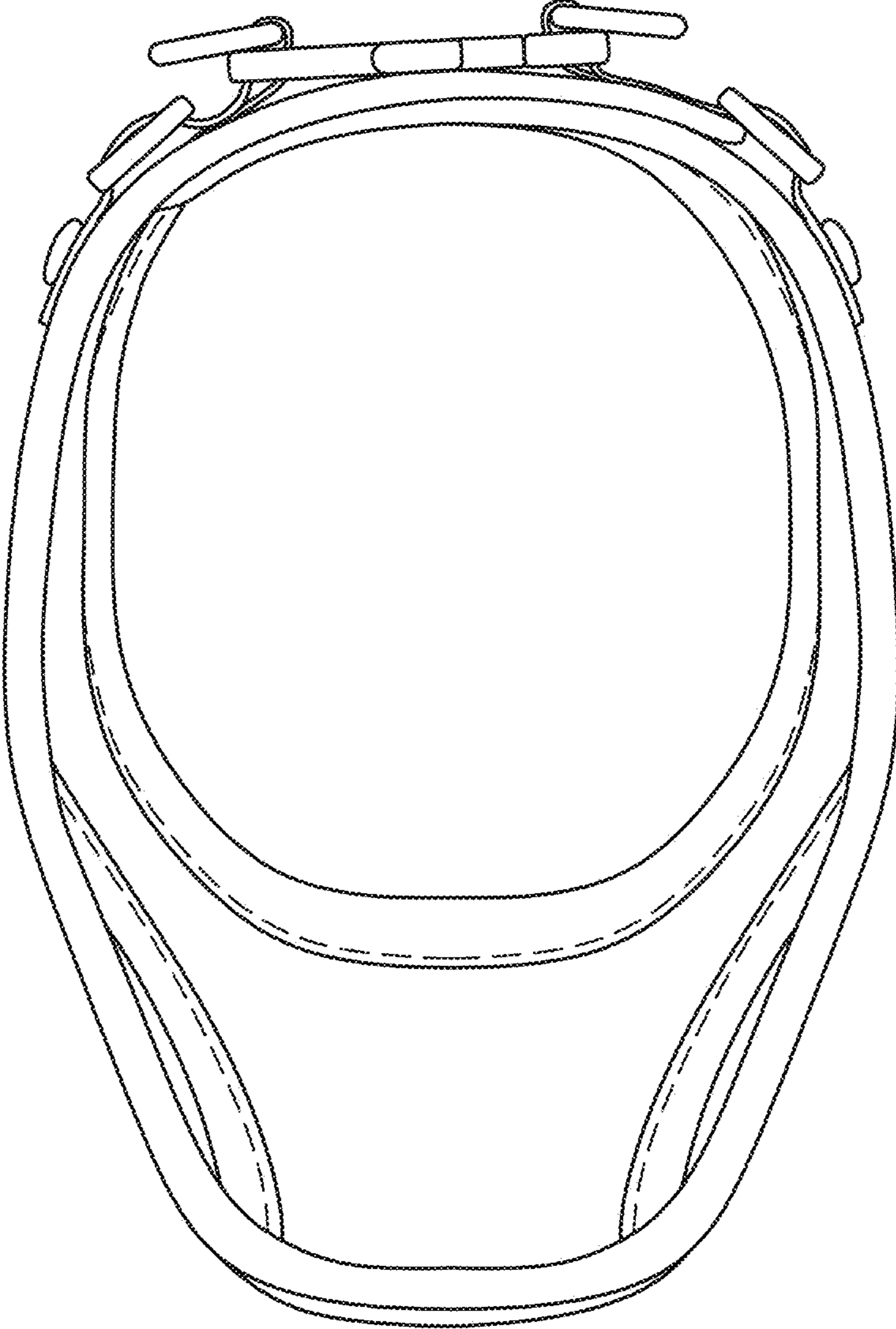

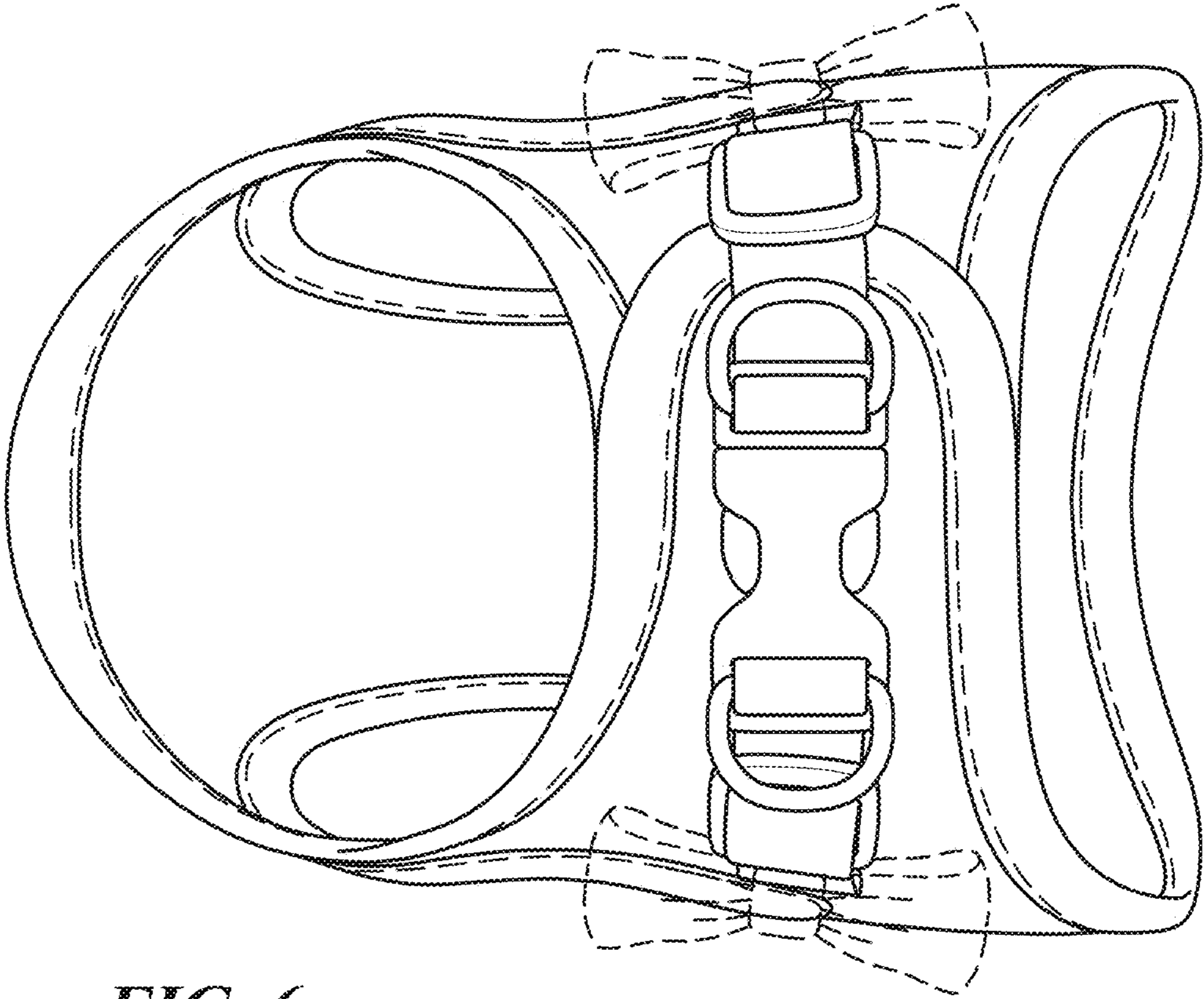

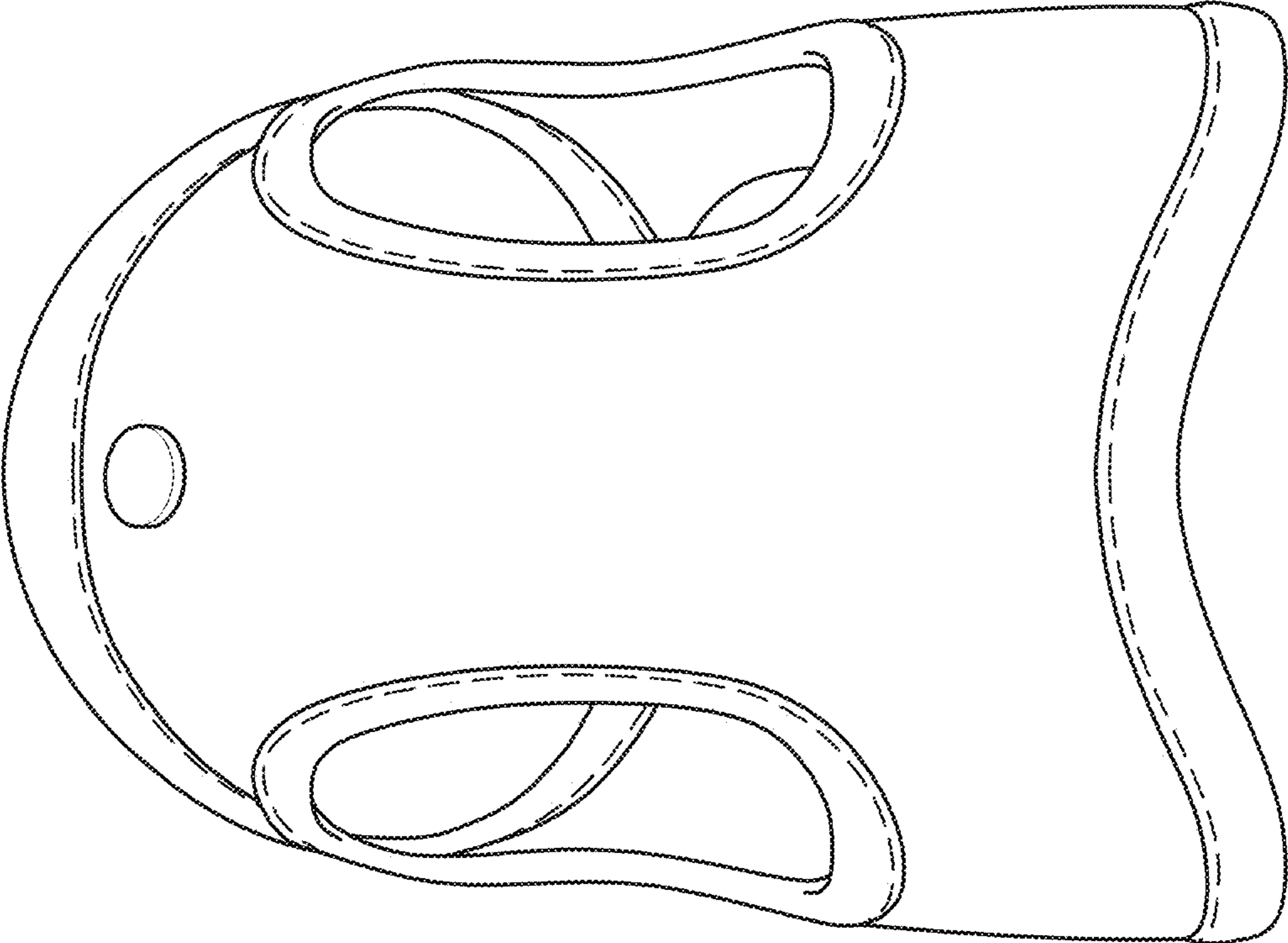

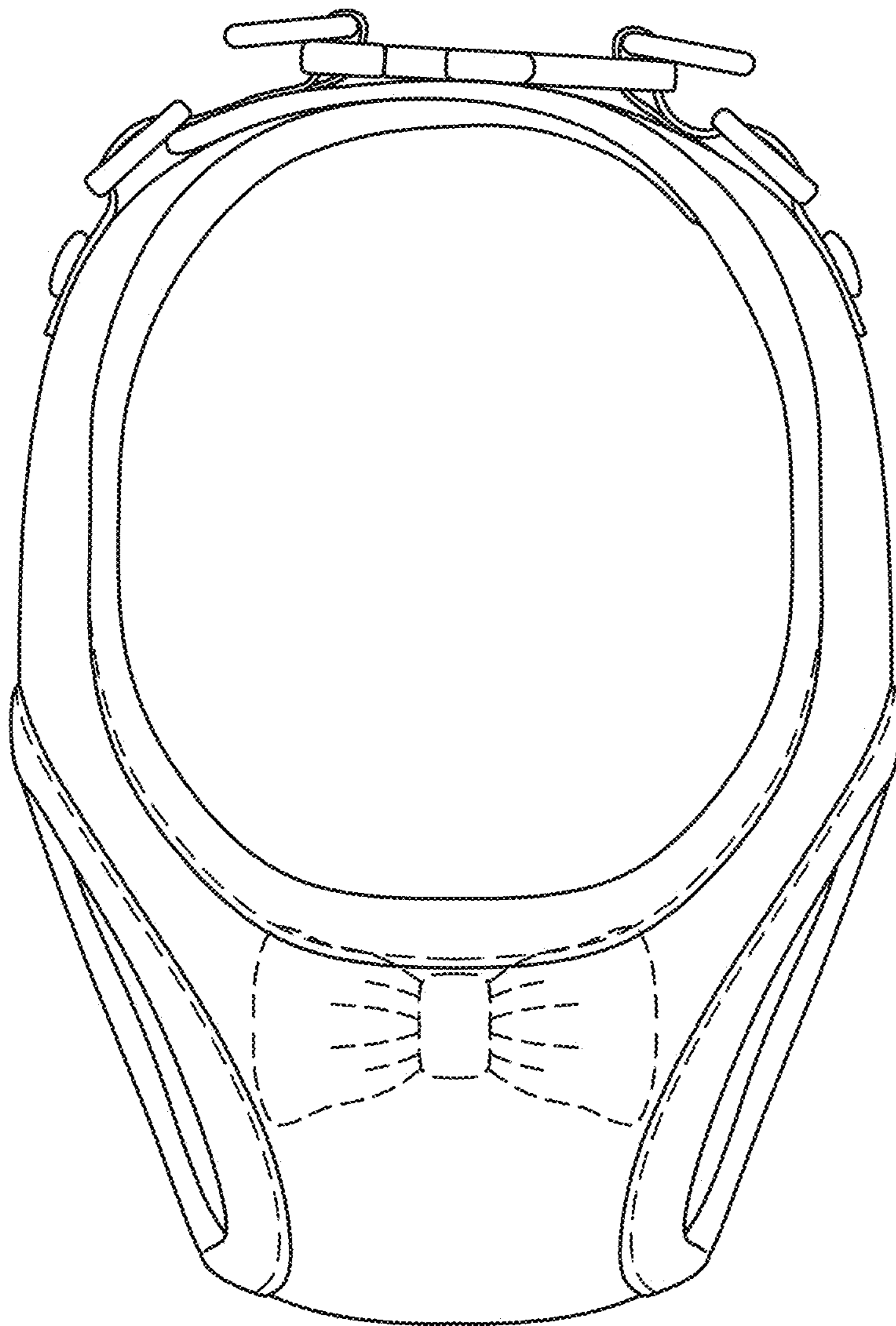

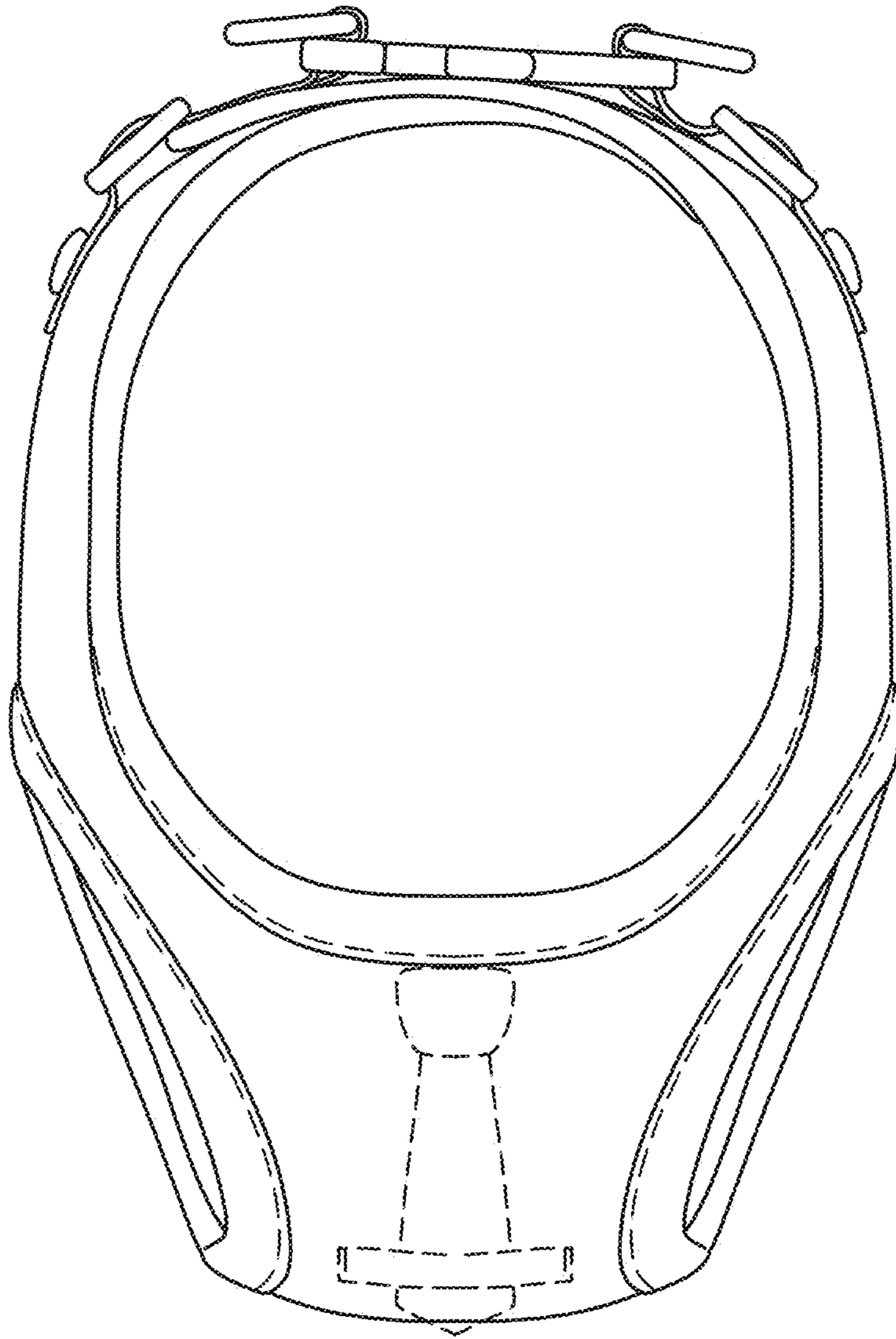
