DESCRIPTION

1. Parasol

1.3 is a side view thereof, in a partially opened condition of use;

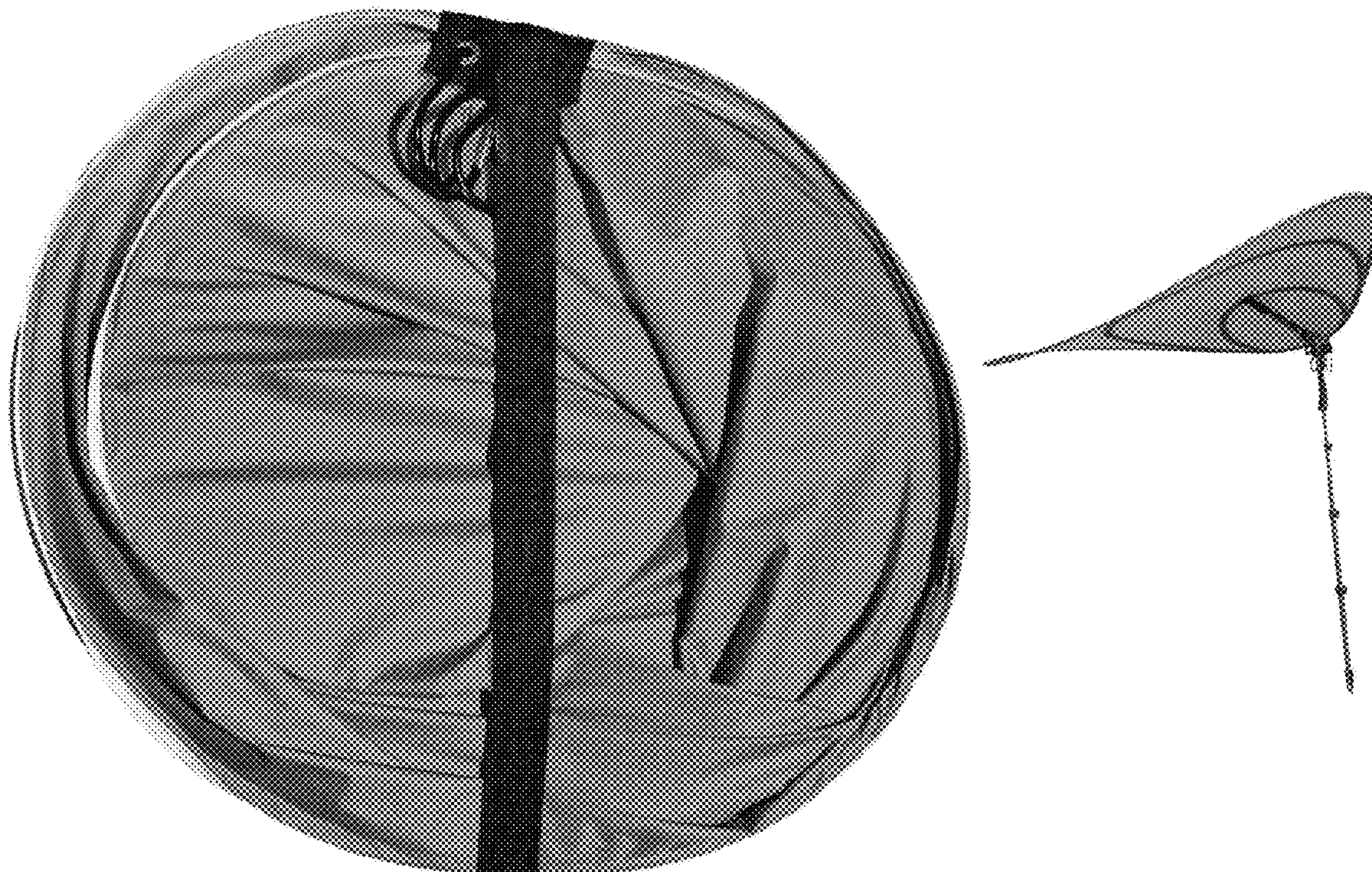
1.4 is a perspective view thereof, in a fully opened condition of use;

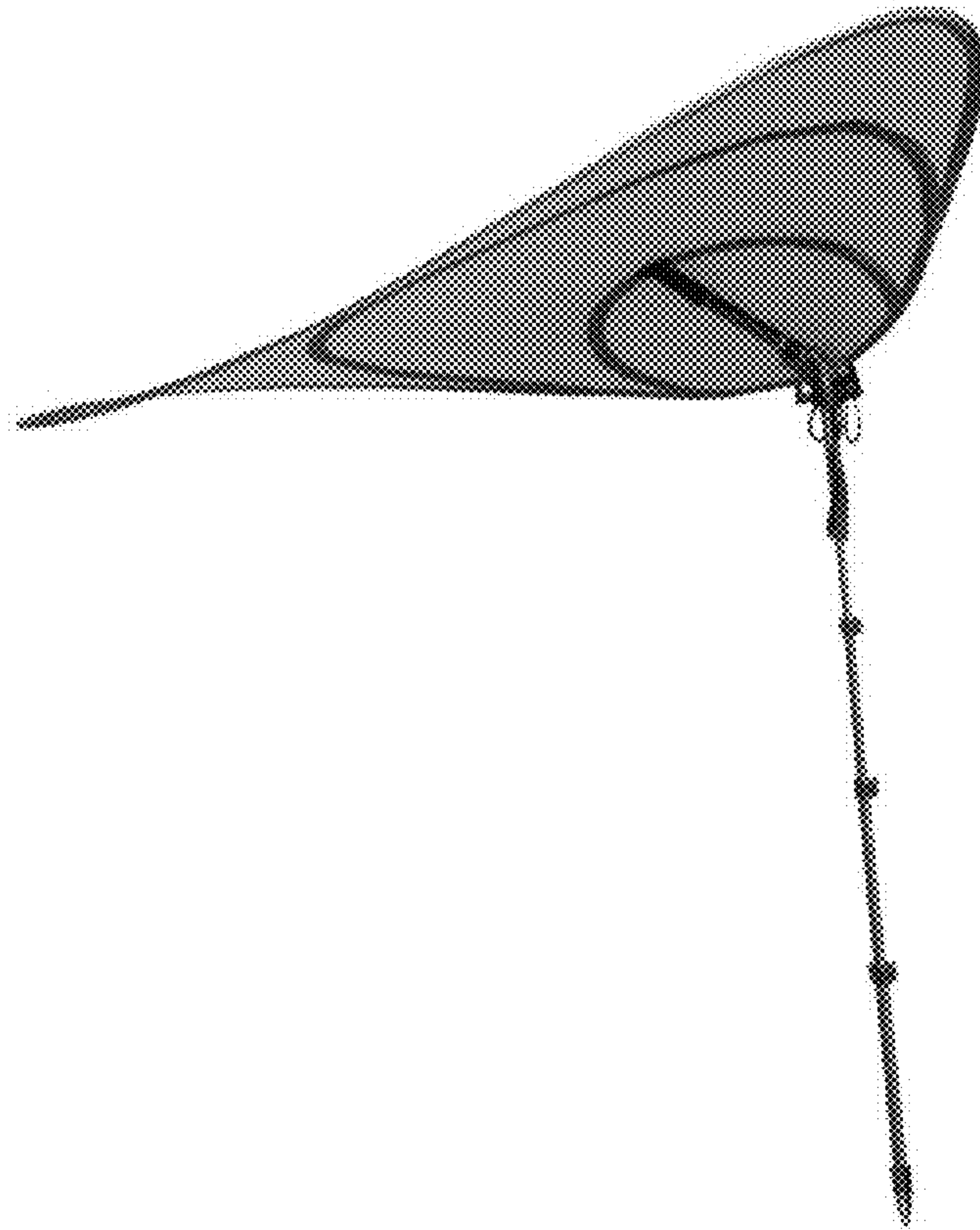

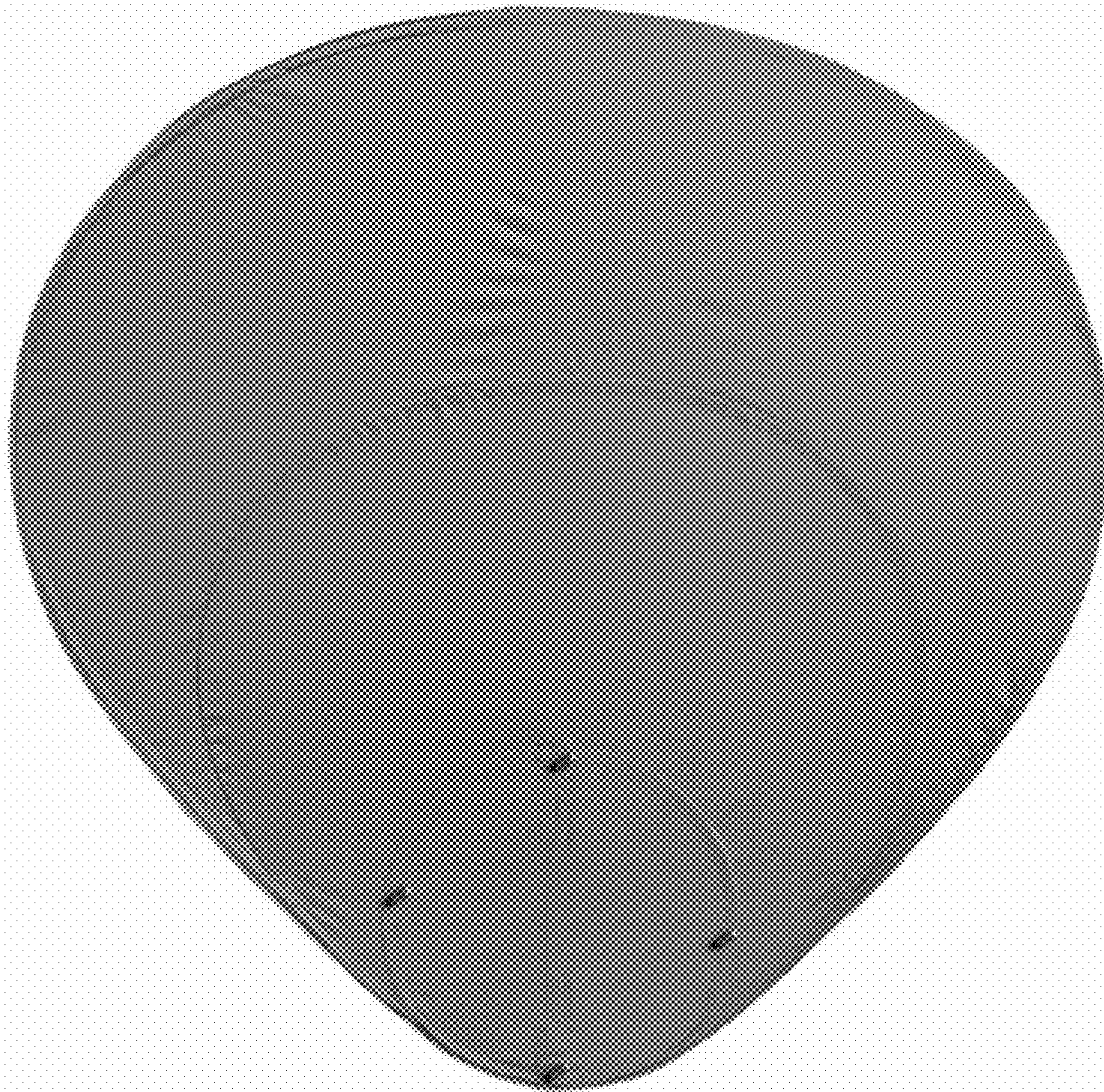
