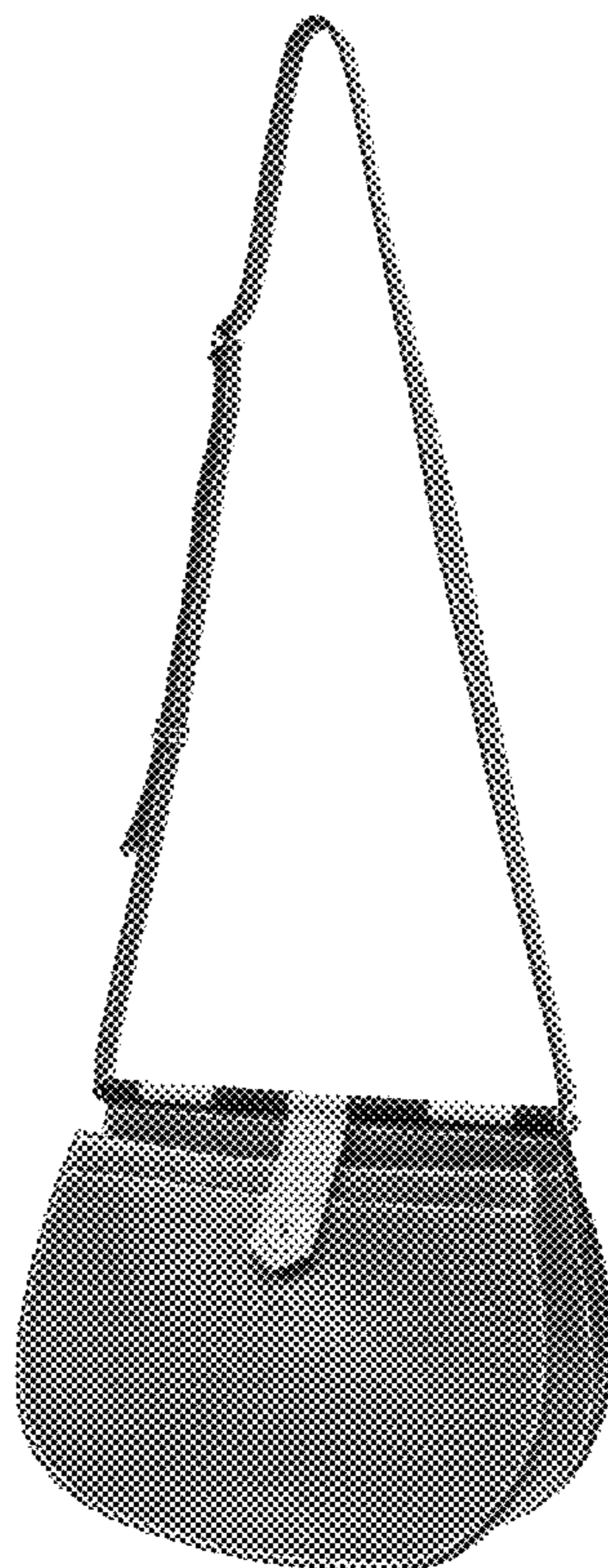

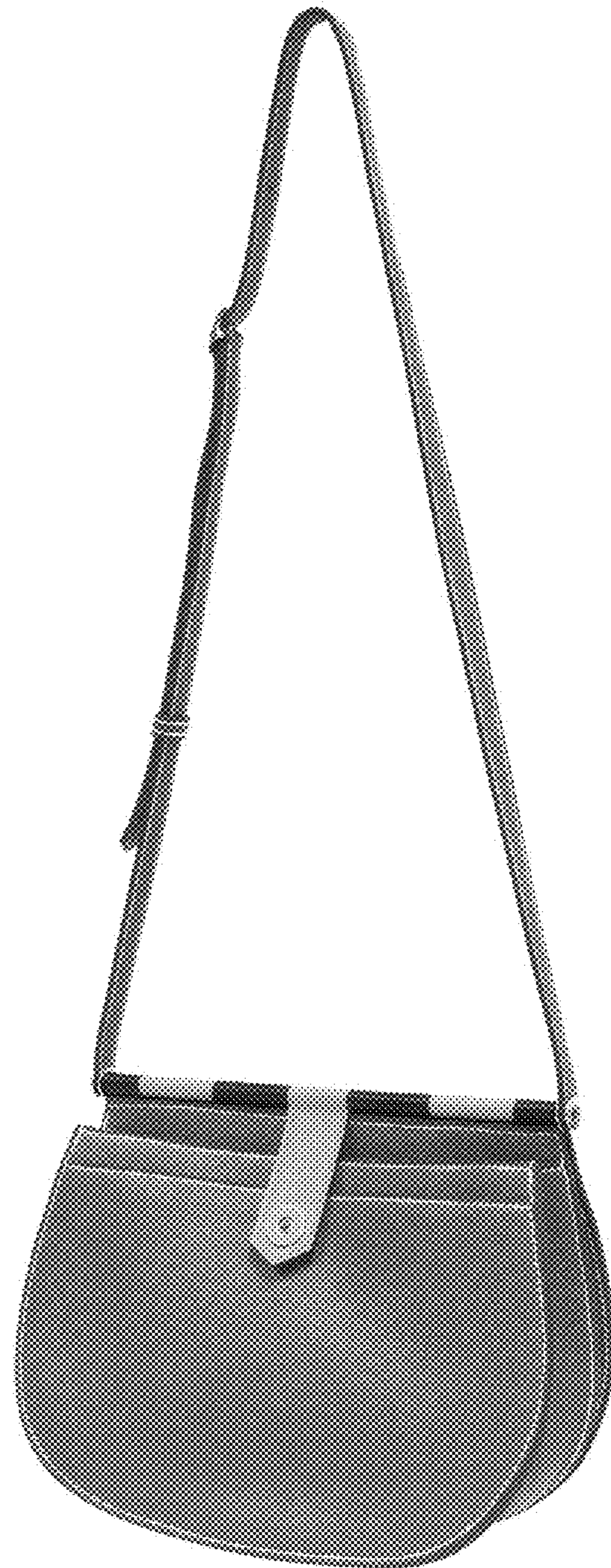

The dashed lines in the drawings depict thread stitching and forms part of the claimed design.

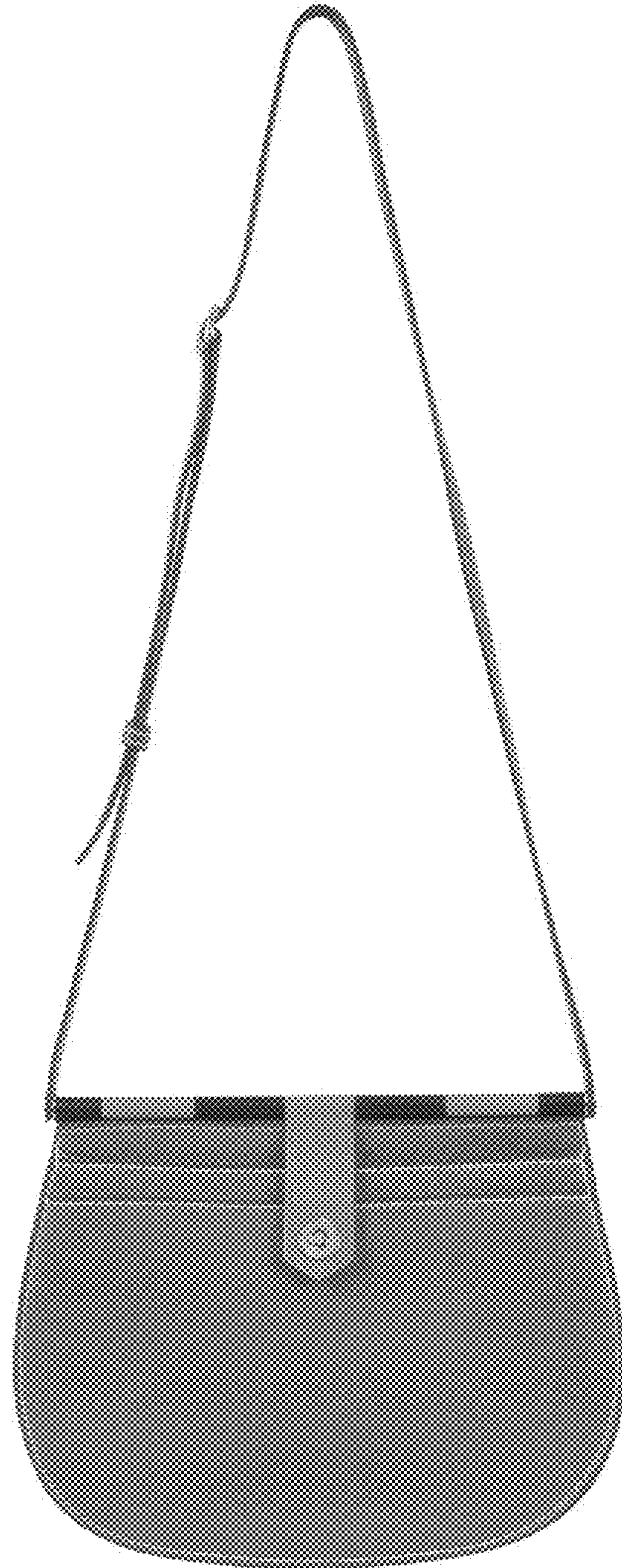

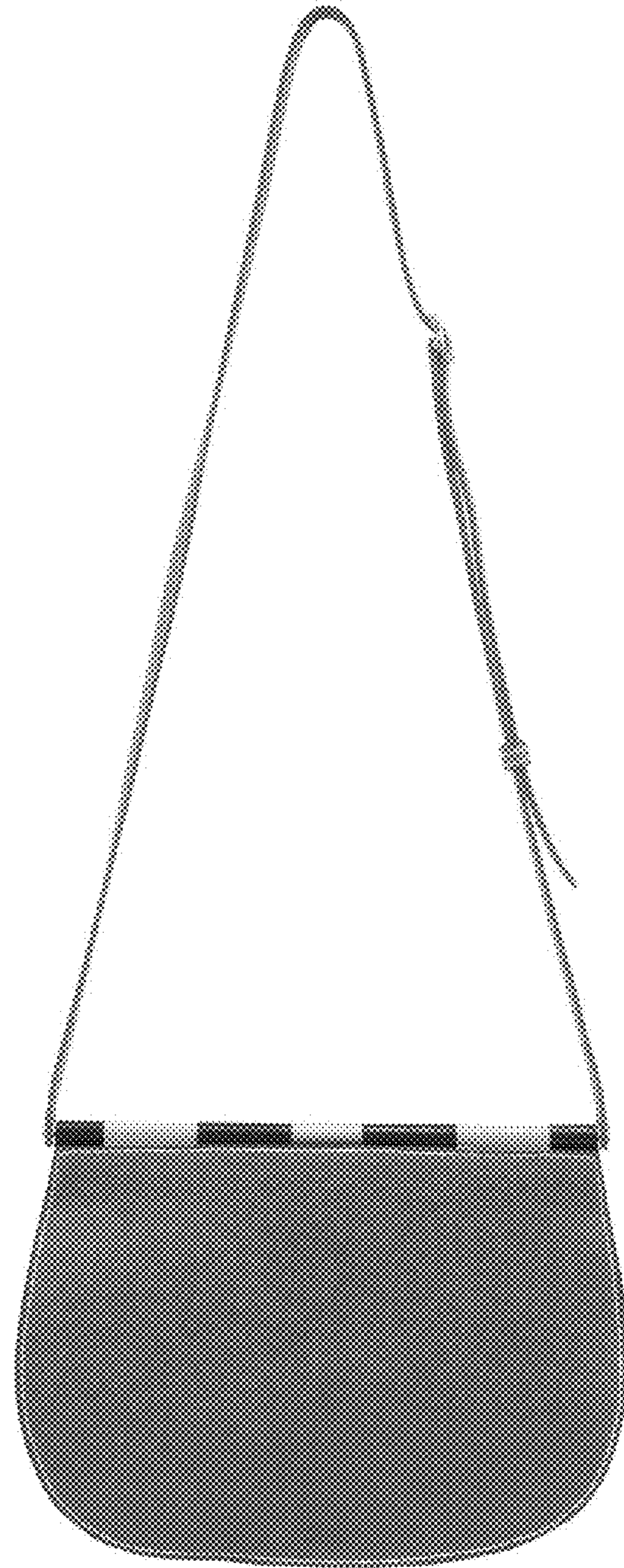

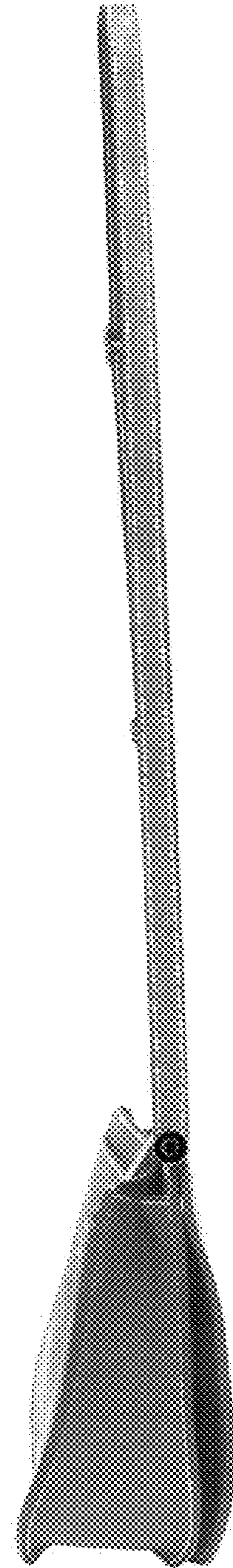

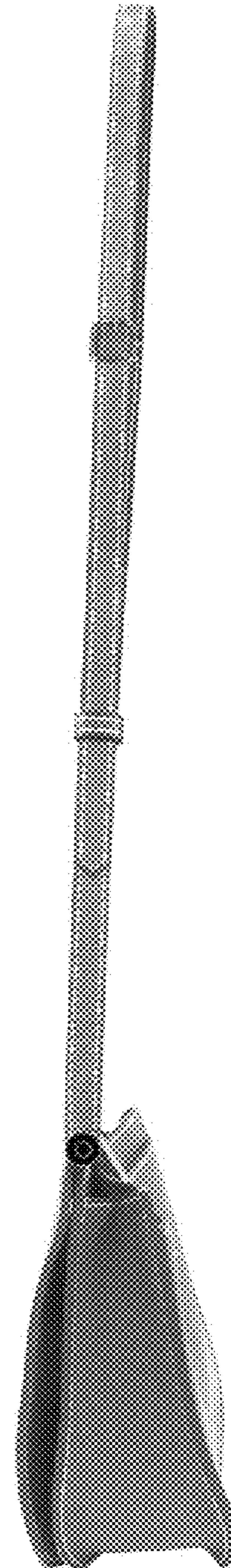

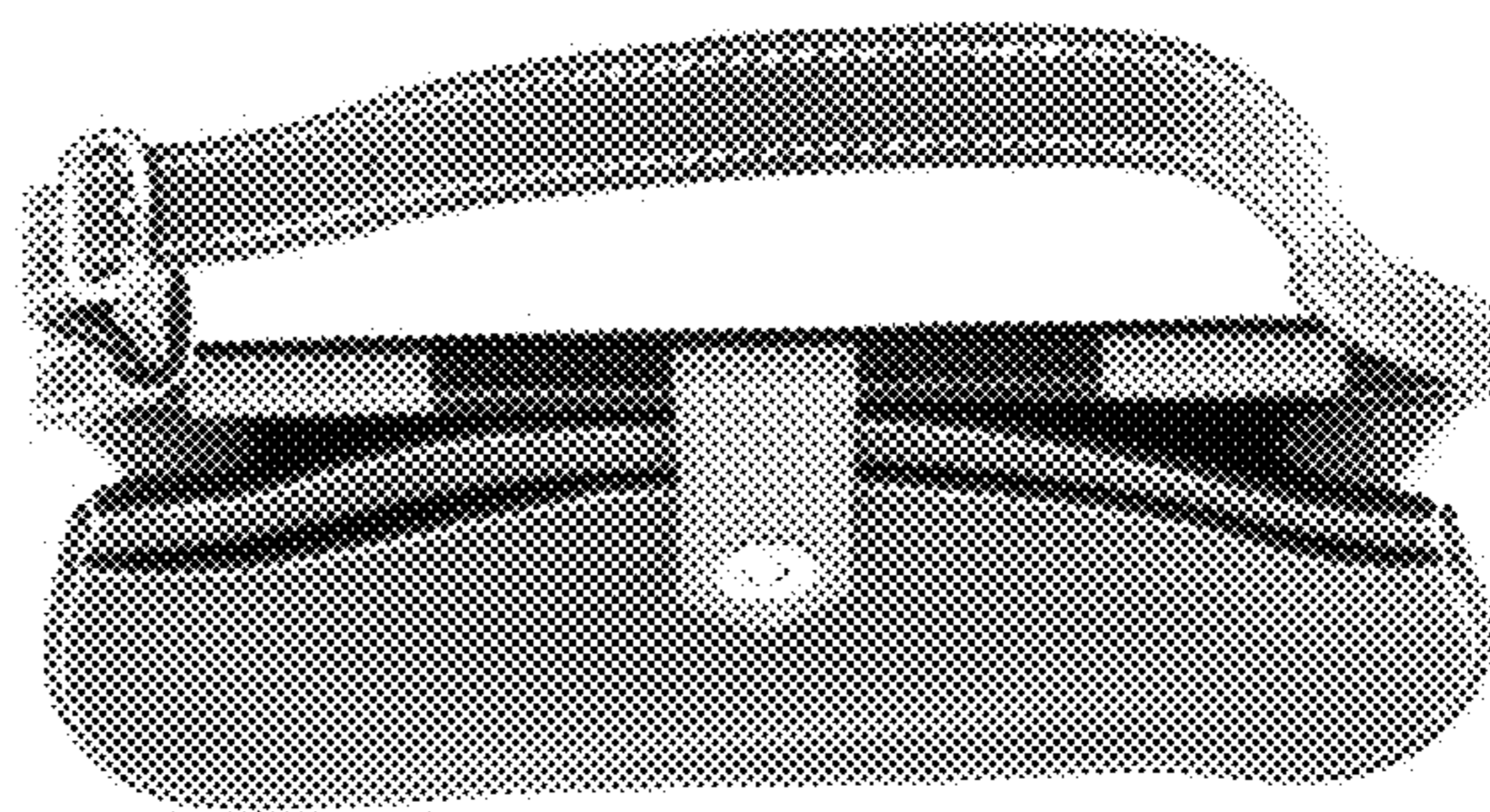

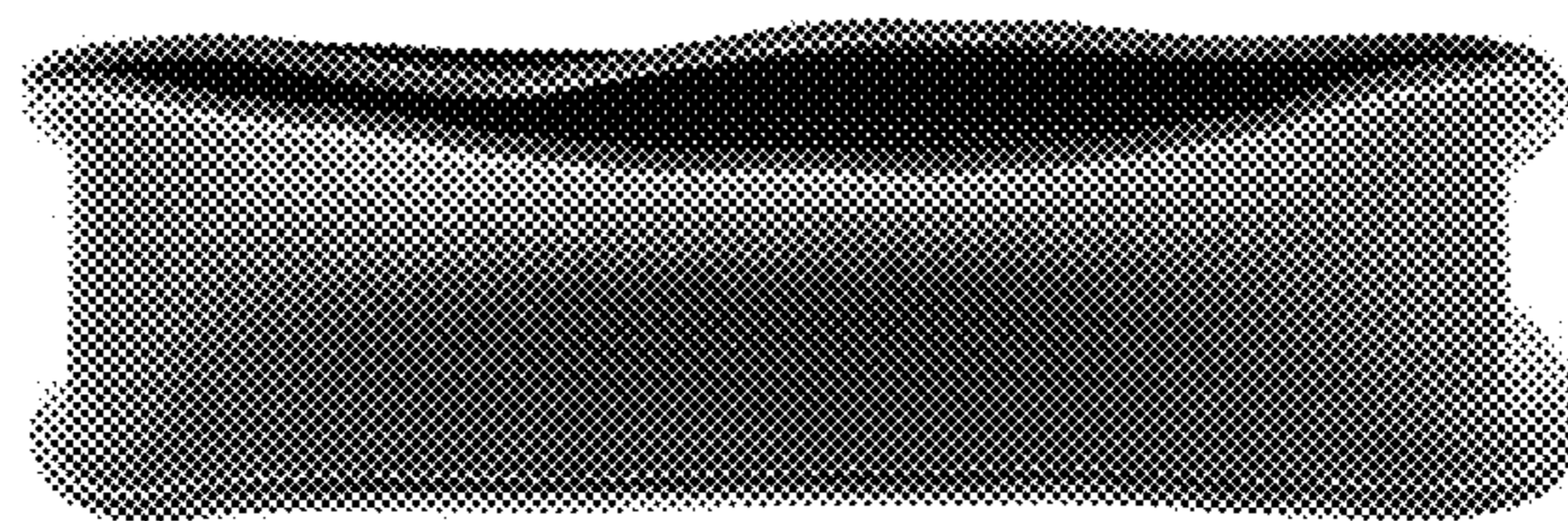
