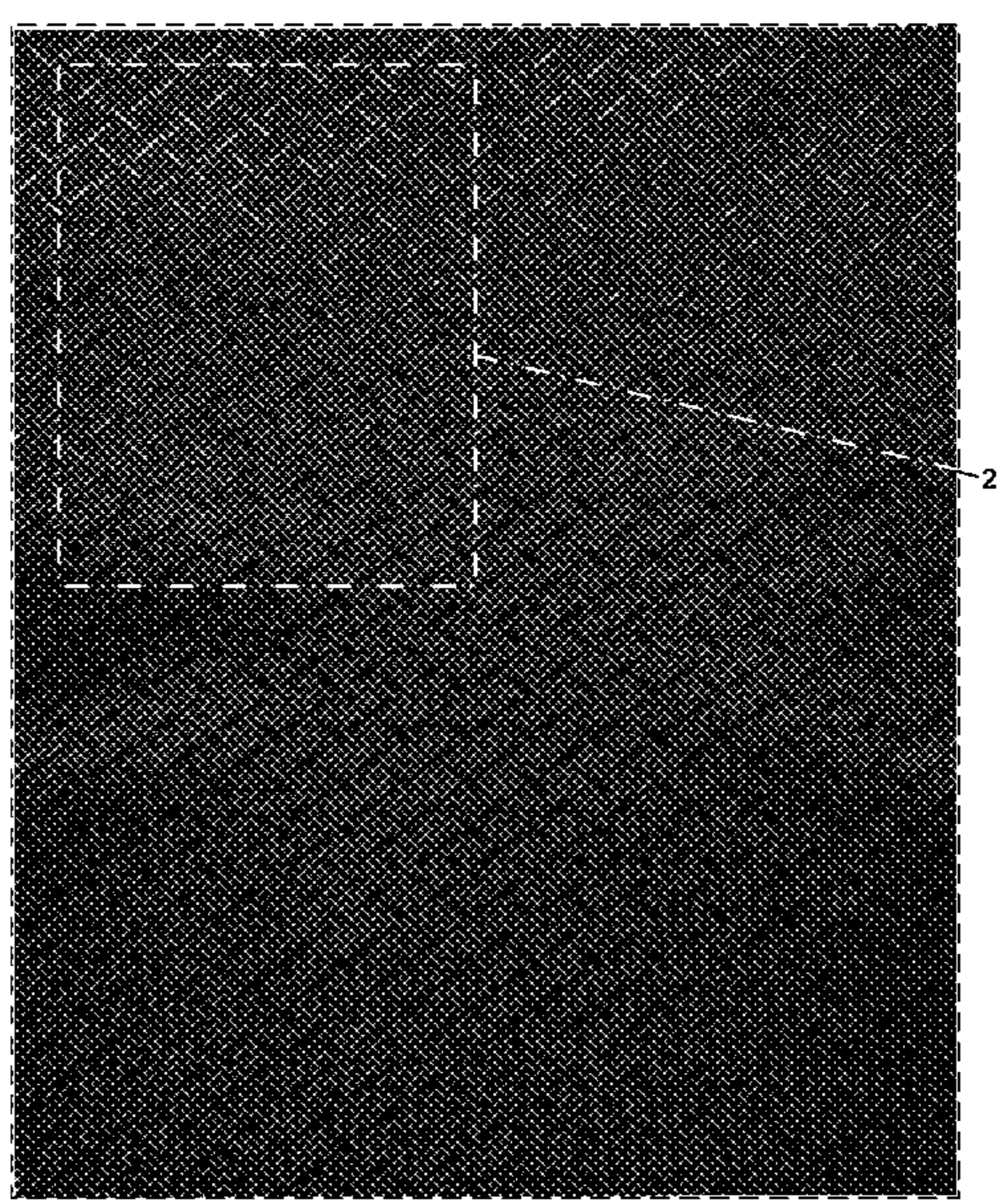
(57) **CLAIM**

The ornamental design for woven fabric, as shown and described.

DESCRIPTION

FIG. 1 is a plan view of a woven fabric embodying the new design; and, FIG. 2 is an enlarged detail view of area 2 circumscribed within FIG. 1. The dot dash dot broken lines within FIG. 1 and surrounding FIG. 2 denote the boundaries of the details and form no part of the claimed design. The evenly spaced broken lines surrounding FIG. 1 depict portions of the woven fabric that form no part of the claimed design.

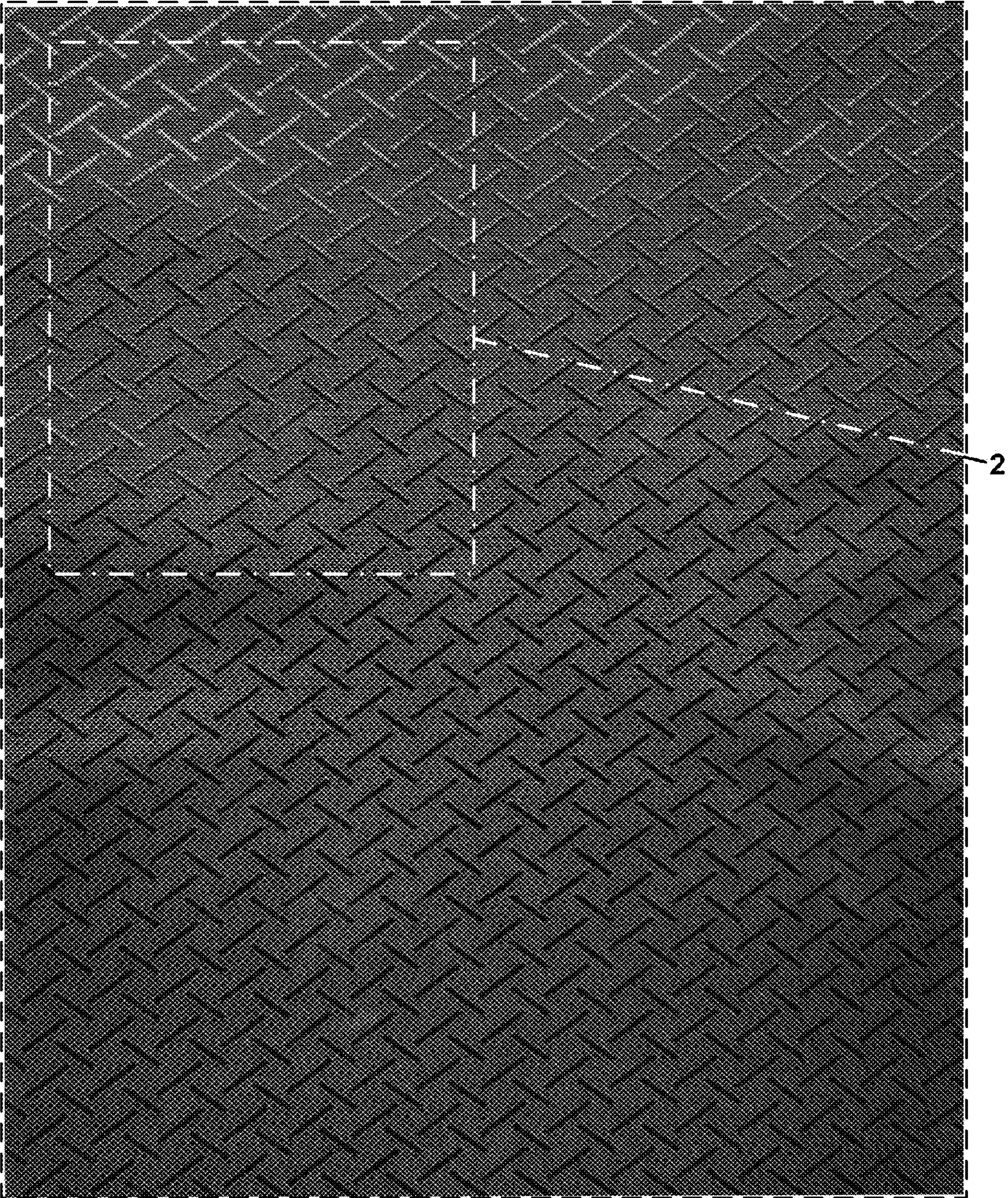

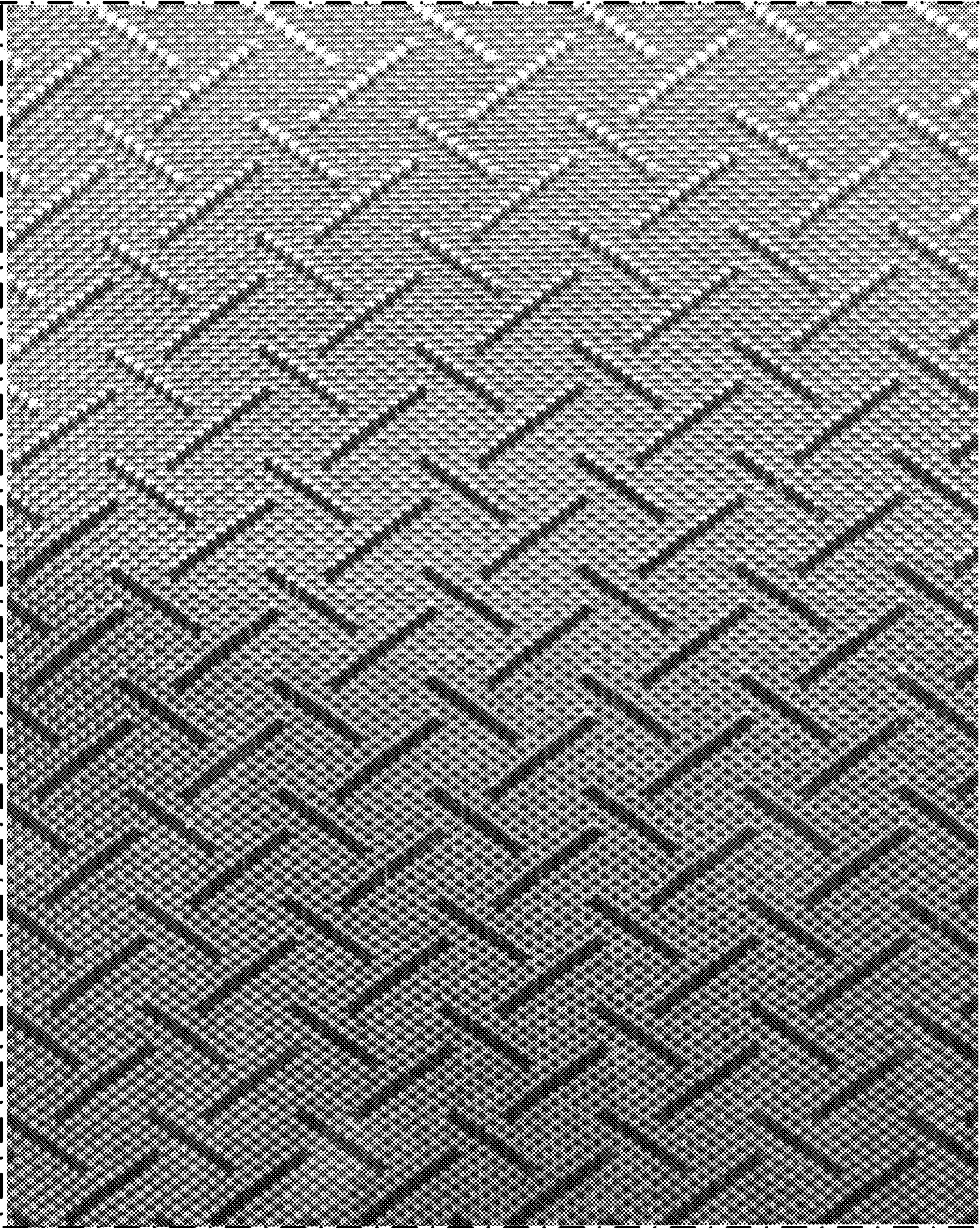
