(57) **CLAIM**

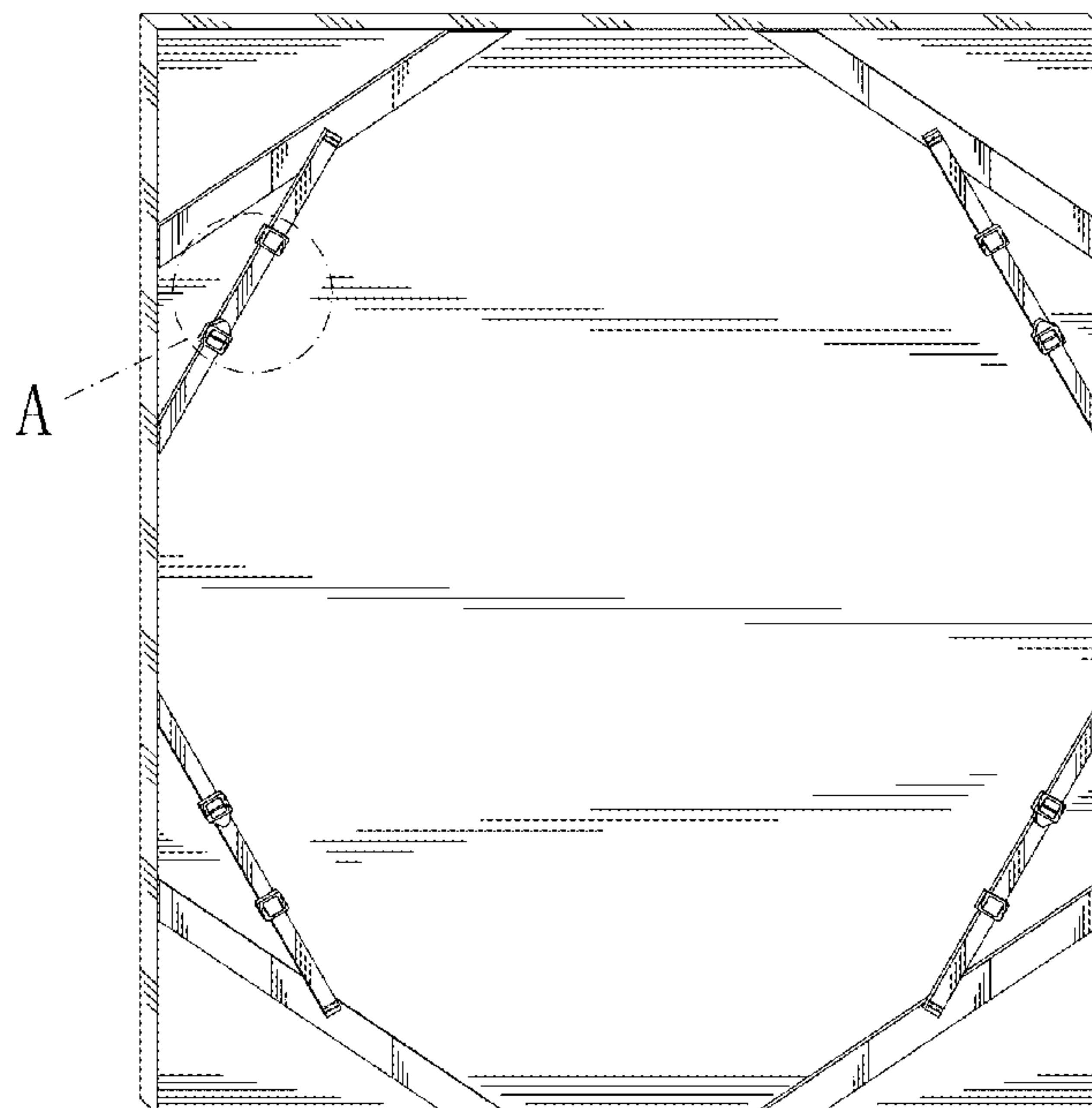
The ornamental design for a mattress cover fastening belt system, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a mattress cover fastening belt system showing the new design; FIG. 2 is a front view thereof; FIG. 3 is a rear view thereof; FIG. 4 is a left view thereof; FIG. 5 is a right view thereof; FIG. 6 is a top view thereof; FIG. 7 is a bottom view thereof; and, FIG. 8 is a partial enlarged view of the area indicated by "A" in FIG. 1.

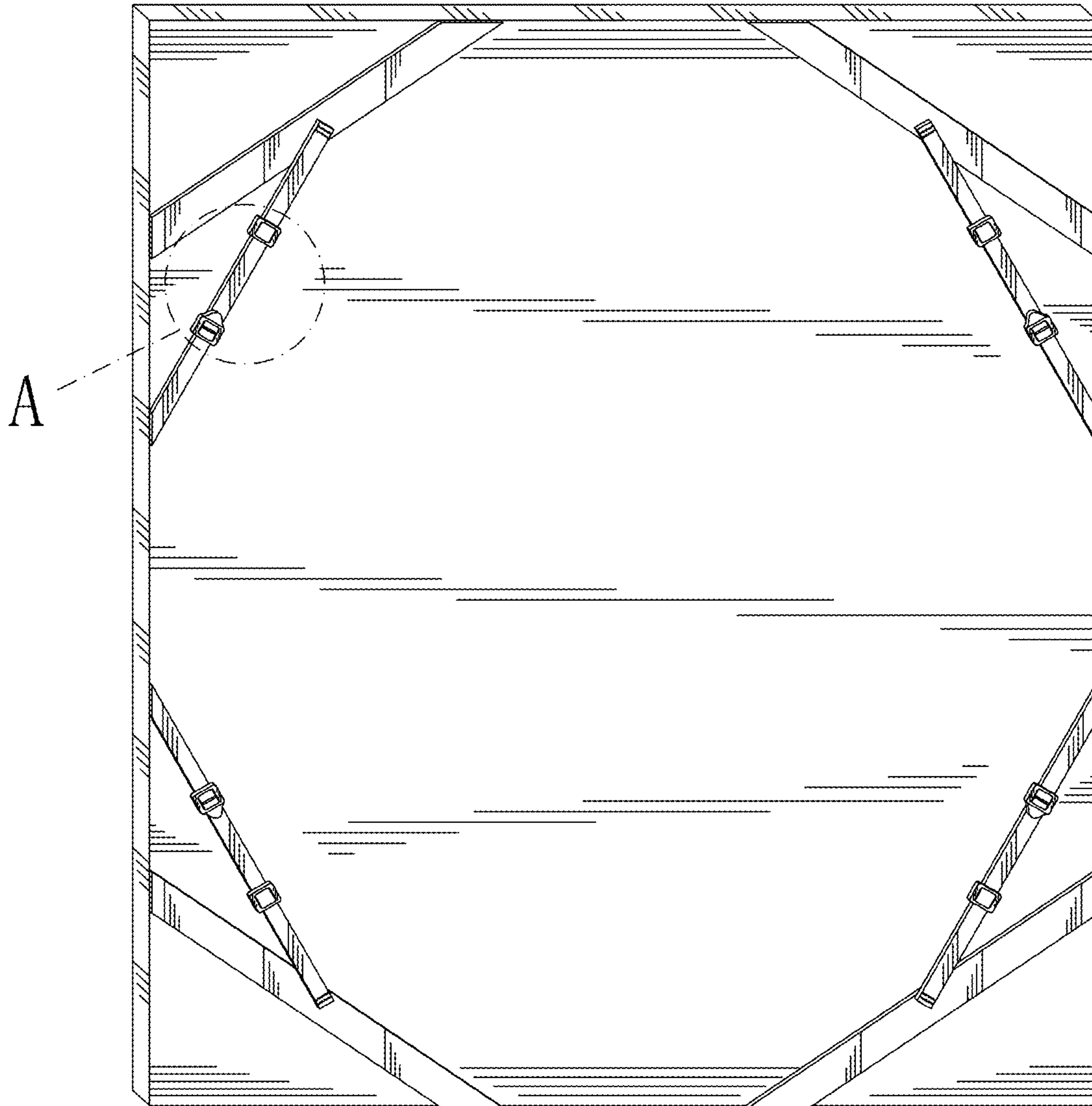

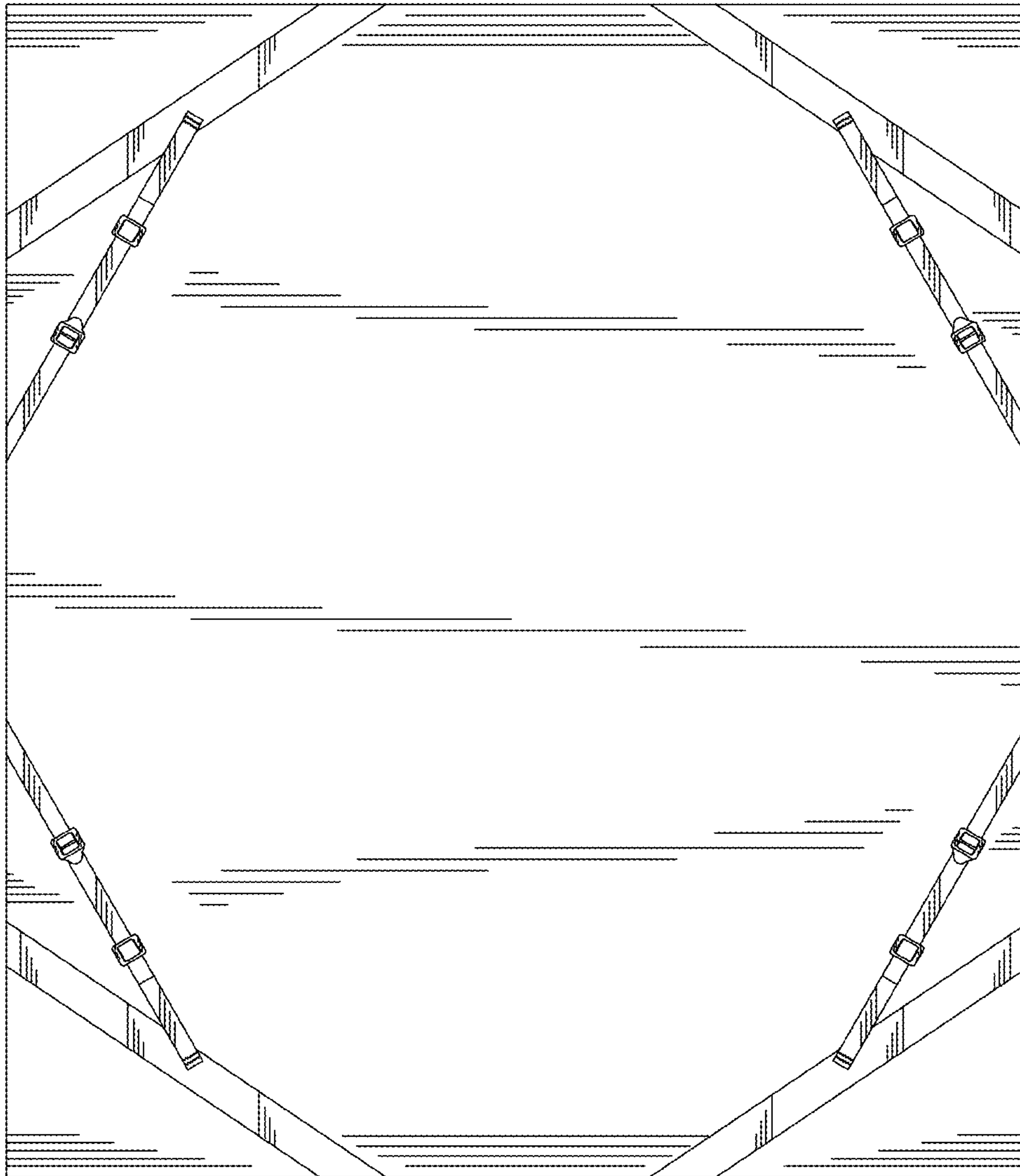

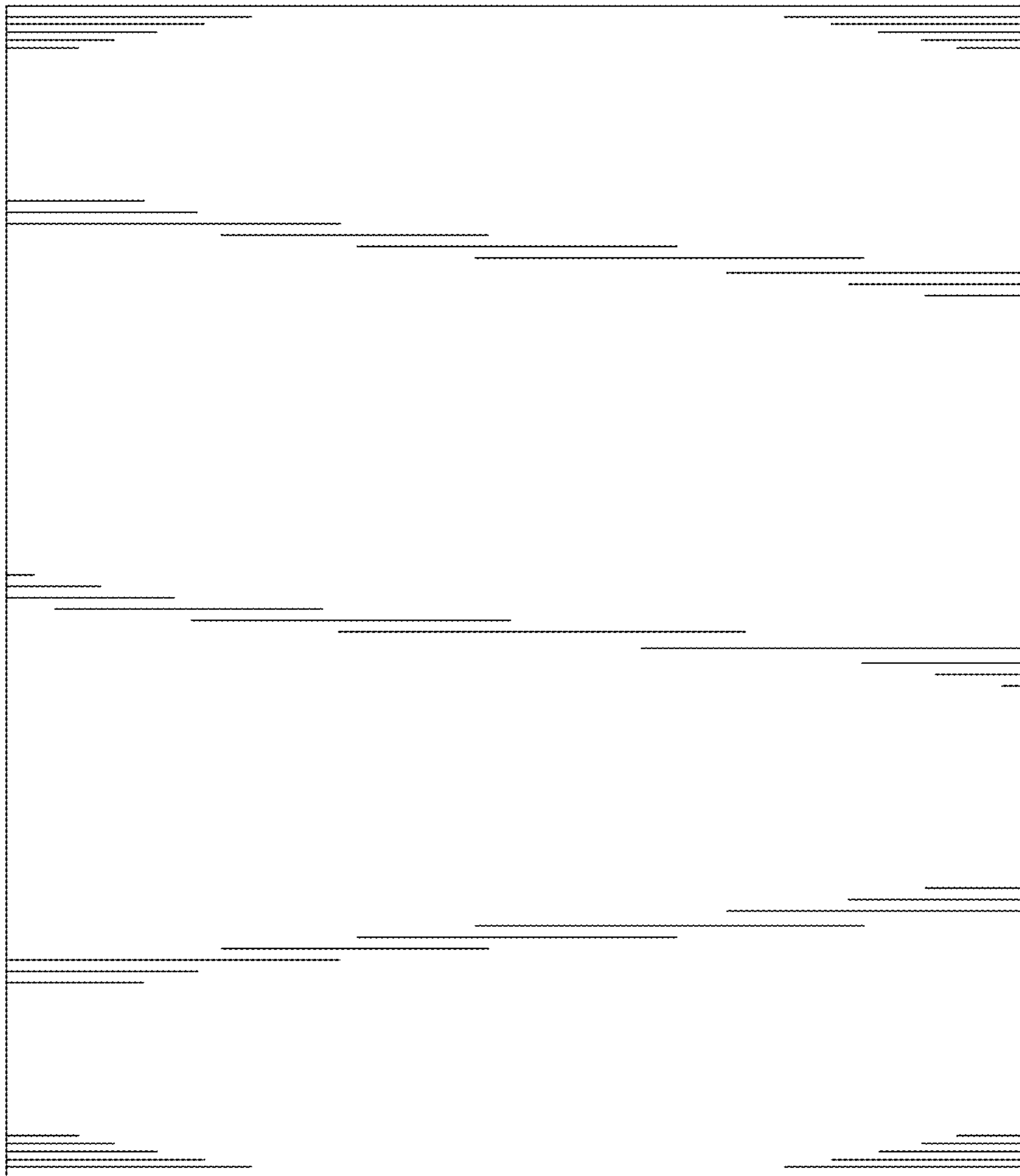

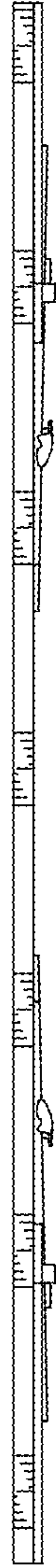

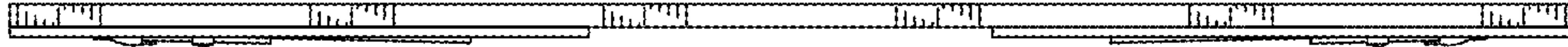

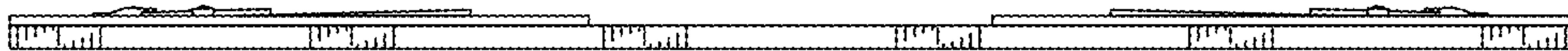

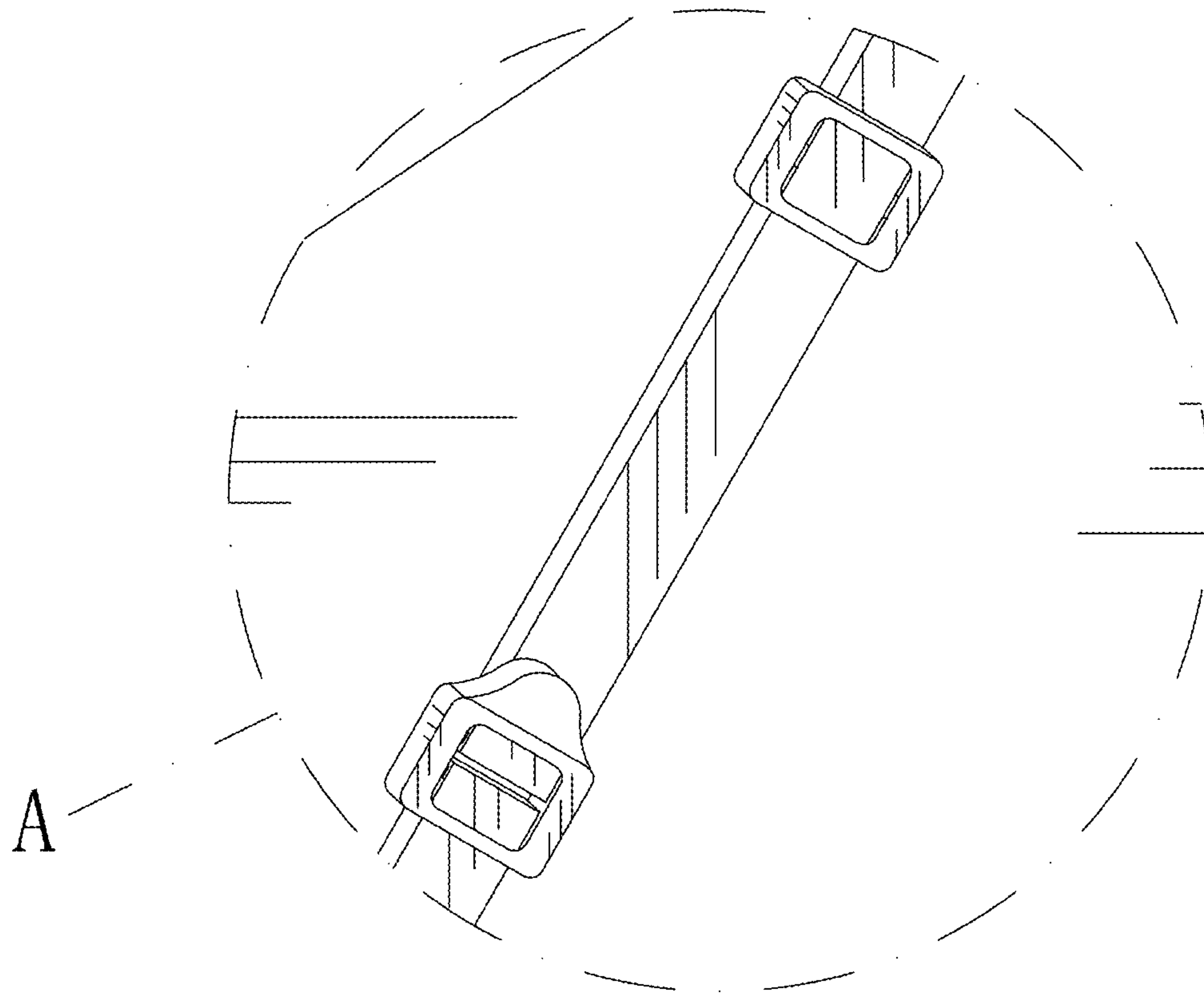
