The ornamental design of a portable holder for a concave container, substantially shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a portable holder for a concave container in accordance with the present invention; FIG. 2 is a front view of the portable holder for a concave container in FIG. 1; FIG. 3 is a rear view thereof; FIG. 4 is a left side view thereof; FIG. 5 is a right side view thereof; FIG. 6 is a top view thereof; and, FIG. 7 is a bottom view thereof. 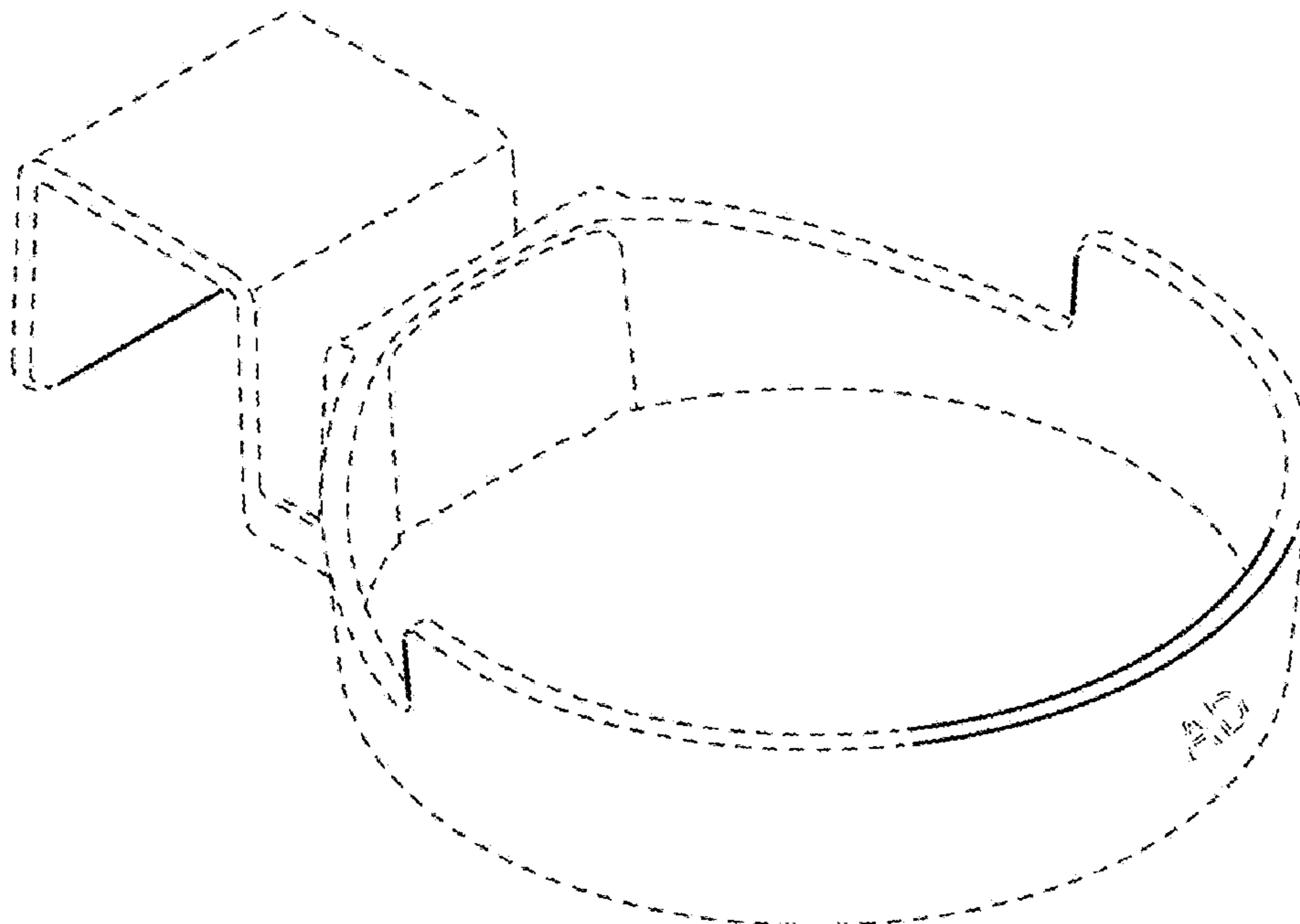

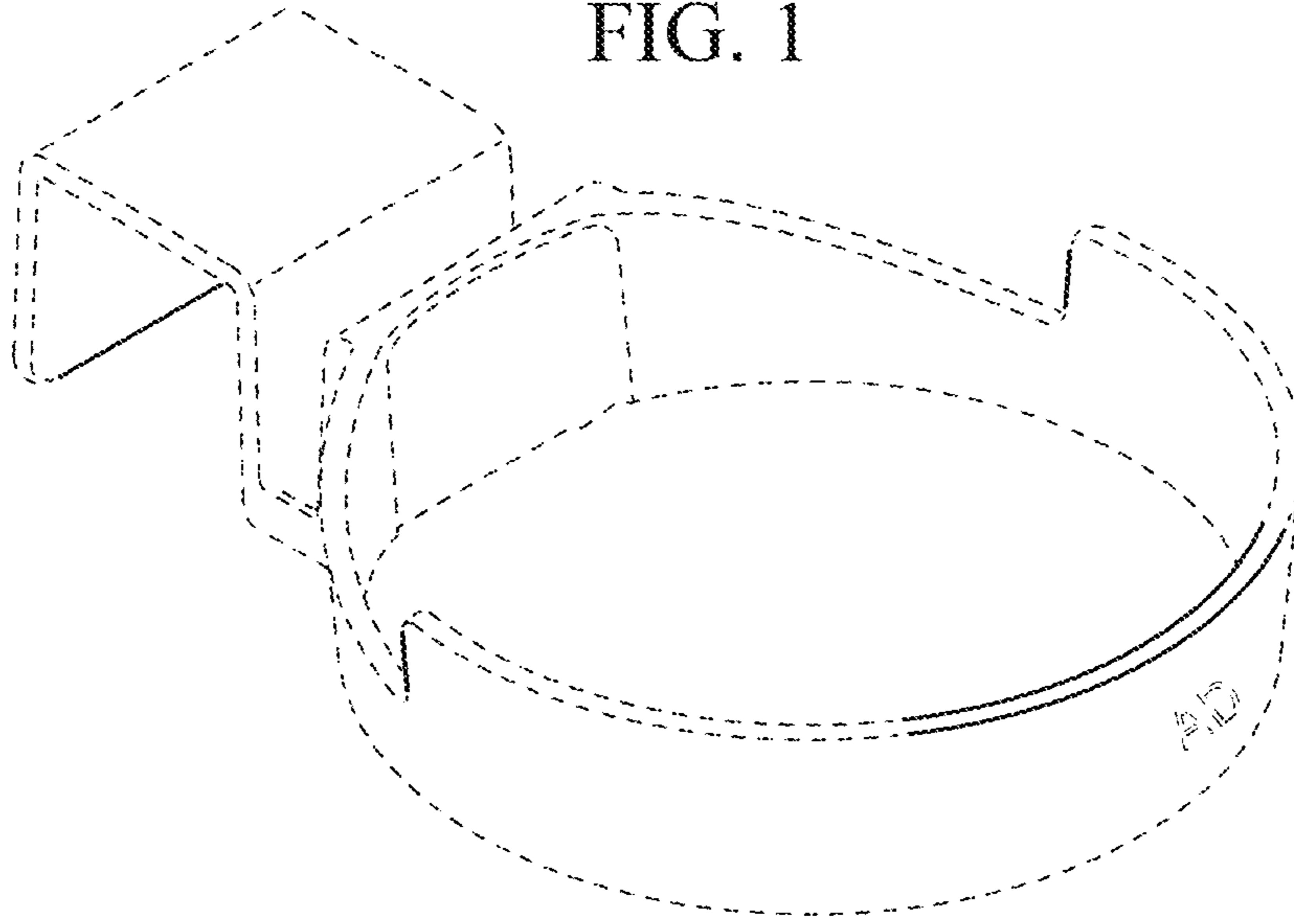

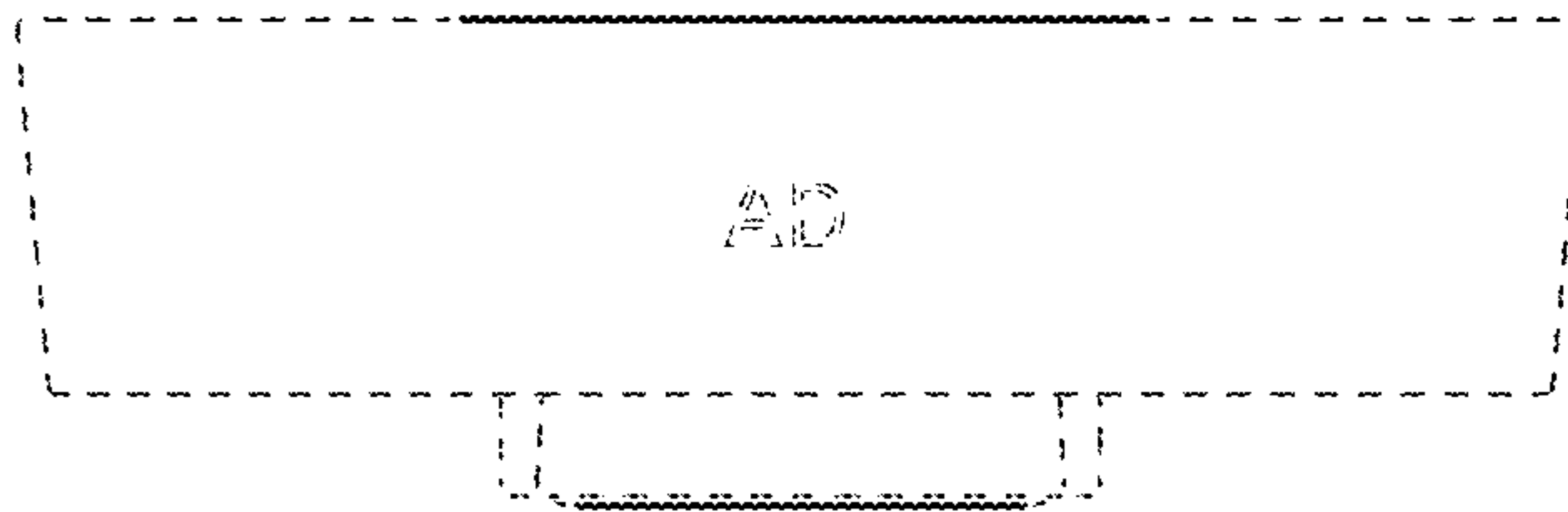

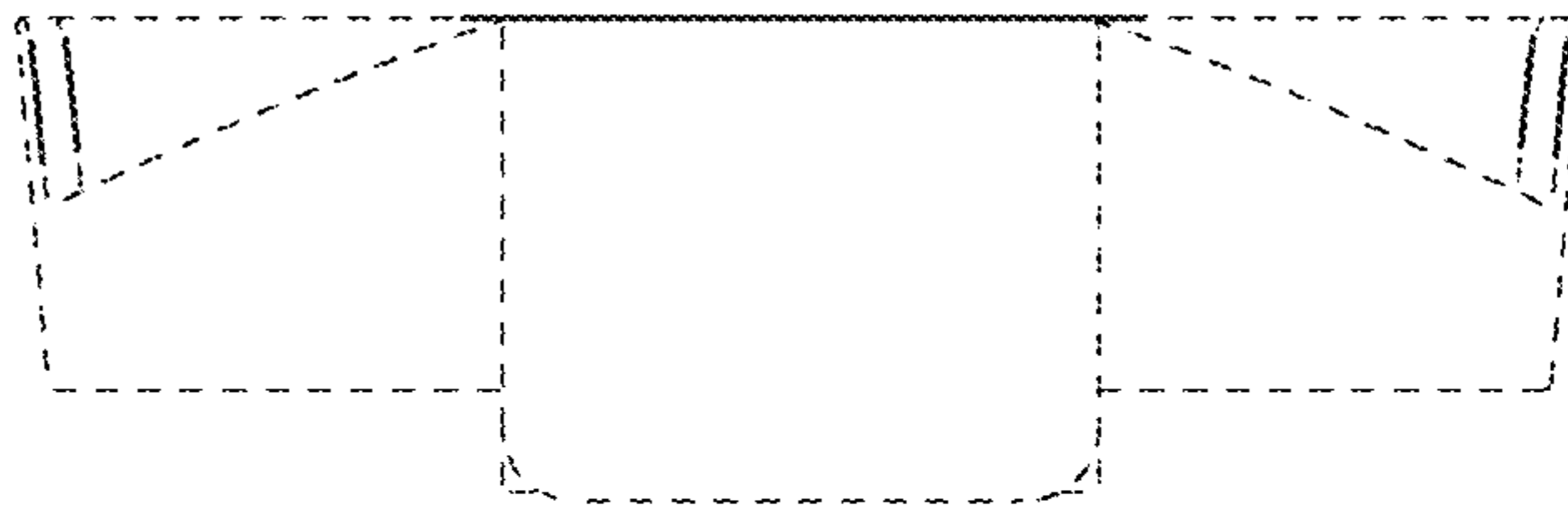

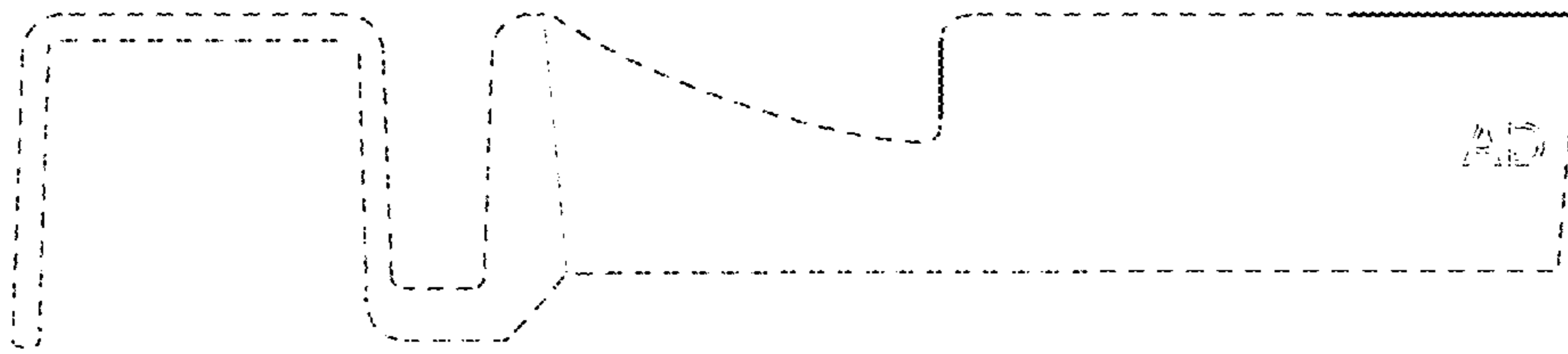

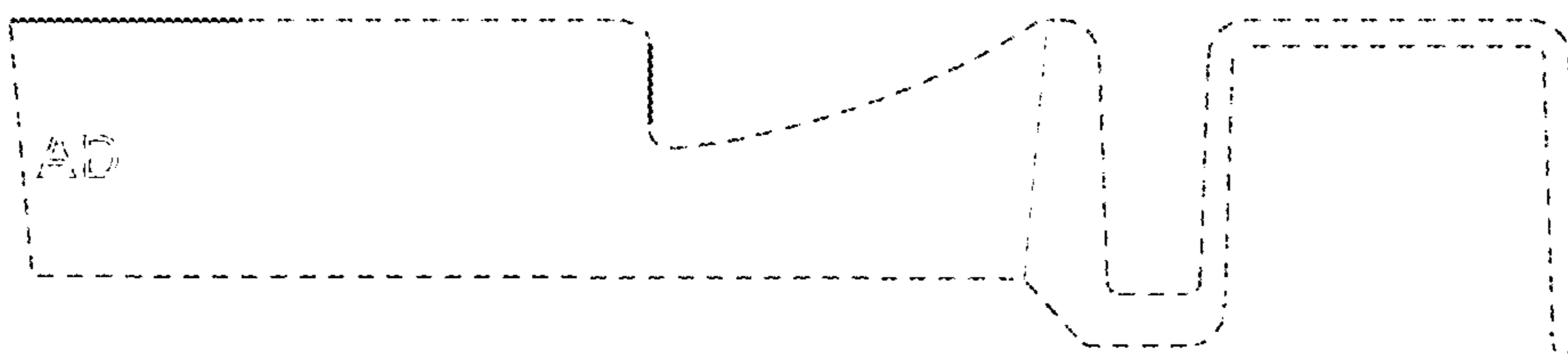

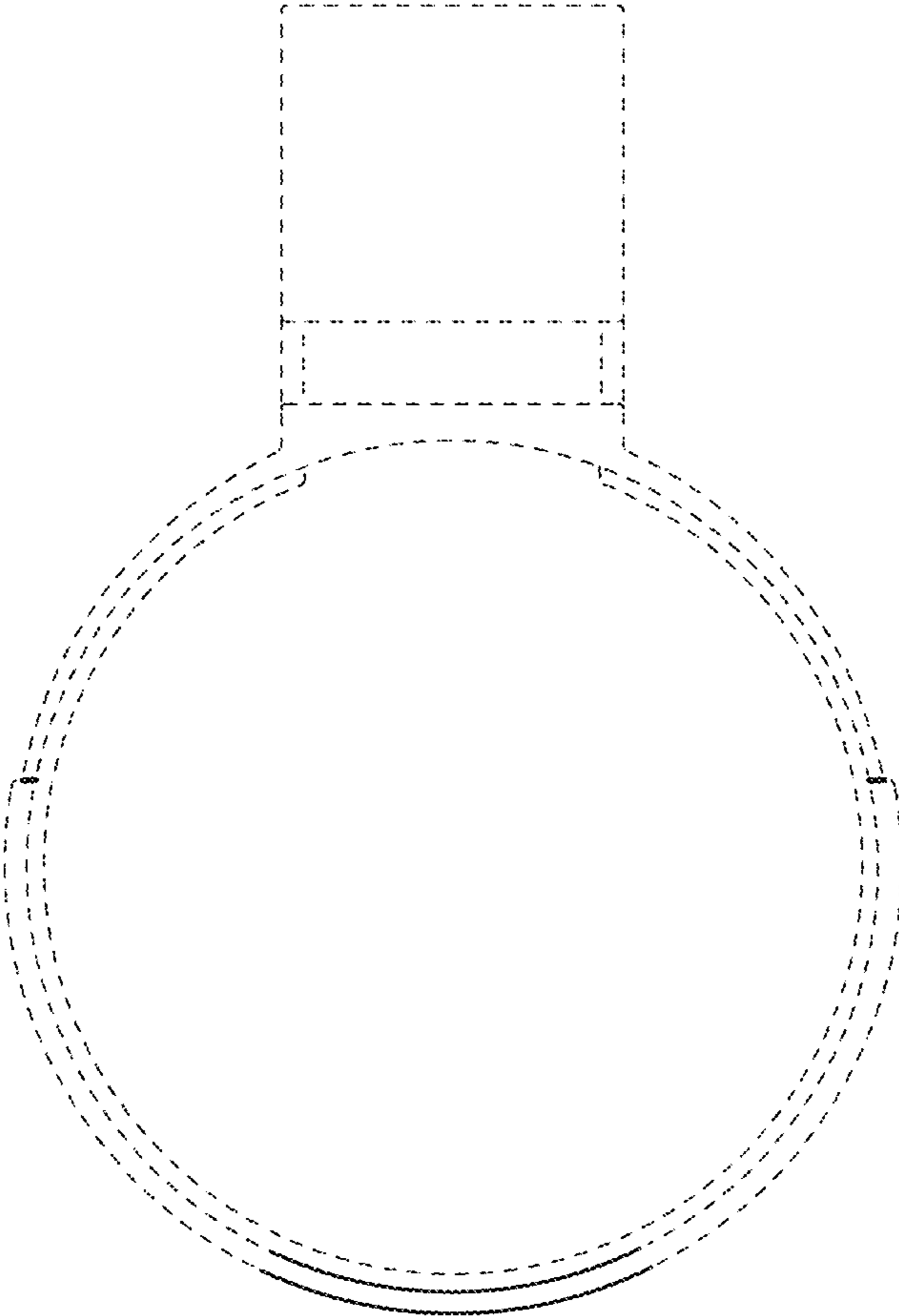
