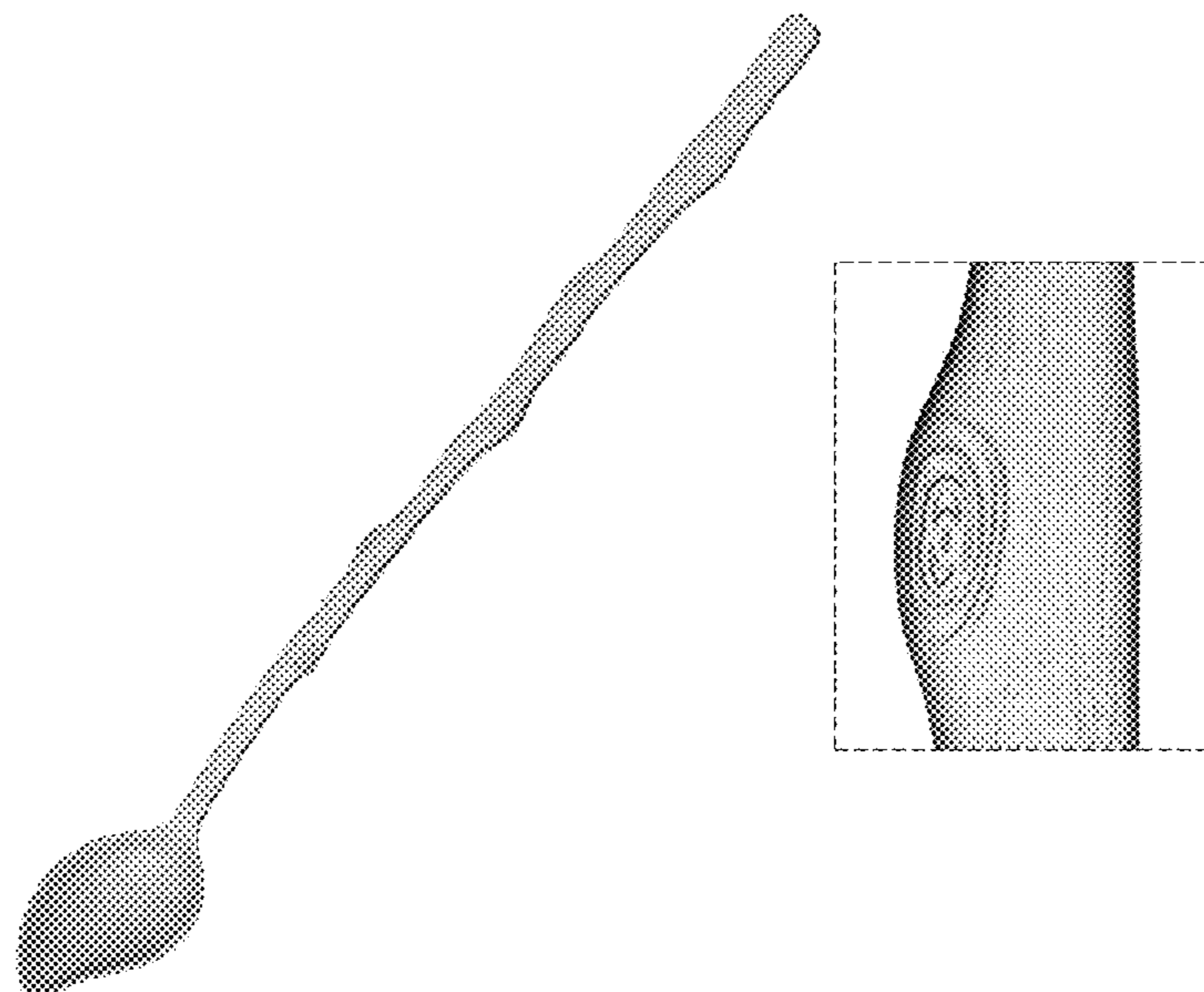
The ornamental design for a stirring spoon, as shown and described.

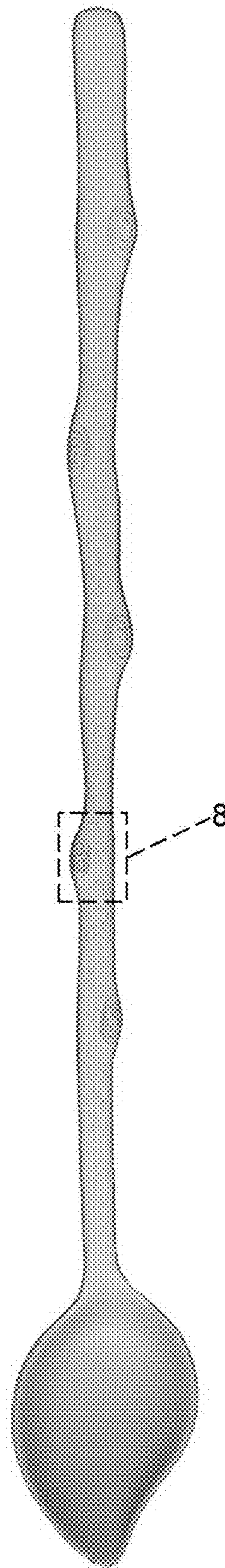

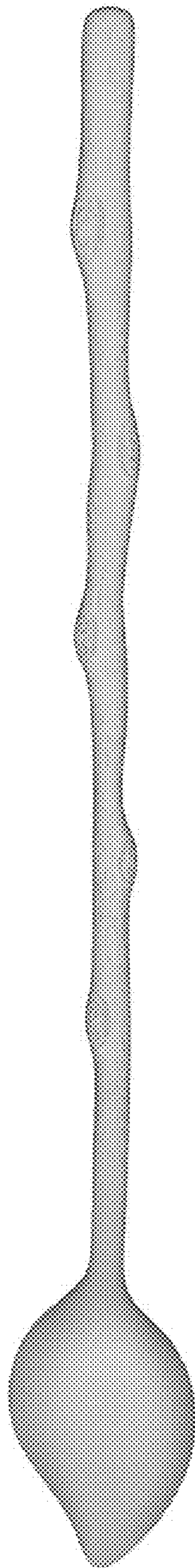

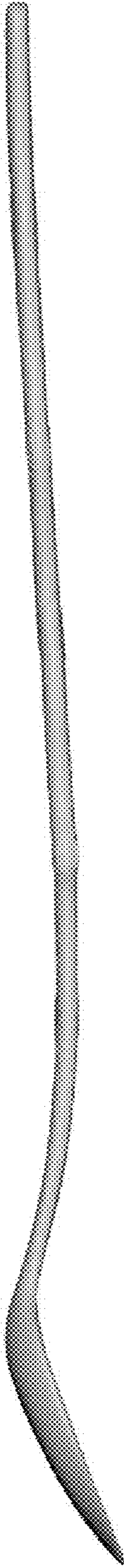

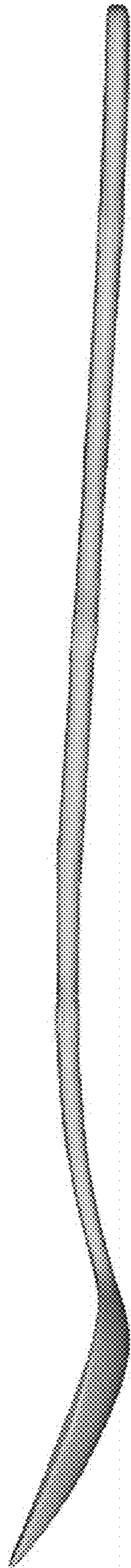

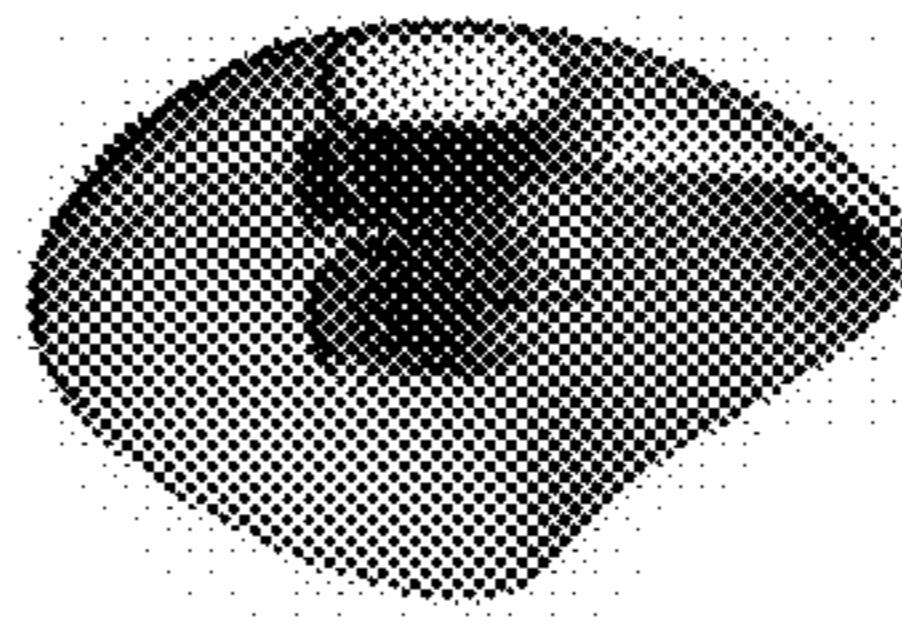

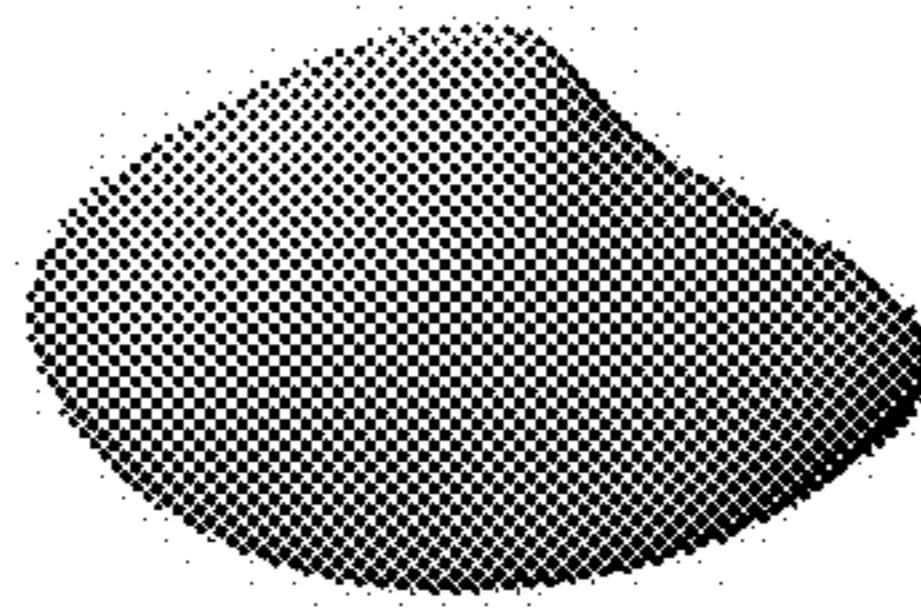

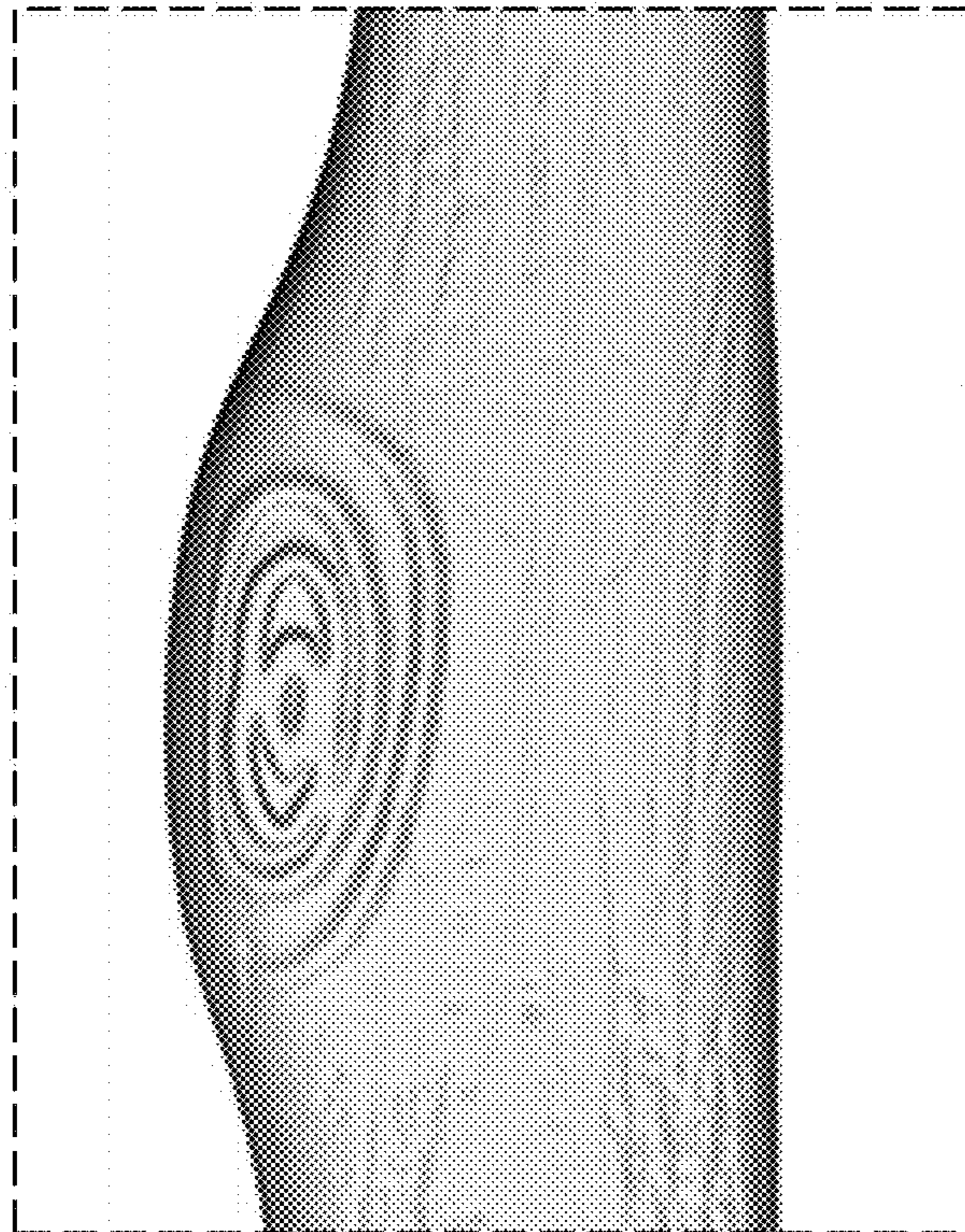

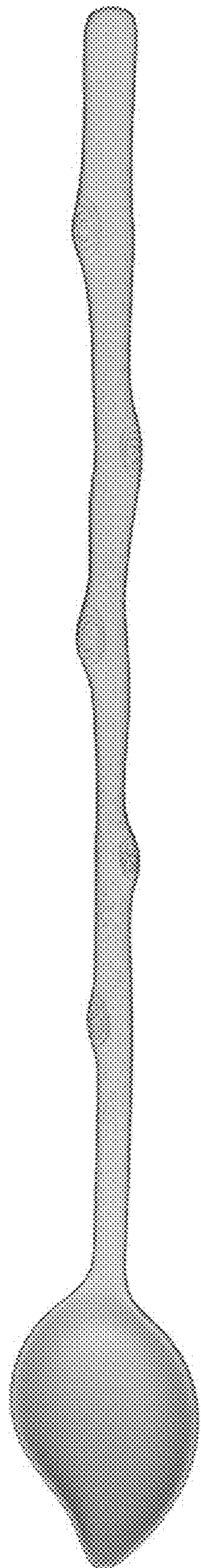

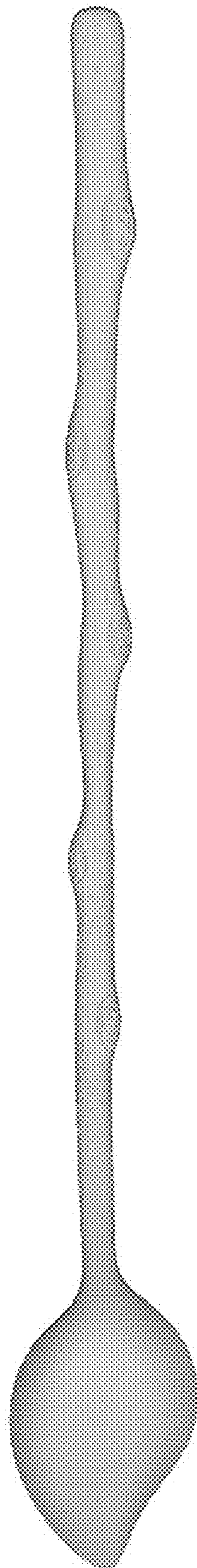

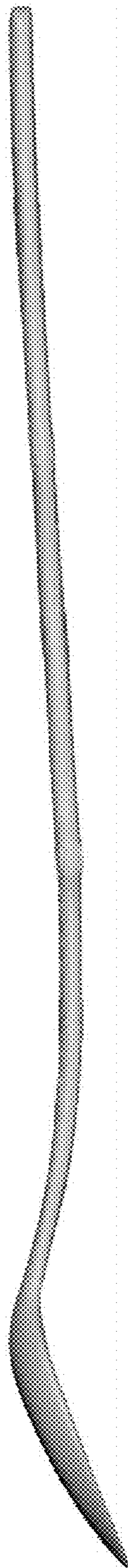

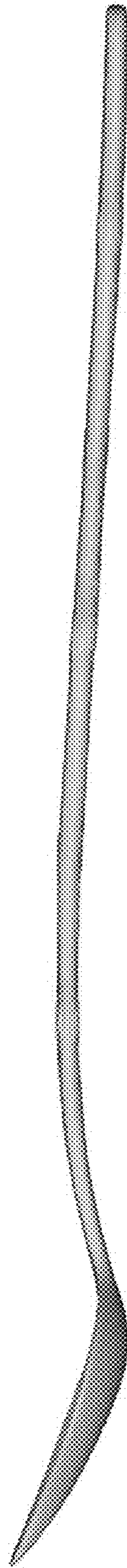

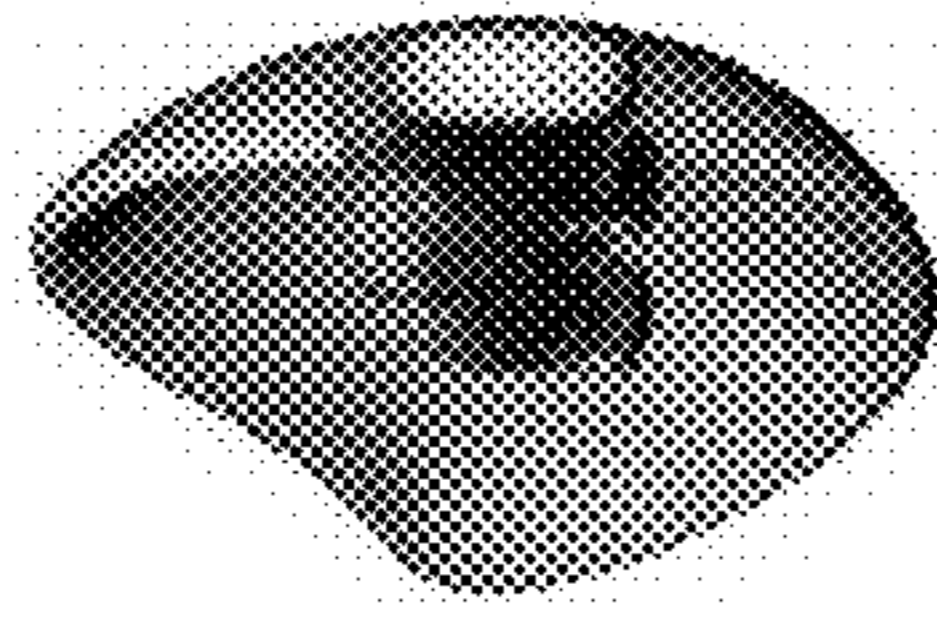

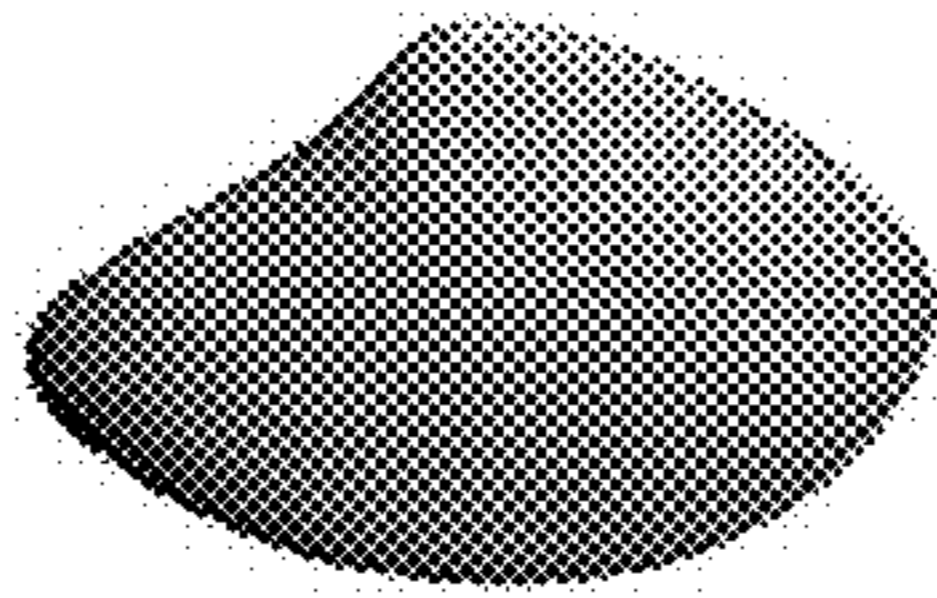

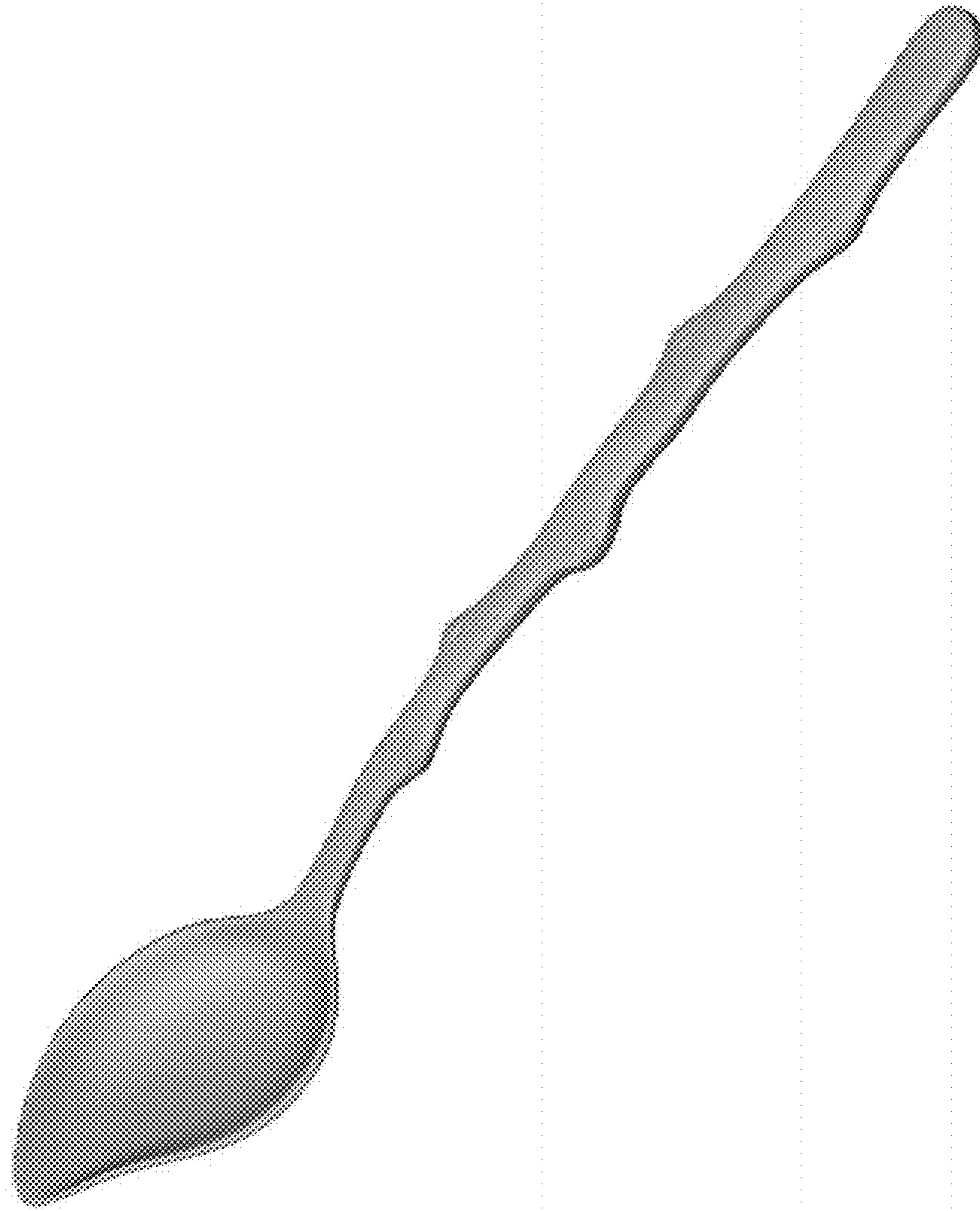

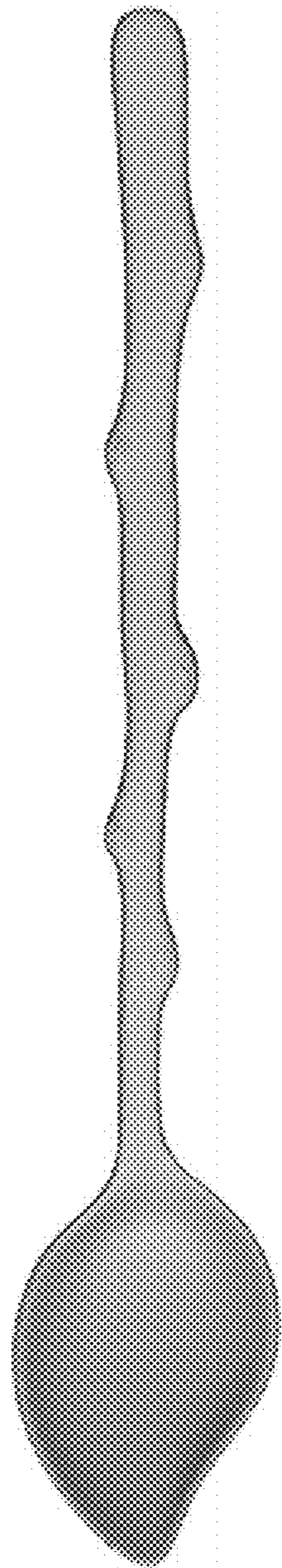

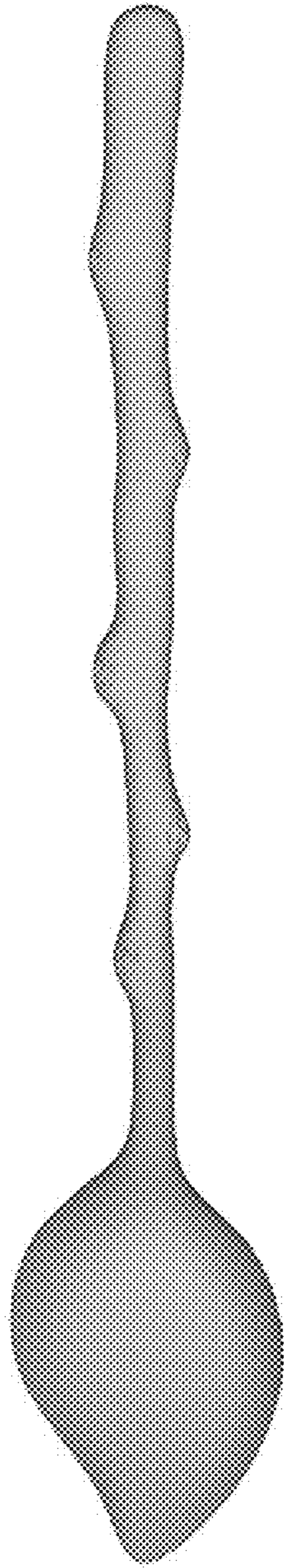

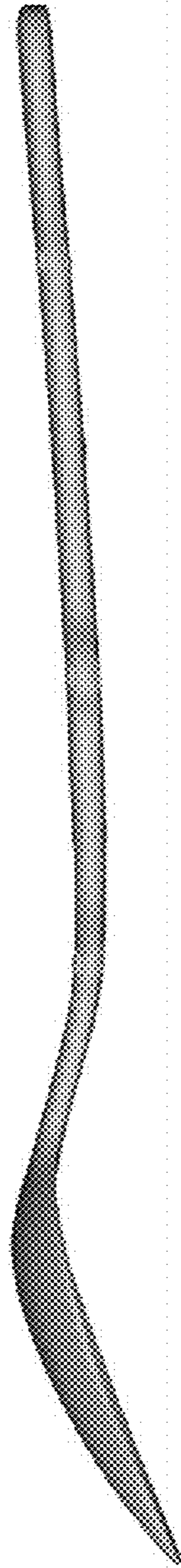

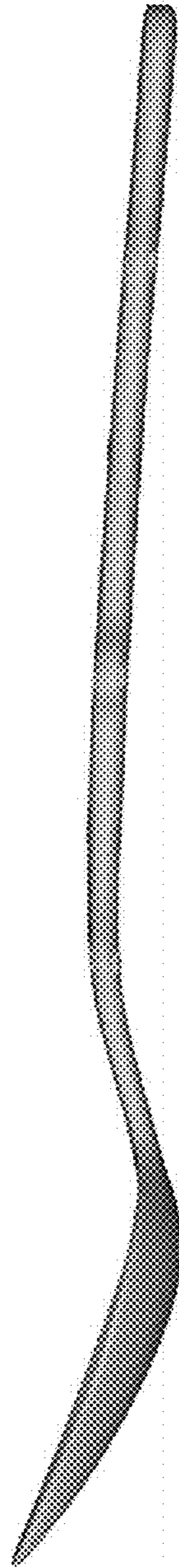

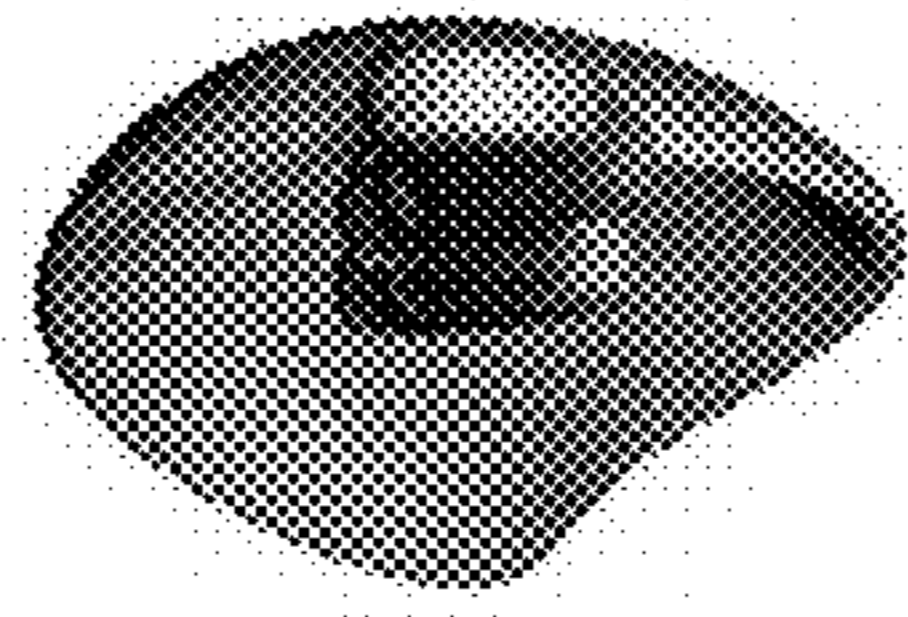

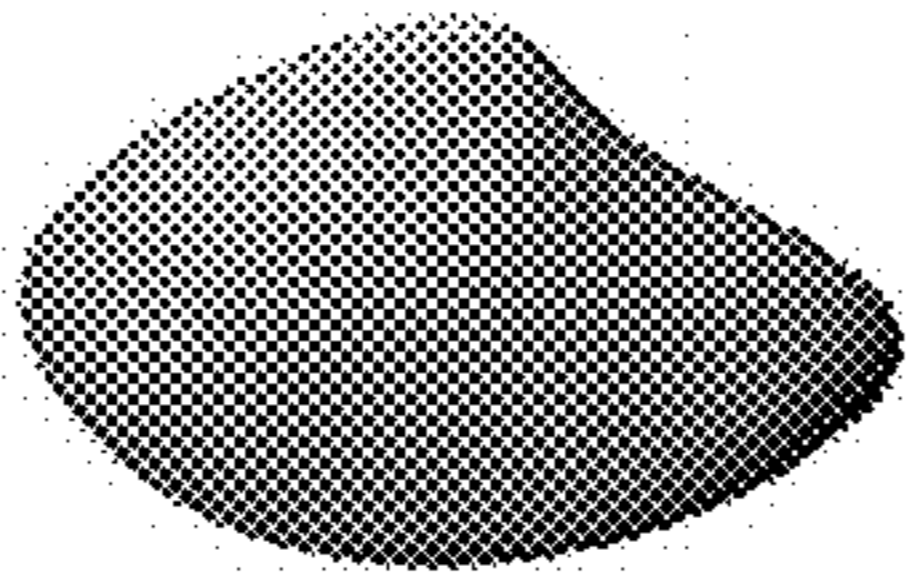

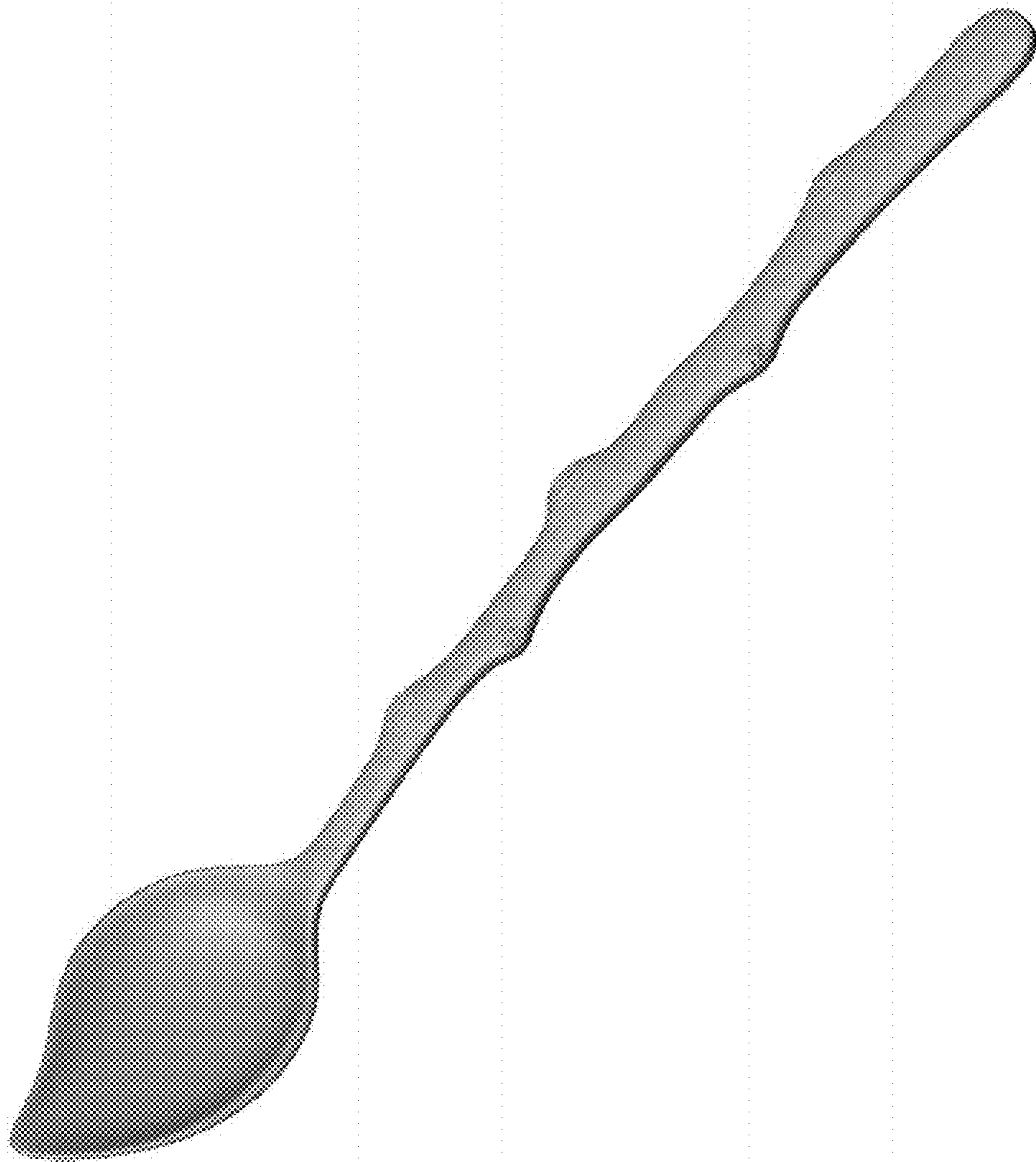

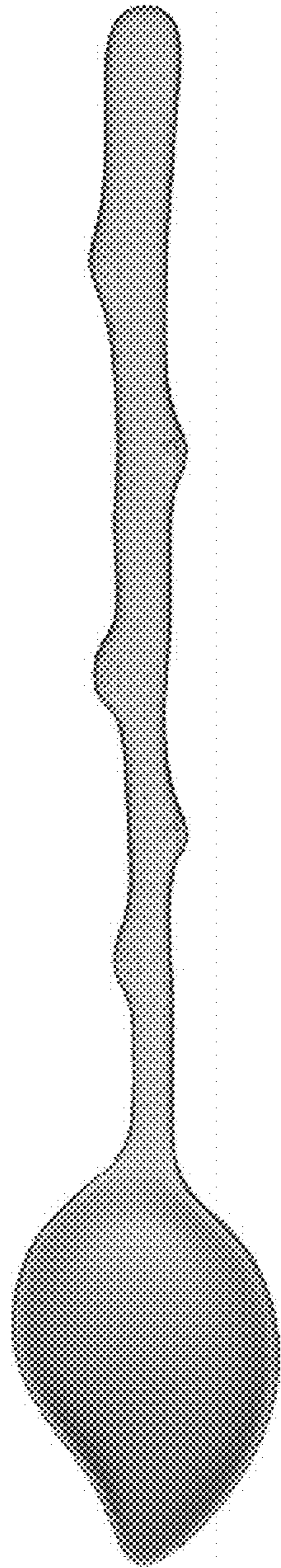

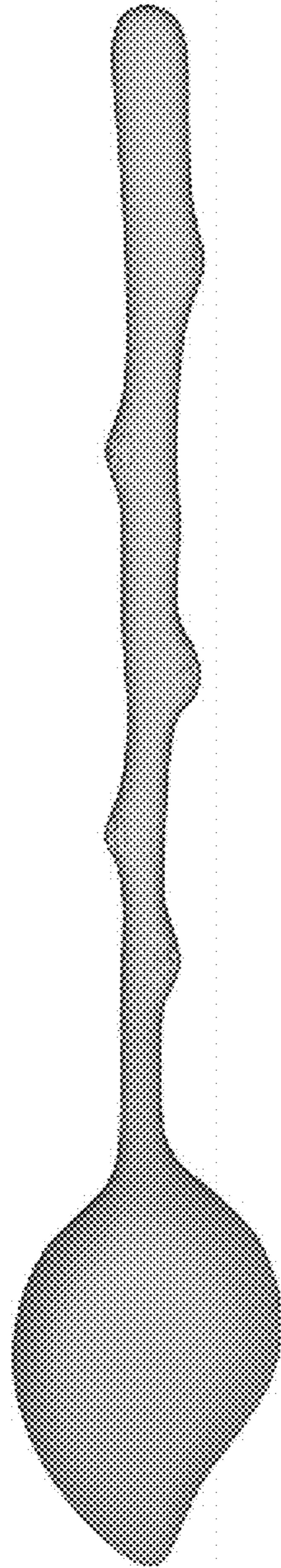

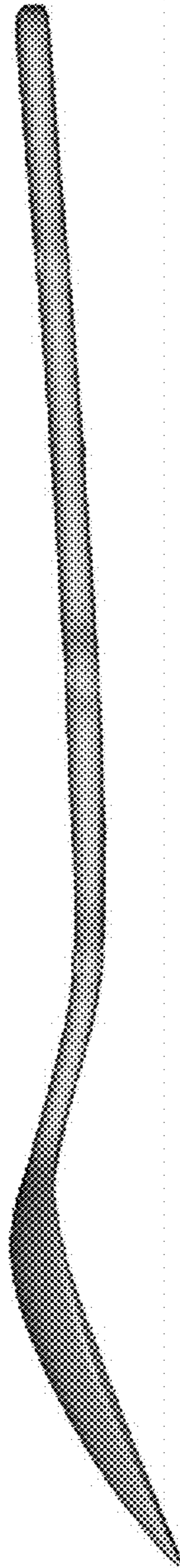

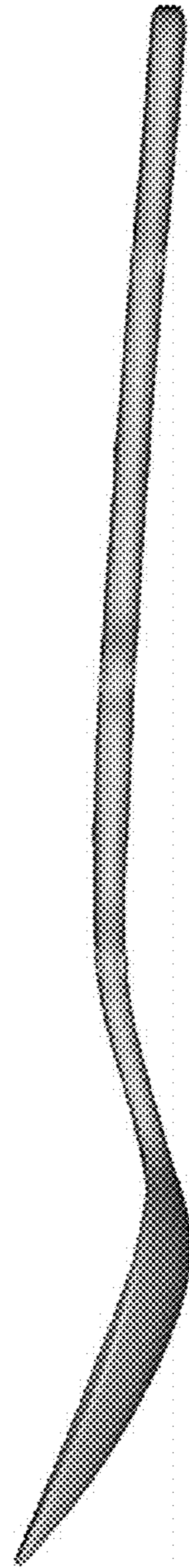

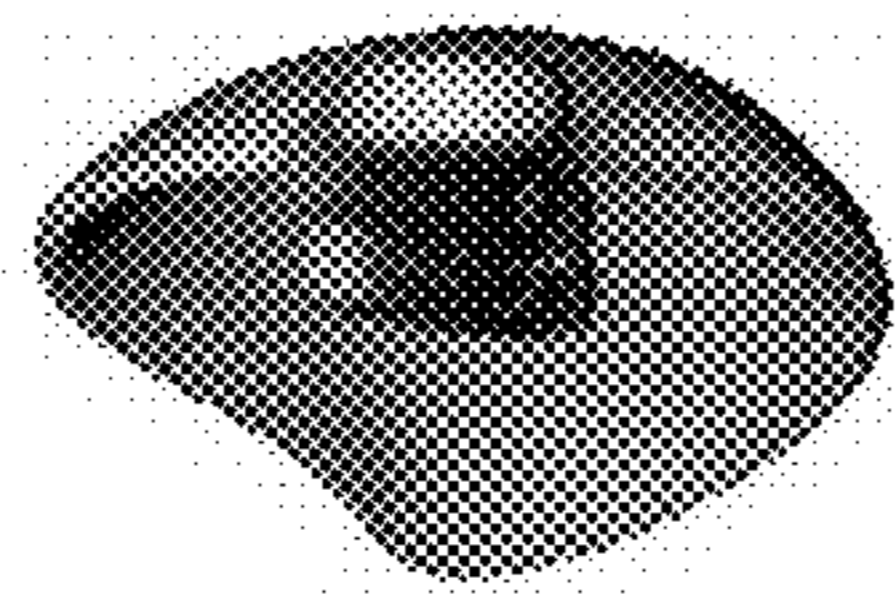

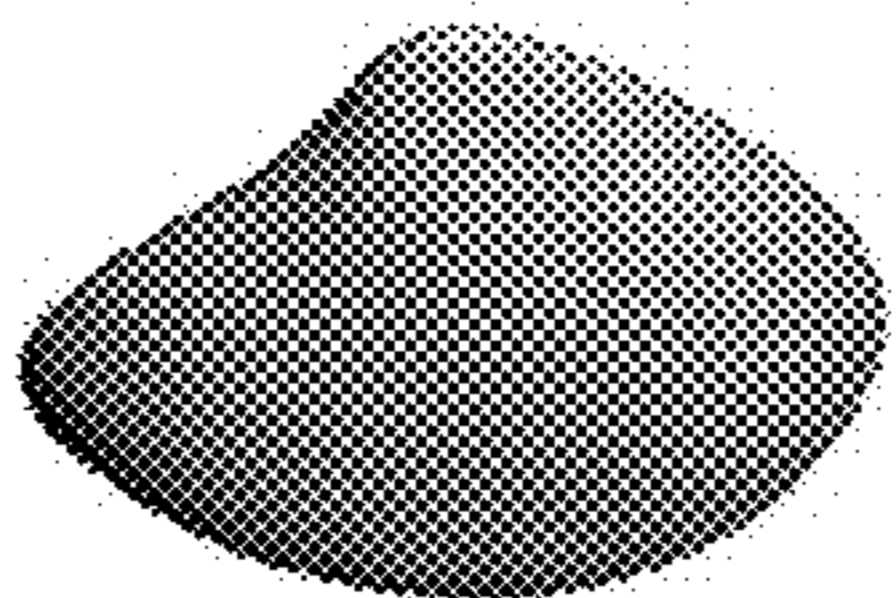
