(57) **CLAIM**

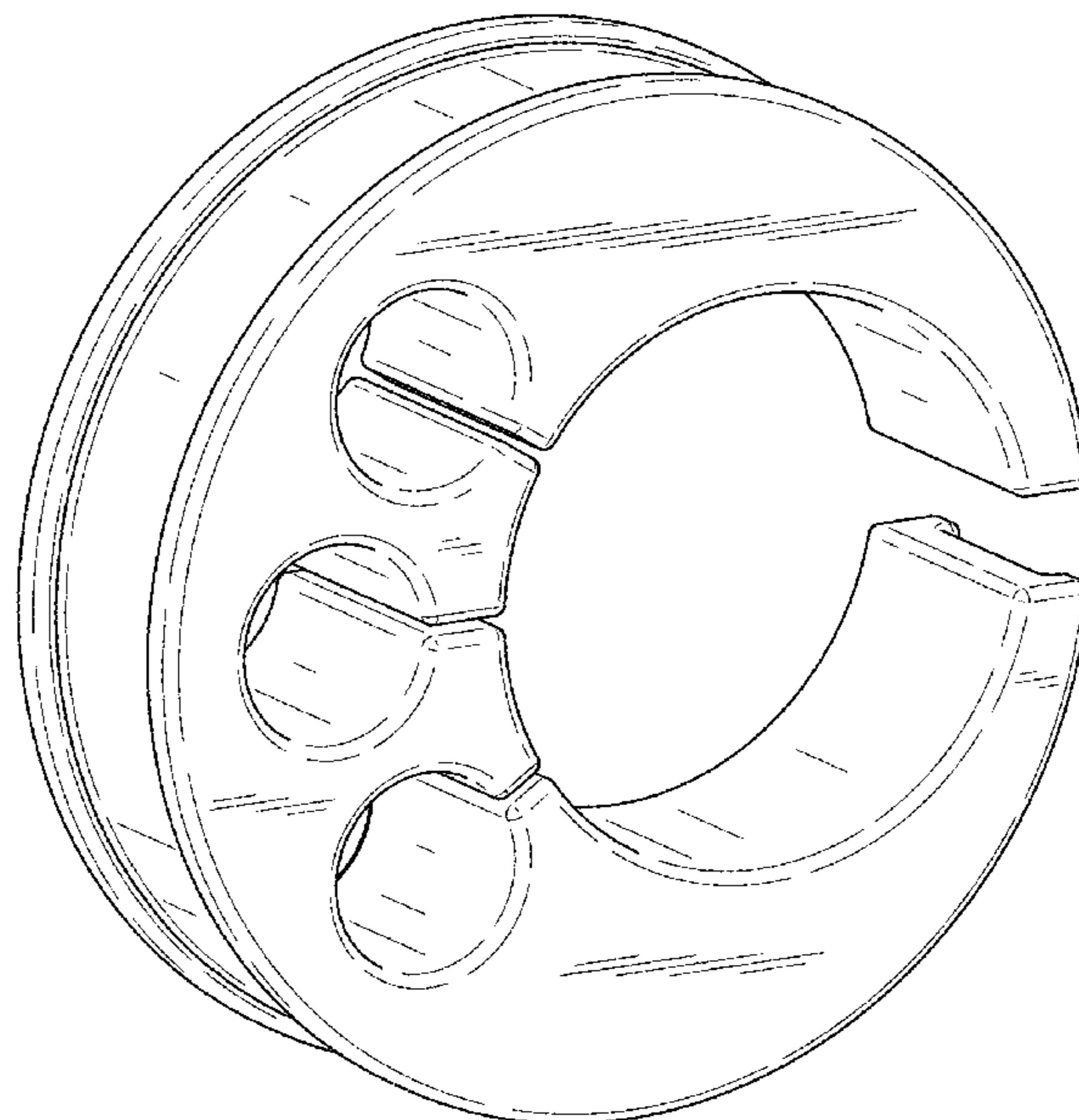
The ornamental design for a flexible hose clamp, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a first embodiment of a flexible hose clamp of the present design. FIG. 2 is a front view of the flexible hose clamp of FIG. 1. FIG. 3 is a rear view of the flexible hose clamp of FIG. 1. FIG. 4 is a left side view of the flexible hose clamp of FIG. 1. FIG. 5 is a right side view of the flexible hose clamp of FIG. 1. FIG. 6 is a top view of the flexible hose clamp of FIG. 1; and, FIG. 7 is a bottom view of the flexible hose clamp of FIG. 1.

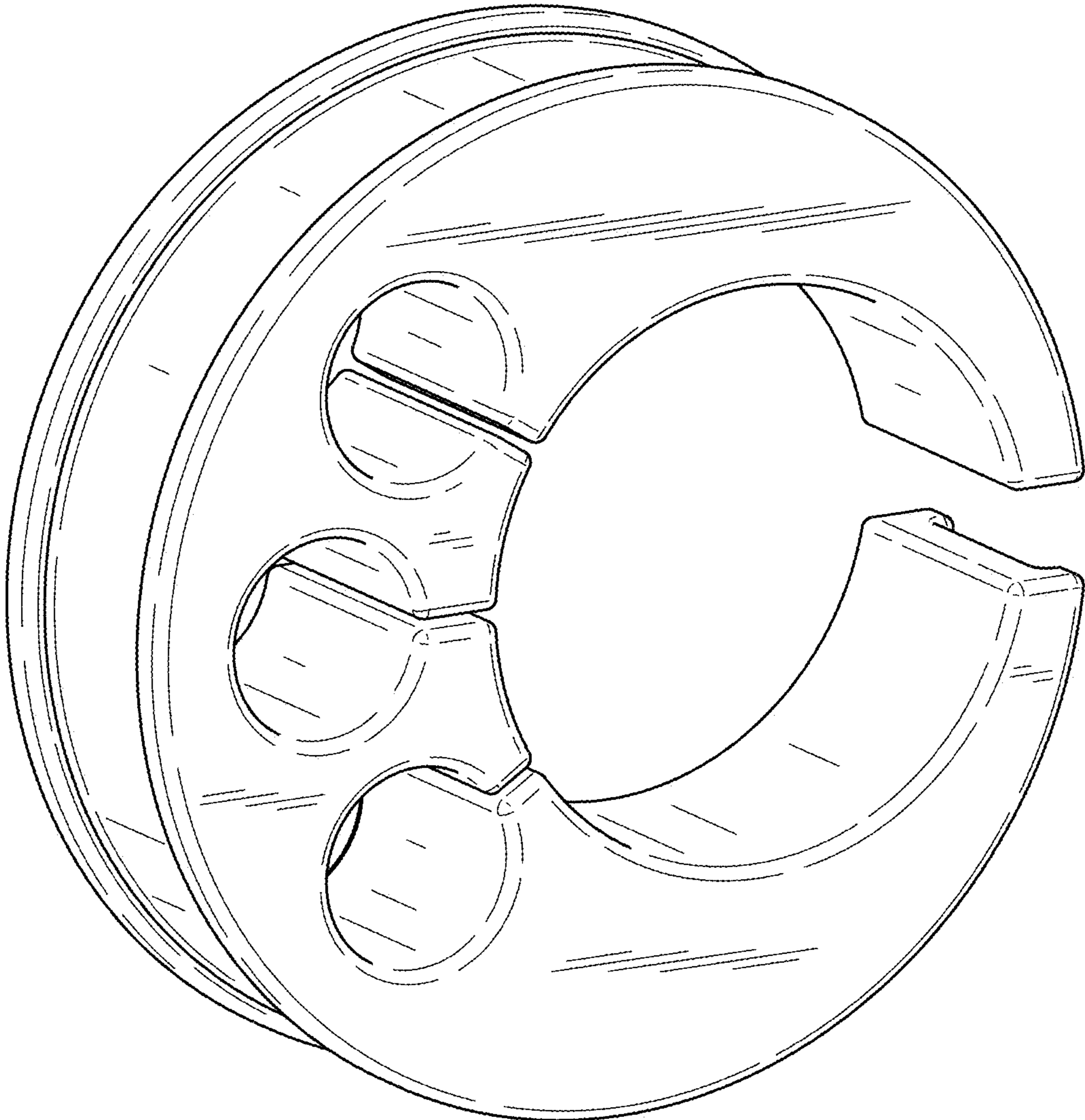

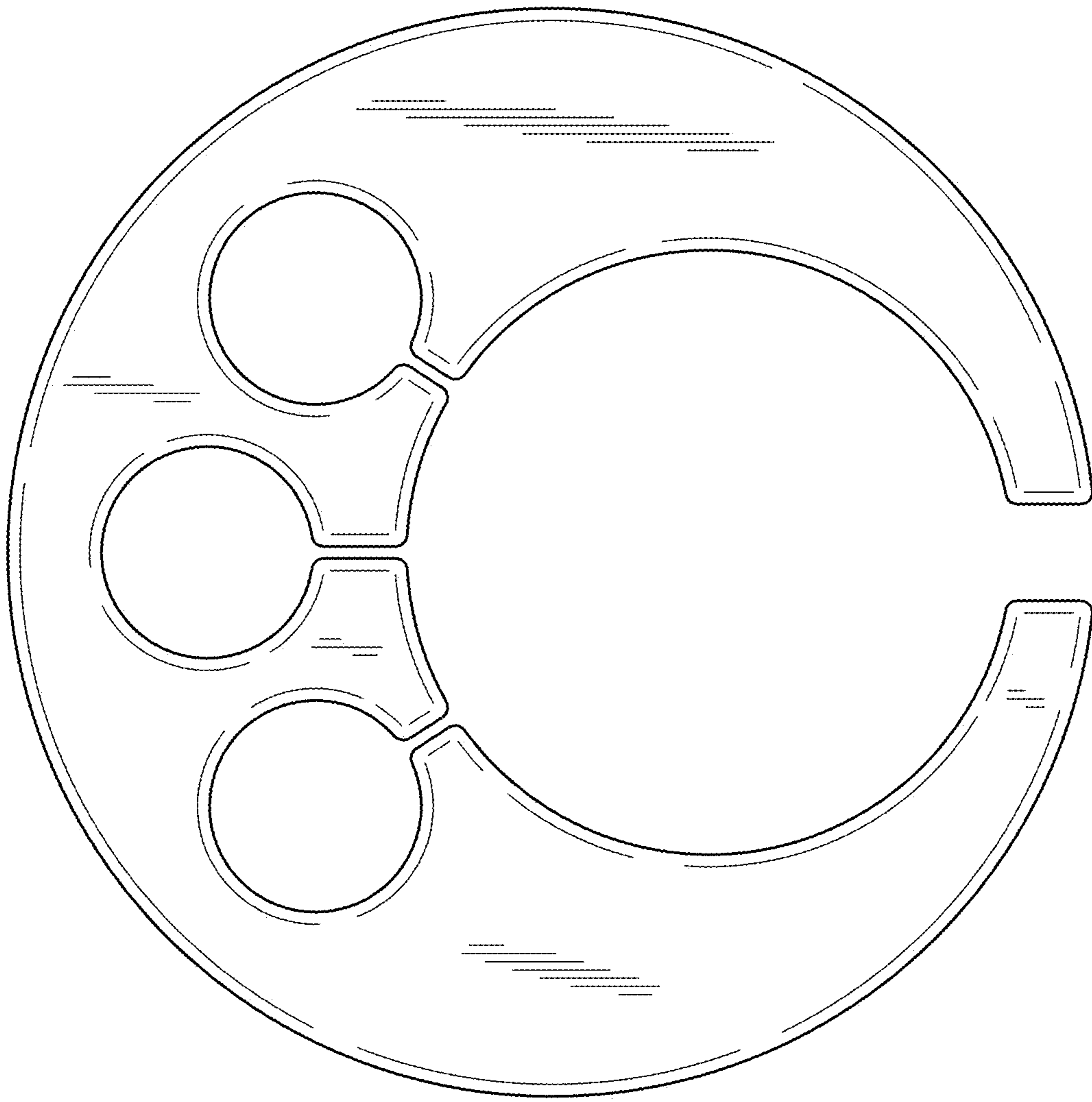

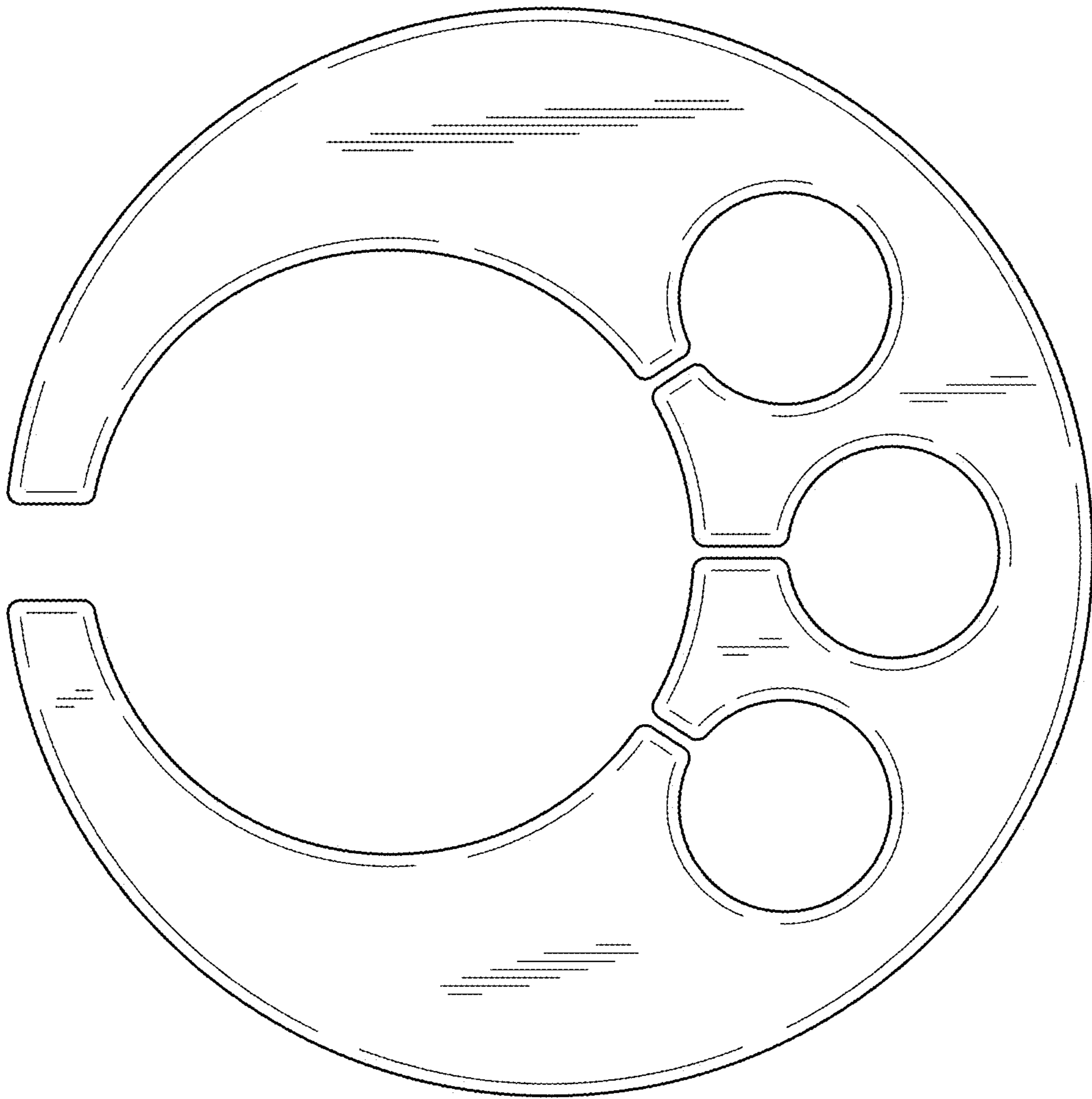

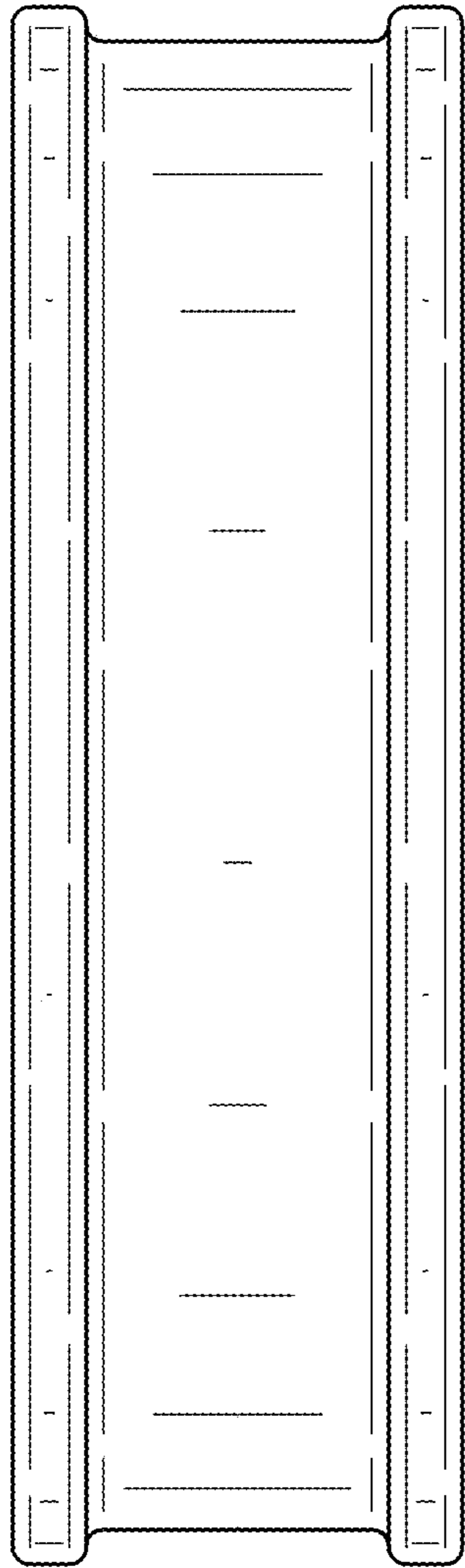

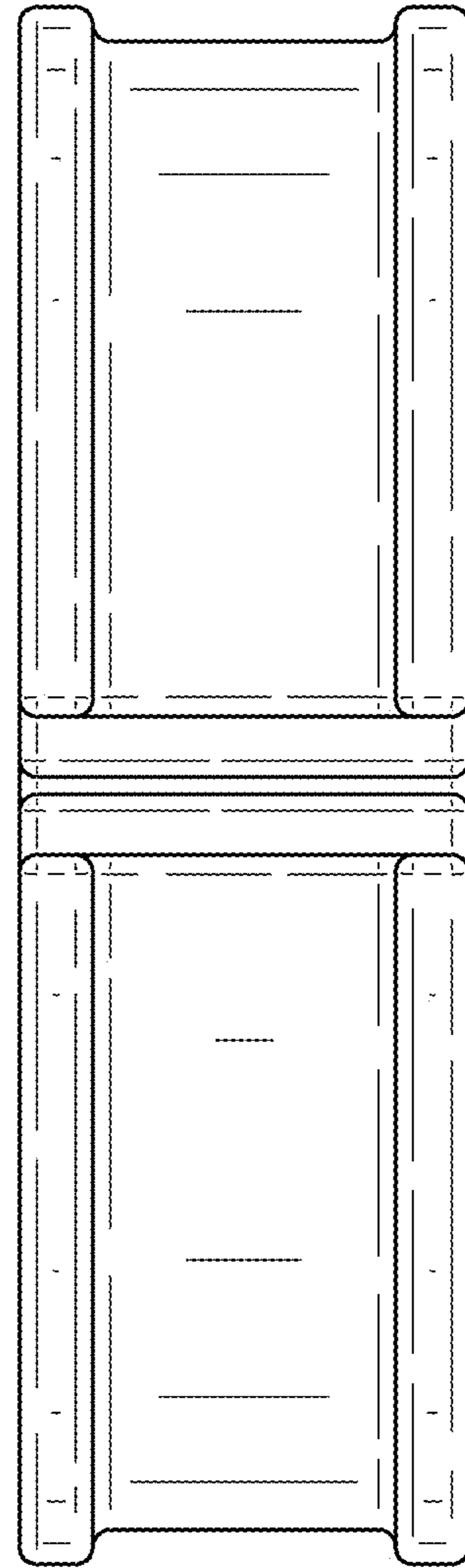

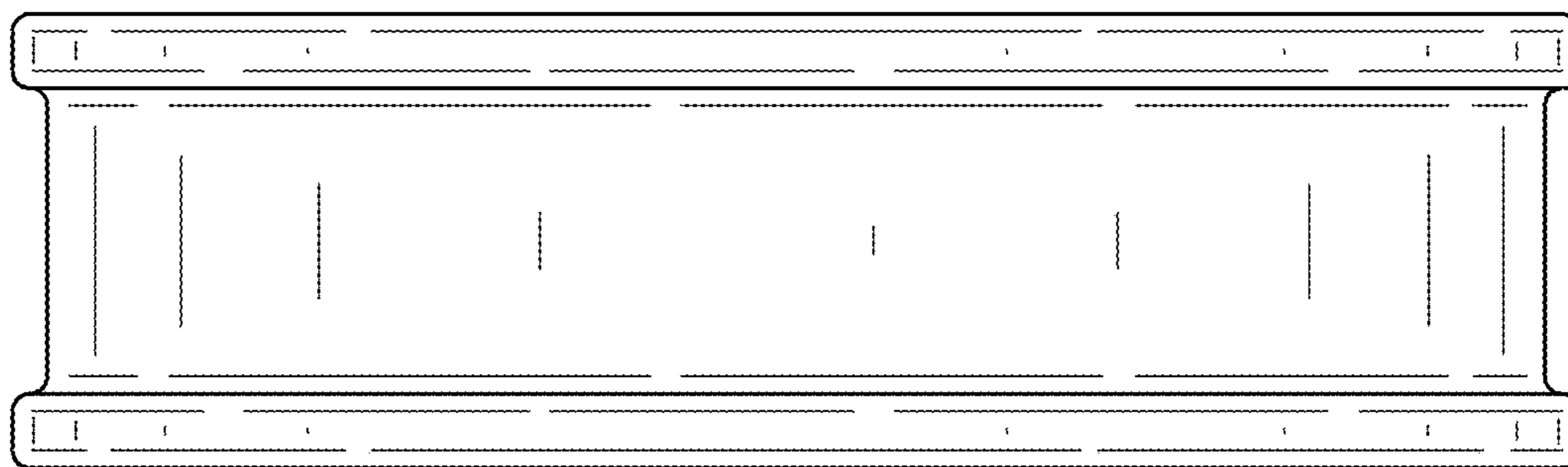

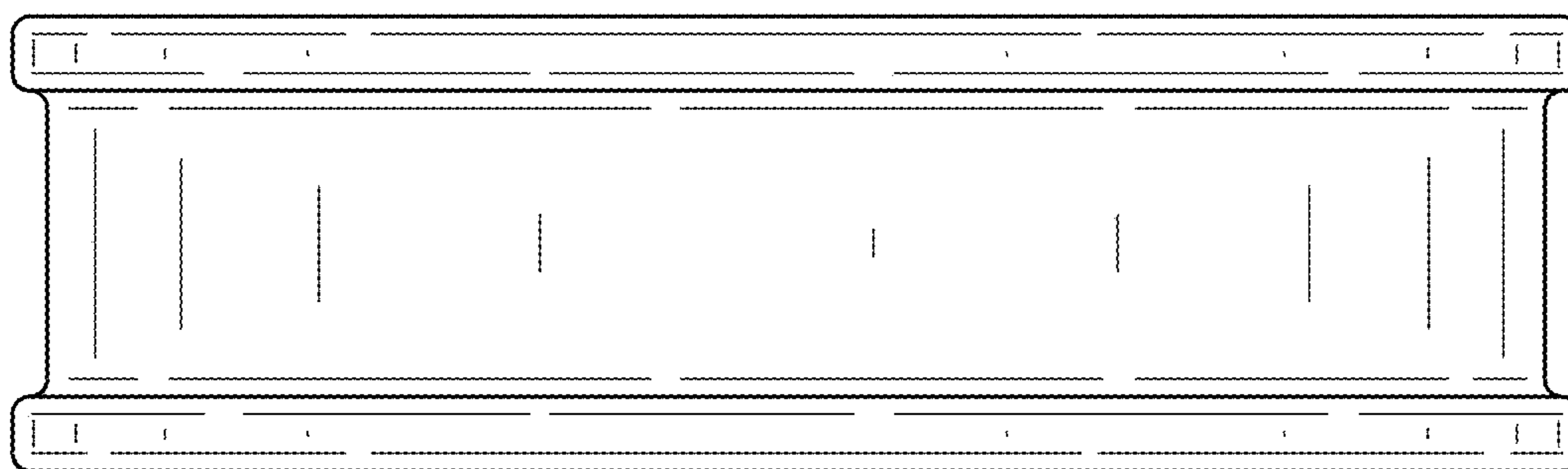
