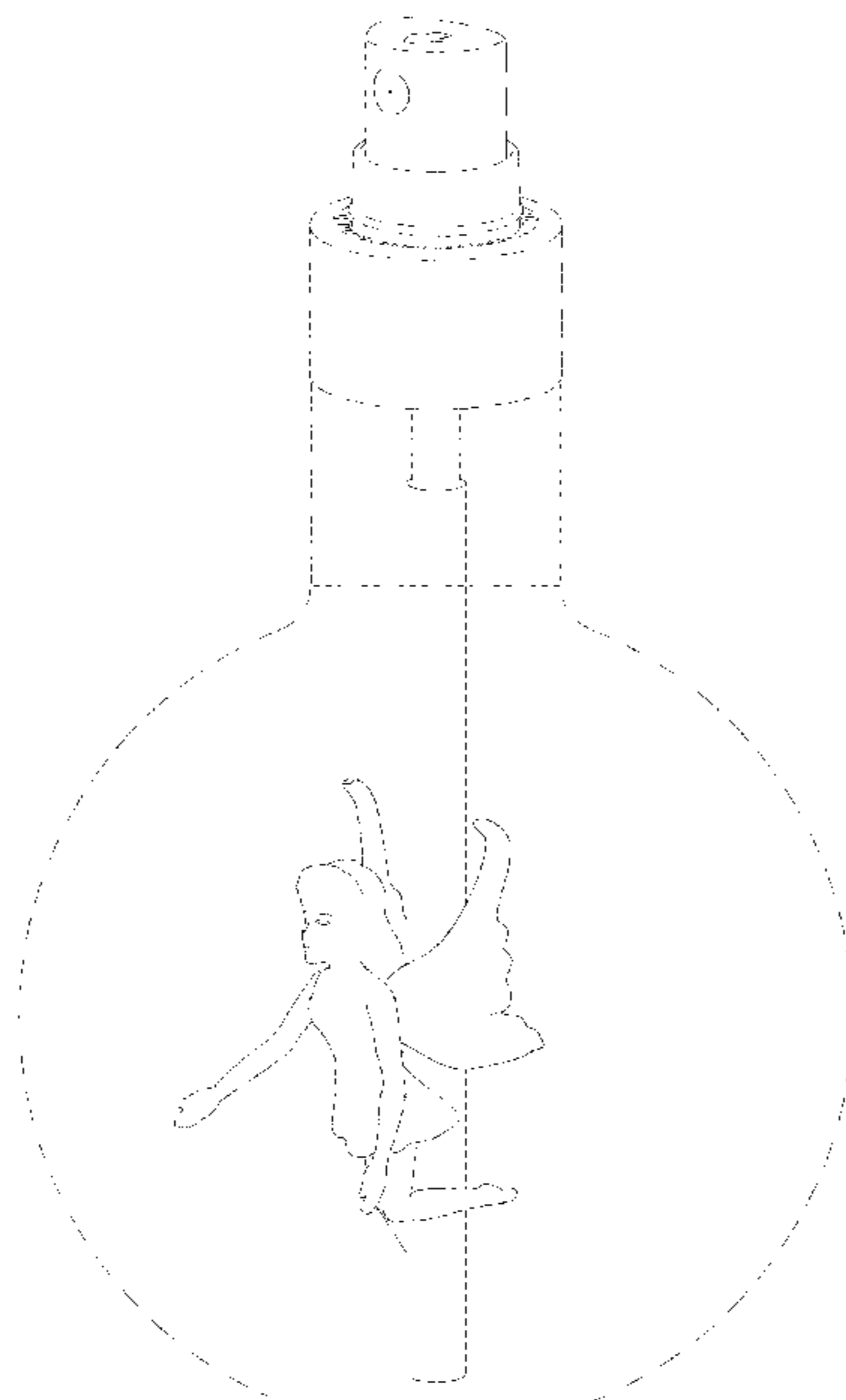
(57) **CLAIM**

The ornamental design for dip tube adornment for a pump sprayer, as shown and described.

DESCRIPTION

FIG. 1 is a front right perspective view of the dip tube adornment for a pump sprayer of the present invention; FIG. 2 is a front view thereof; FIG. 3 is a rear view thereof; FIG. 4 is a rear left perspective view thereof; FIG. 5 is a rear right perspective view thereof; FIG. 6 is a front right perspective view thereof, illustrating the dip tube adornment for a pump sprayer inside of a liquid container; and, FIG. 7 is a front view thereof, illustrating the dip tube adornment for a pump sprayer inside of a liquid container. The broken lines shown in the drawings are included for the purpose of illustrating unclaimed portions of the dip tube adornment for a pump sprayer, and form no part of the claimed design.

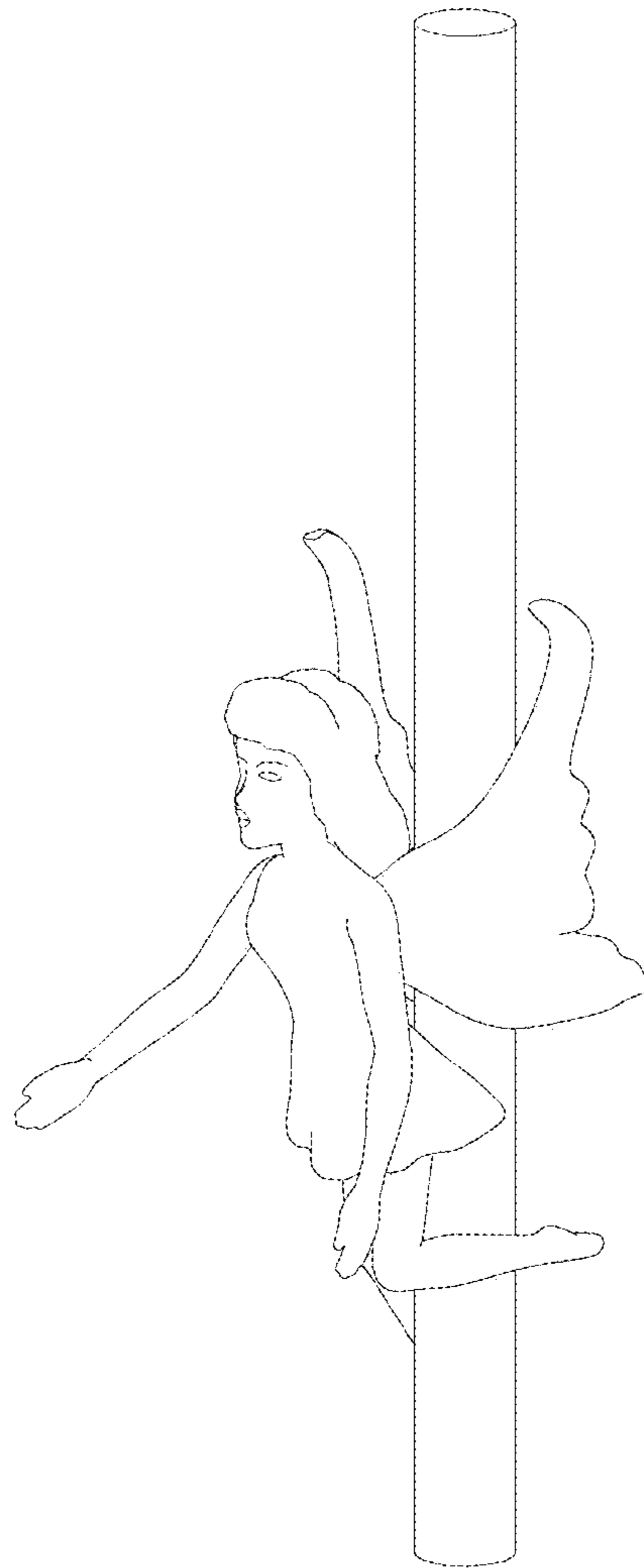

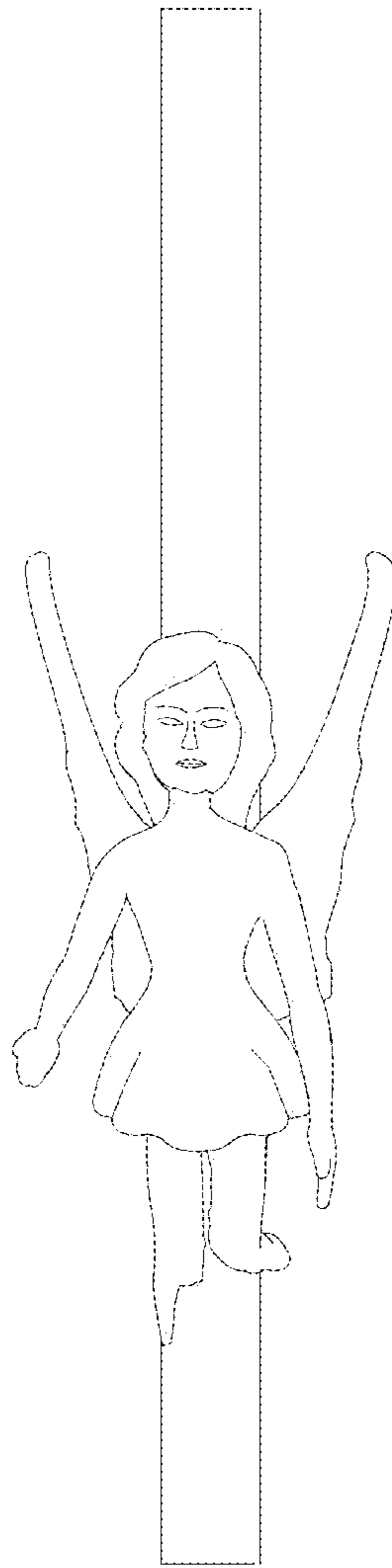

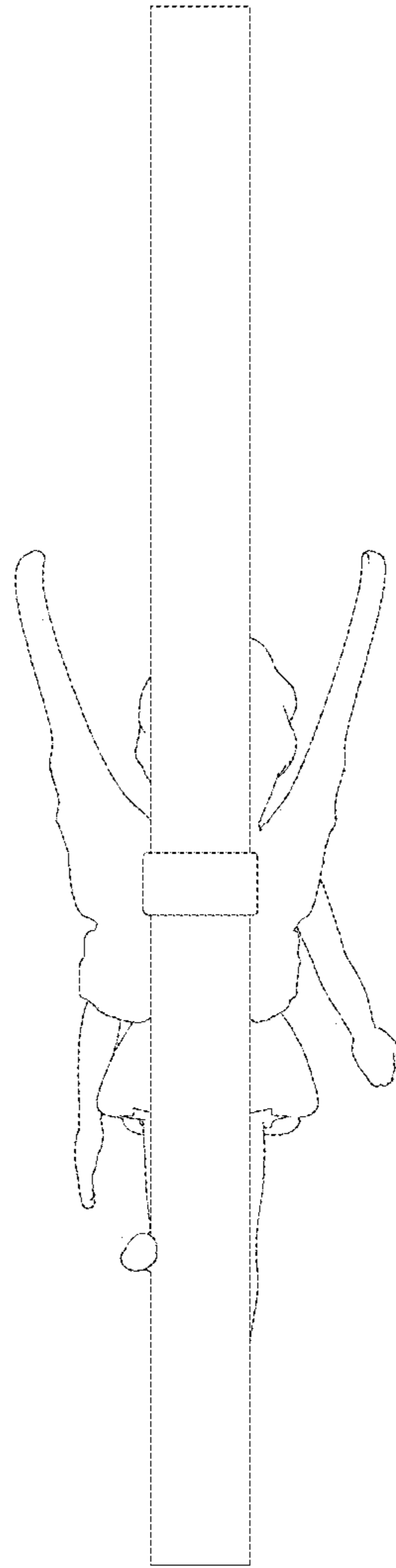

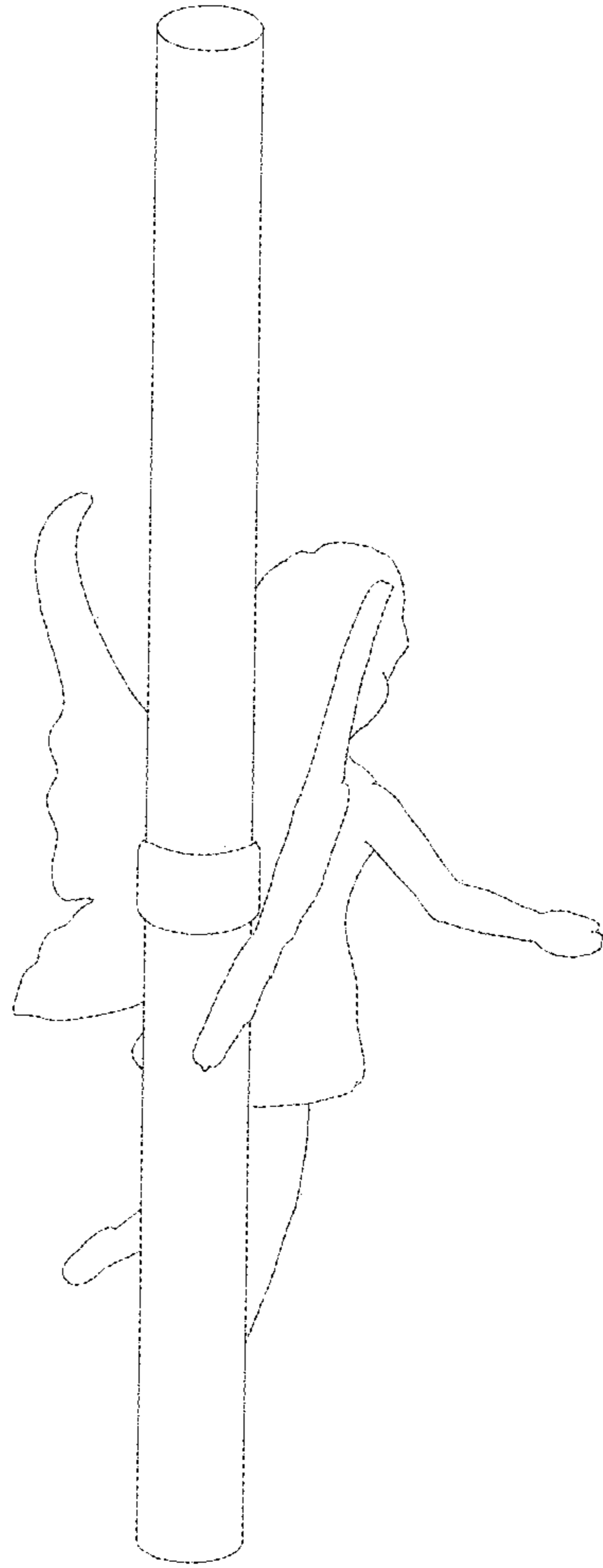

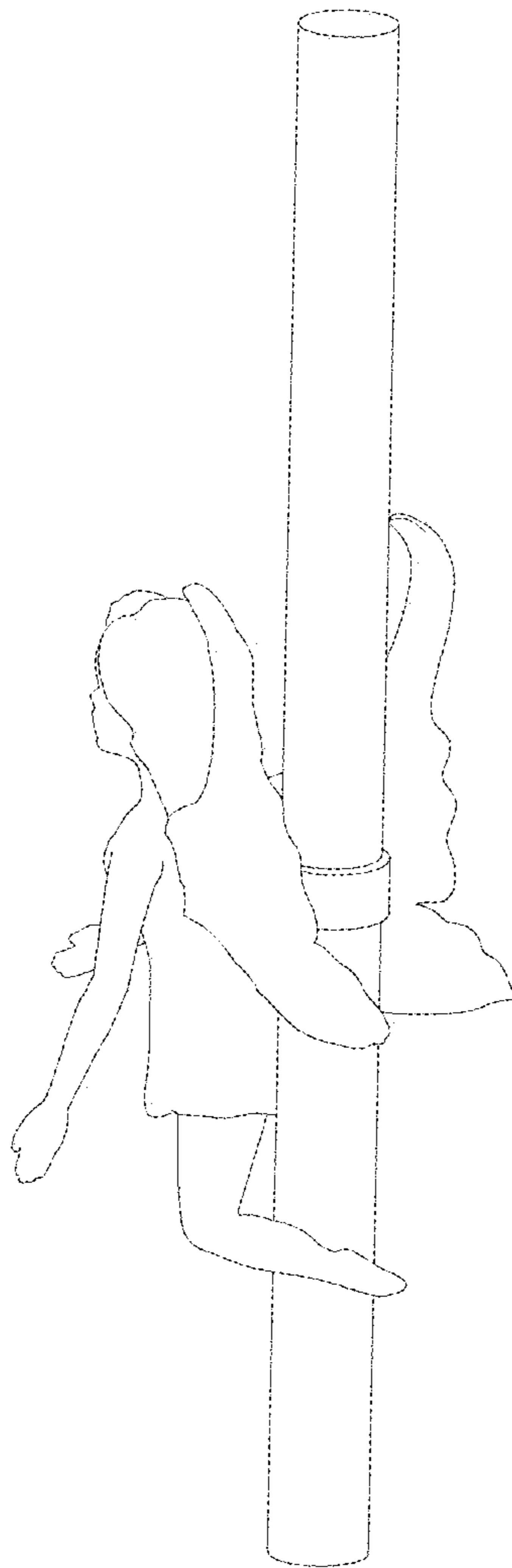

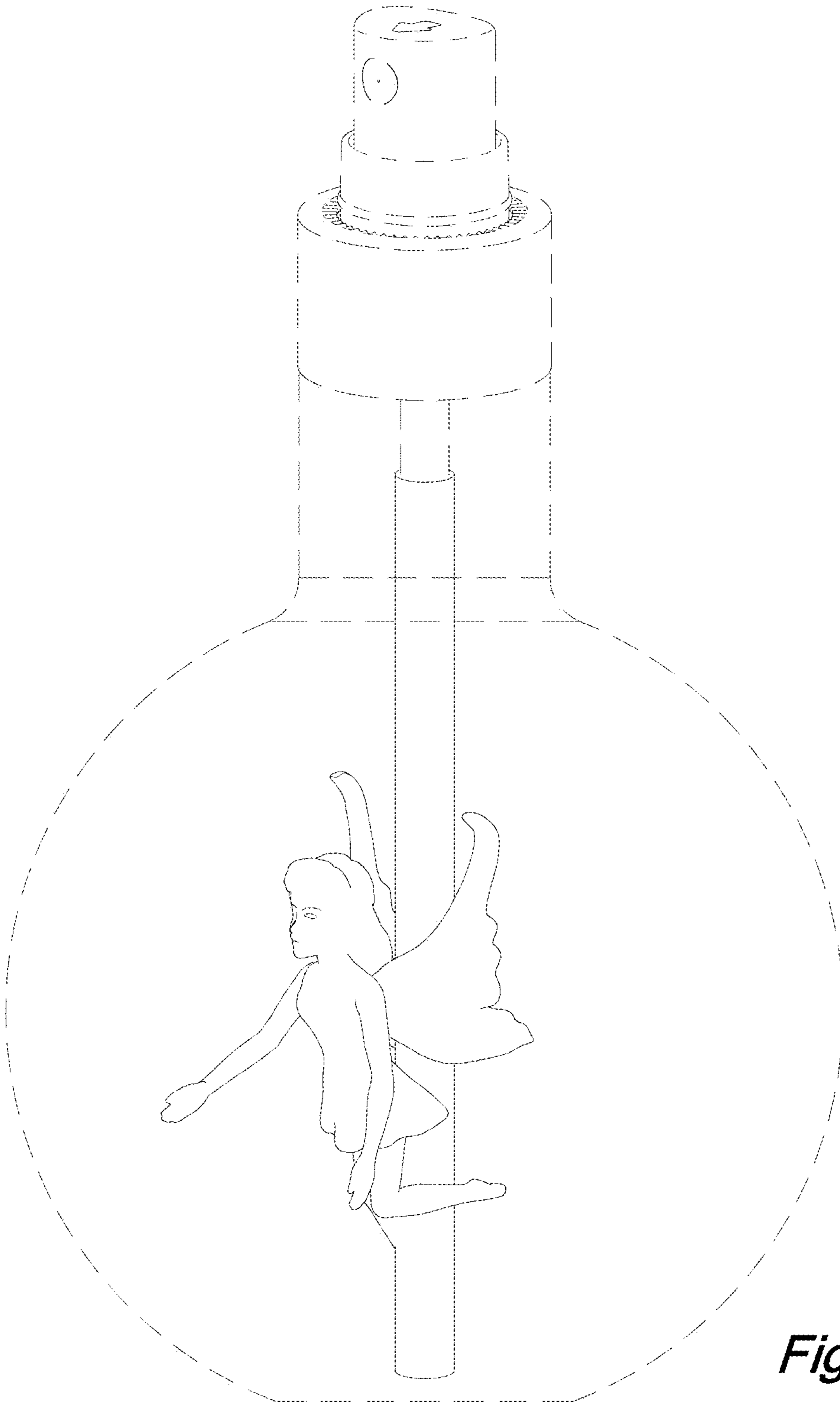

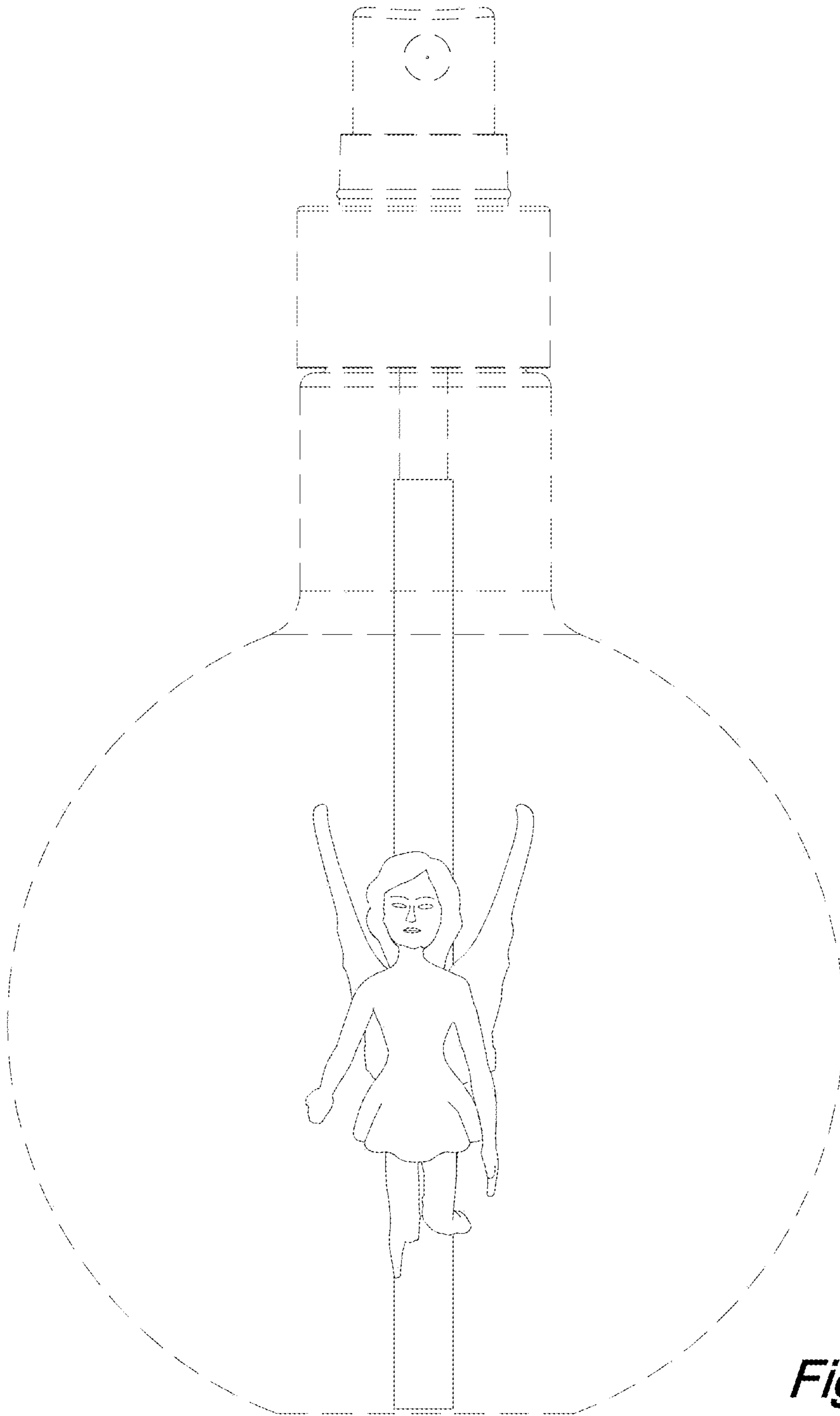
