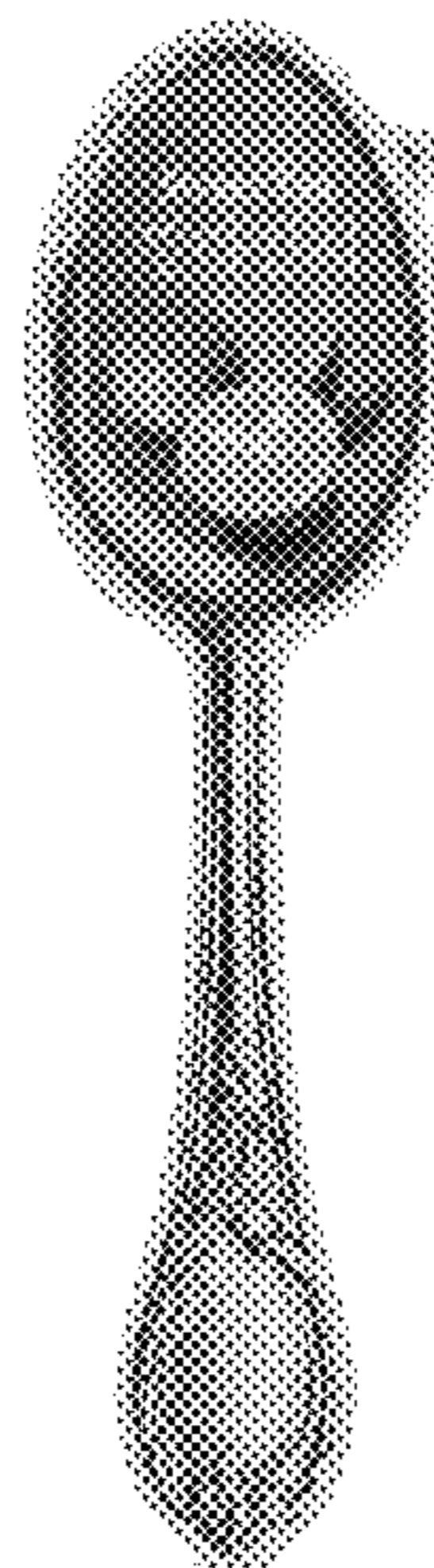
The ornamental design for container for food packing, as shown and described.

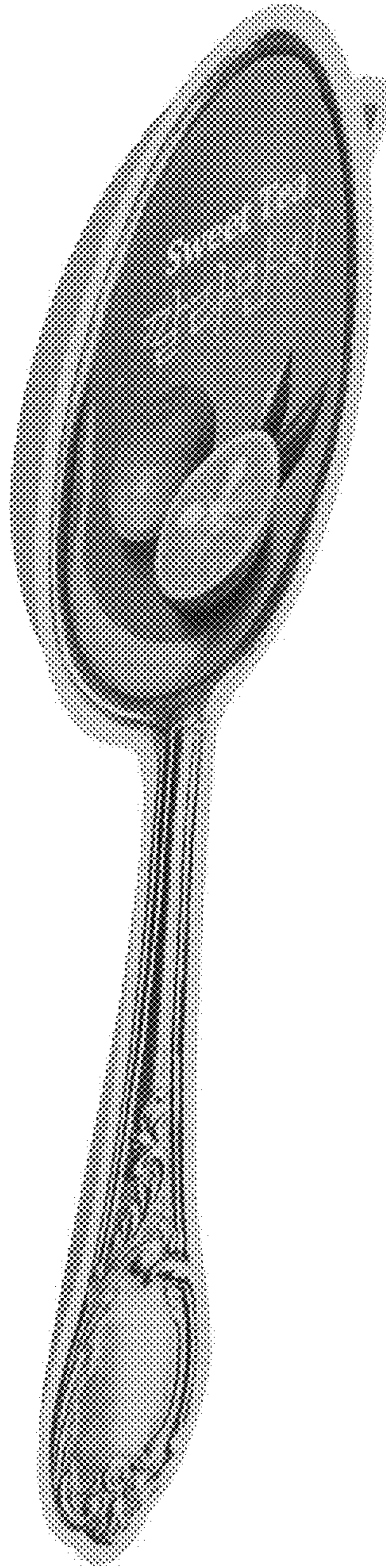

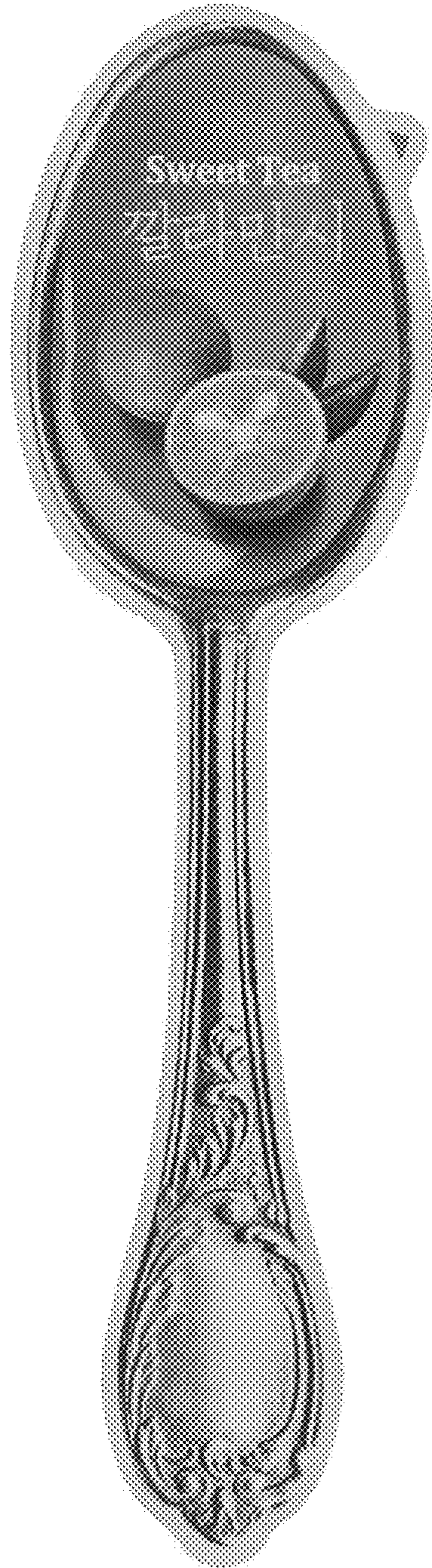
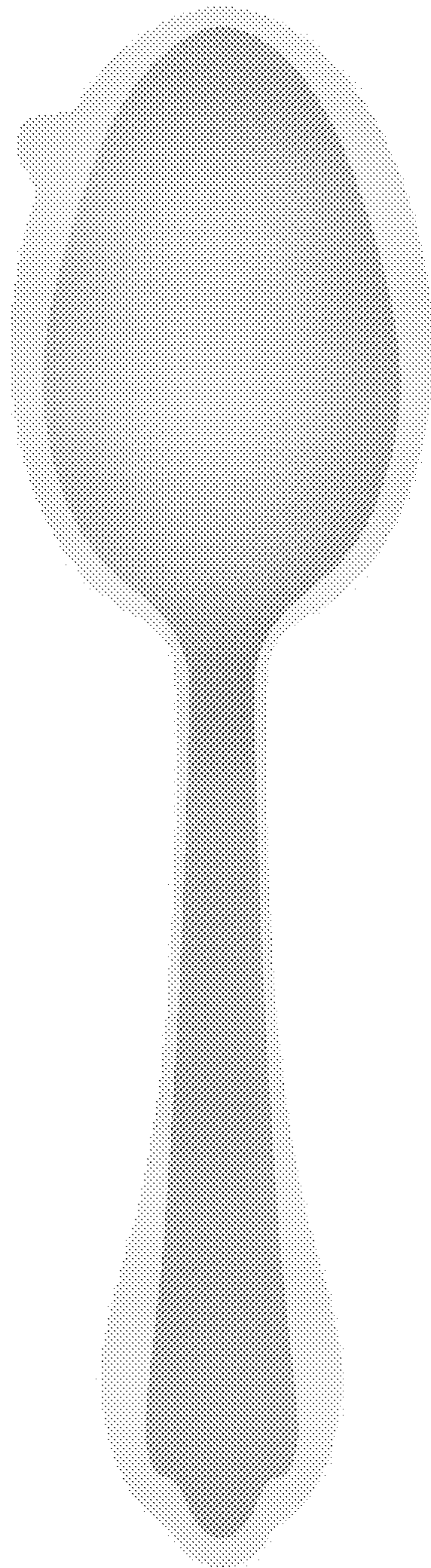
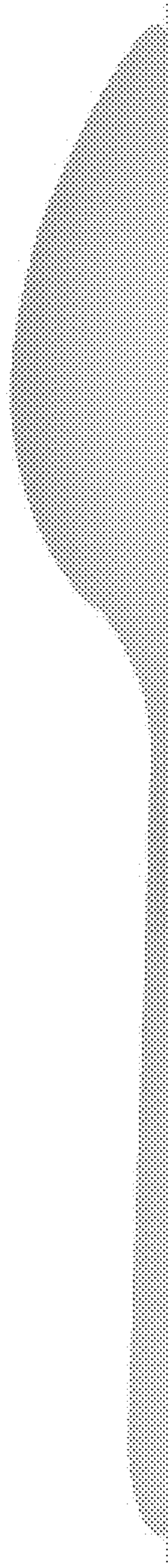

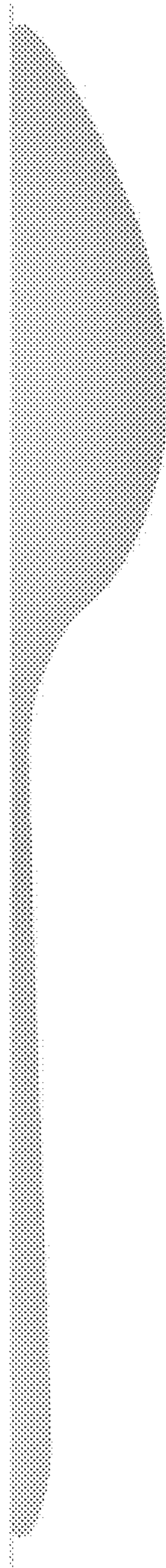
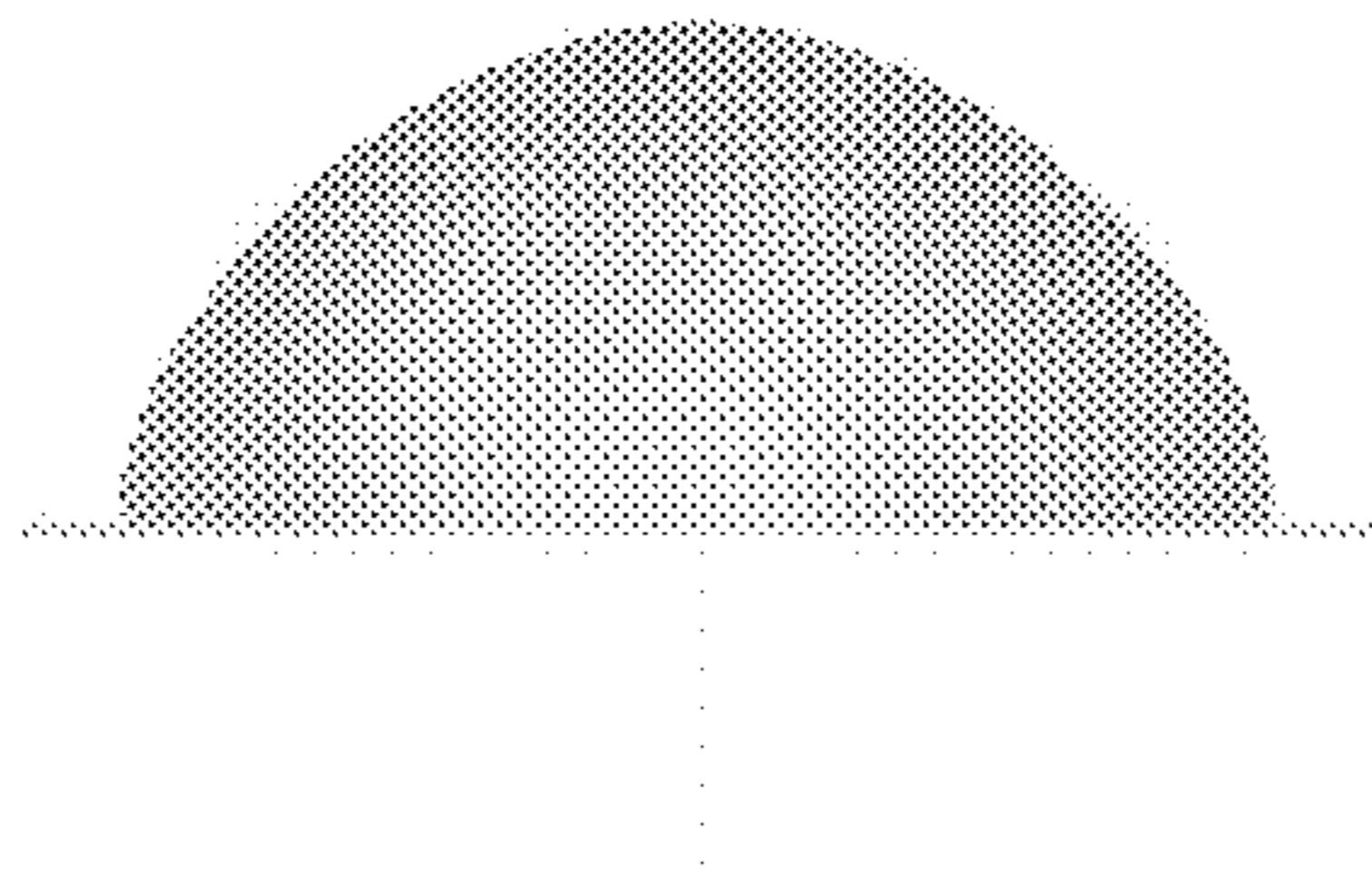
