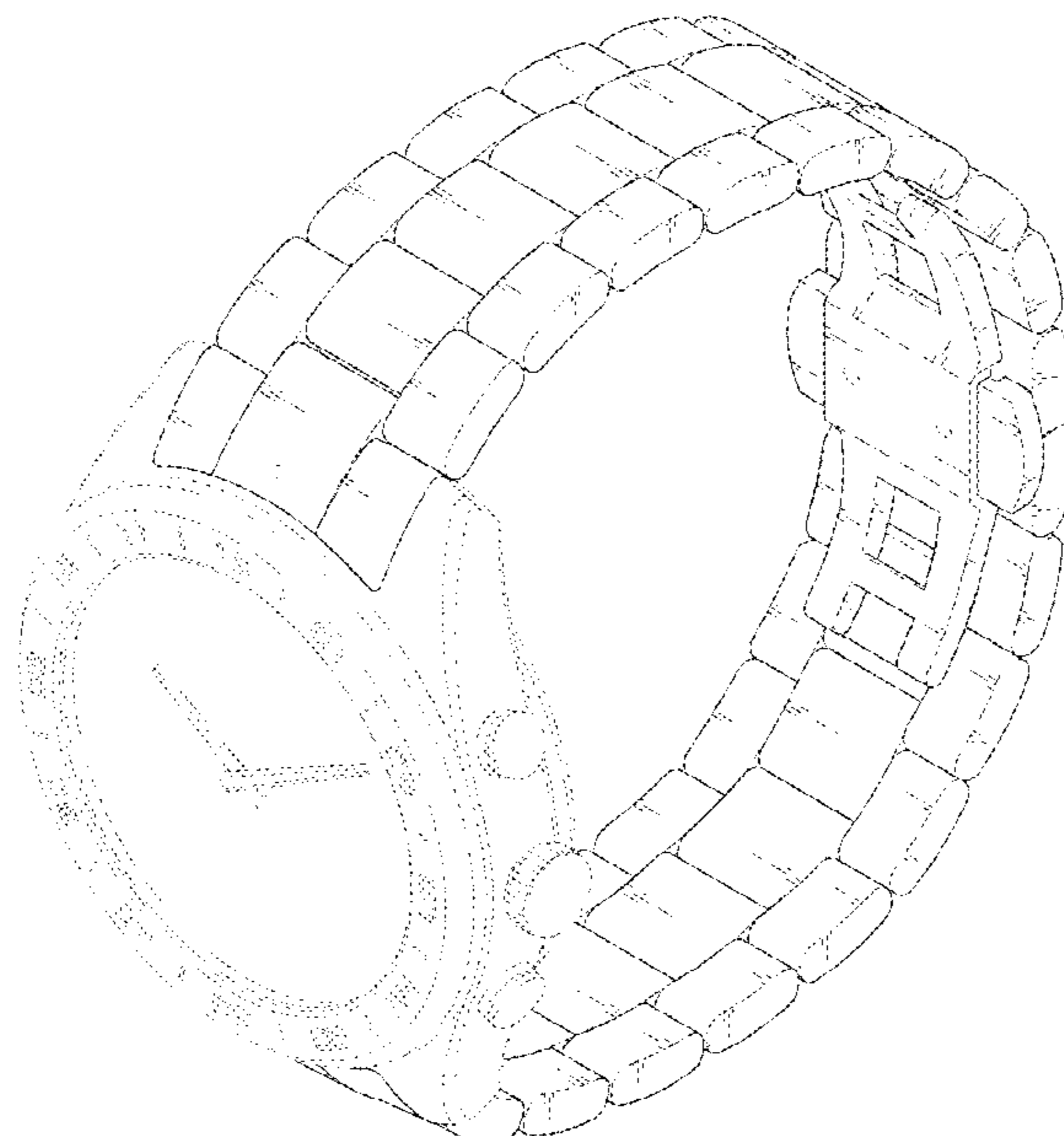

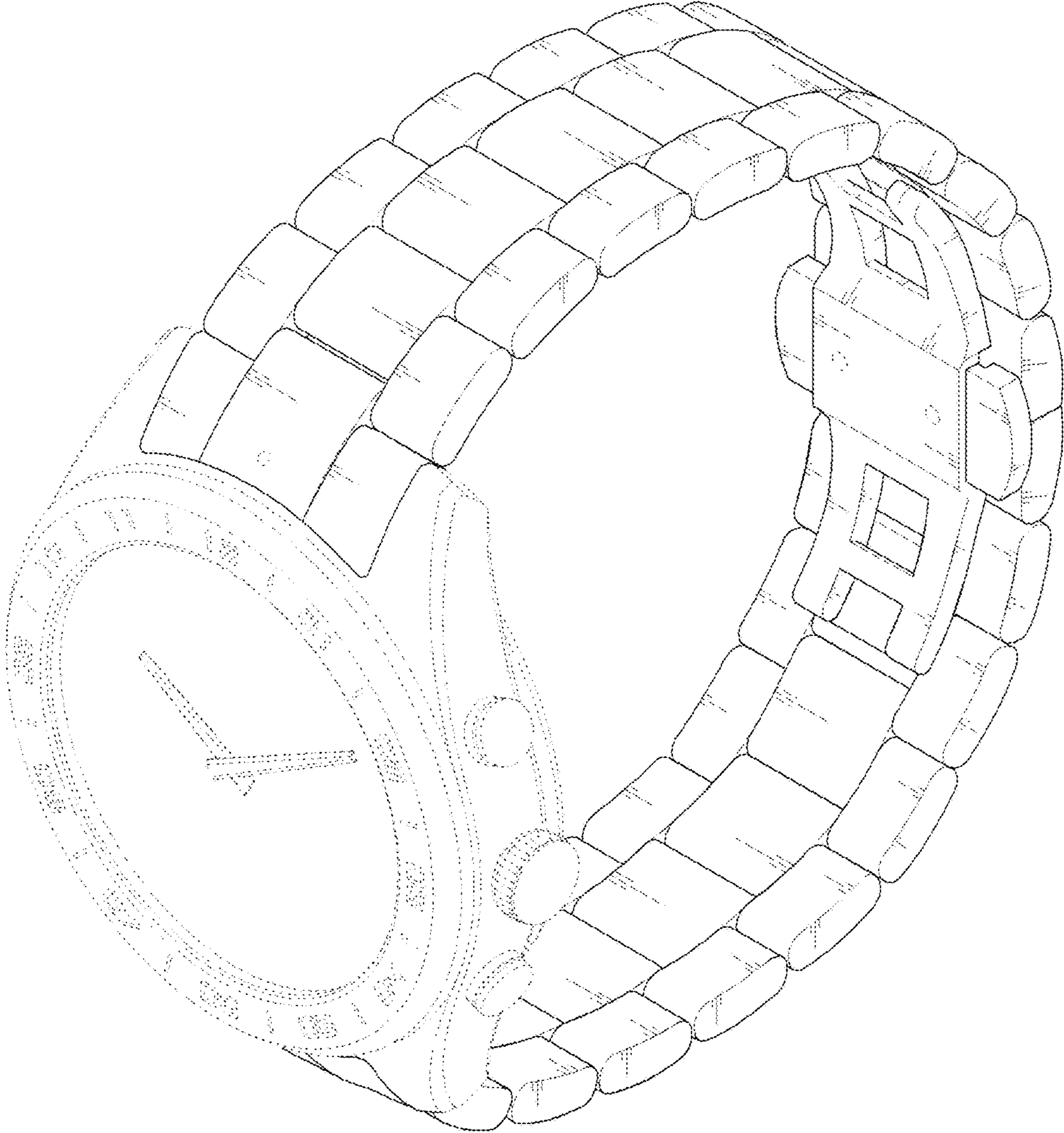

The broken lines depict portions of the smartwatch that form no part of the claimed design.

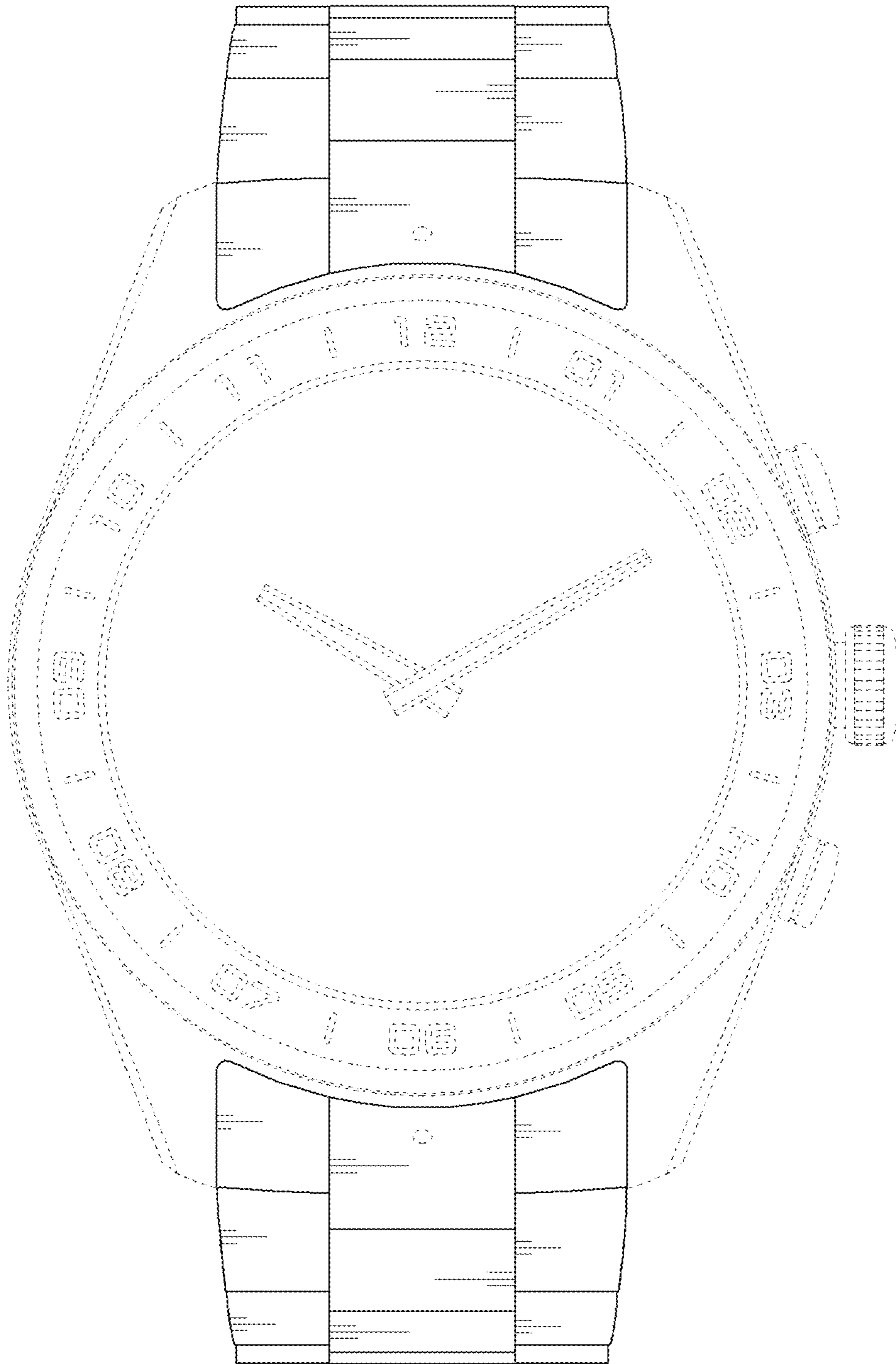

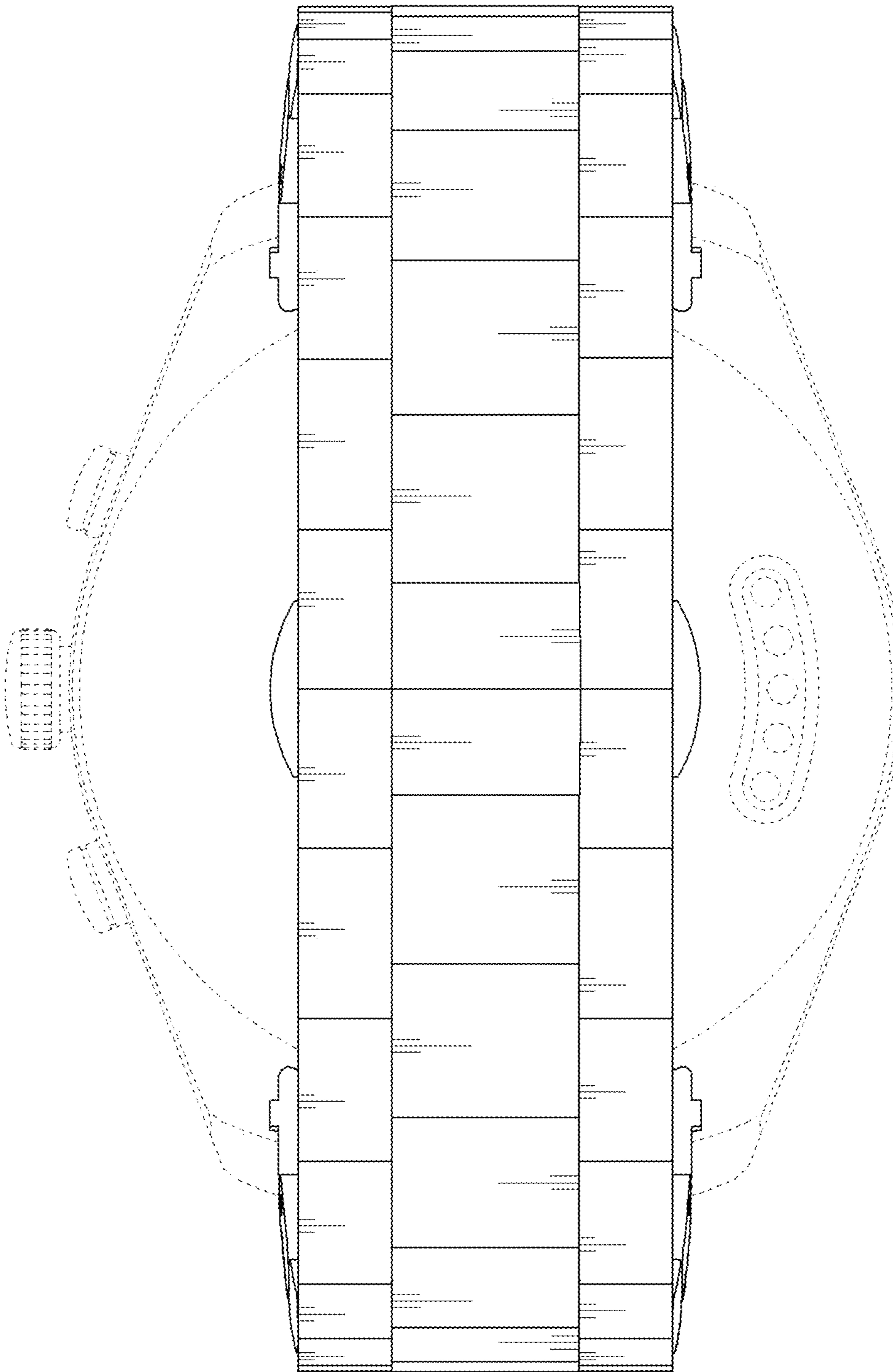

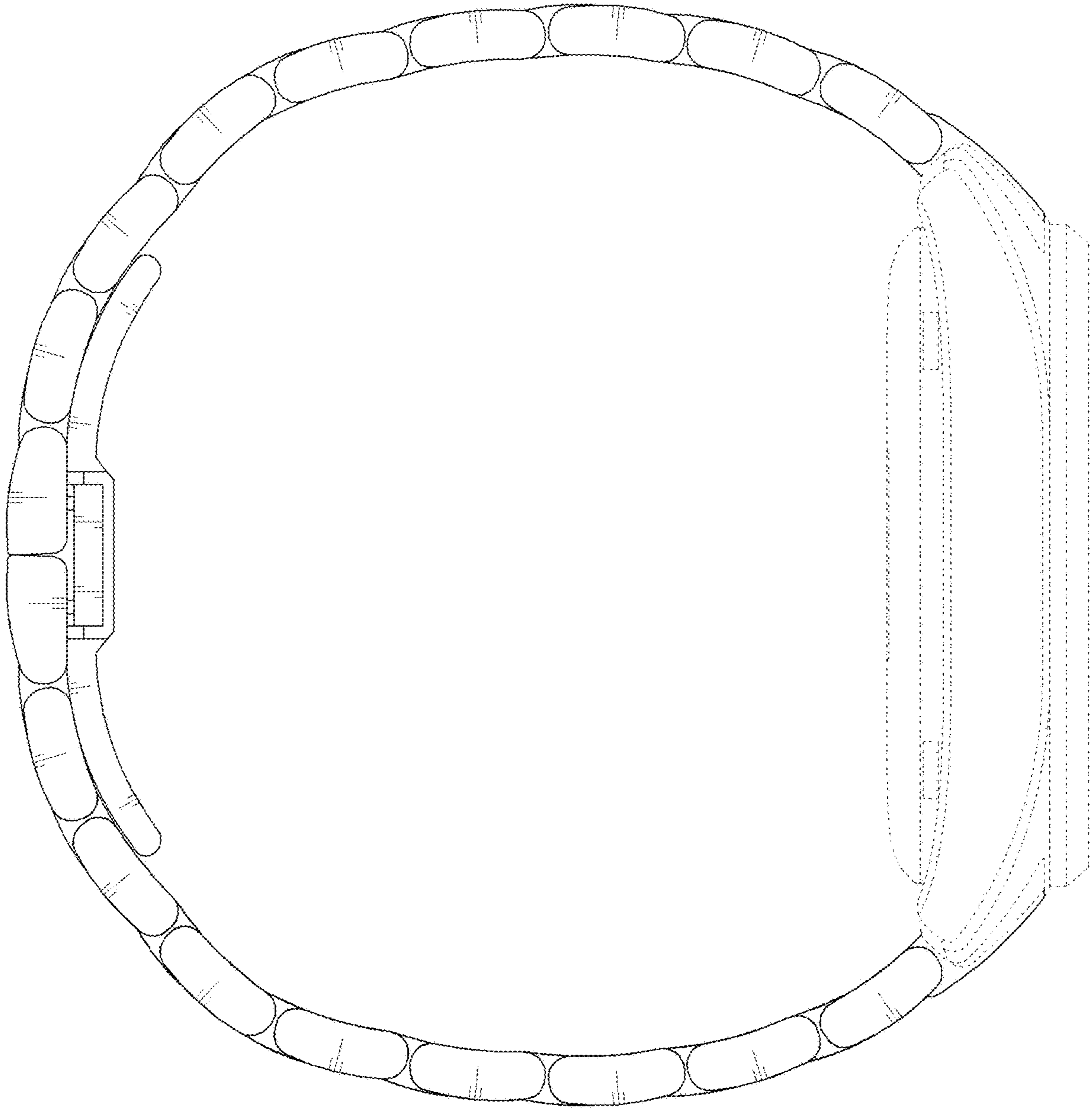

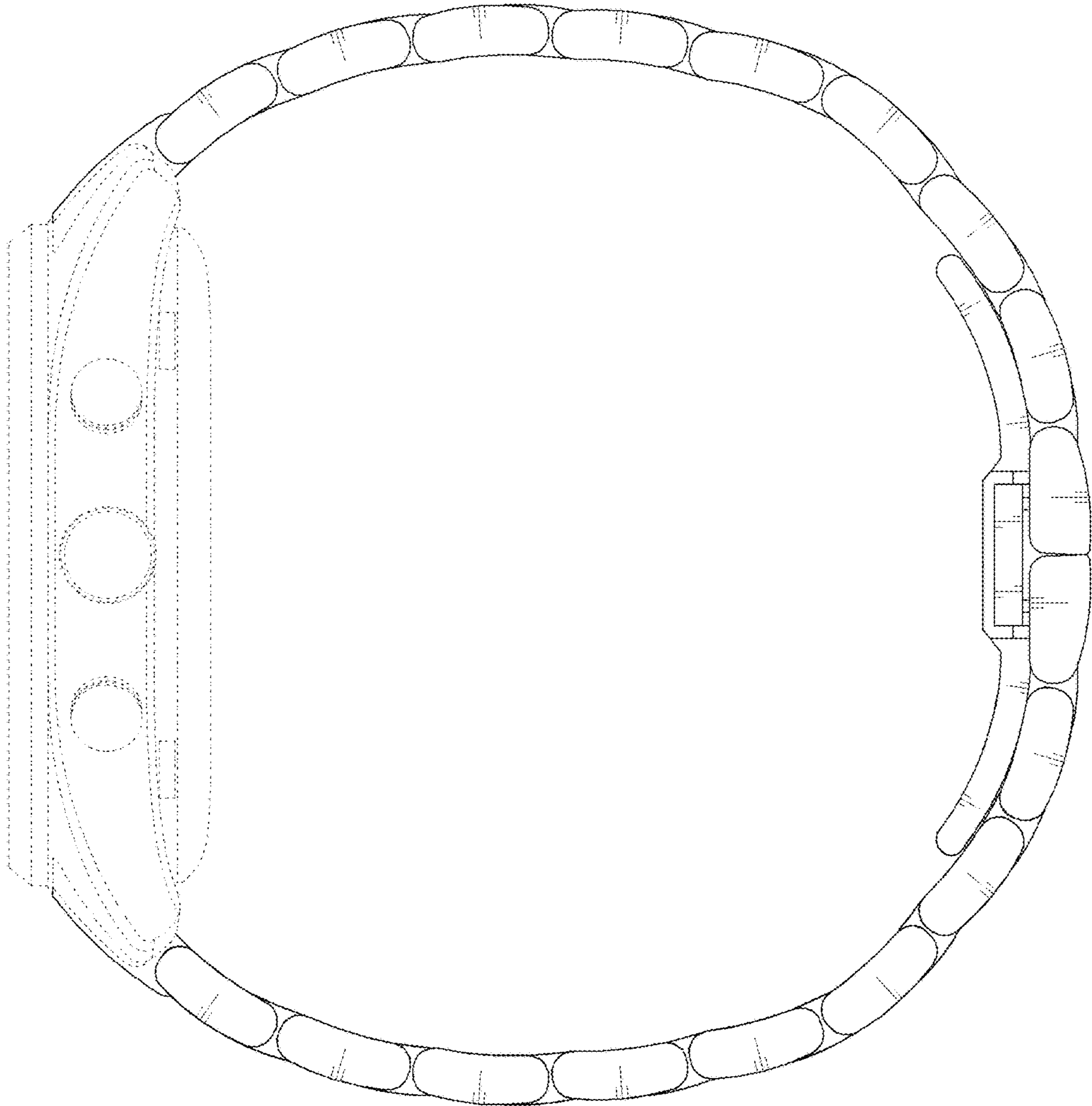

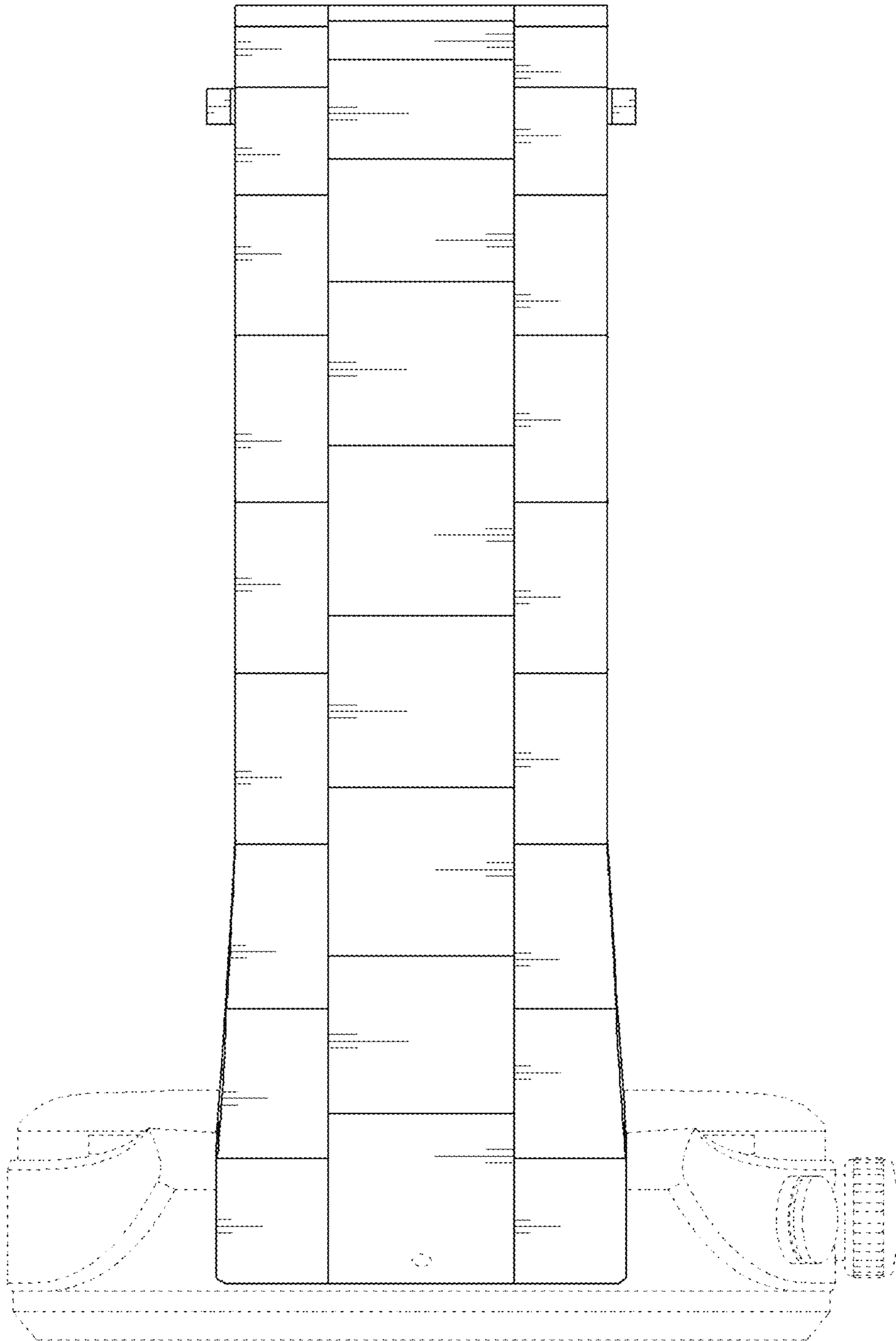
