DESCRIPTION

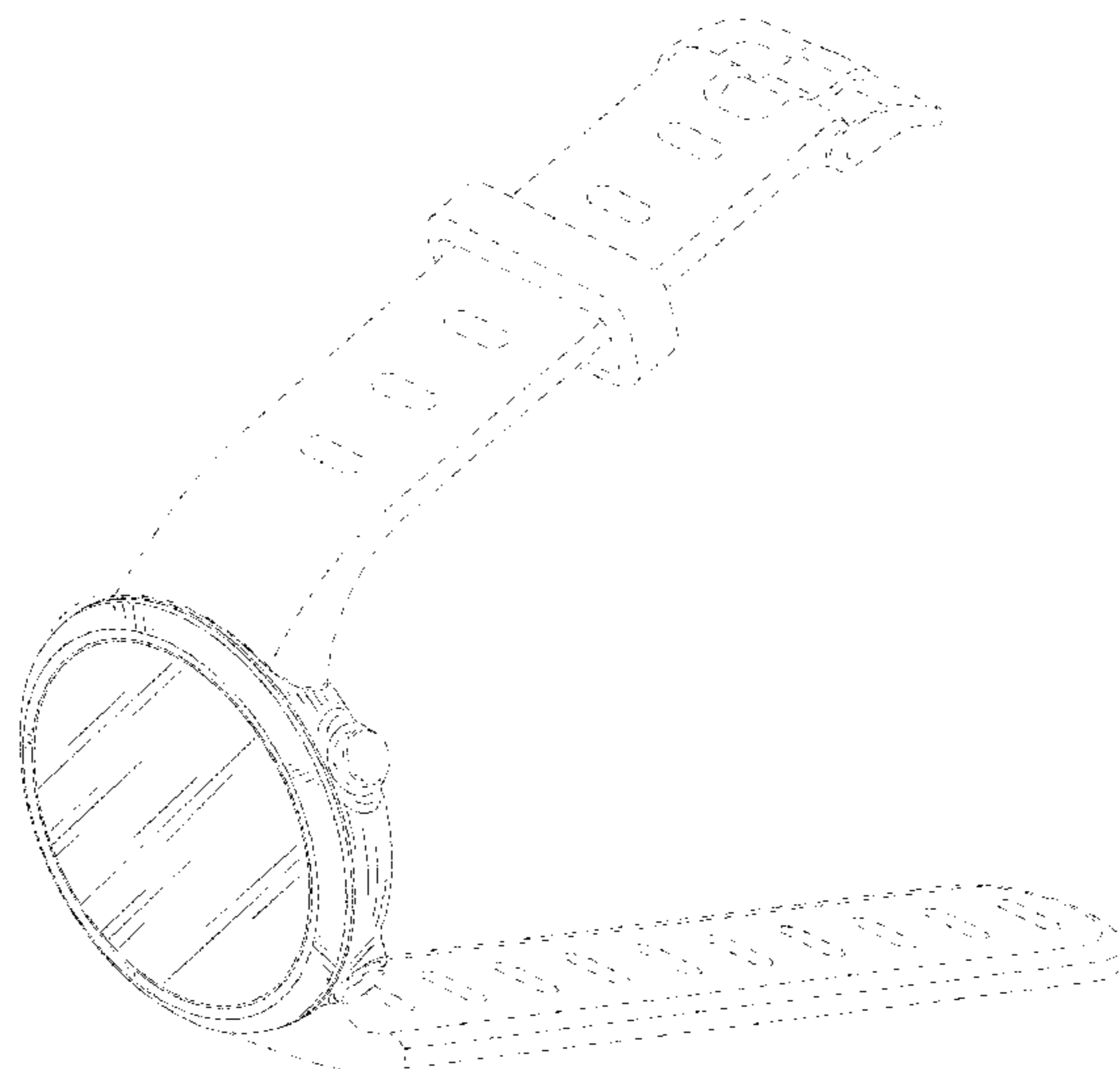
FIG. 1 is a front perspective view of a watch with display according to the present invention;

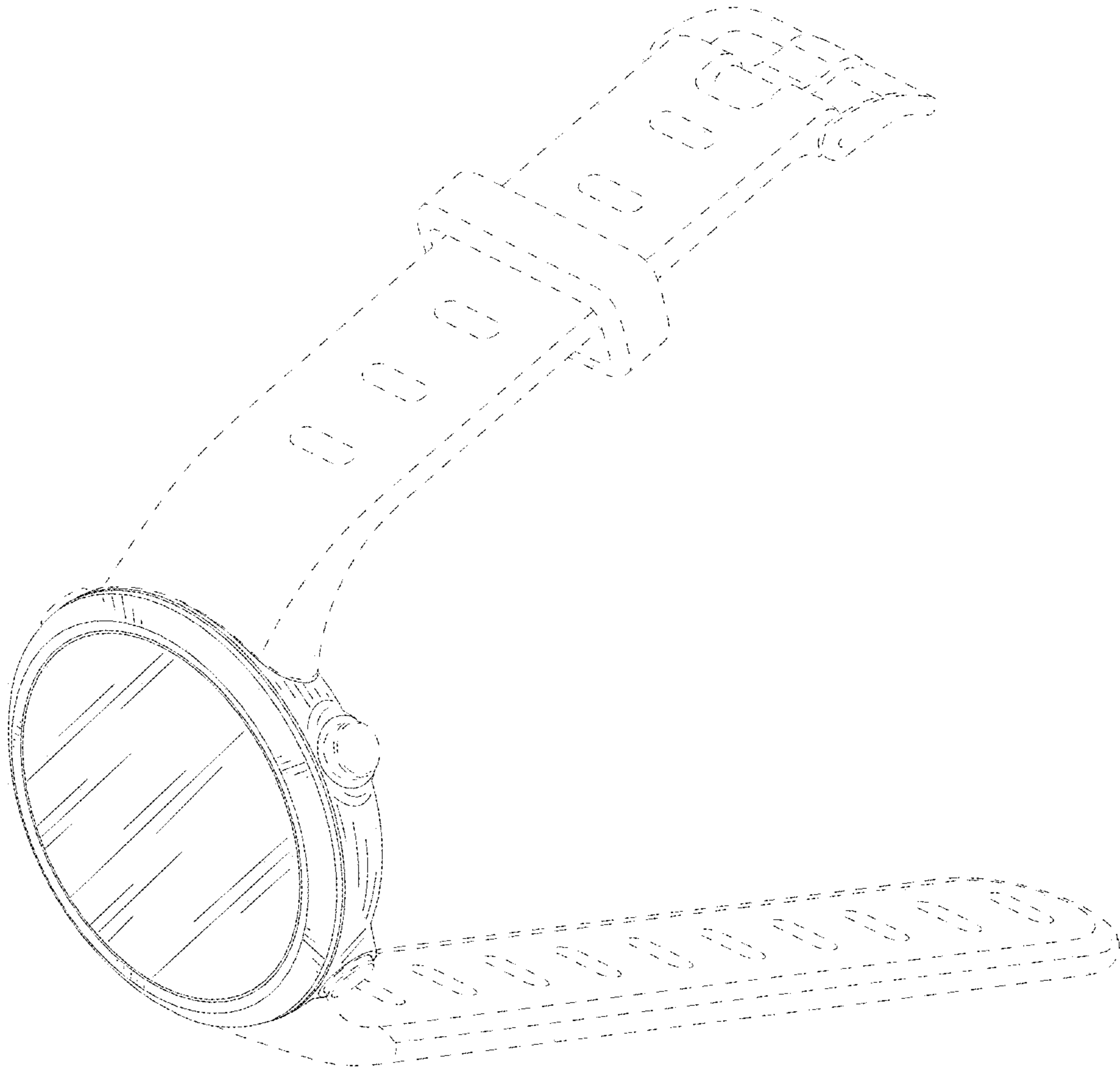

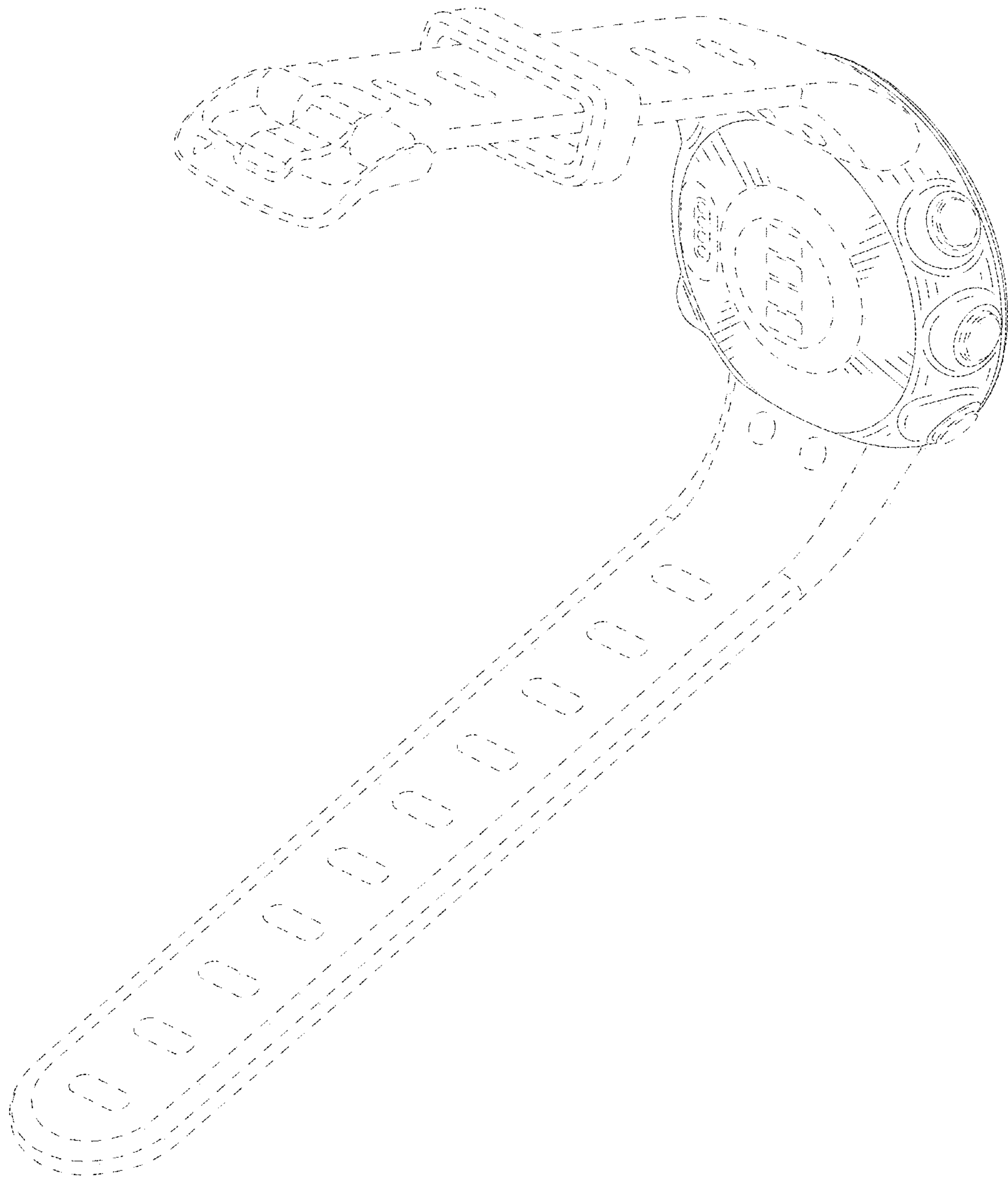

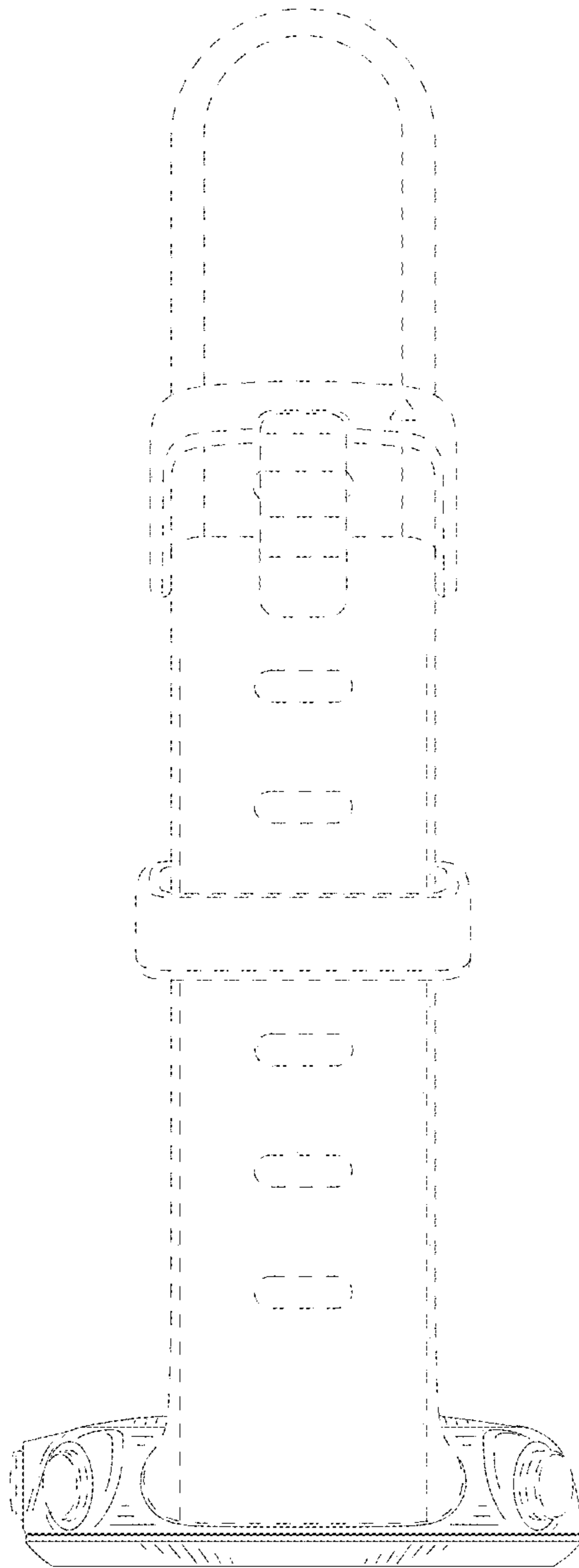

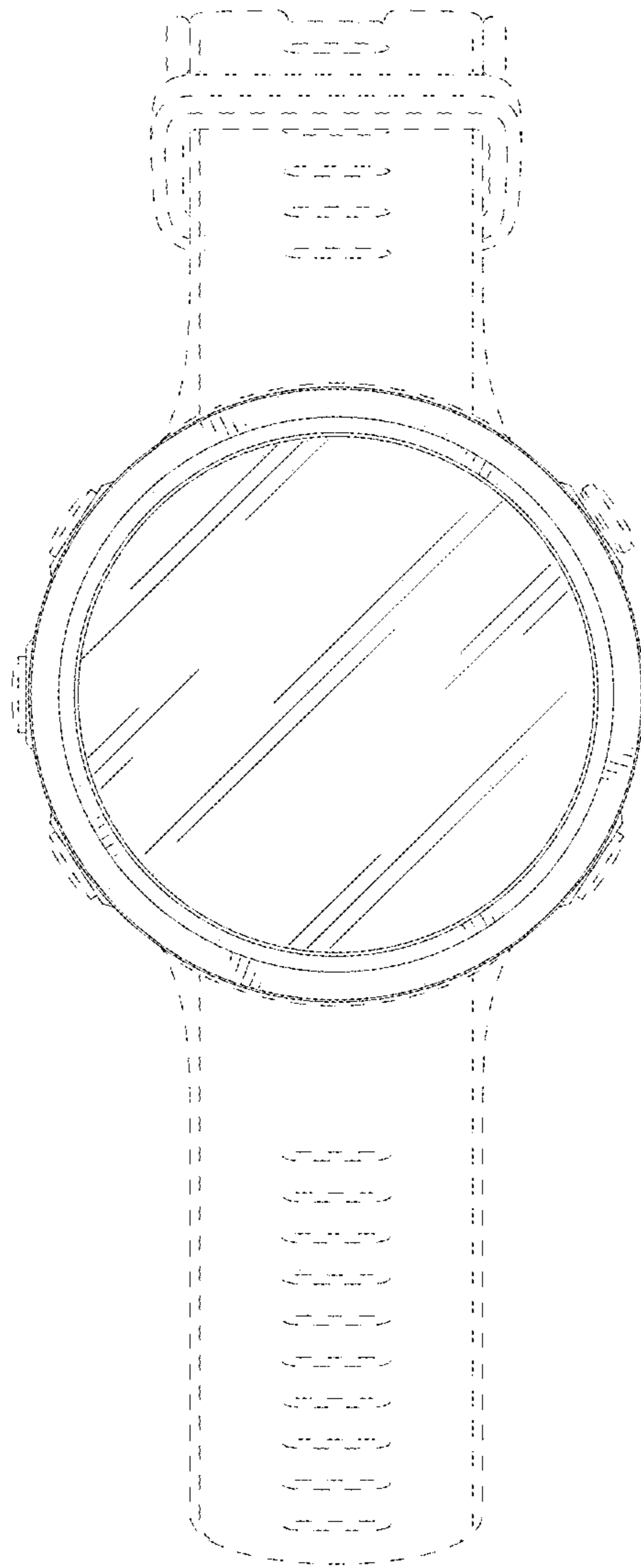

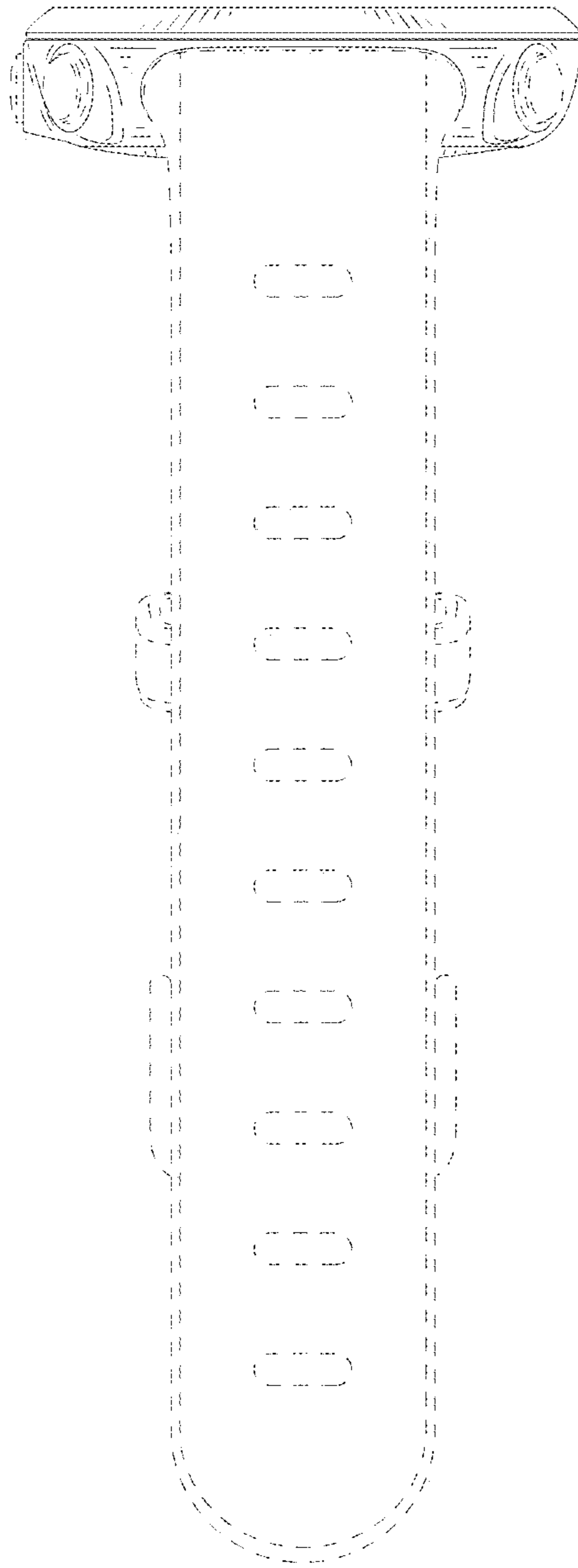

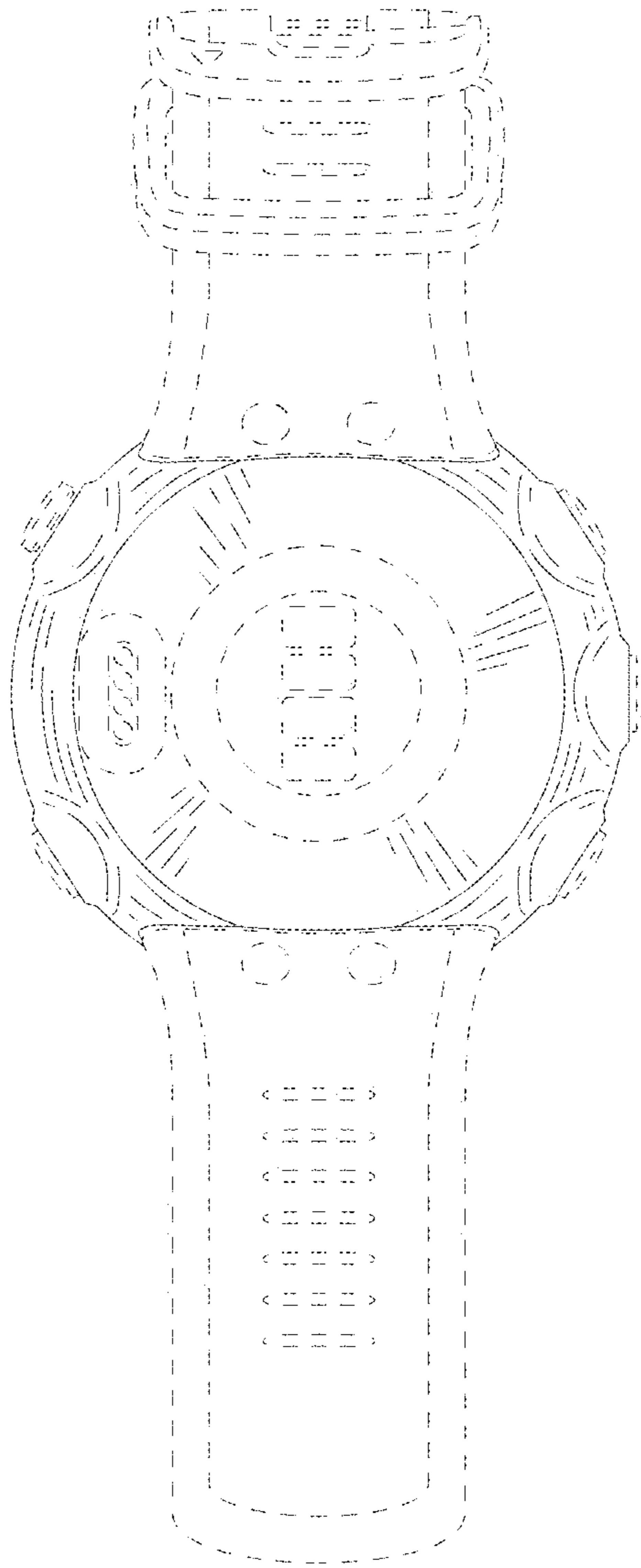

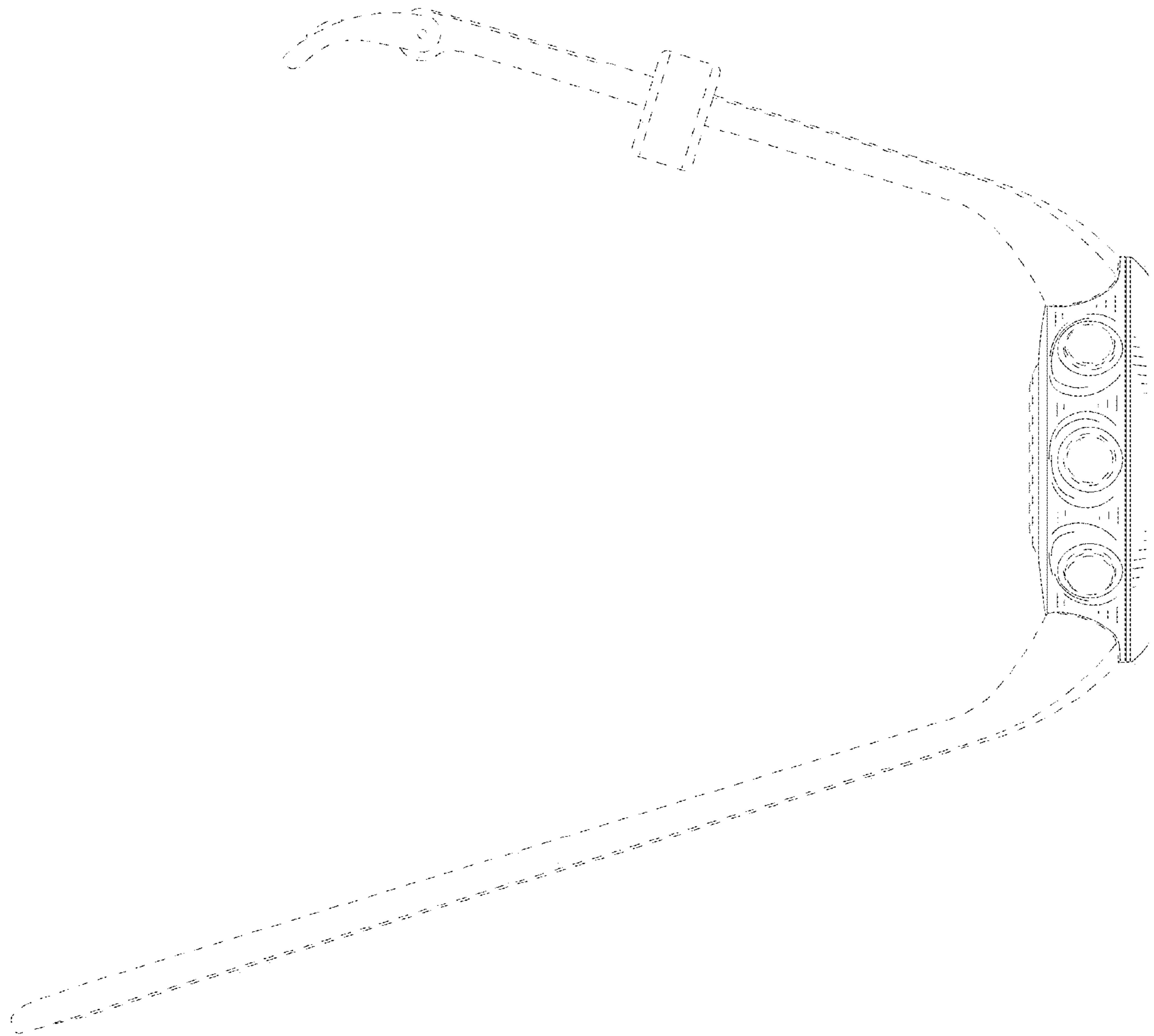

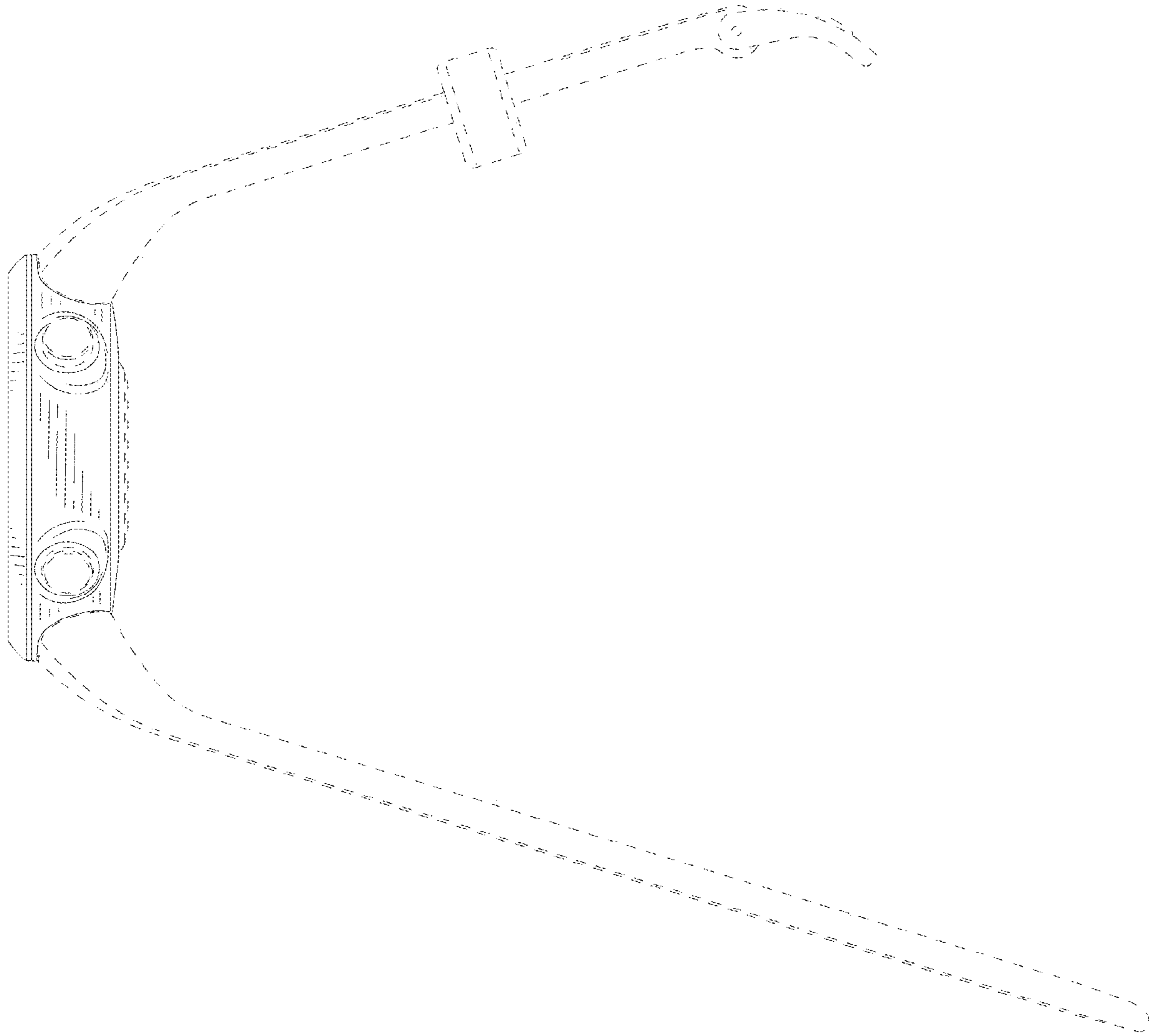
