The ornamental design for a watch, as shown and described.

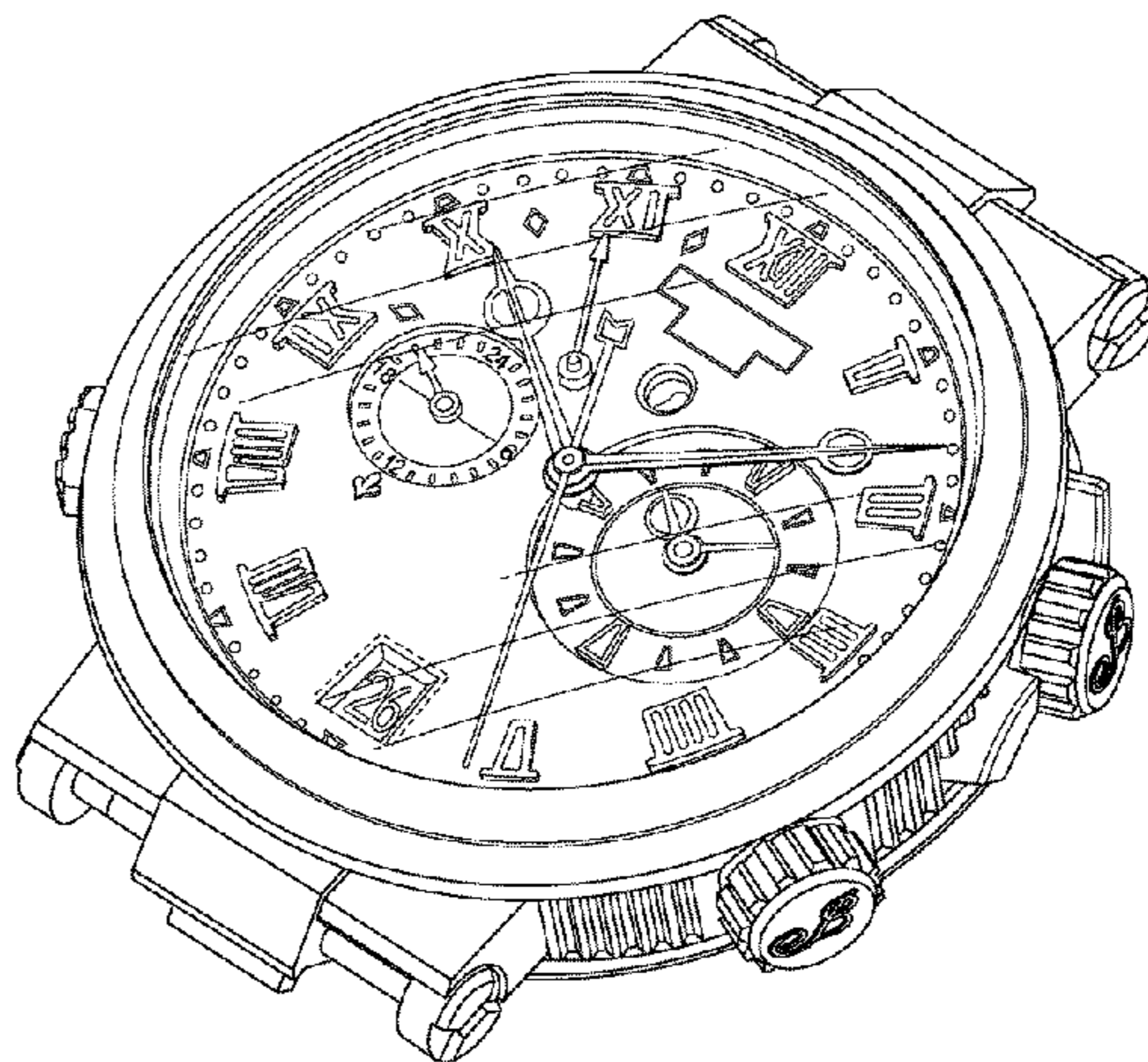
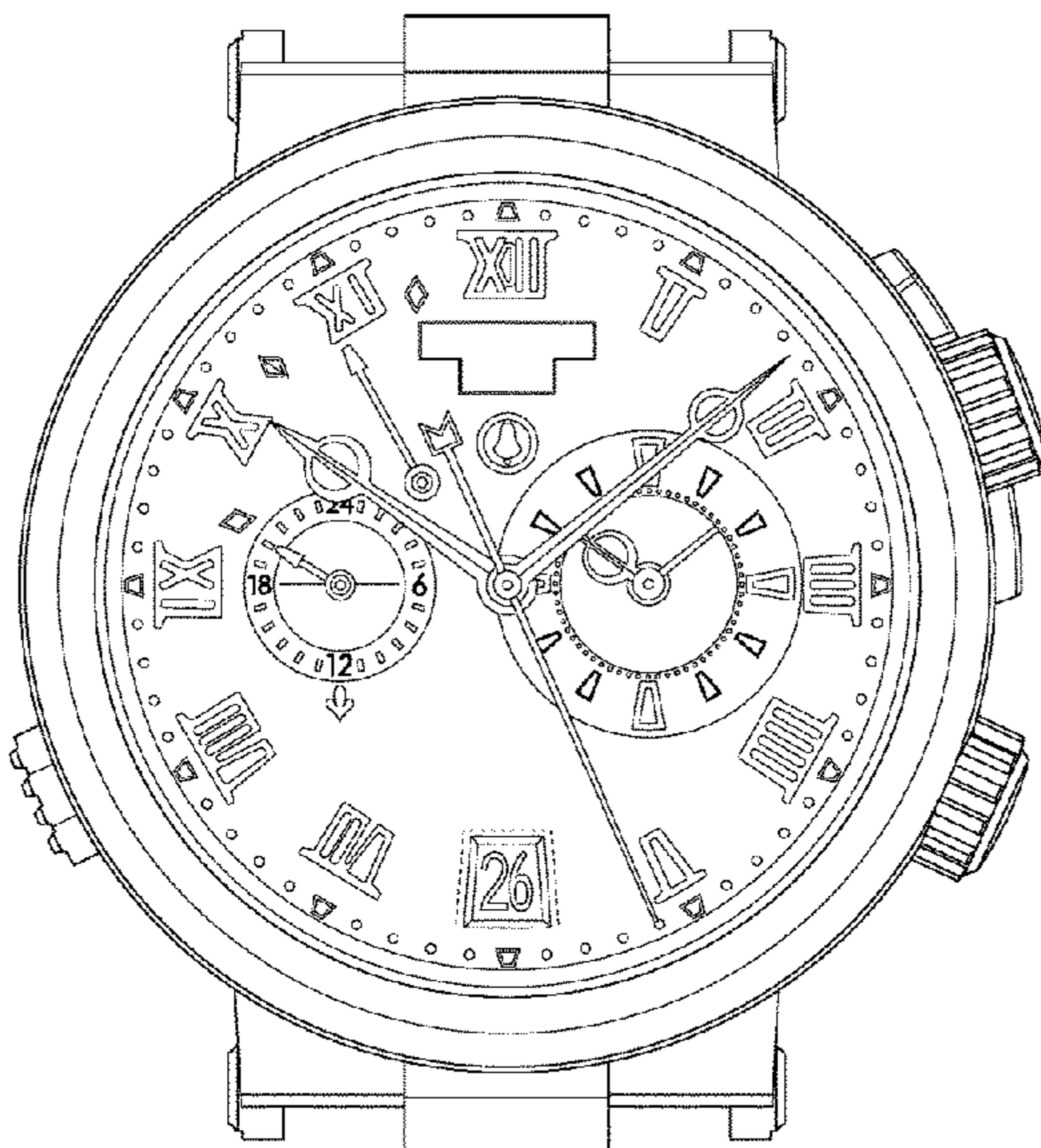
DESCRIPTION

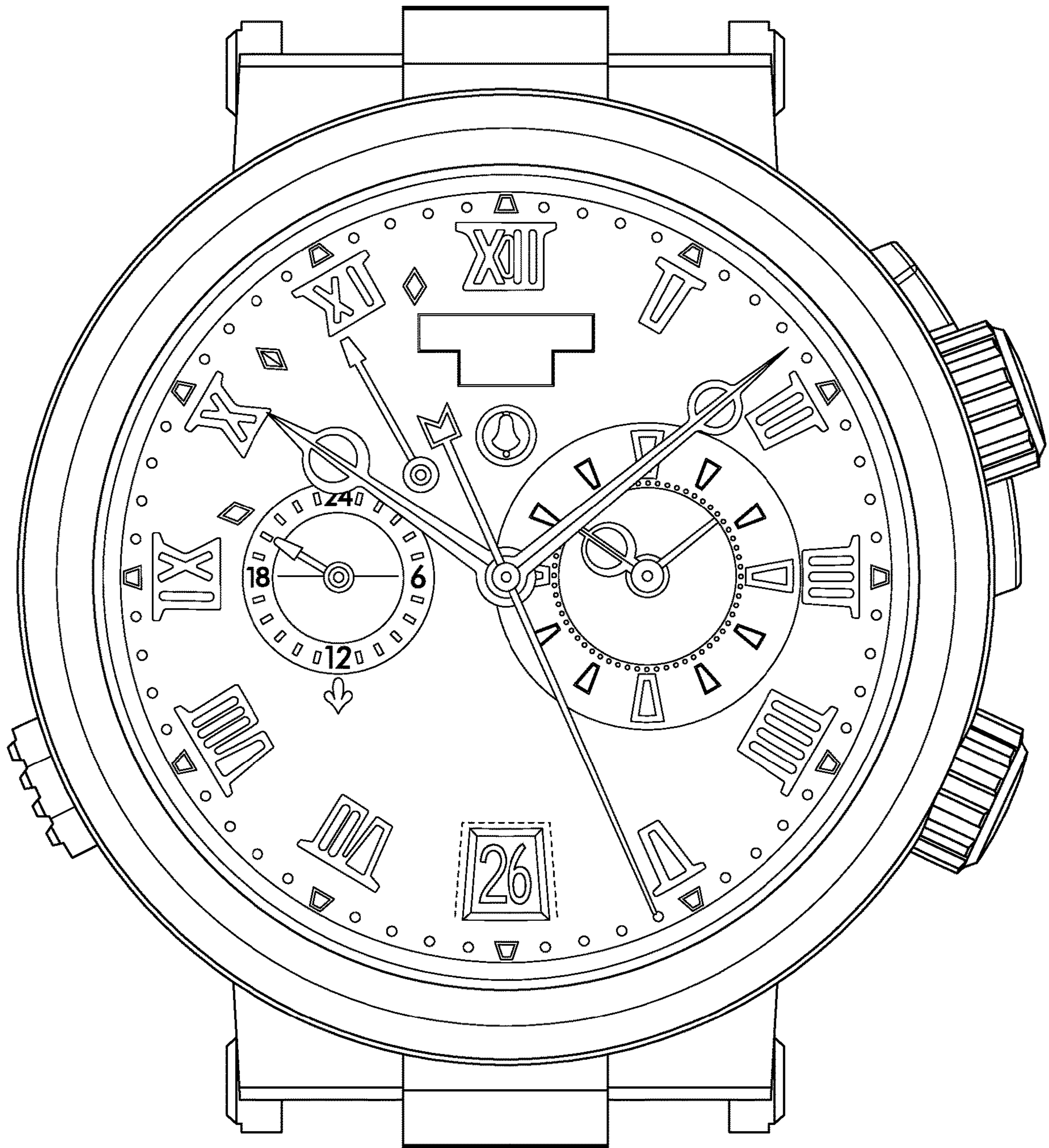

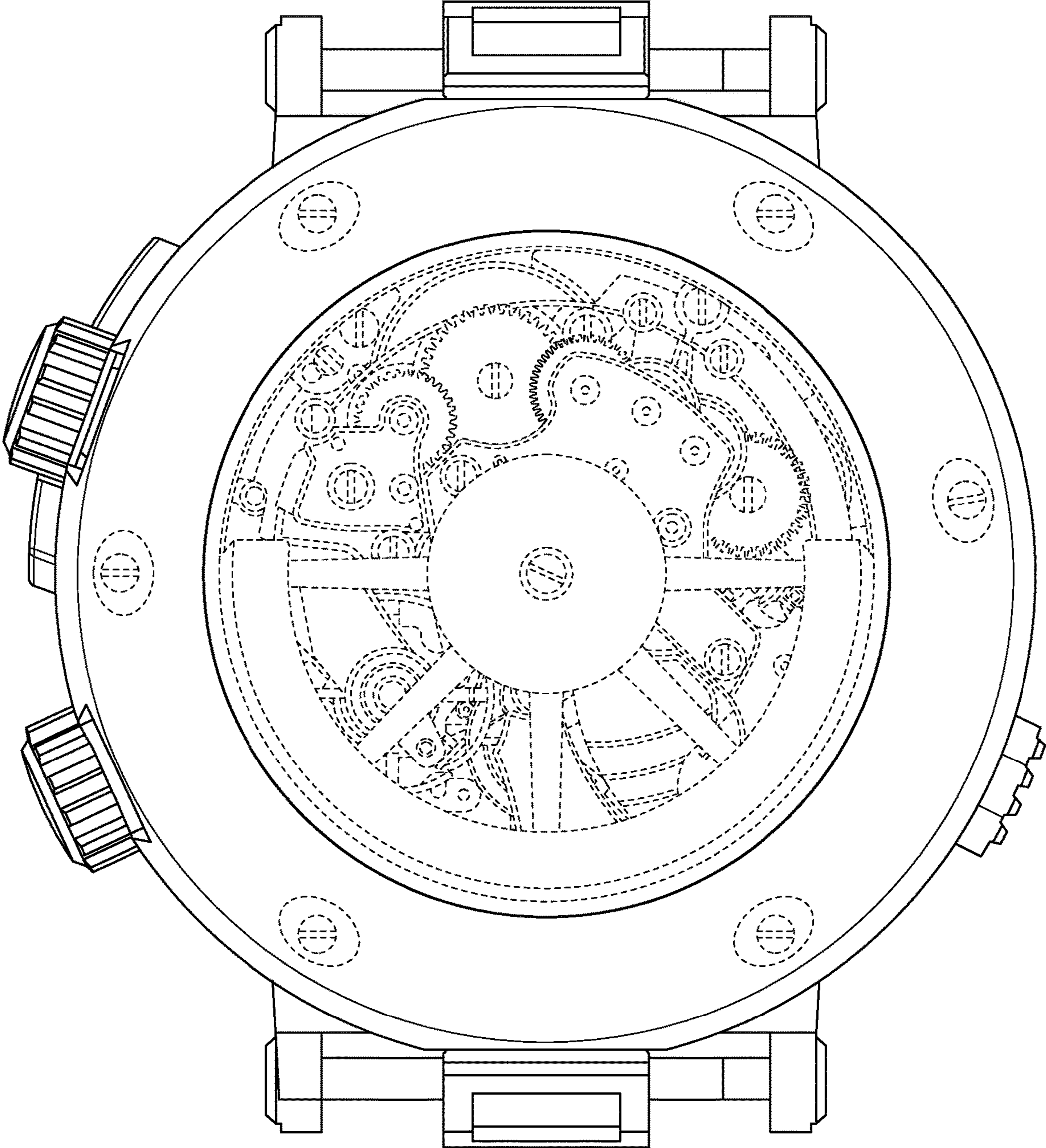

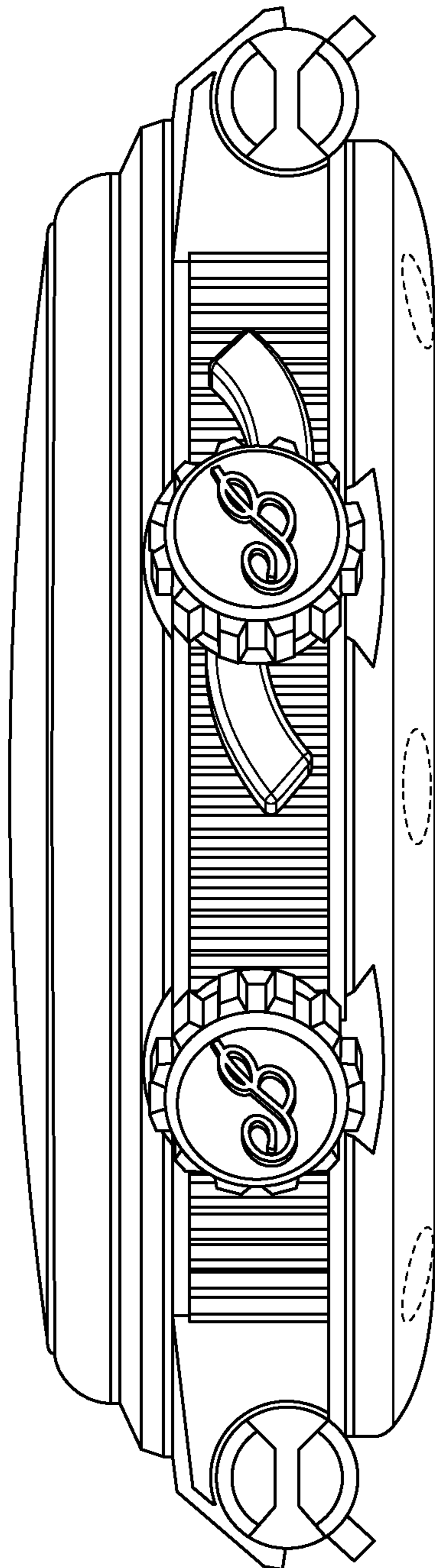

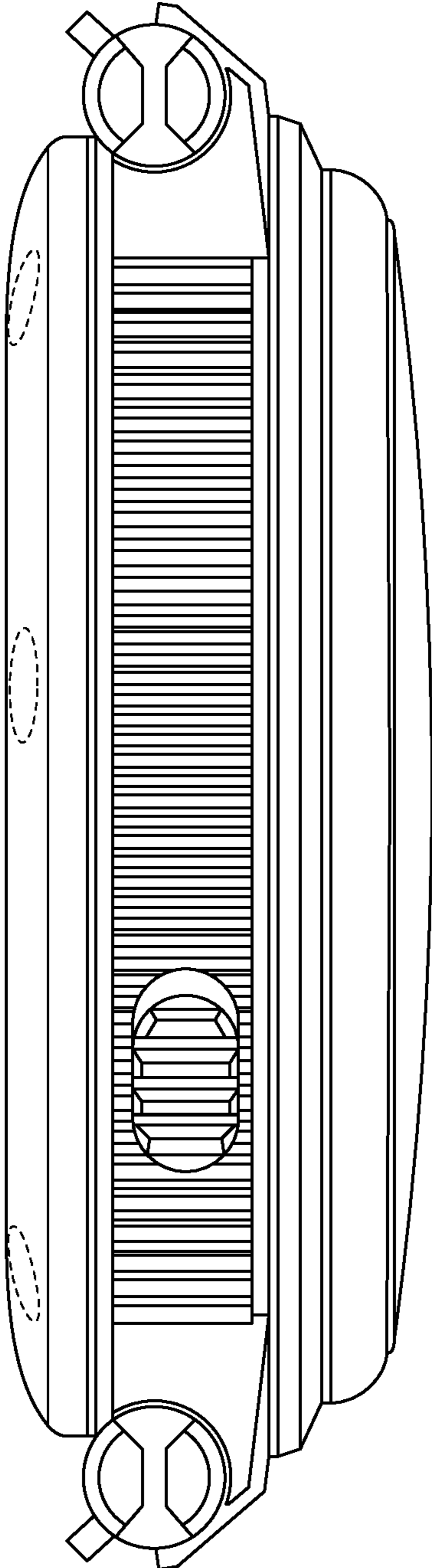

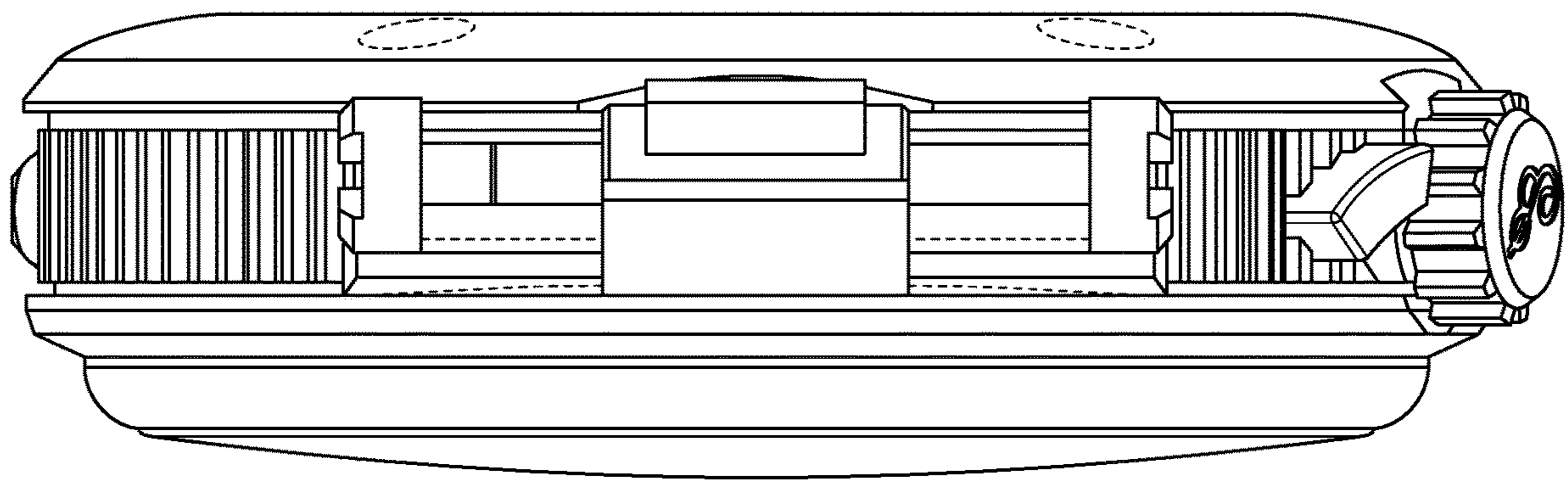

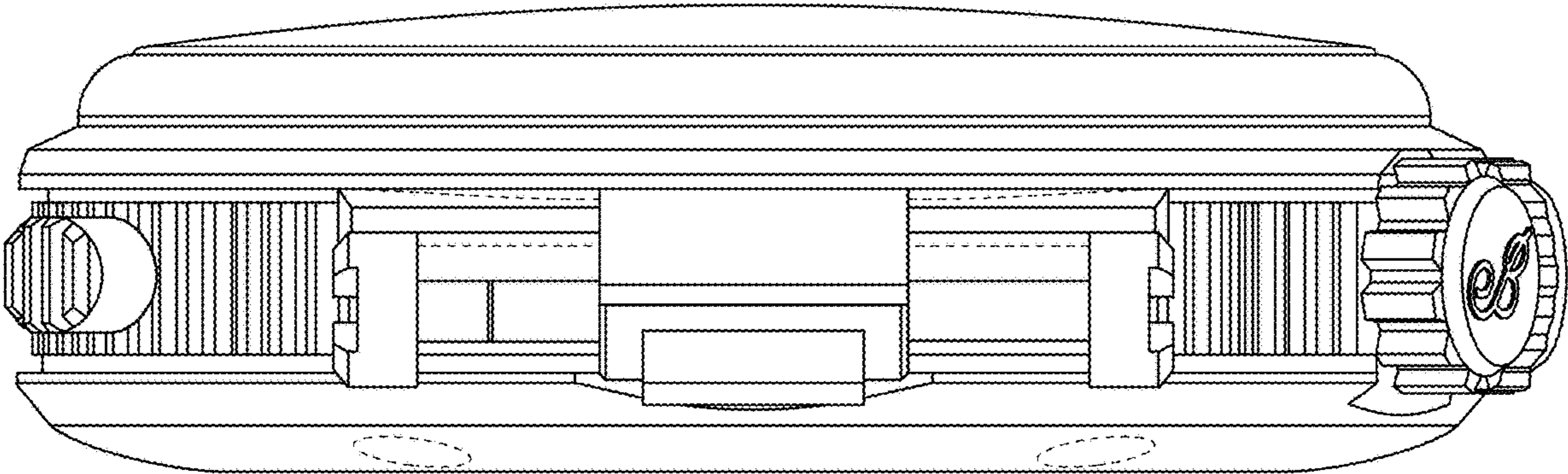
