The ornamental design for a pendant, as shown and described.

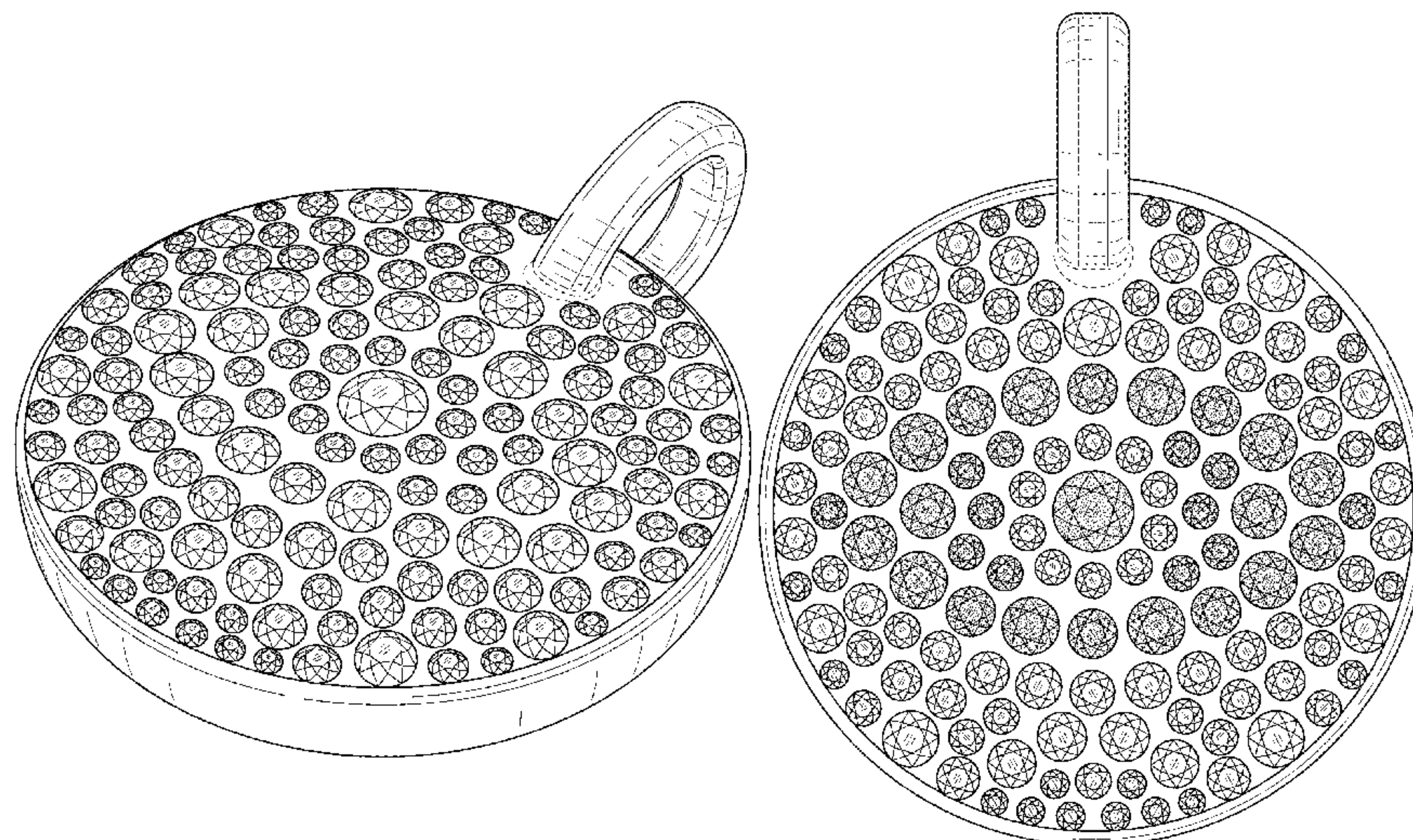
DESCRIPTION

FIG. 1 is a front view of a pendant showing my new design; FIG. 2 is a rear view thereof; FIG. 3 is a right side view thereof; FIG. 4 is a left side view thereof; FIG. 5 is a top view thereof; FIG. 6 is a bottom view thereof; FIG. 7 is a front perspective view thereof; and, FIG. 8 is a front view of the pendant of FIGS. 1-7 showing a stone region in a changed state of appearance relative to FIGS. 1-7.

The stippling shown on the stone region in FIG. 8 represents a contrast of appearance with respect to remaining stones and the change of state if affected.

The broken lines depict portions of the pendant that form no part of the claimed design.

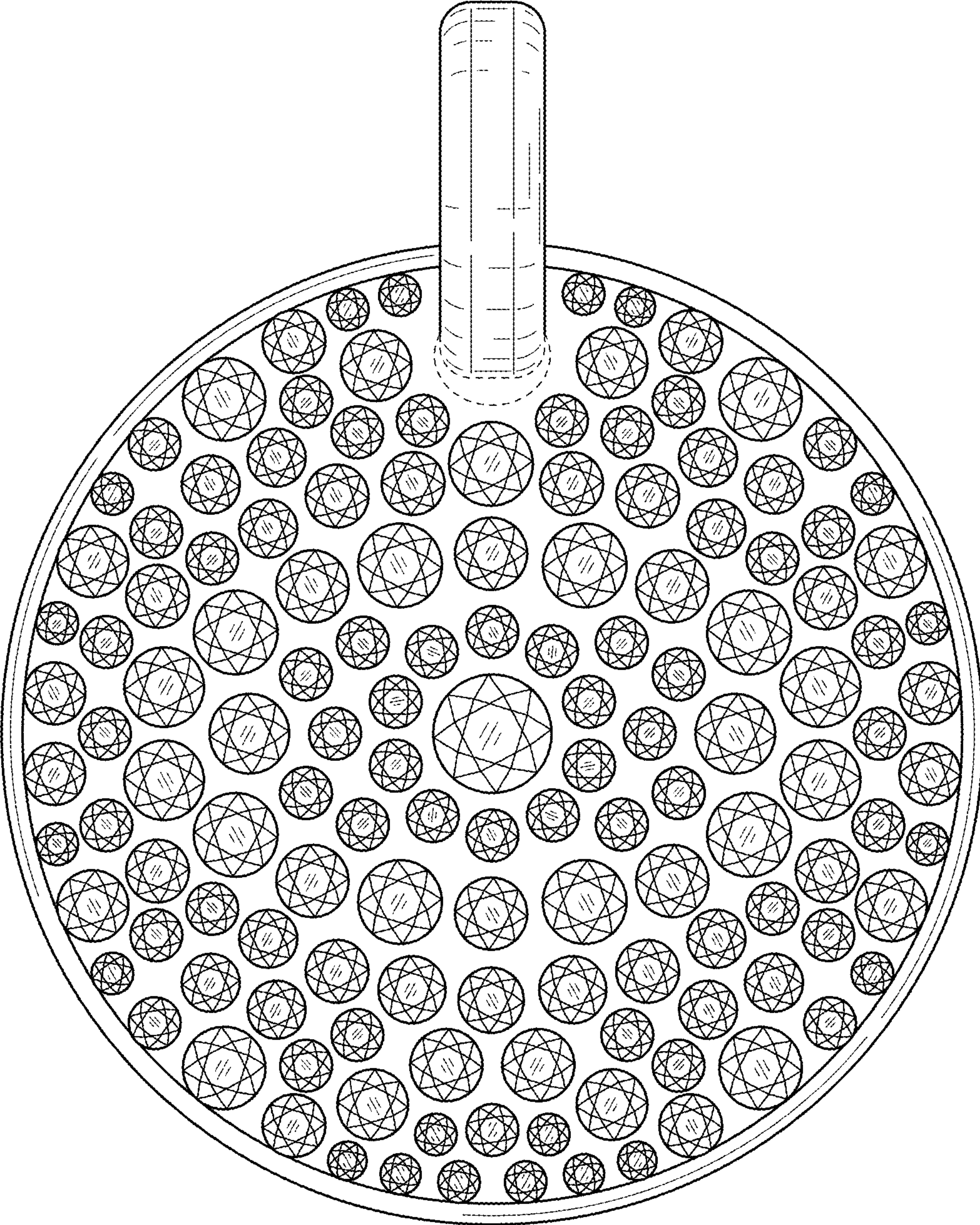

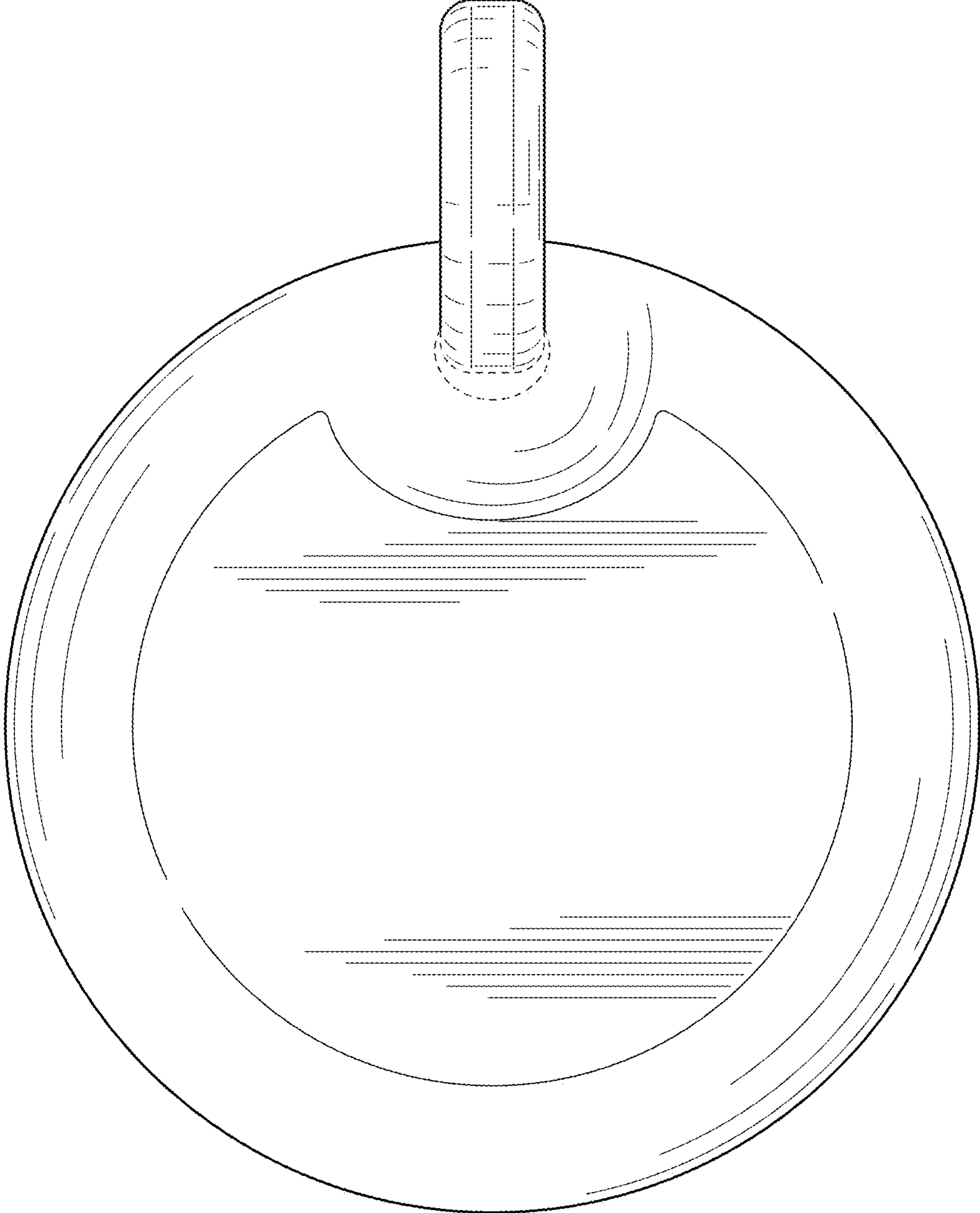

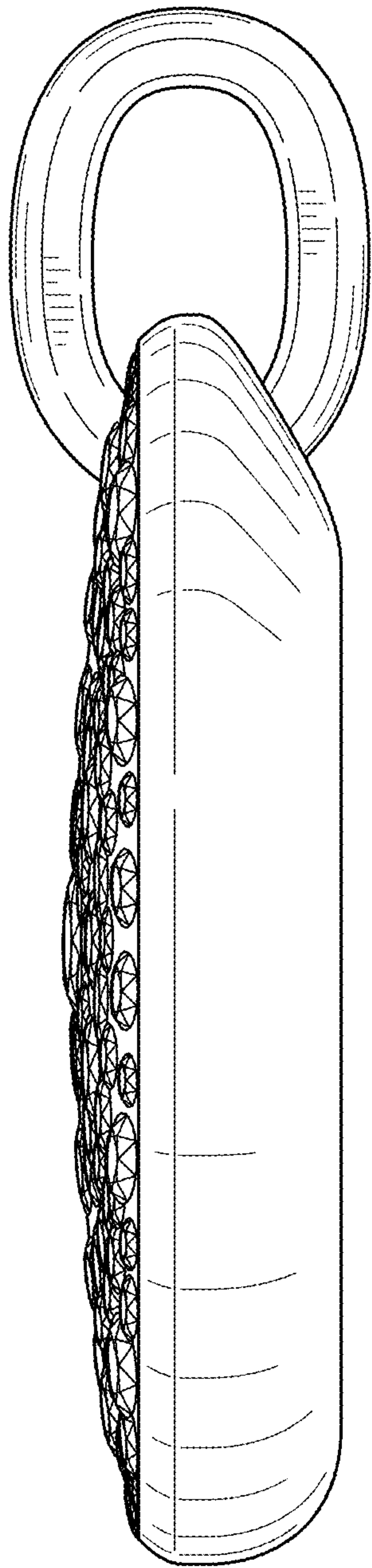

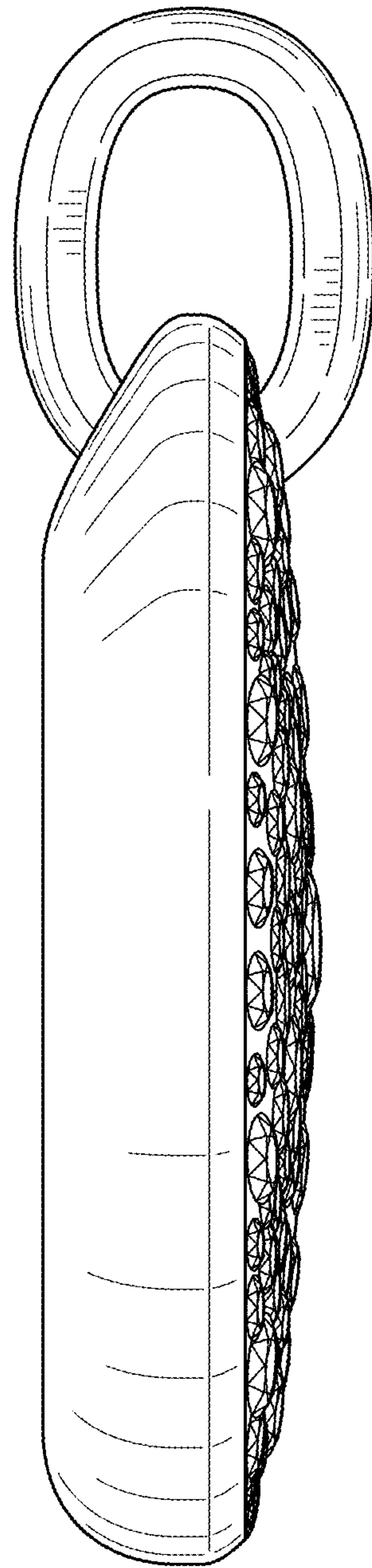

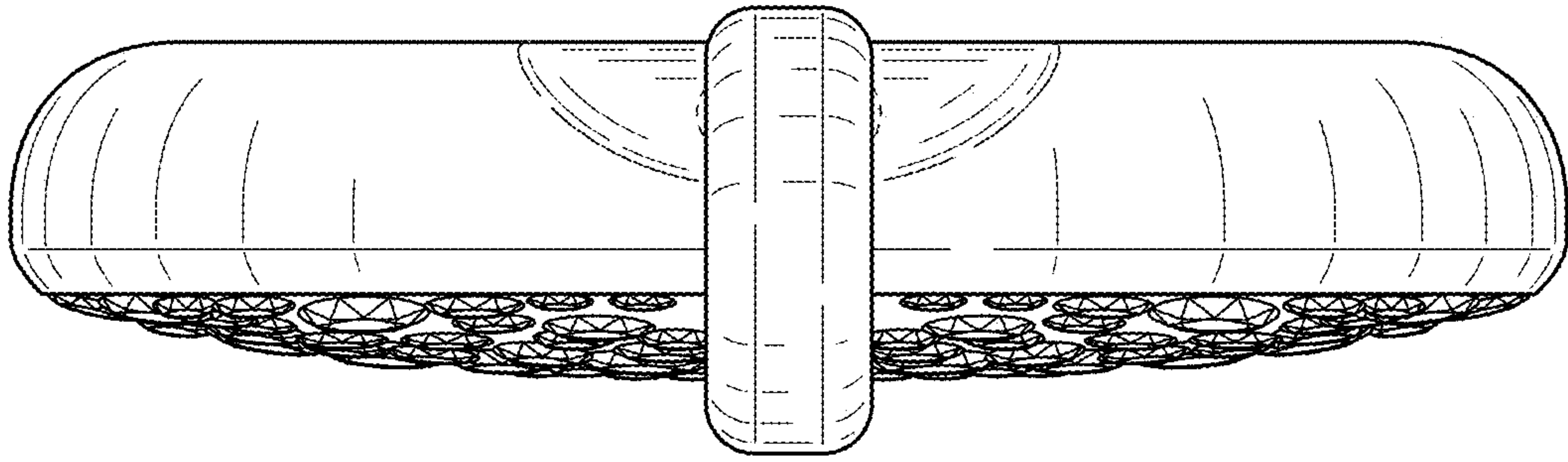

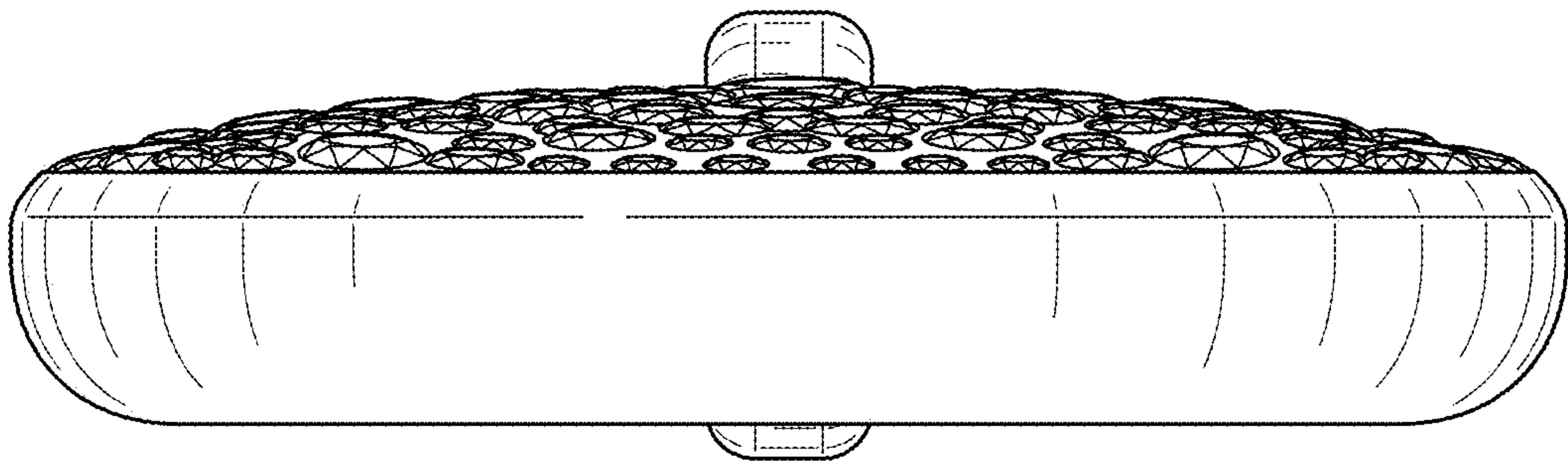

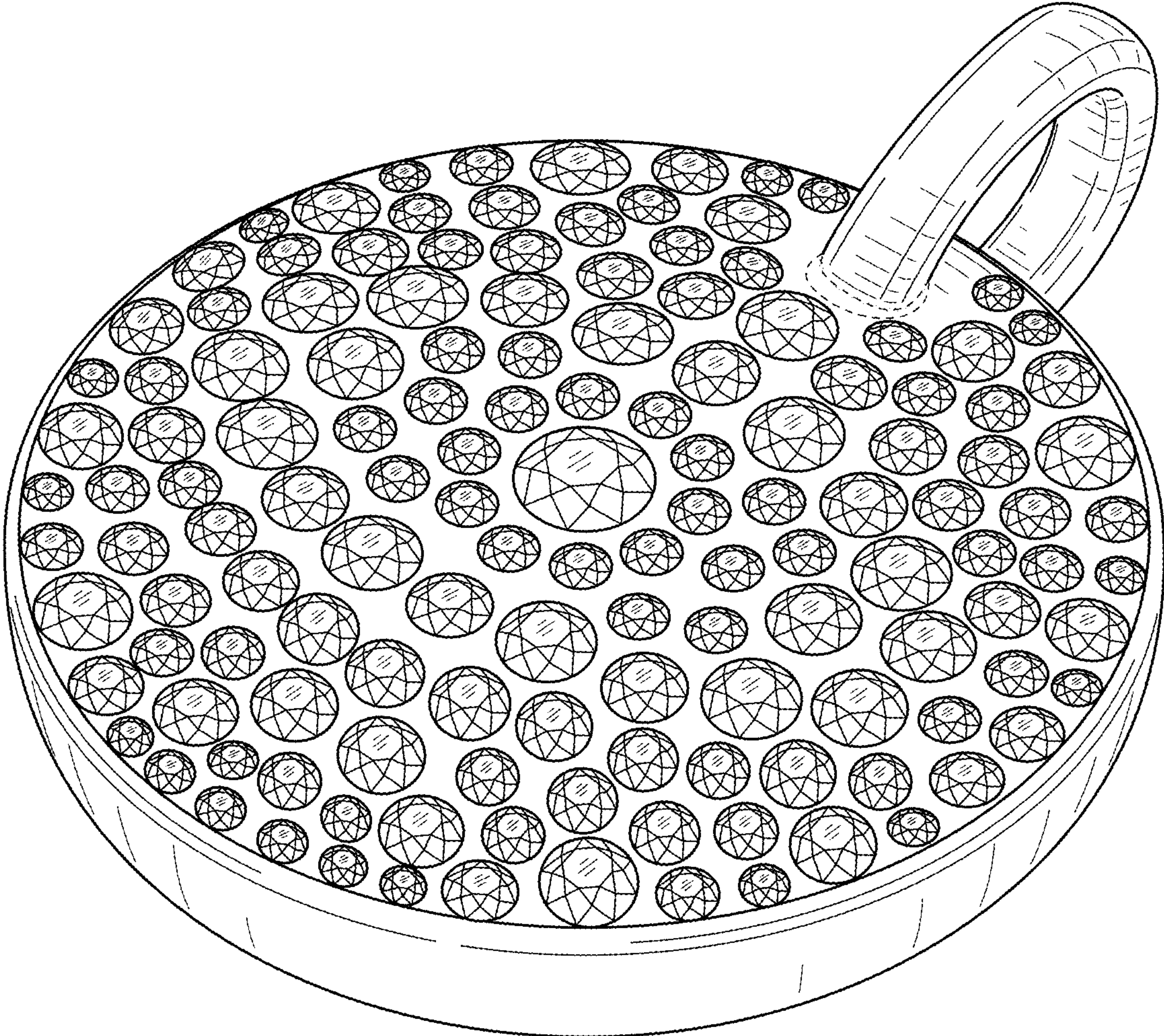

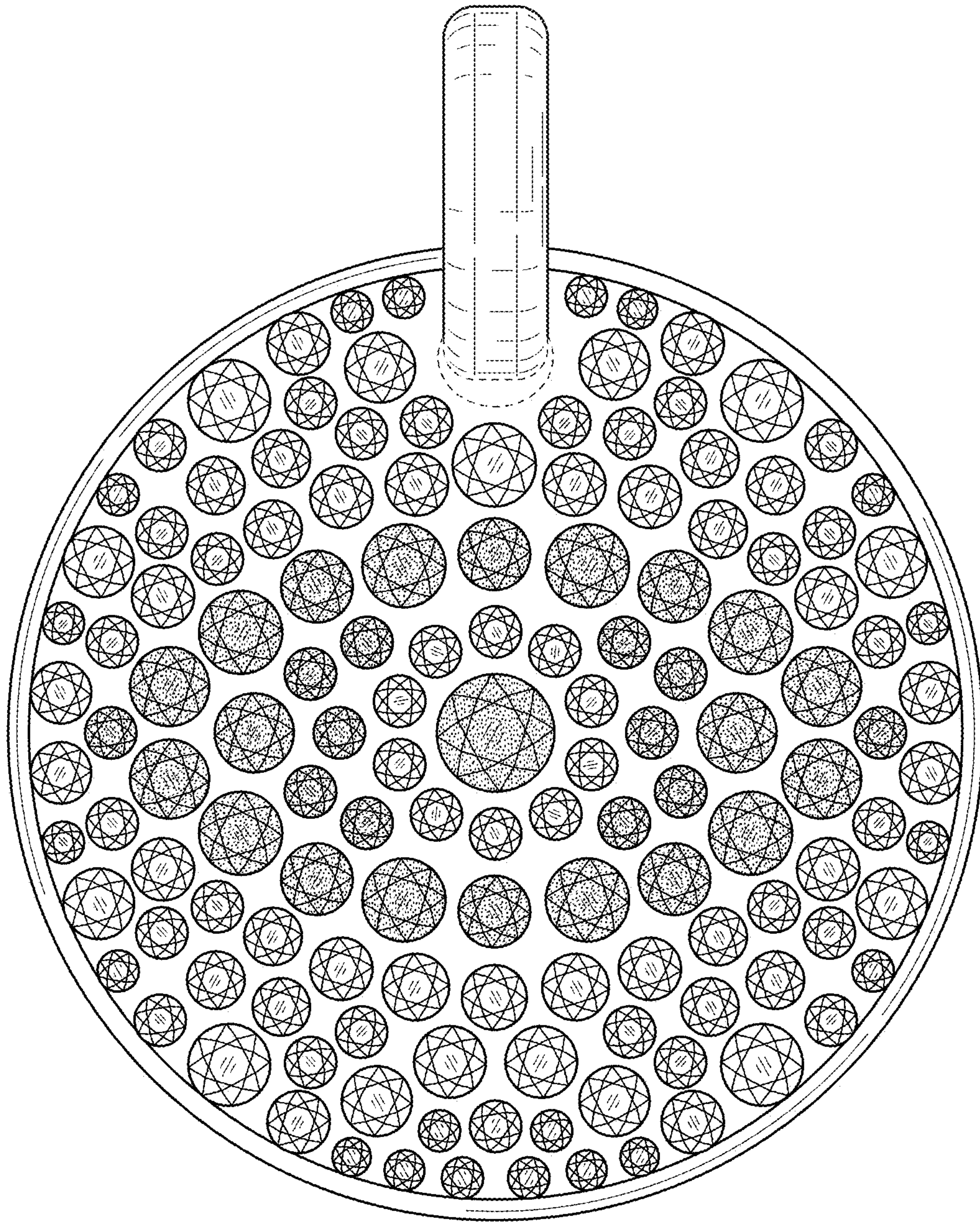
