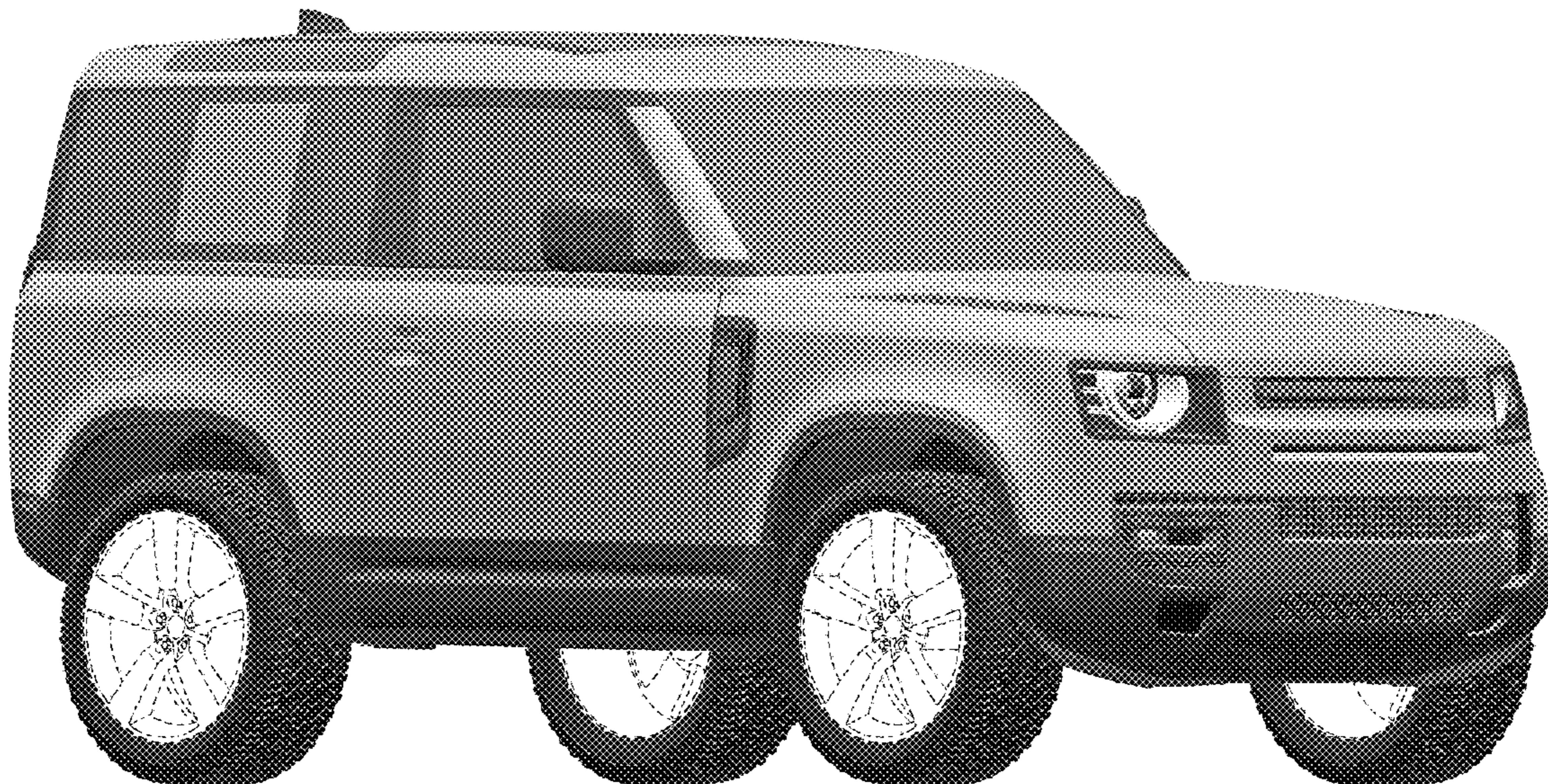
The ornamental design for a vehicle, as shown and described.

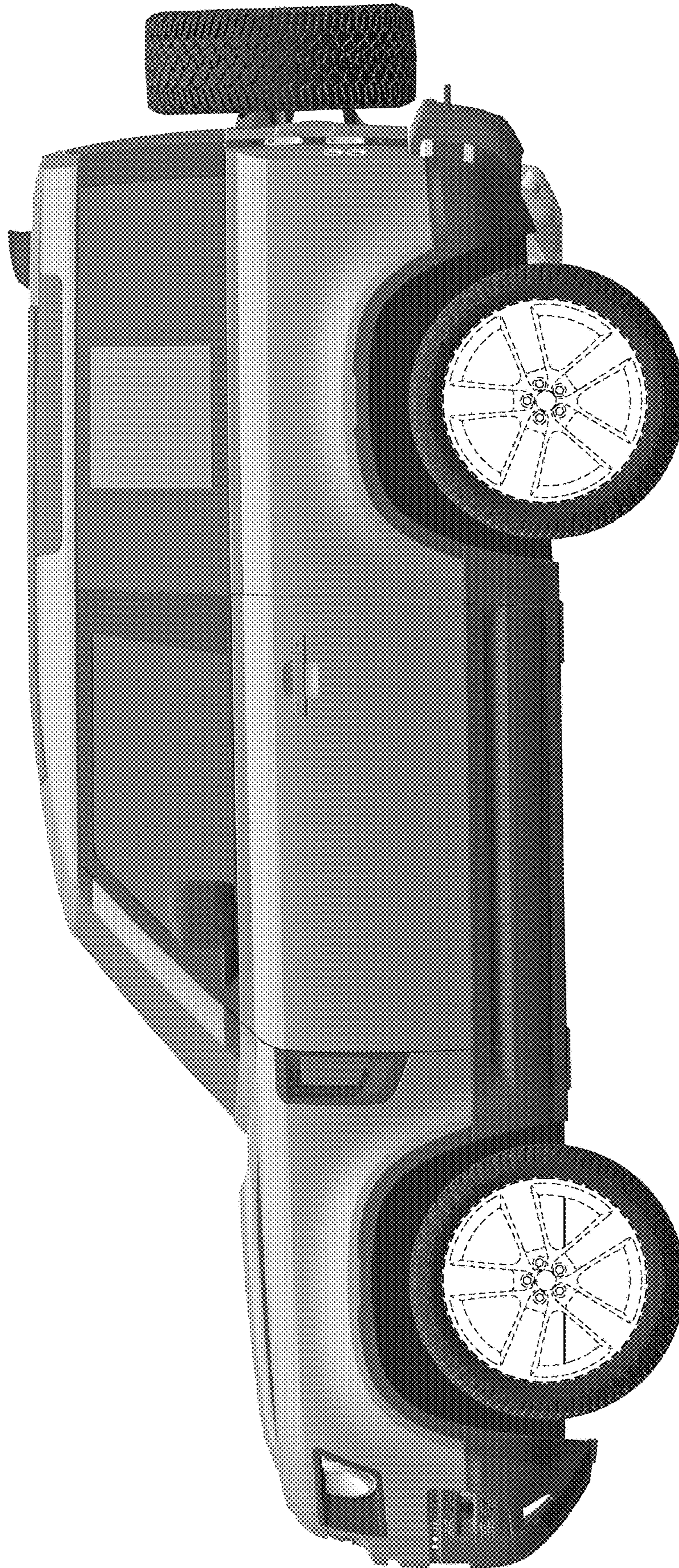

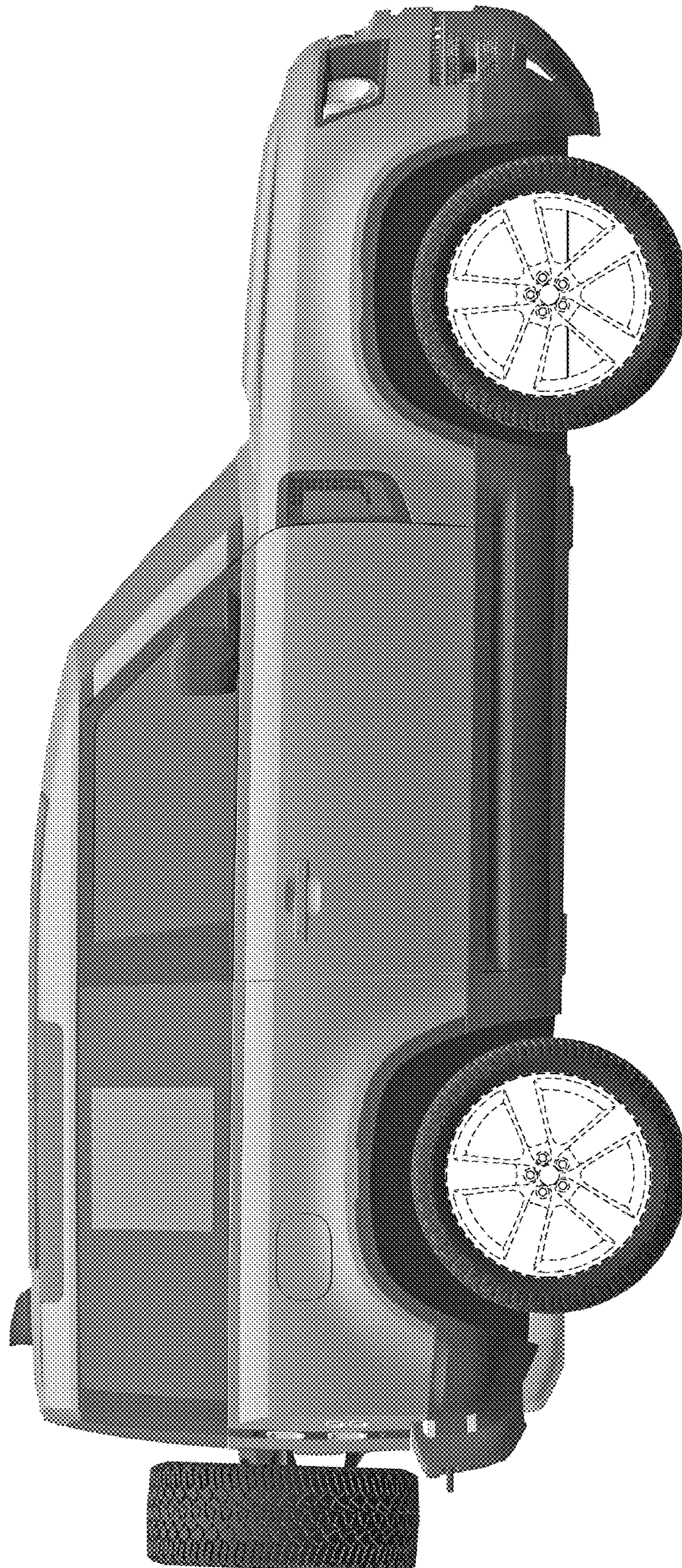

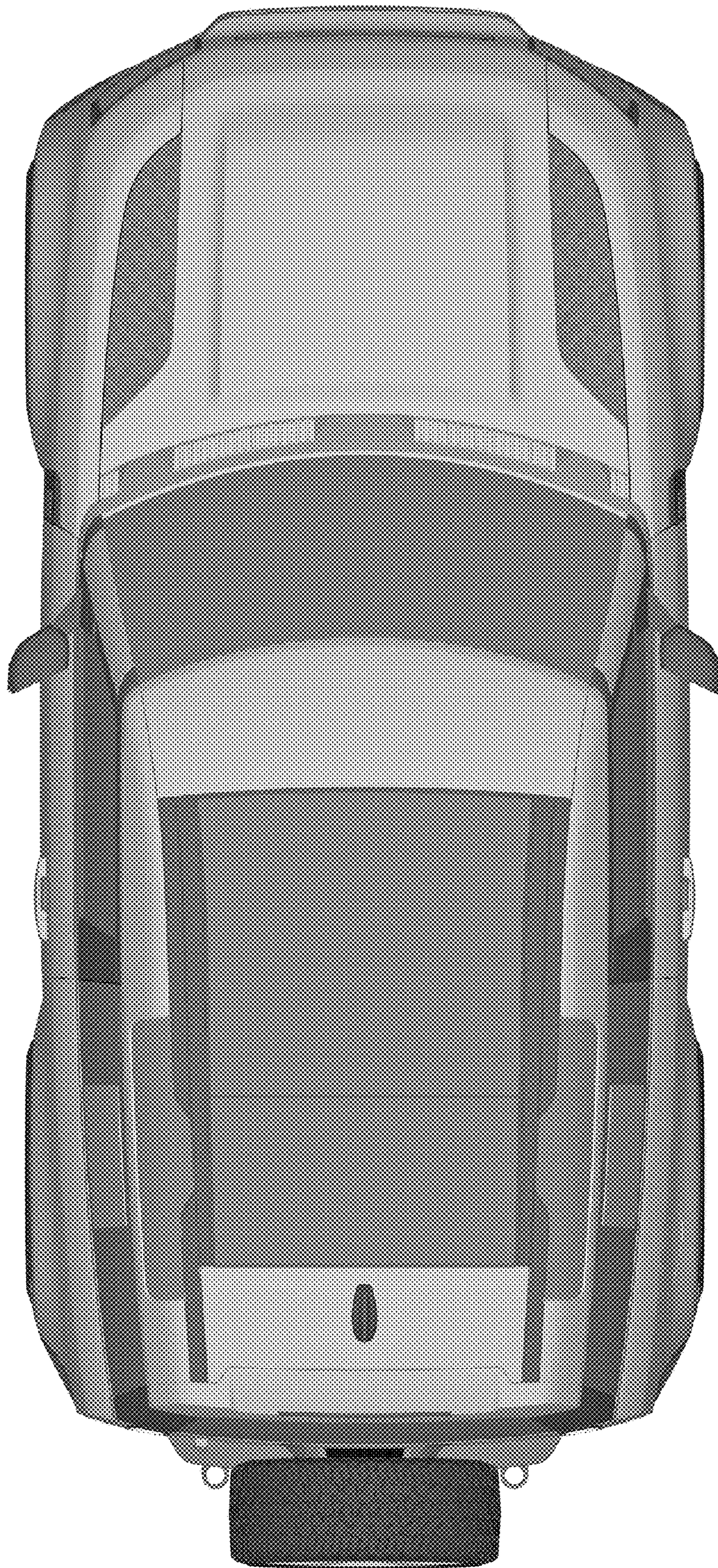
