(57) **CLAIM**

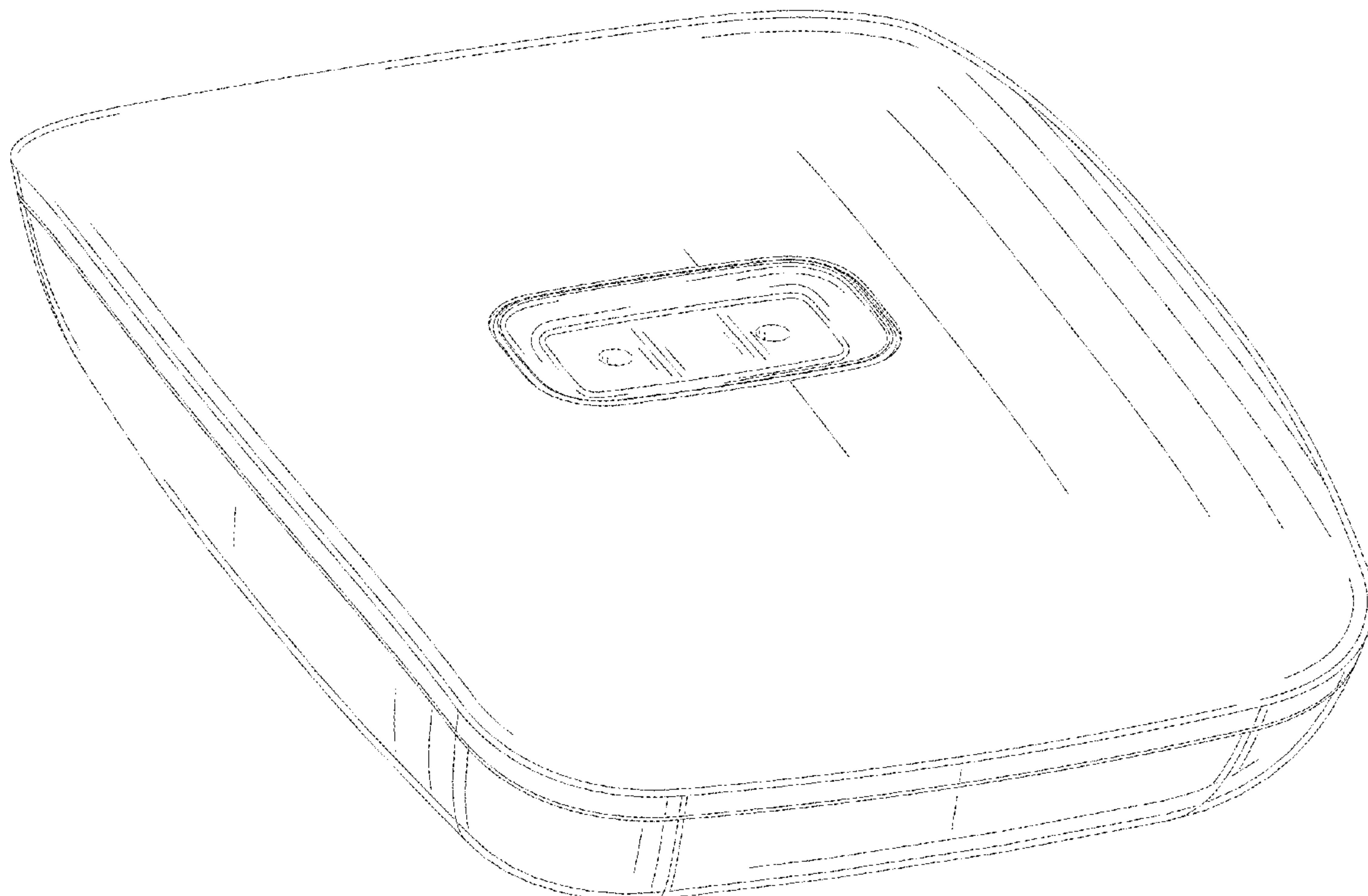
The ornamental design for an electronic cigarette charger, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an electronic cigarette charger showing my new design;
FIG. 2 is a top plan view thereof;

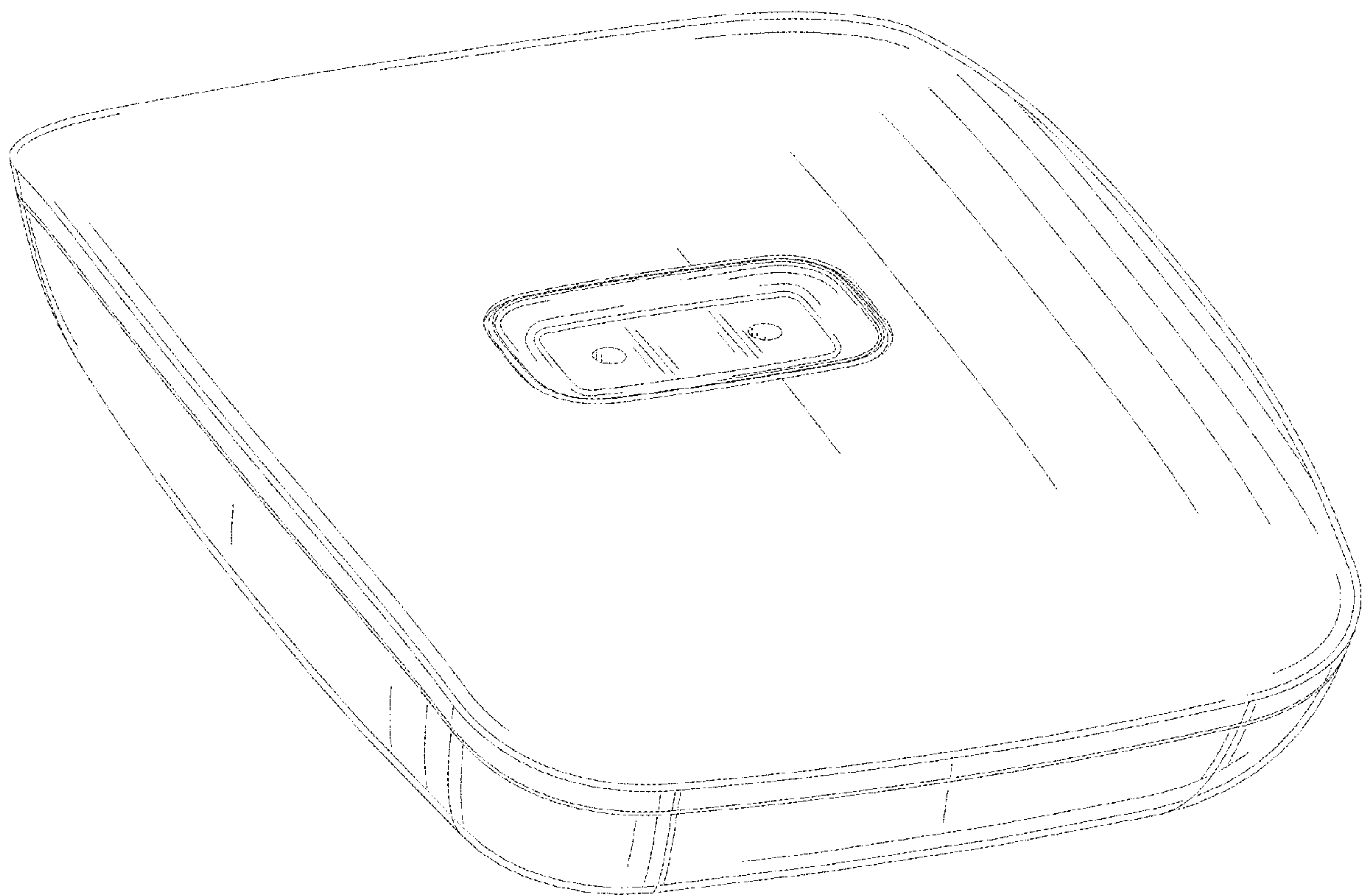

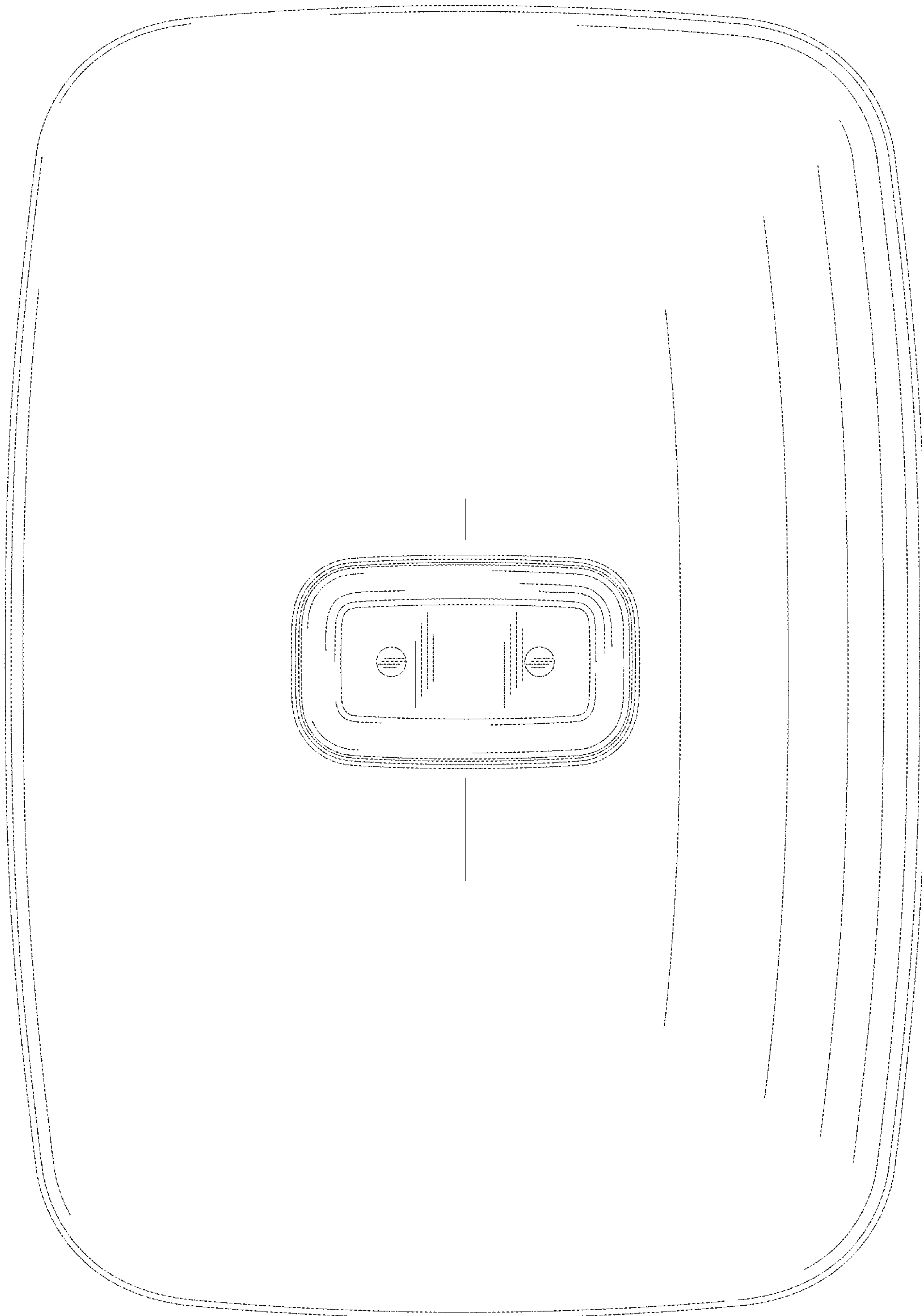

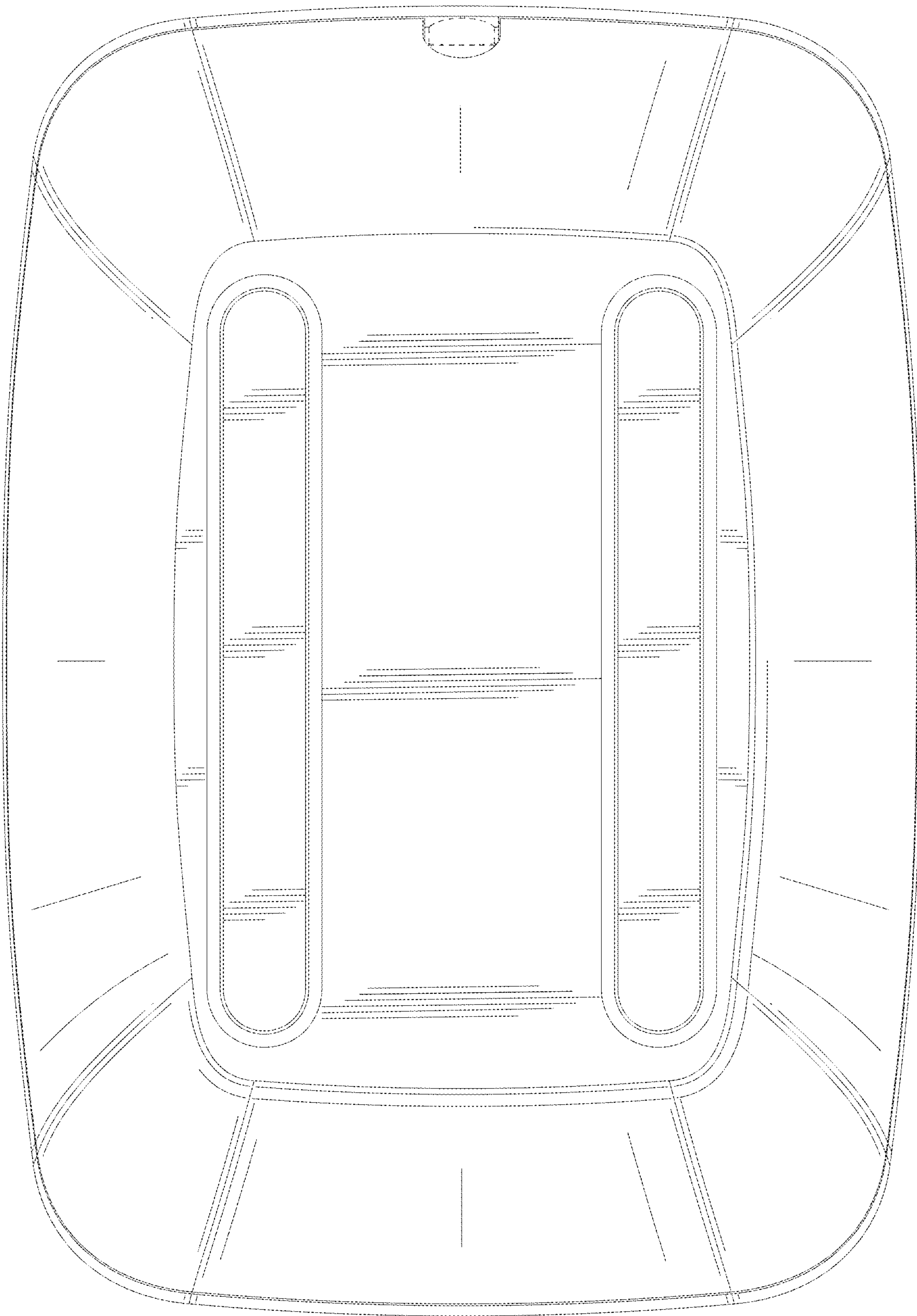

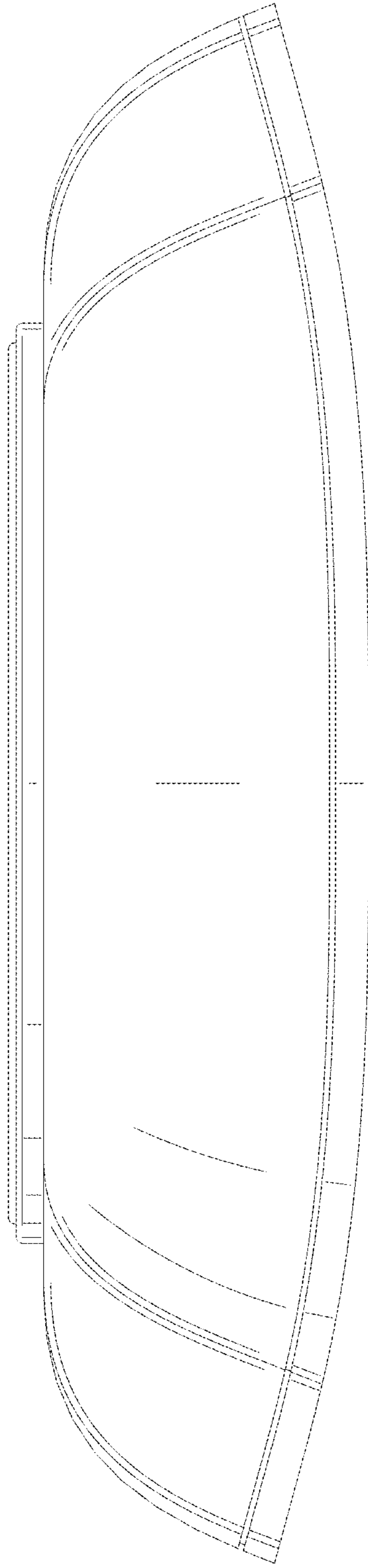

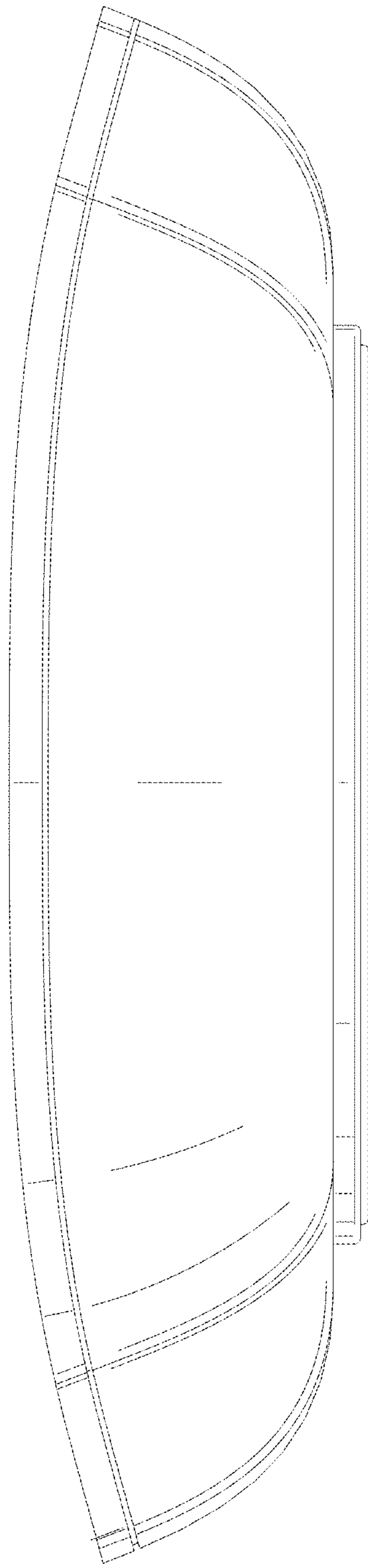

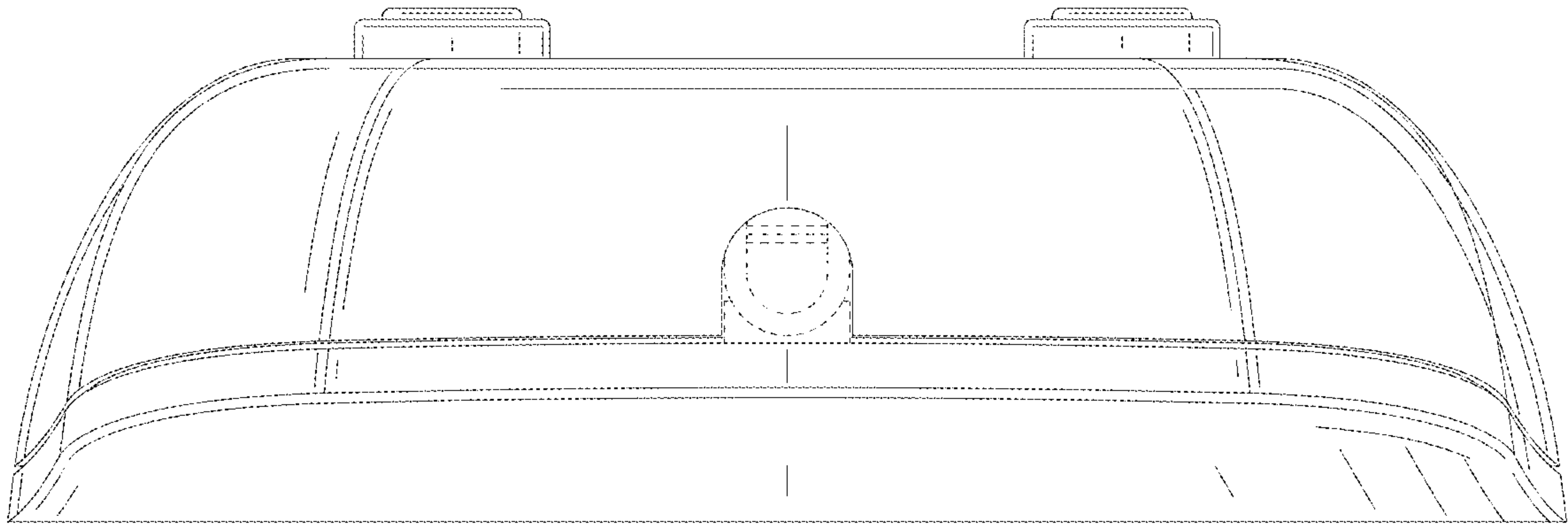

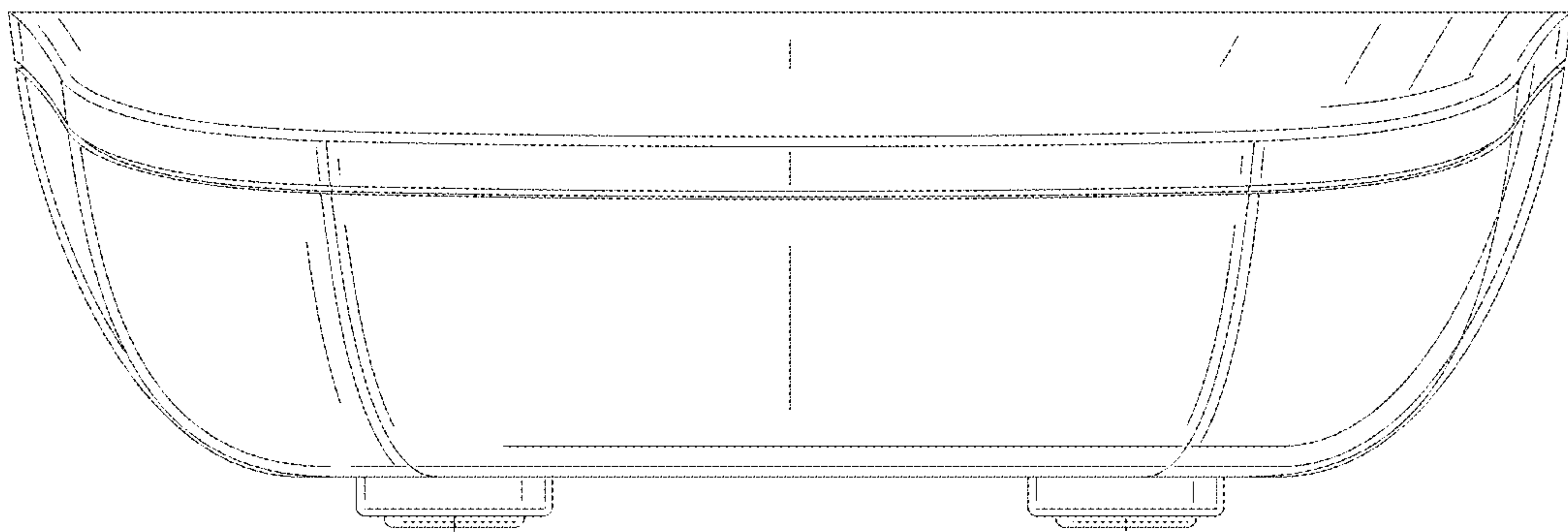
