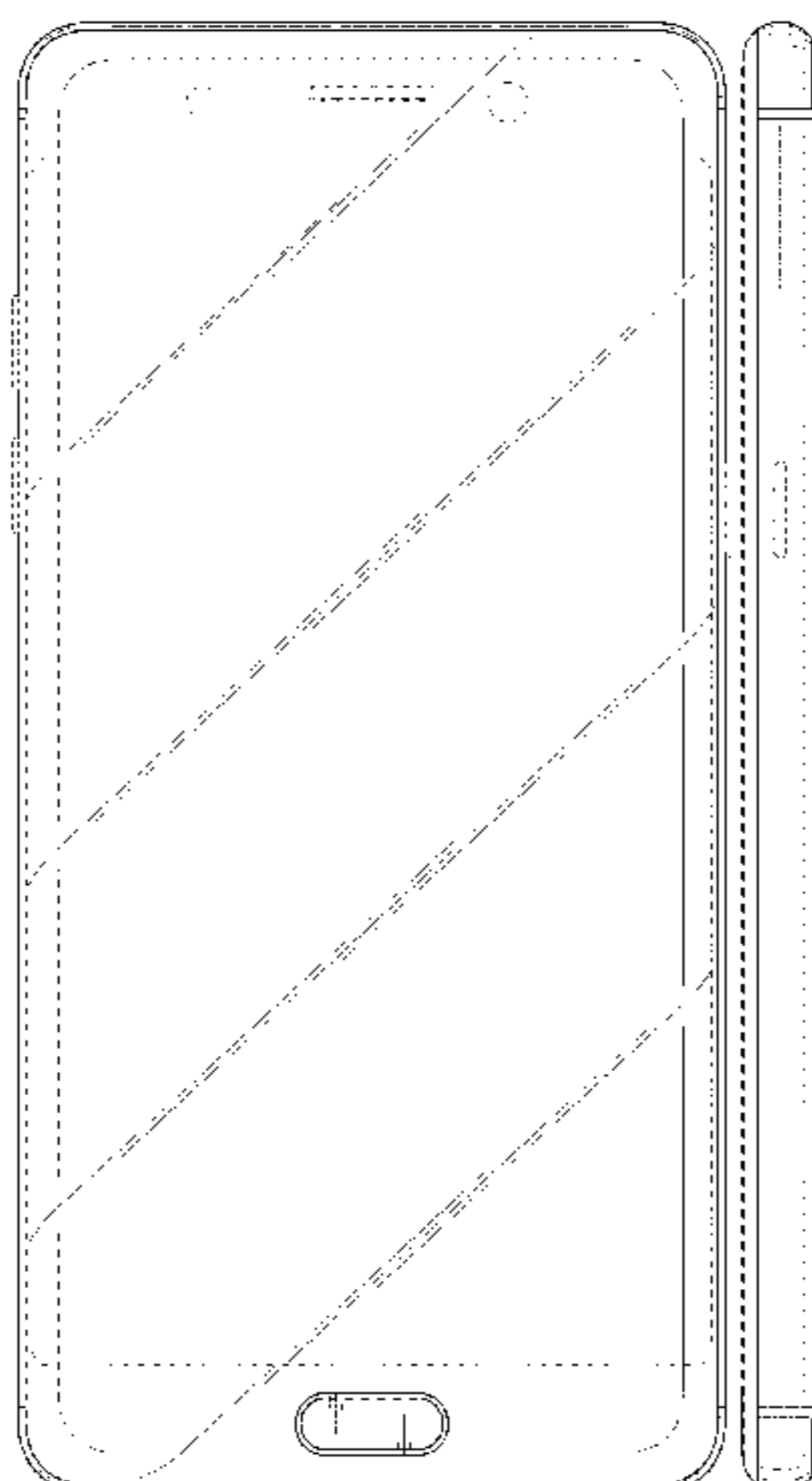

(57) **CLAIM**

The ornamental design for a mobile phone, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a mobile phone showing our new design according to a first embodiment;
FIG. 2 is a front elevation view thereof;

FIG. 4 is a left side elevation view thereof;

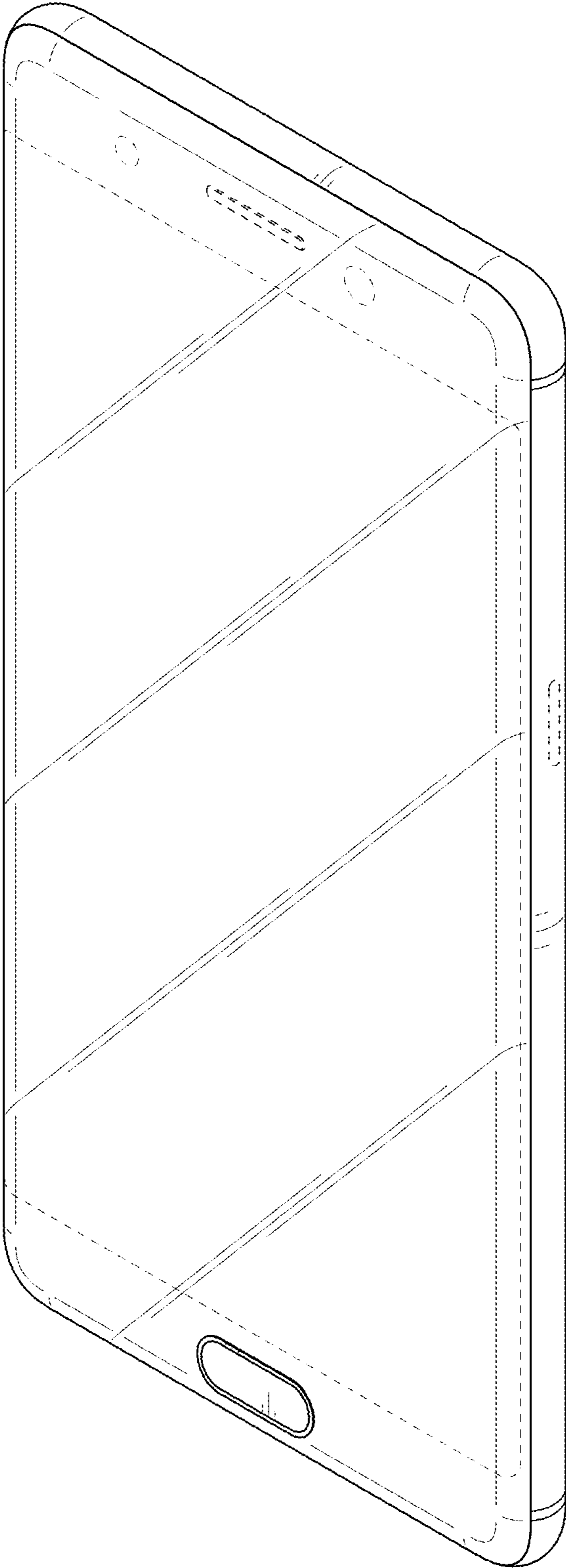

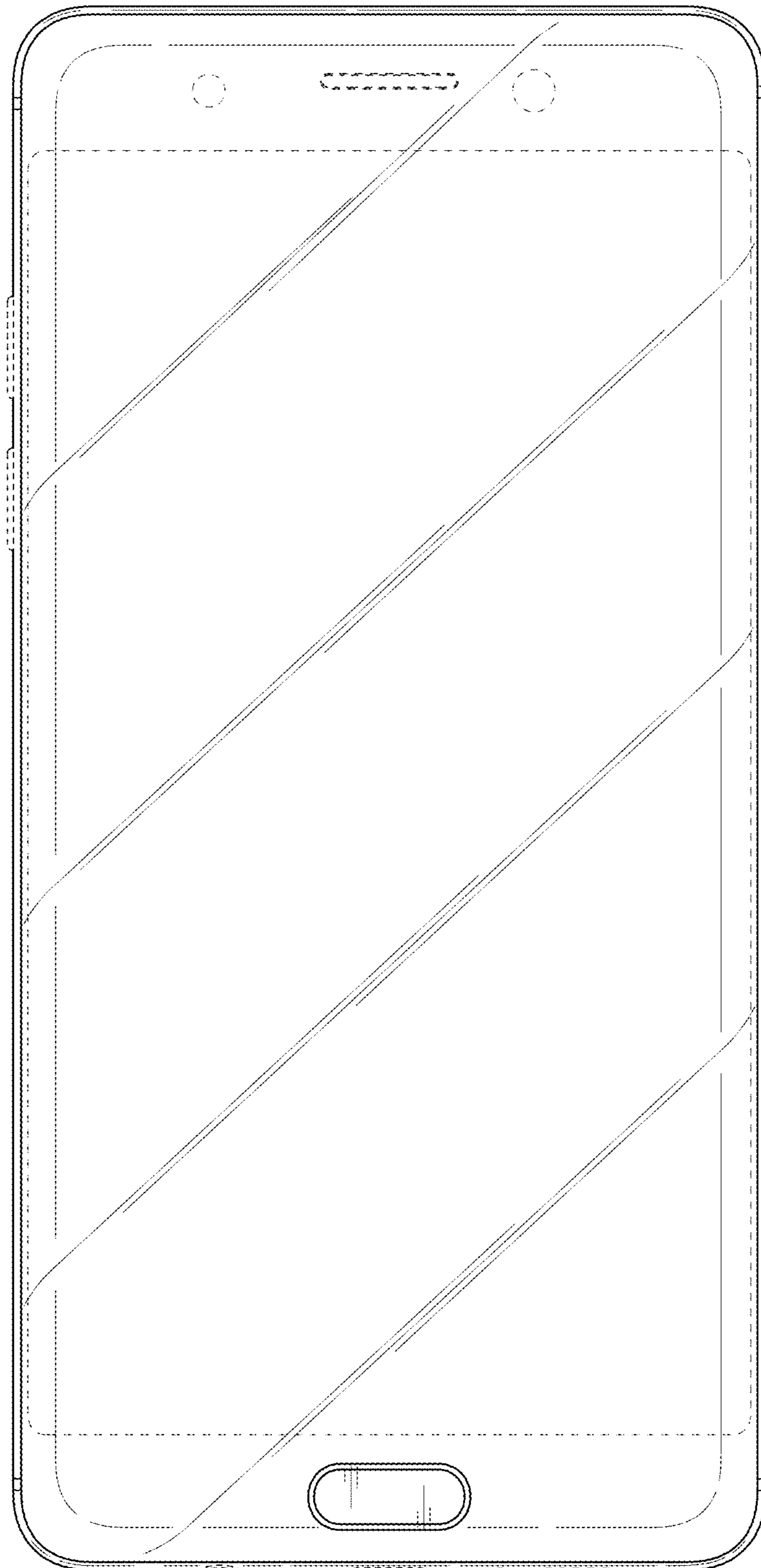

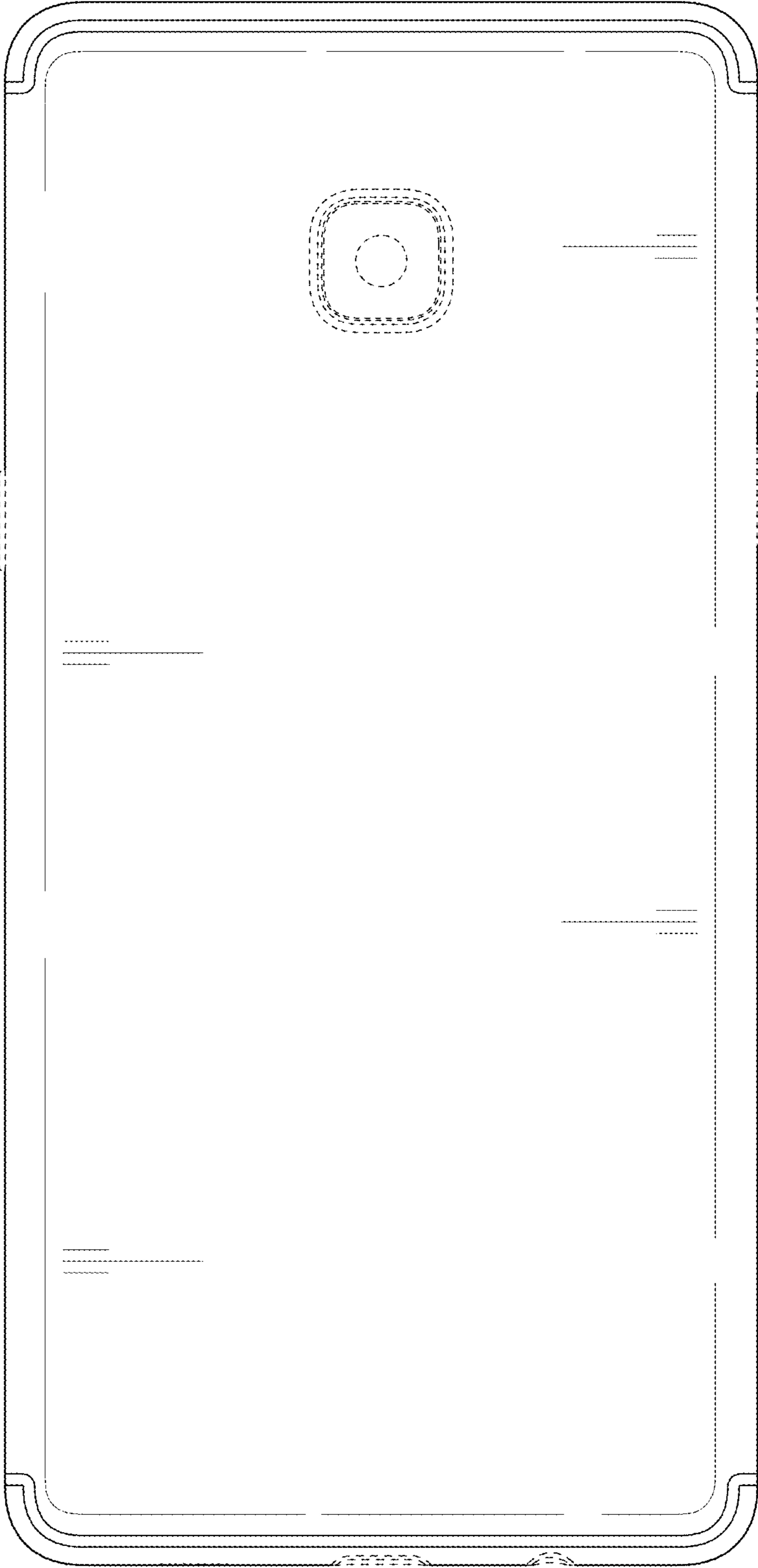

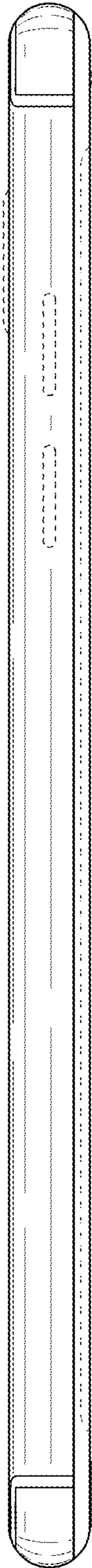

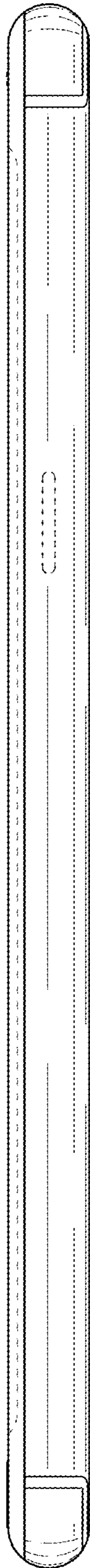

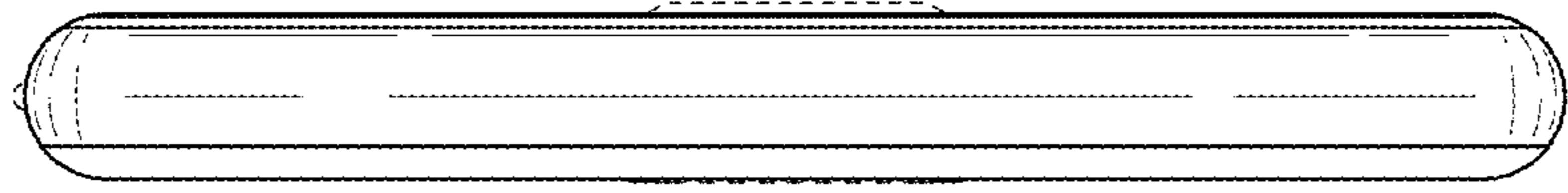

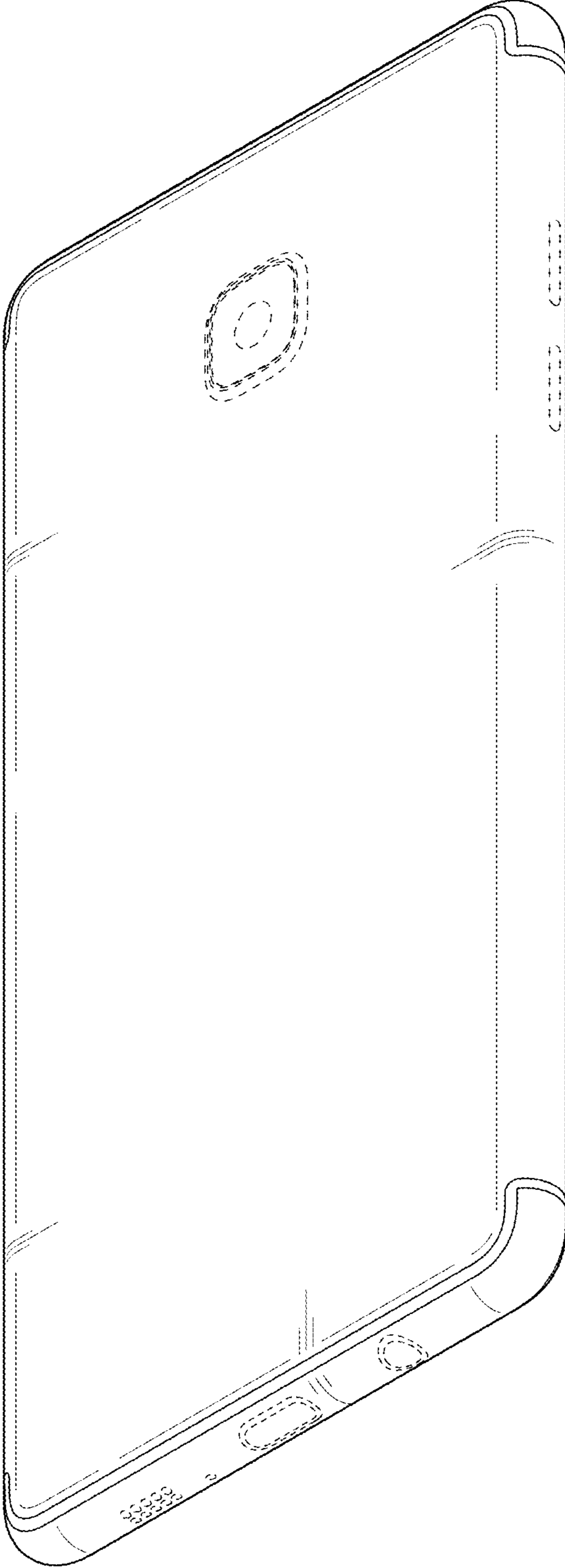

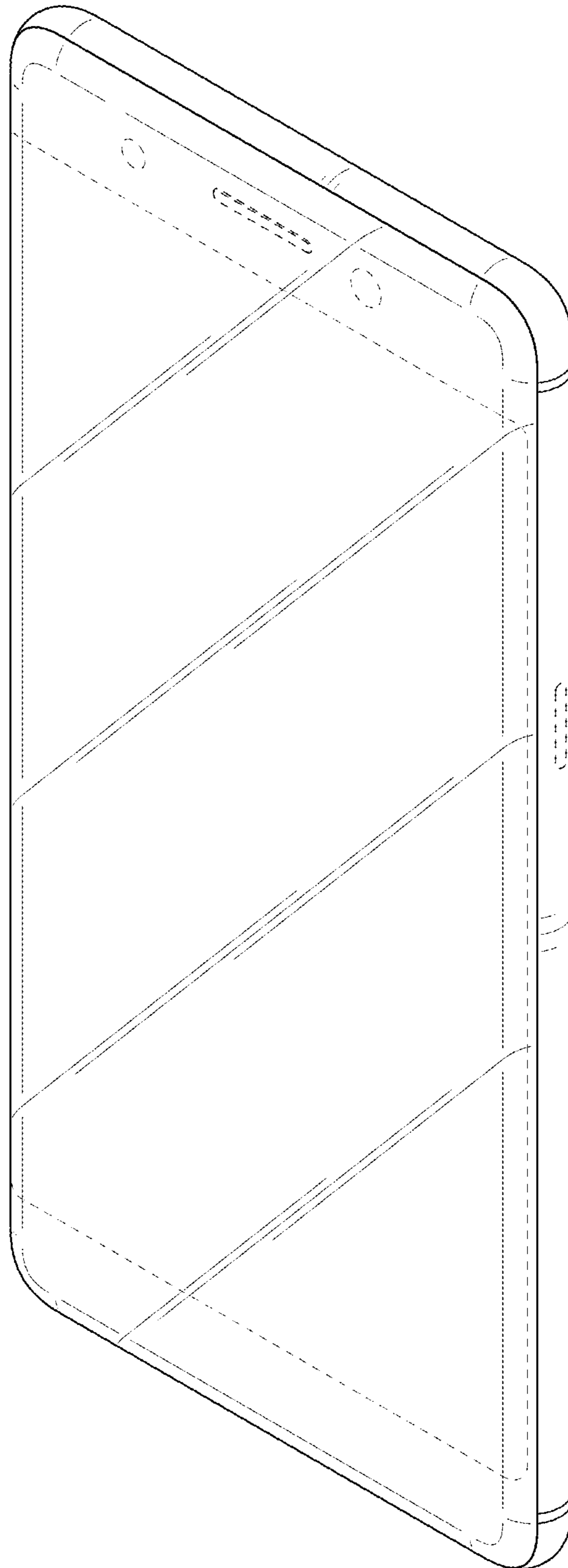

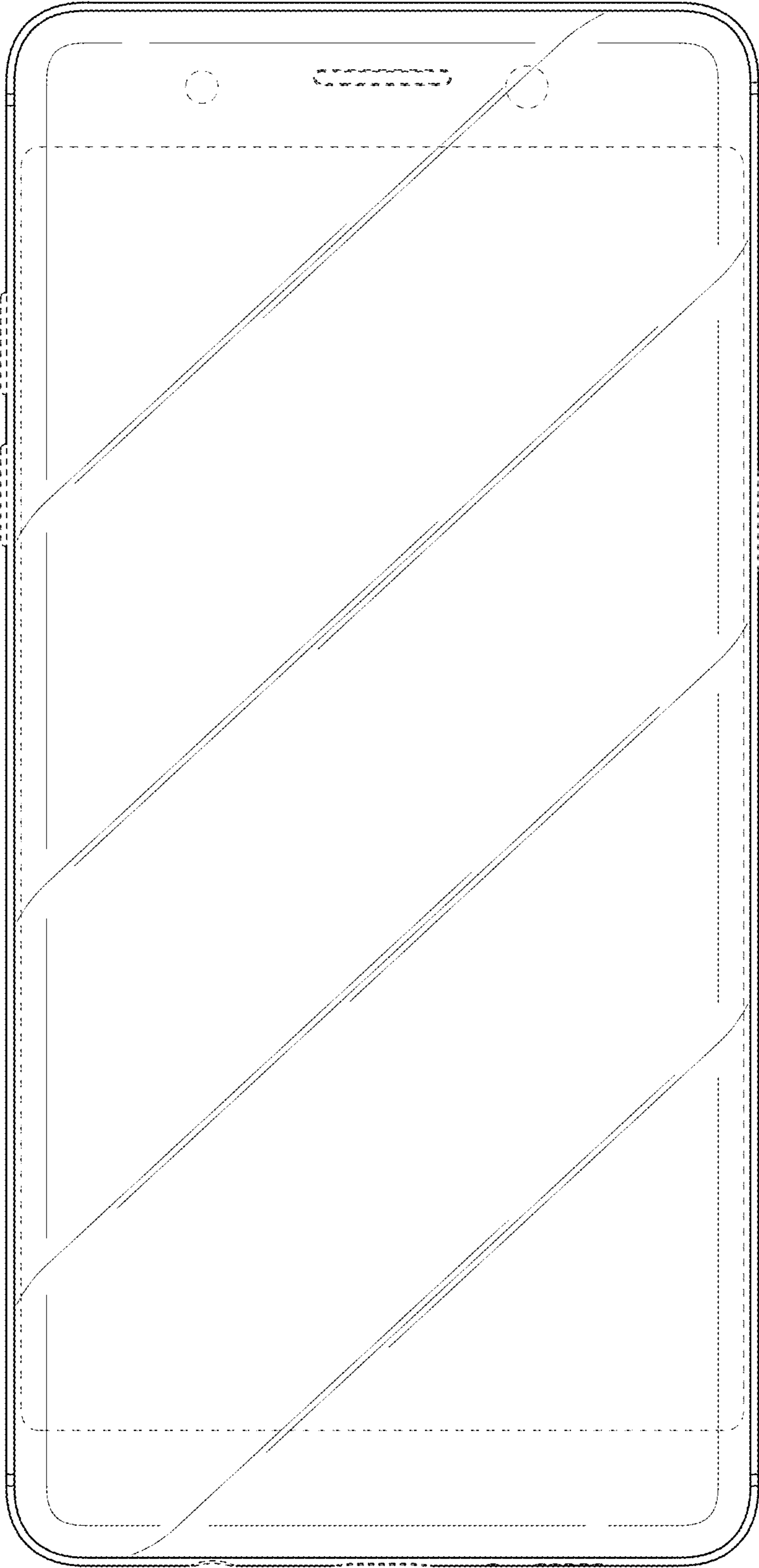

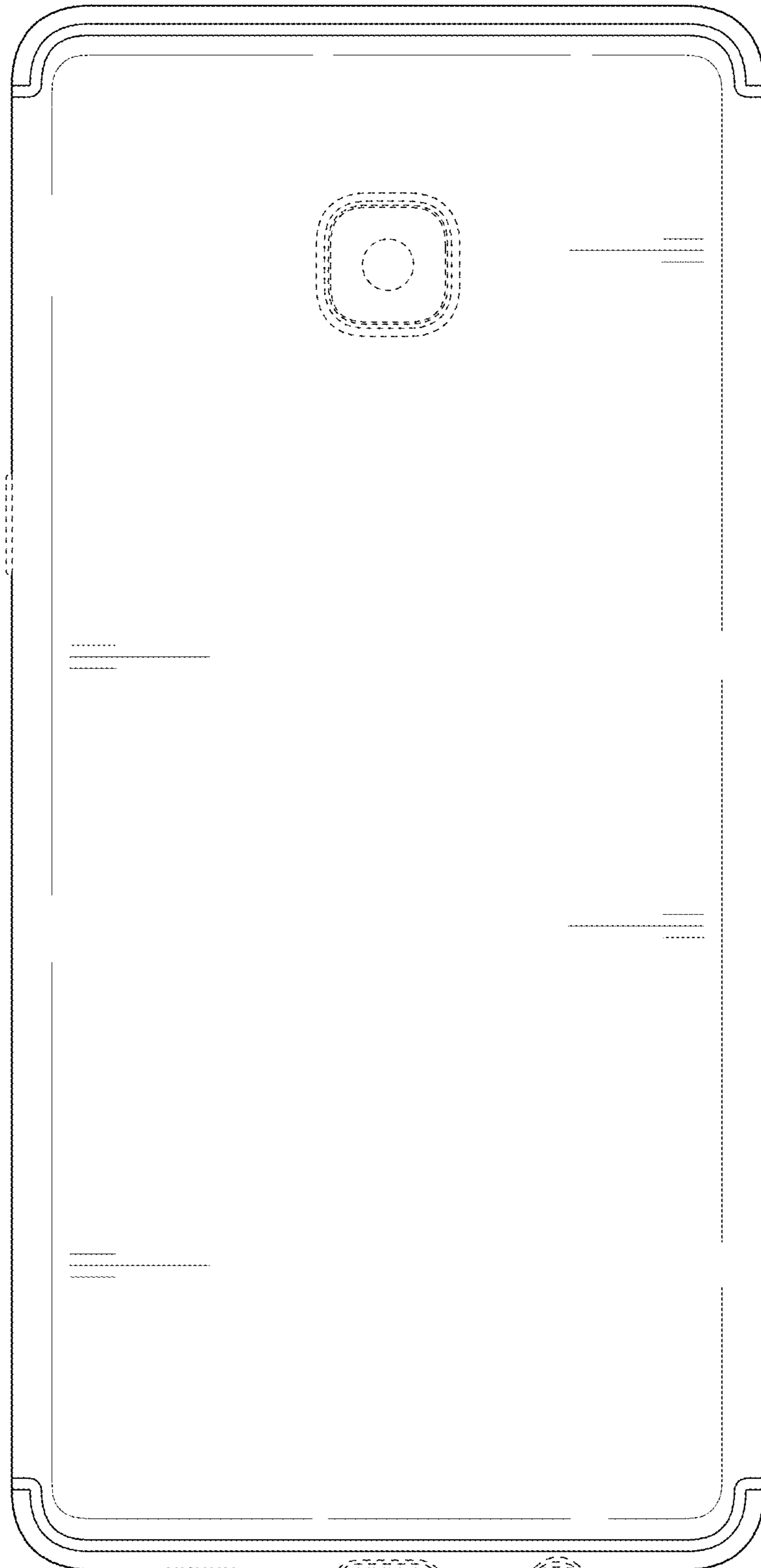

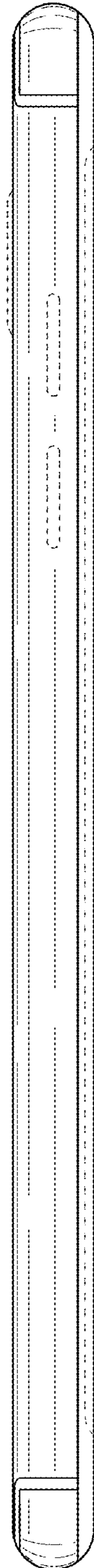

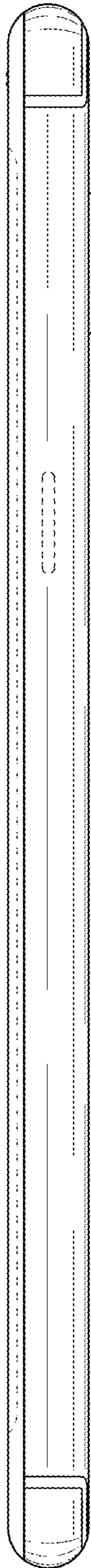

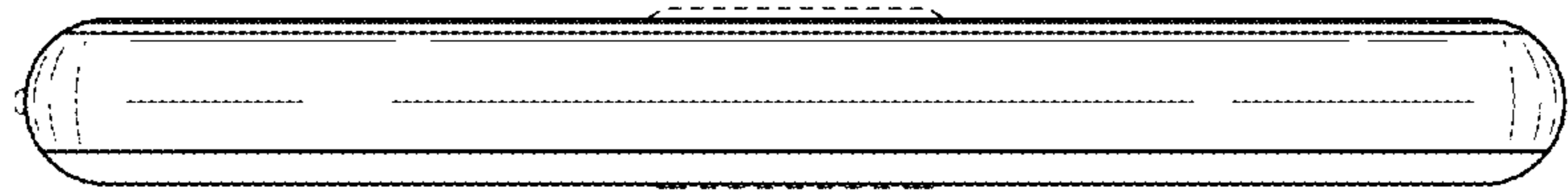

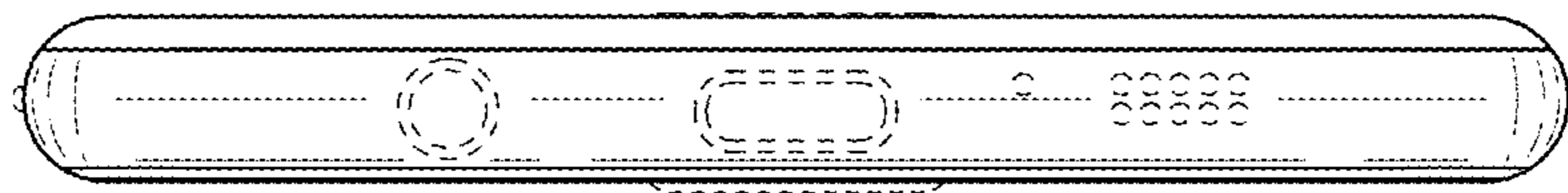
