**1.5** is a right view thereof;

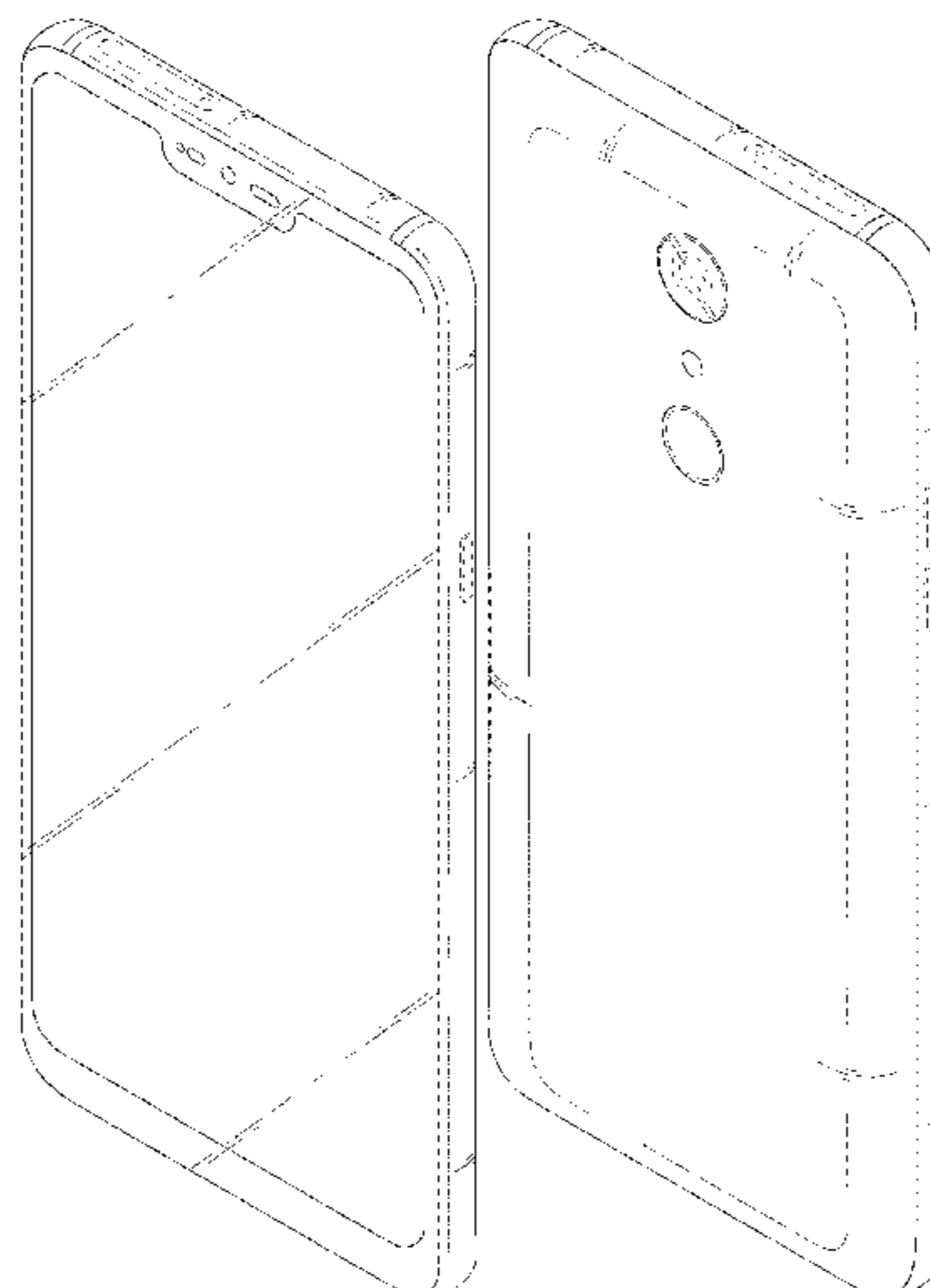
**1.6** is a top view thereof;

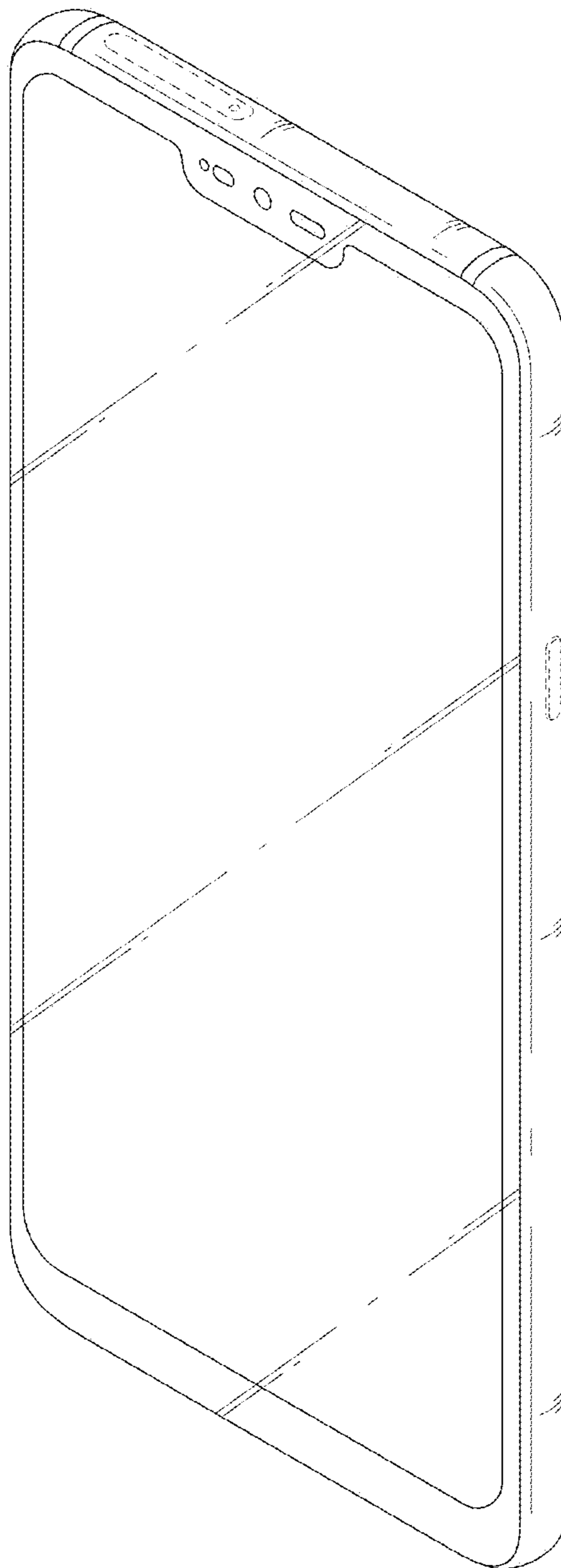

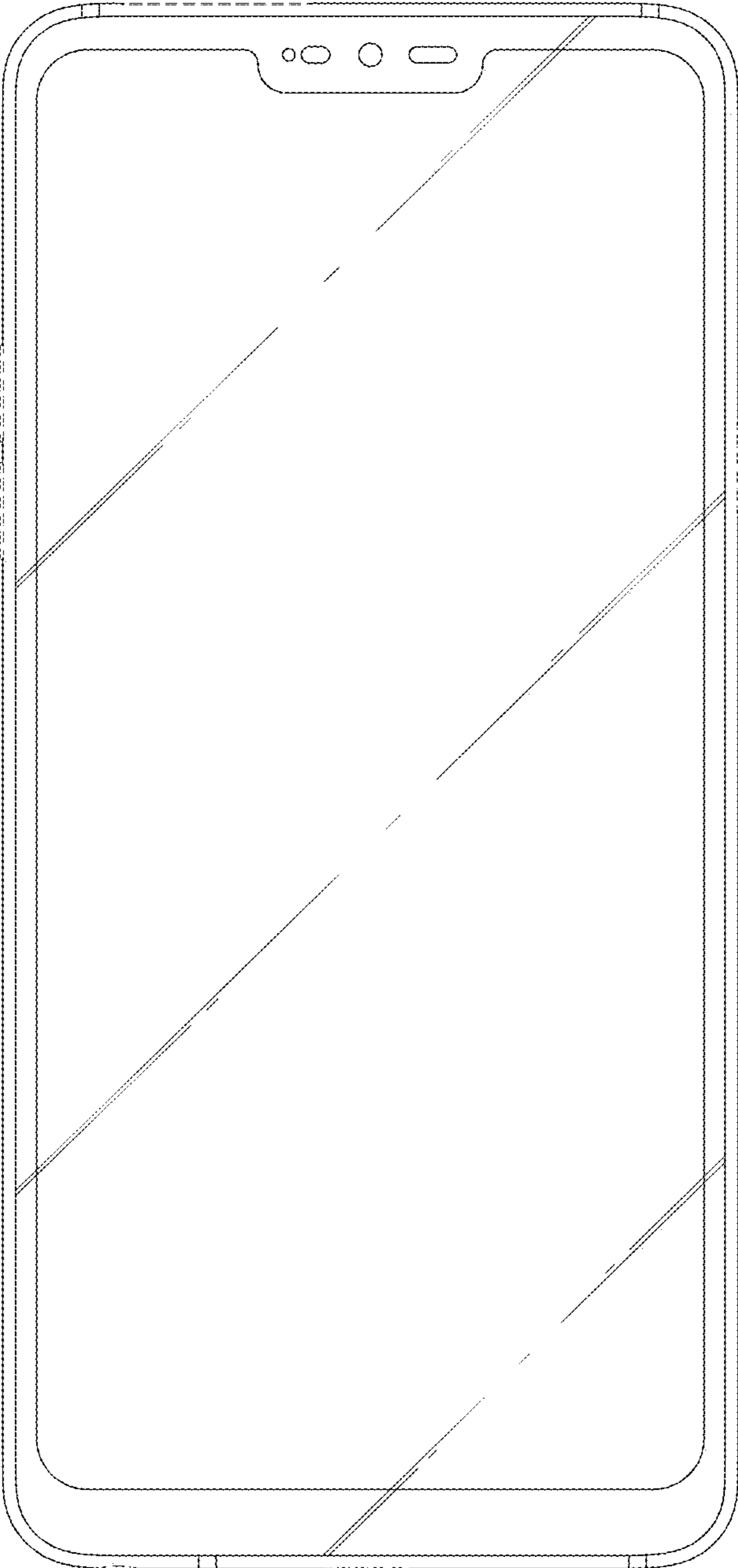

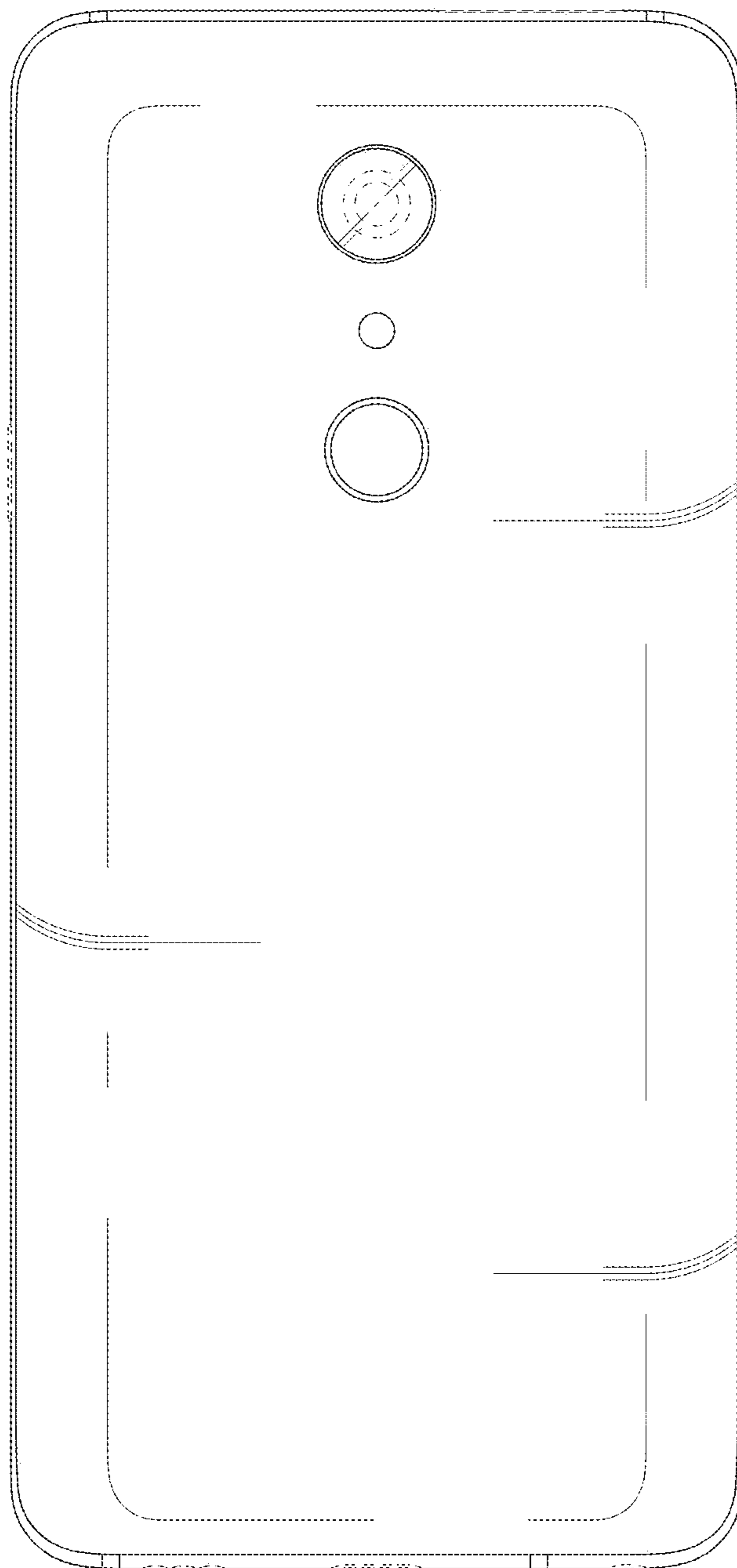

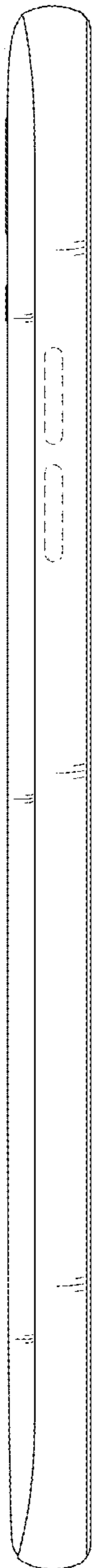

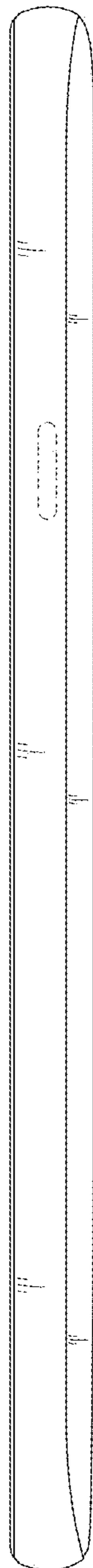

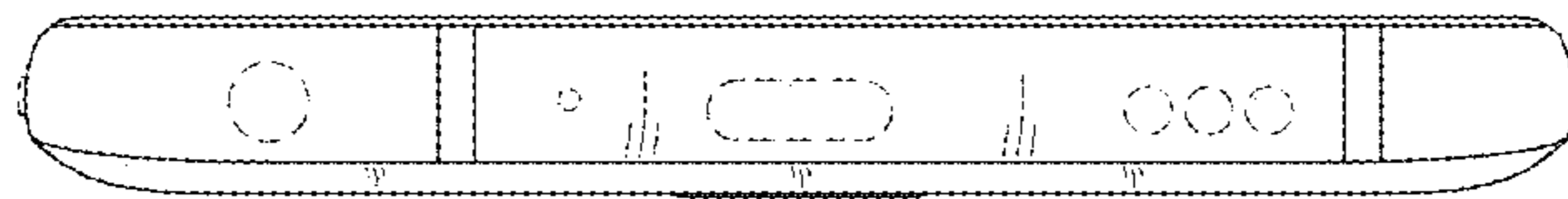
