FIG. 3 is a back view of the mounting clip.

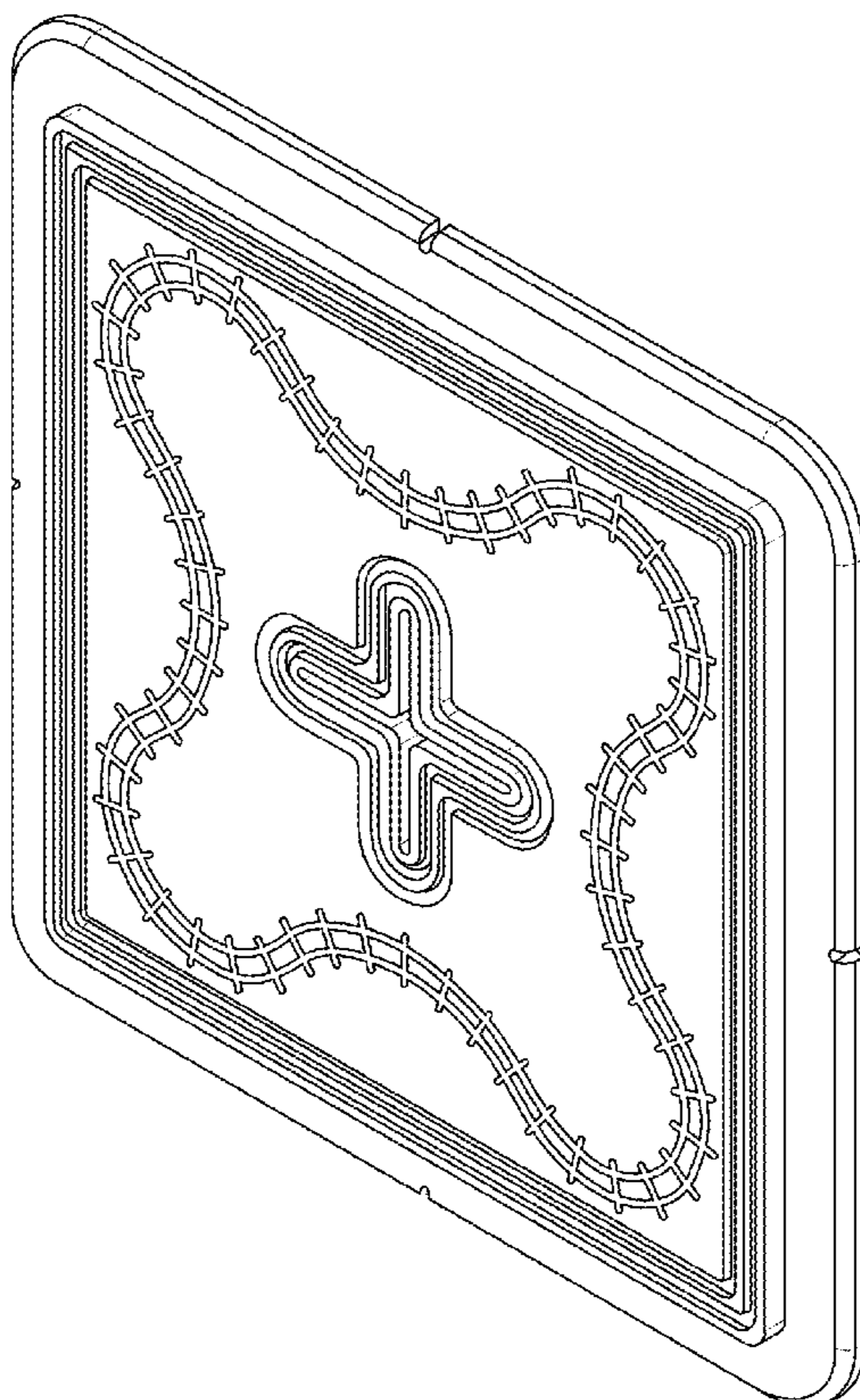
FIG. 4 is a left view of the mounting clip.

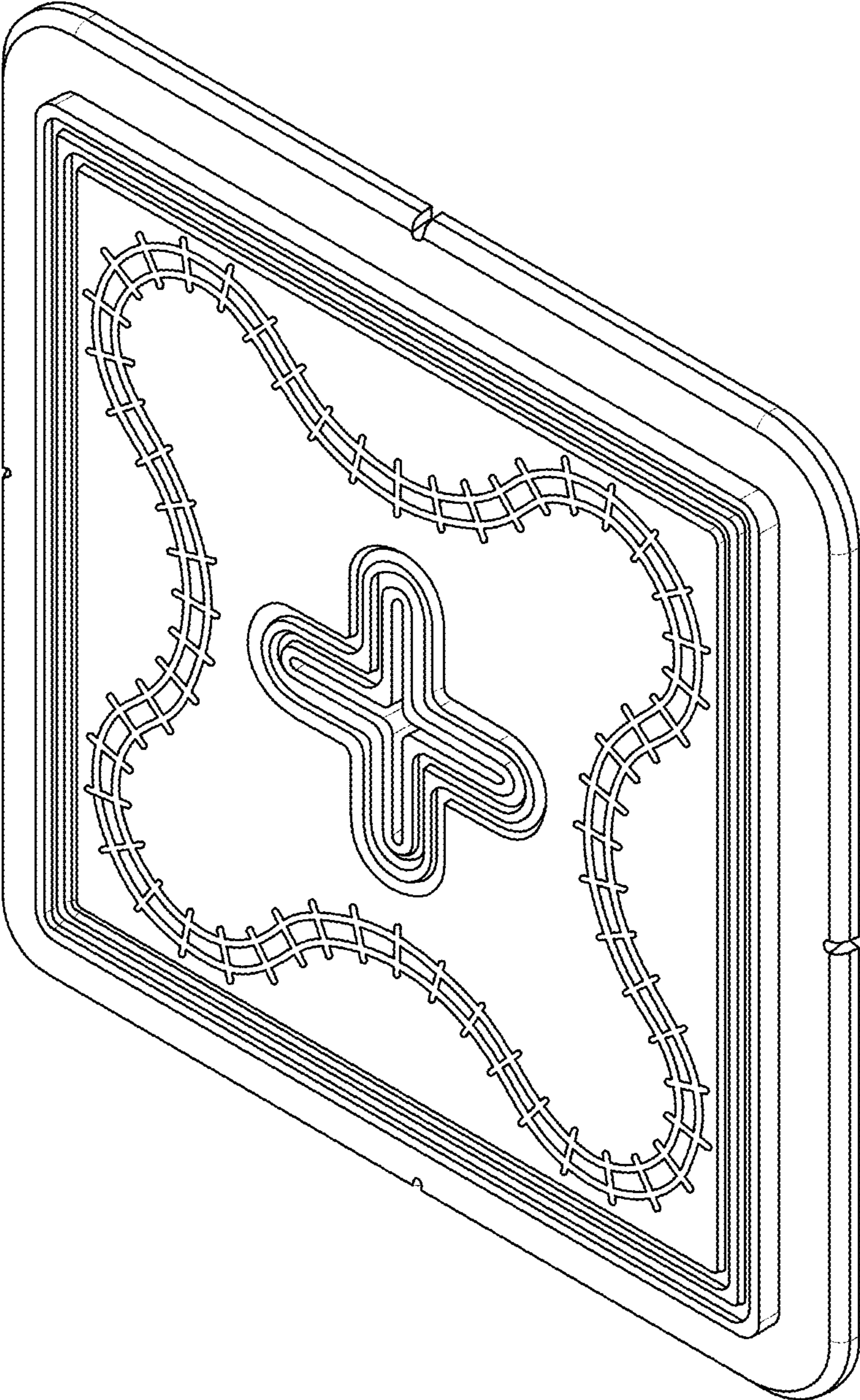

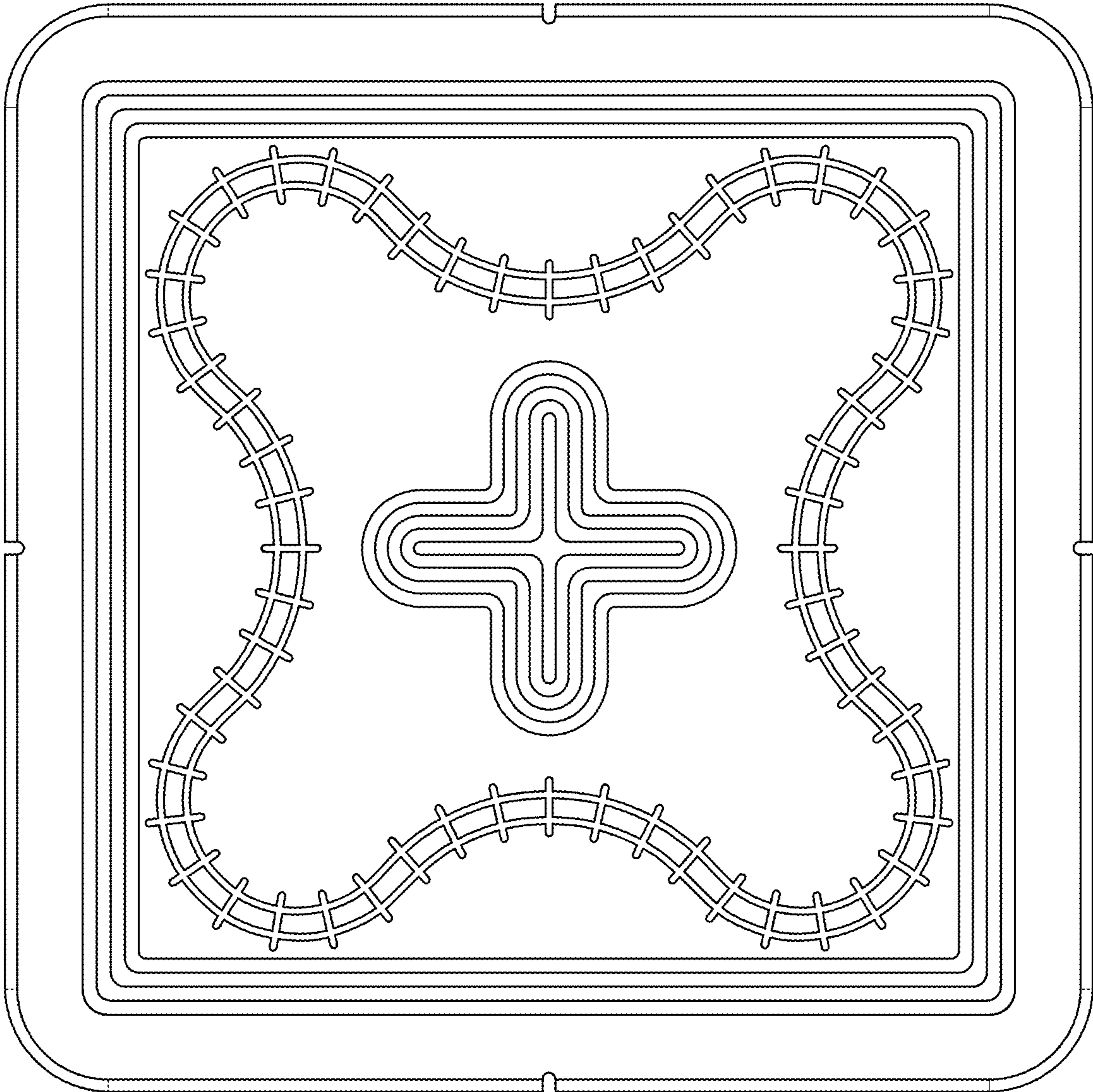

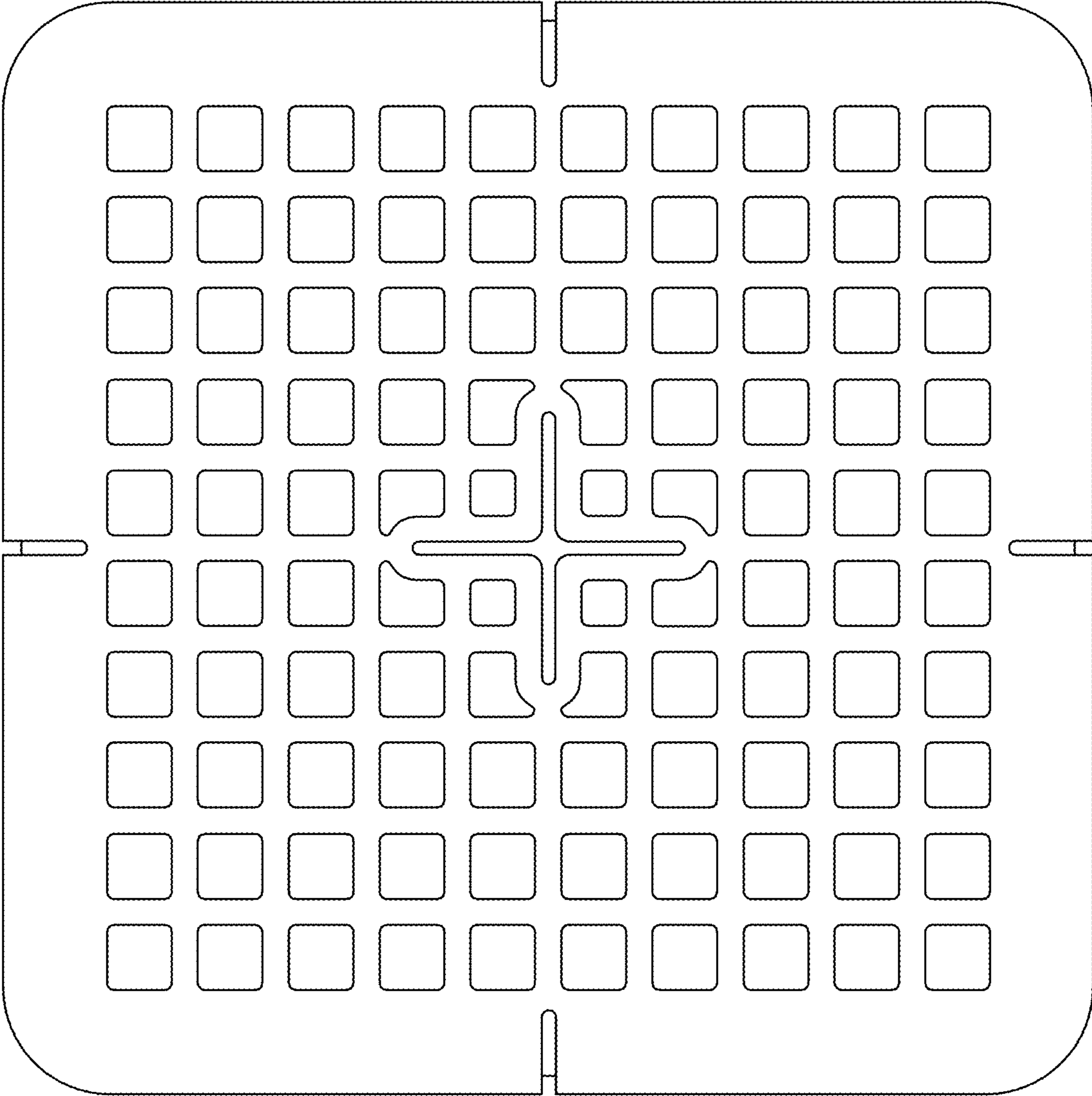

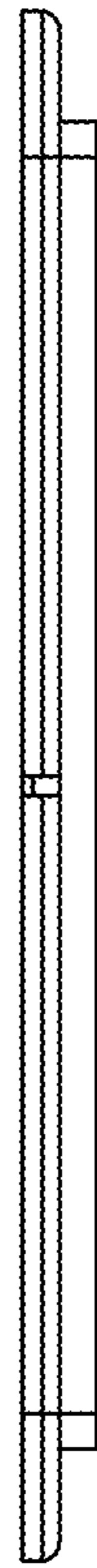

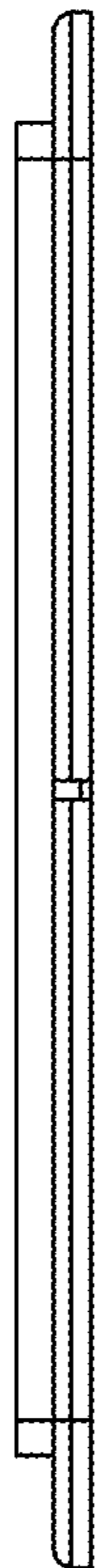

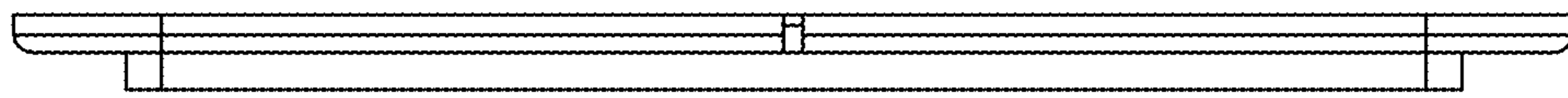

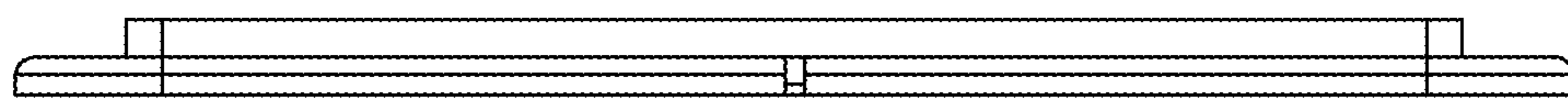
