(57) **CLAIM**

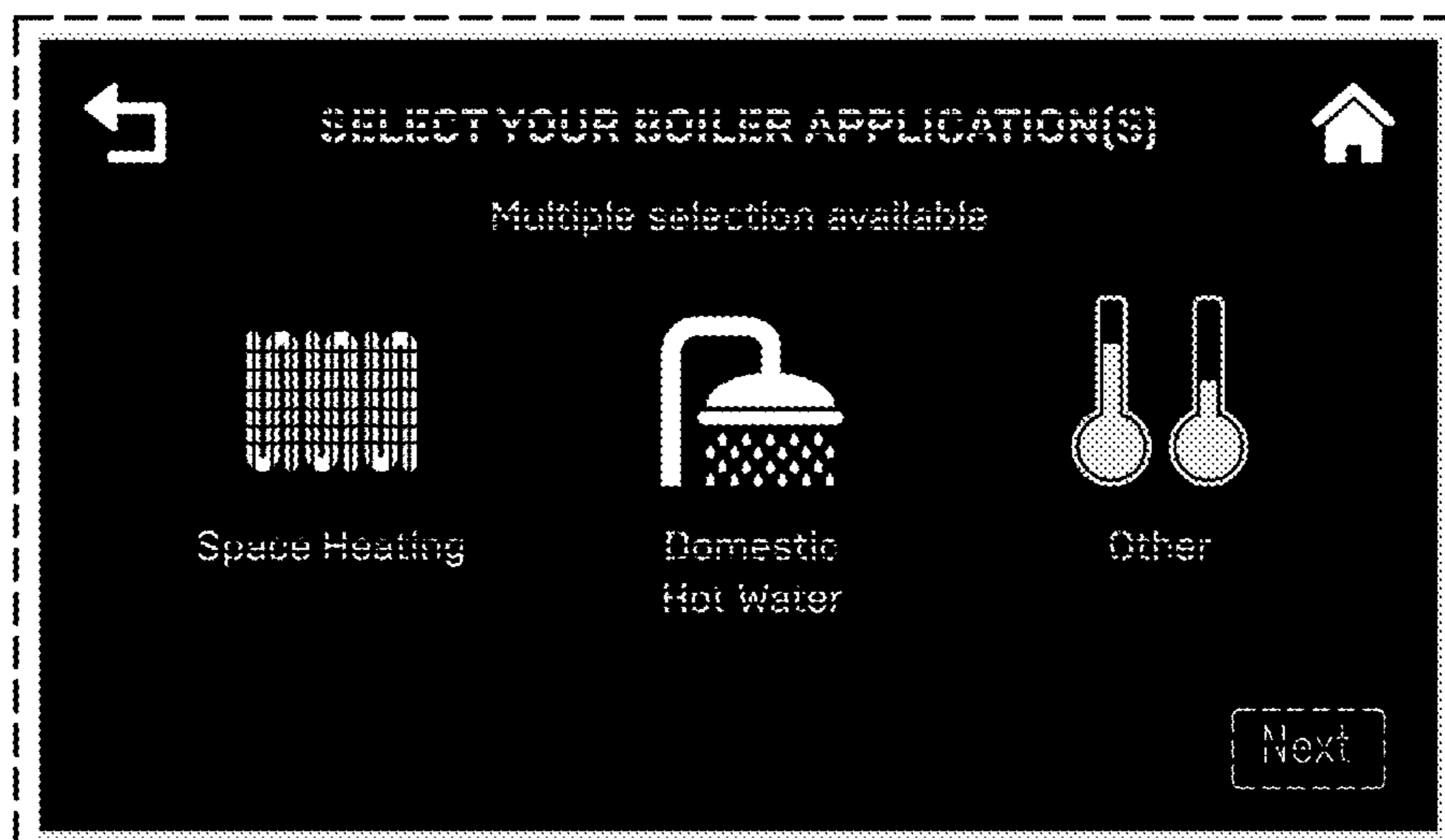
The ornamental design for a display screen or portion thereof with graphical user interface for configuring a boiler or water heater application, as shown and described.
