(57) **CLAIM**

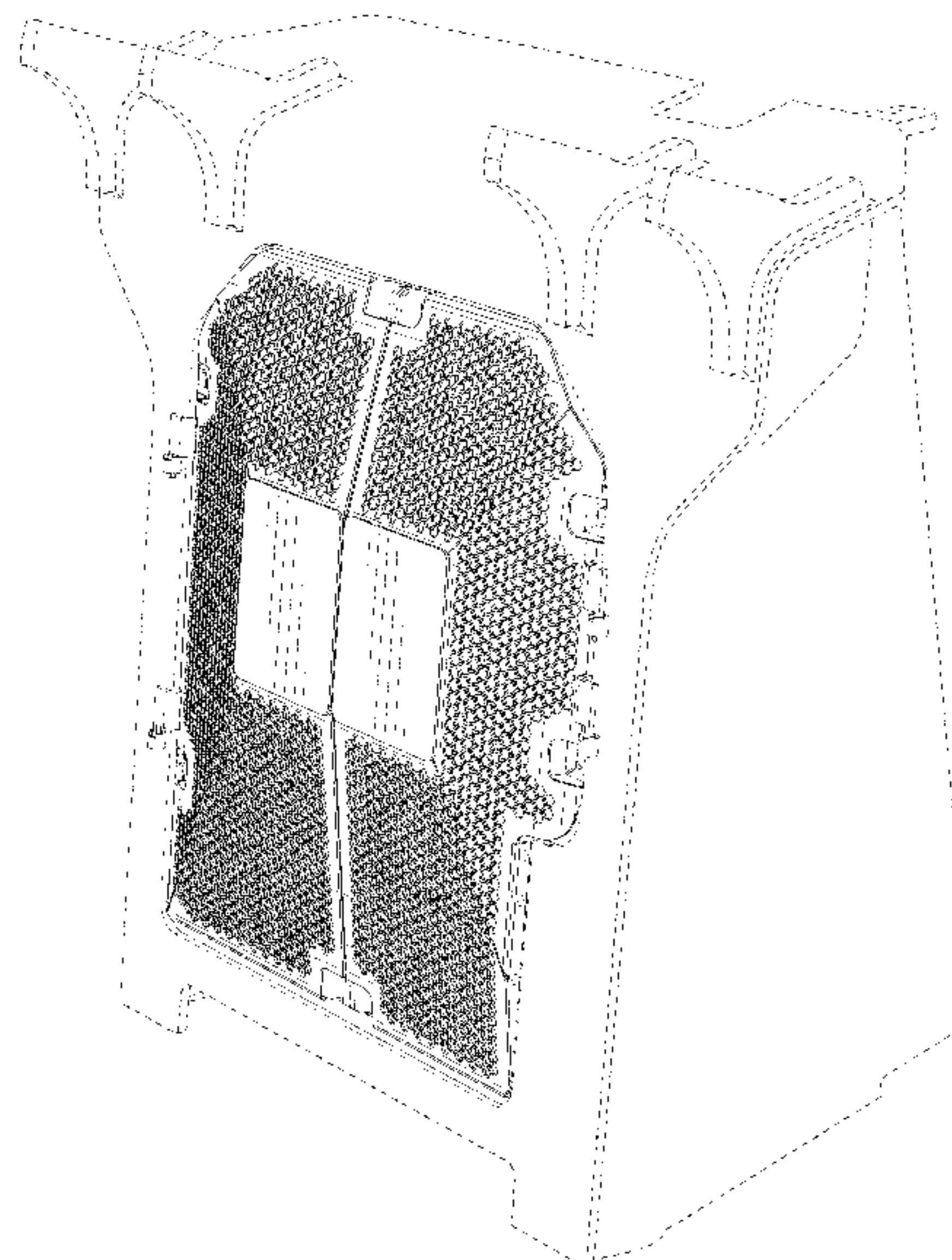
The ornamental design for a grill, as shown and described.

DESCRIPTION

FIG. 1 is a front, top, right perspective view of a grill showing the new design;
 FIG. 2 is a rear, bottom, left perspective view thereof;
 FIG. 3 is a front elevation view thereof;
 FIG. 4 is a rear elevation view thereof;
 FIG. 5 is a left-side elevation view thereof;
 FIG. 6 is a right-side elevation view thereof;
 FIG. 7 is an enlarged top plan view thereof;
 FIG. 8 is an enlarged bottom plan view thereof;
 FIG. 9 is an enlarged front elevation view as indicated in FIG. 3;
 FIG. 10 is an enlarged left-side elevation view as indicated in FIG. 5; and,
 FIG. 11 is an enlarged right-side elevation view as indicated in FIG. 6.

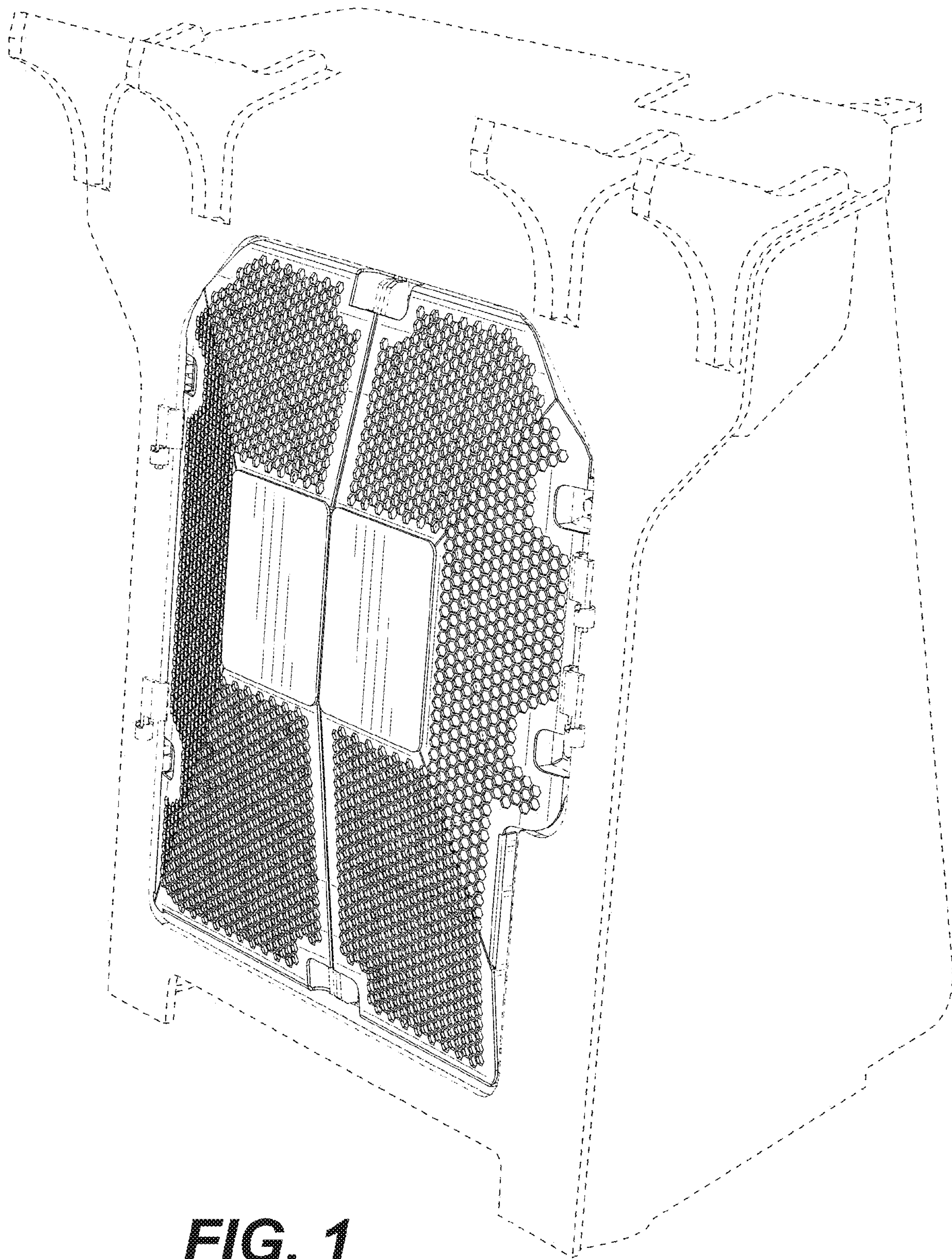

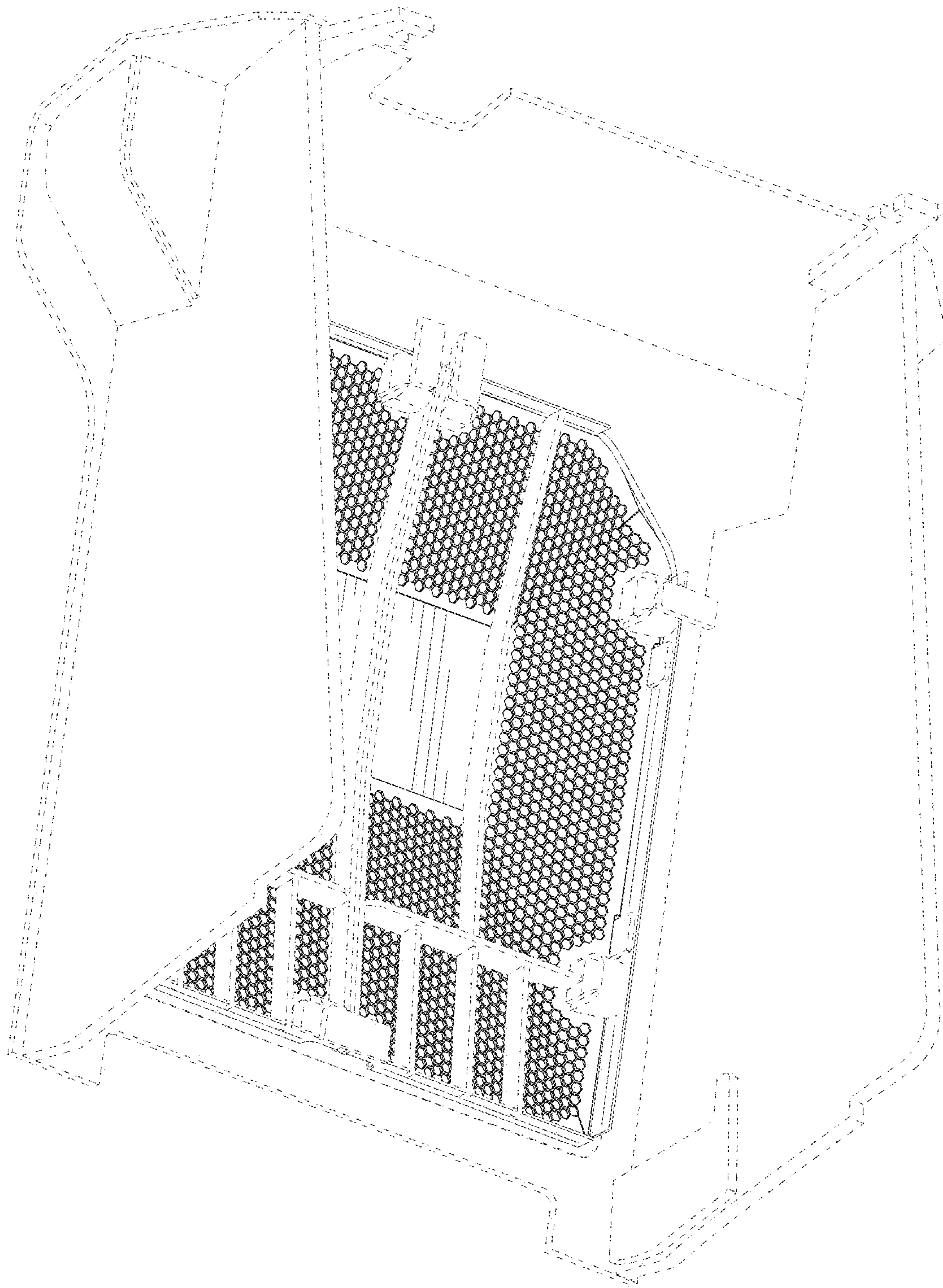

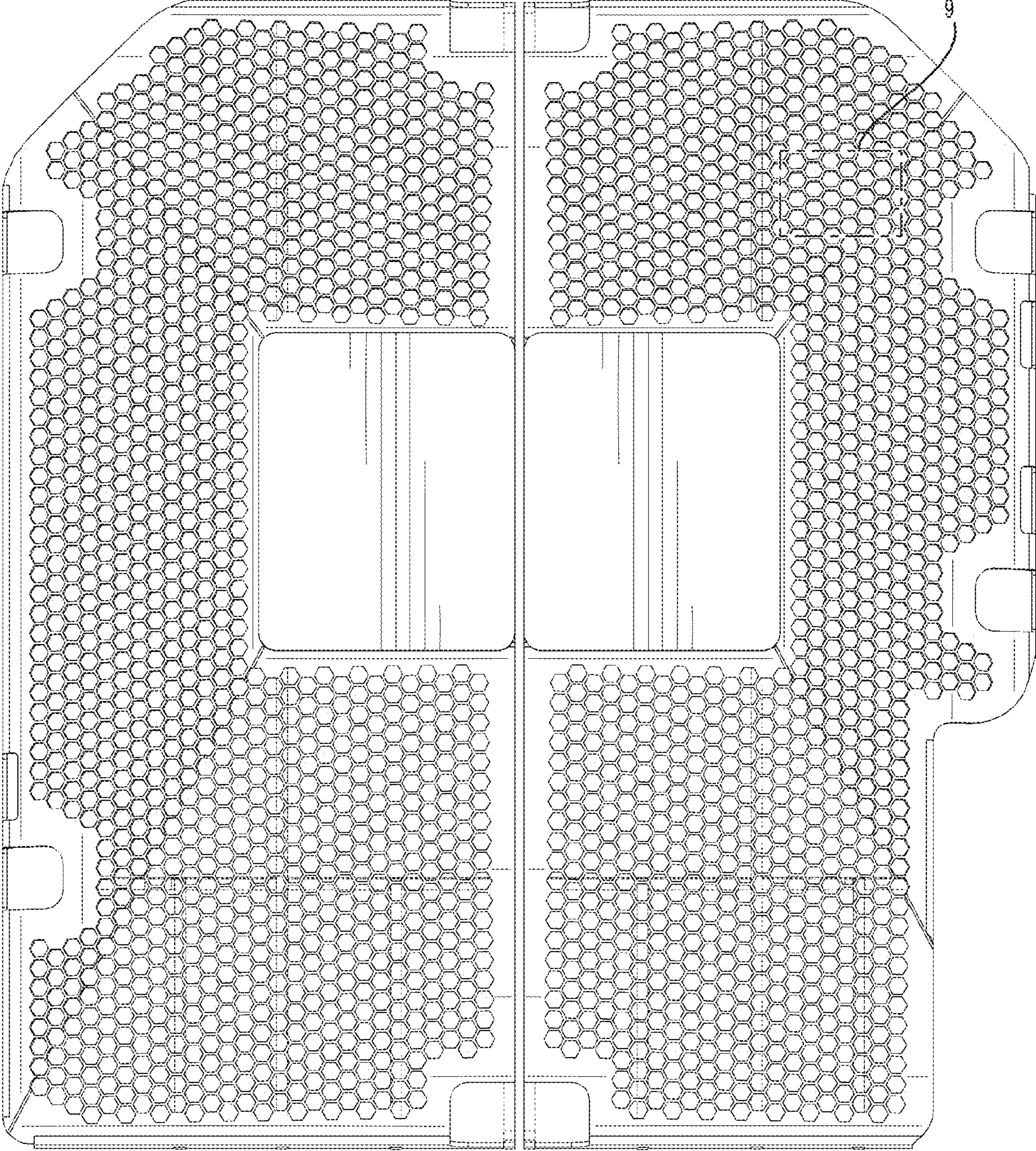

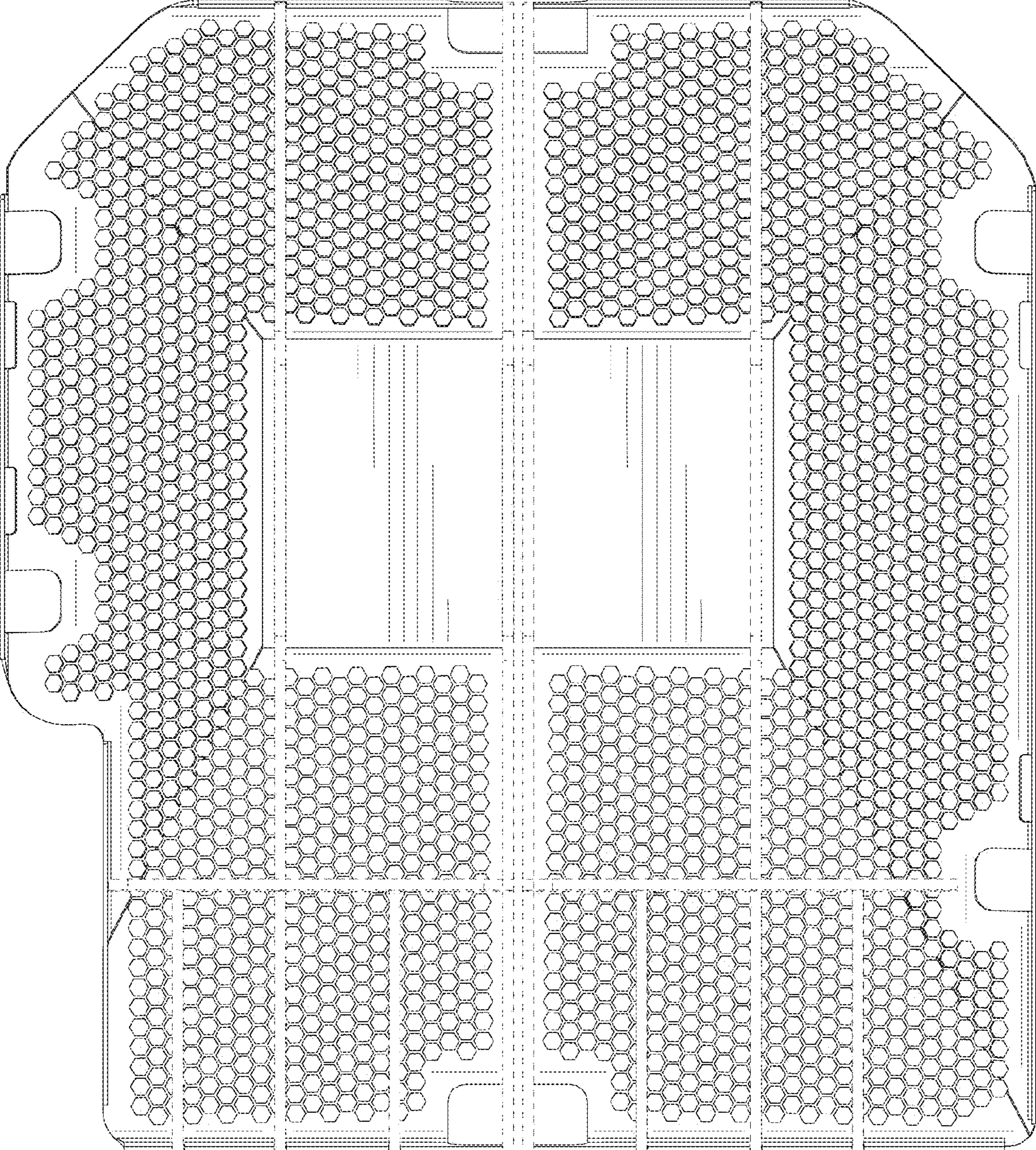

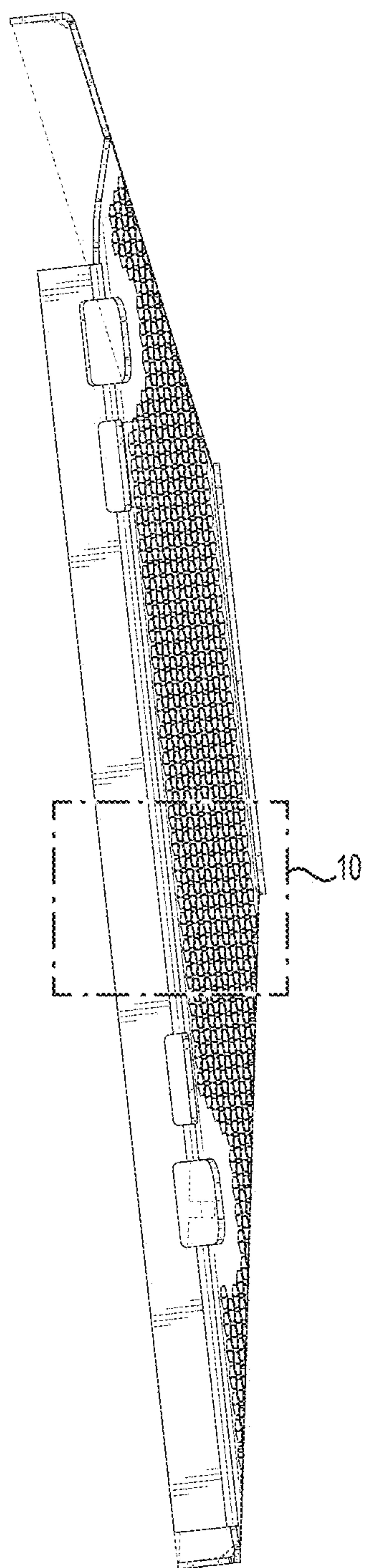

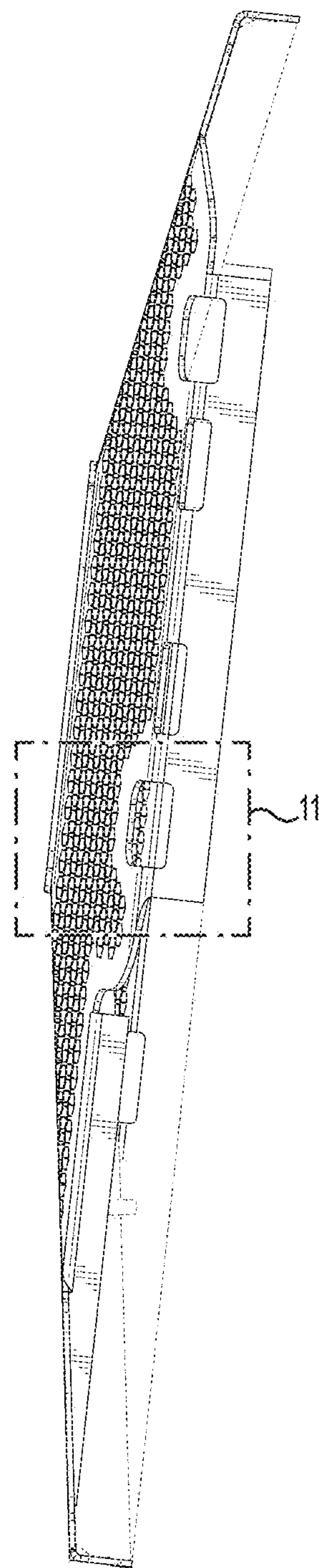

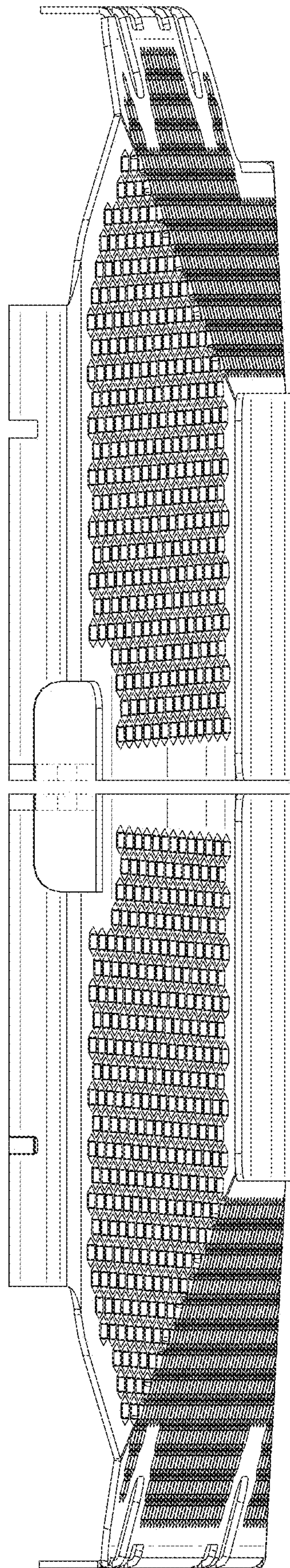

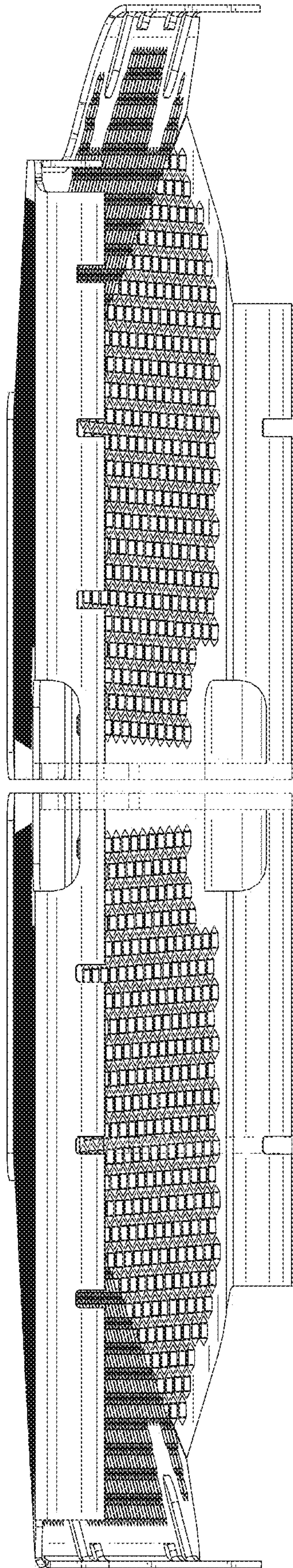

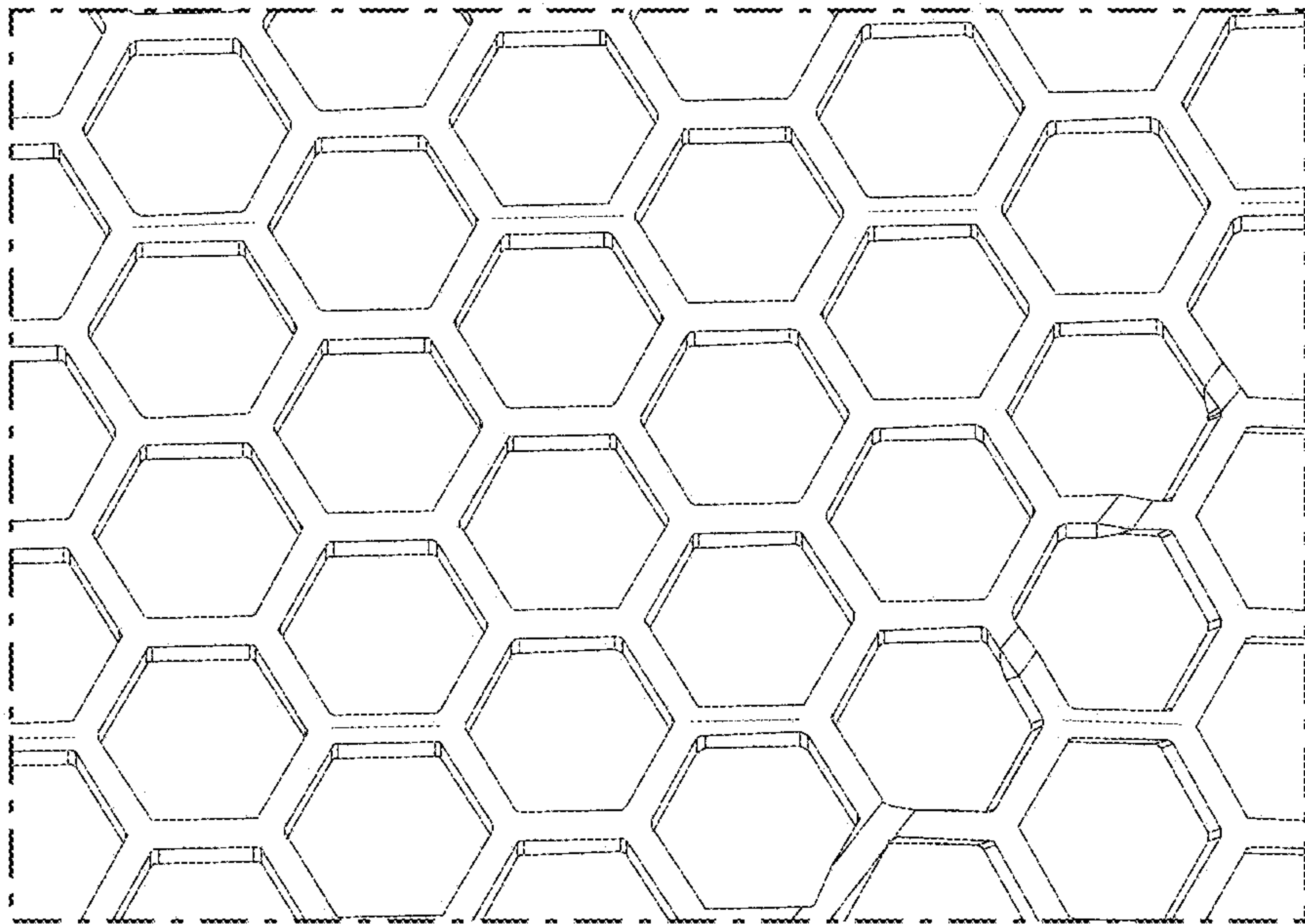

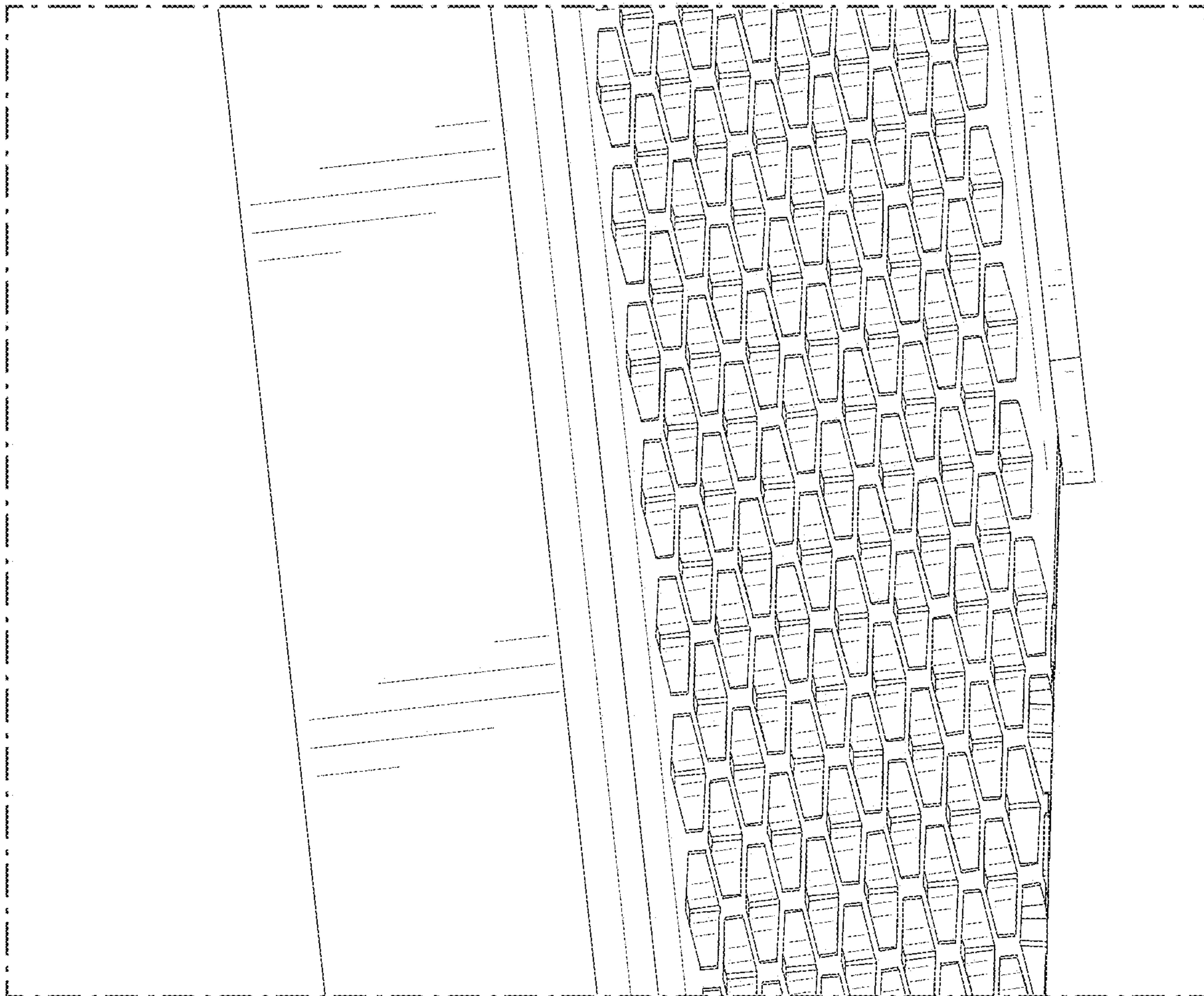

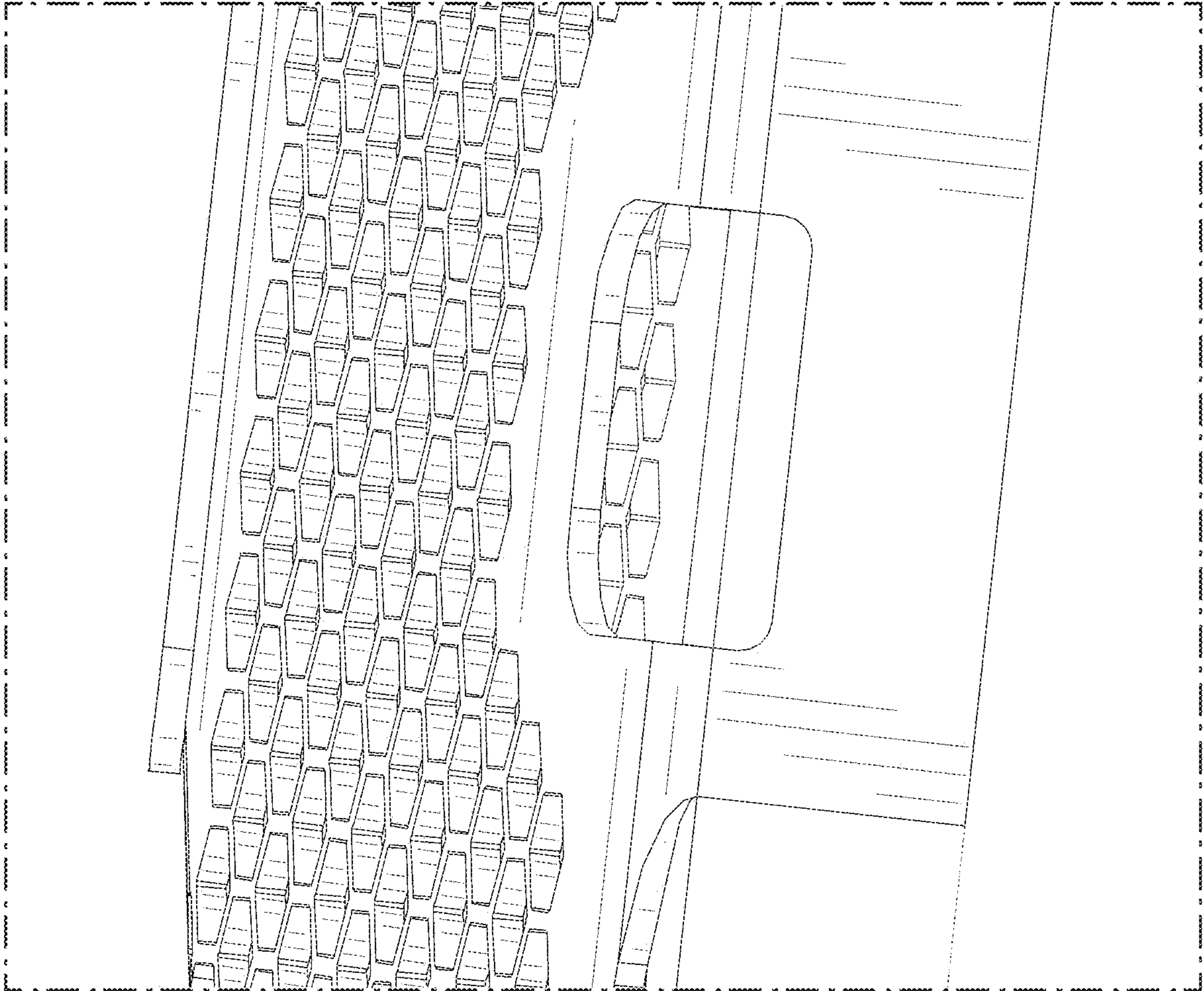
