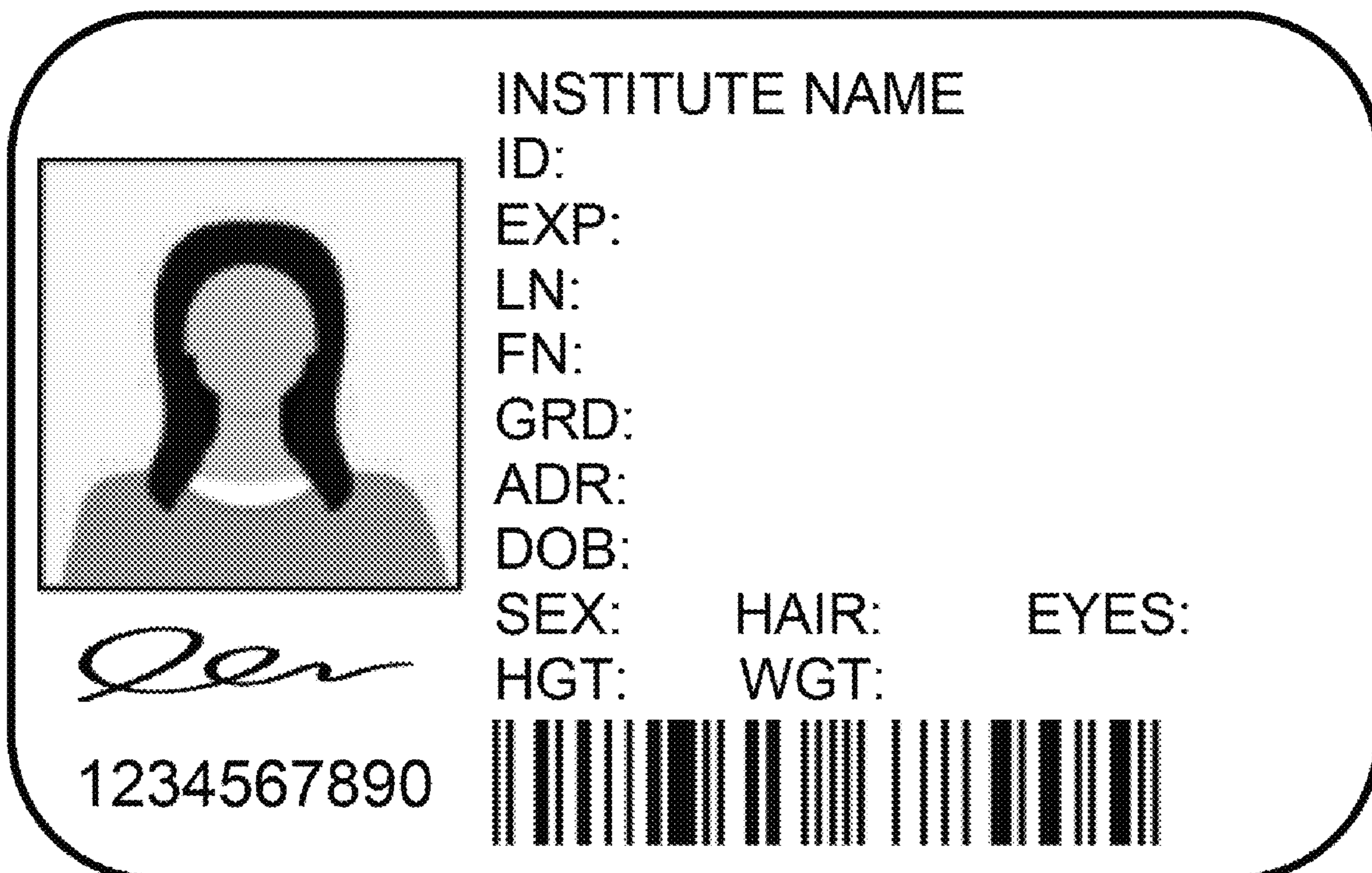

DESCRIPTION
FIG. 1 is a front view of the smart student ID card showing our new design.
FIG. 2 is a top view, the bottom view being a mirror image thereof;

FIG. 4 is a left side view, the right side view being a mirror image thereof; and,

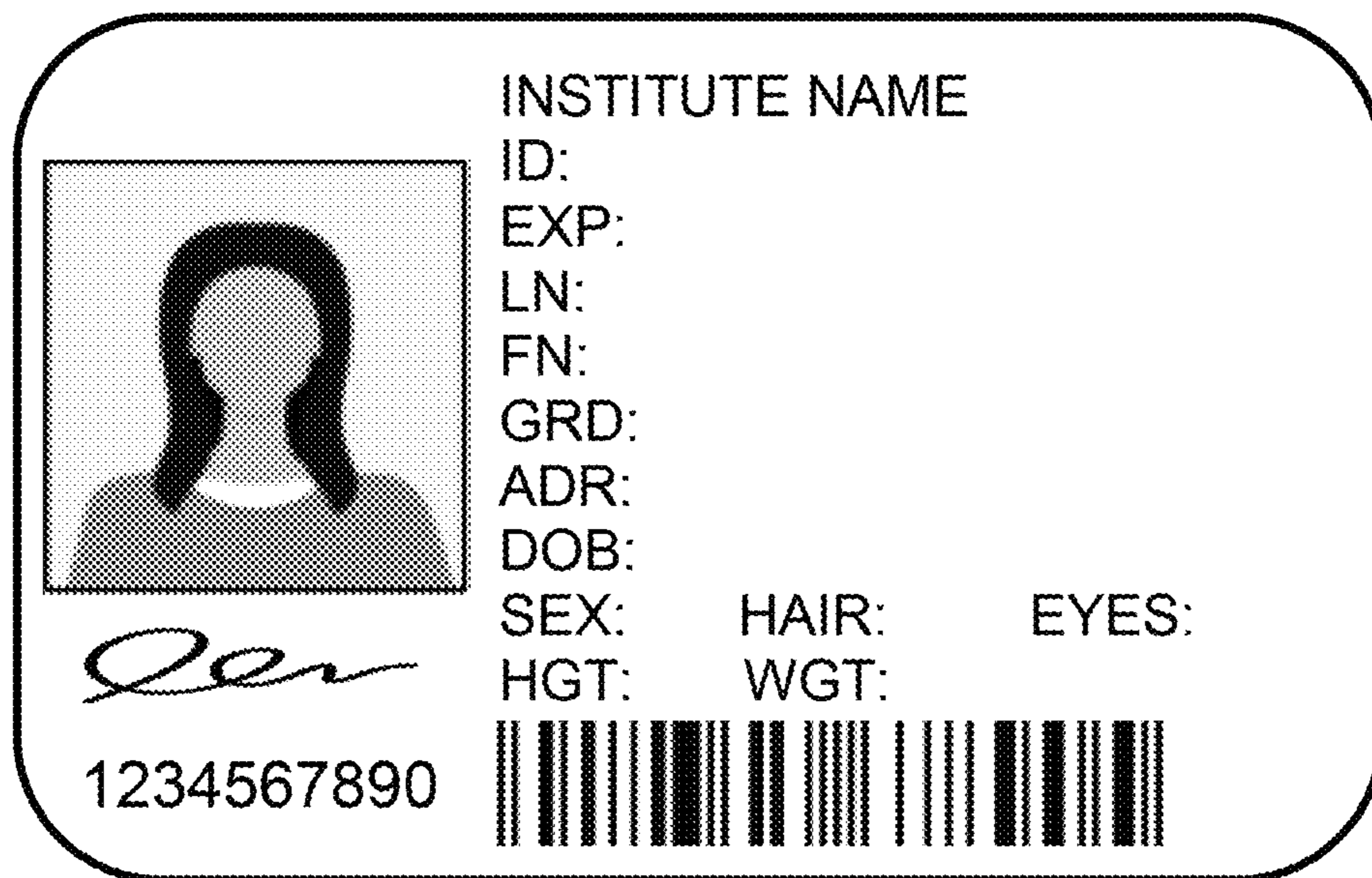

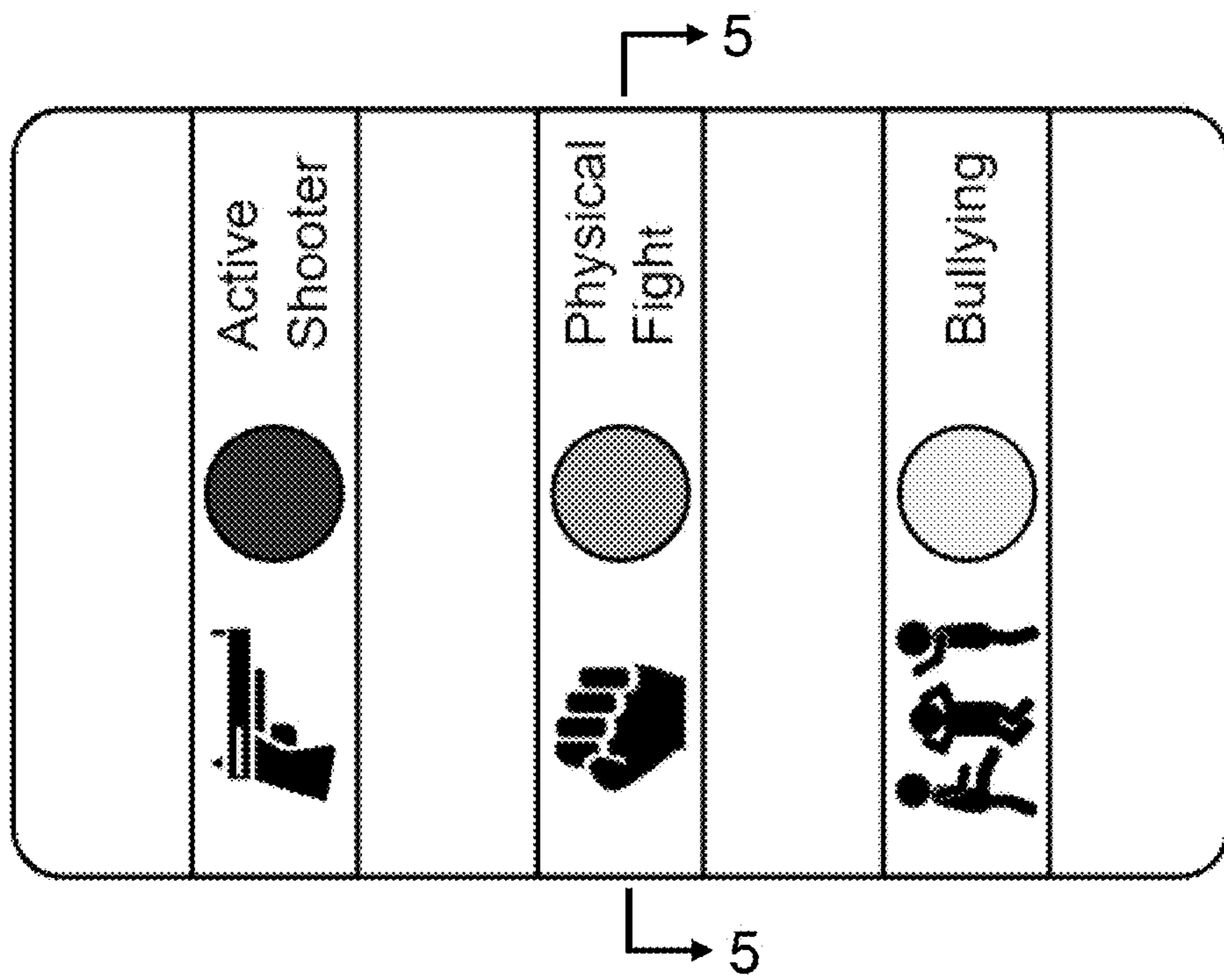

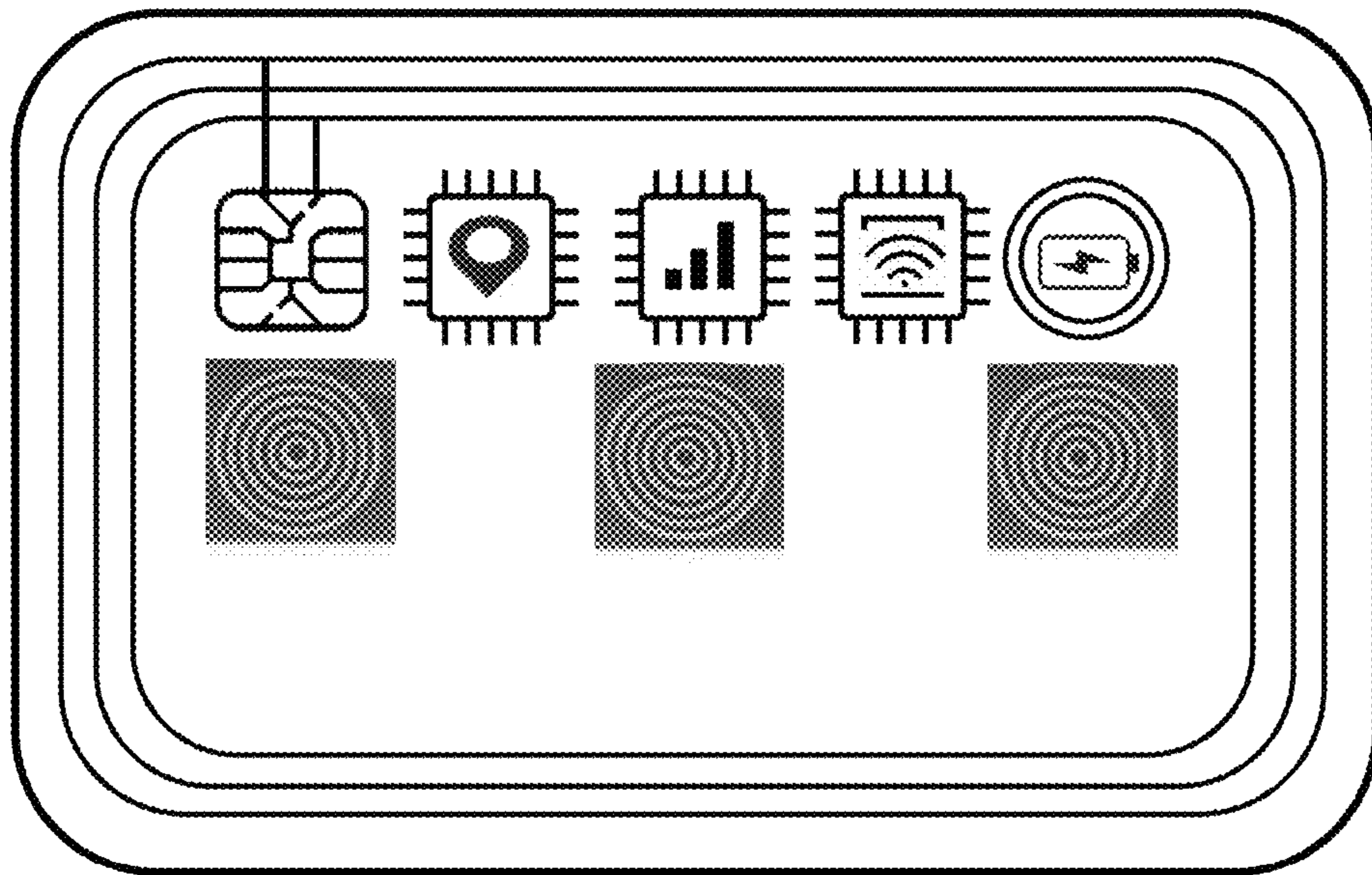
