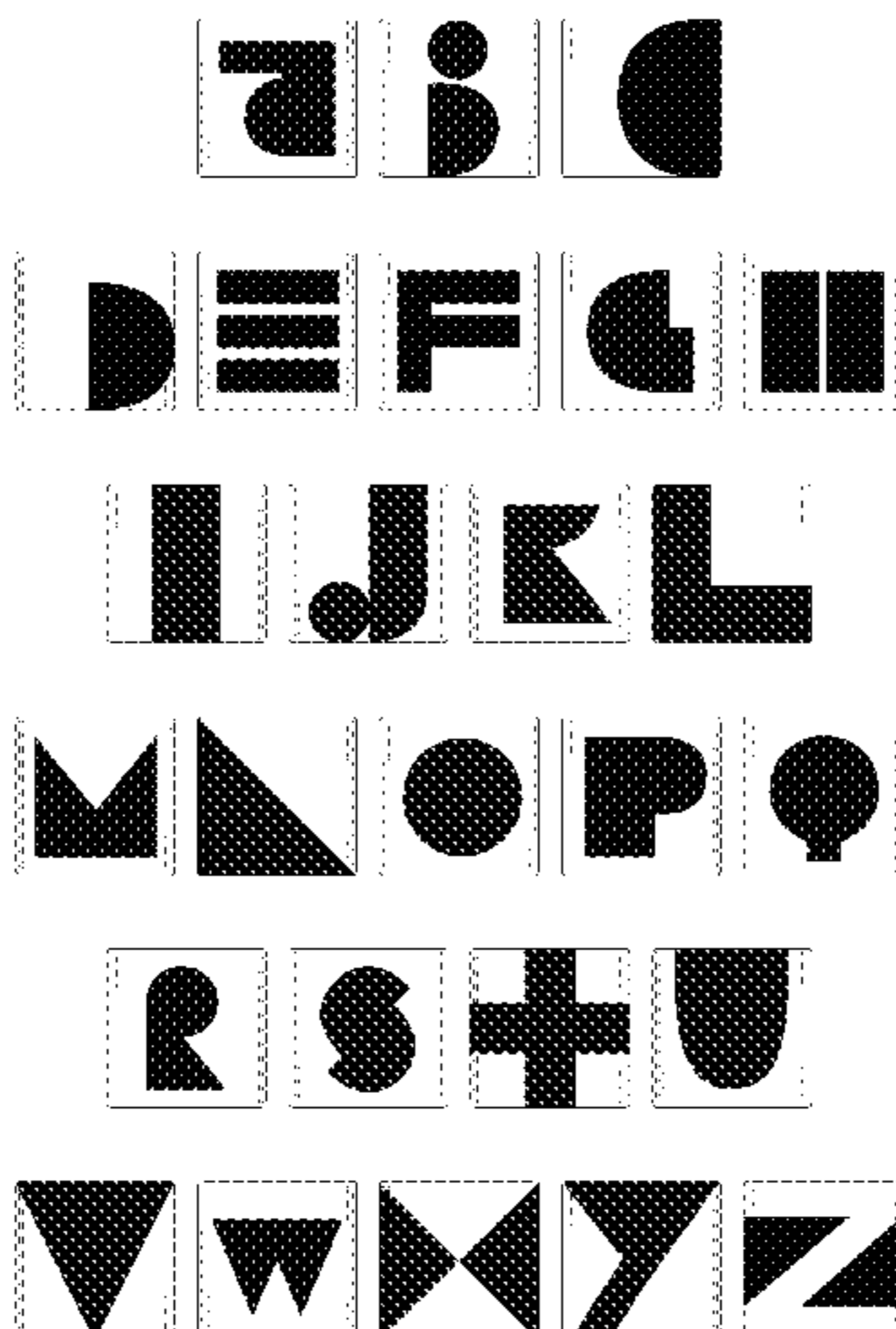


FIG. 17 is a multi-facet perspective view of the sixteenth block shown in FIG. 1, the opposite facets thereof being identical;

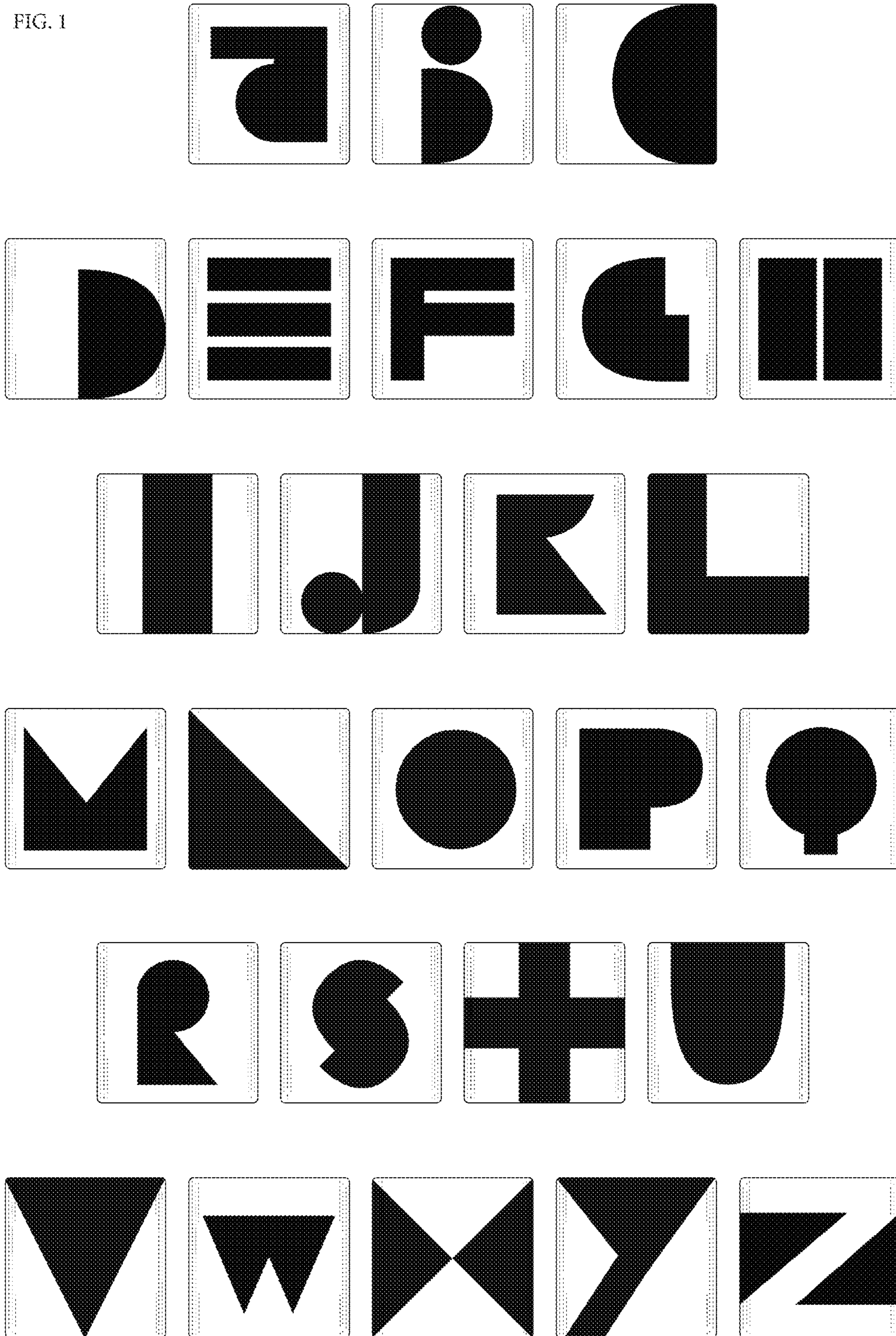

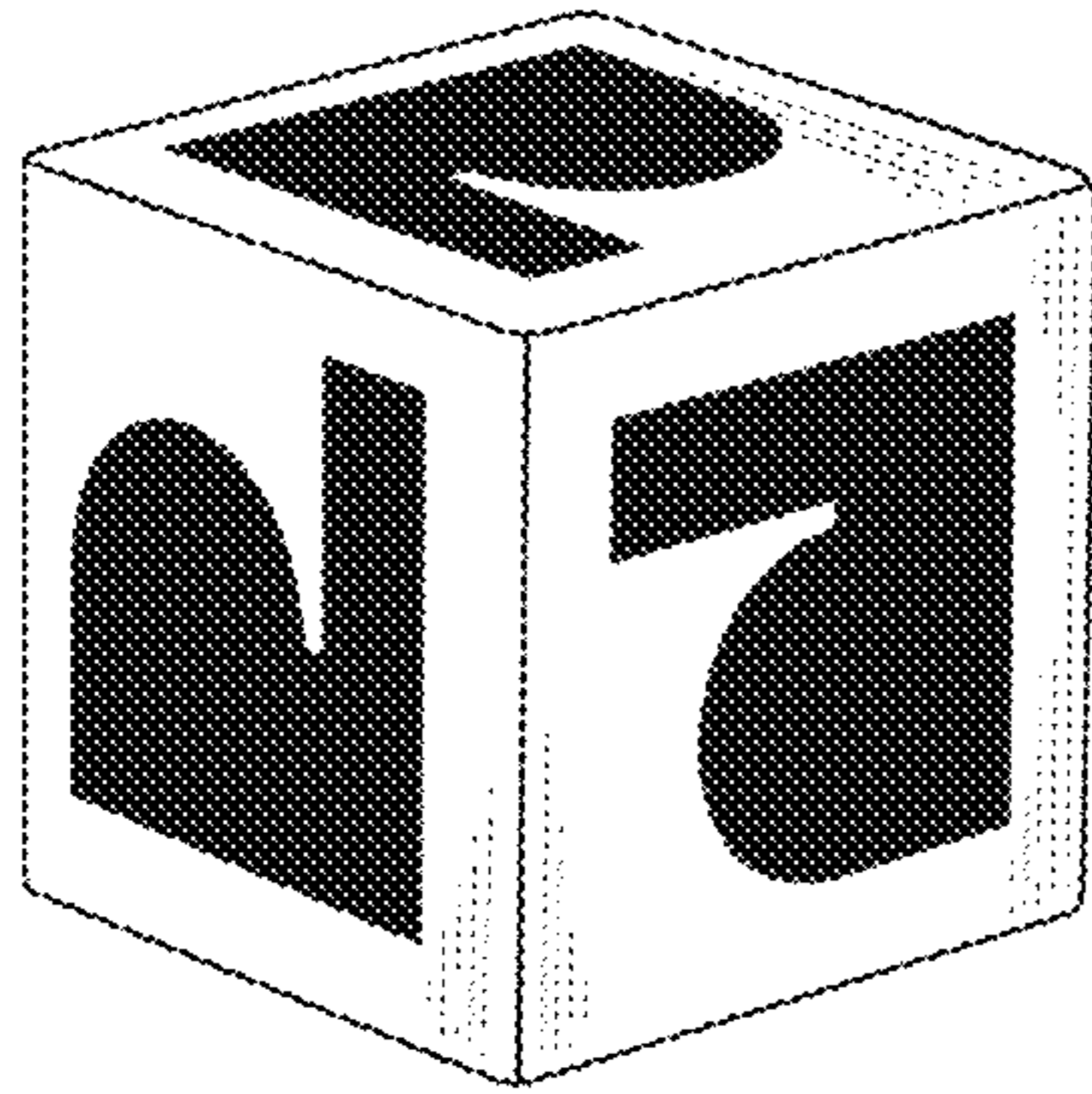

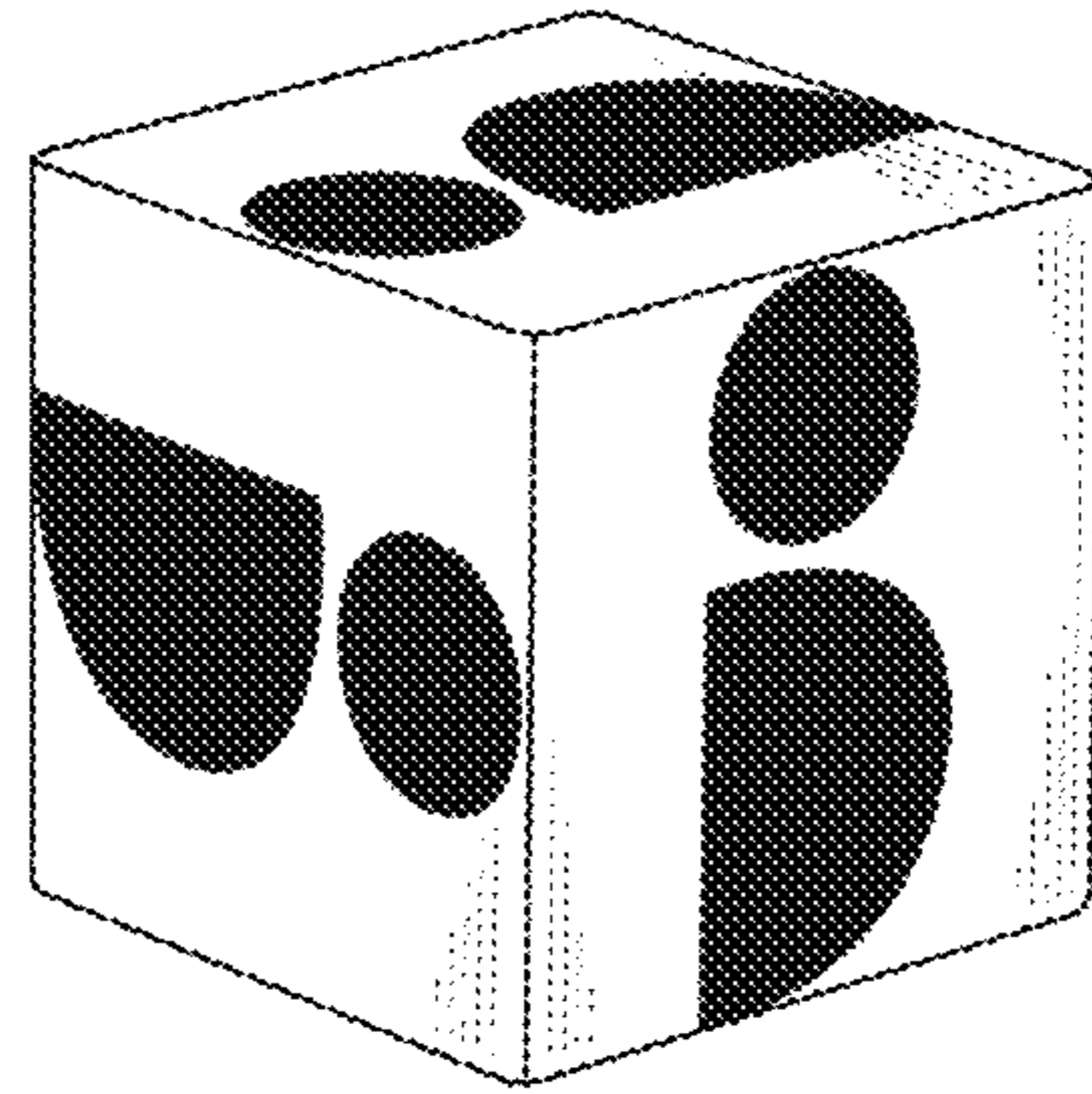

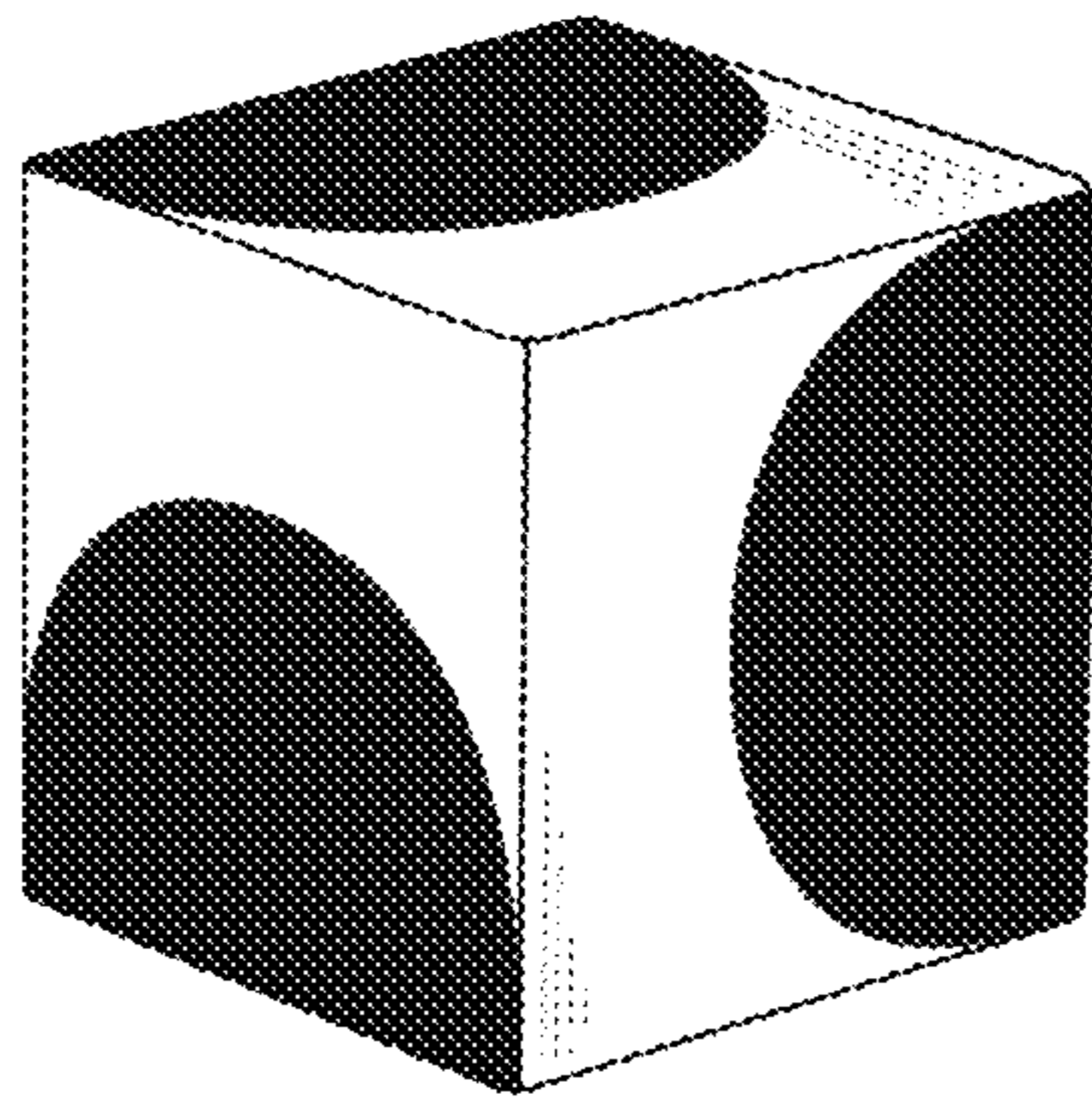

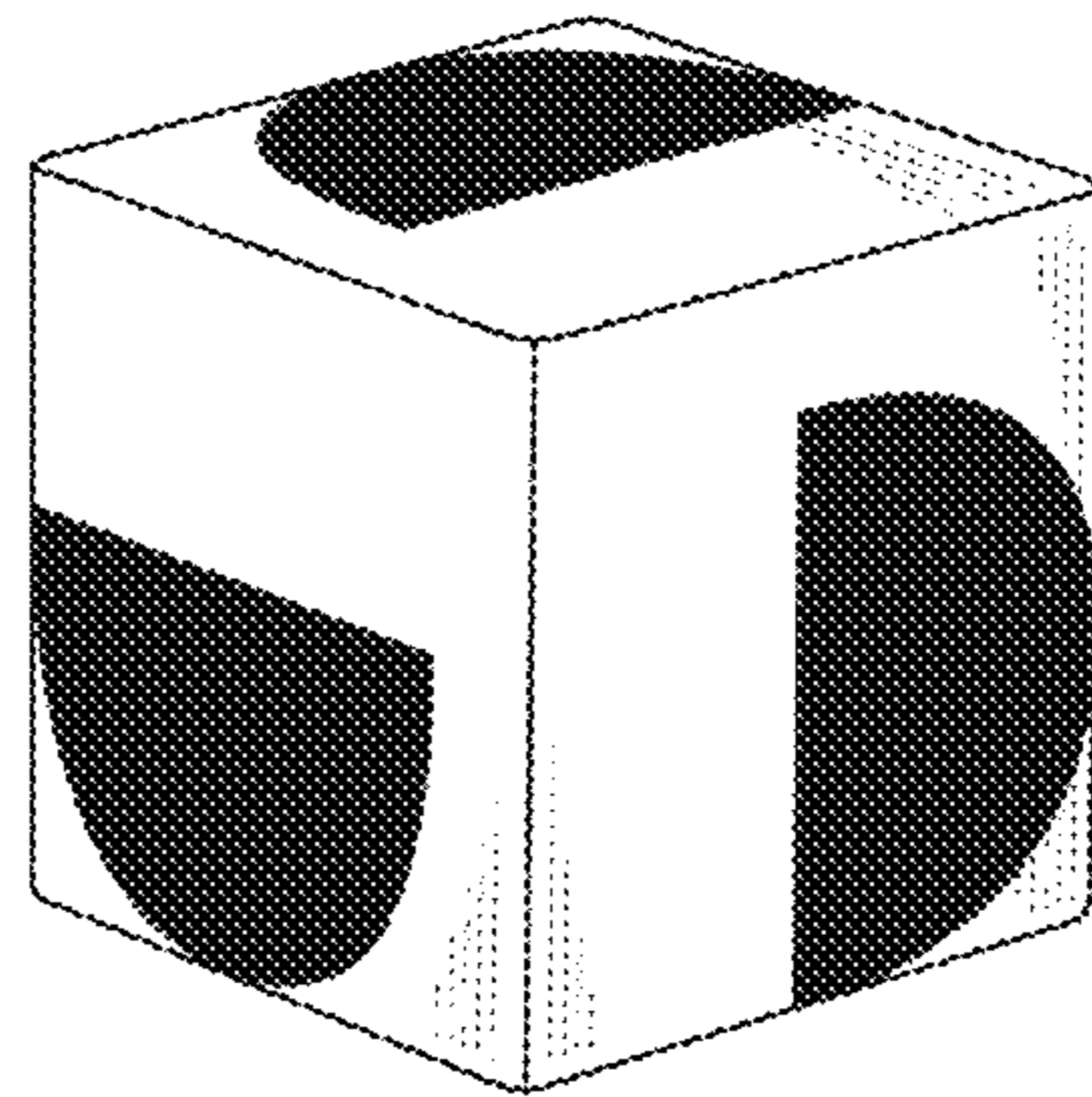

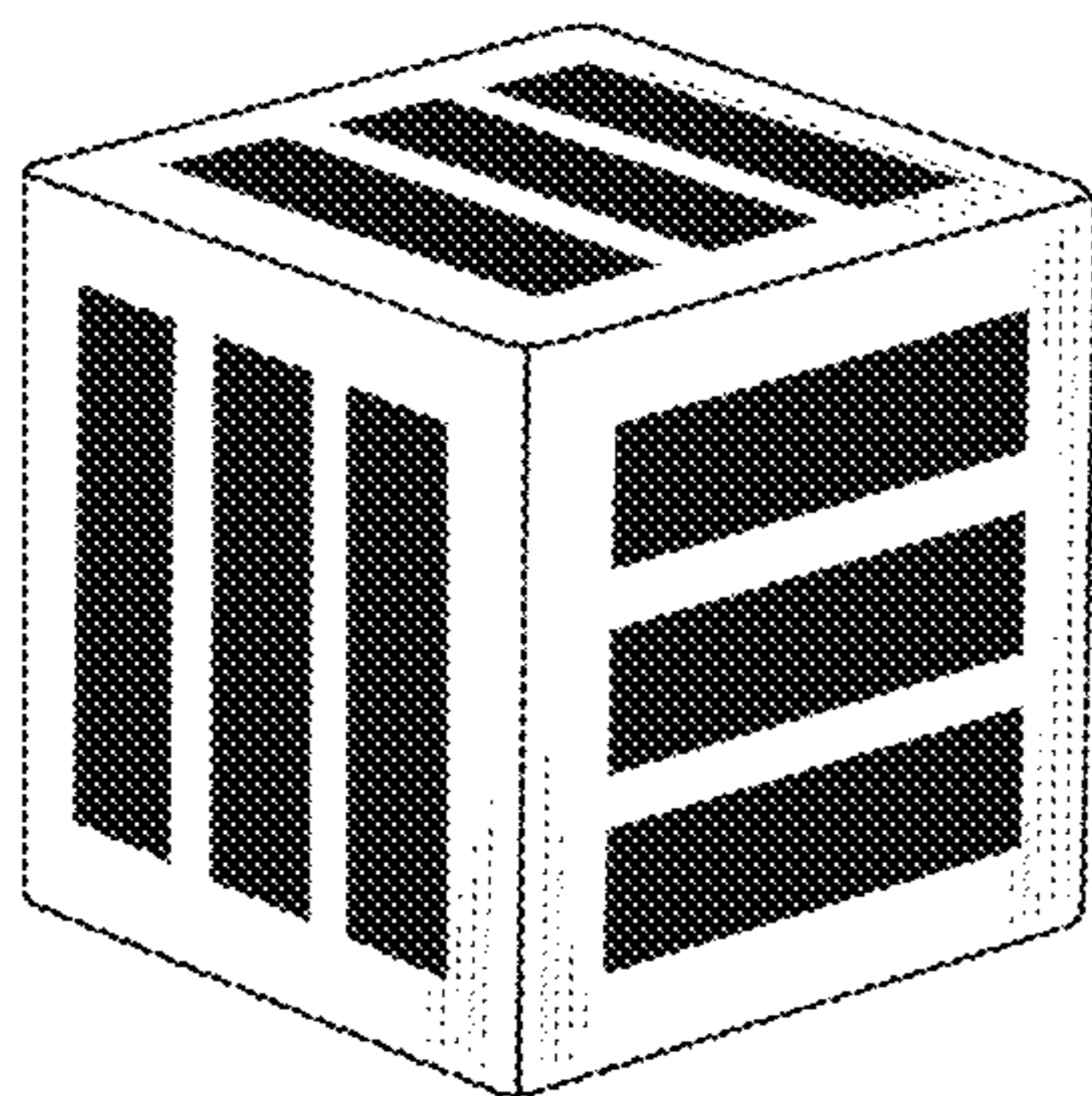

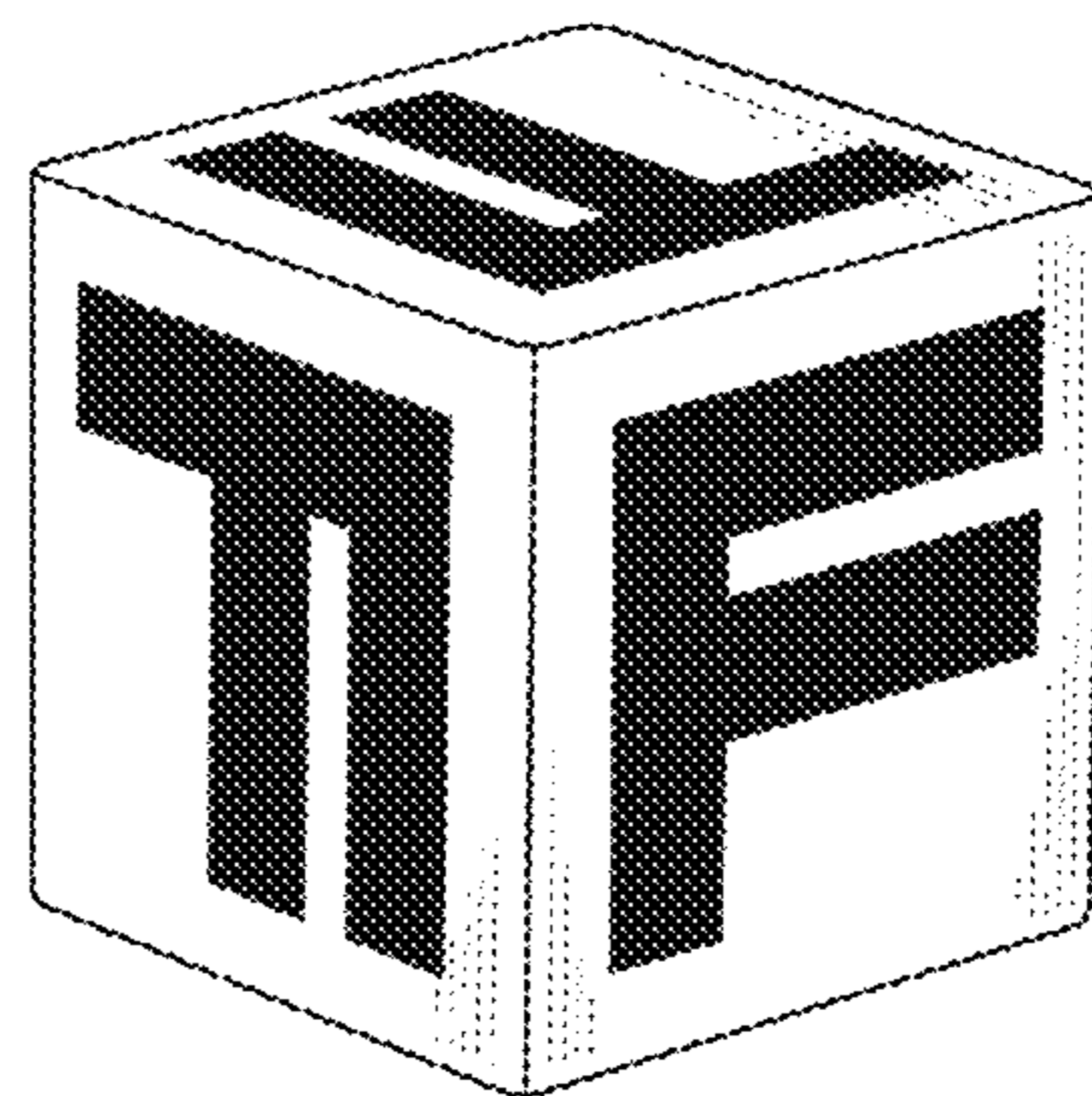

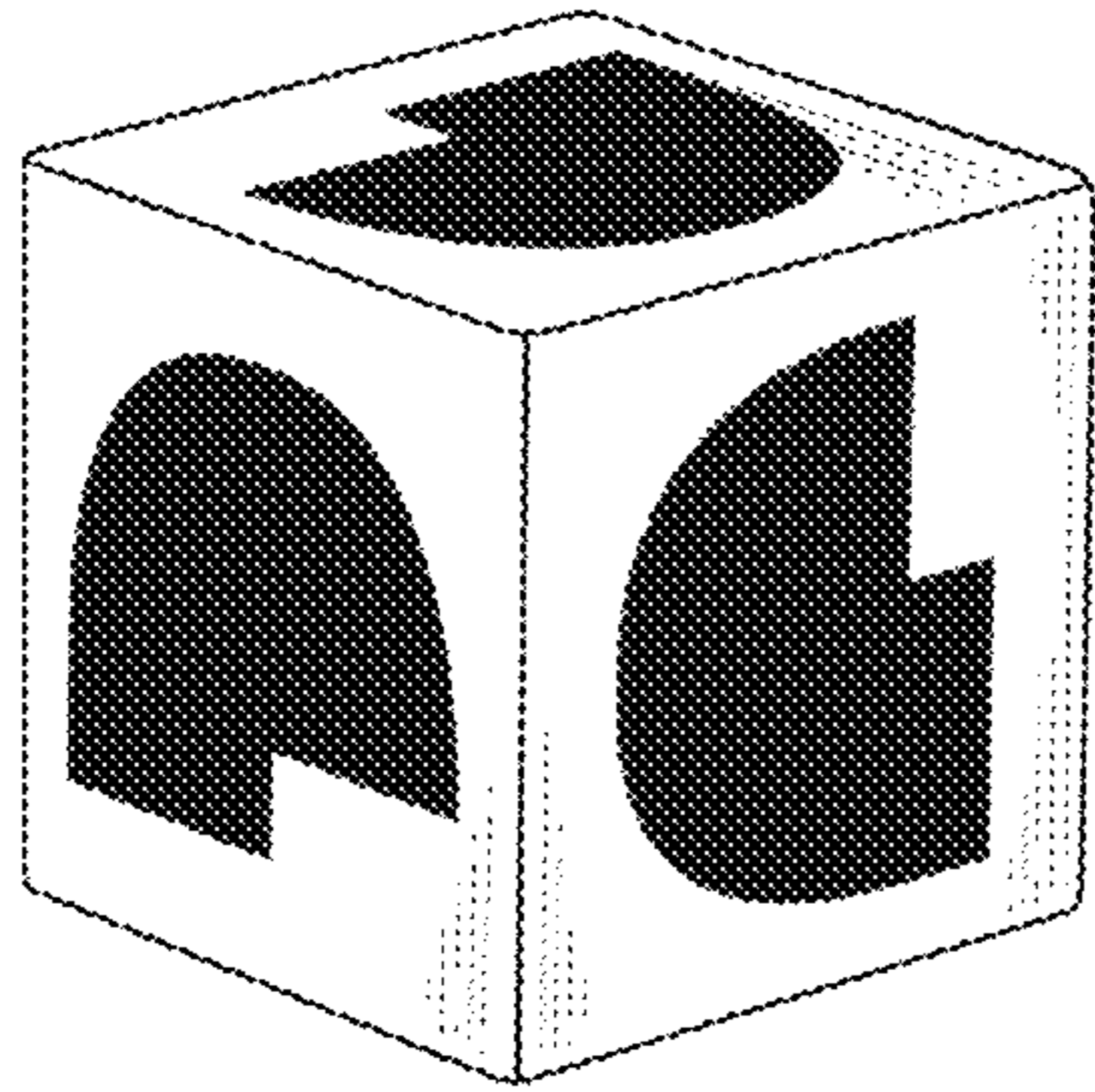

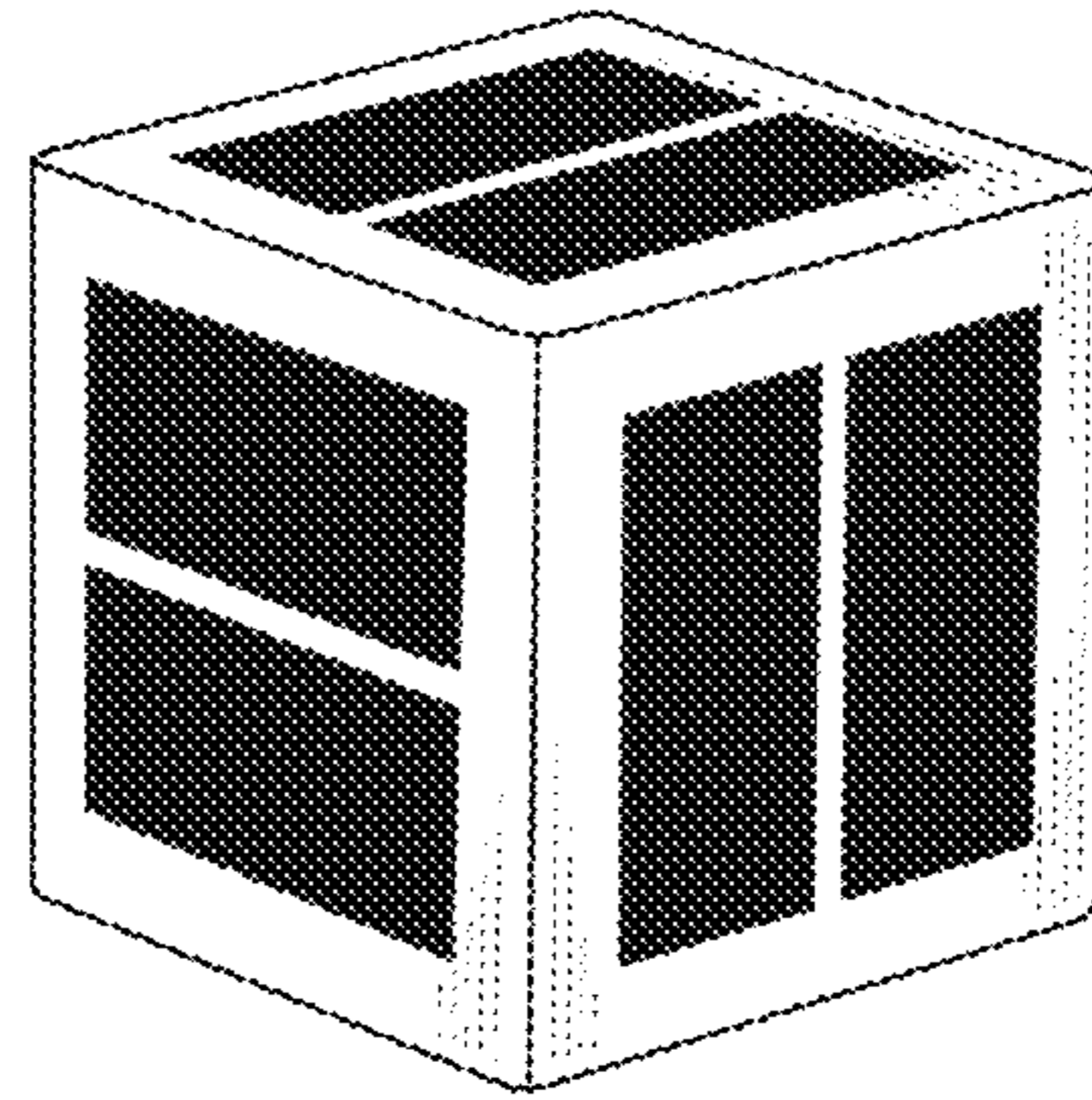

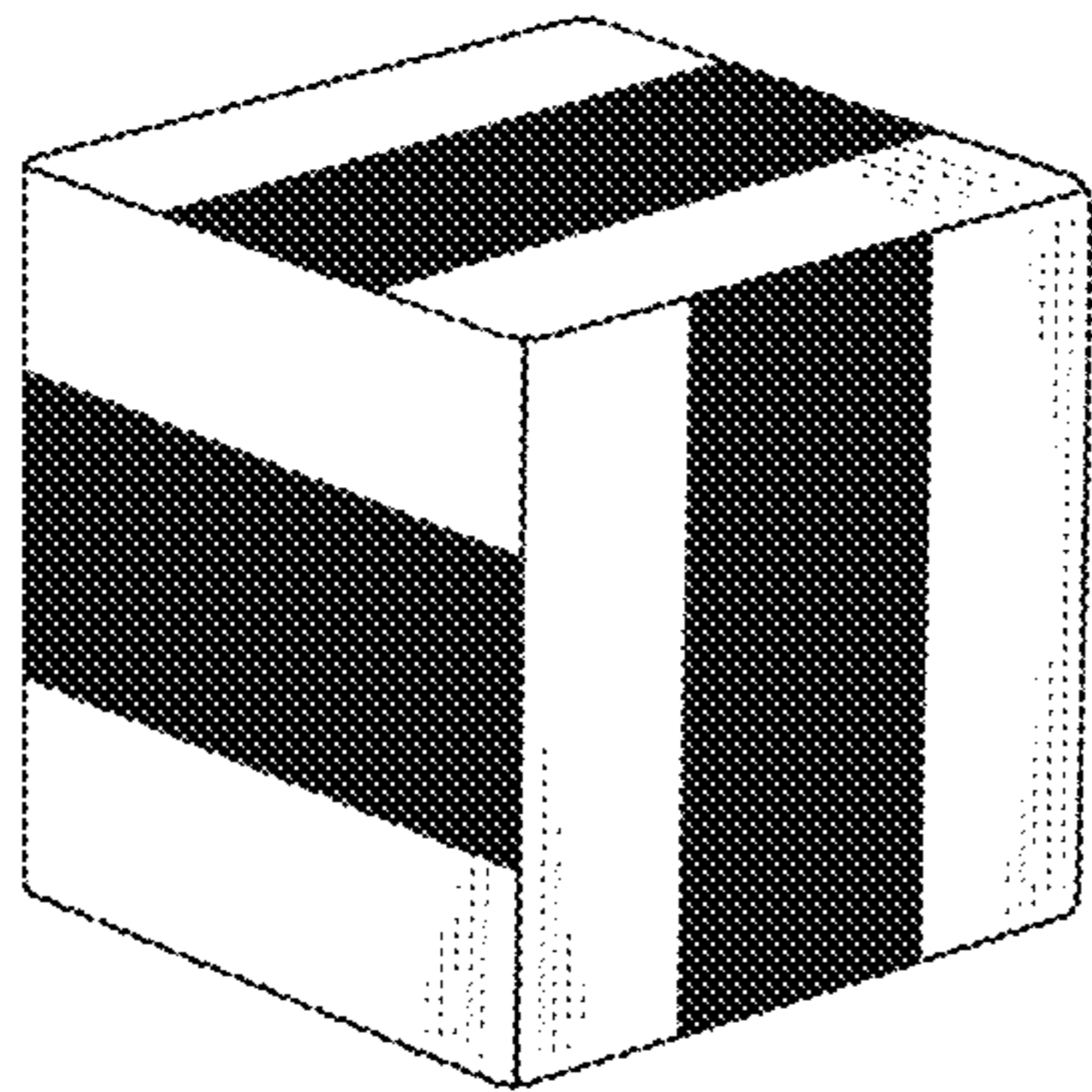

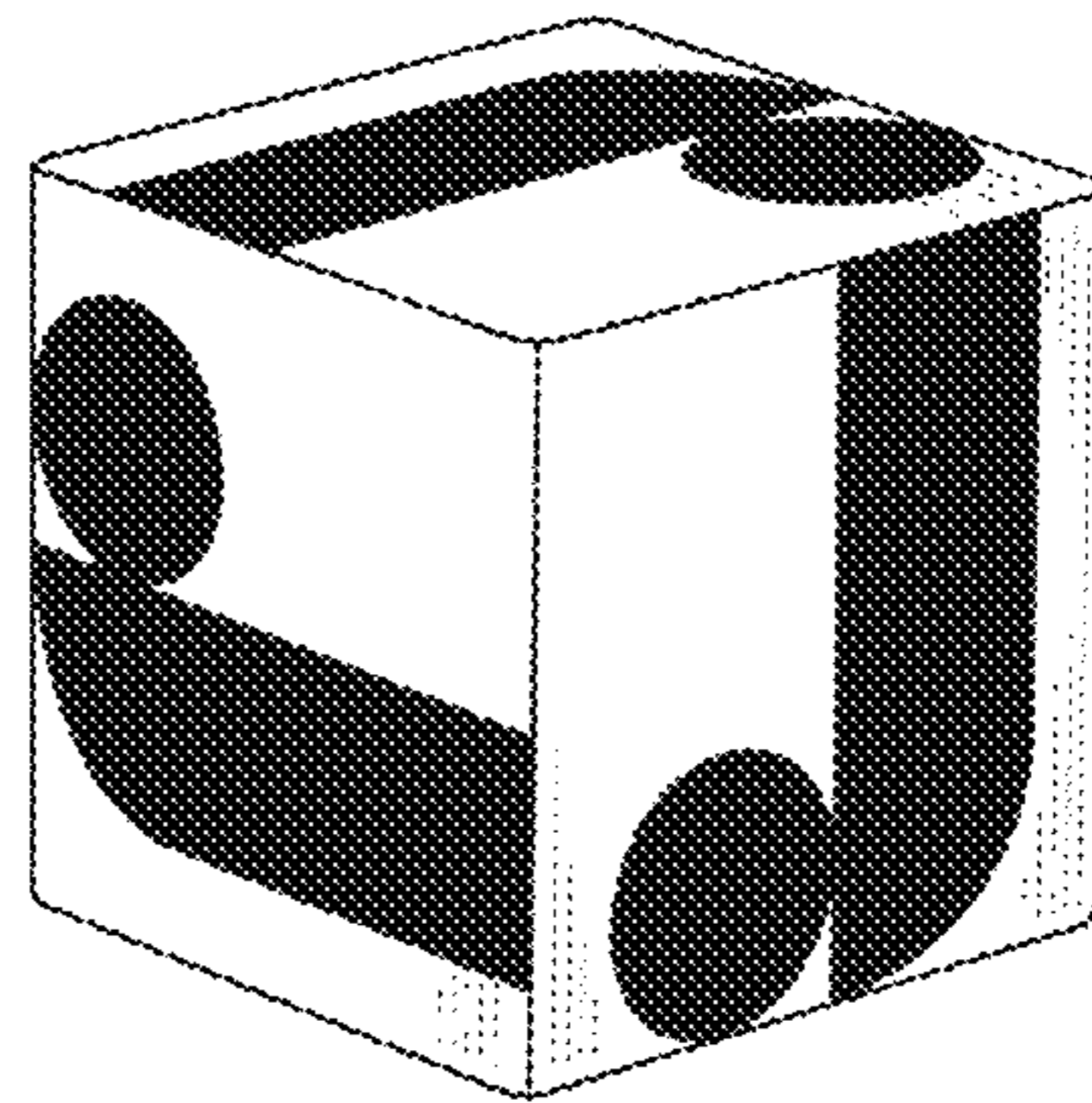

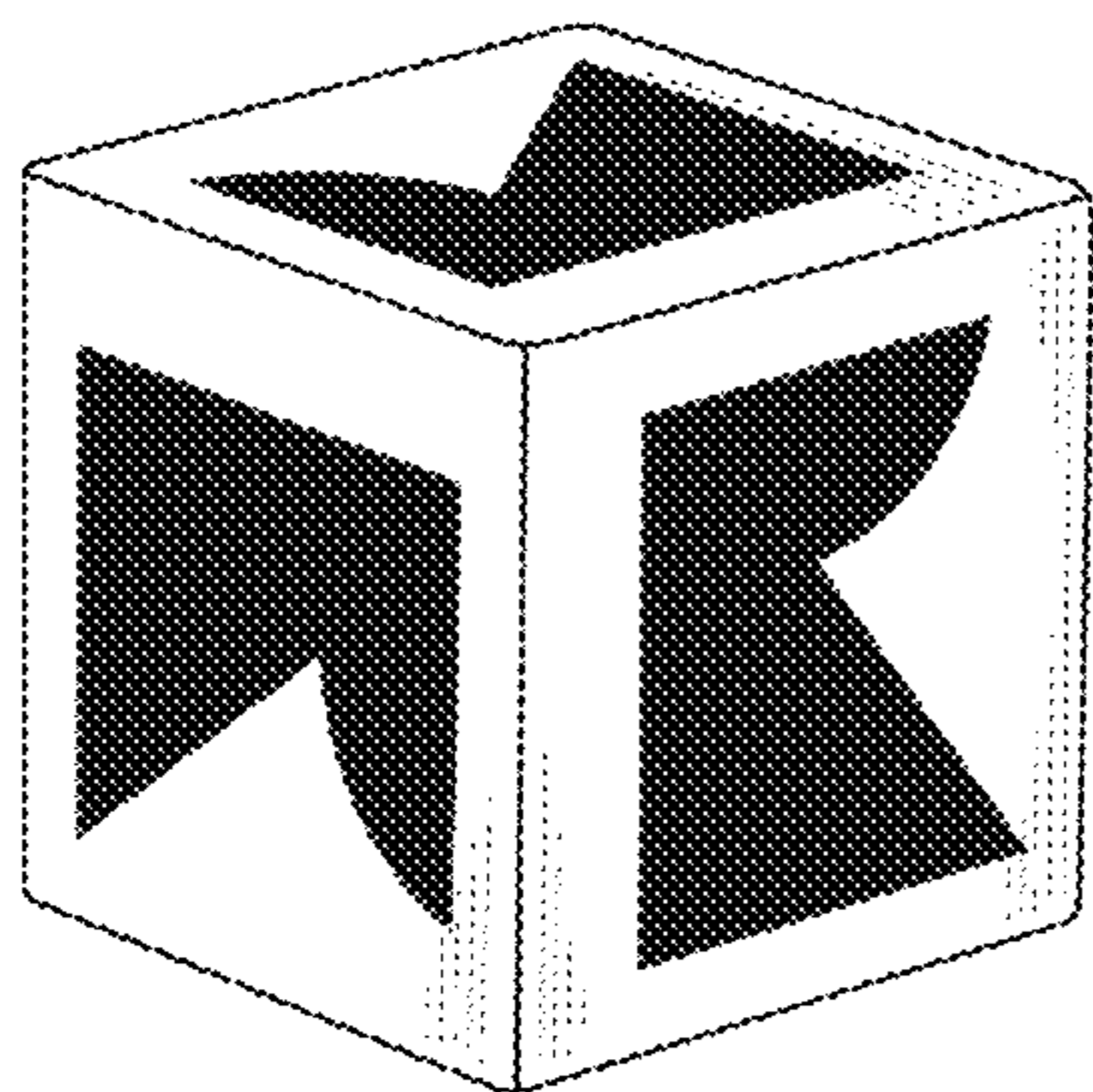

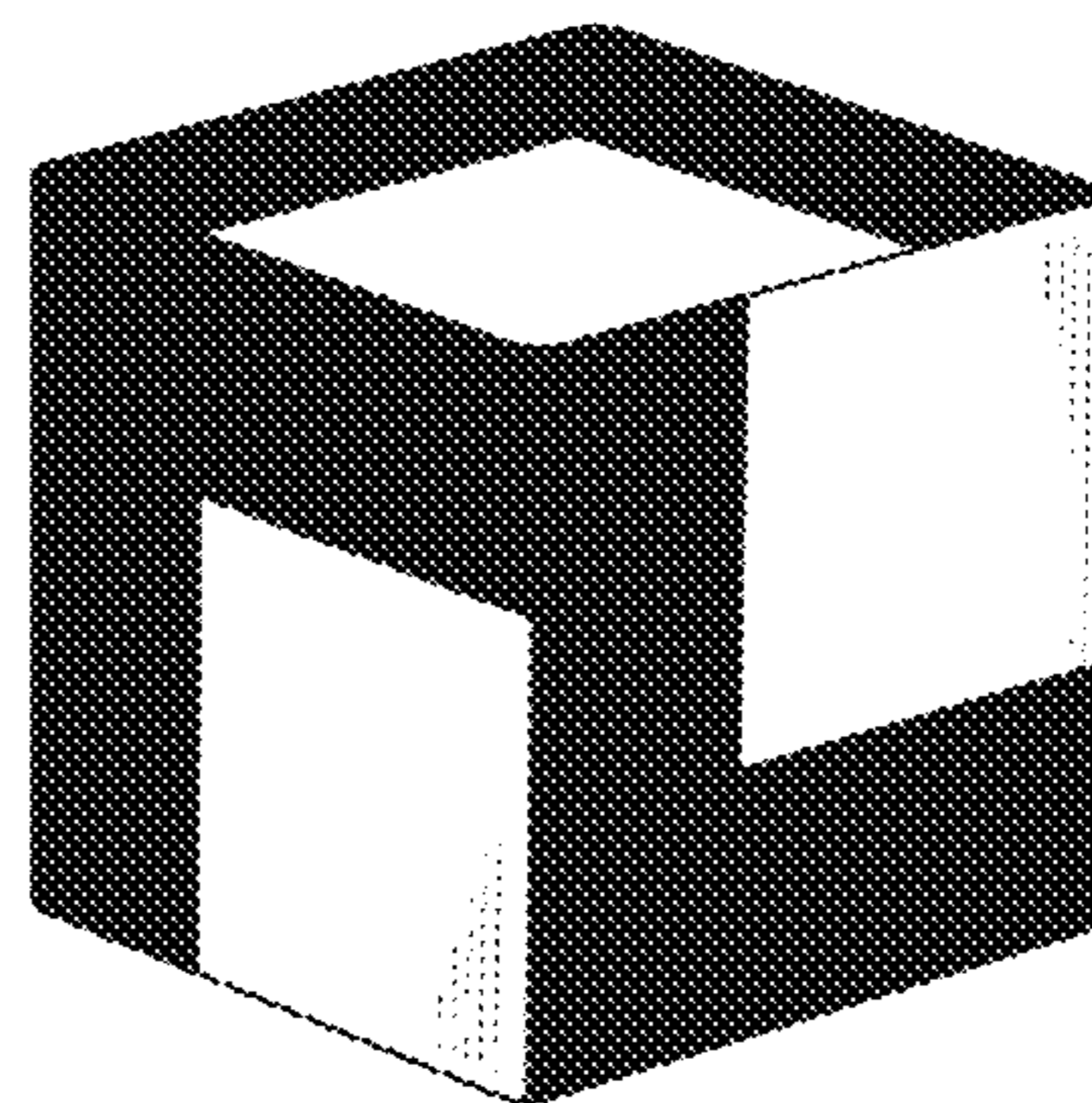

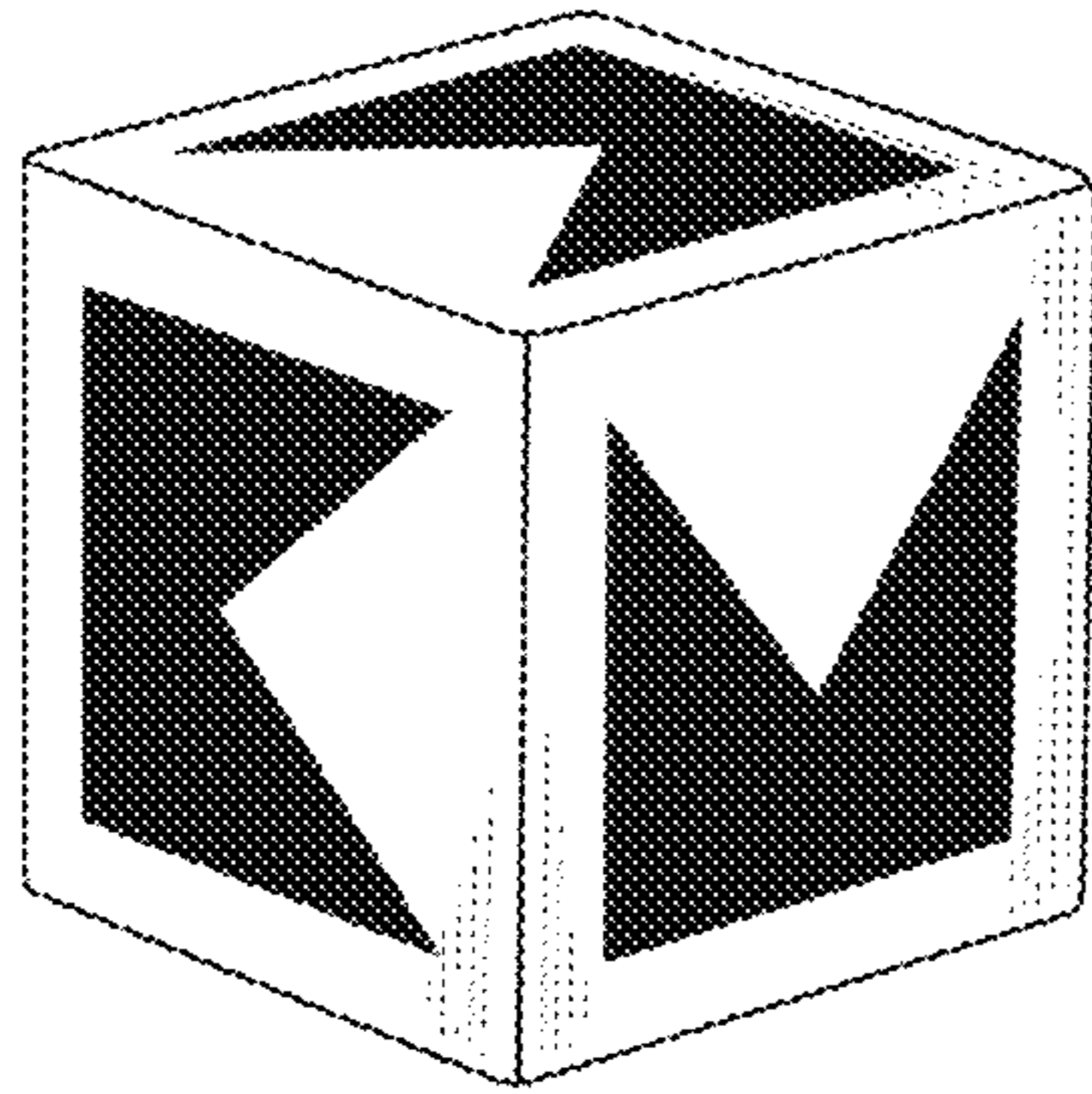

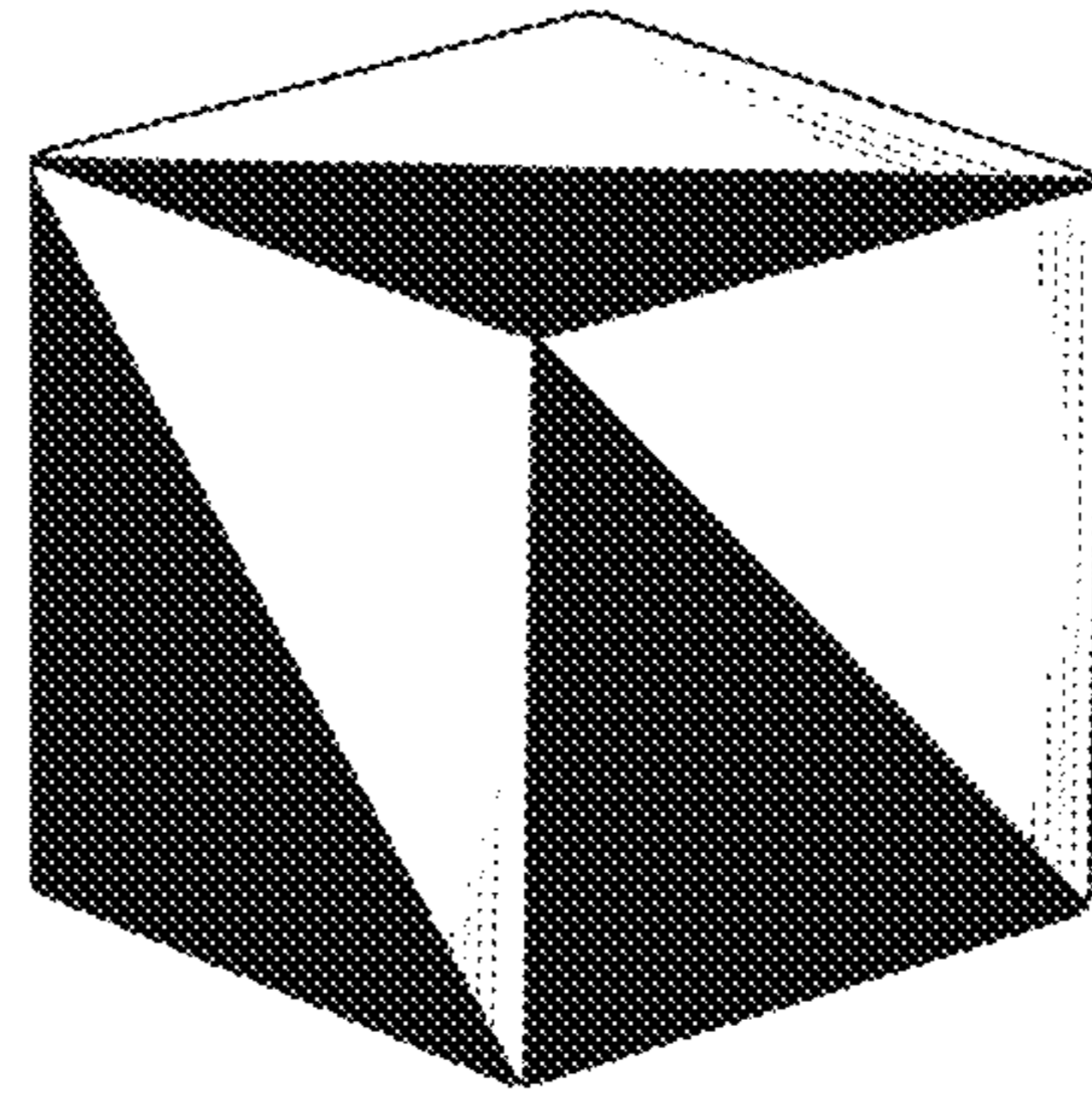

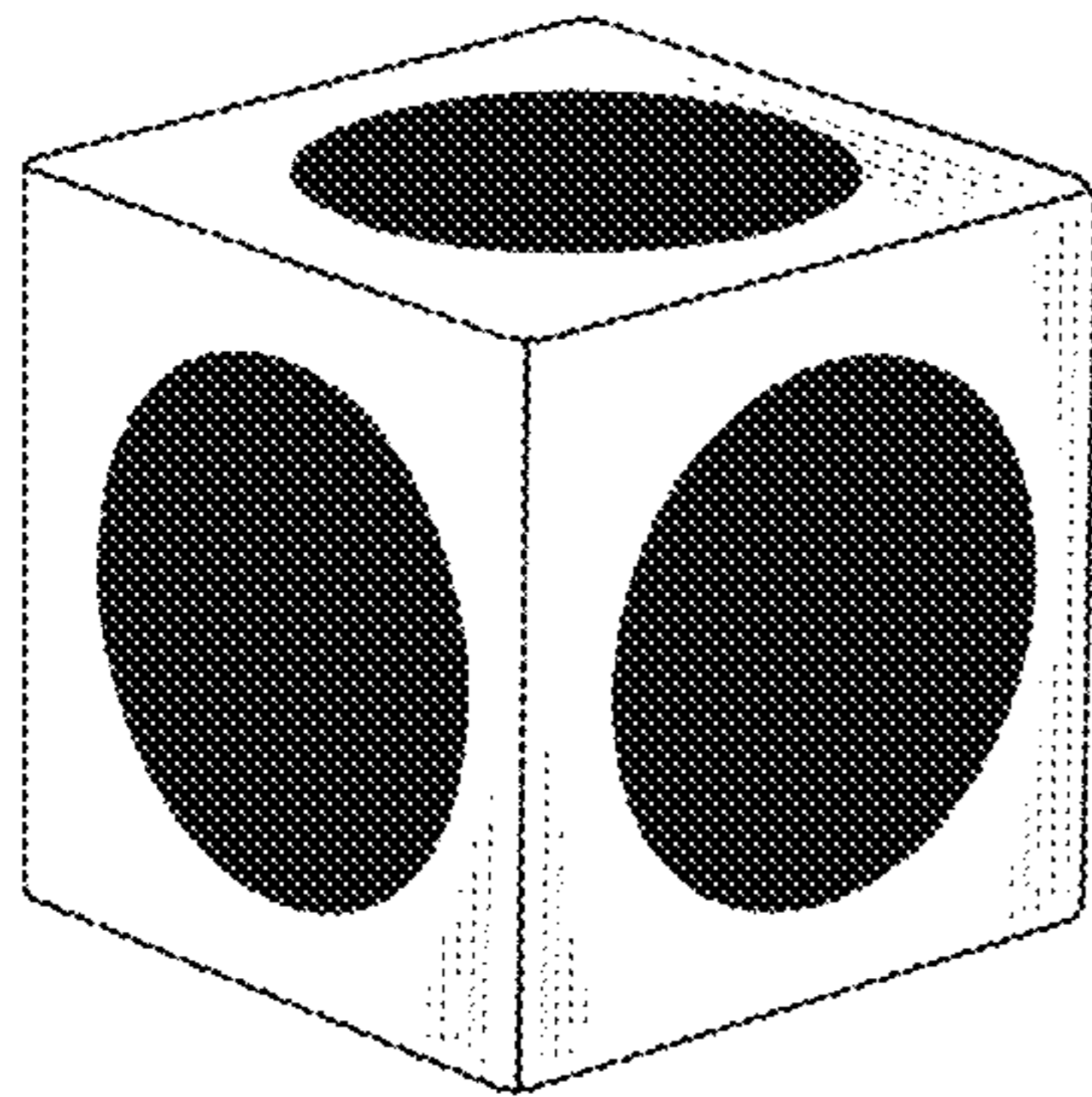

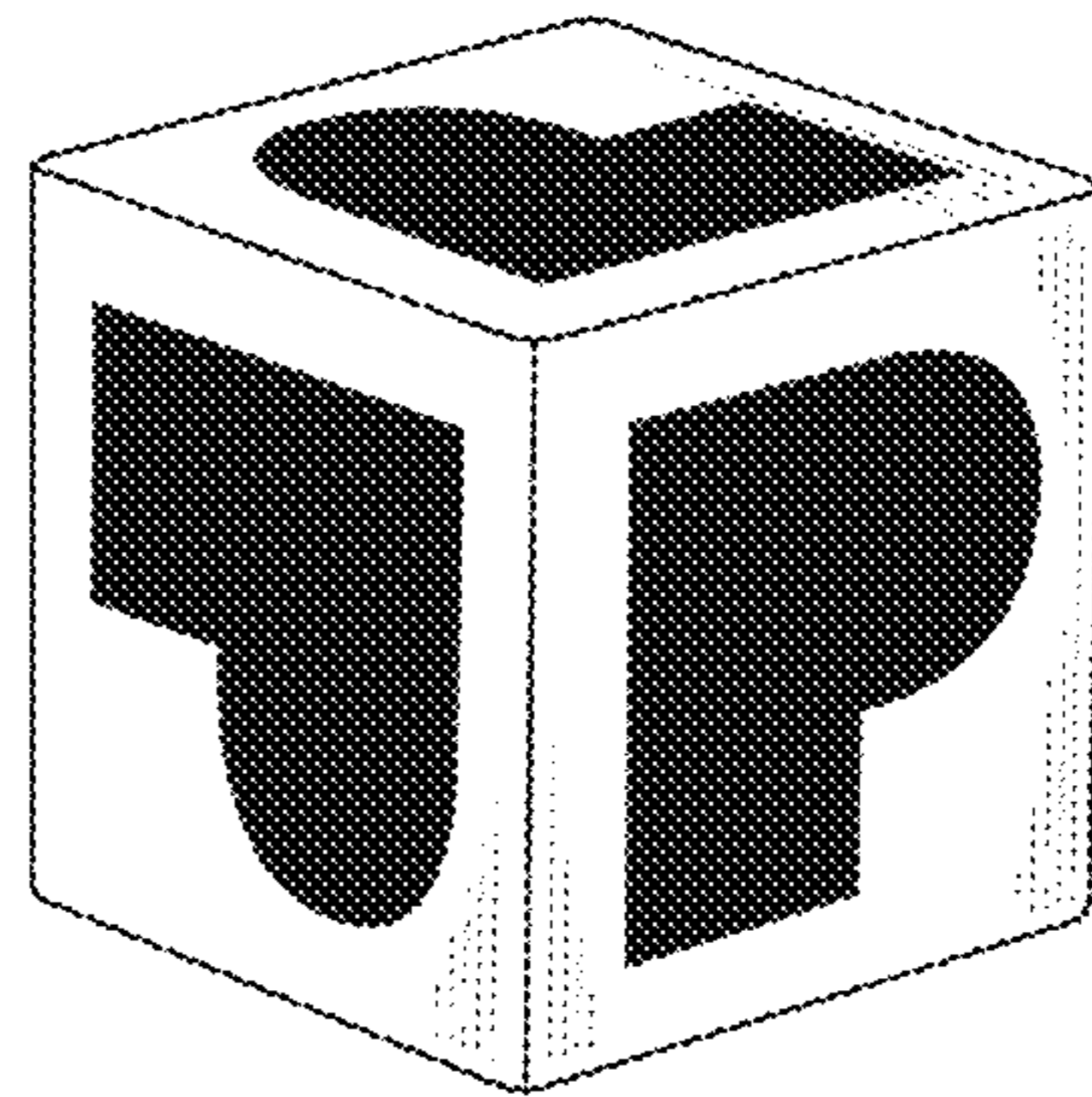

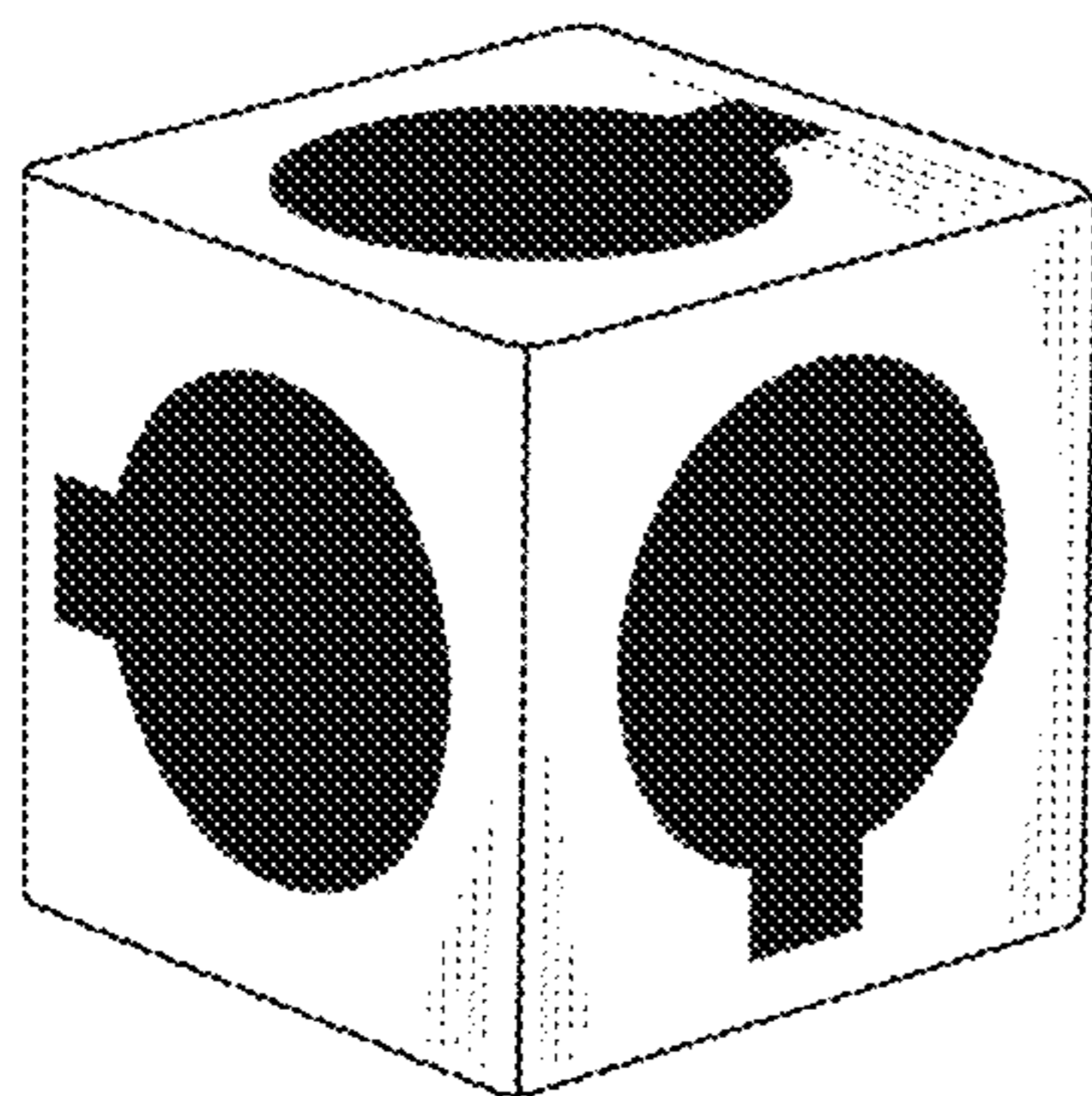

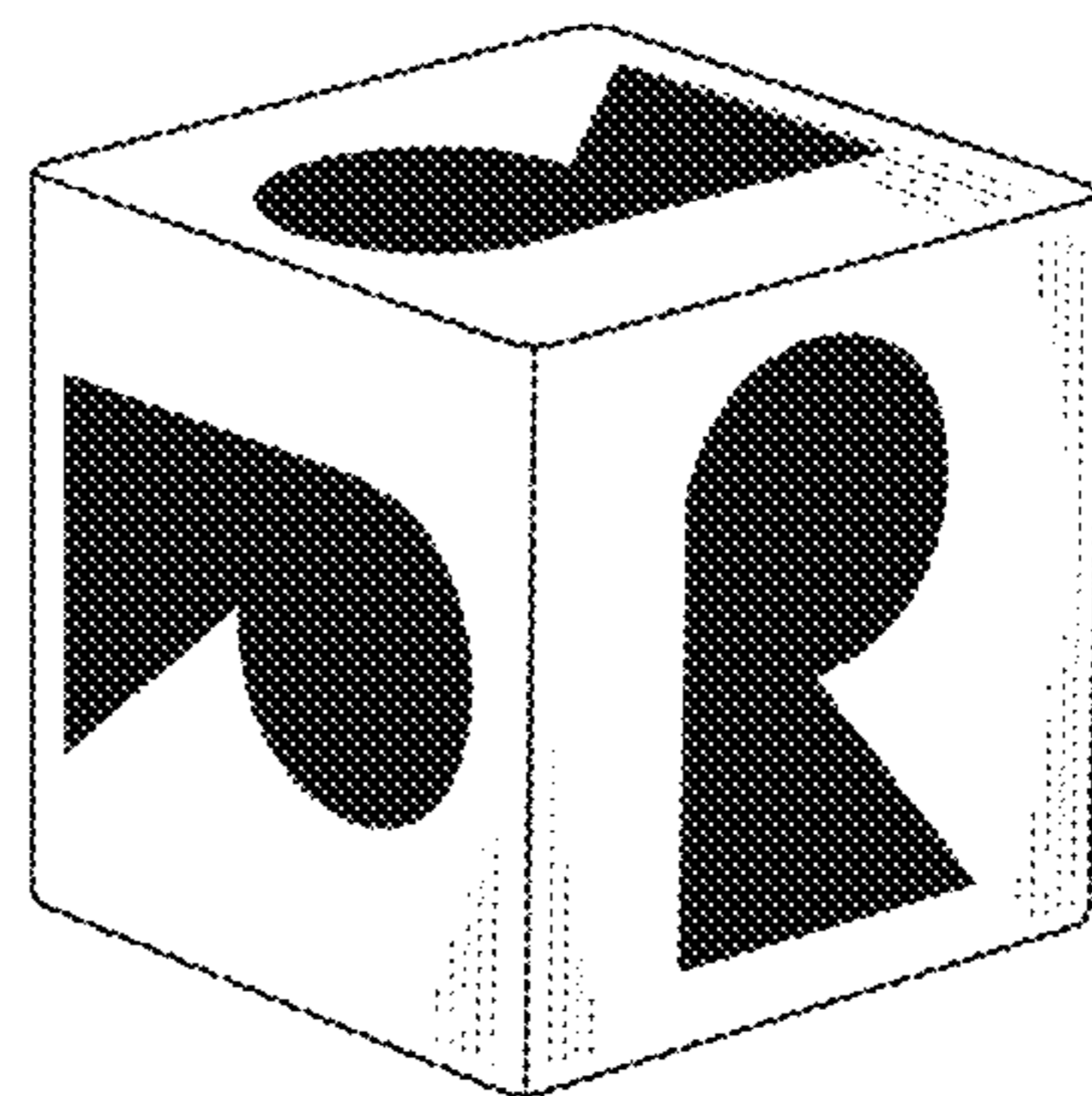

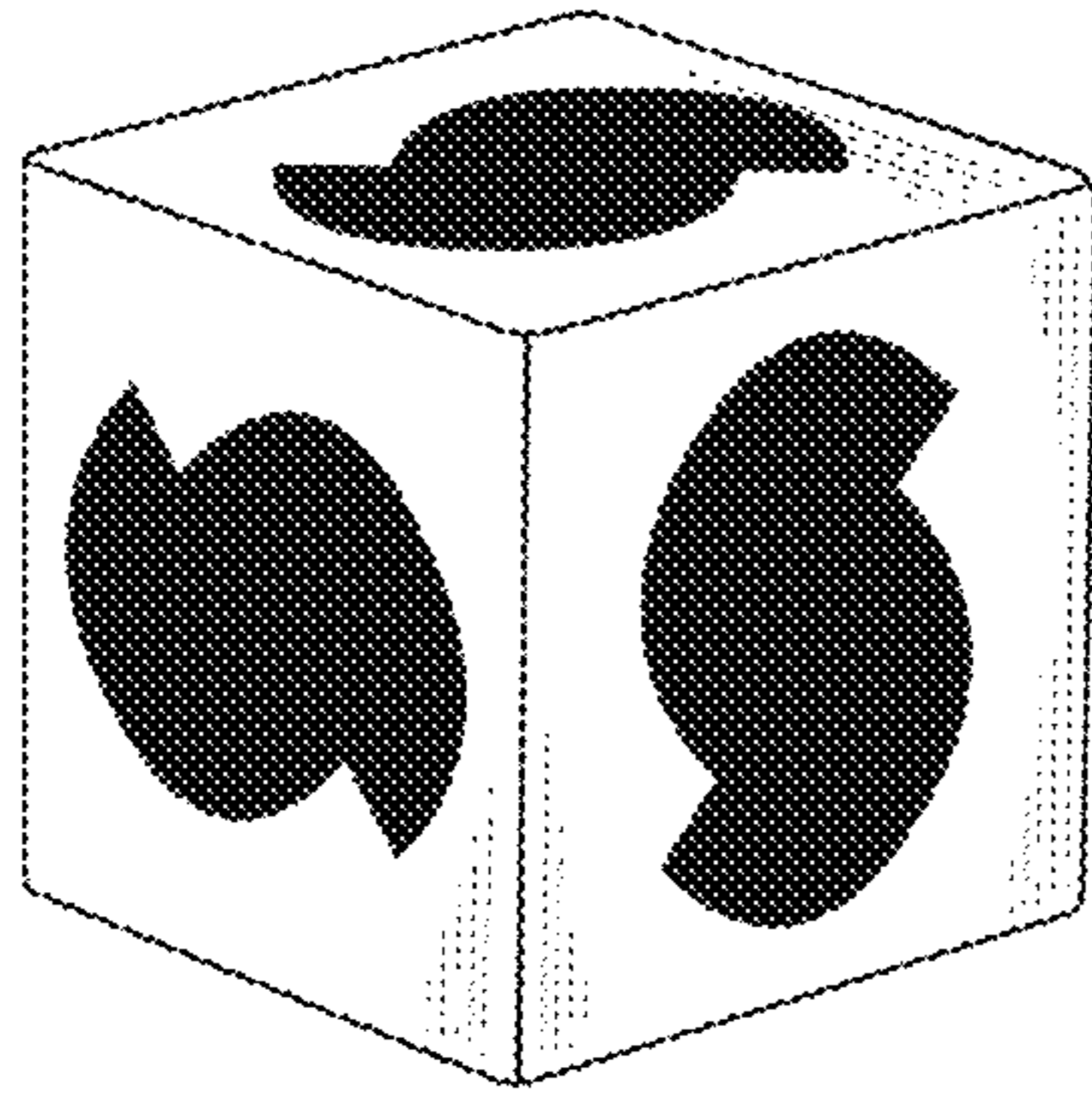

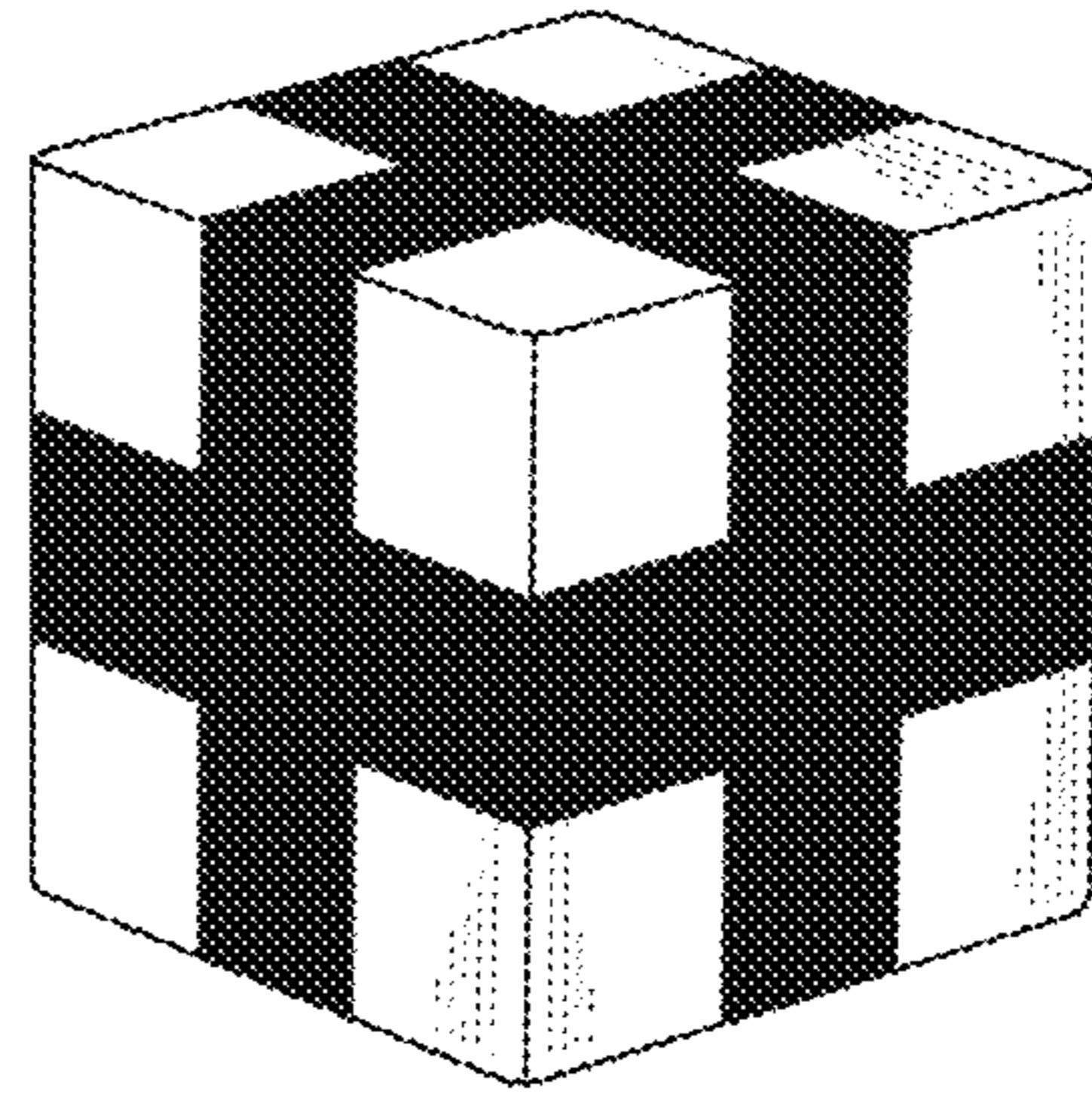

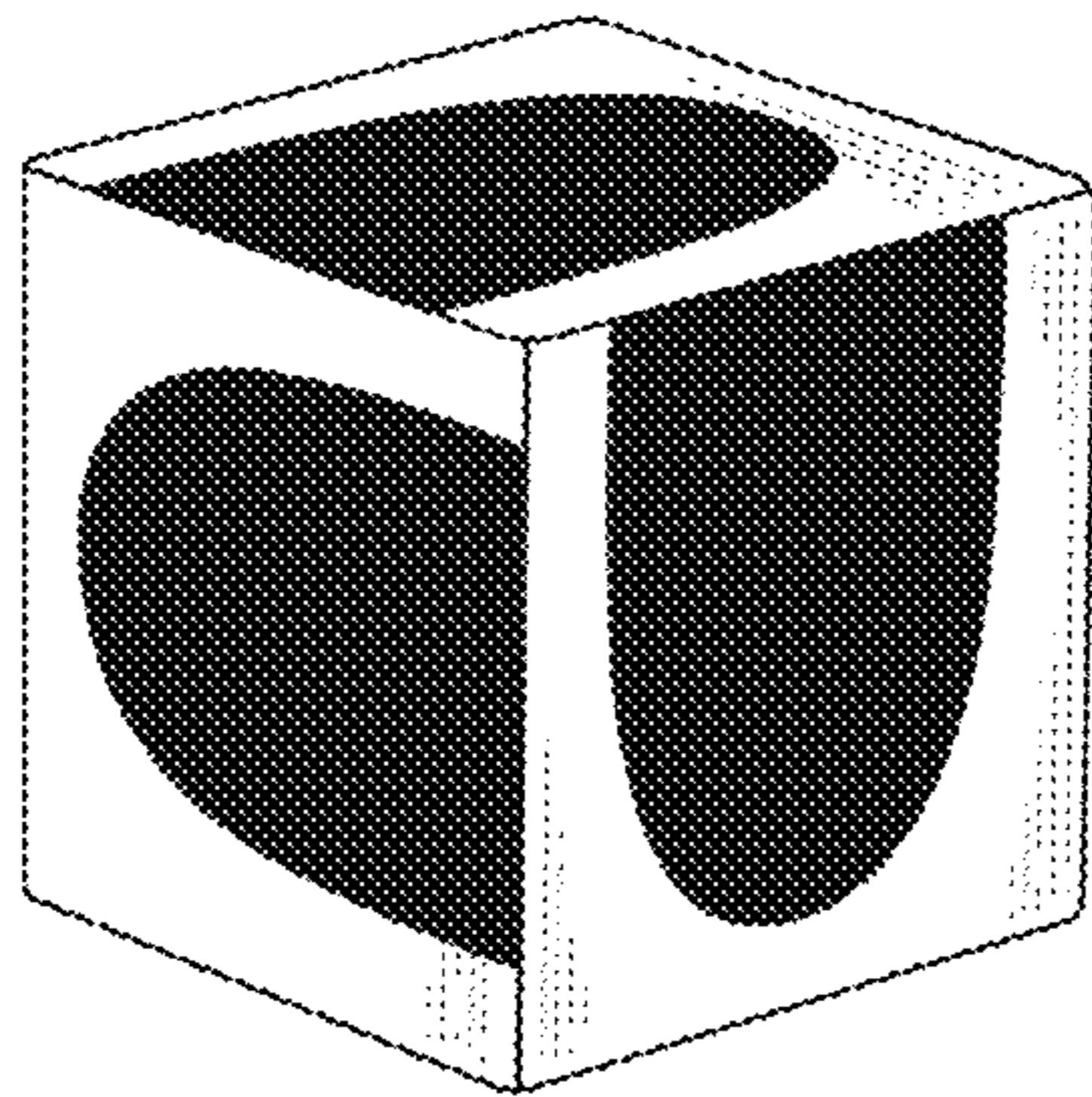

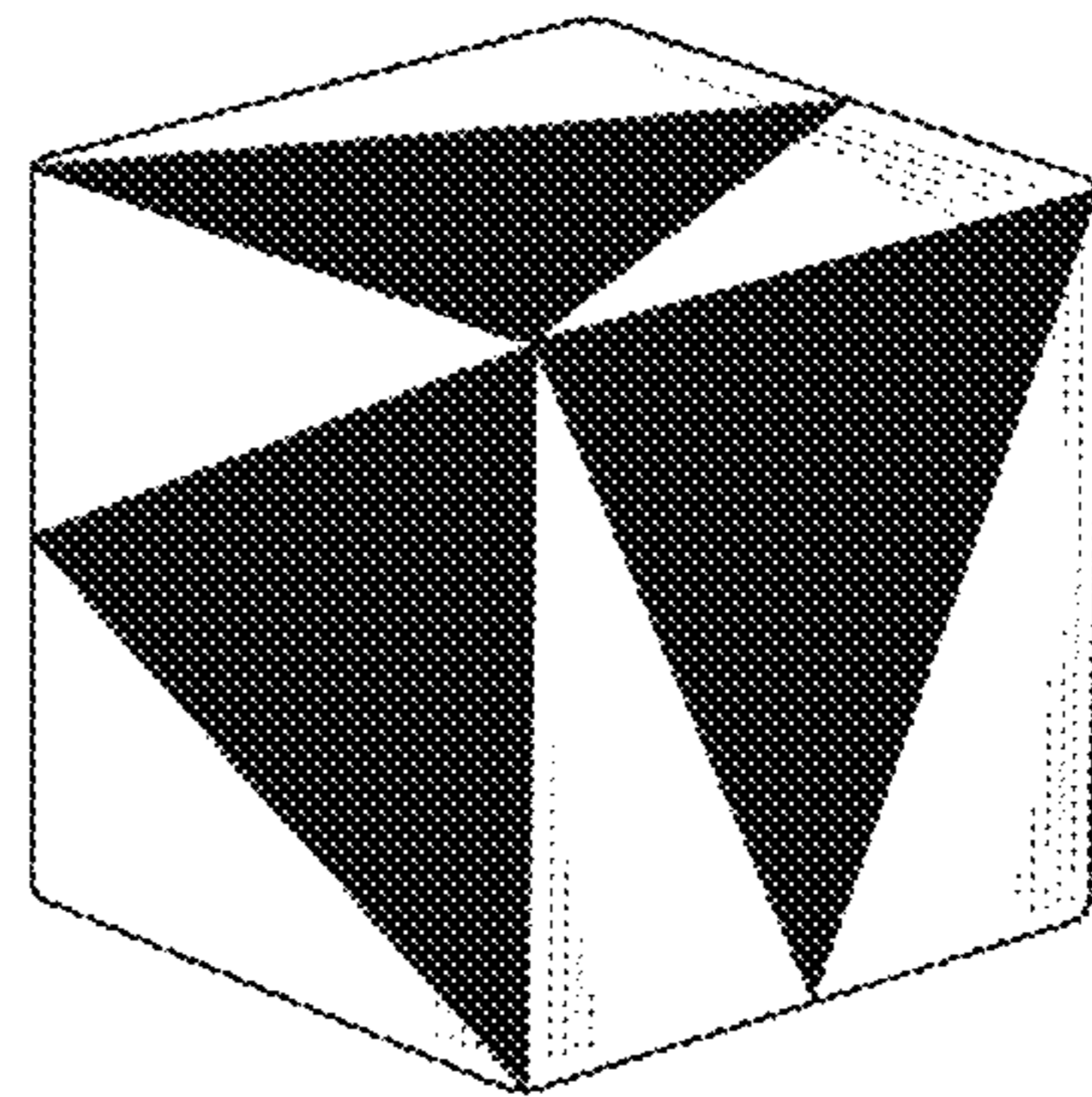

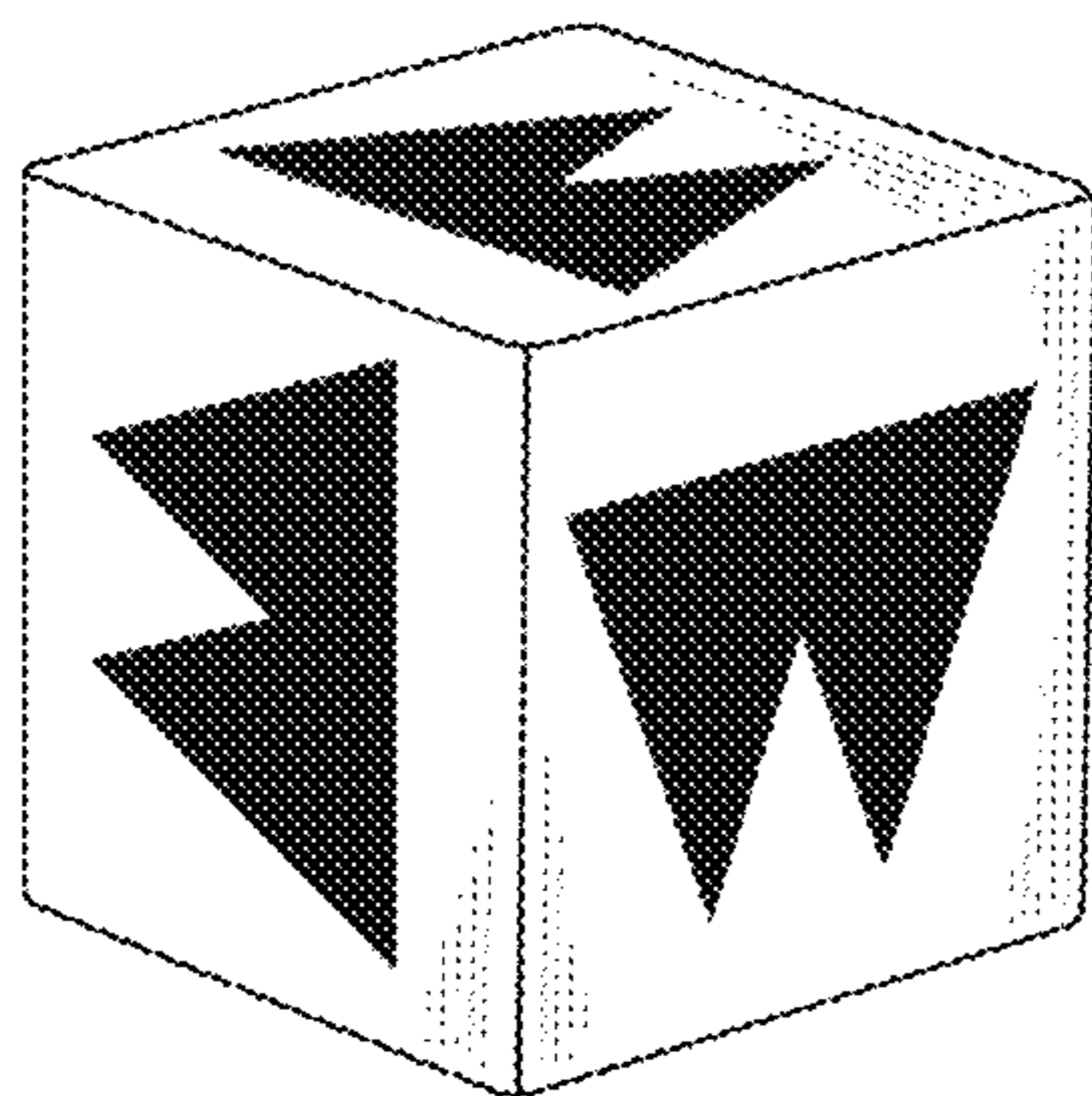

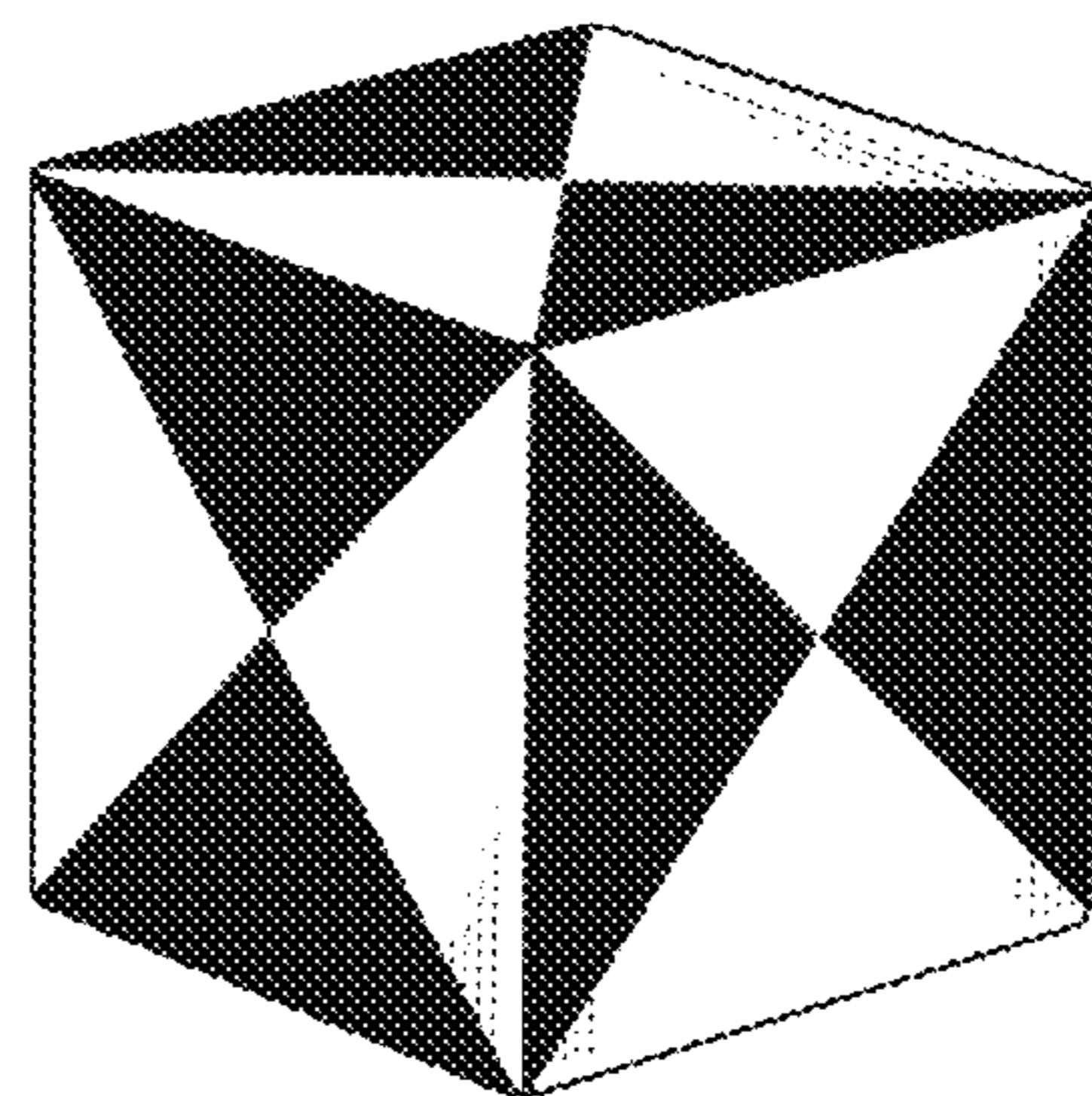

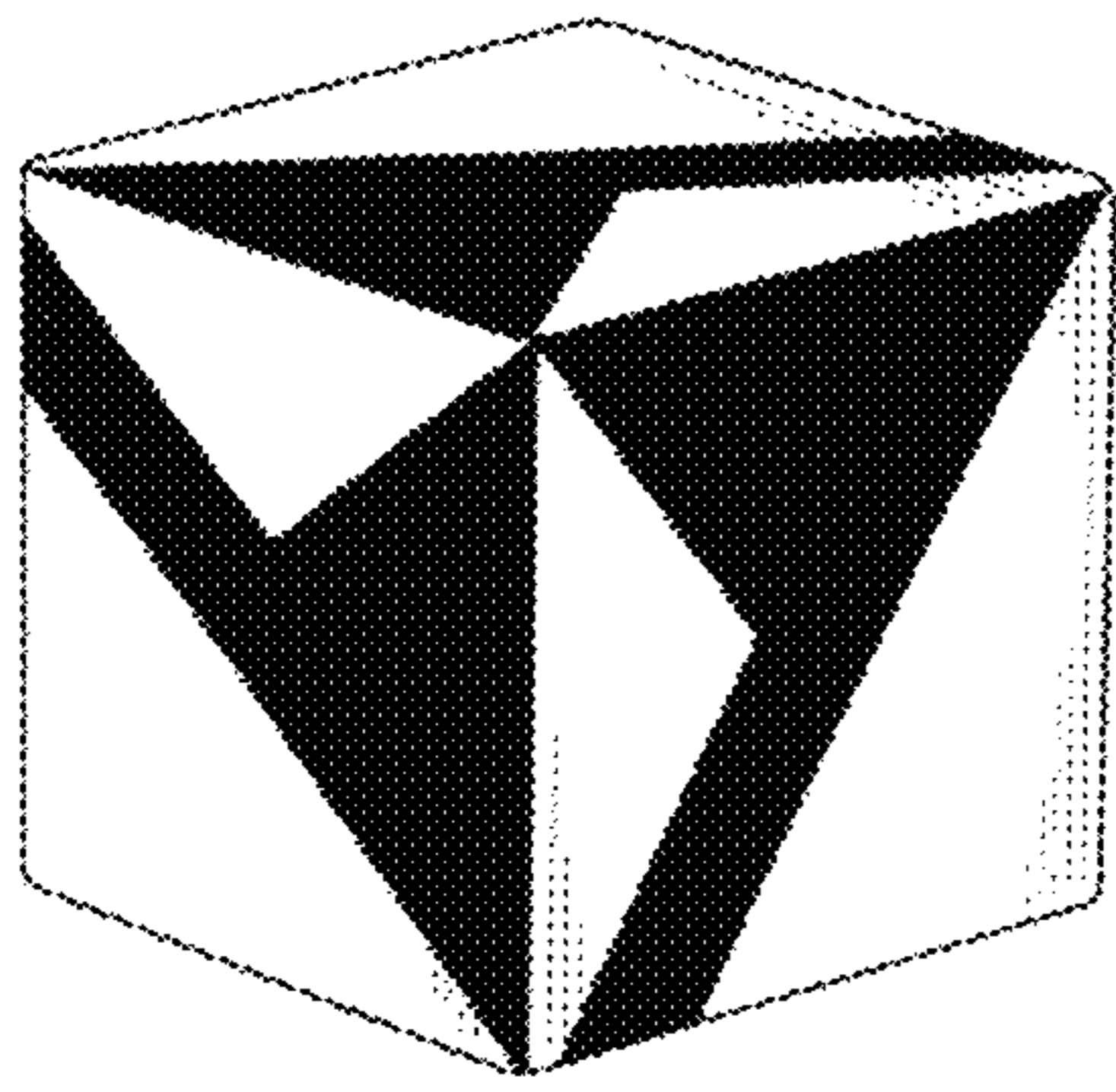

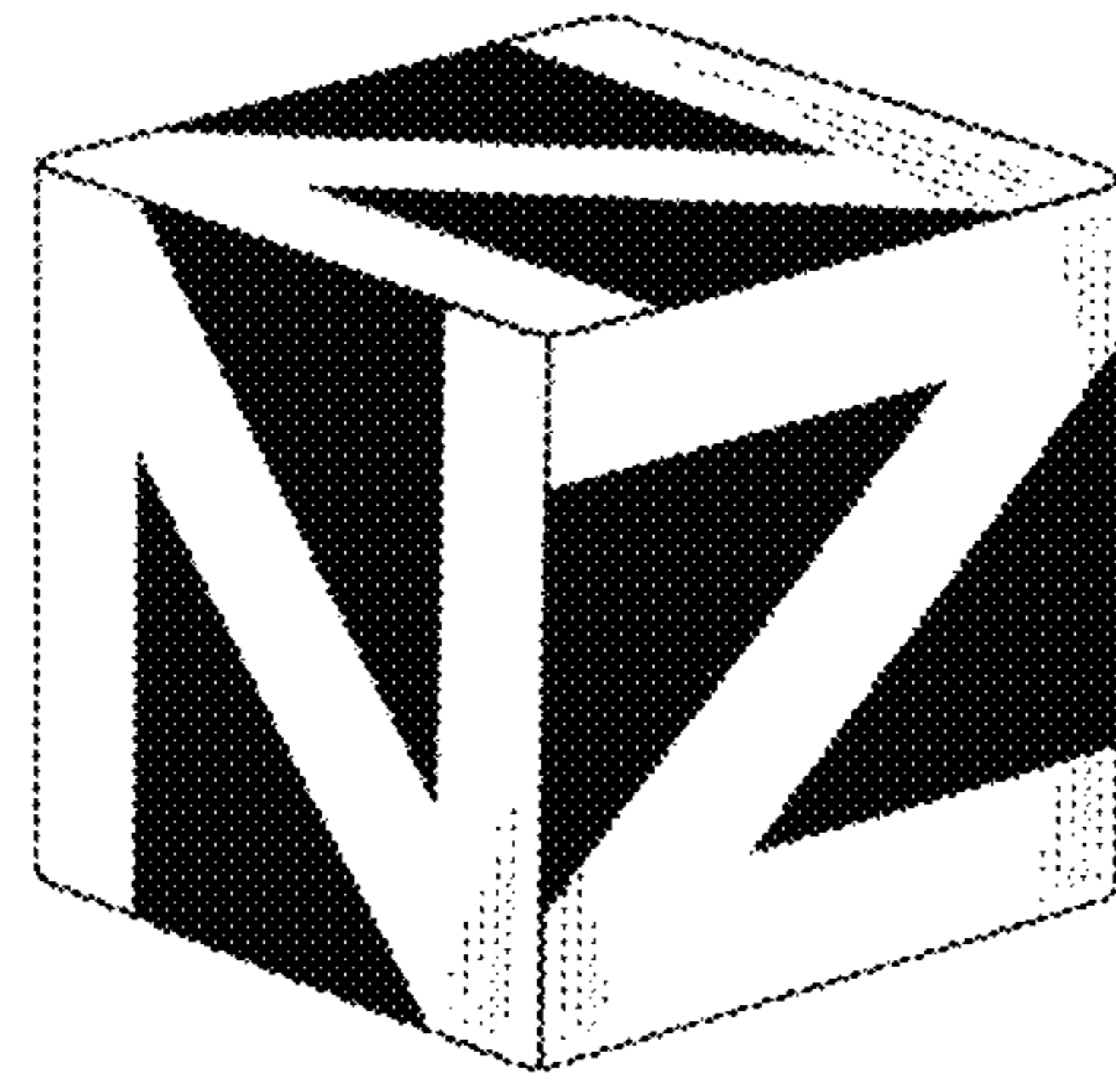
