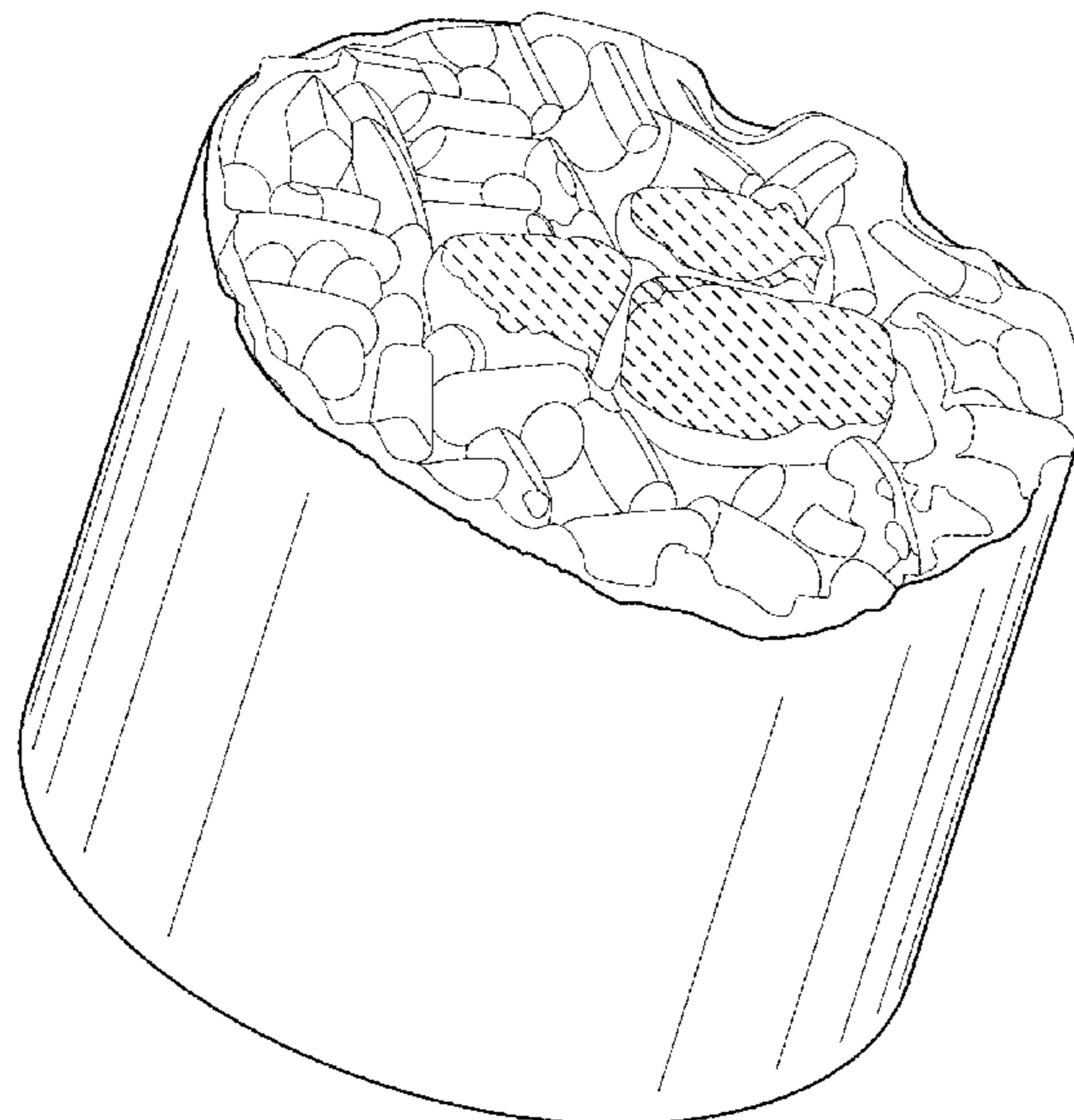
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of the sushi chalk showing the new design;

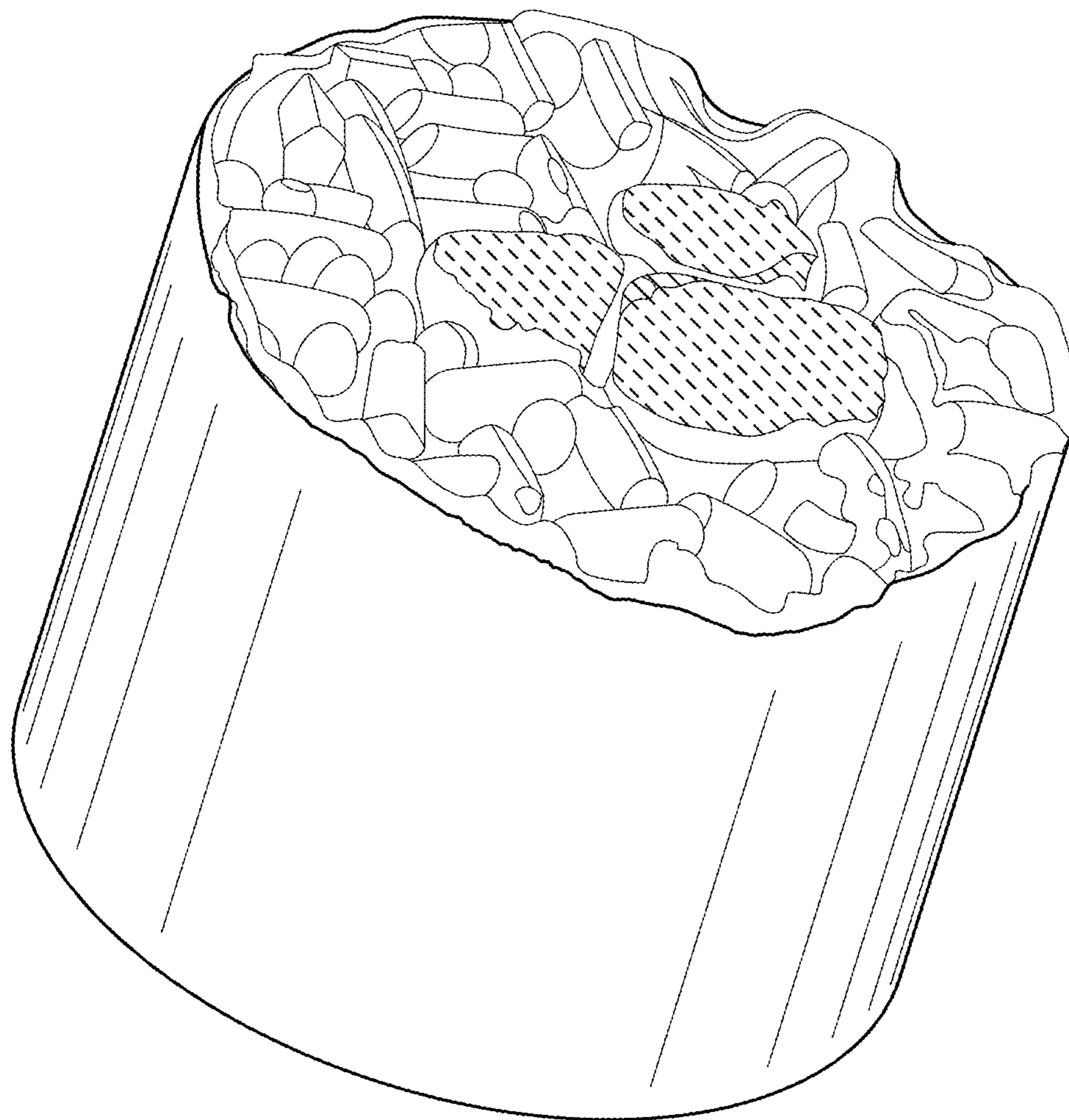

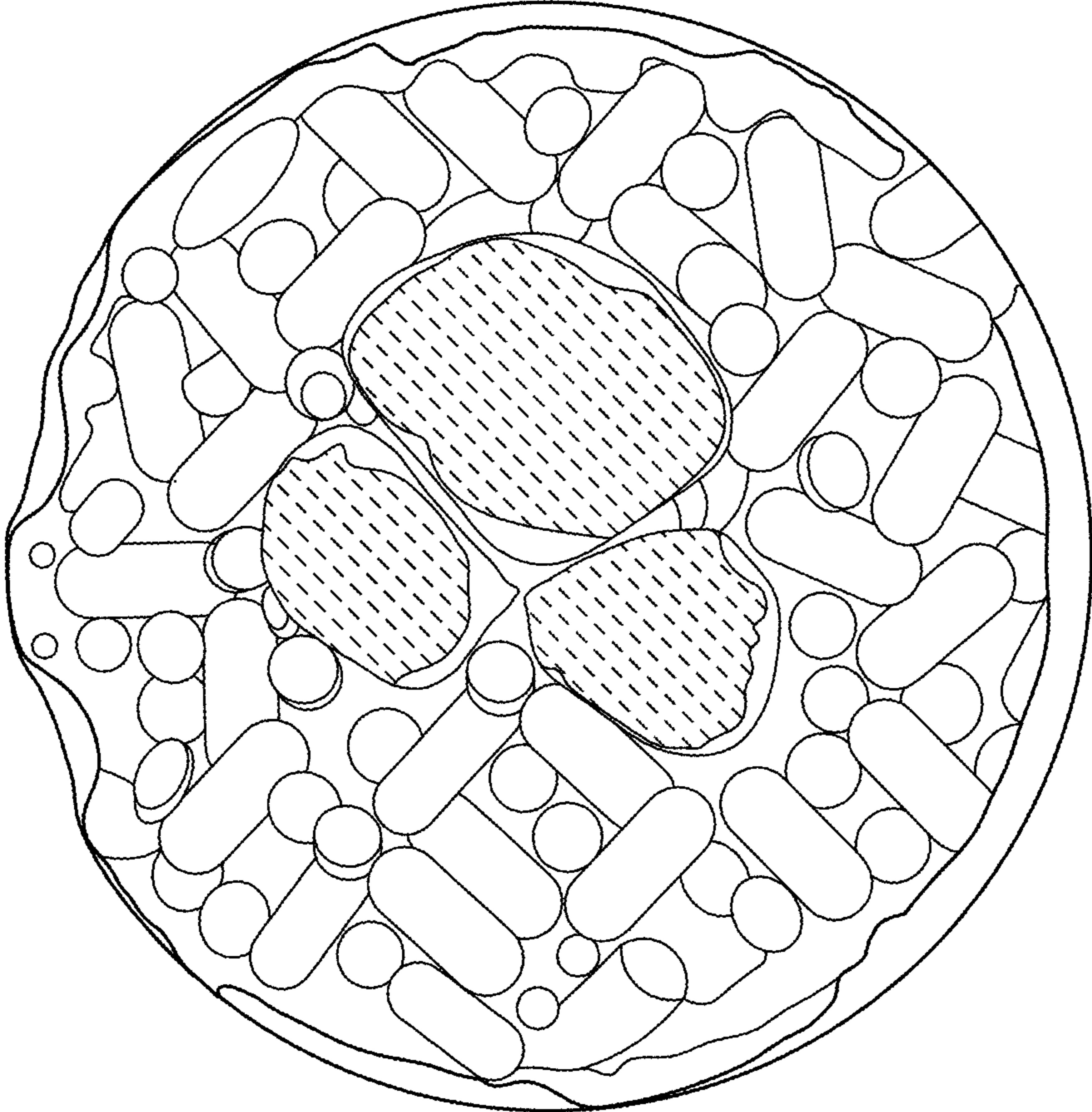

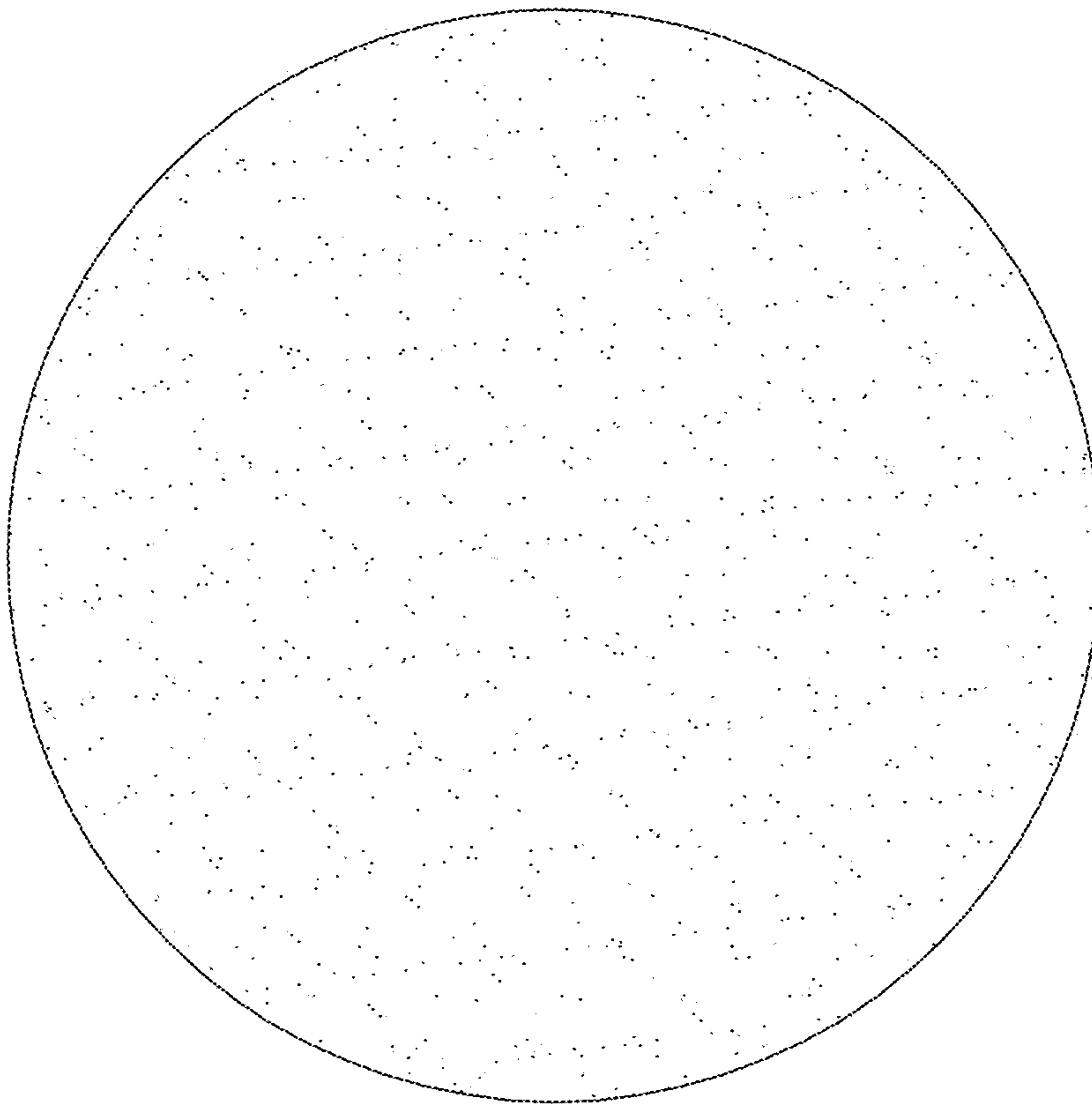

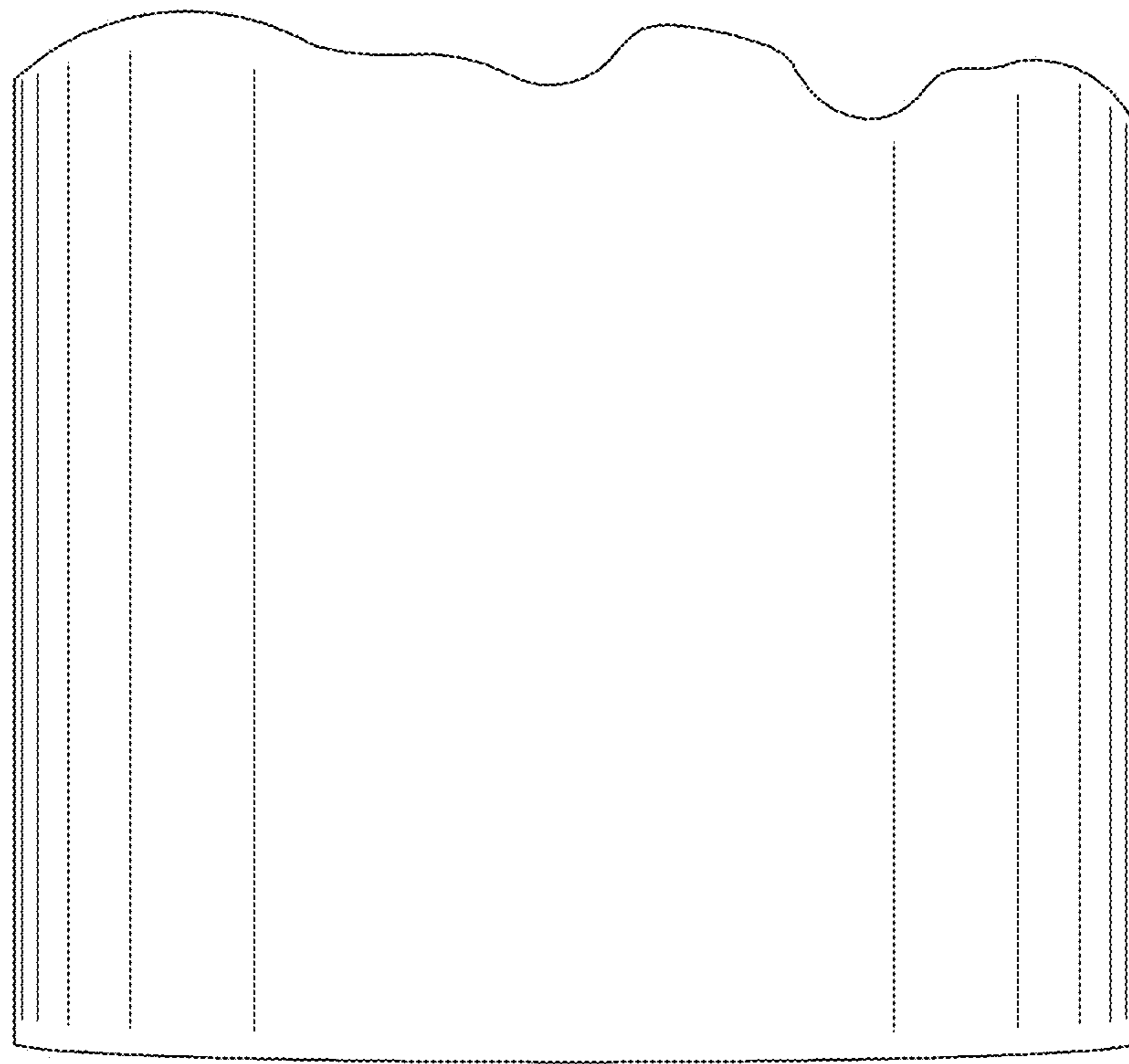

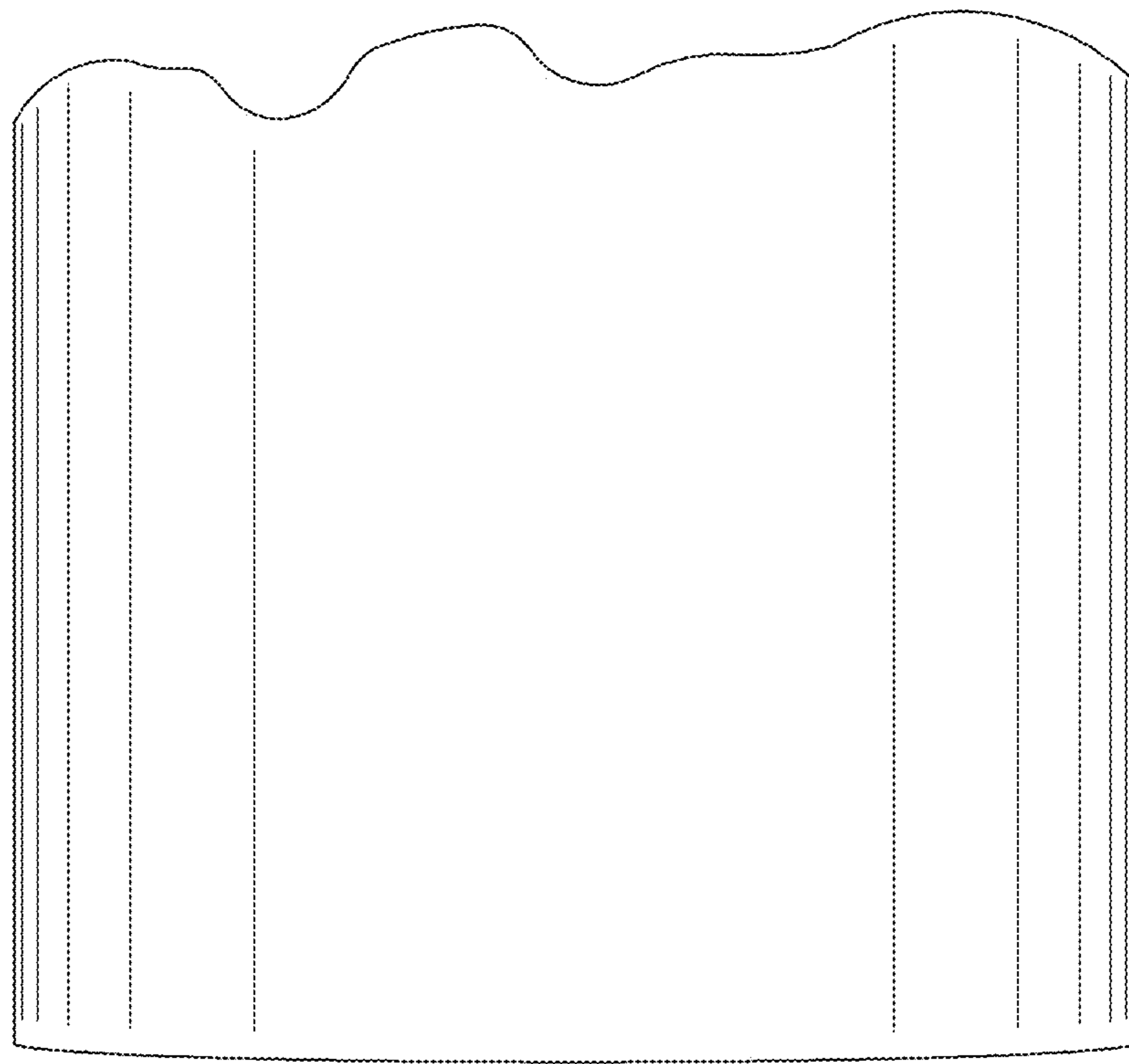

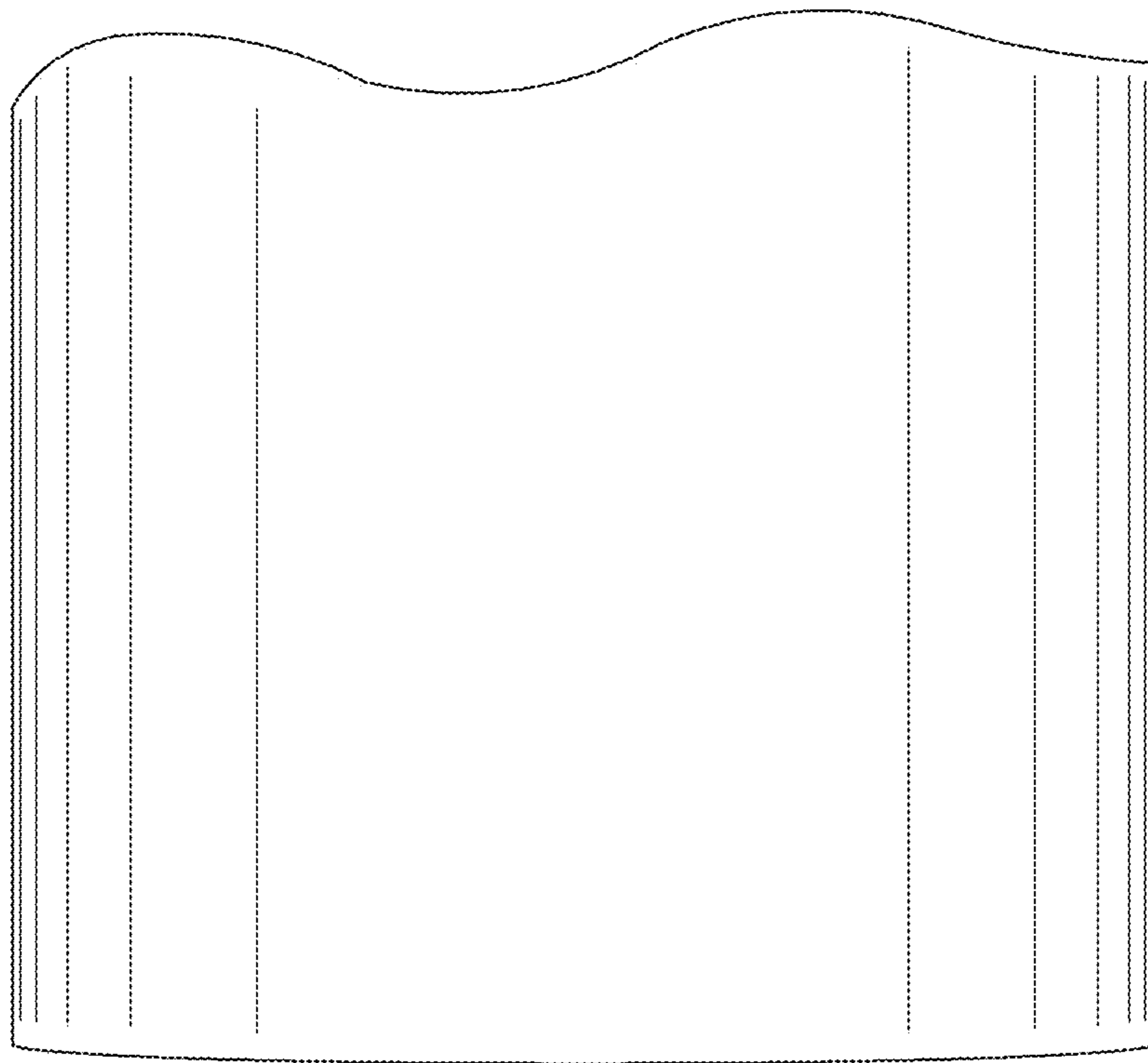

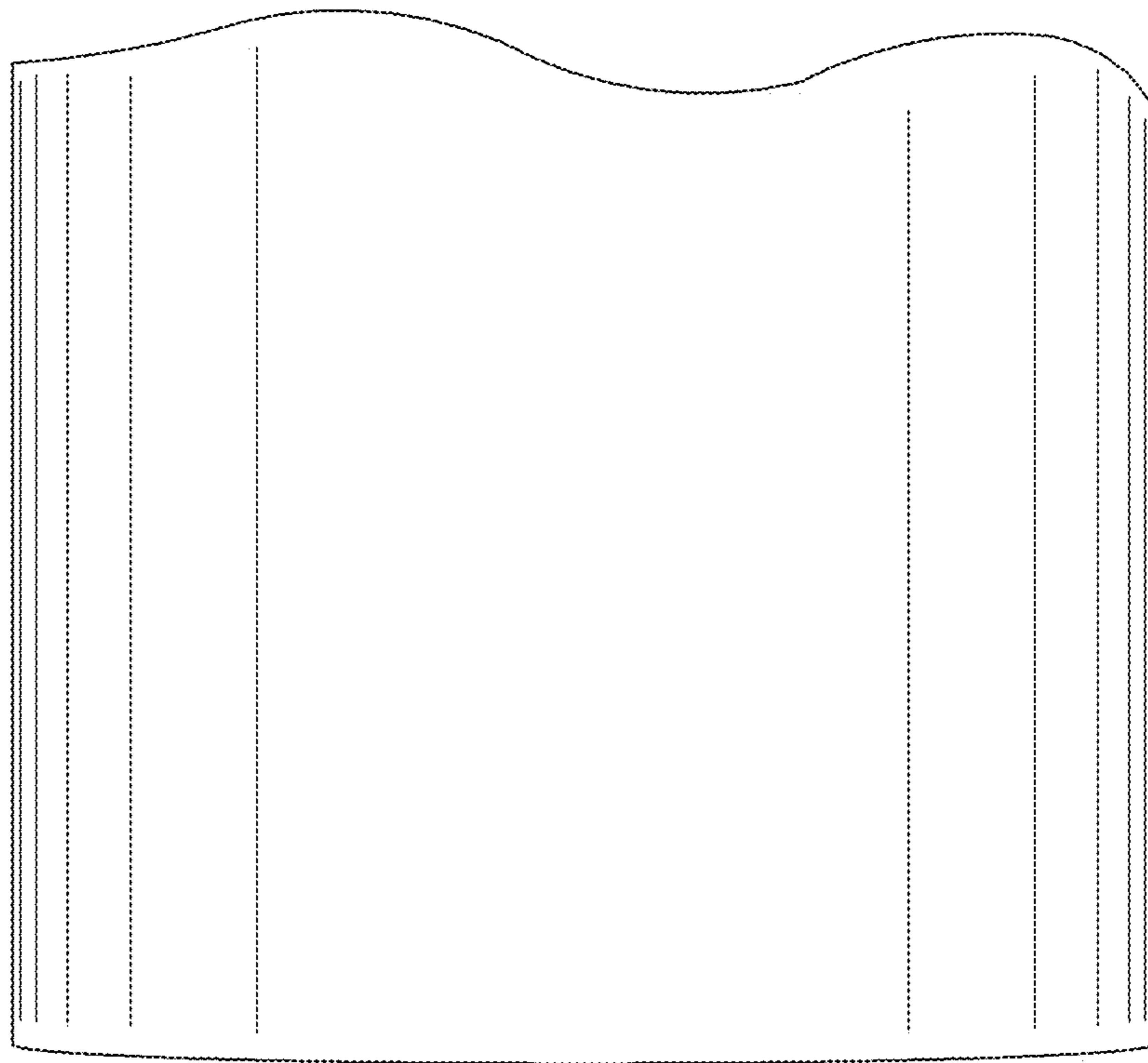
