(57) **CLAIM**

The ornamental design for an acupressure mat, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of an acupressure mat according to the present invention.

FIG. 2 is a top view of the acupressure mat of FIG. 1. A bottom view is not shown as it do not contain any features being claimed.

FIG. 3 is a first side view of the acupressure mat of FIG. 1, with the second side view being identical to the first side view.

FIG. 4 is a front view of the acupressure mat of FIG. 1, with the back view being identical to the front view.

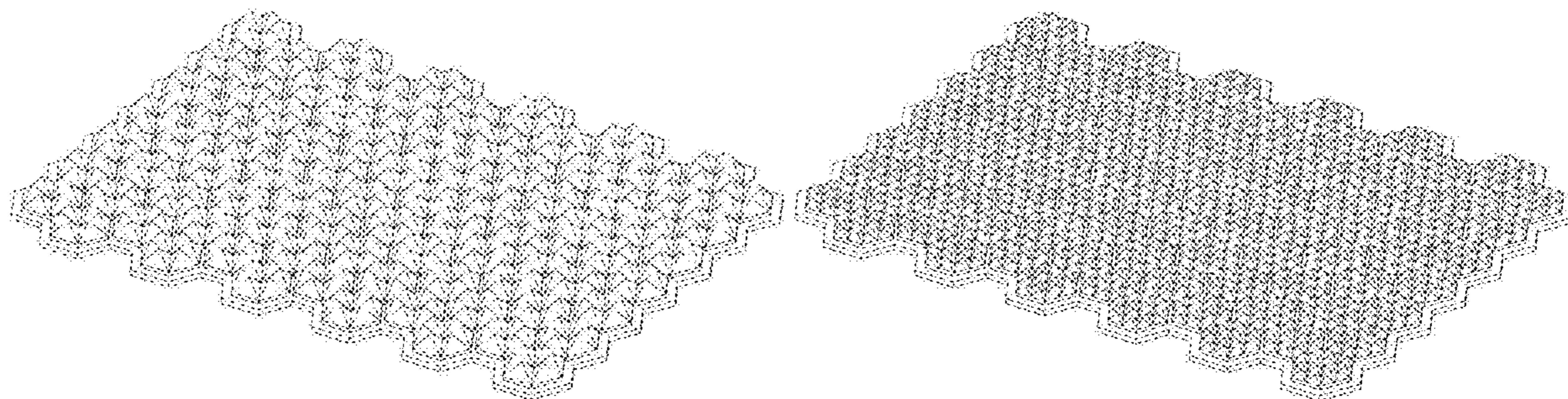
FIG. 5 is a perspective view of a second embodiment of an acupressure mat according to the present invention.

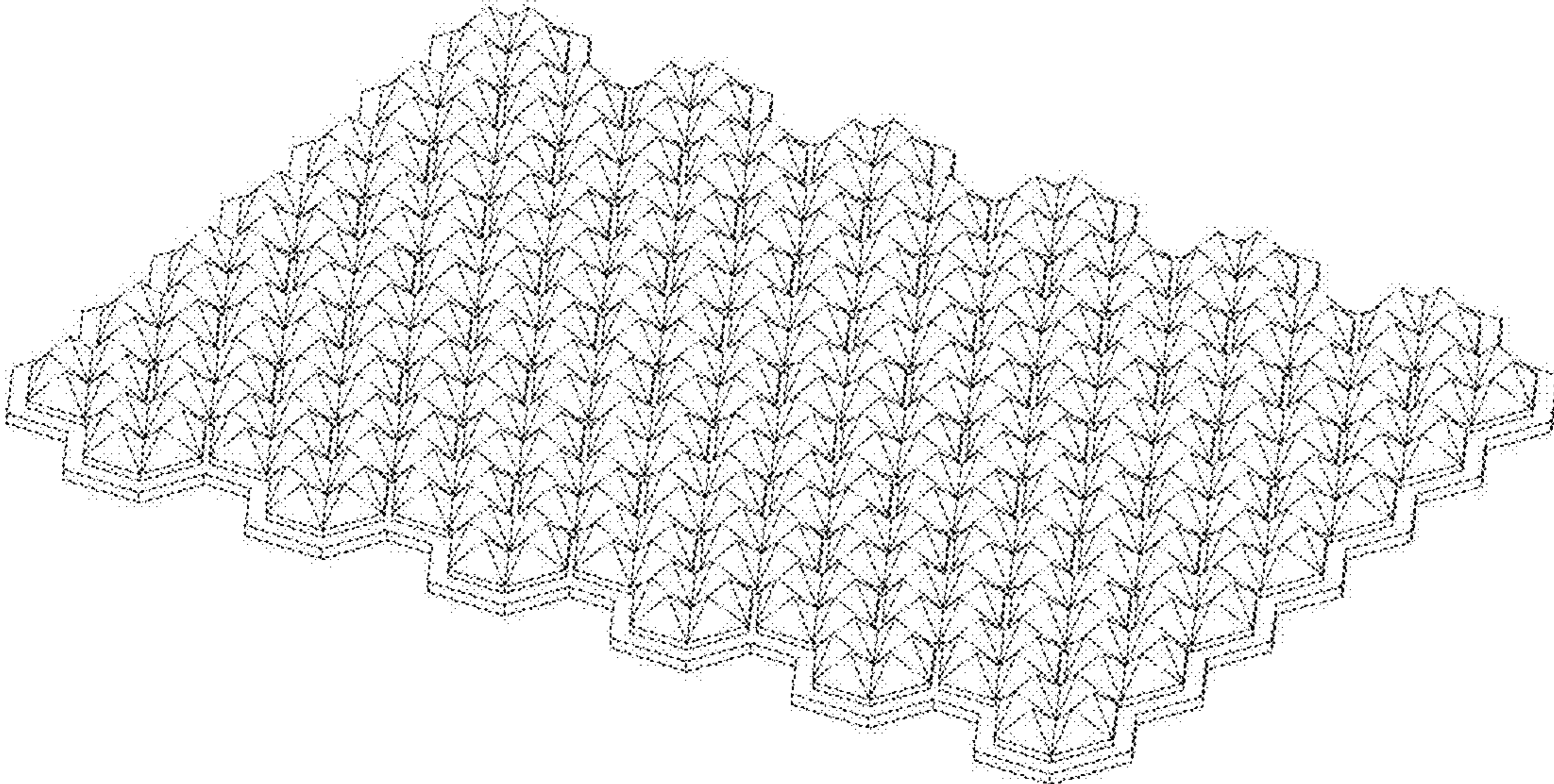

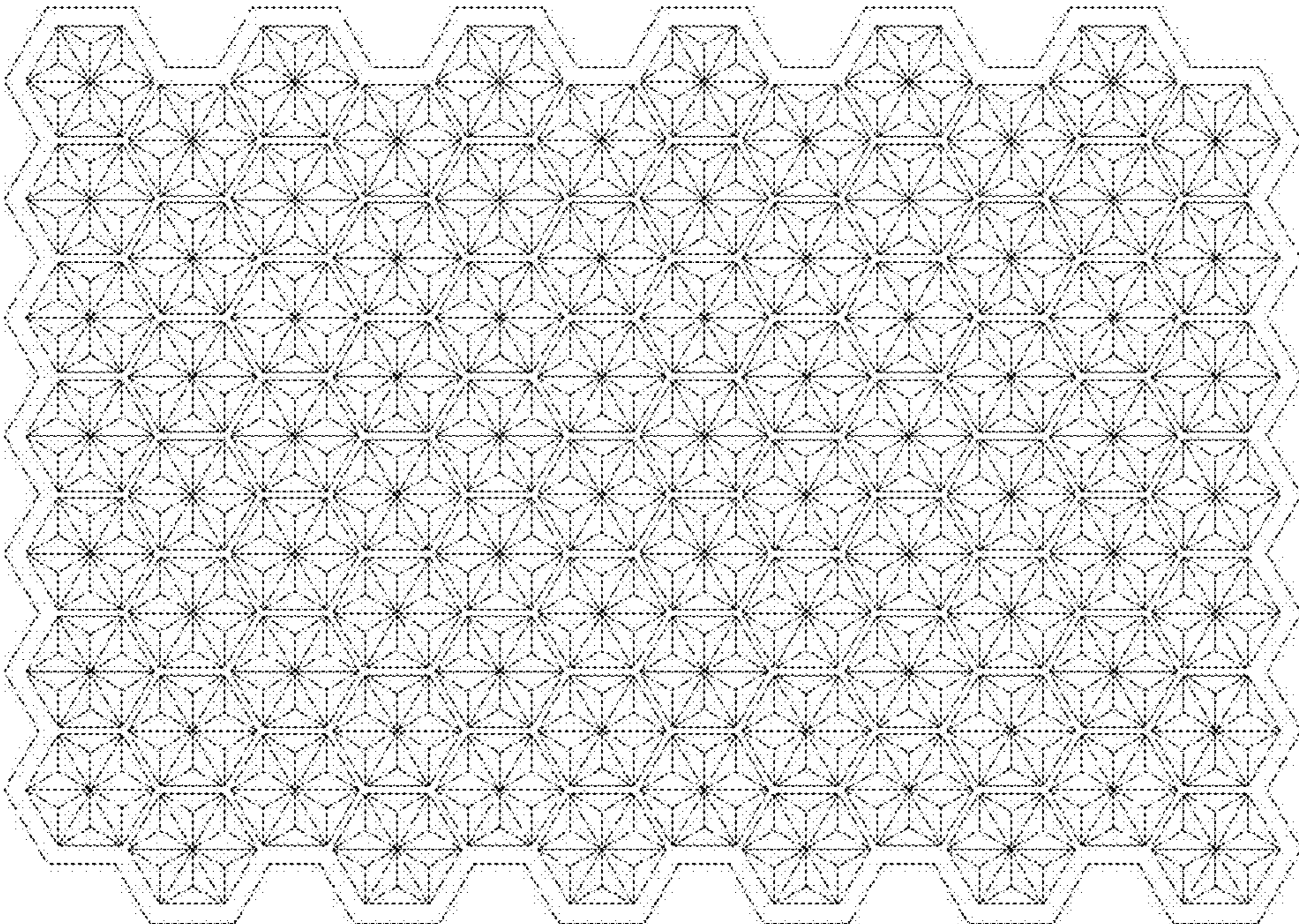

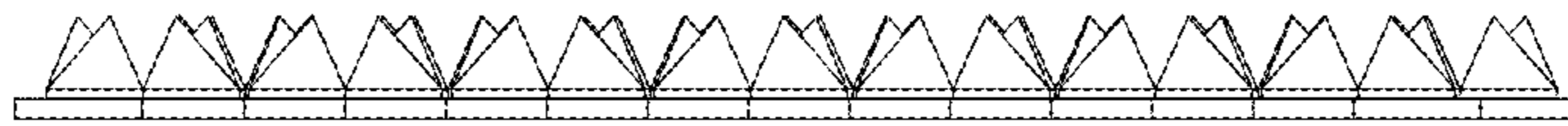

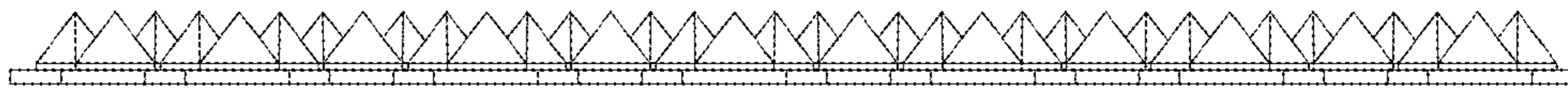

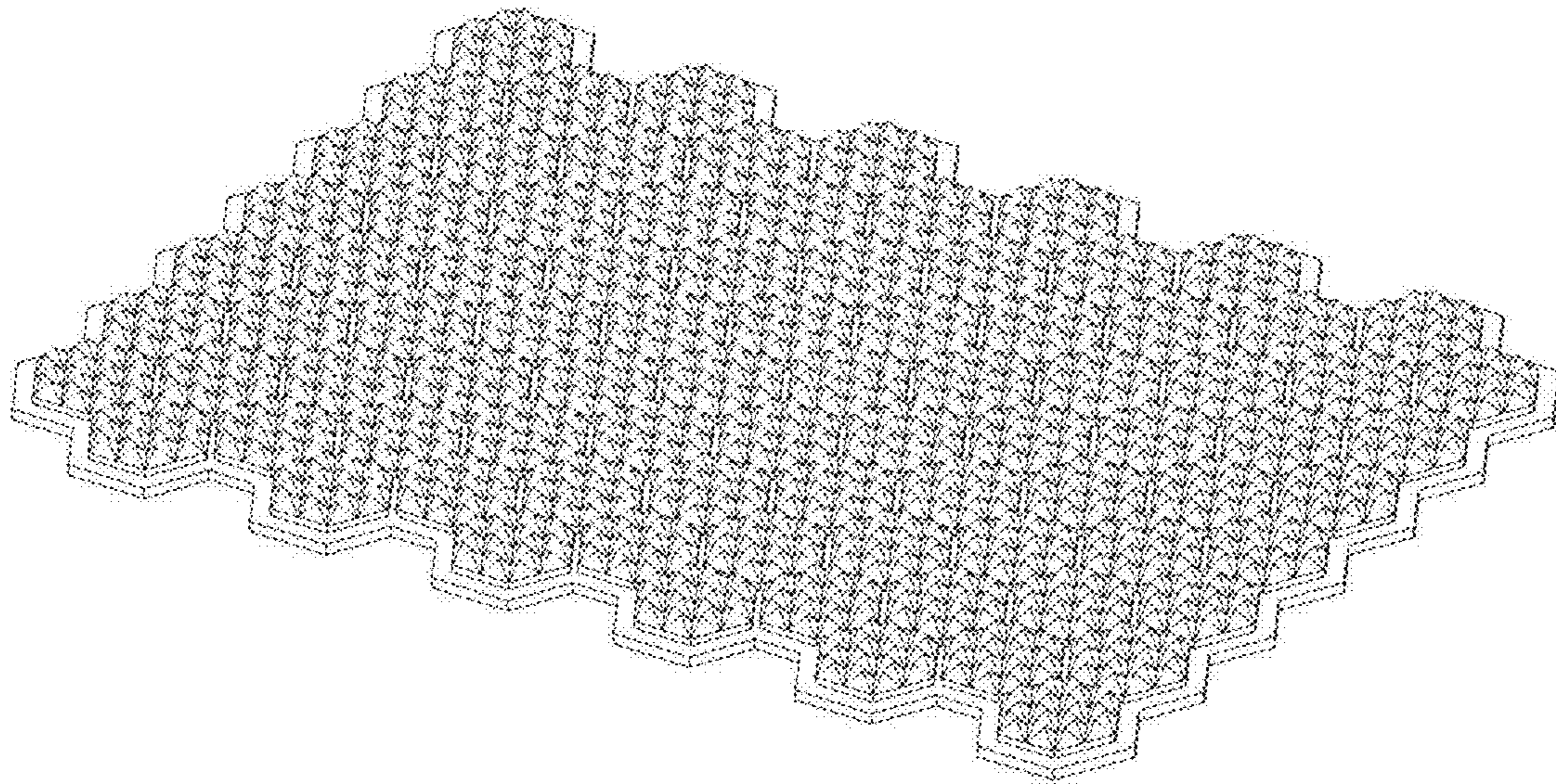

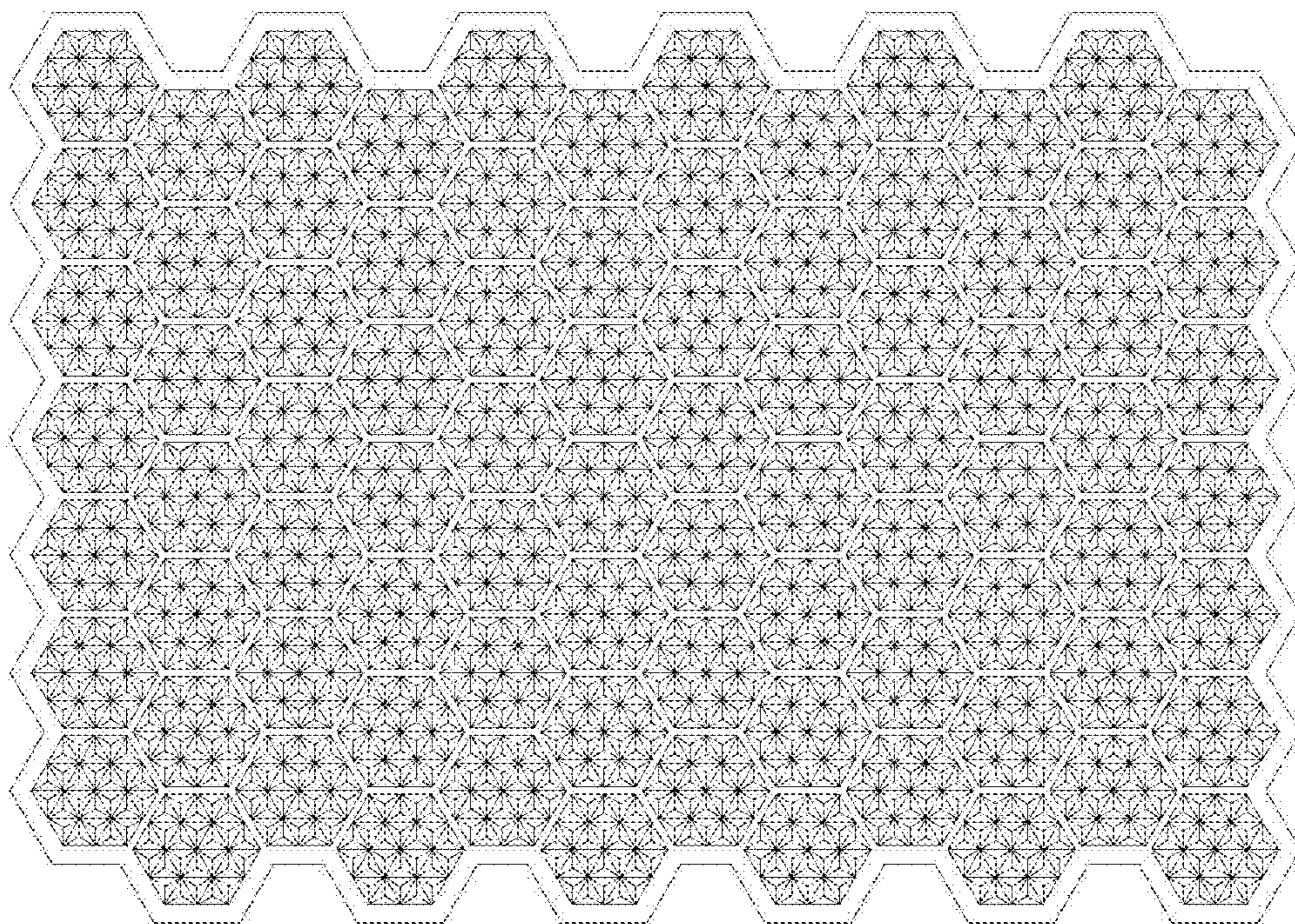

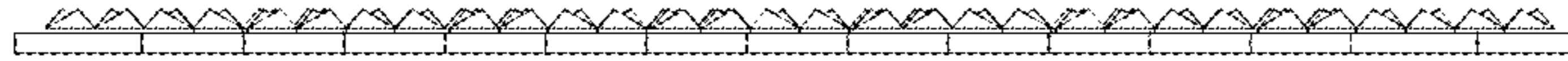
