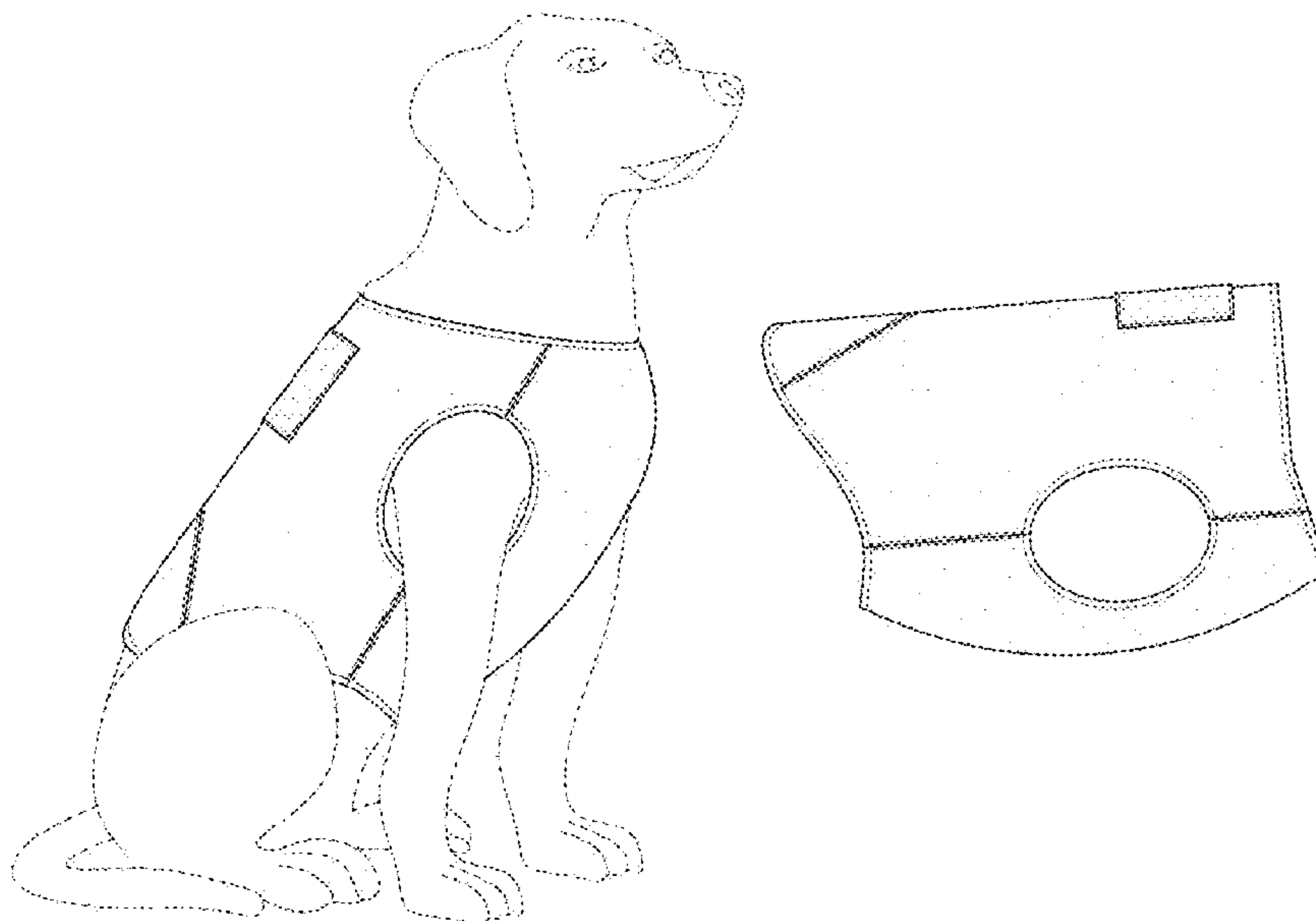
(57) **CLAIM**

I claim the ornamental design for a dog garment, as shown and described.

DESCRIPTION

FIG. 1 is a side perspective view of a dog garment, showing my new design within an environment of use; FIG. 2 is a front perspective view thereof; FIG. 3 is a side elevation of the dog garment; FIG. 4 is a top plan view thereof; FIG. 5 is a bottom plan view thereof; FIG. 6 is a front elevation view thereof; and, FIG. 7 is a rear elevation view thereof. In FIGS. 1 and 2, the broken lines depicting a dog are showing environmental subject matter that forms no part of the claimed design. All other broken lines represent portions of the article that form no part of the claimed design.

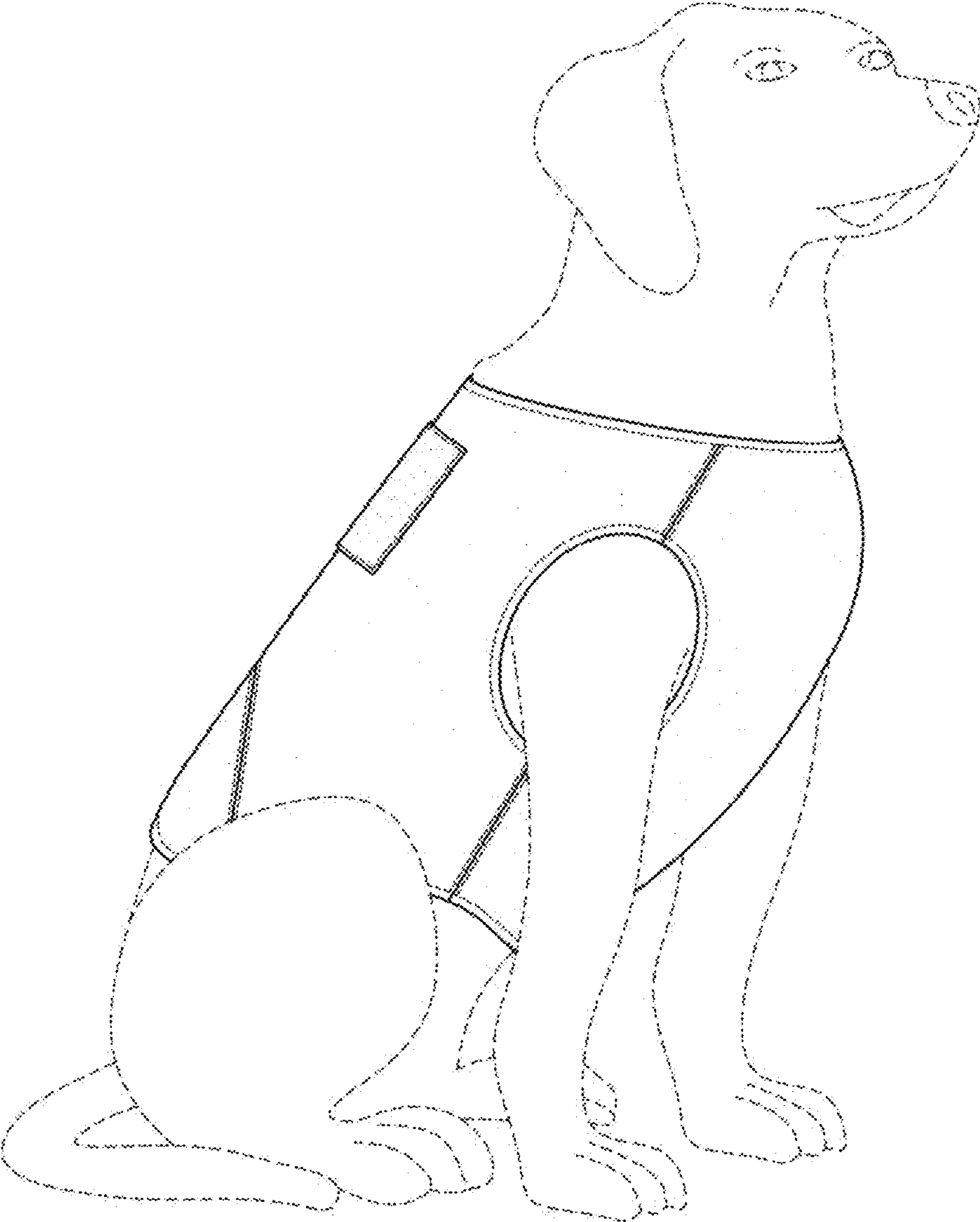

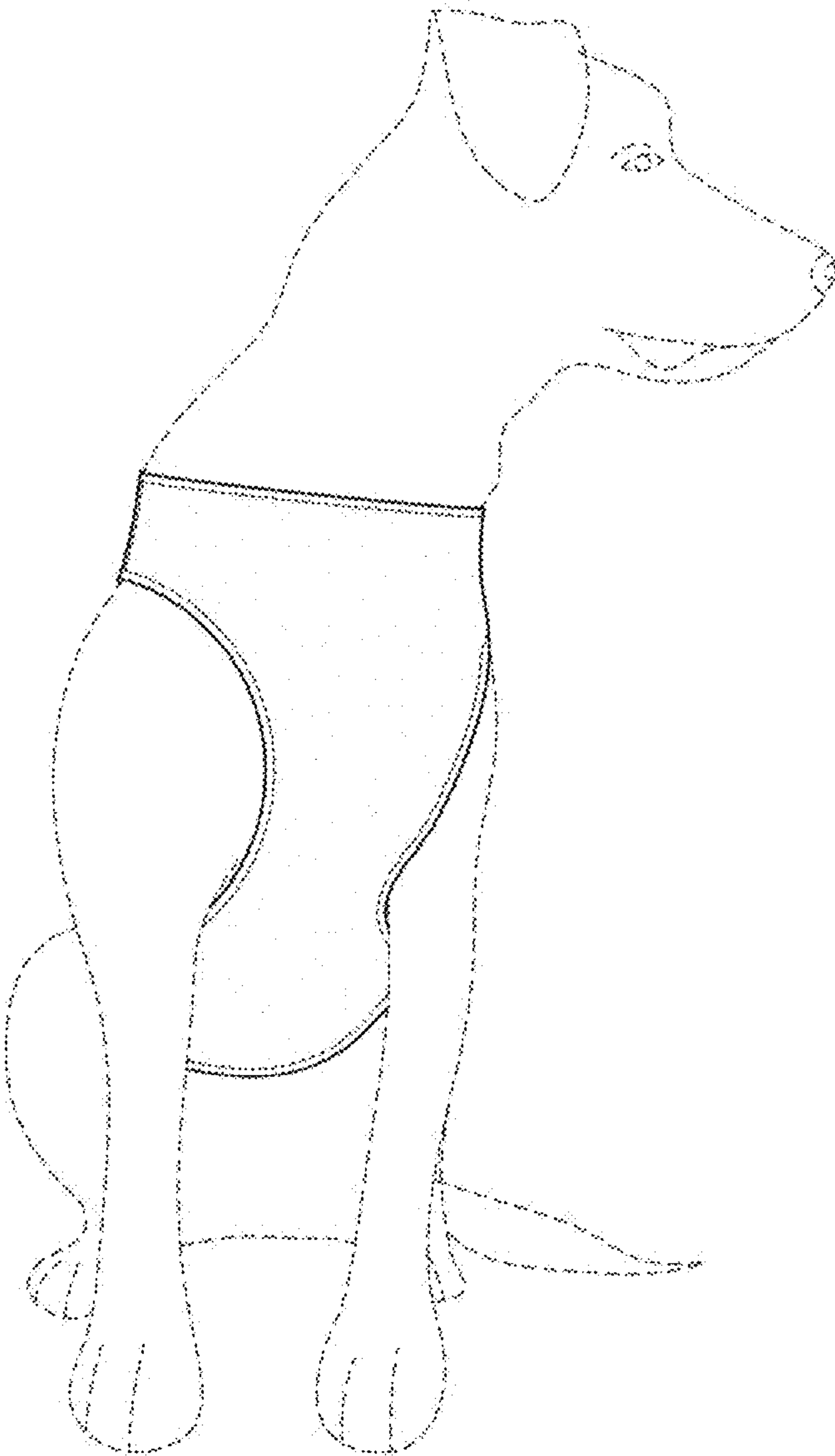

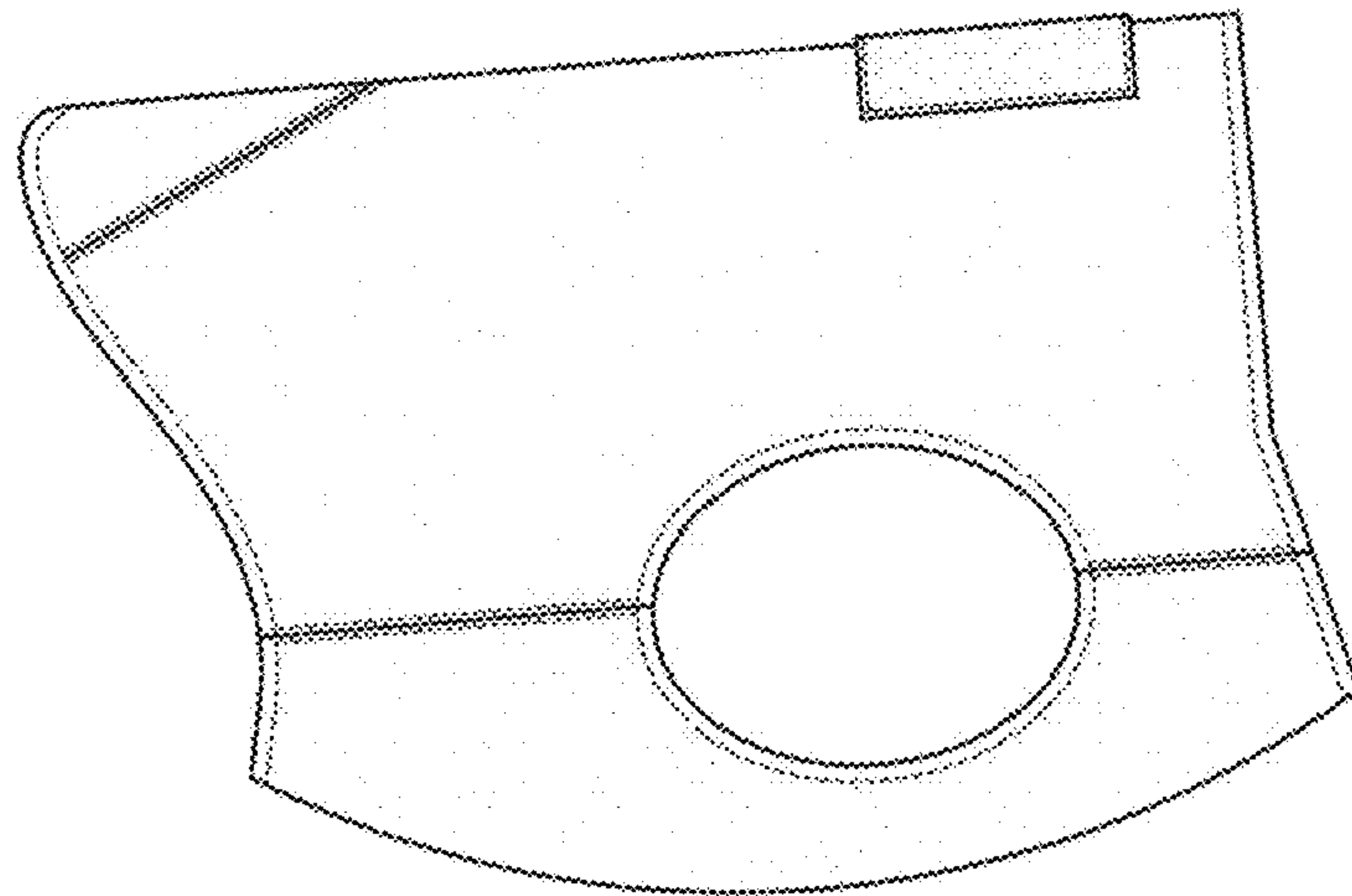

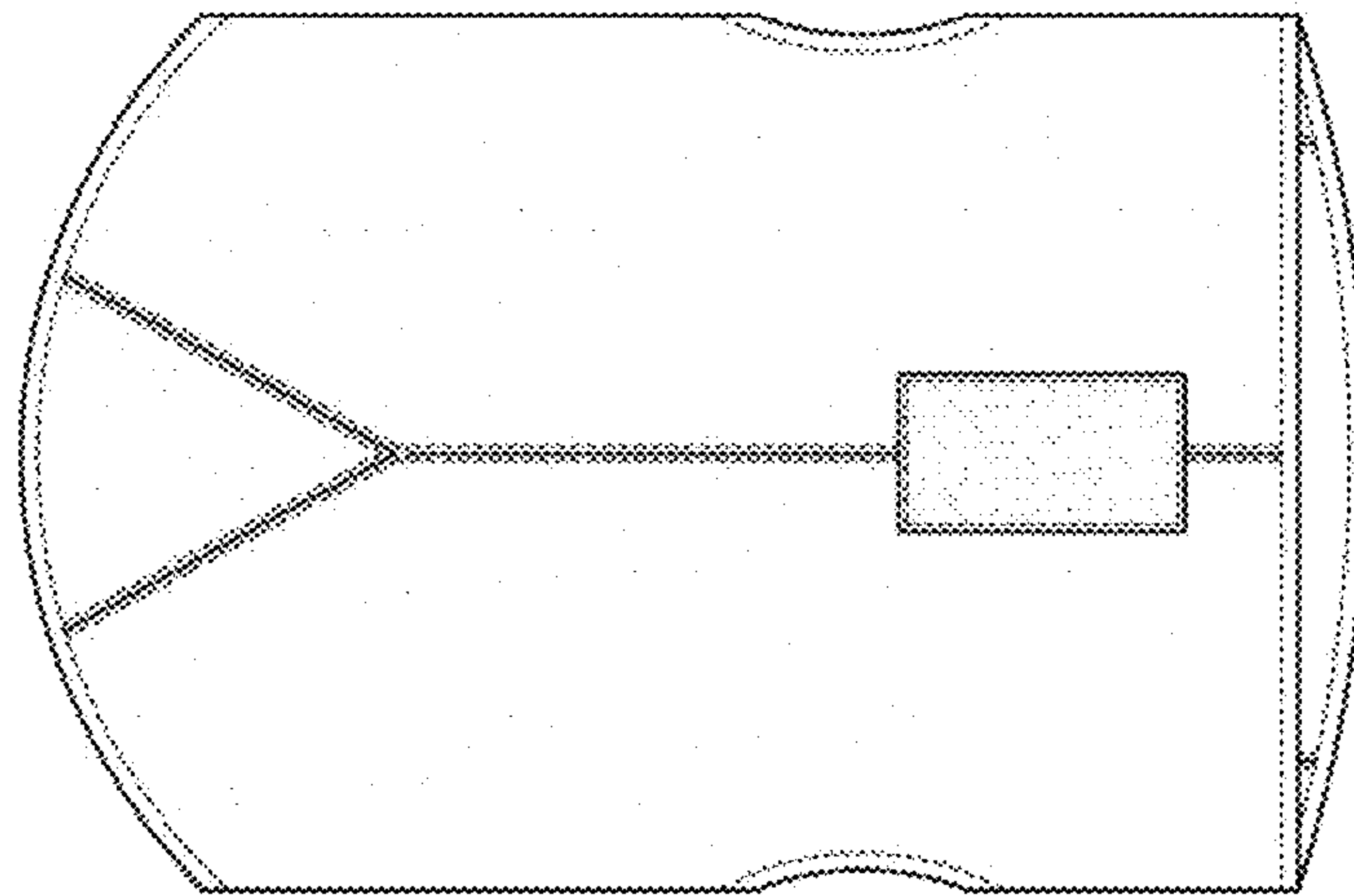

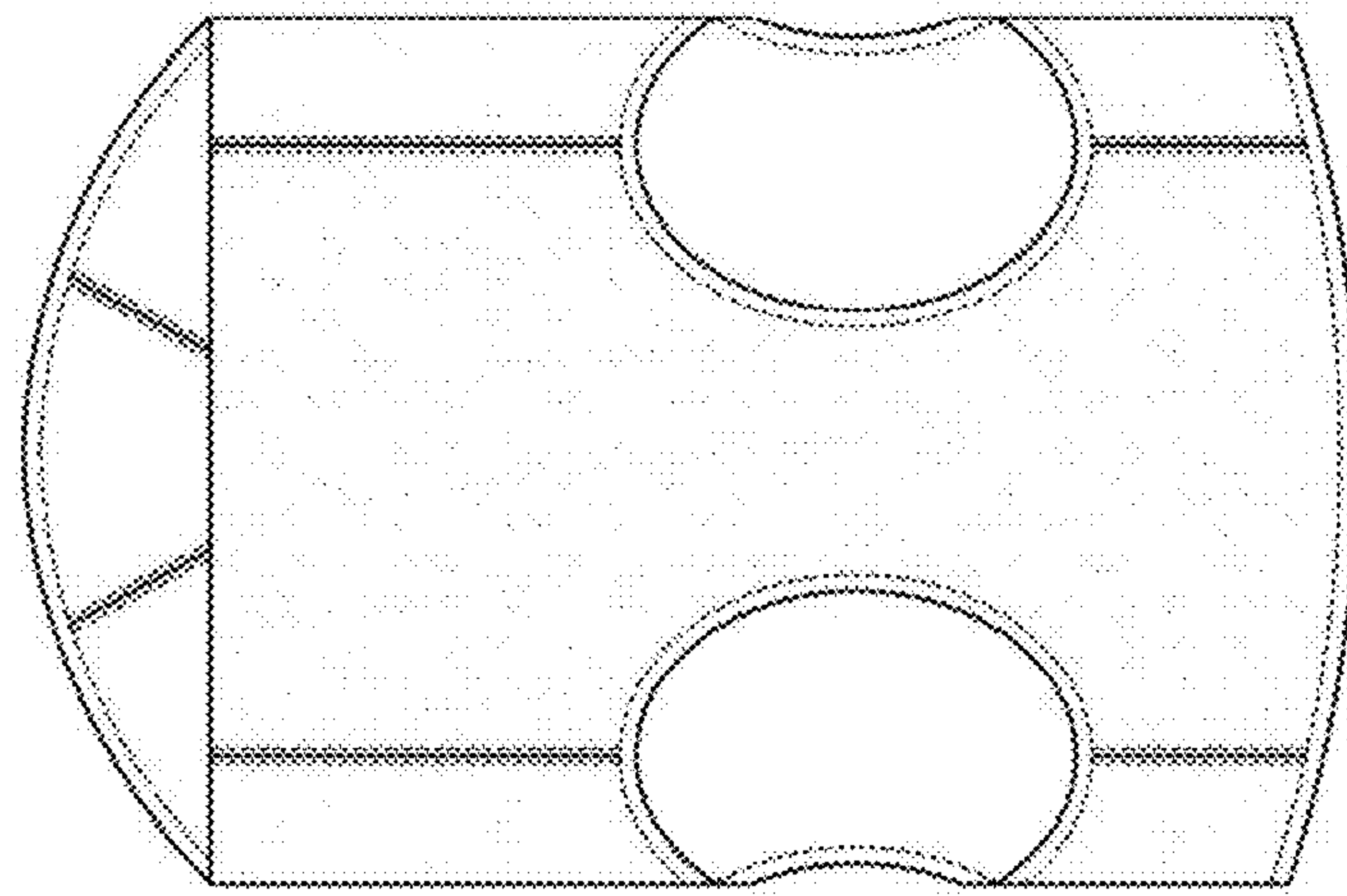

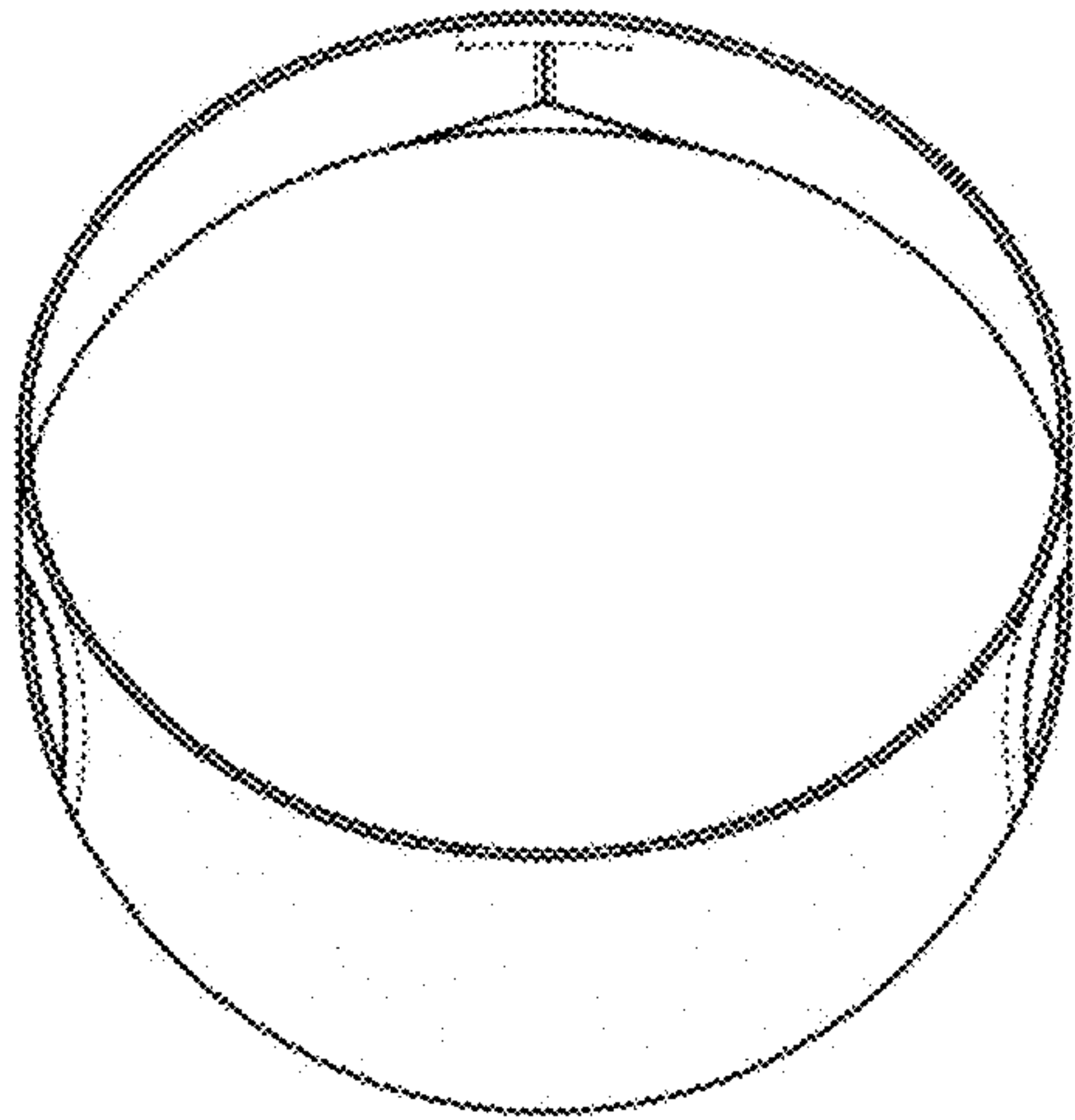

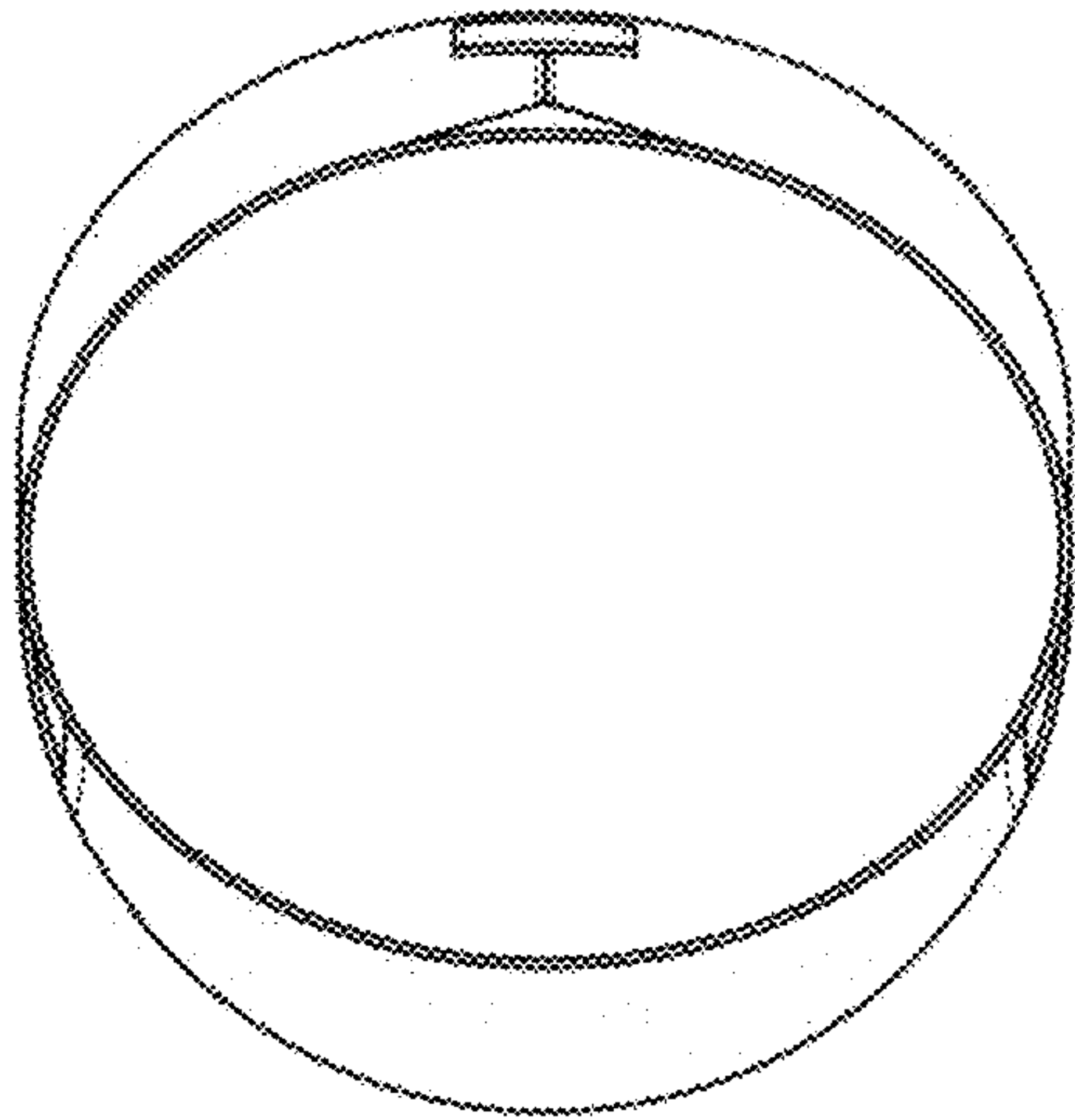
