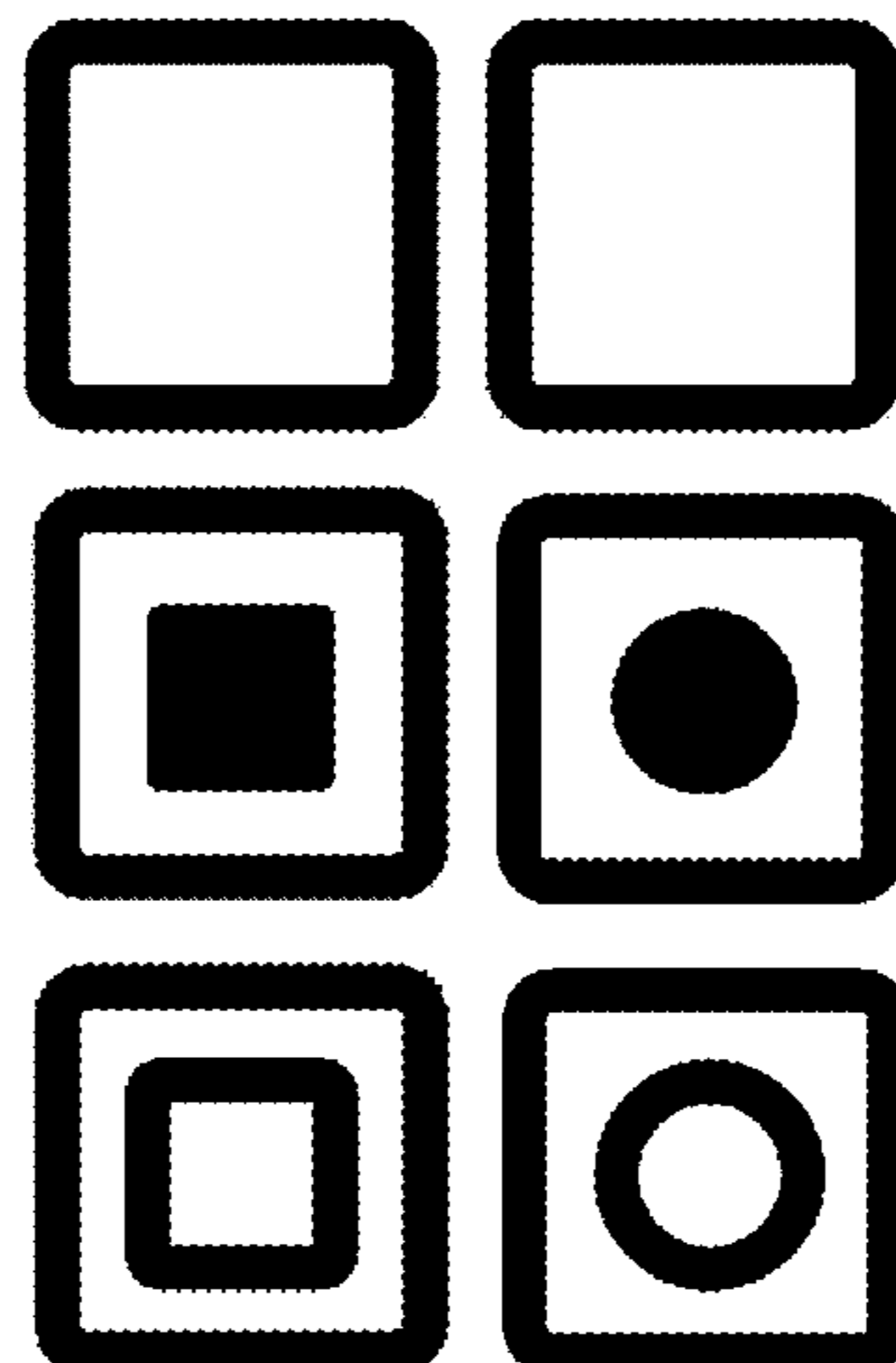
(57) **CLAIM**

We claim the ornamental design for an identification tag set, as shown and described.

DESCRIPTION

FIG. 1 is a front view of an identification tag set;
FIG. 2 is a front view of the identification tag set according to a second embodiment;
FIG. 3 is a side elevation view of the identification tag set for both embodiments, all side elevation views being the same; and,
FIG. 4 is a back elevation view thereof.

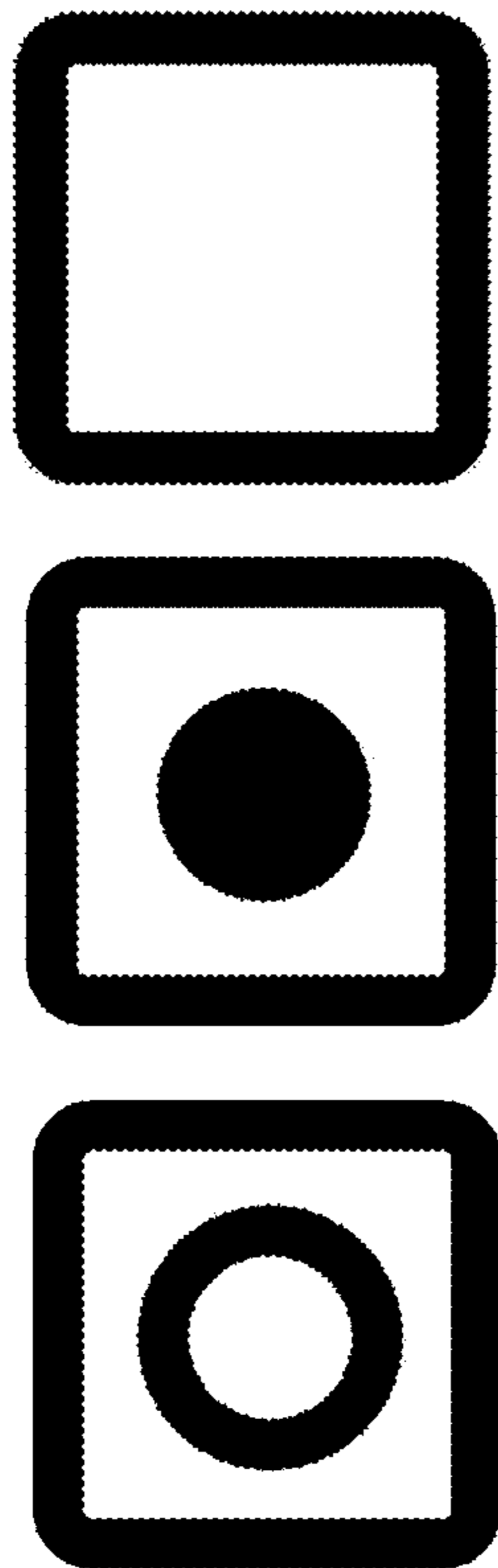

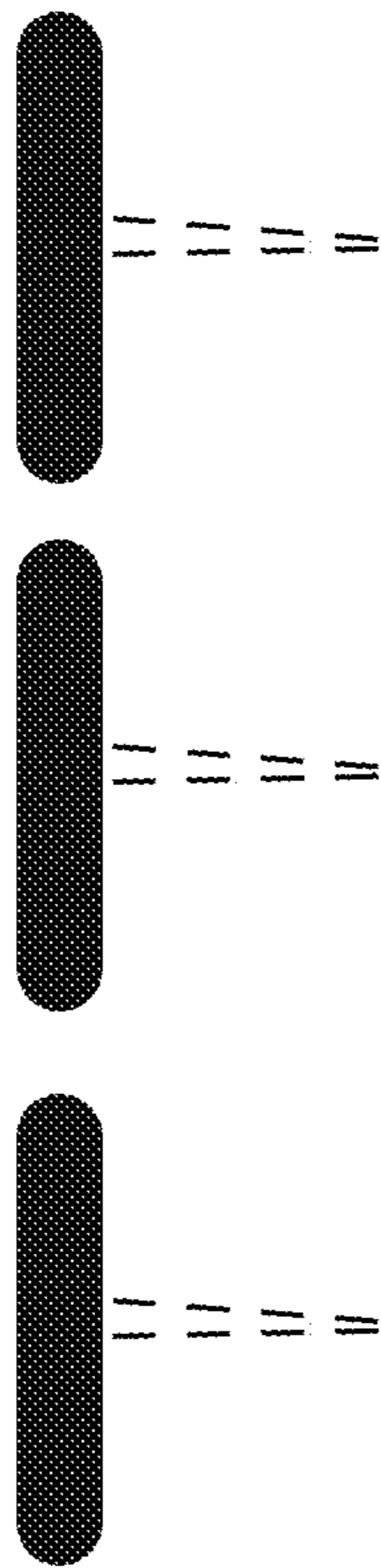
