DESCRIPTION

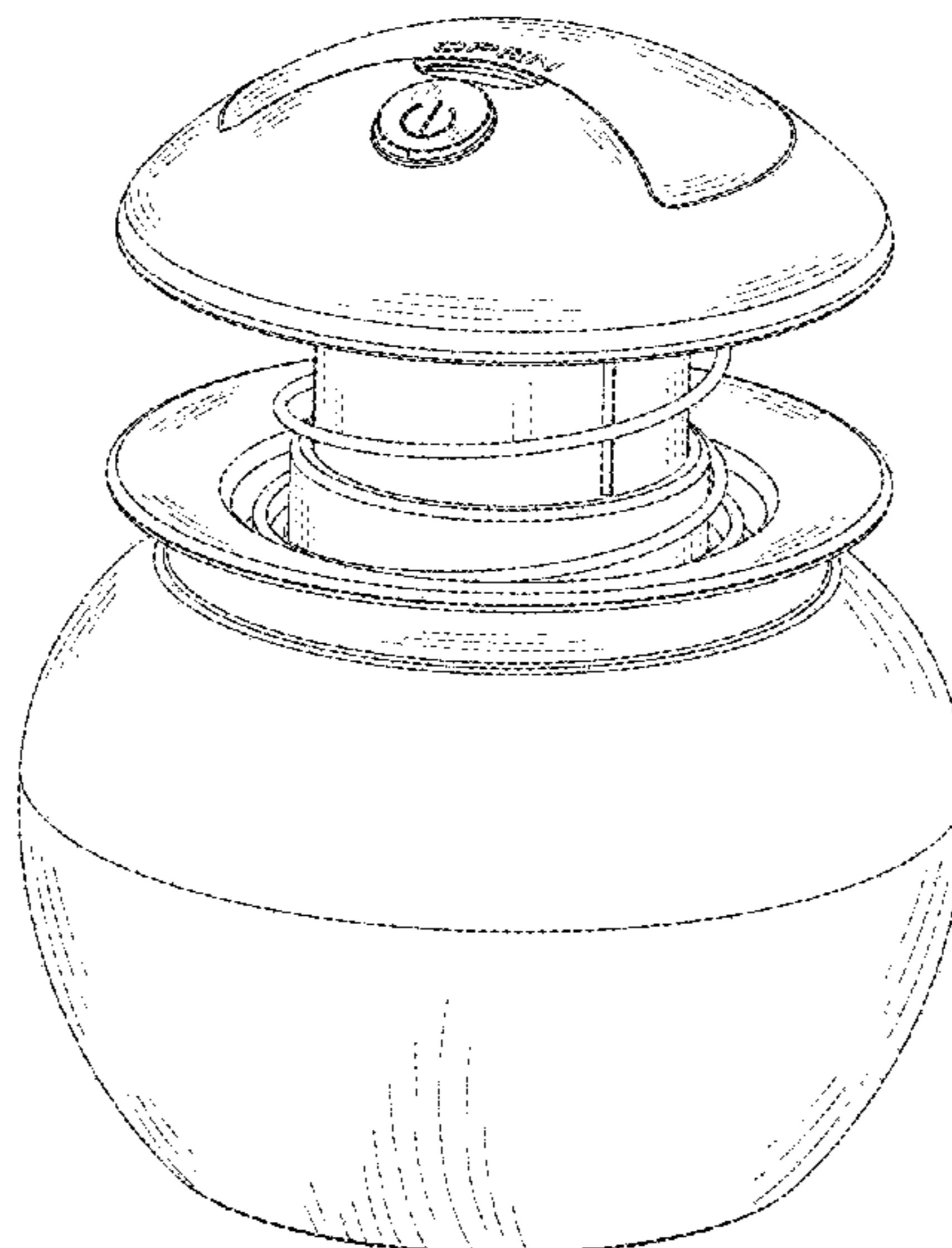
FIG. 1 is a perspective view of a cleaner for cosmetic brushes showing my new design;

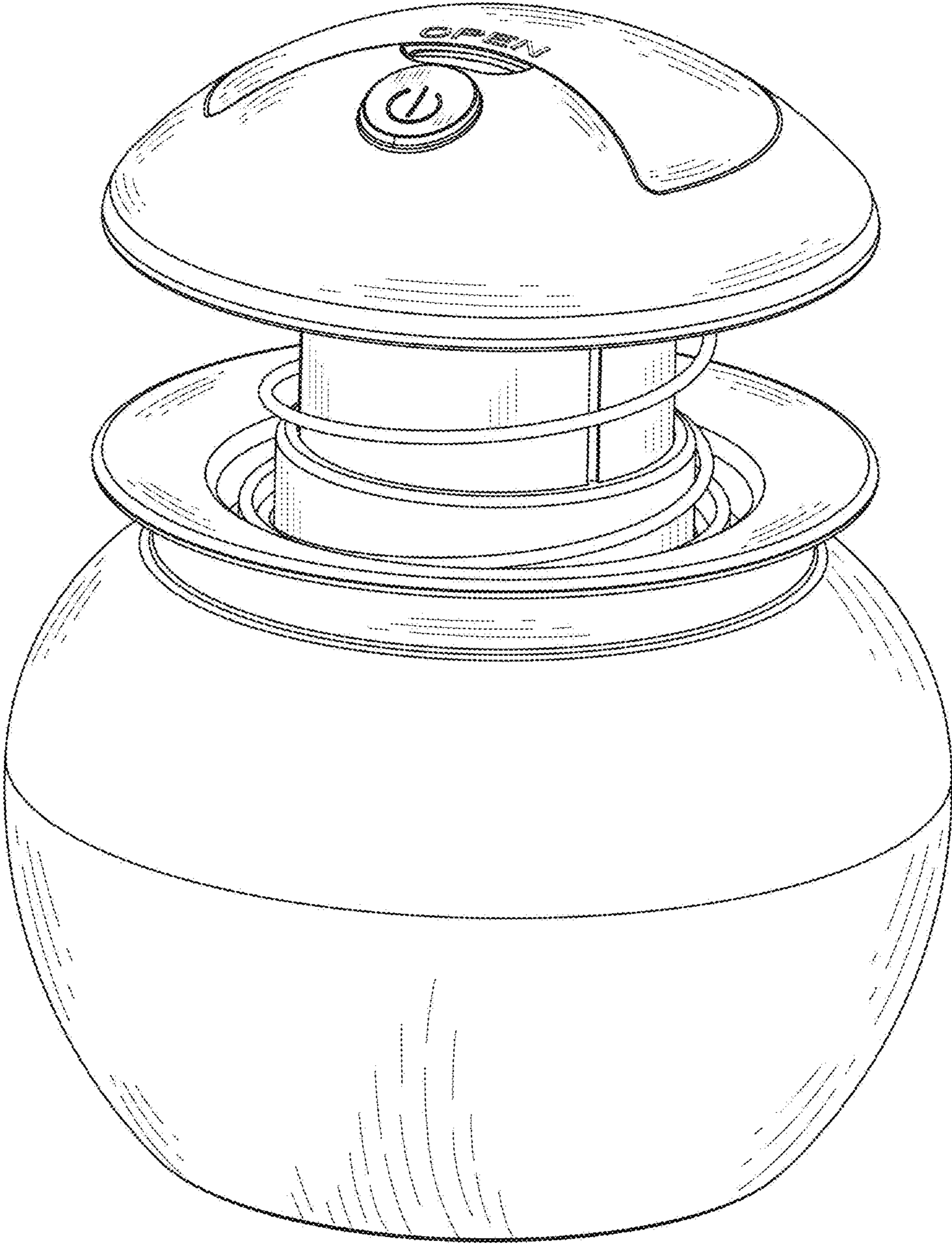

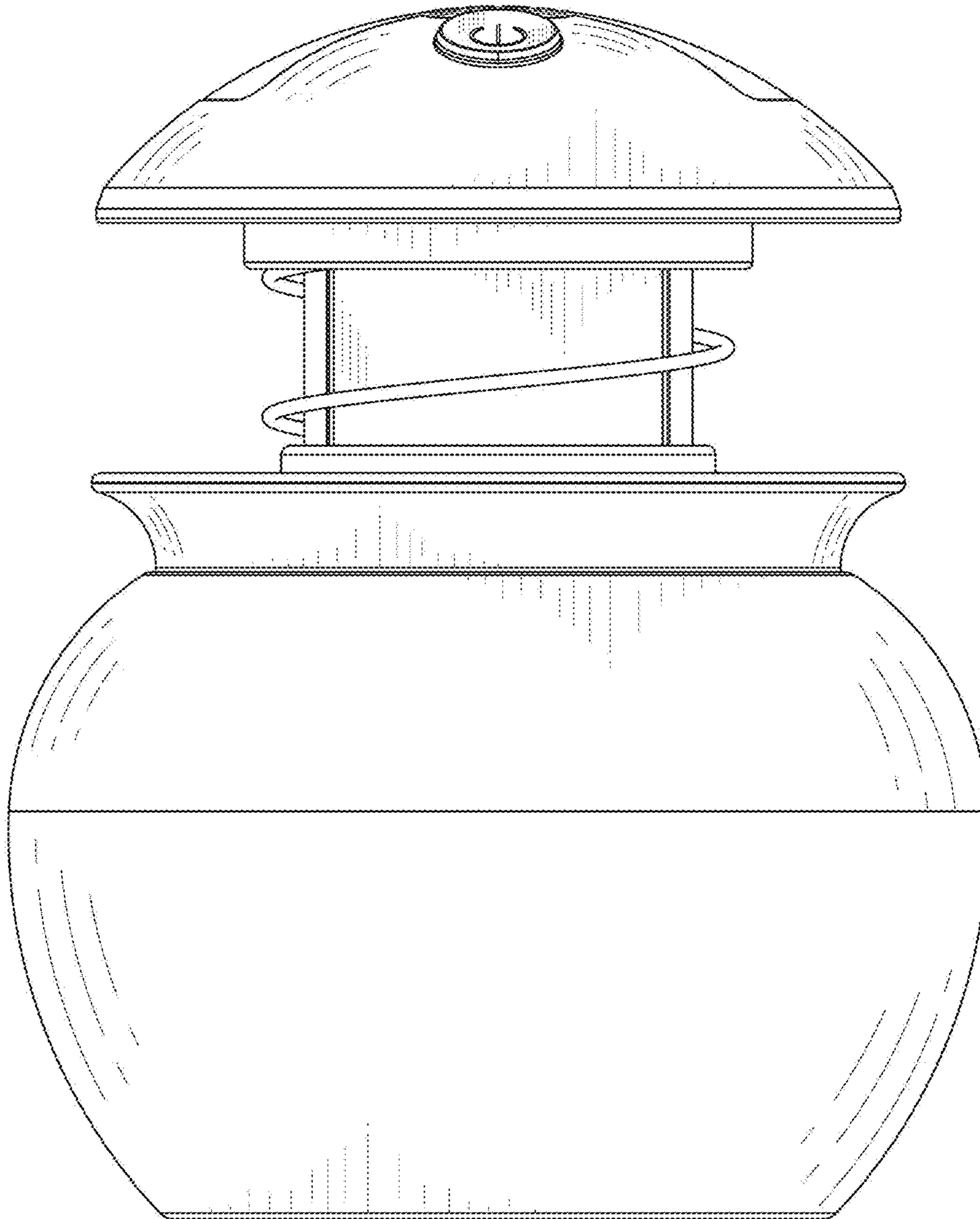

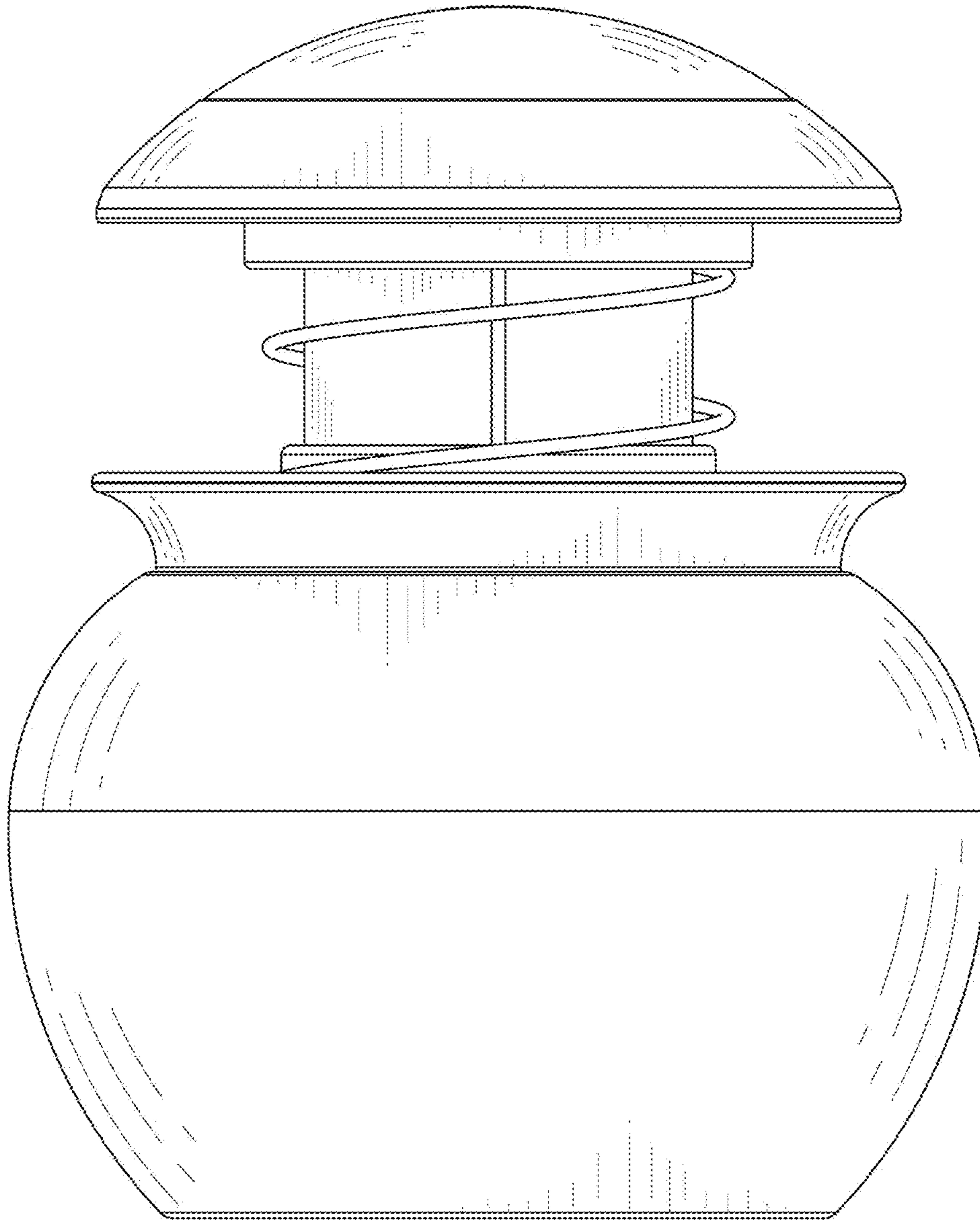

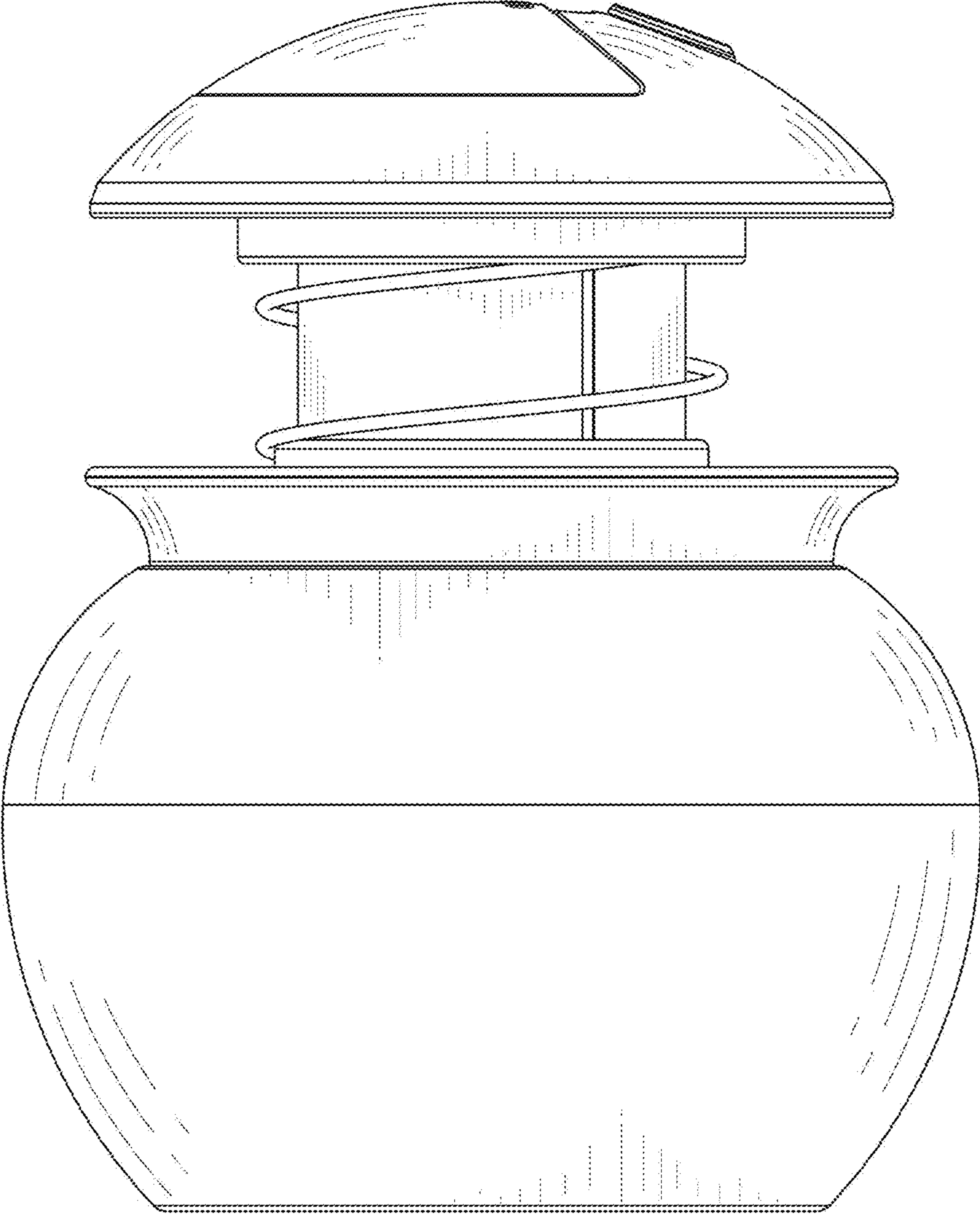

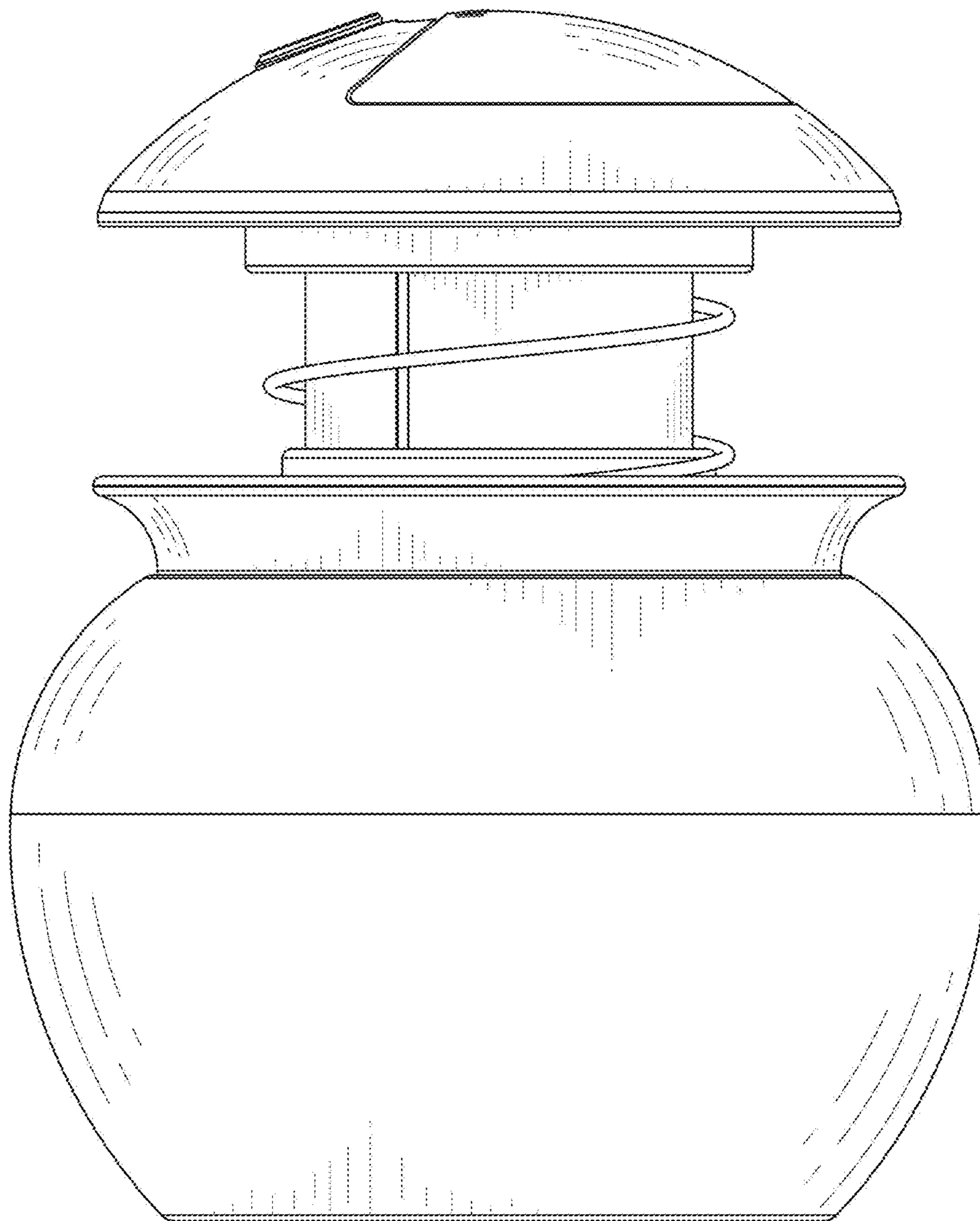

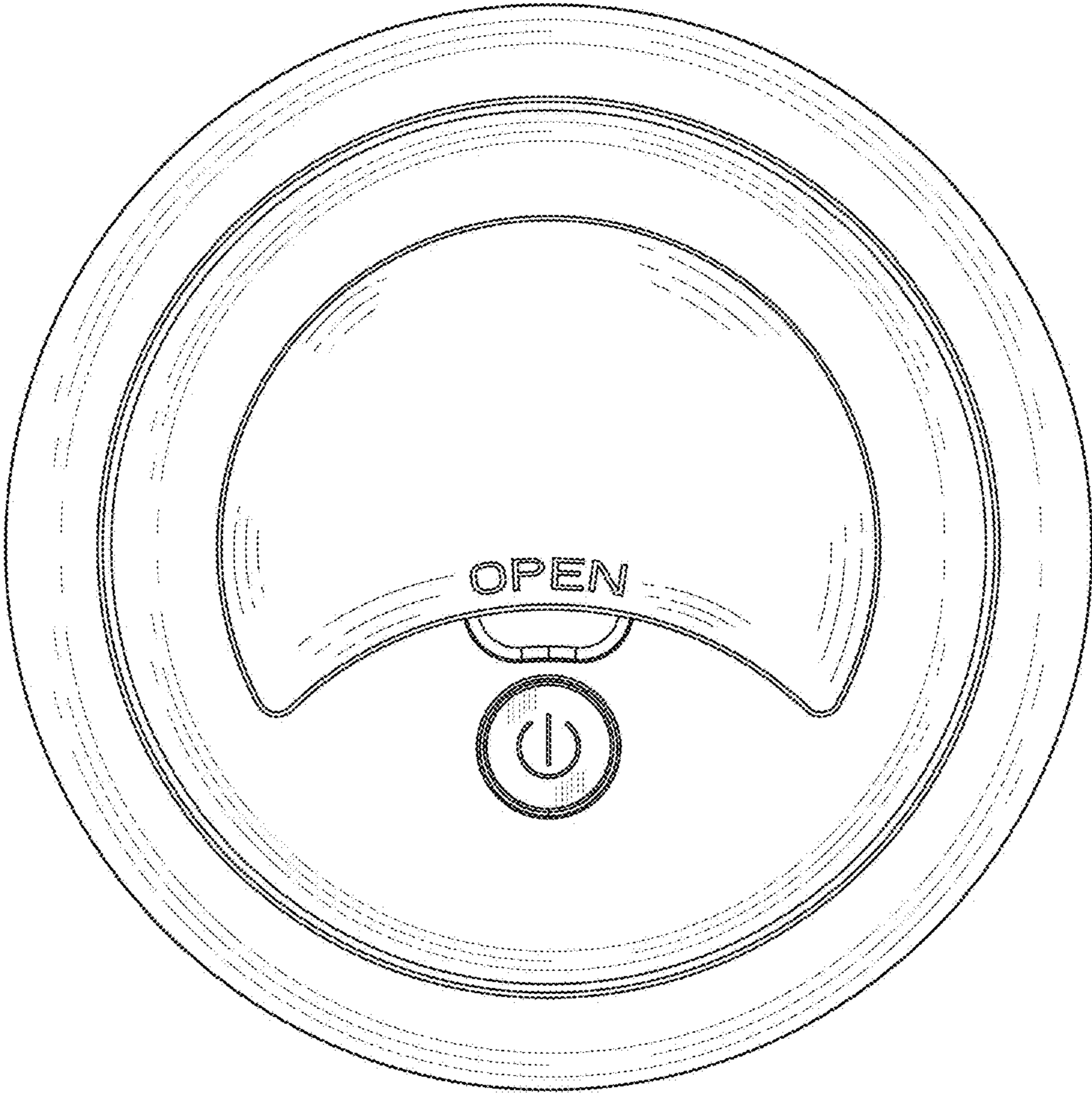

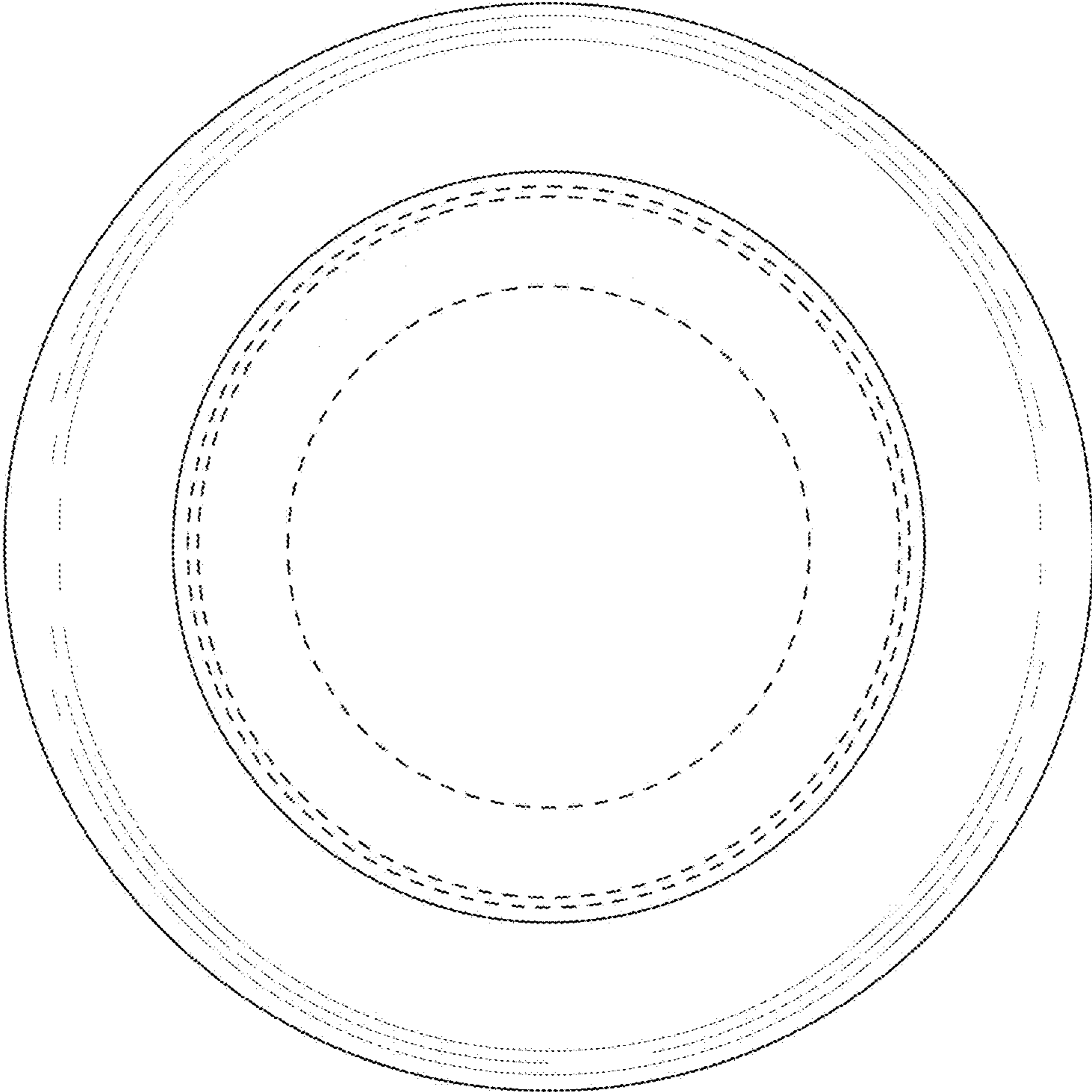
