FIG. 5 is a left side view thereof, the right side view being a mirror image thereof.

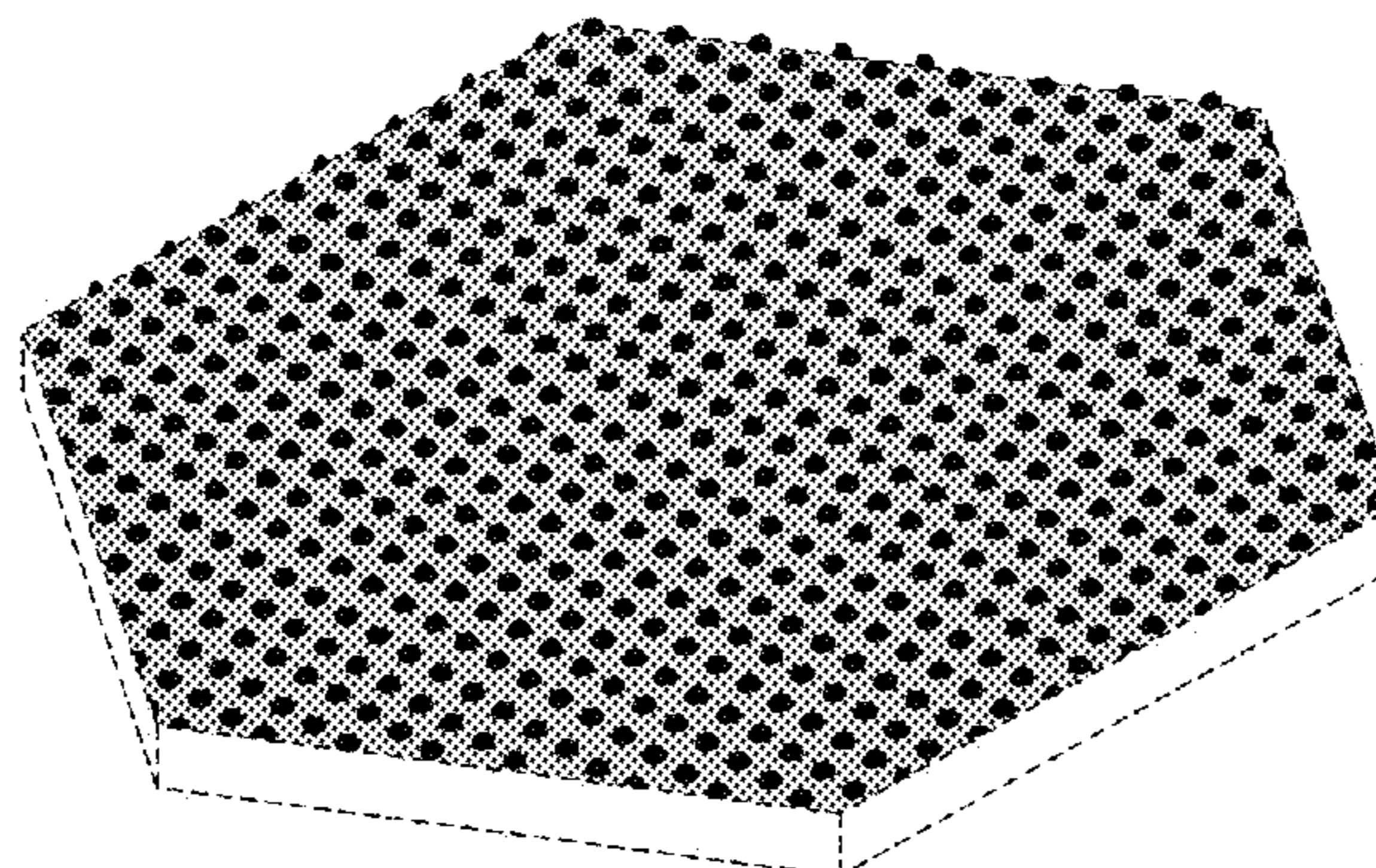
The broken lines show portions of the scouring article that form no part of the claimed design.

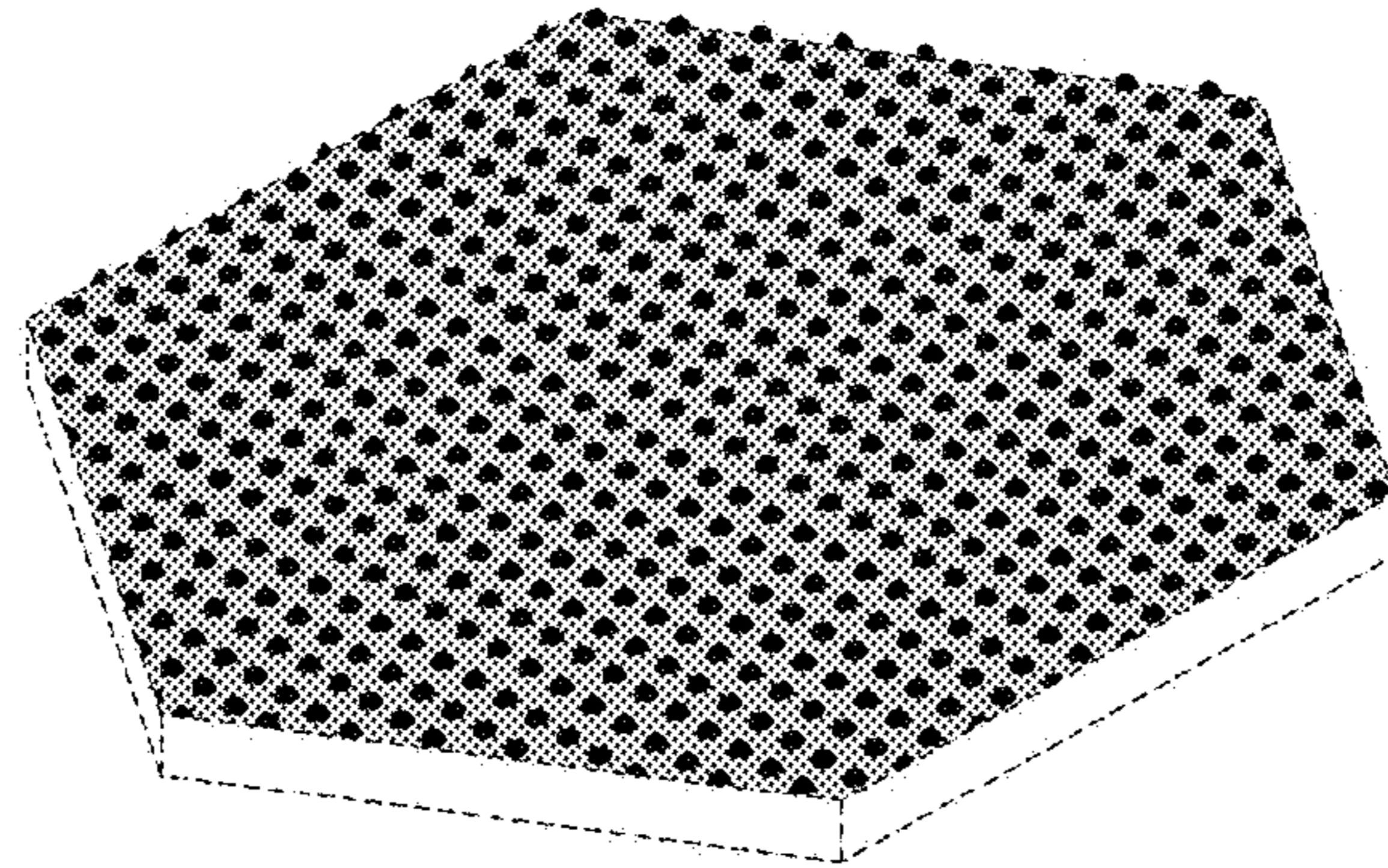

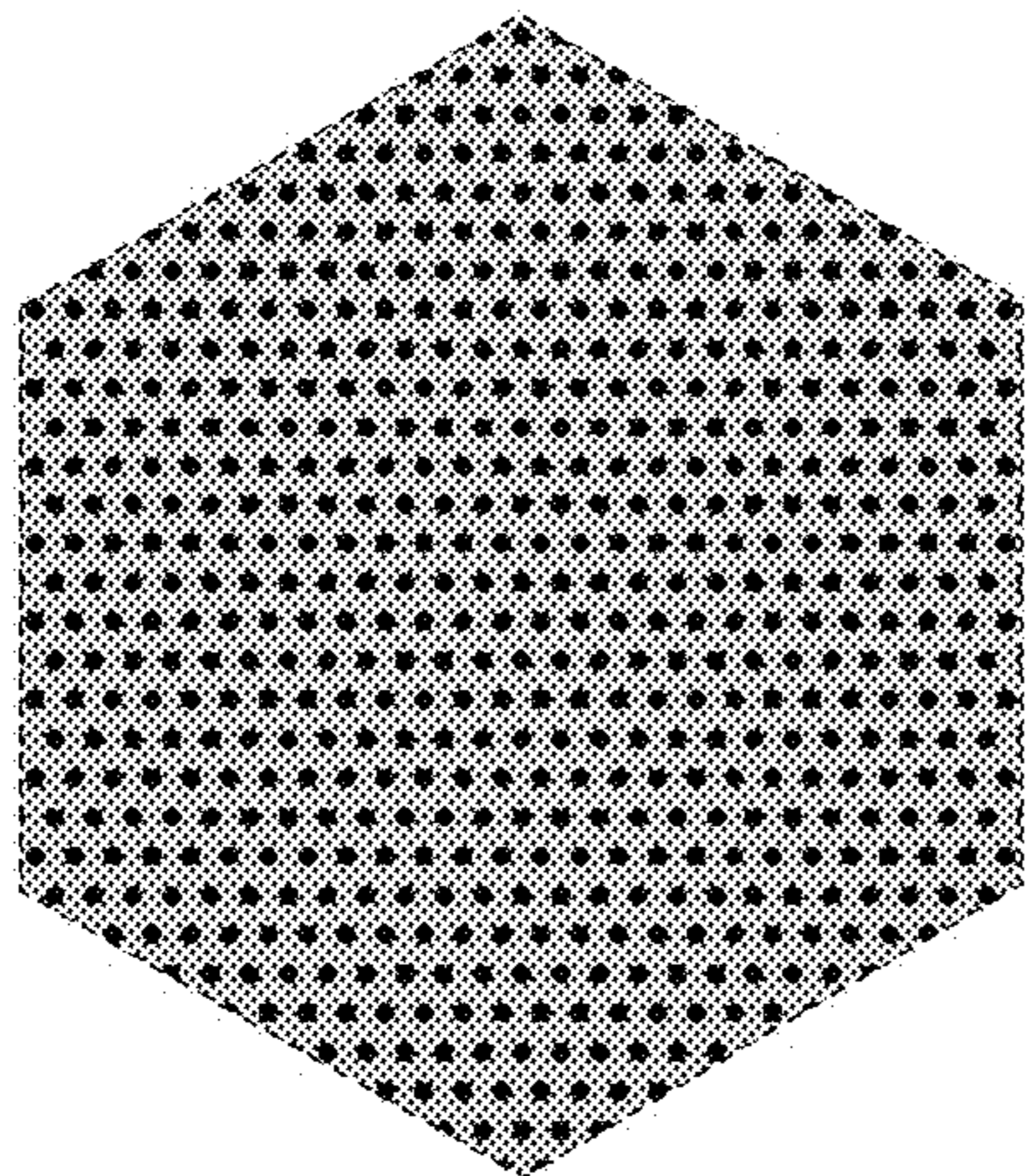

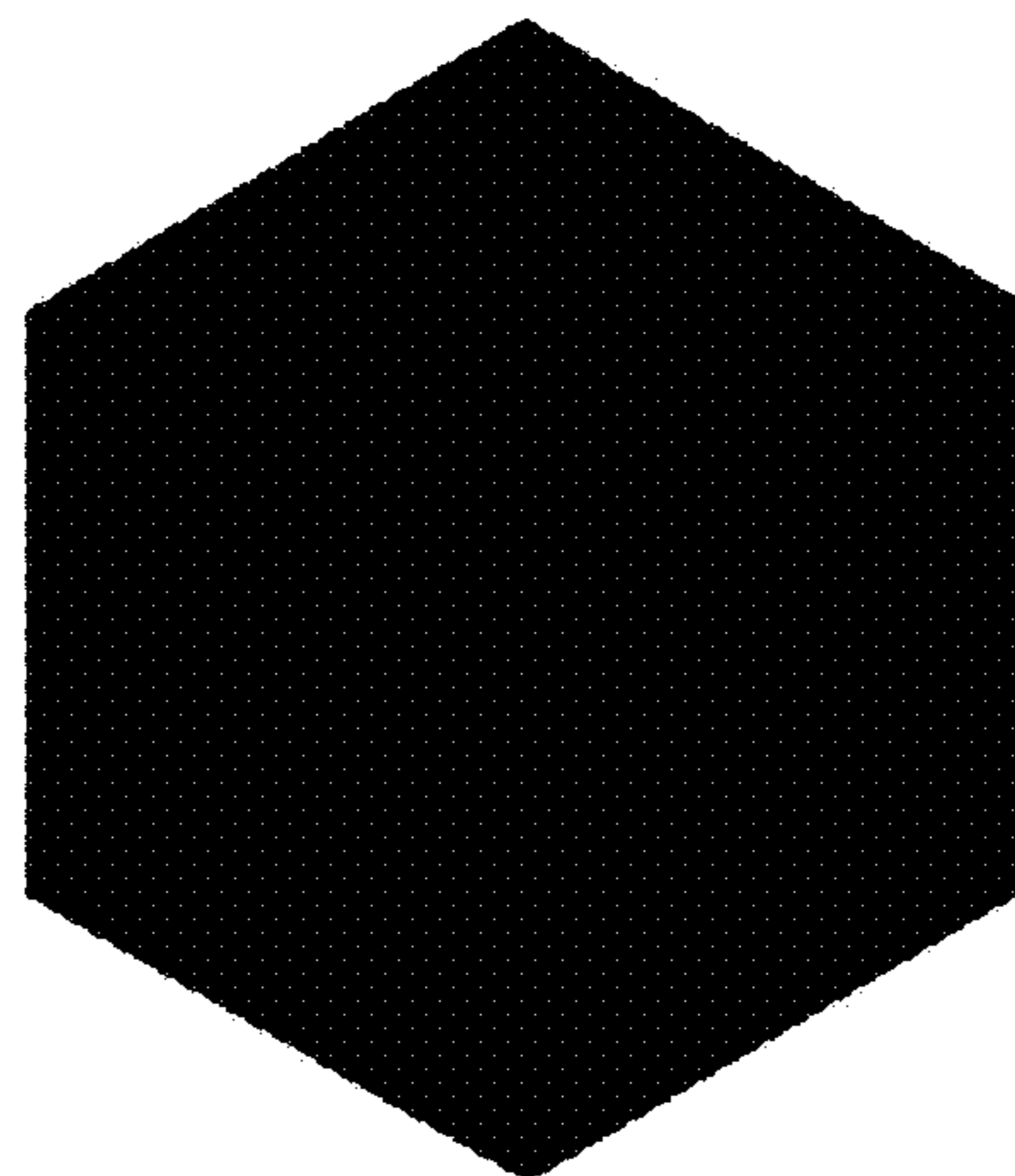

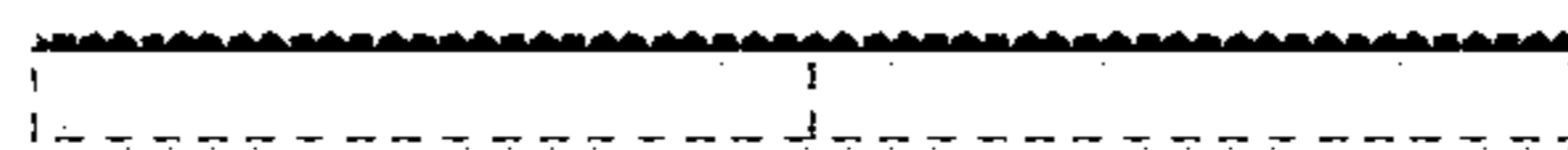

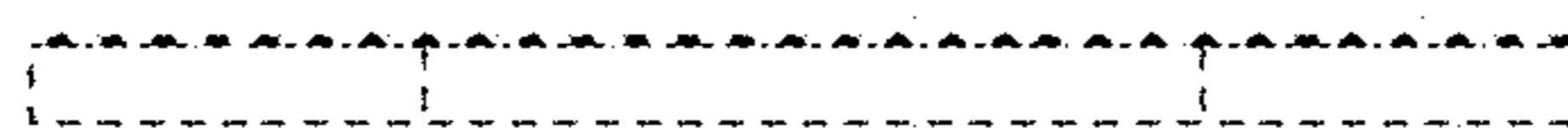
