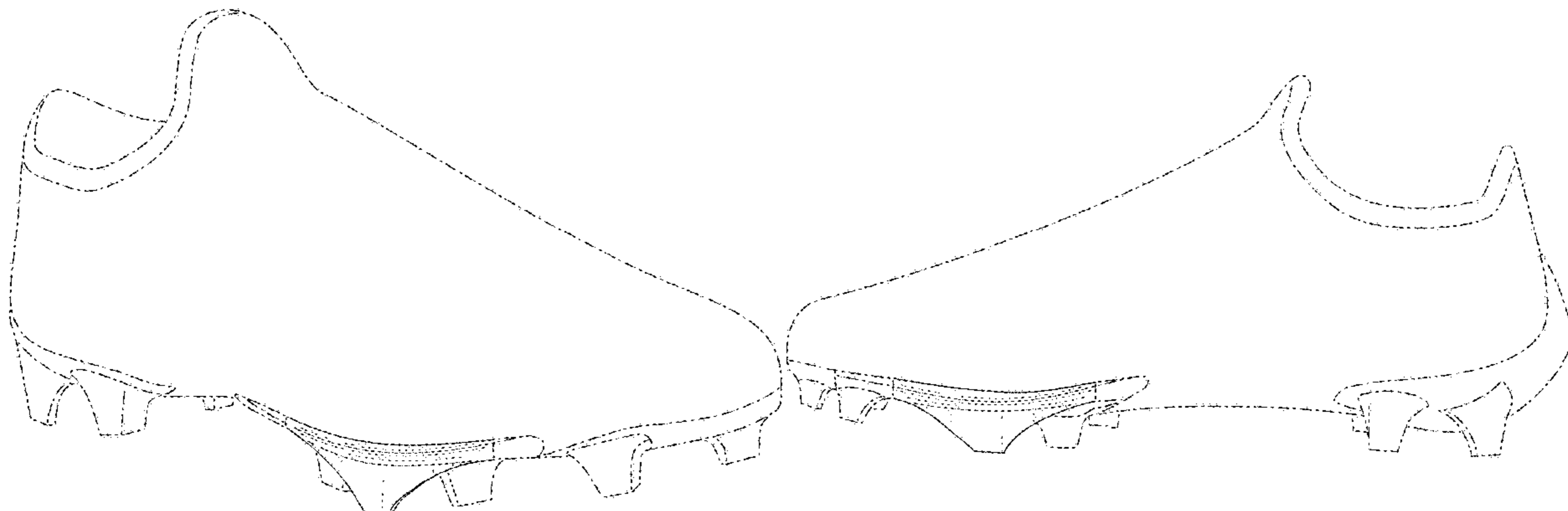
(57) **CLAIM**

DESCRIPTION

FIG. 6 is a bottom view thereof;

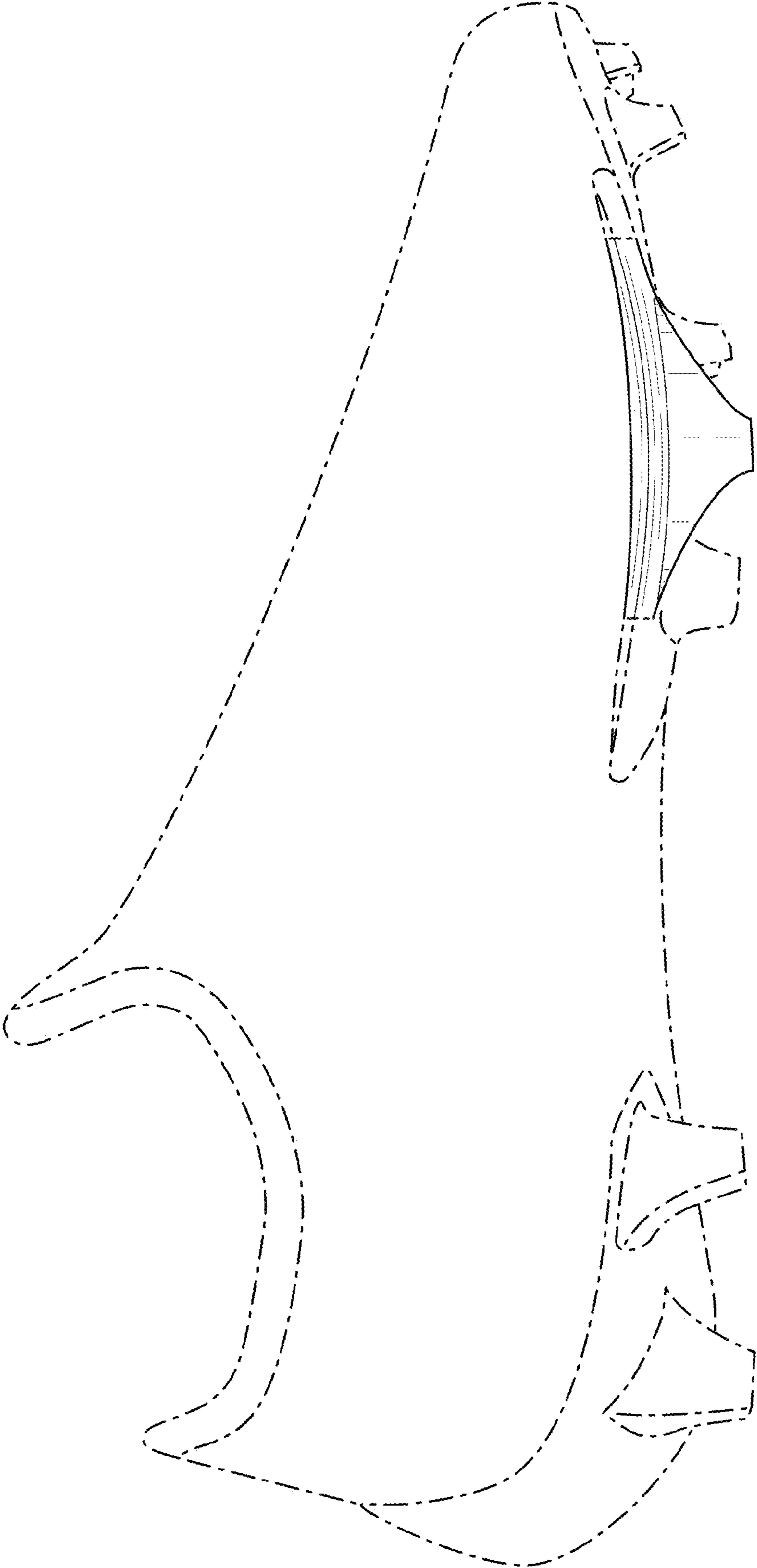

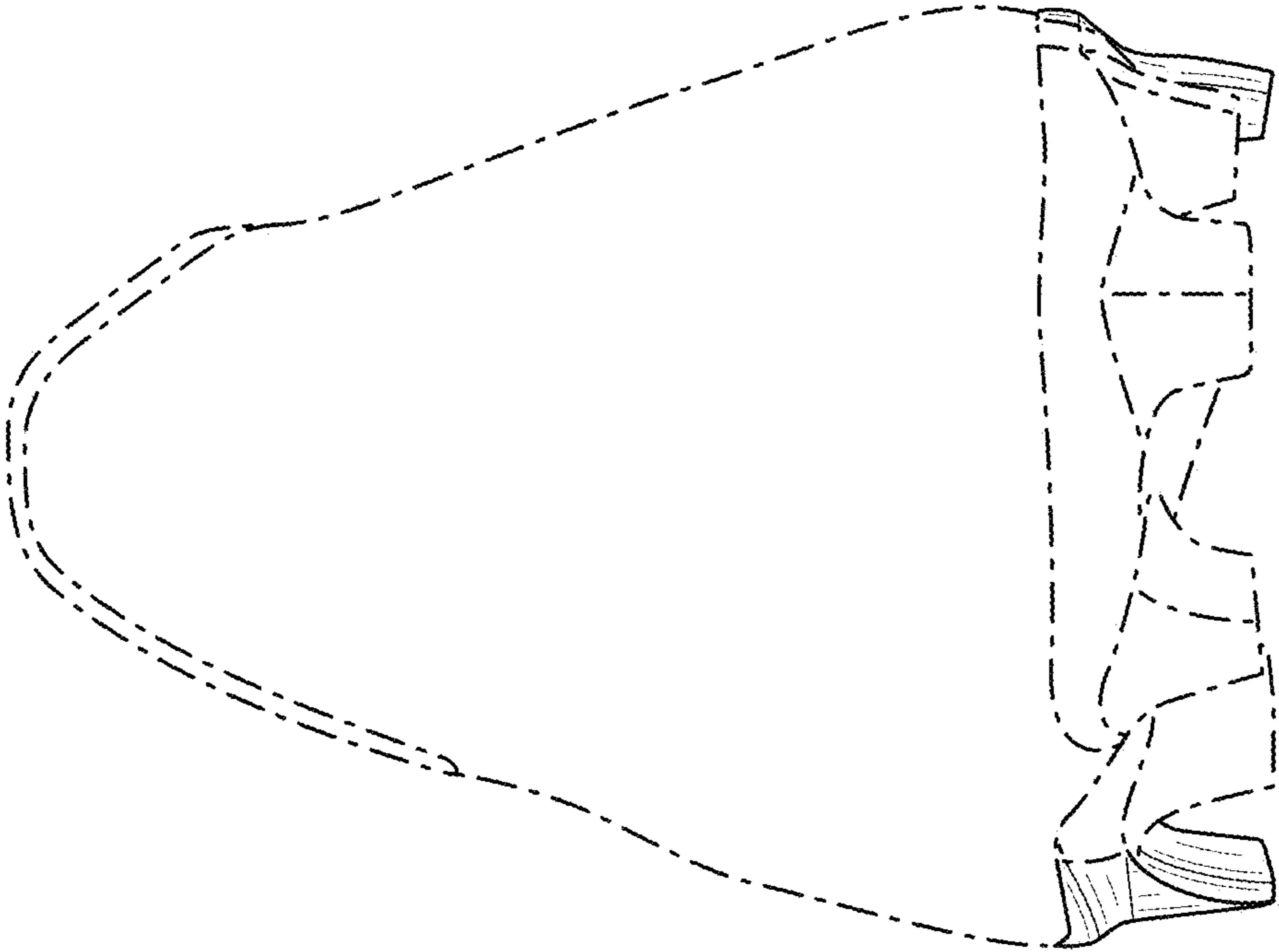

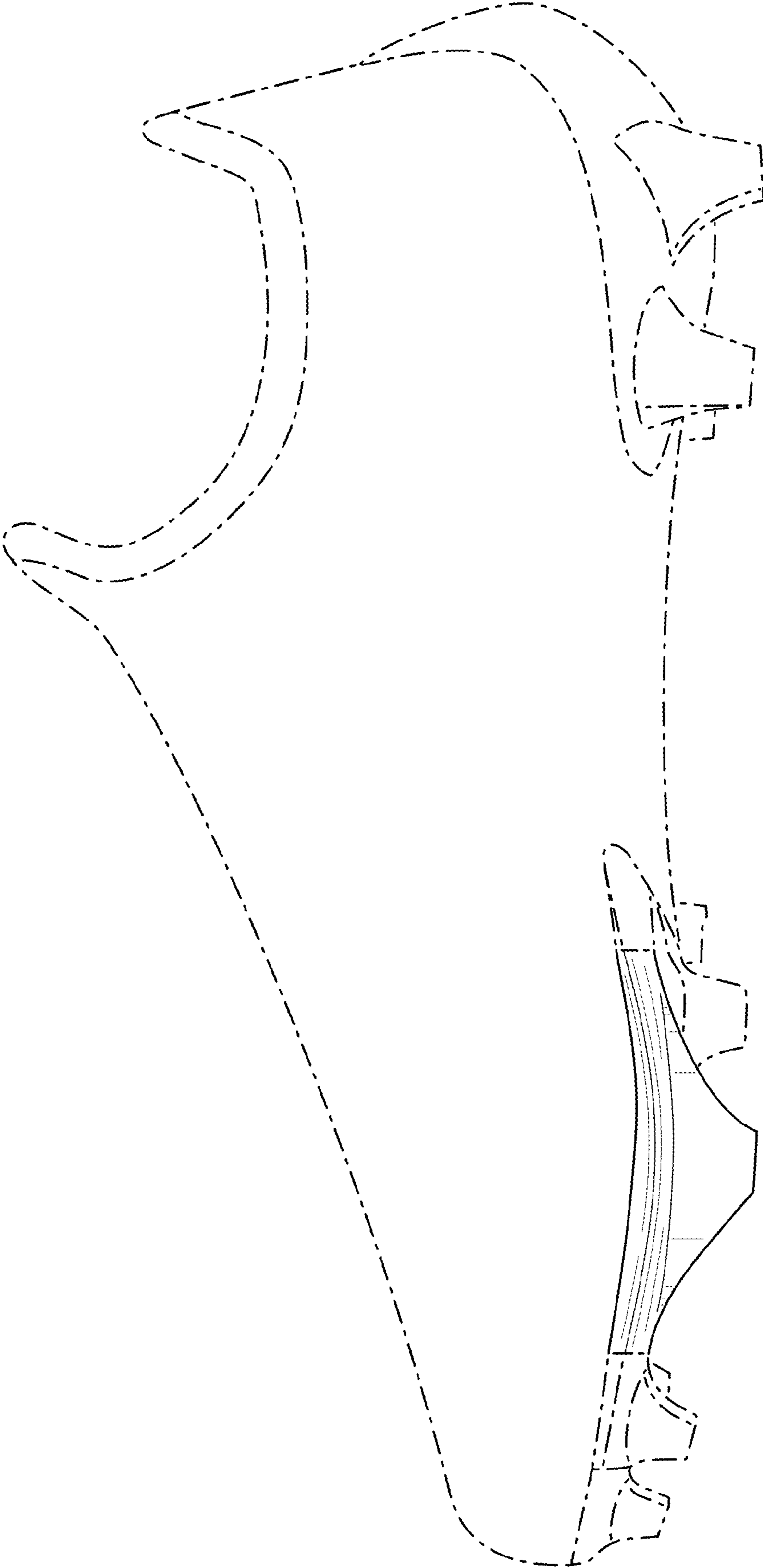

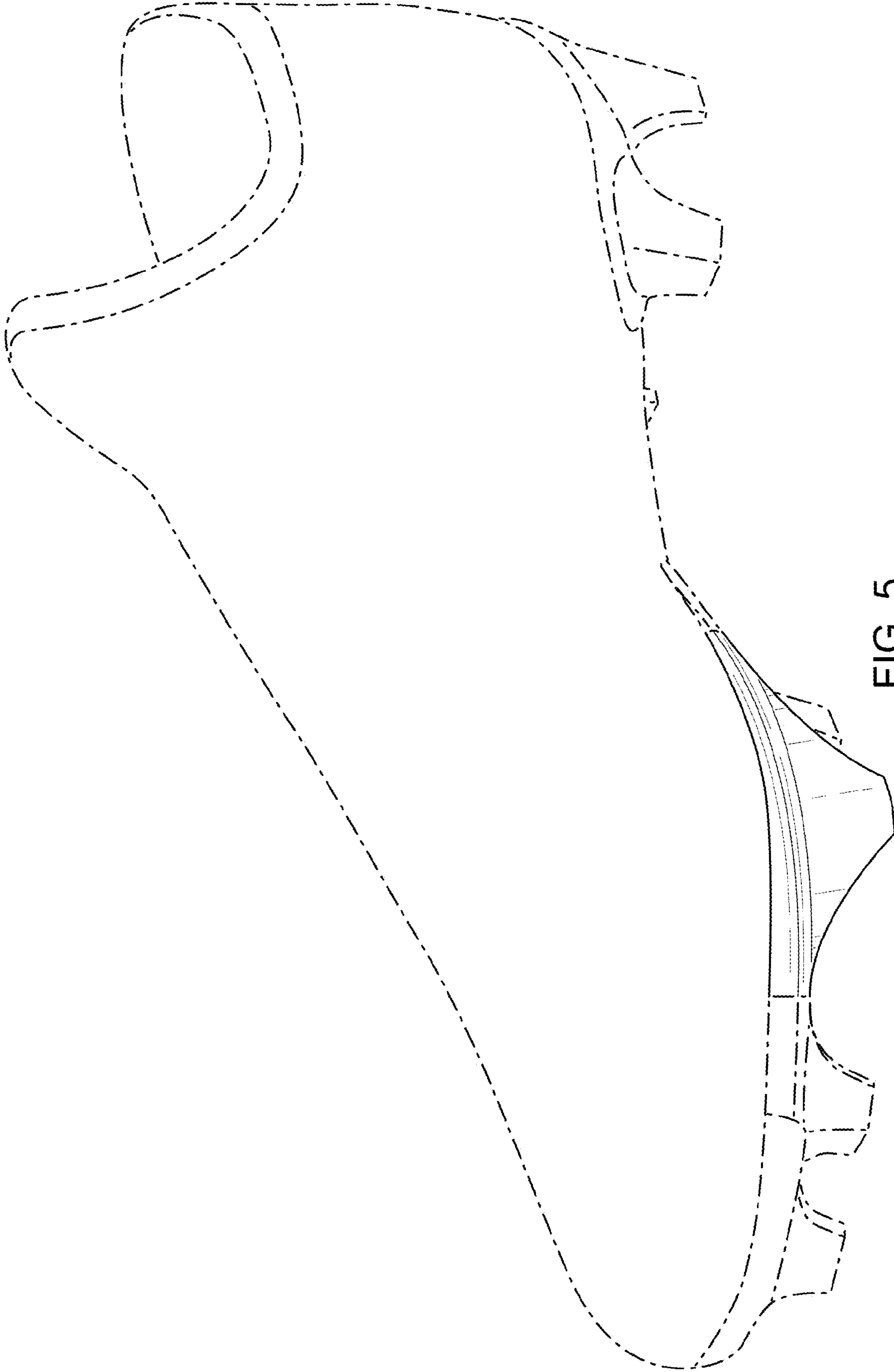

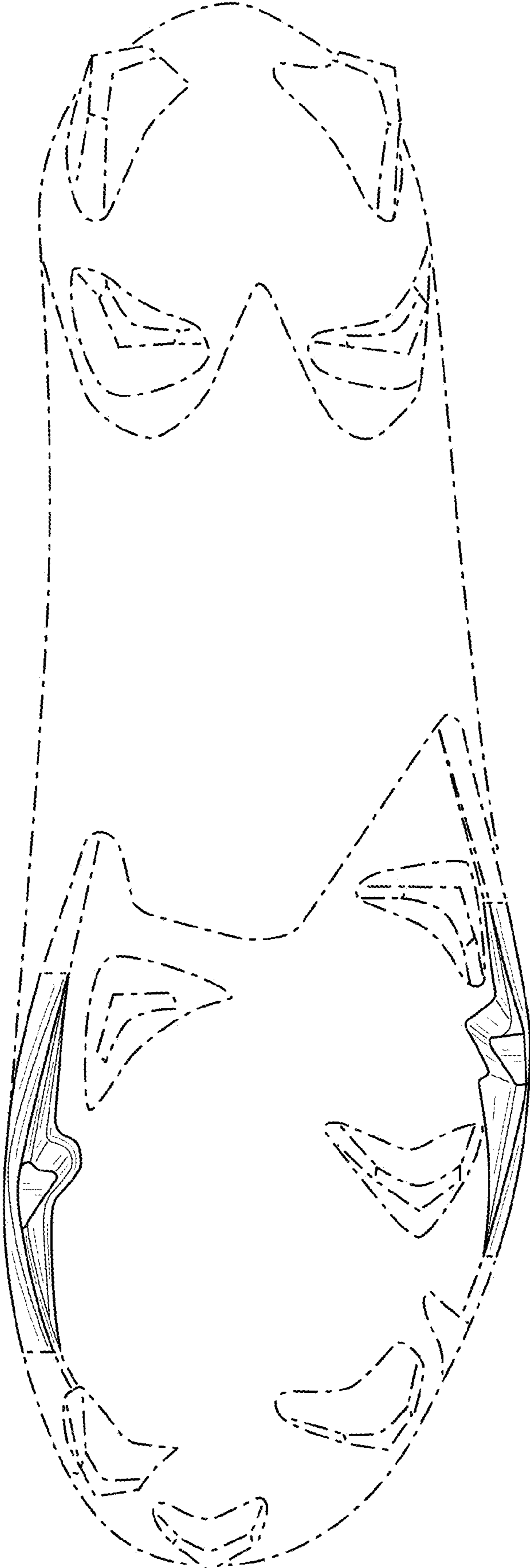

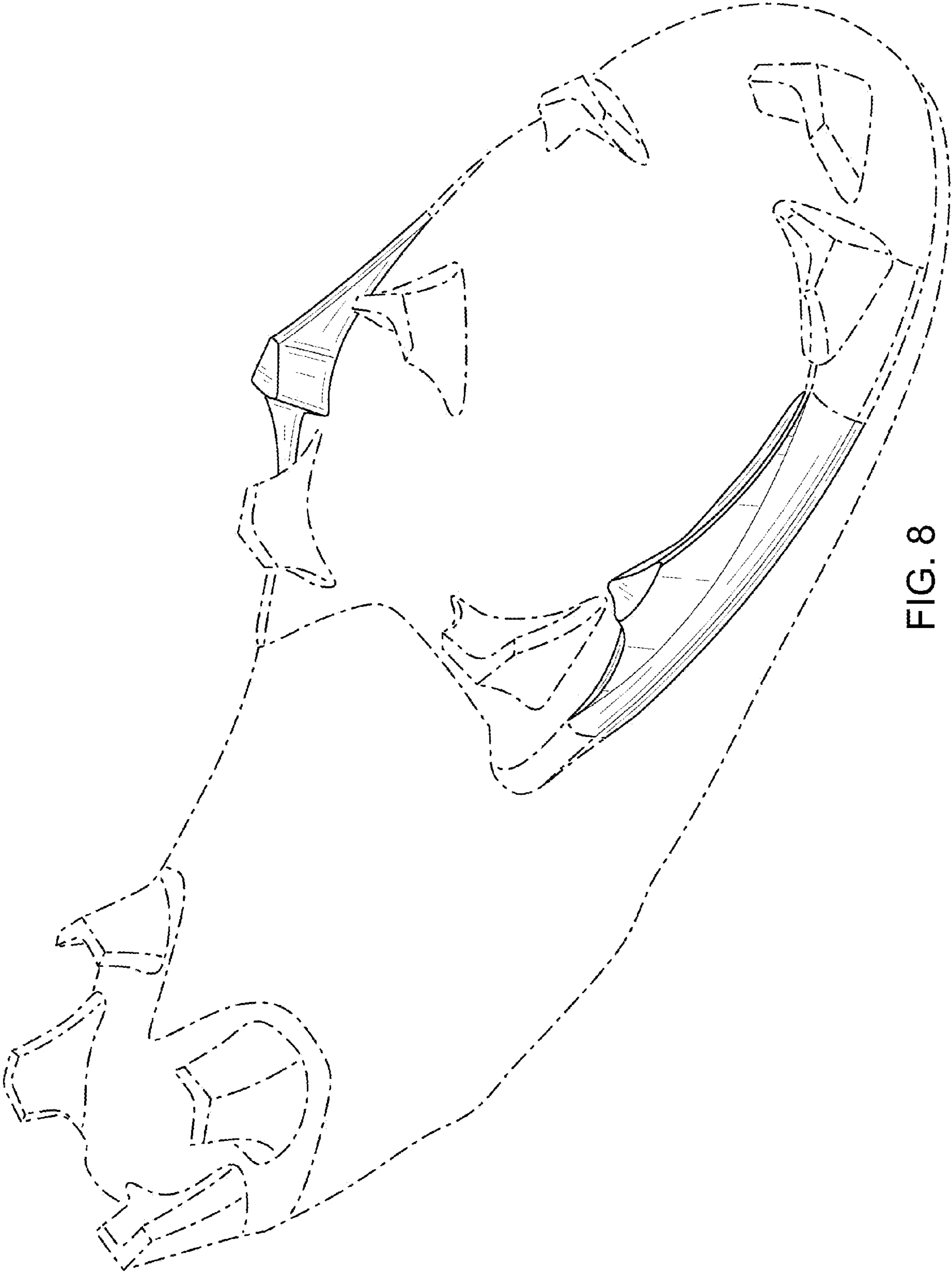
