FIG. 3 is a bottom rear perspective view thereof.

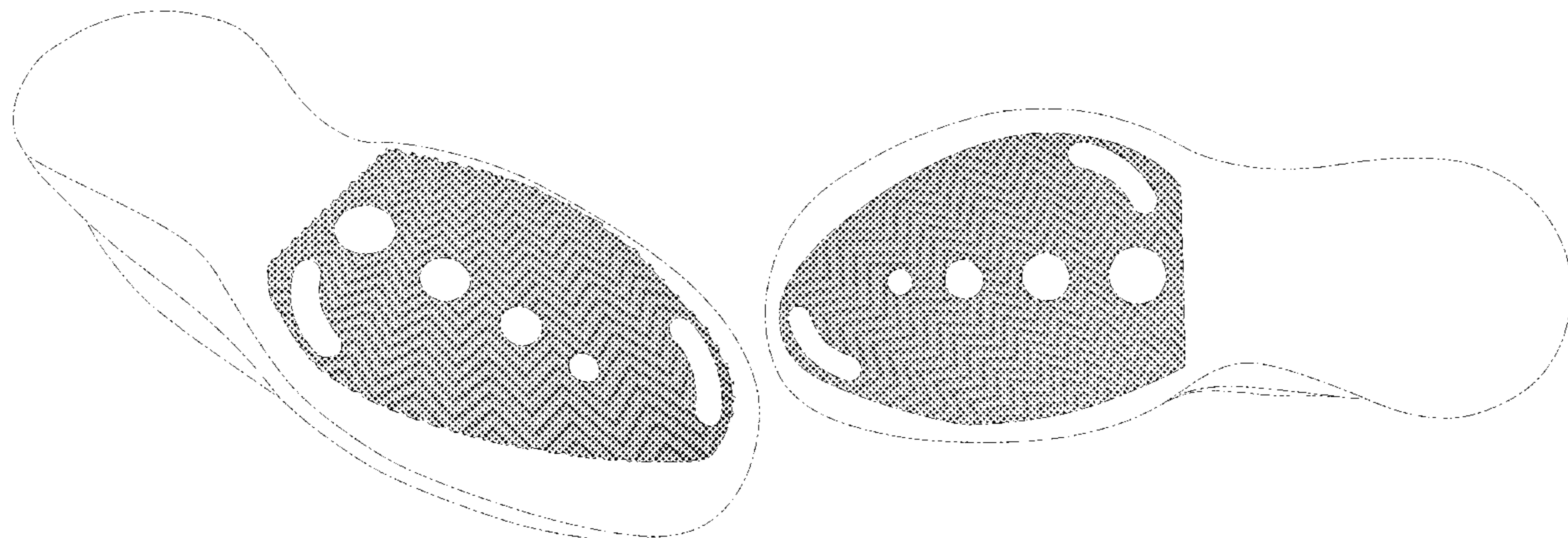

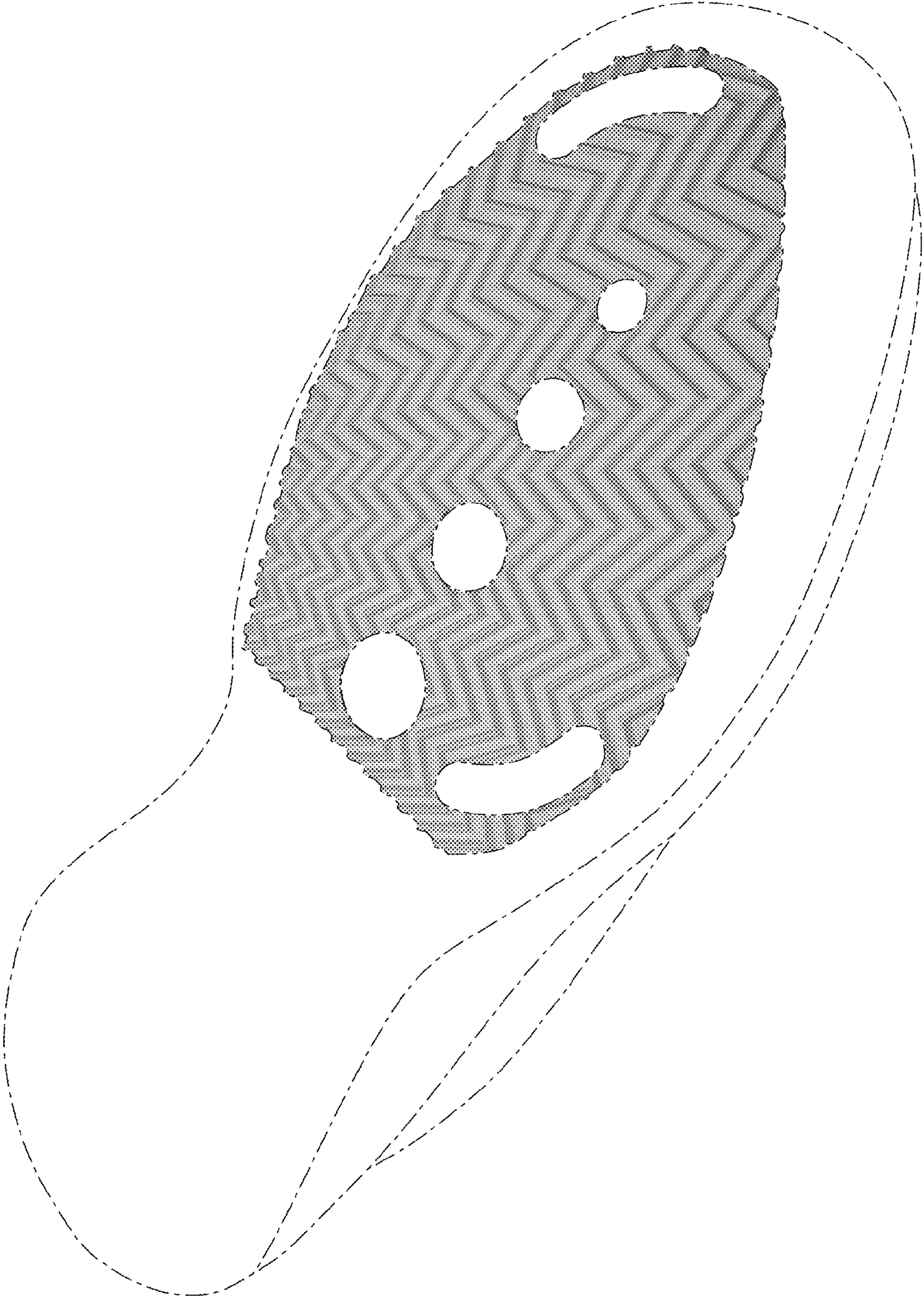
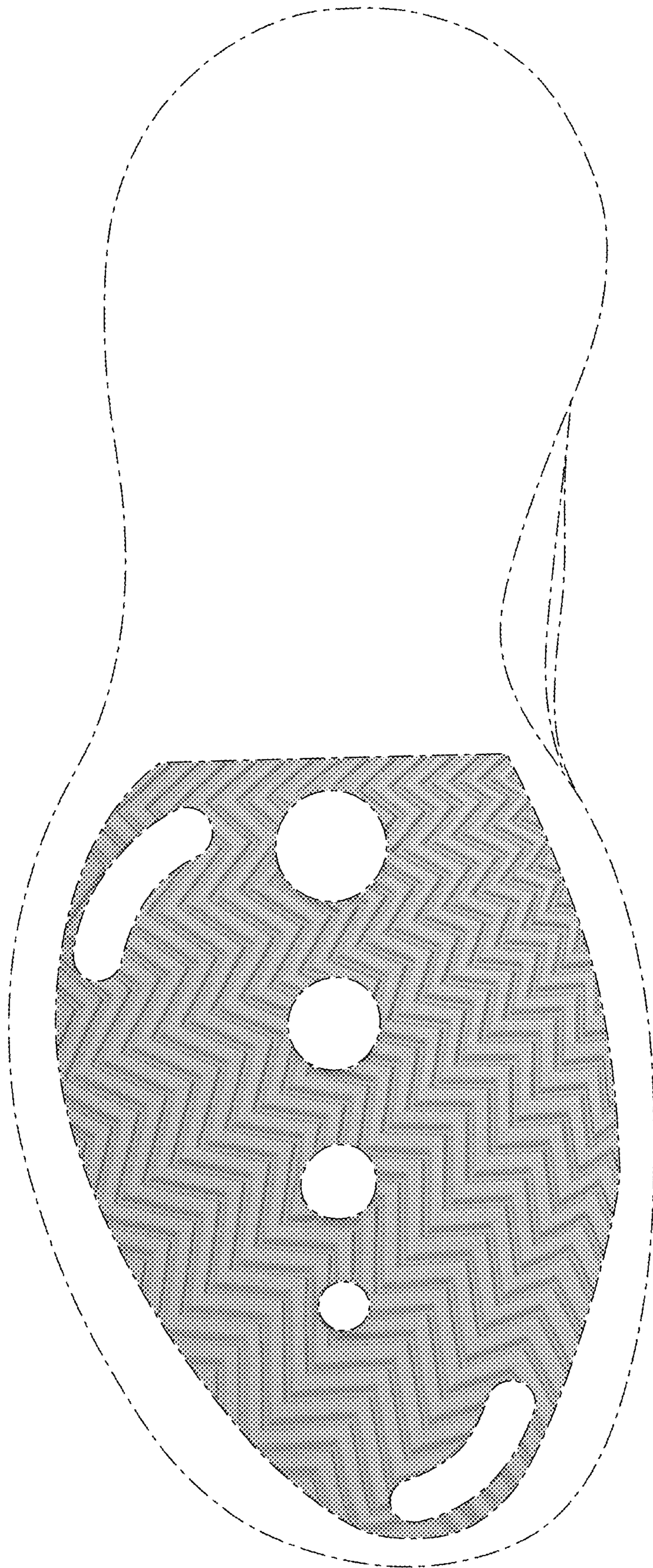

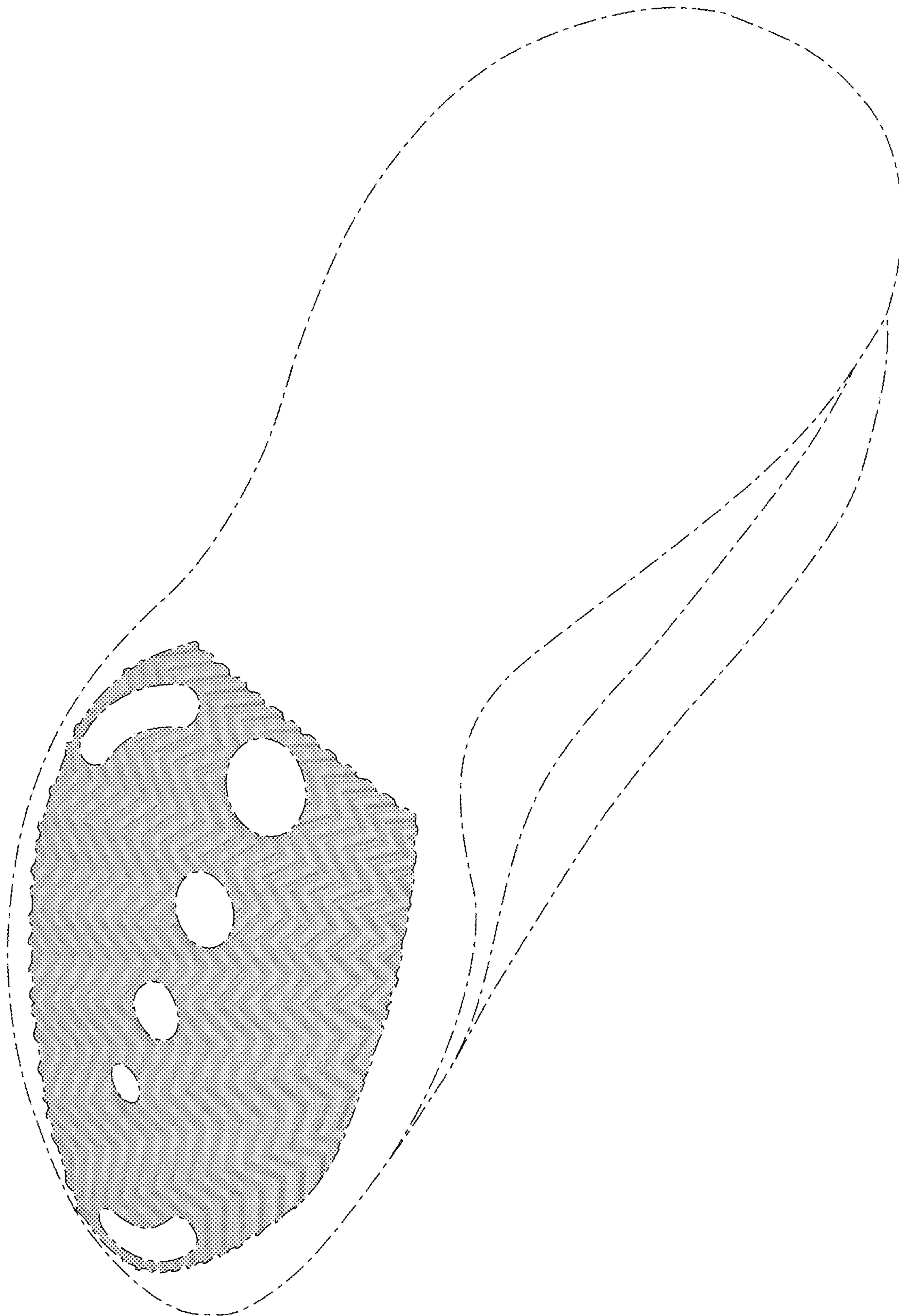
