FIG. 1 is a front perspective view of a shoe showing our new design;

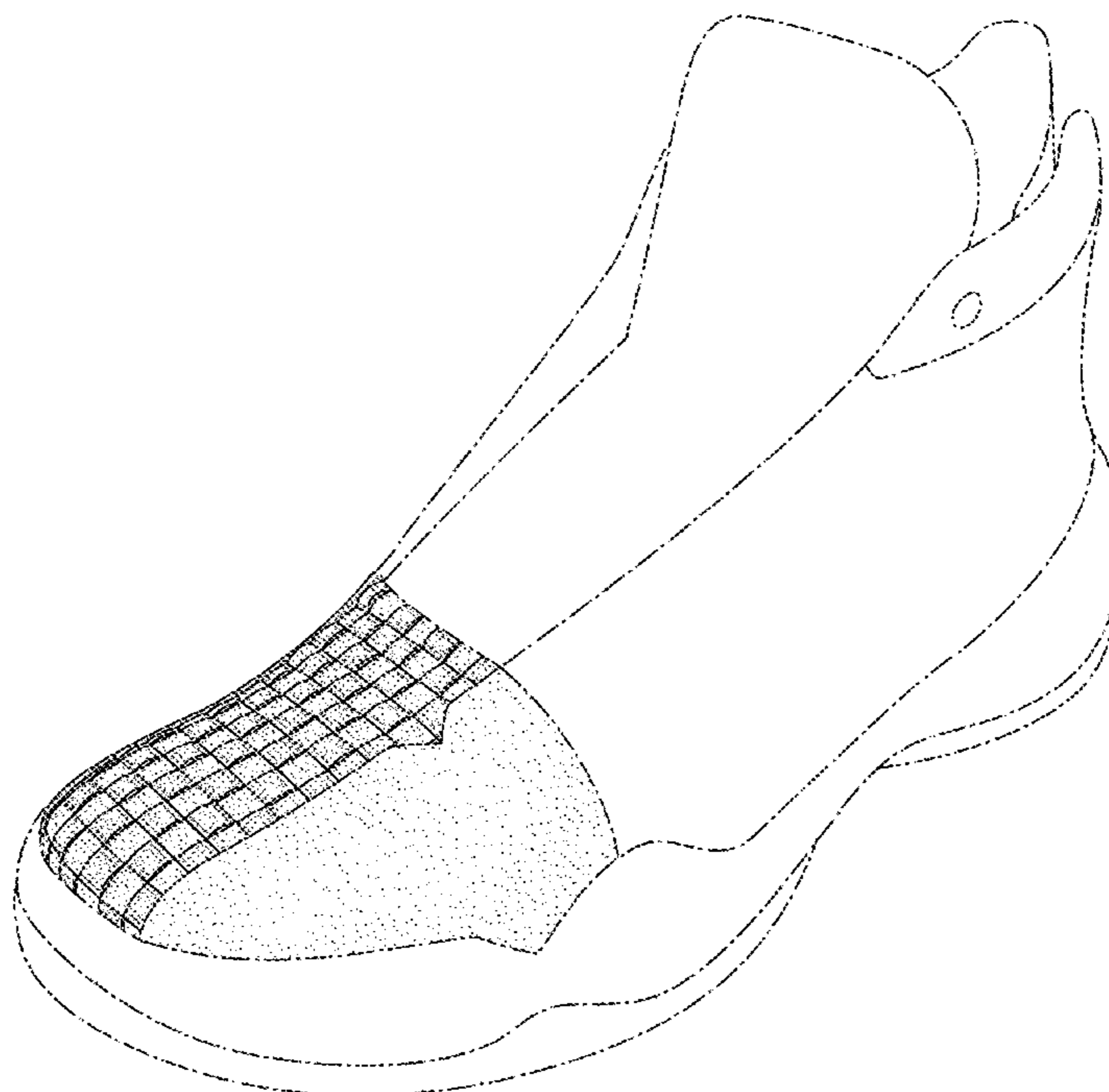
FIG. 2 is a second front perspective view thereof;

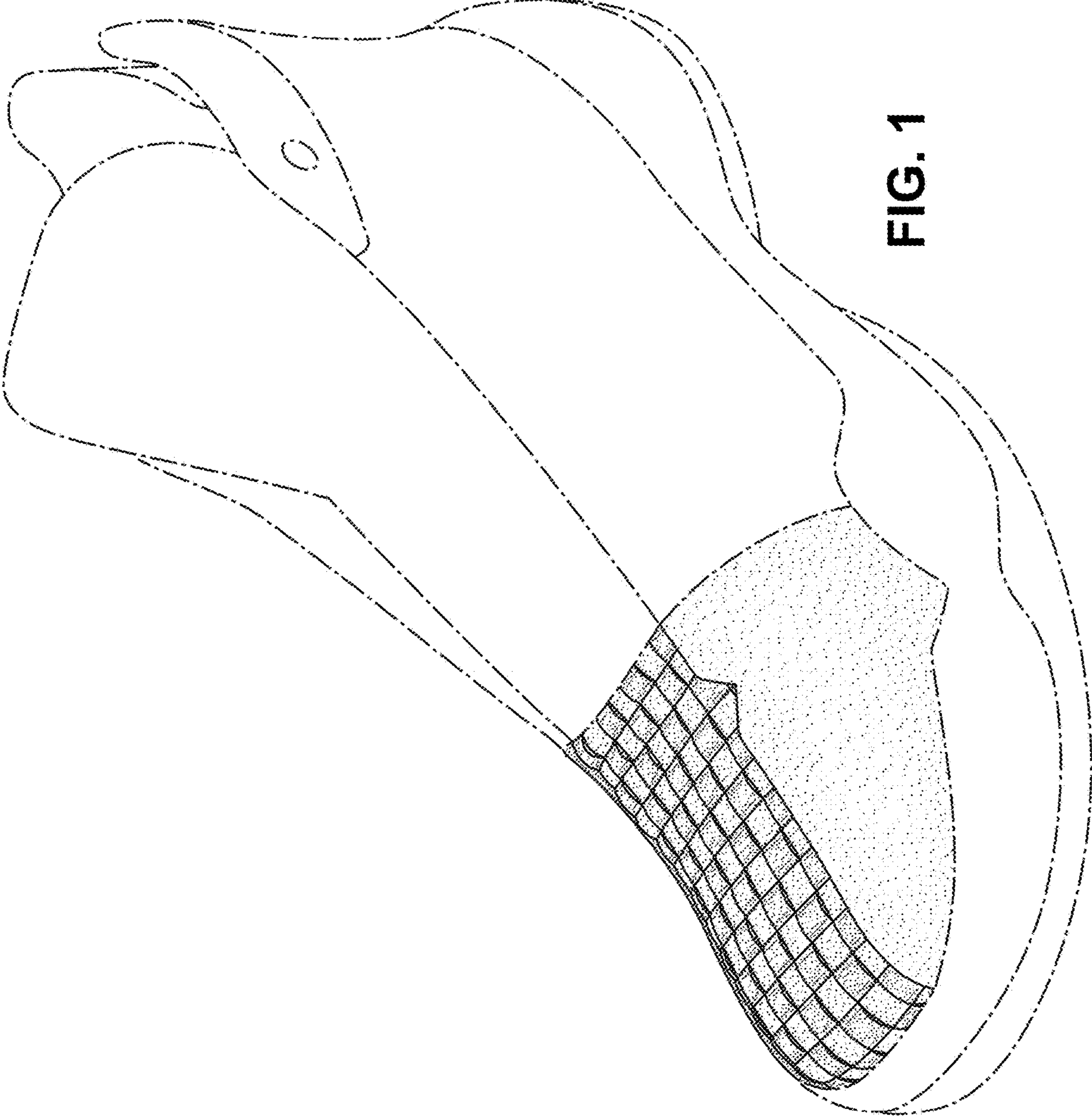

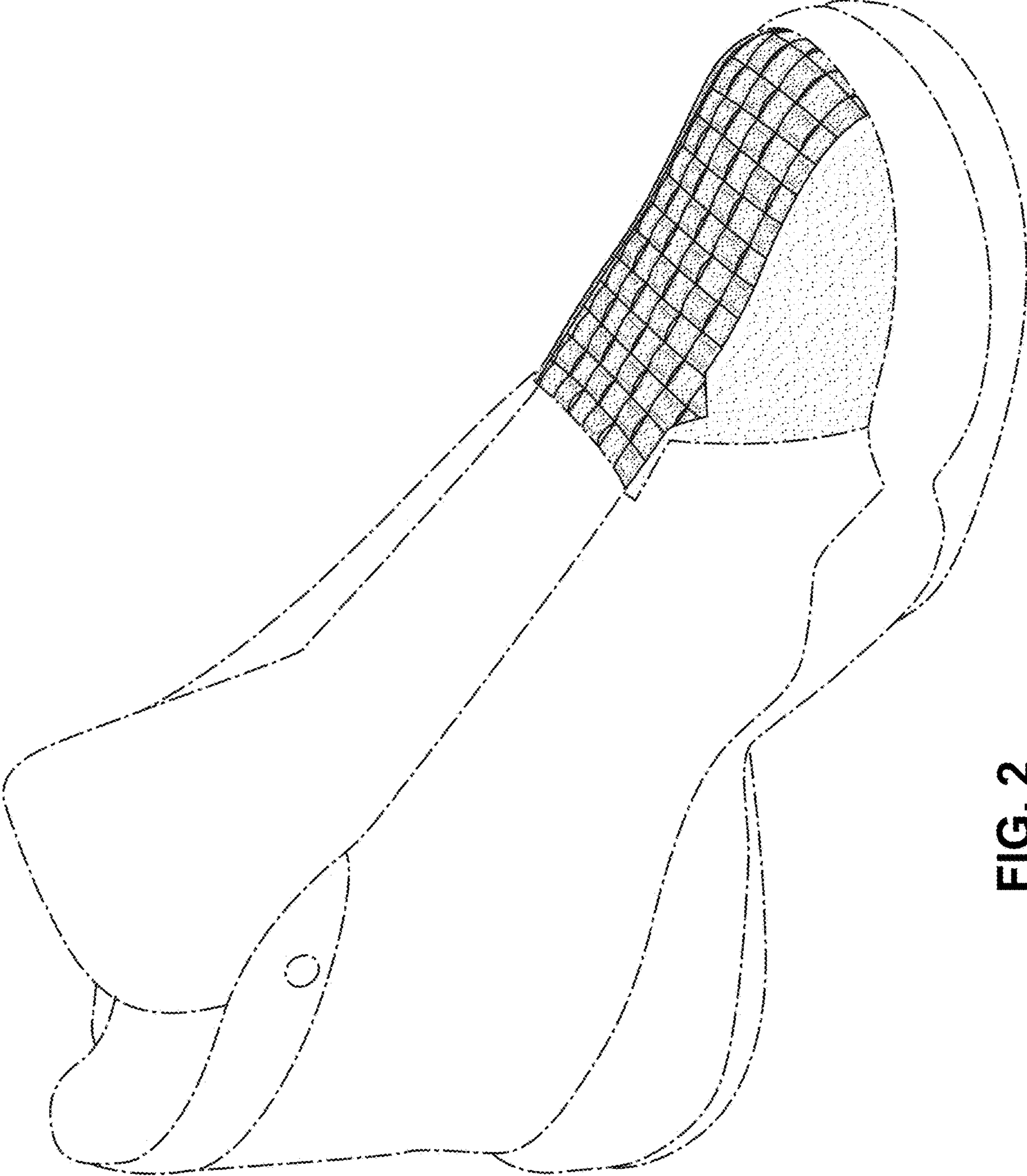

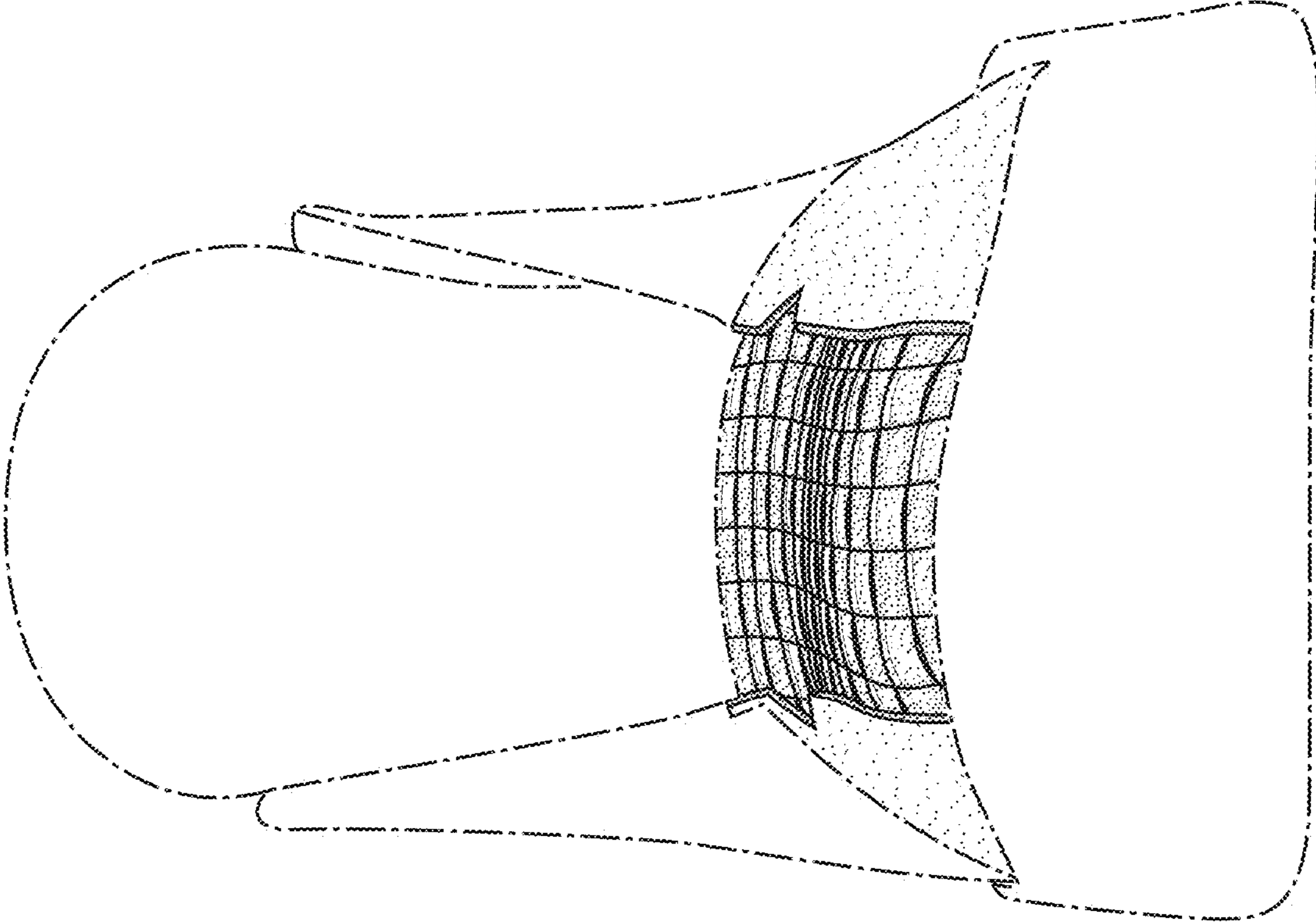

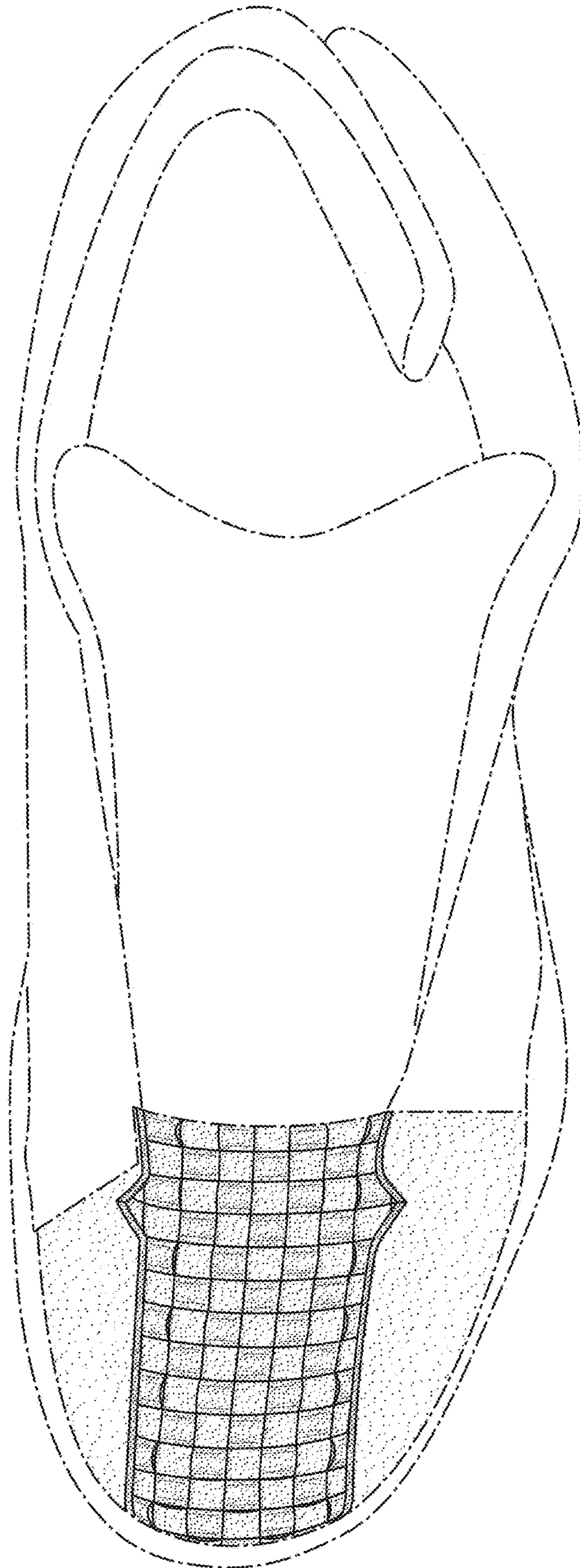
