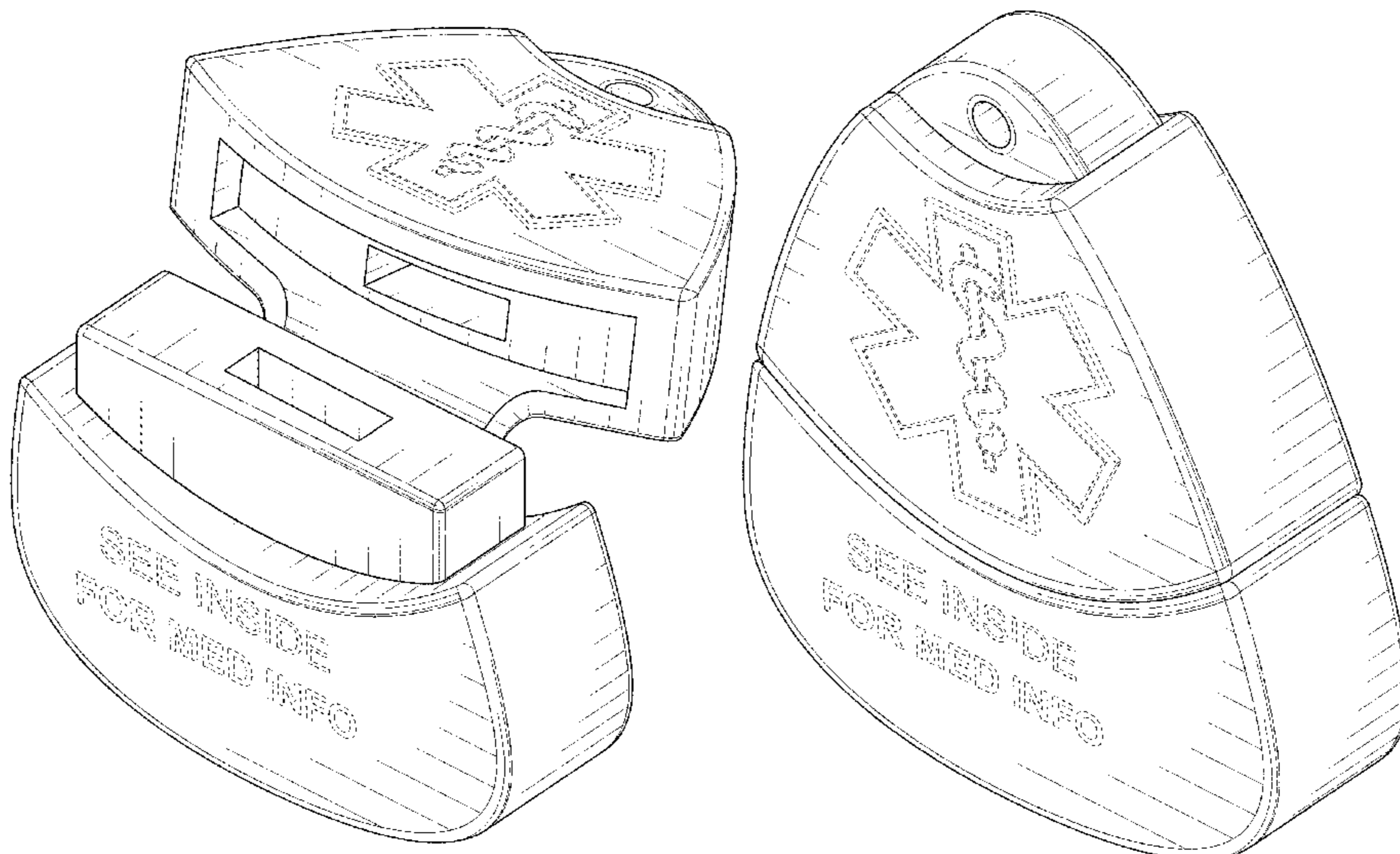
(57) **CLAIM**

The ornamental design for a medical alert keychain pendant with a USB and engraved plate pocket, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a medical alert keychain pendant with a USB and engraved place pocket, showing my new design in an open configuration; FIG. 2 is a rear perspective view of FIG. 1; FIG. 3 is a front perspective view thereof, illustrated in a closed configuration; FIG. 4 is a rear perspective view of FIG. 3; FIG. 5 is a front elevational view of FIG. 3; FIG. 6 is a rear elevational view of FIG. 3; FIG. 7 is a right-side elevational view of FIG. 3, the left-side elevational view being a mirror image thereof; FIG. 8 is a top plan view of FIG. 3; and, FIG. 9 is a bottom plan view of FIG. 3. The broken lines showing a raised logo and text in the figures depict environmental matter and form no part of the claimed design.

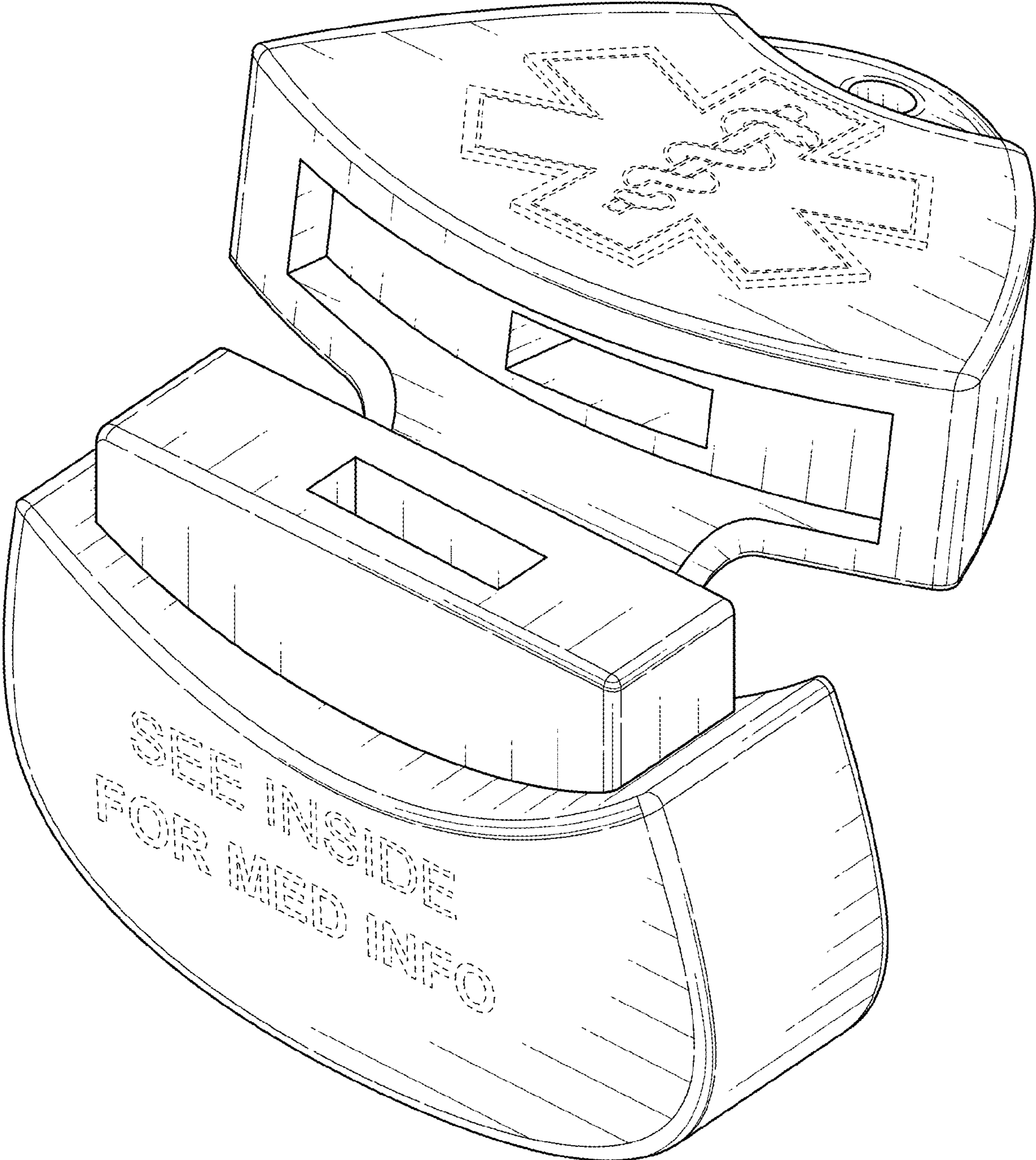

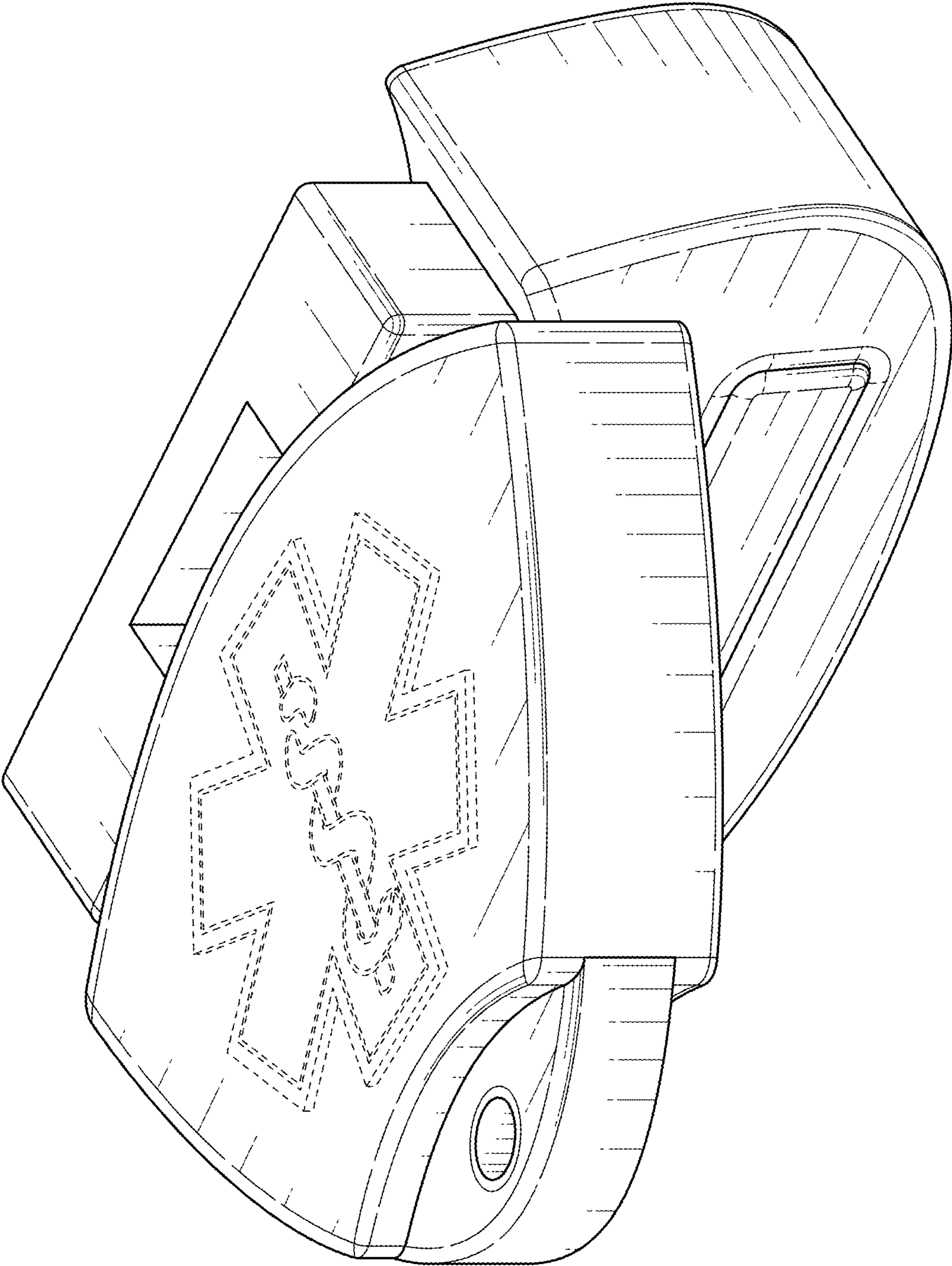

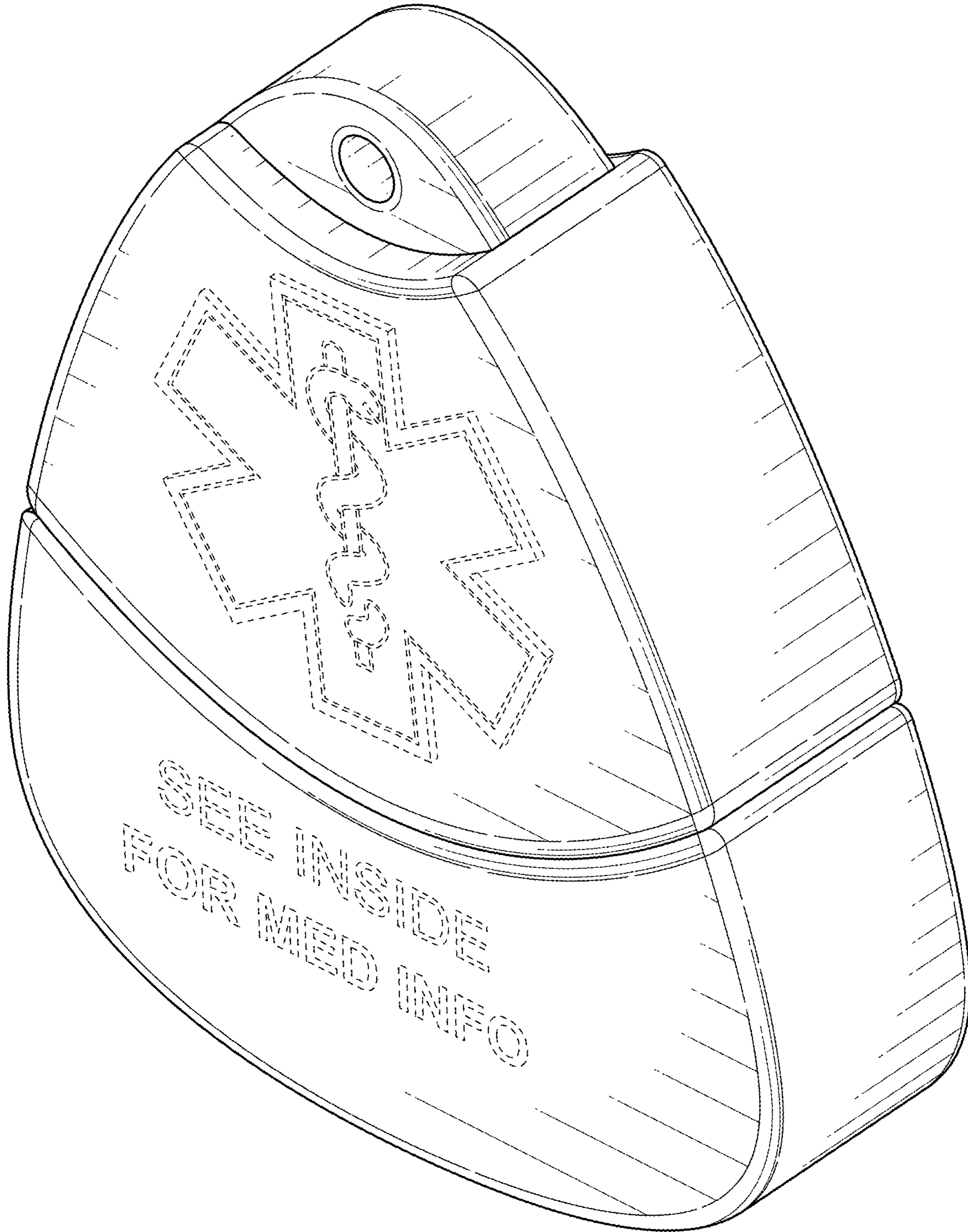

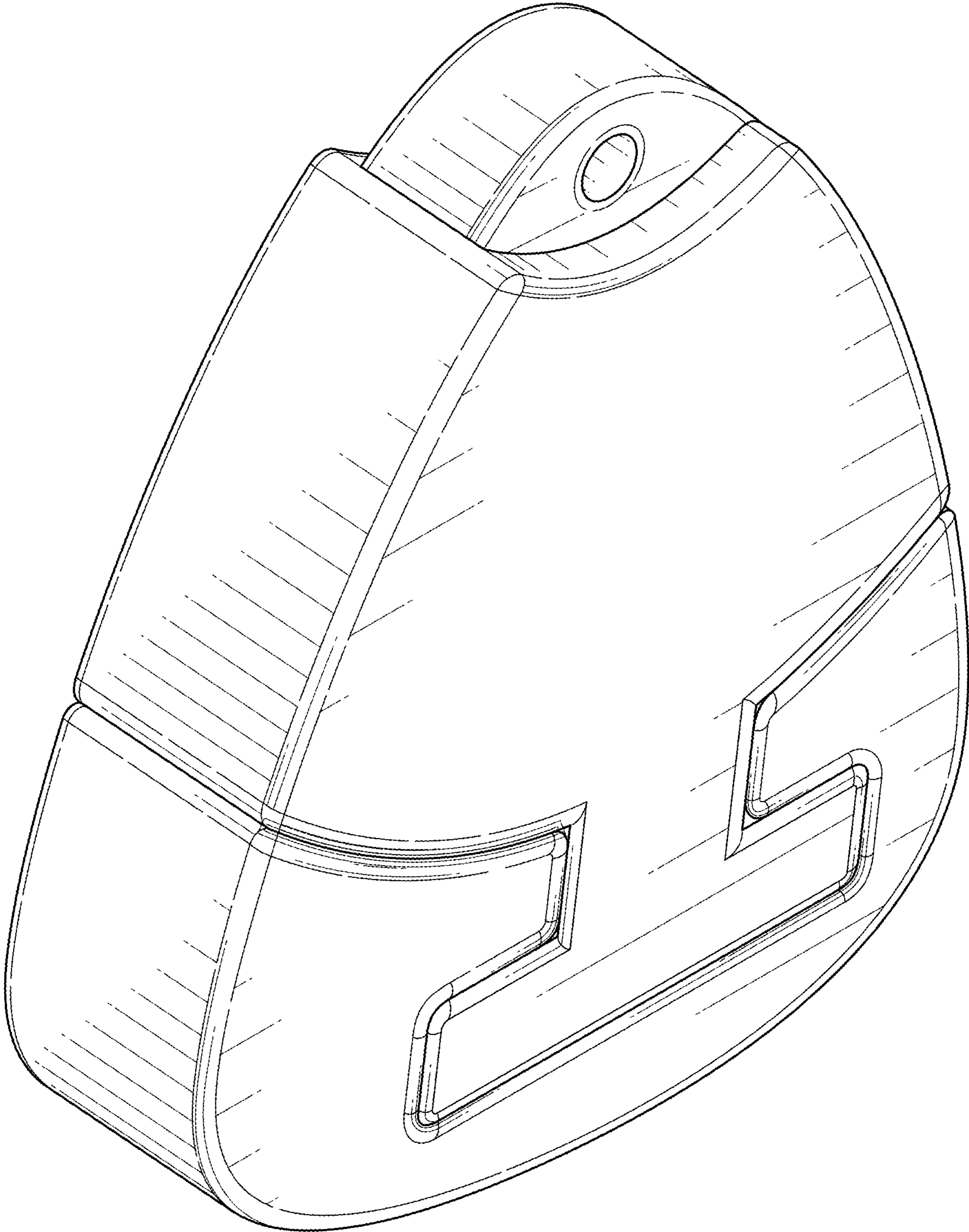

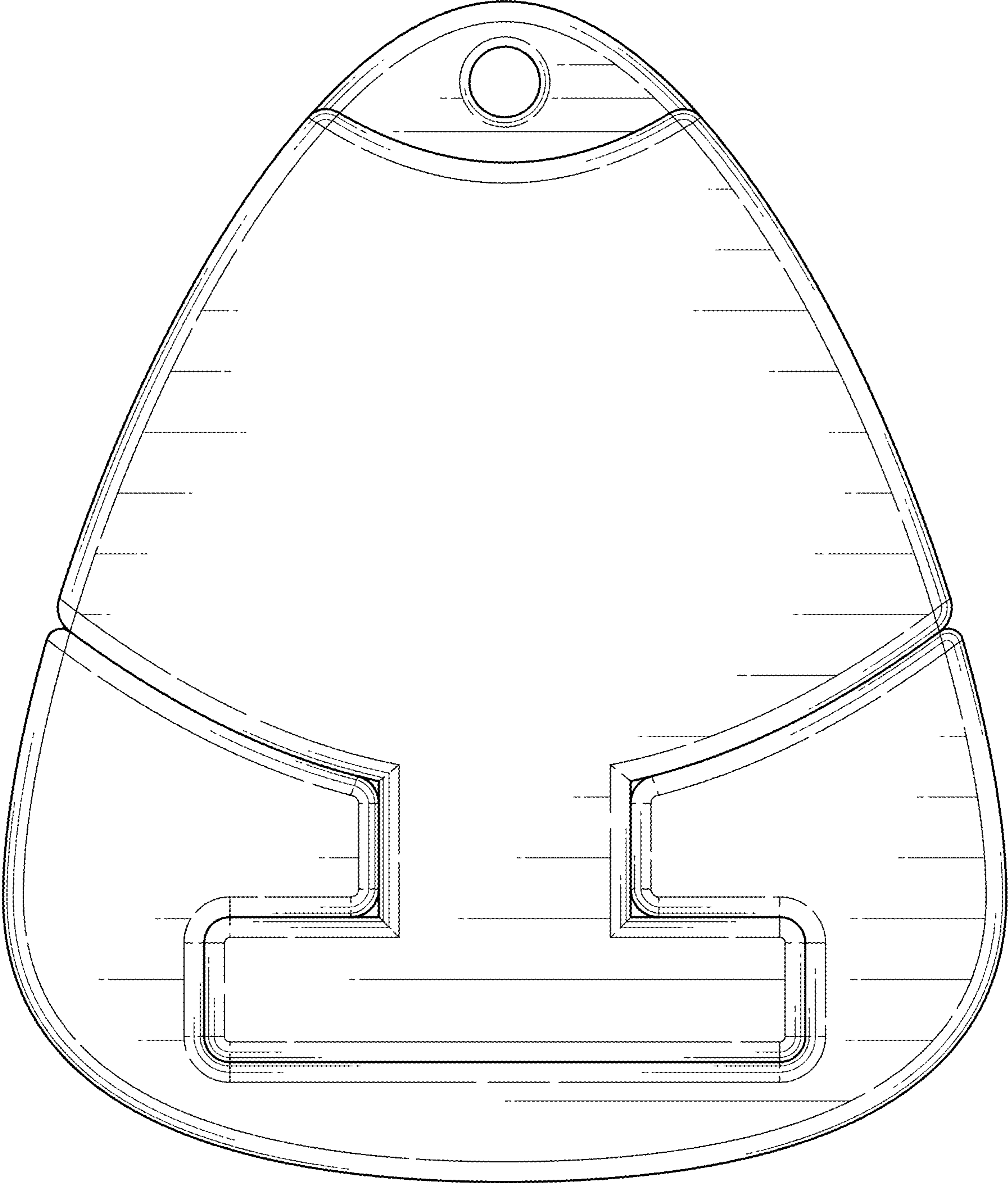

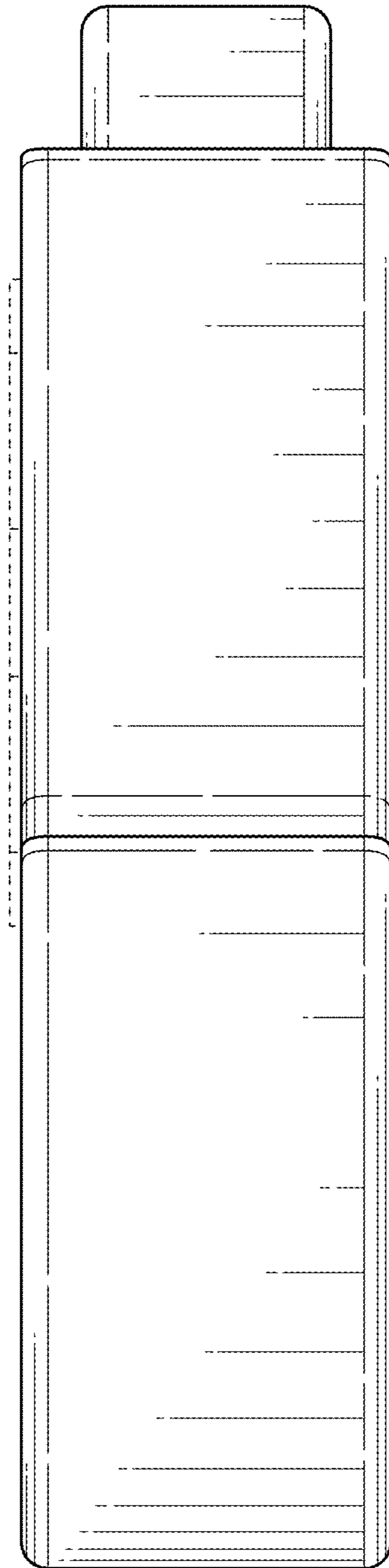

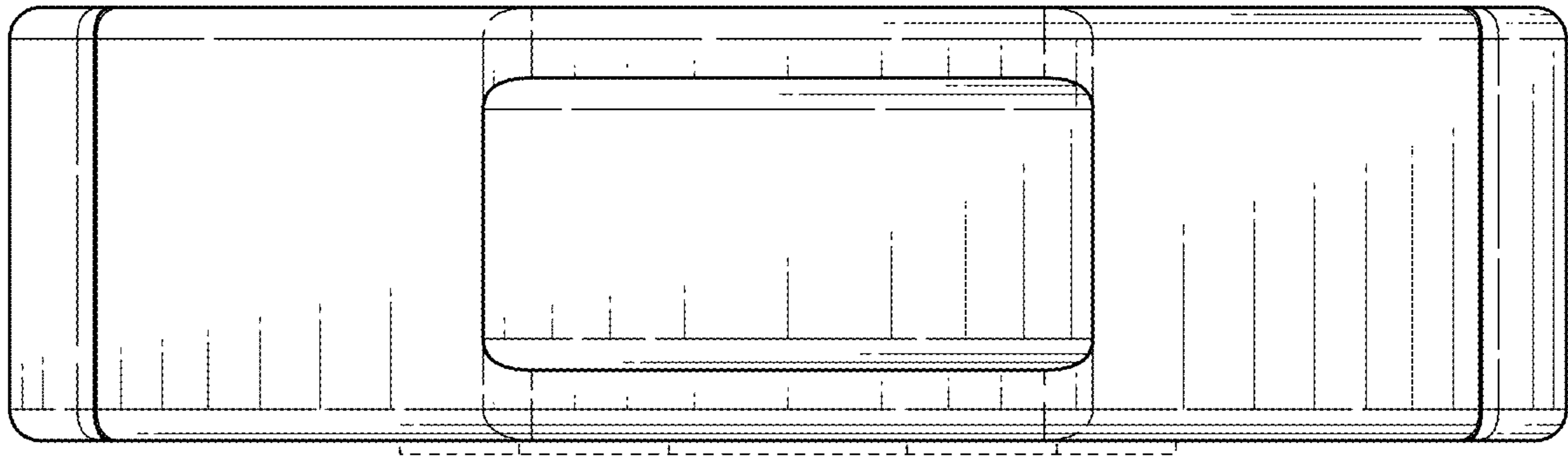

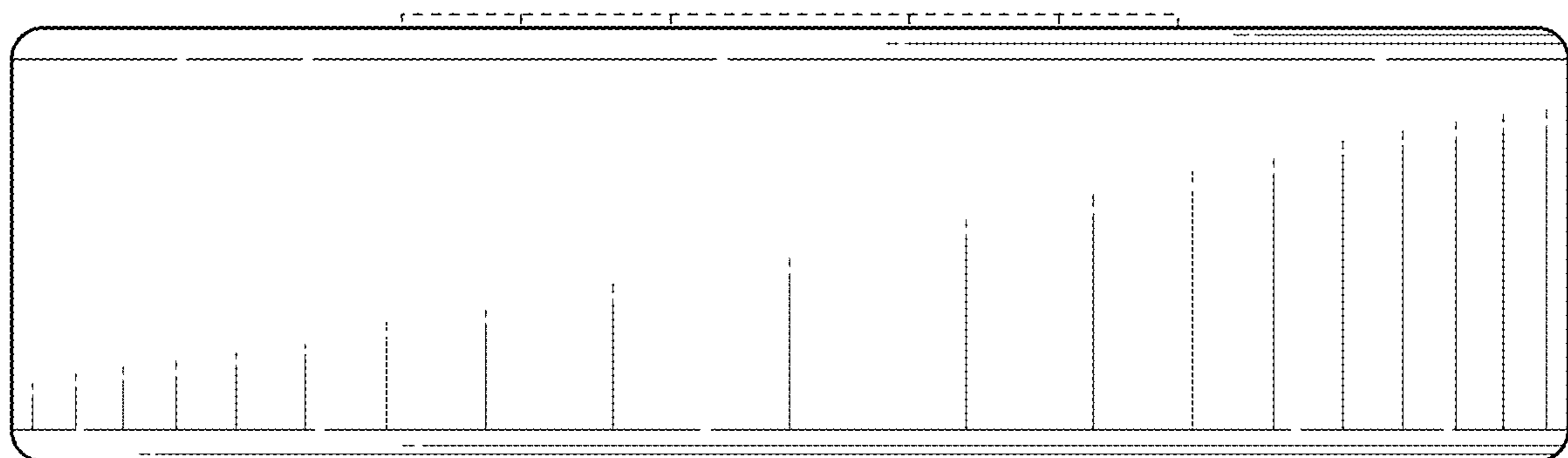
