FIG. 11 is a side elevational view thereof, shown in an open configuration;

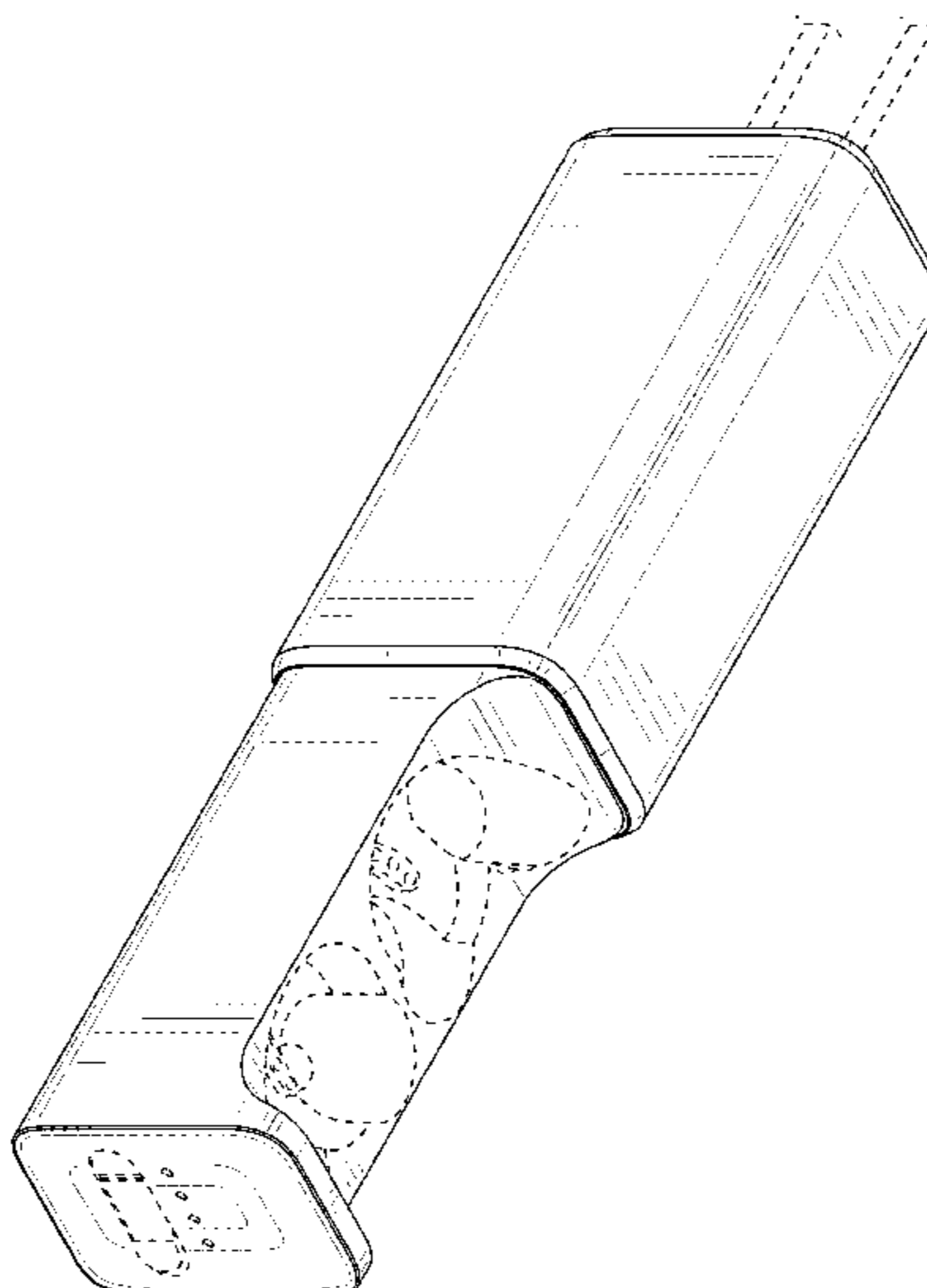
FIG. 12 is an opposite side elevational view thereof, shown in an open configuration;

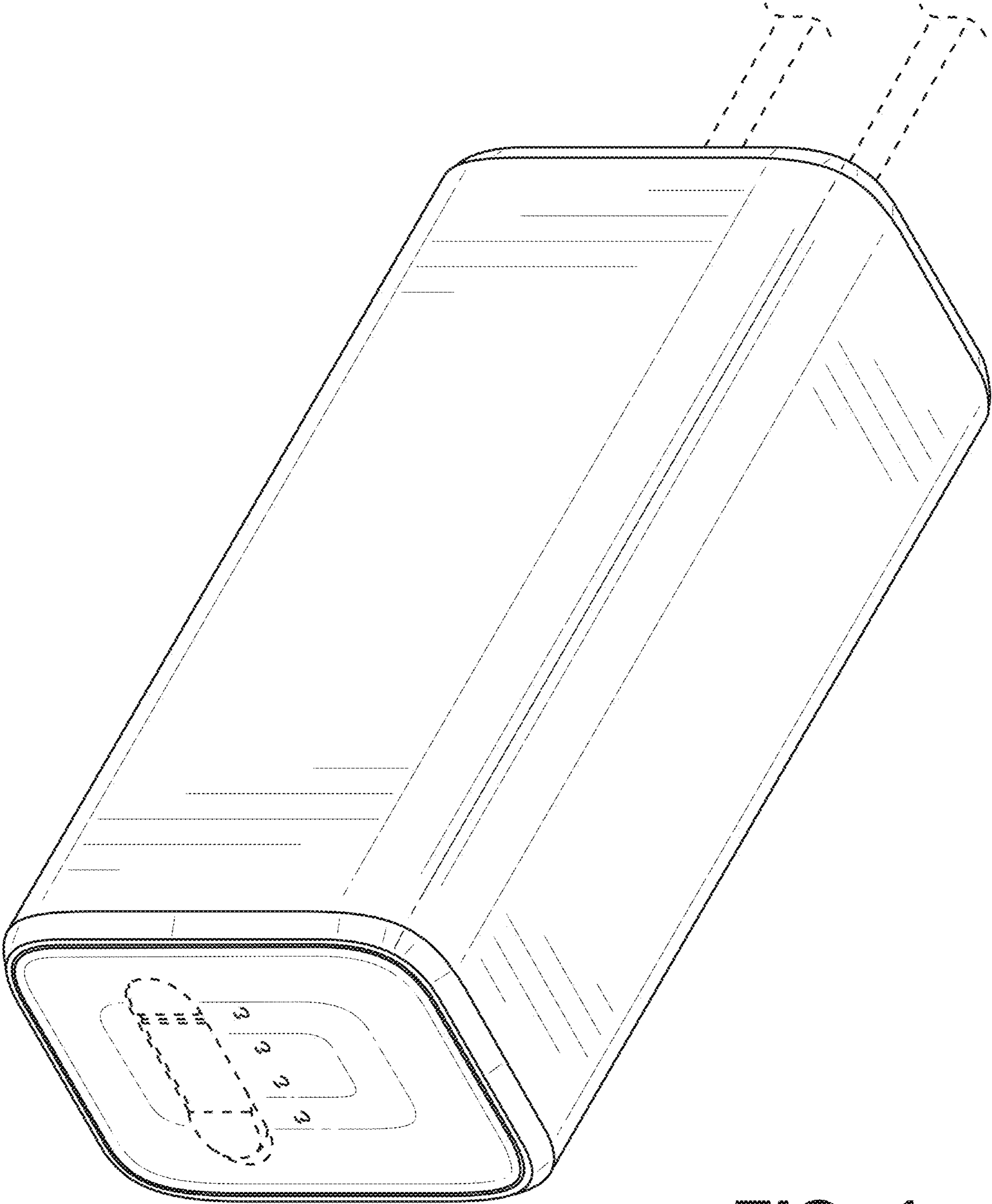

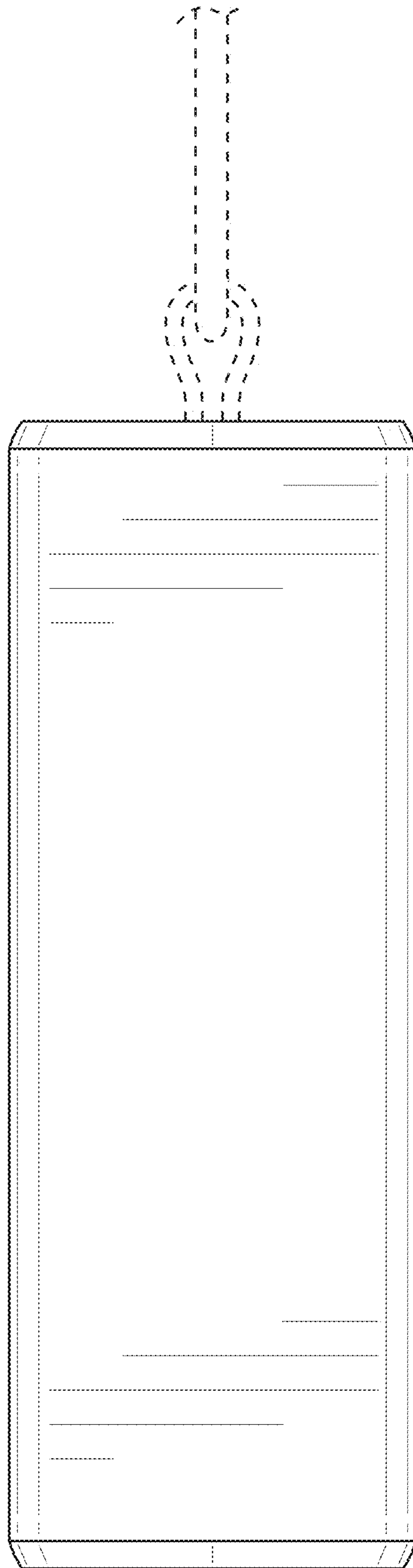

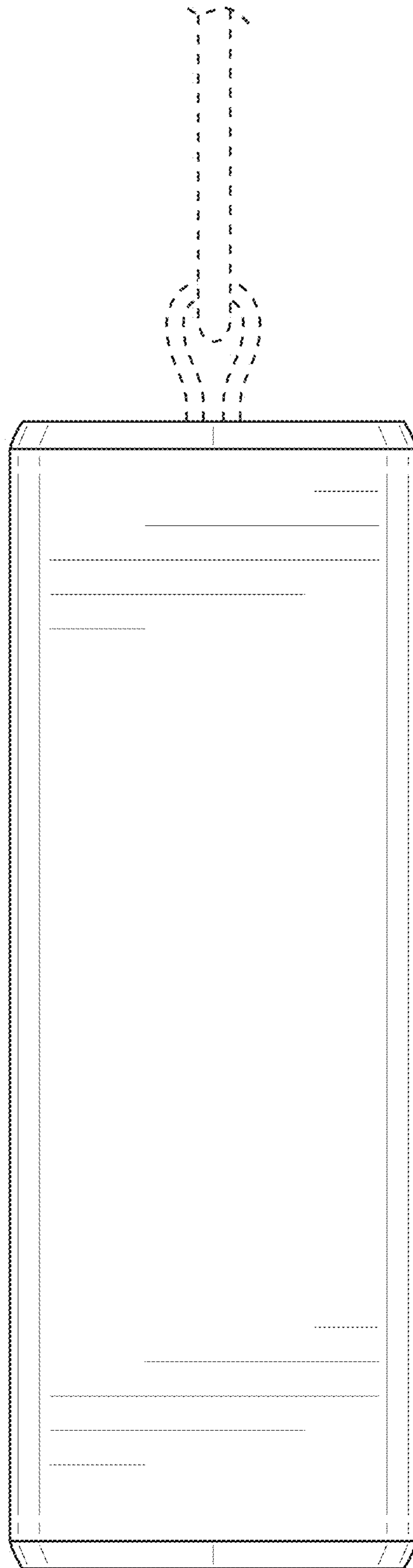

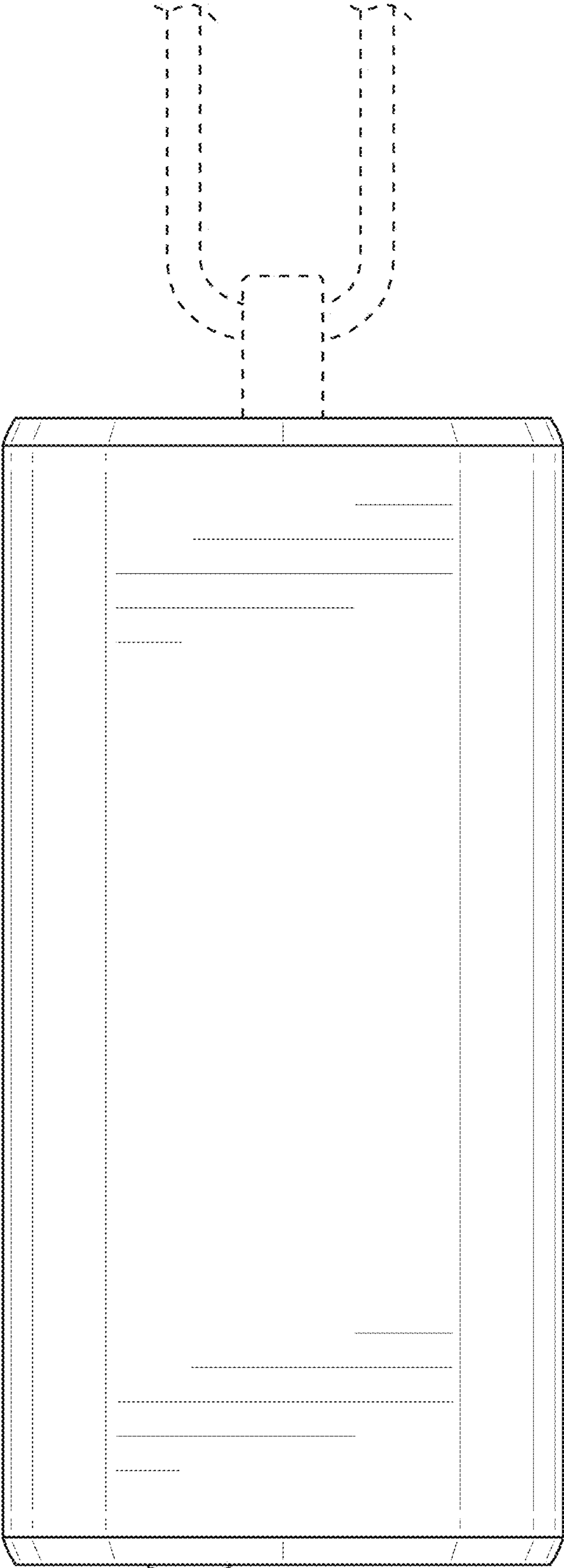

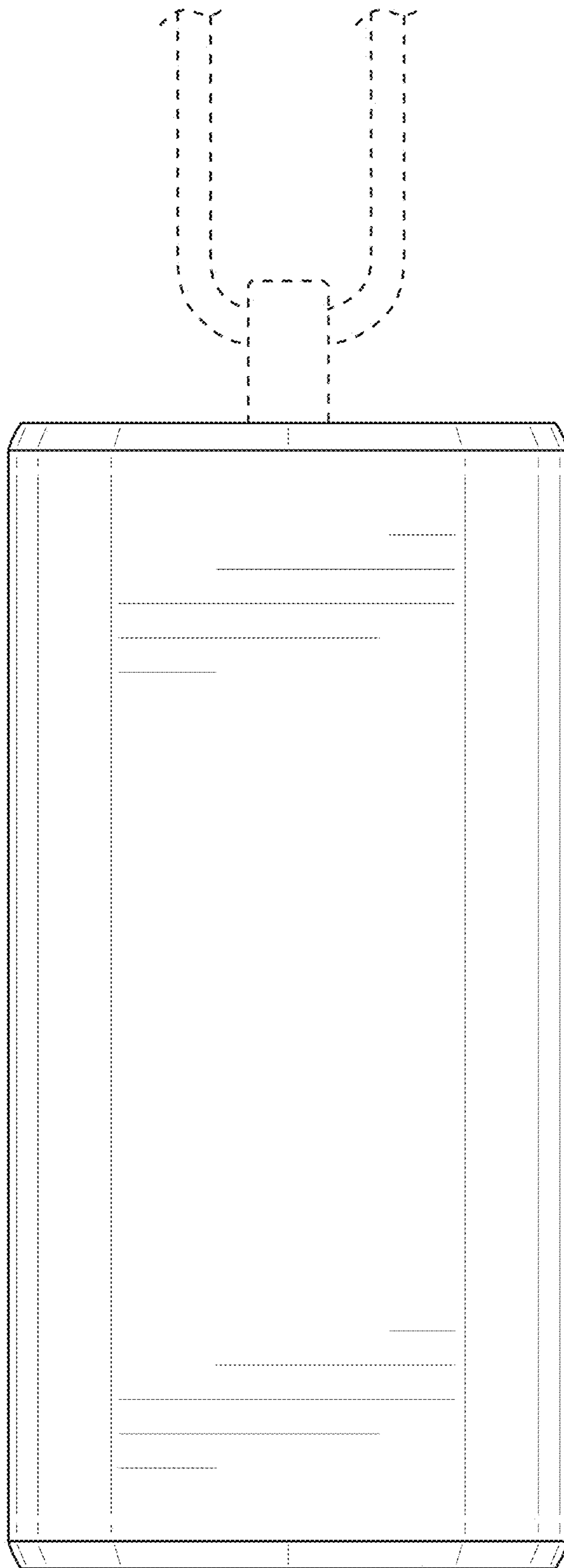

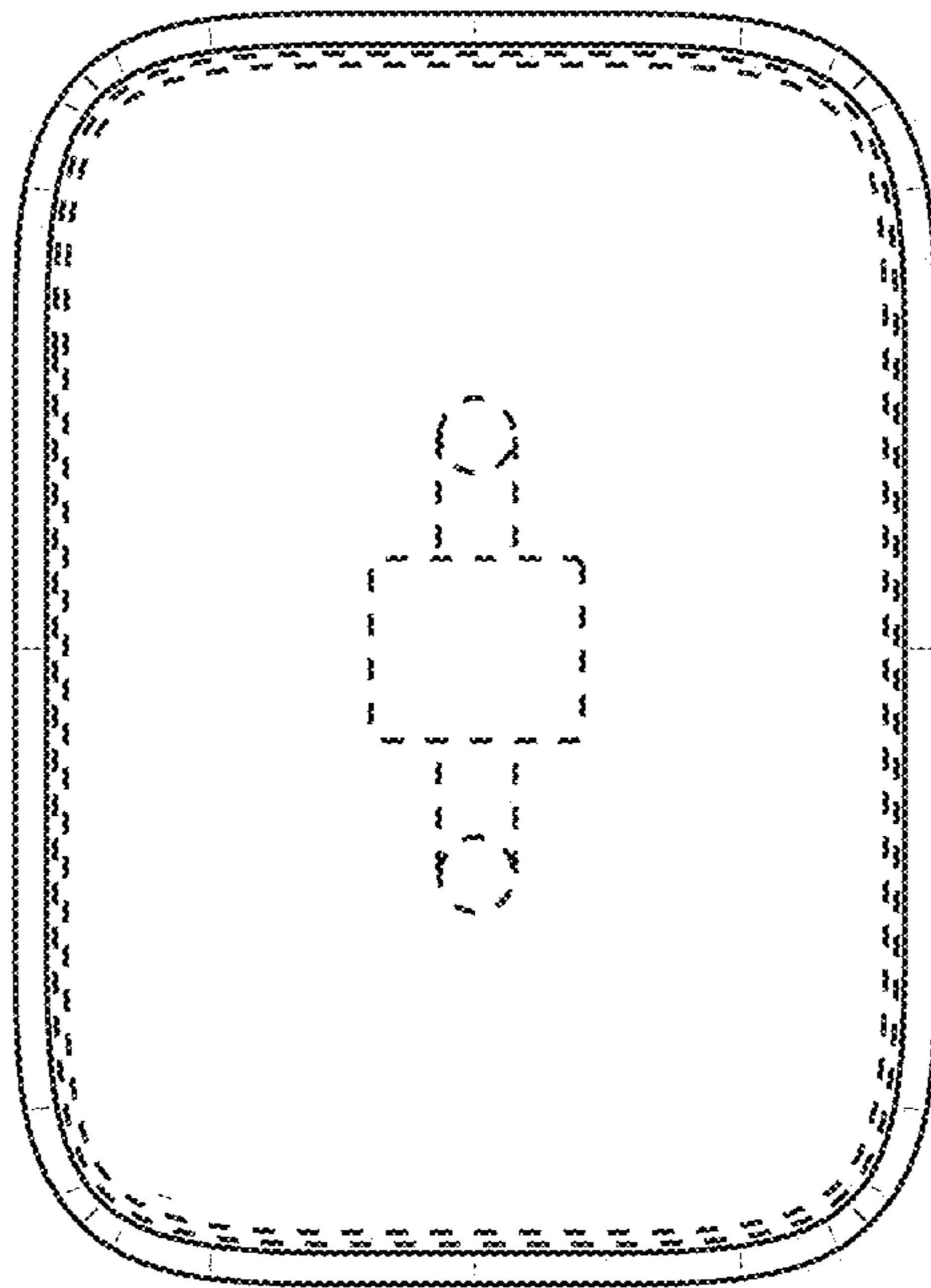

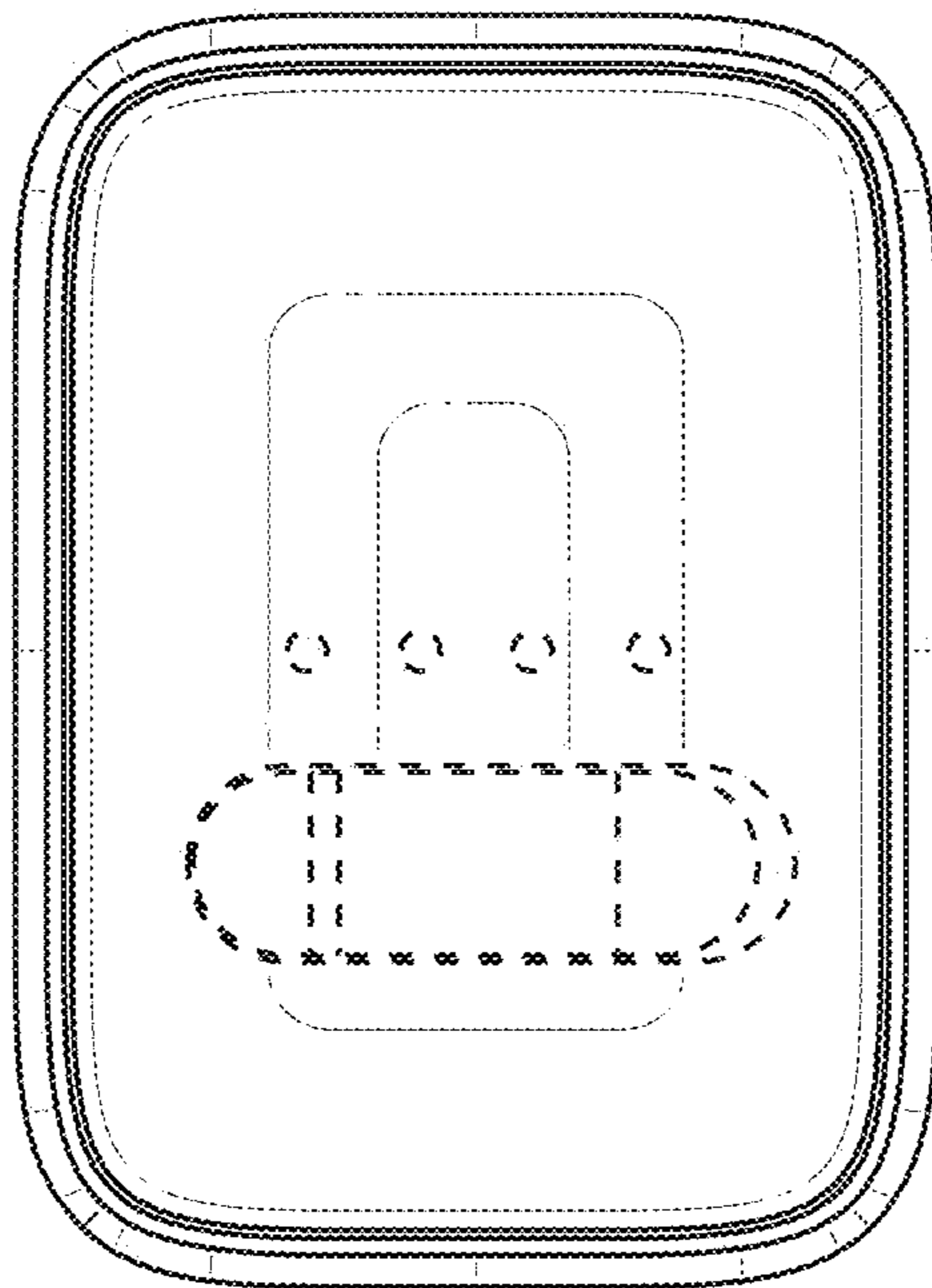

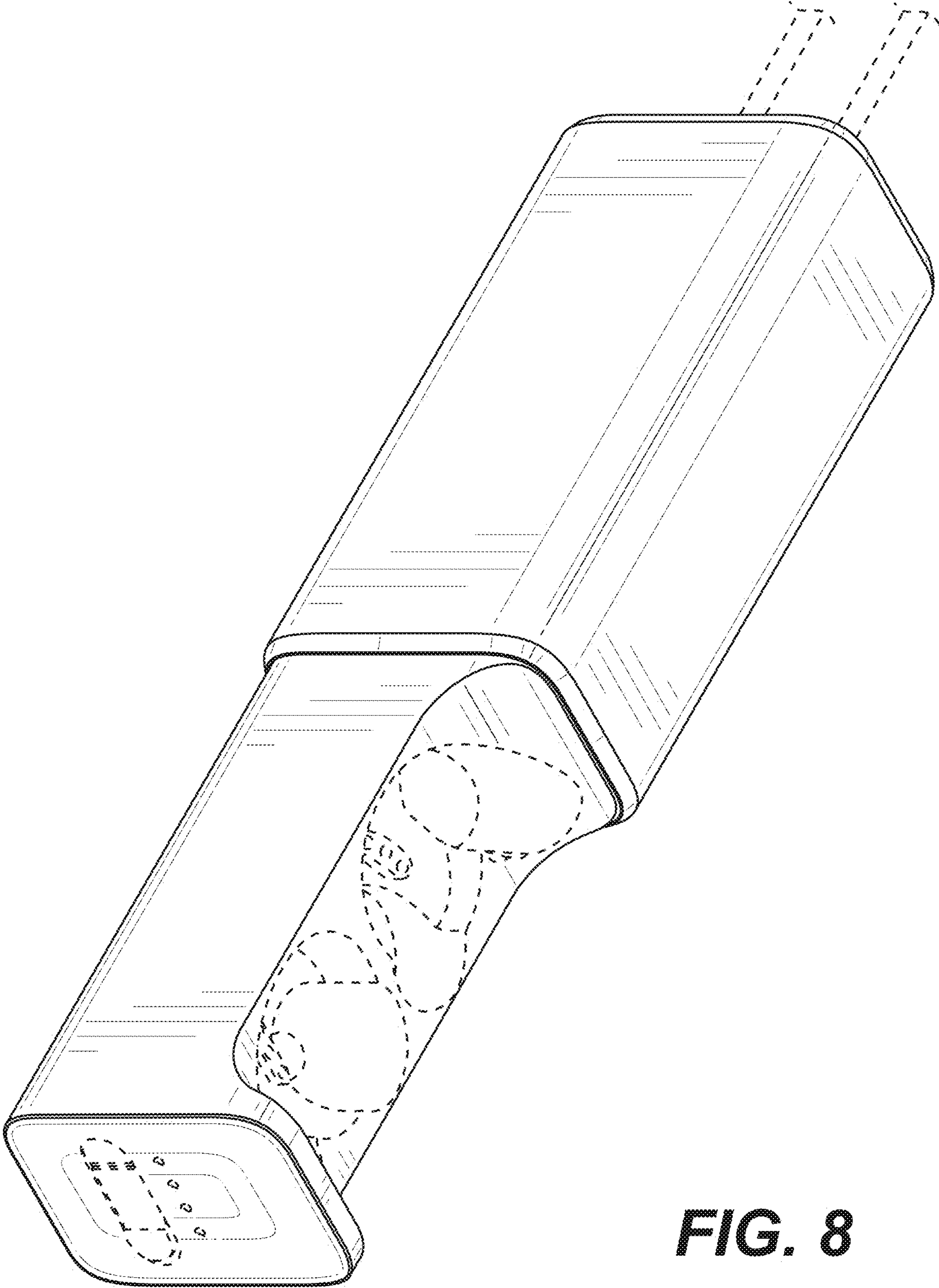

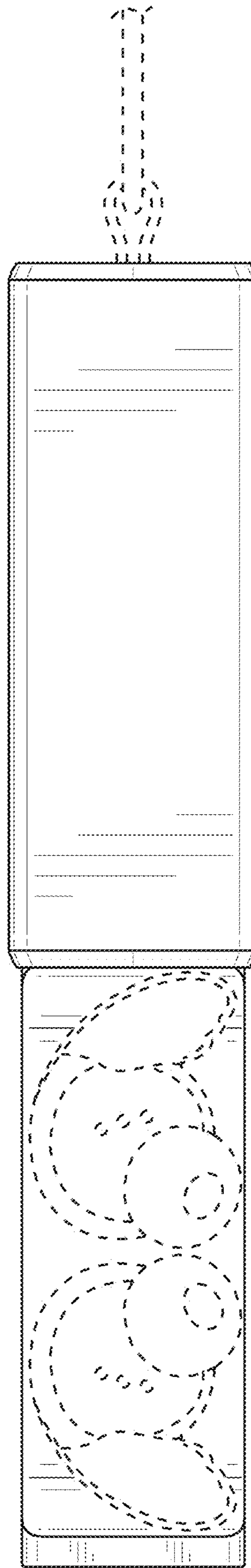

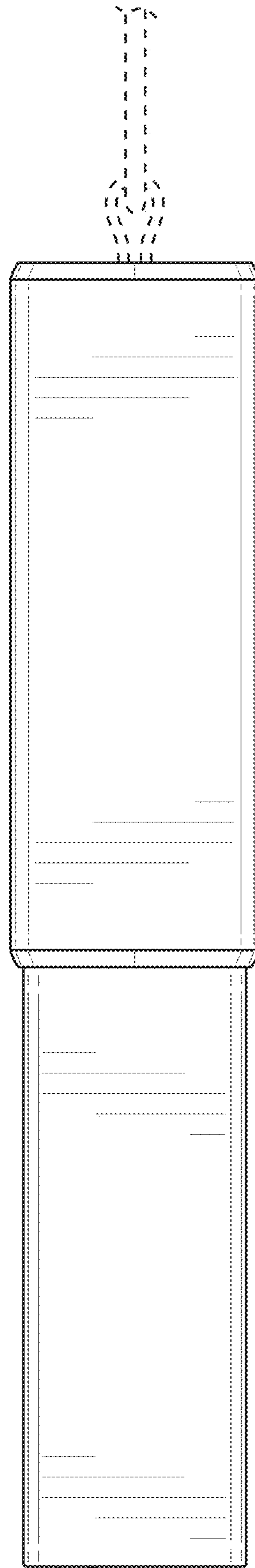

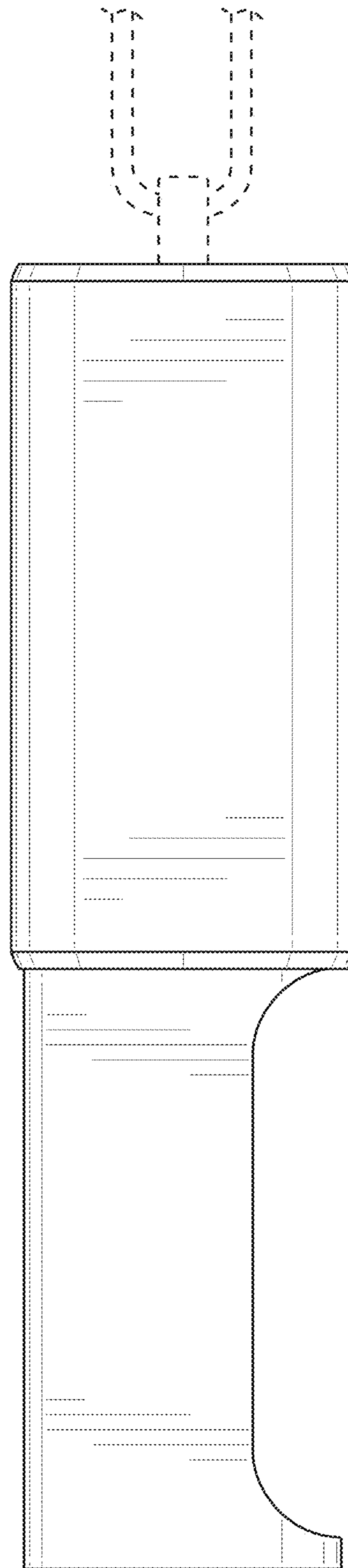

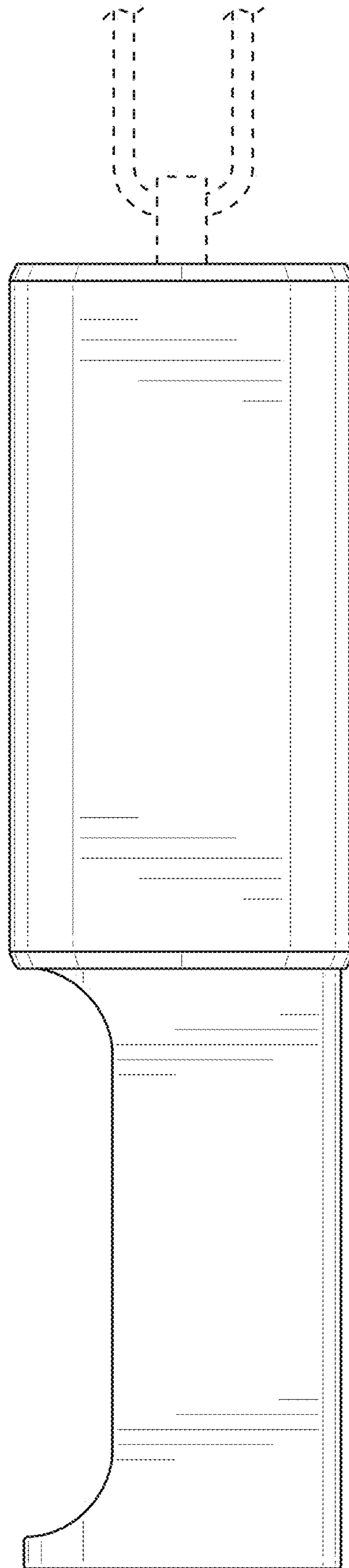

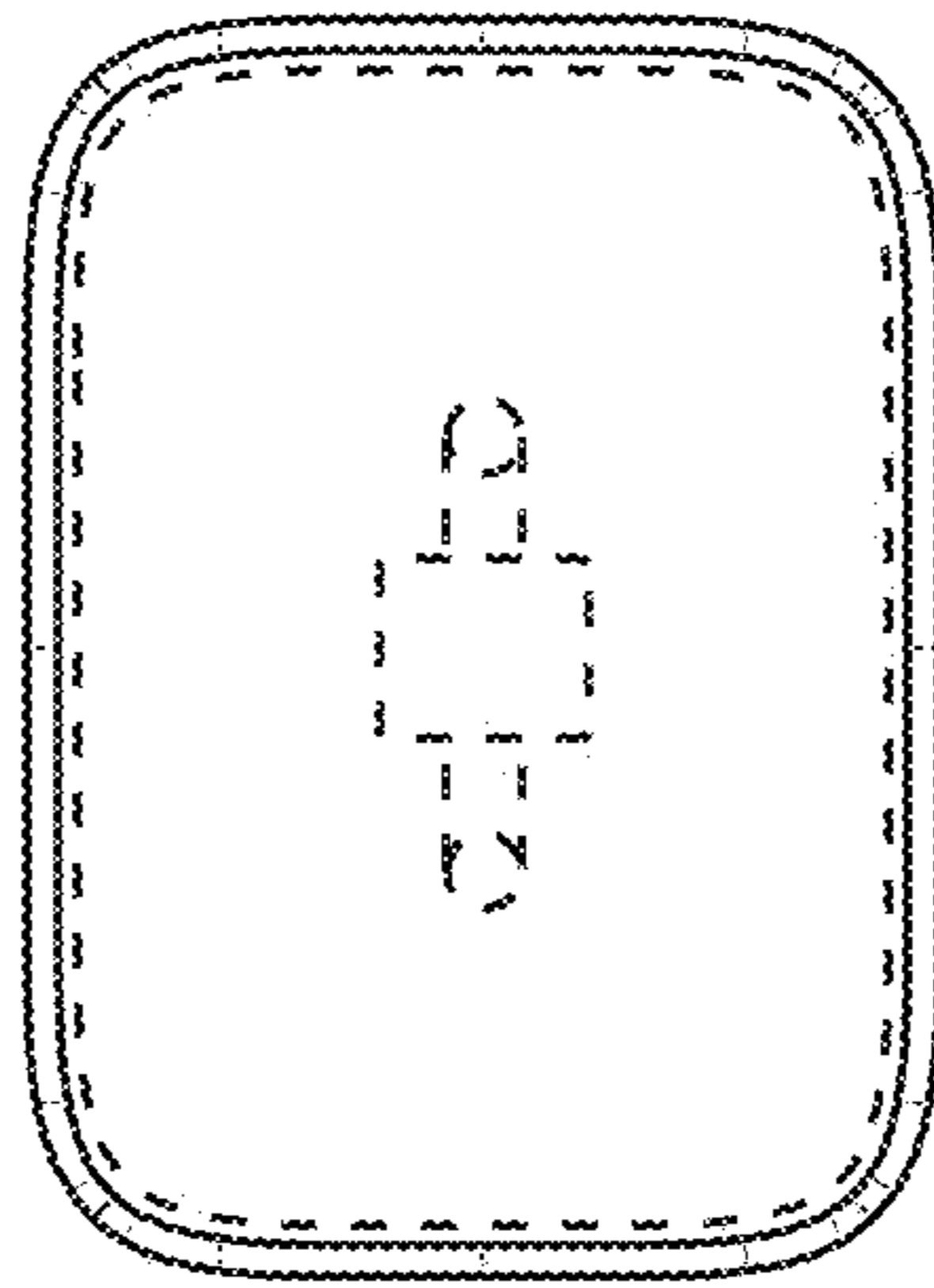

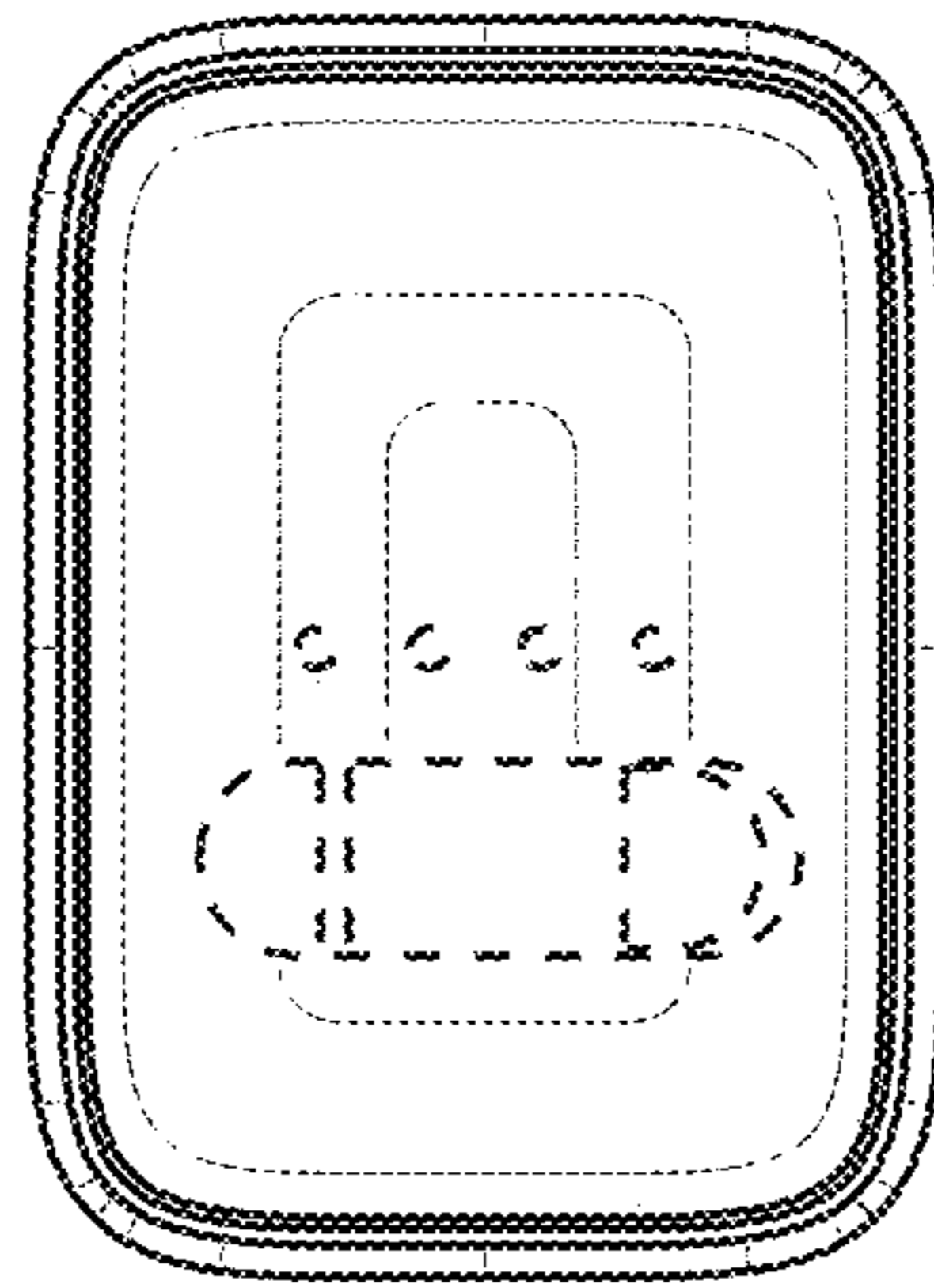
