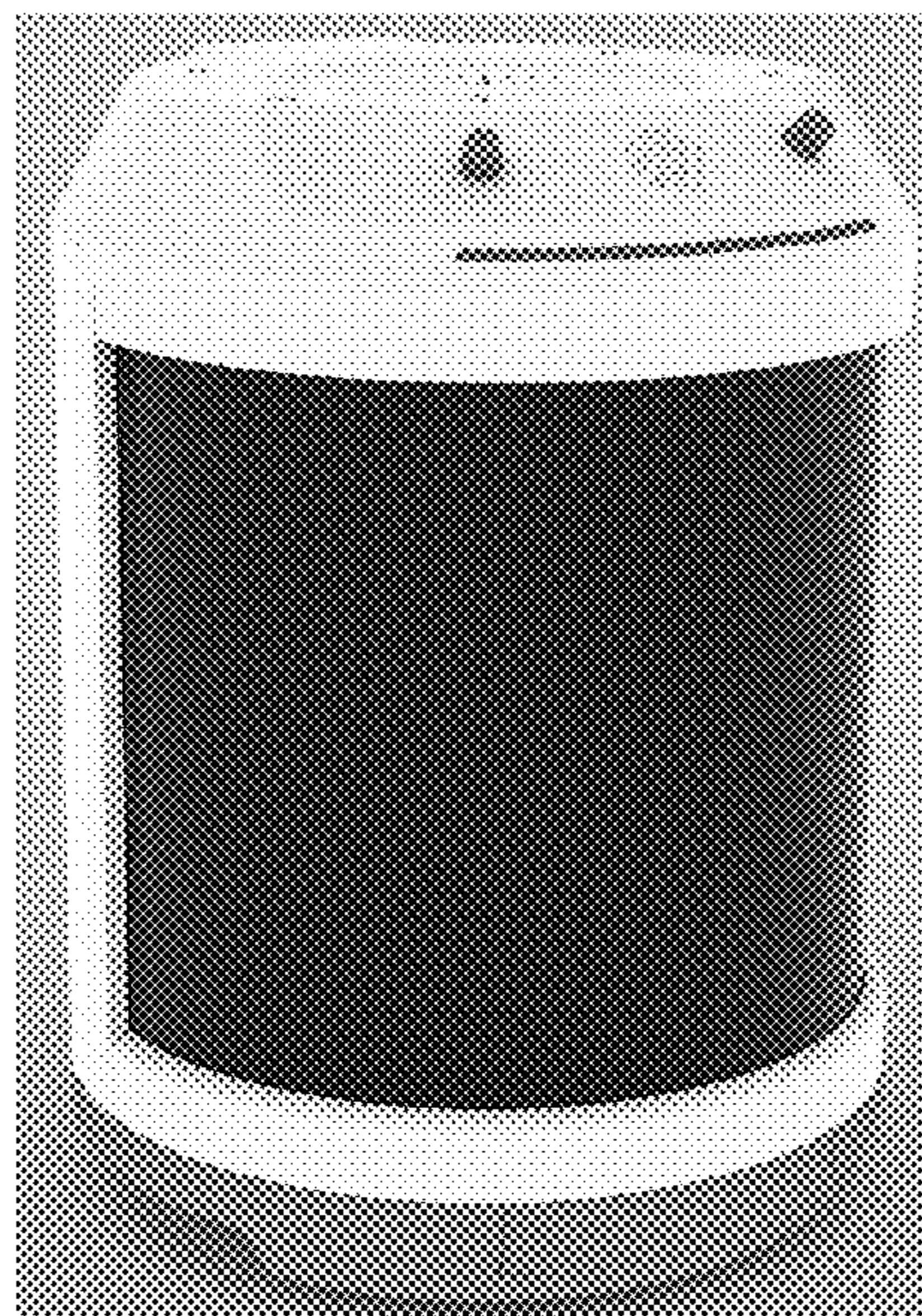
The ornamental design for an oven, as shown and described.

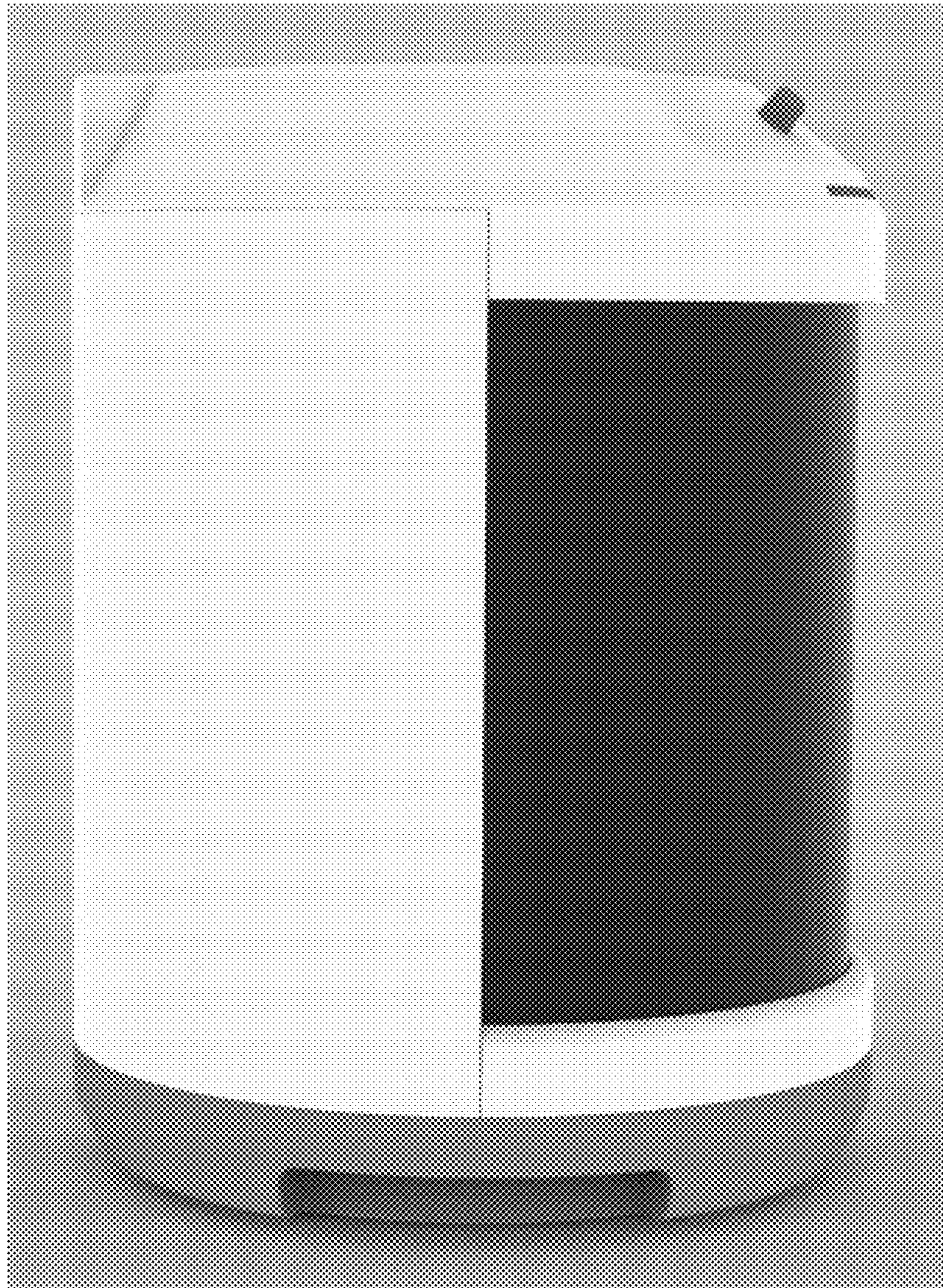

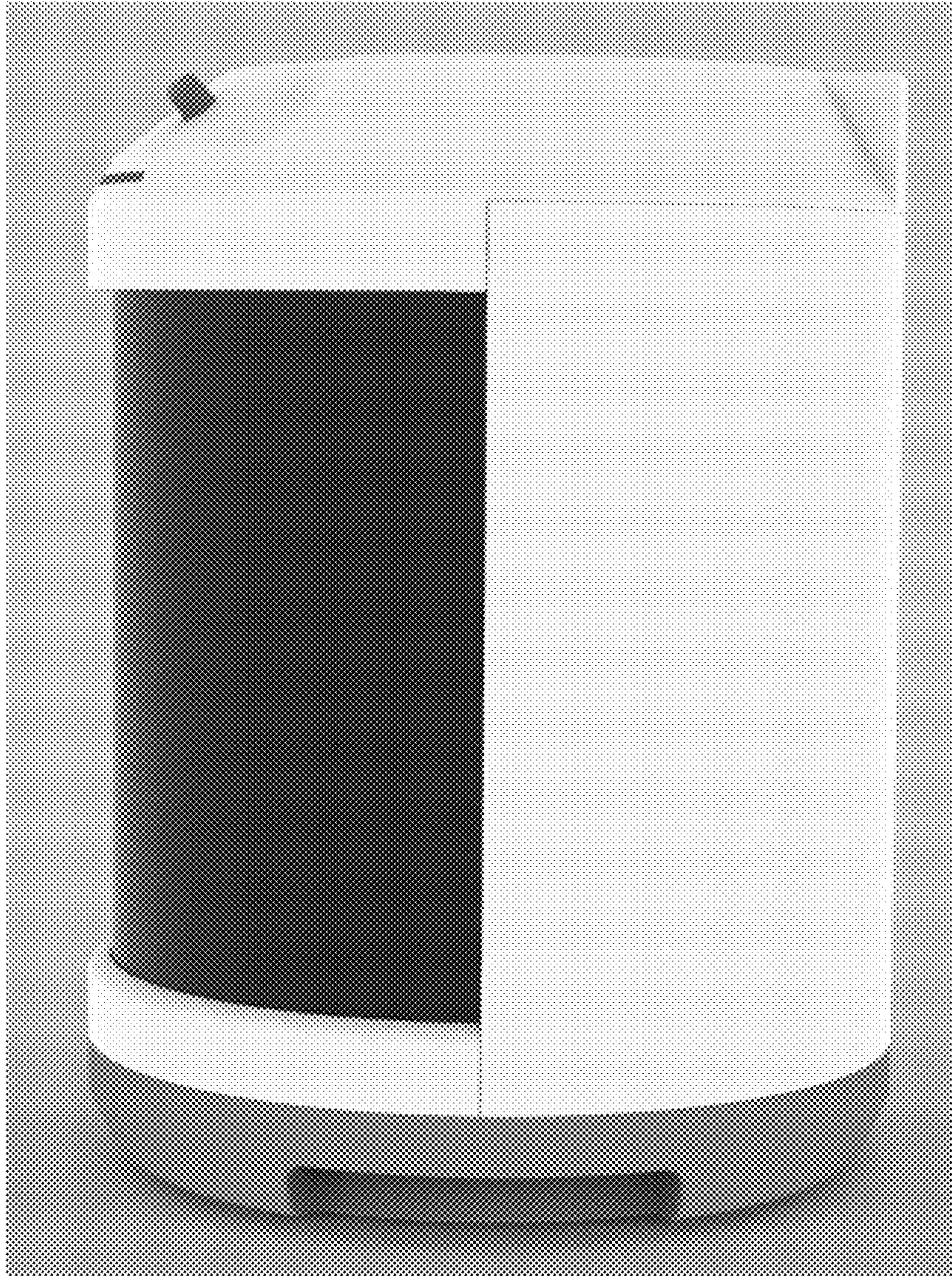

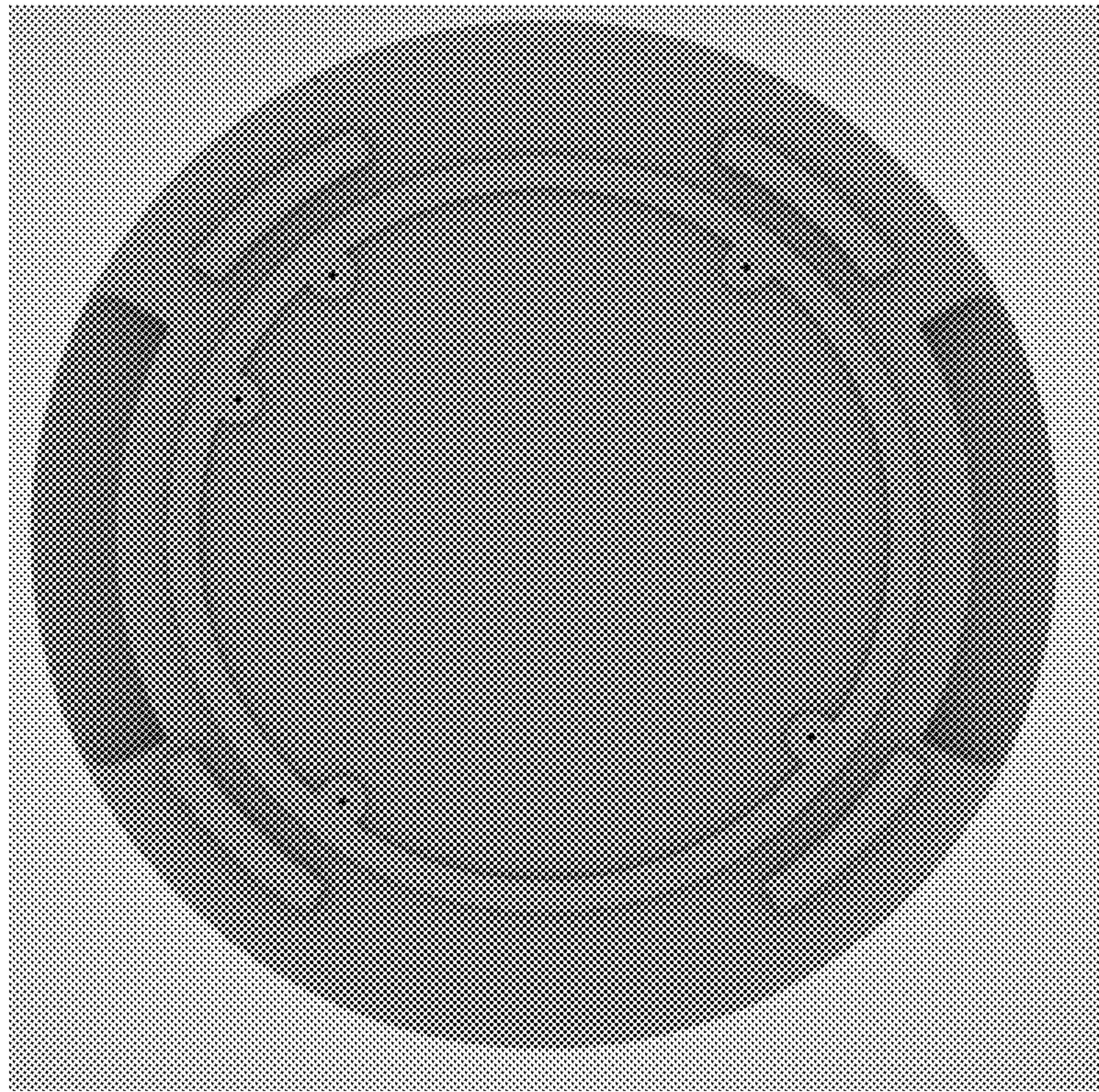

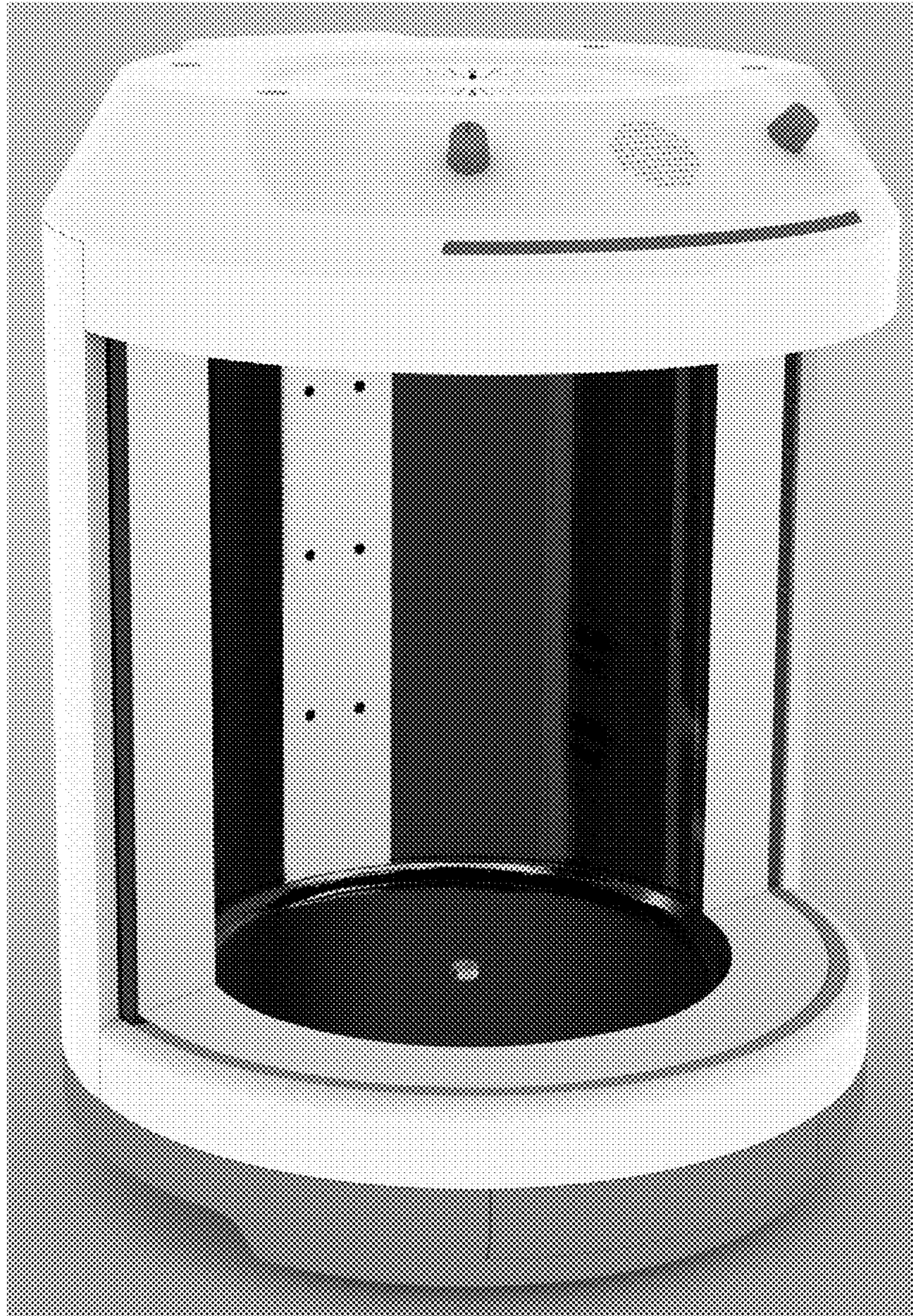

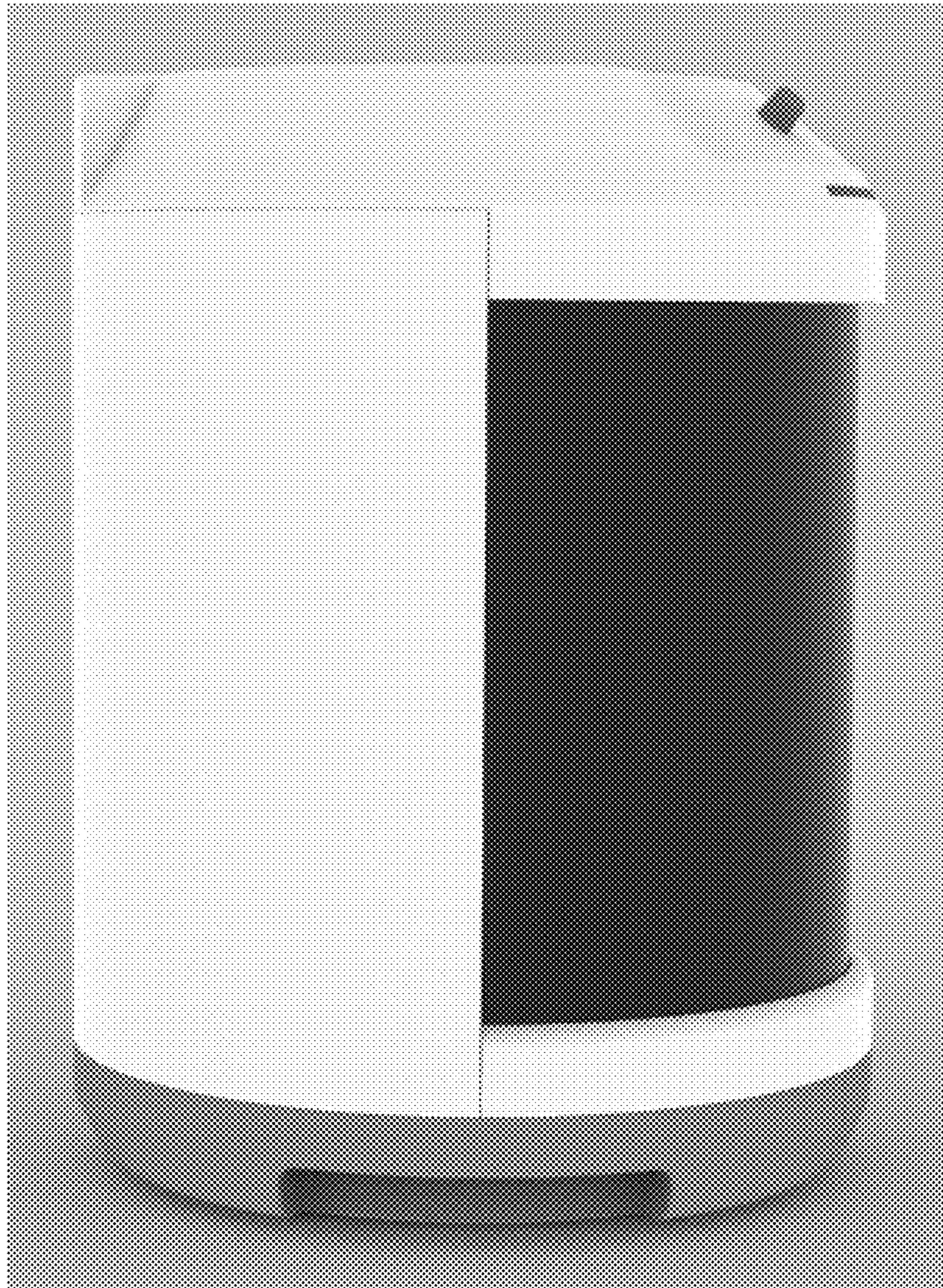

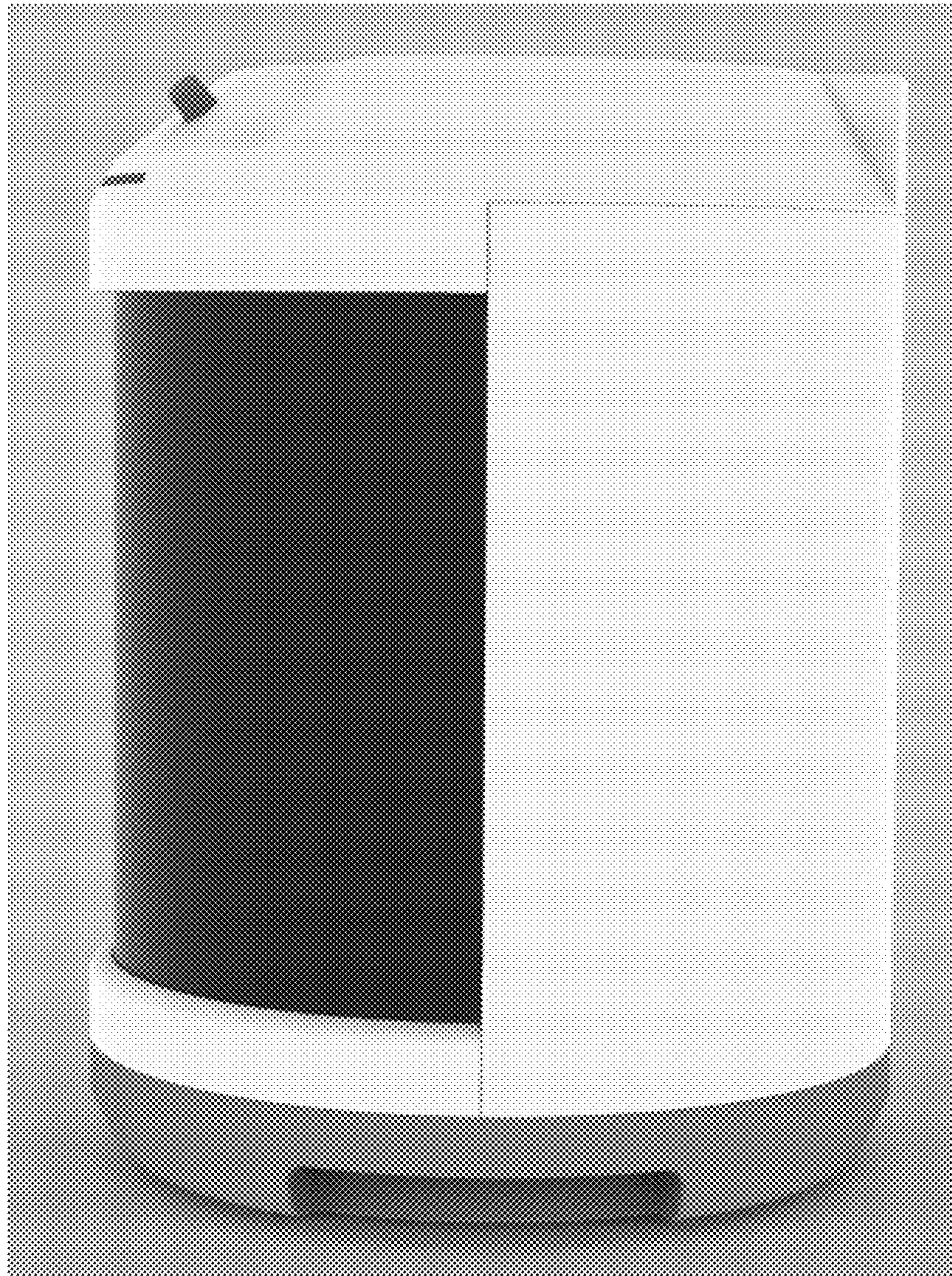

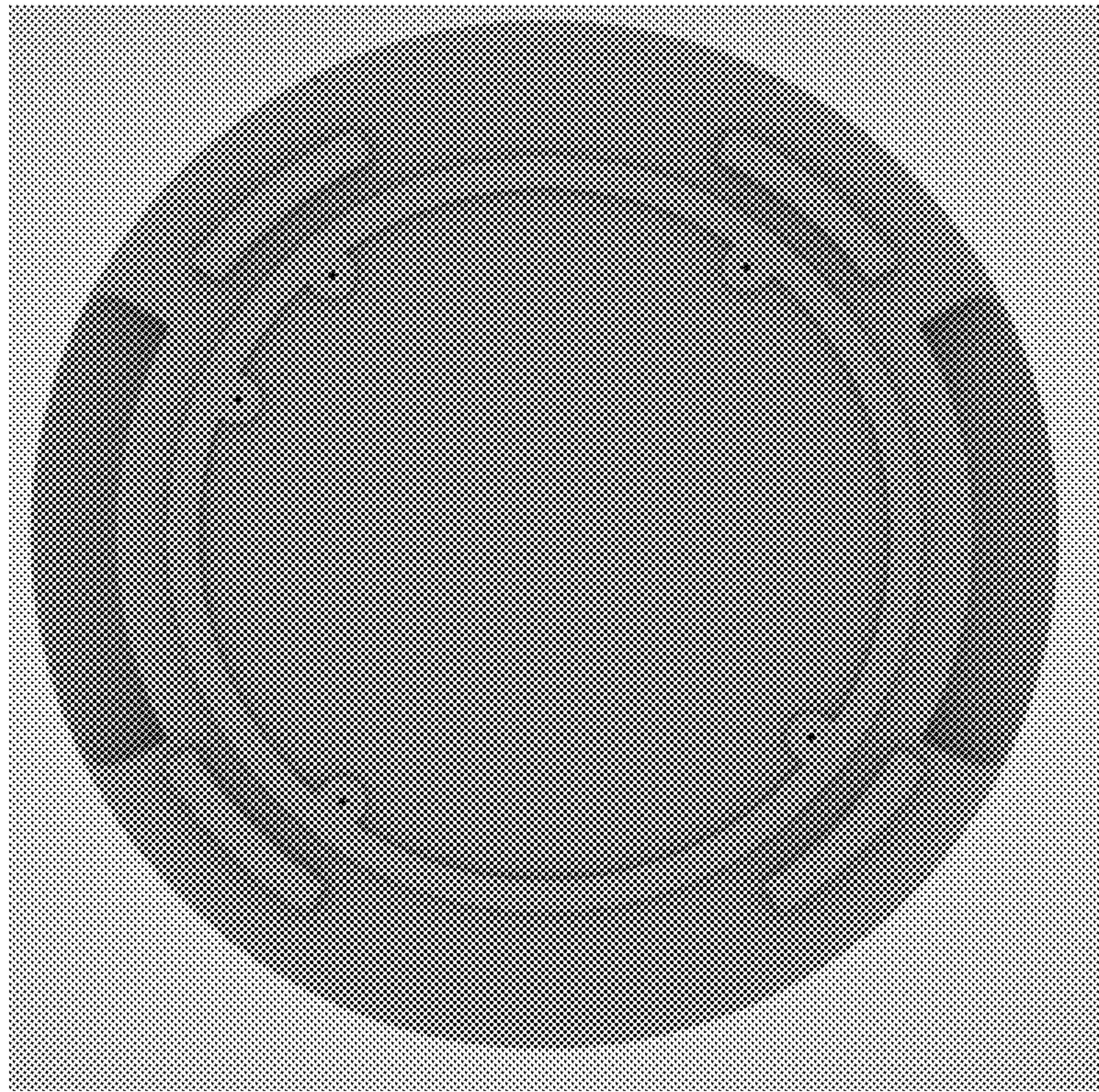

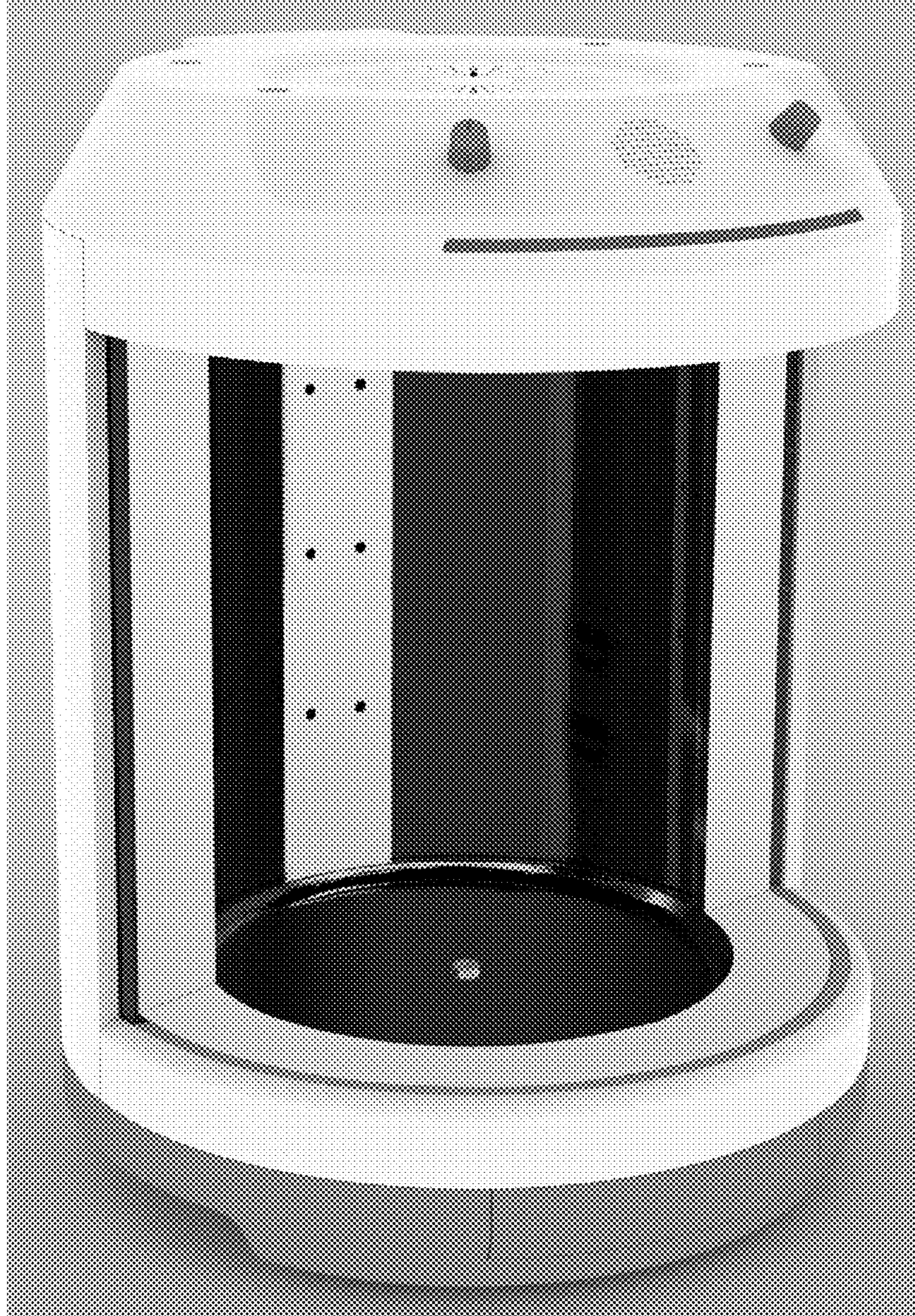
