(57) **CLAIM**

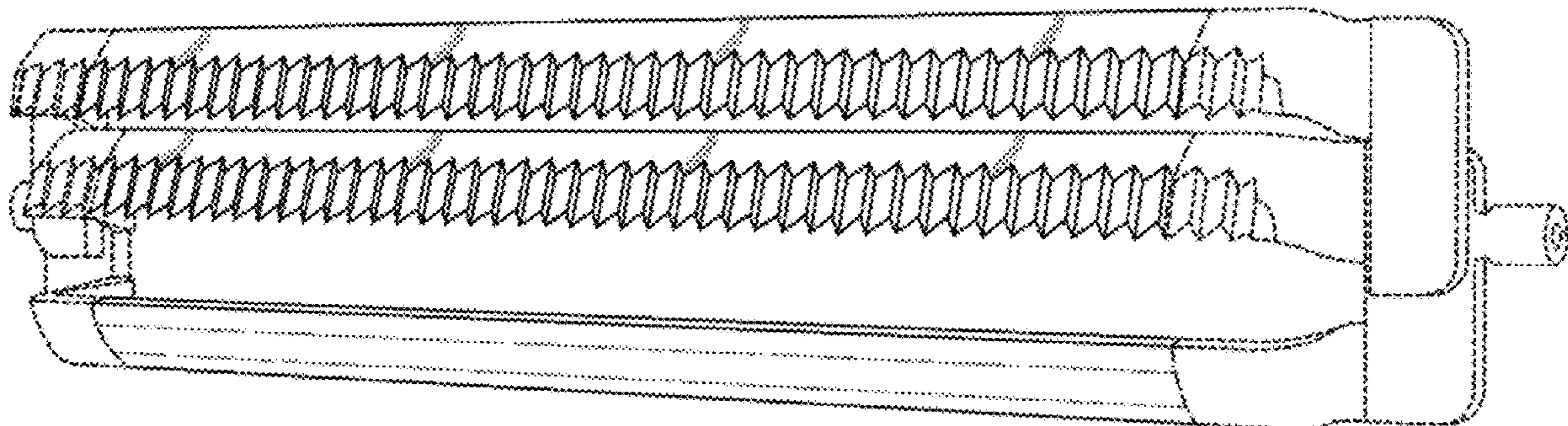
The ornamental design for a peeler blade, as shown and described.

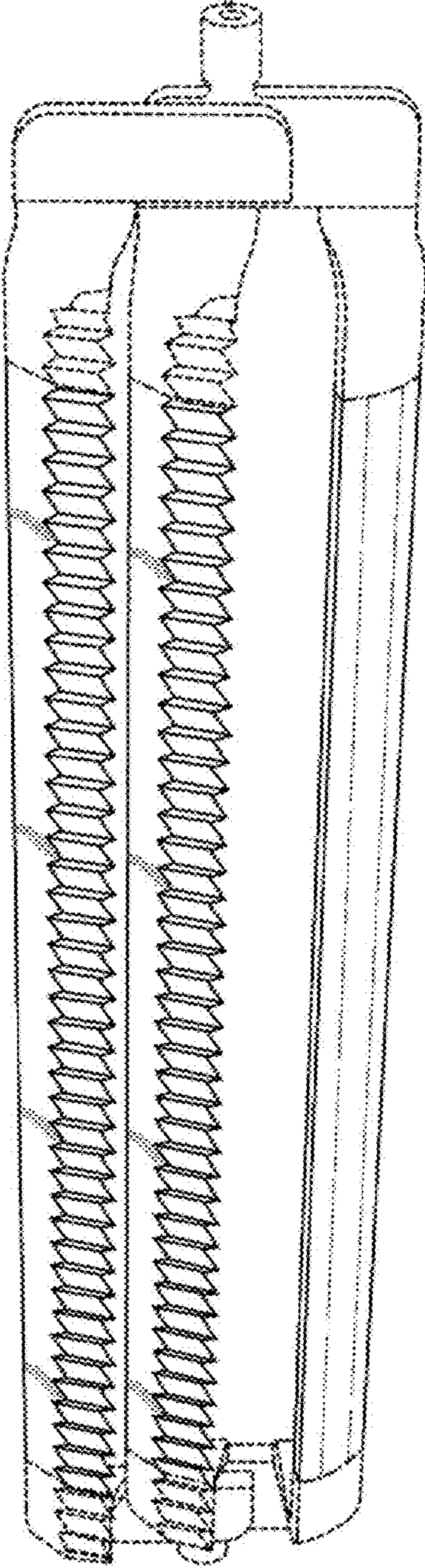
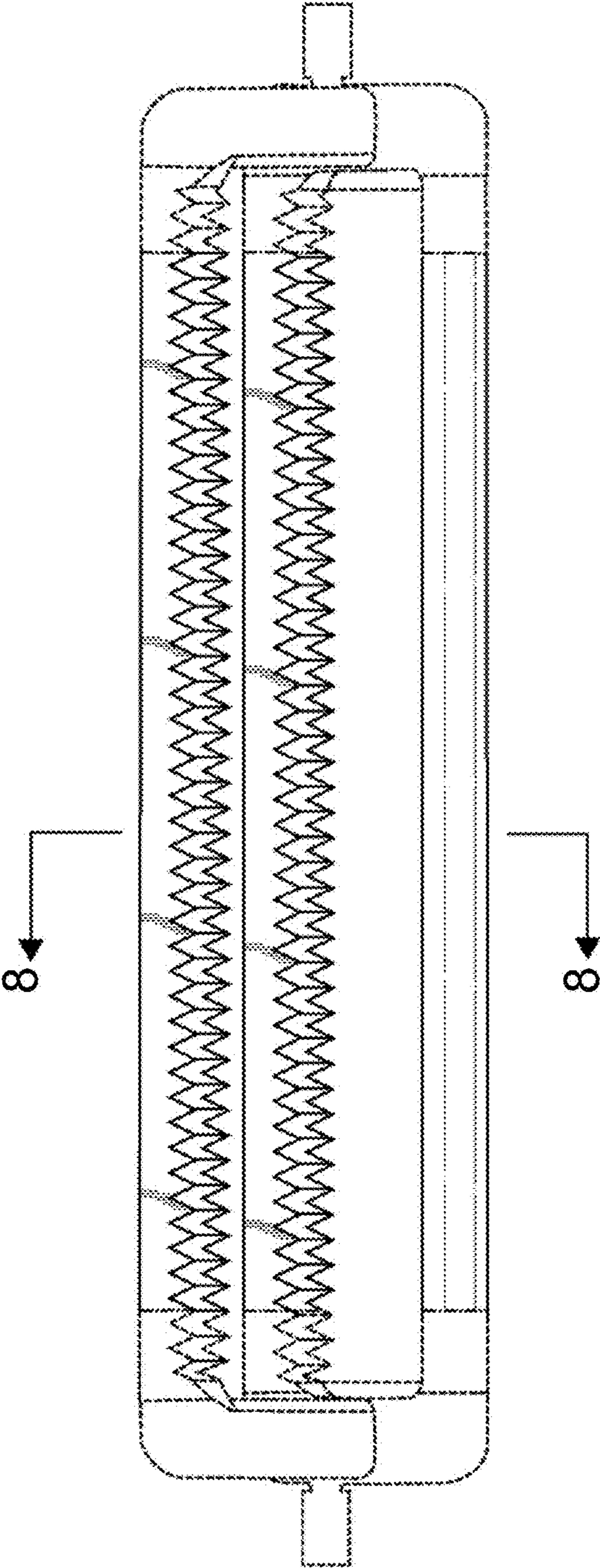

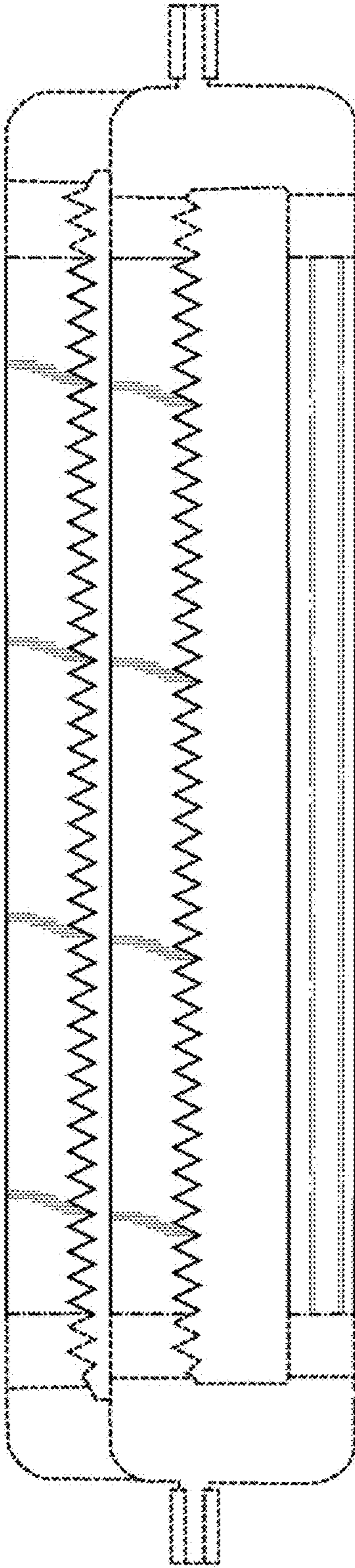

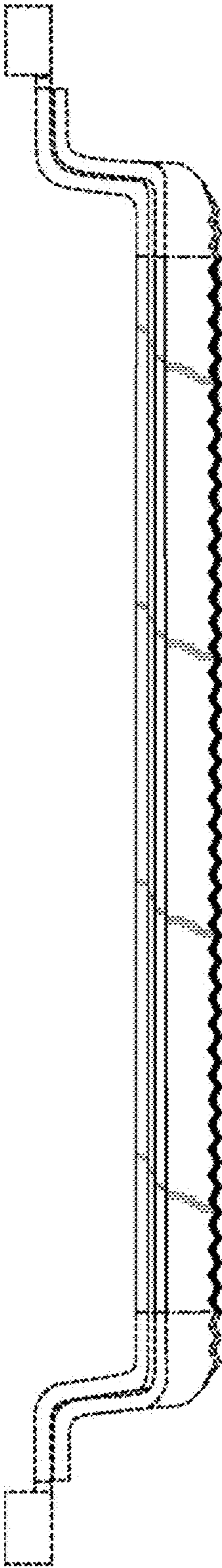

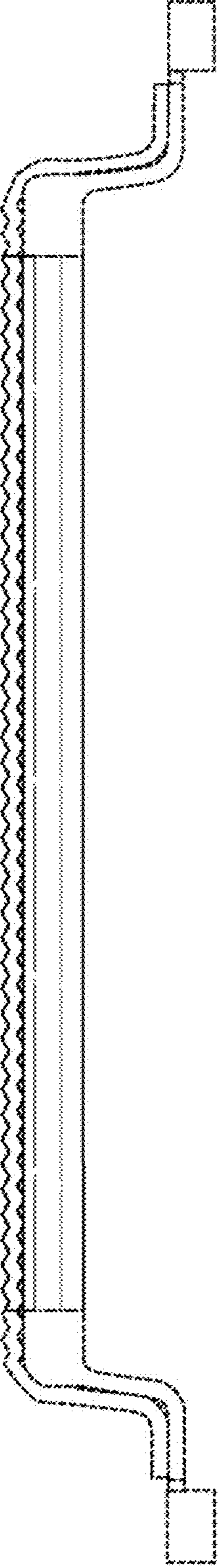

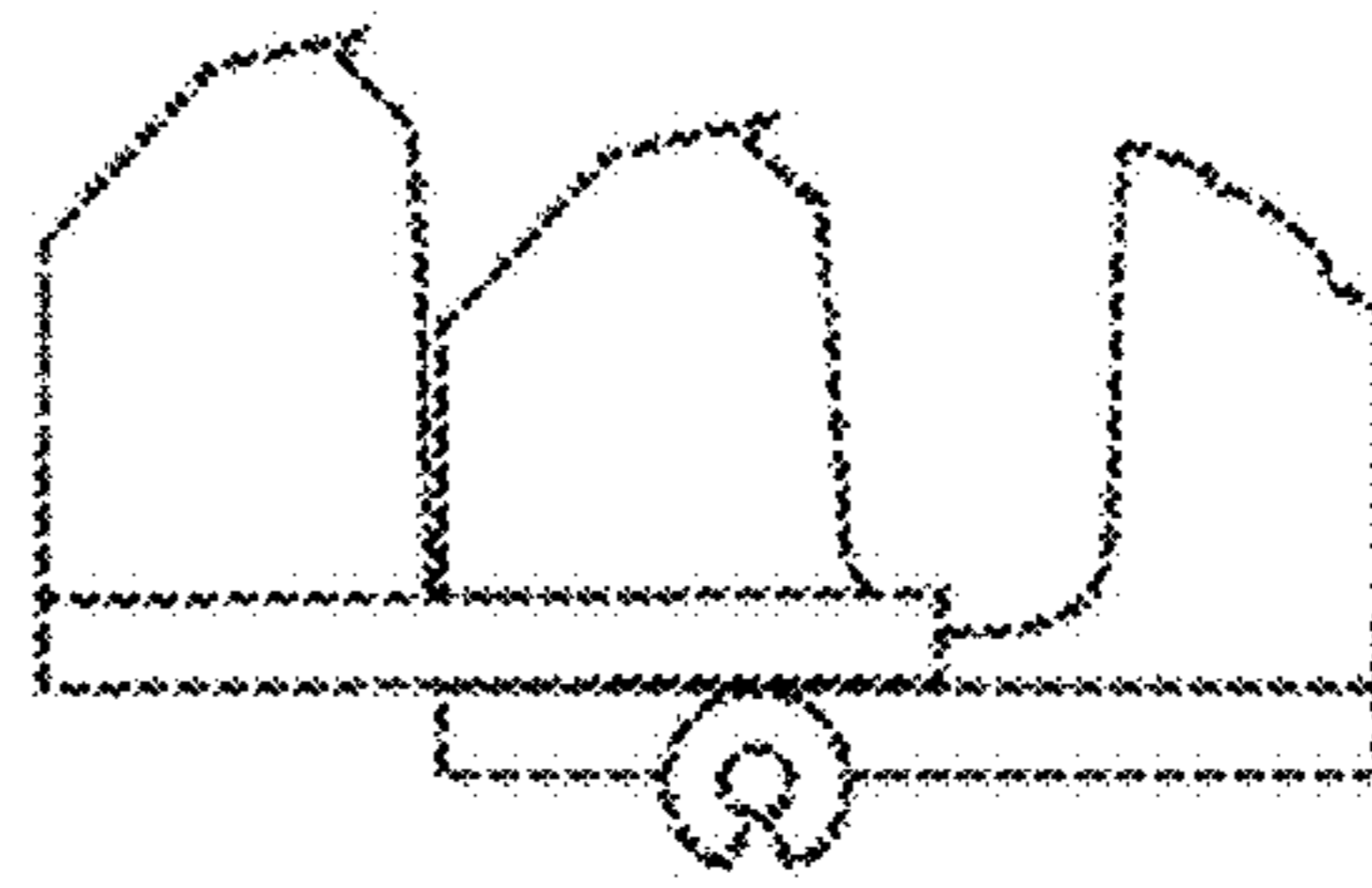

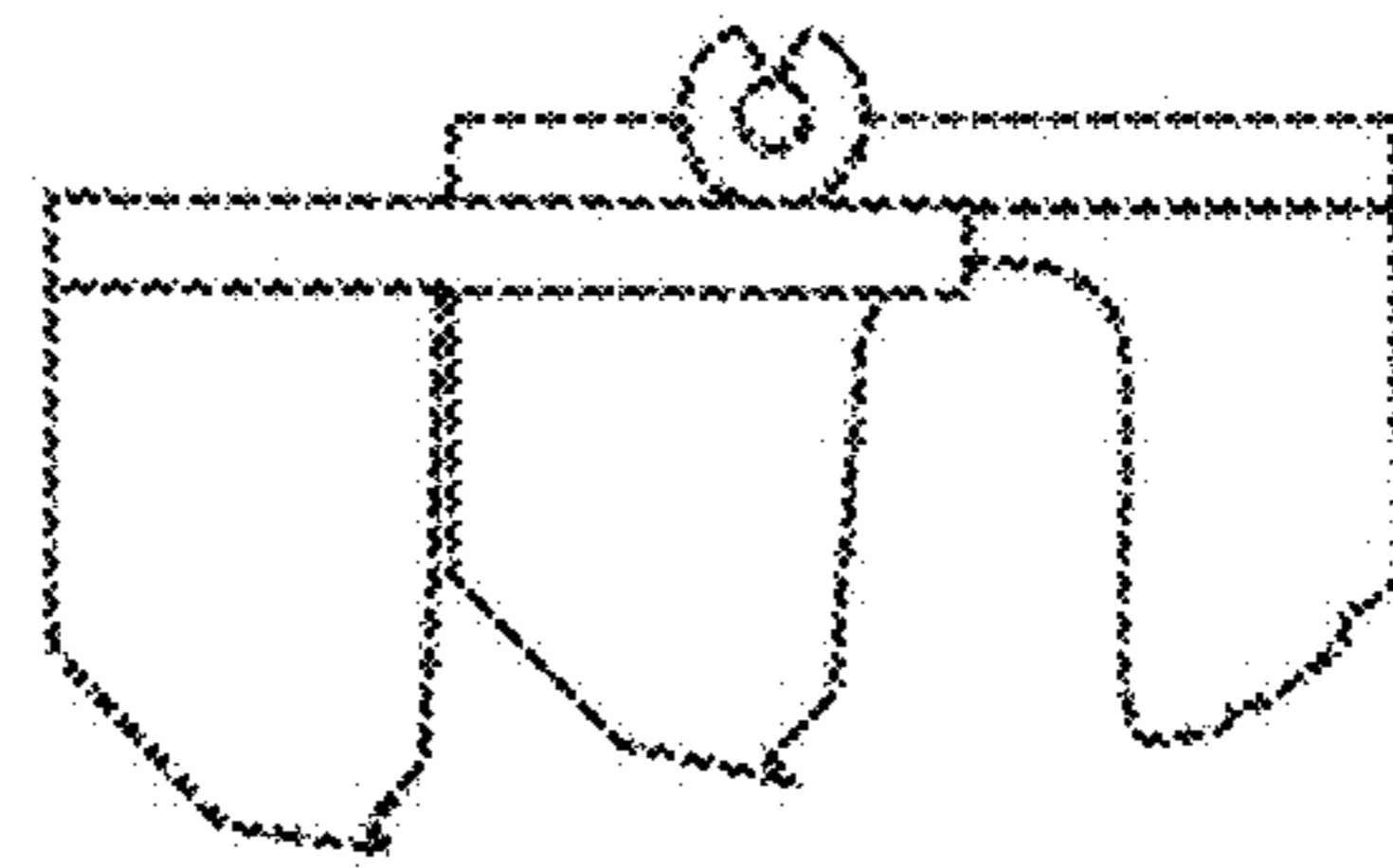

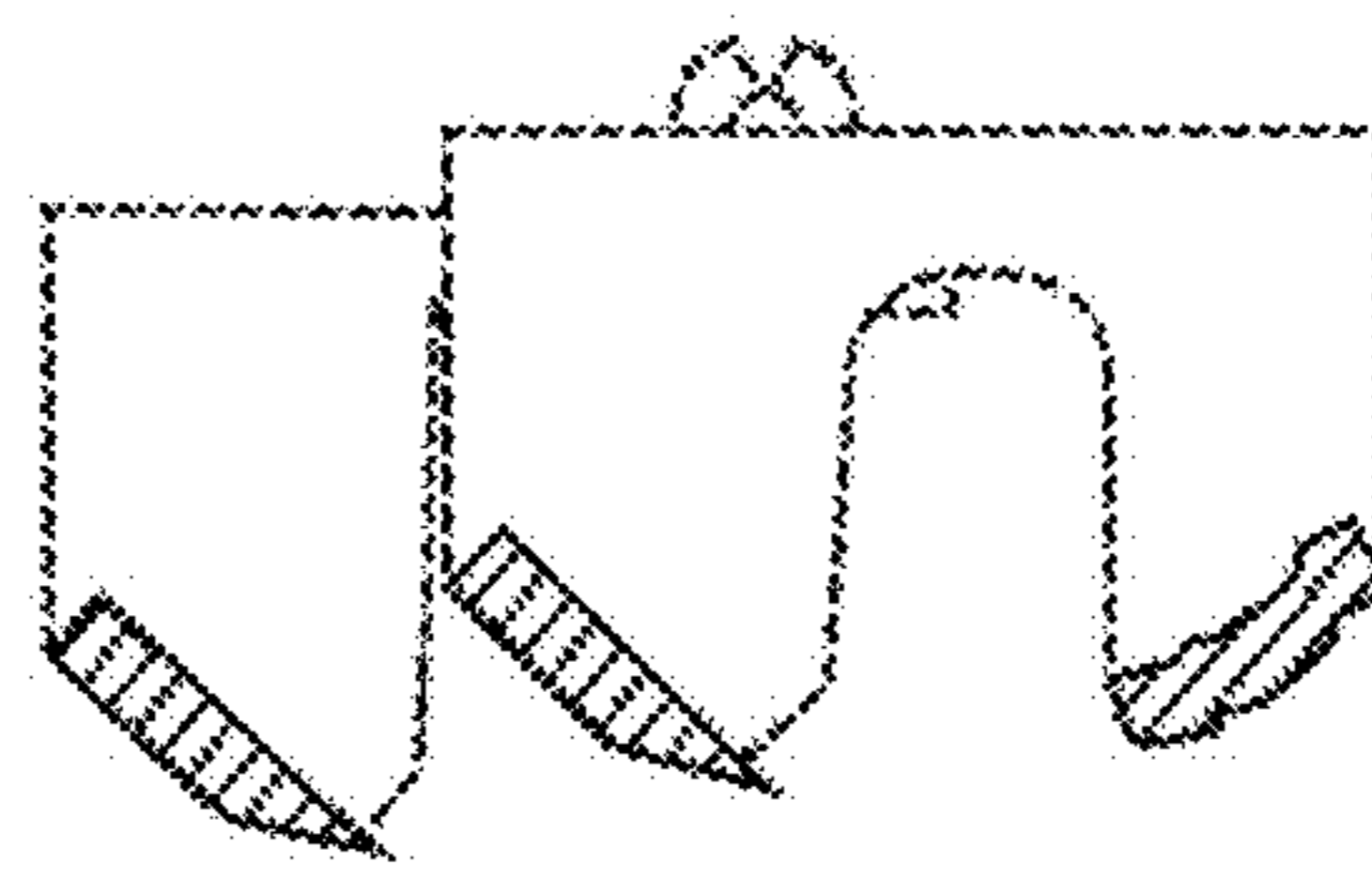
