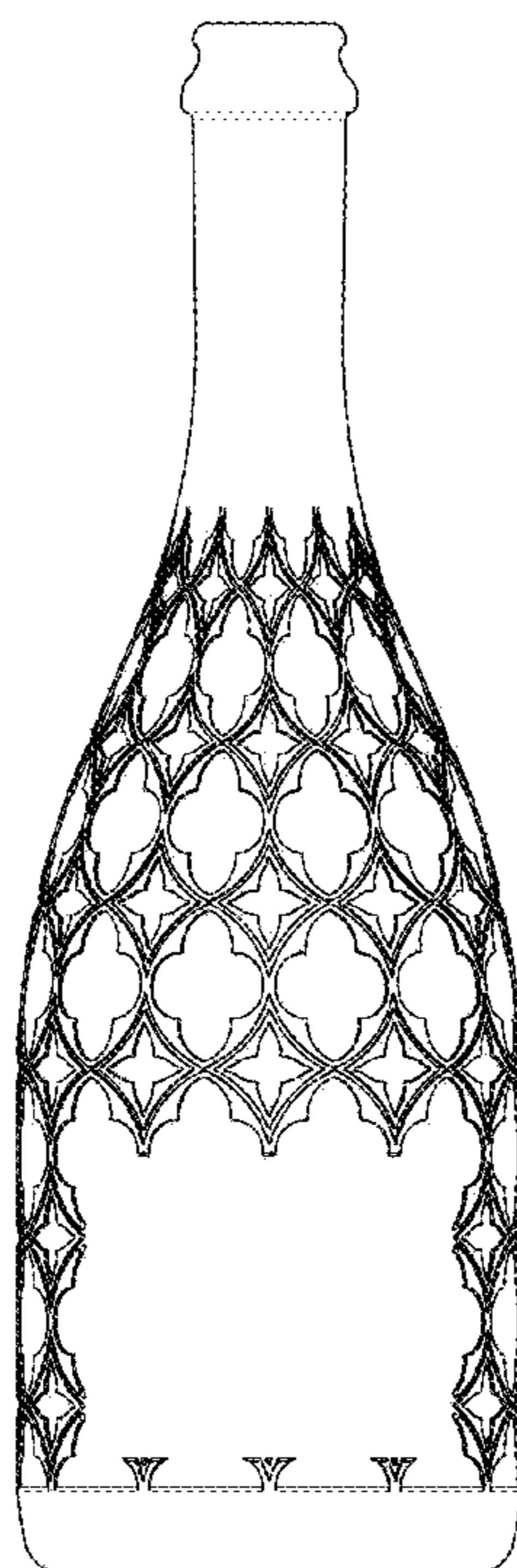
(57) **CLAIM**

The ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a bottle showing my new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a right elevational view thereof;
FIG. 5 is the left elevational view thereof;
FIG. 6 is a top plan view thereof; and,
FIG. 7 is a bottom plan view thereof.
The pattern on the outer surface of the bottle is in relief.
The broken lines in the figures are included for illustrating portions of the bottle that form no part of the claimed design.

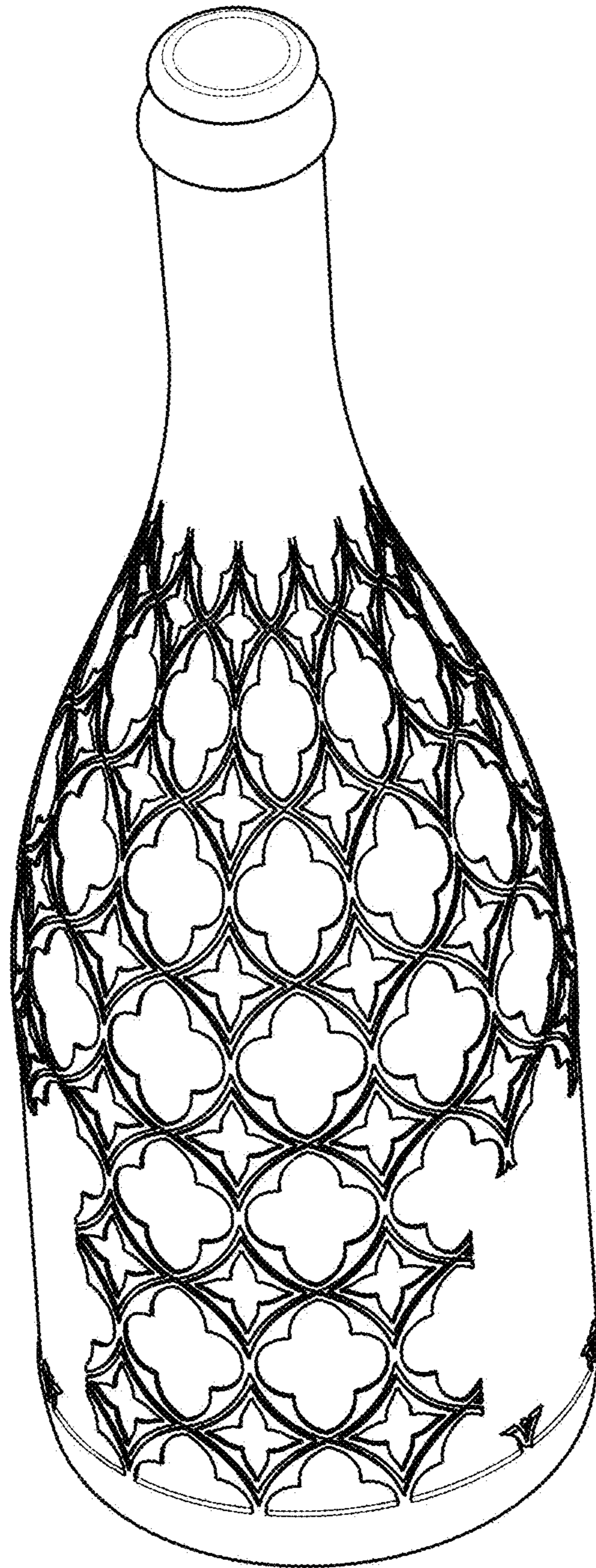

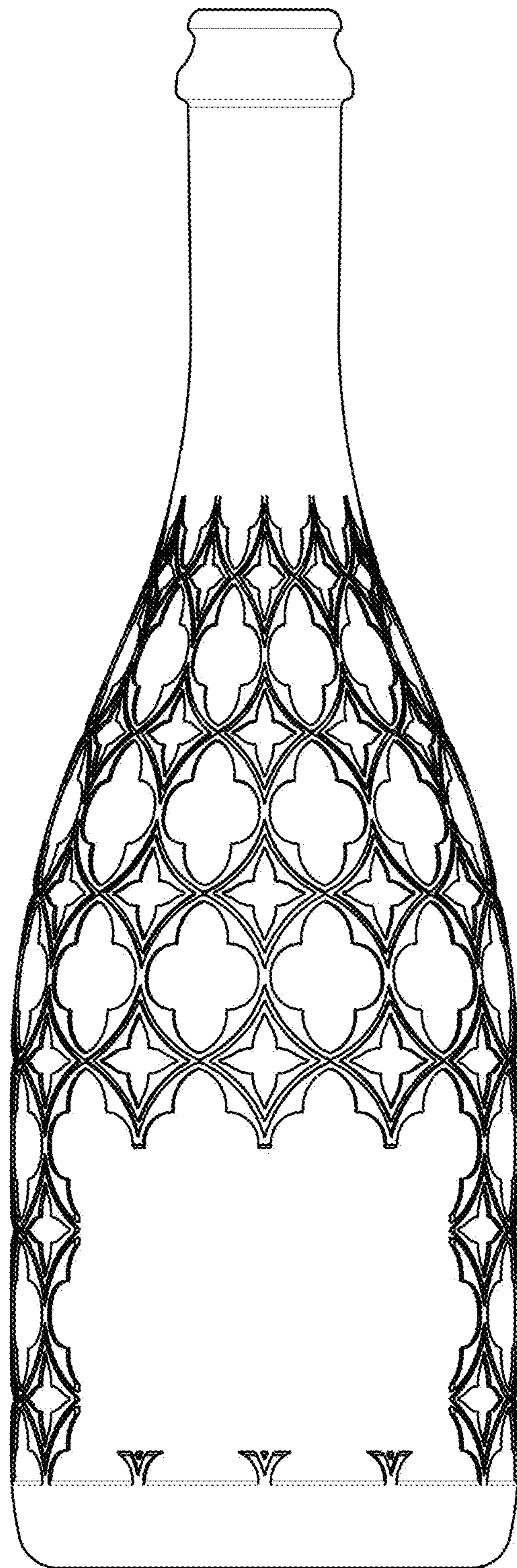

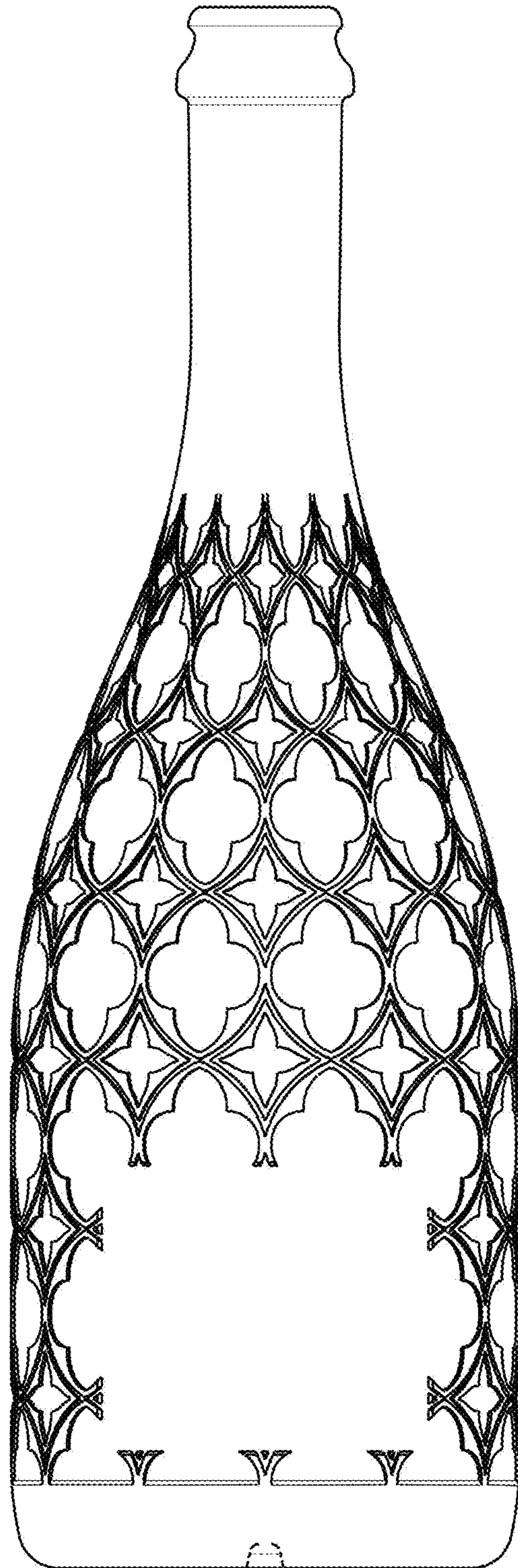

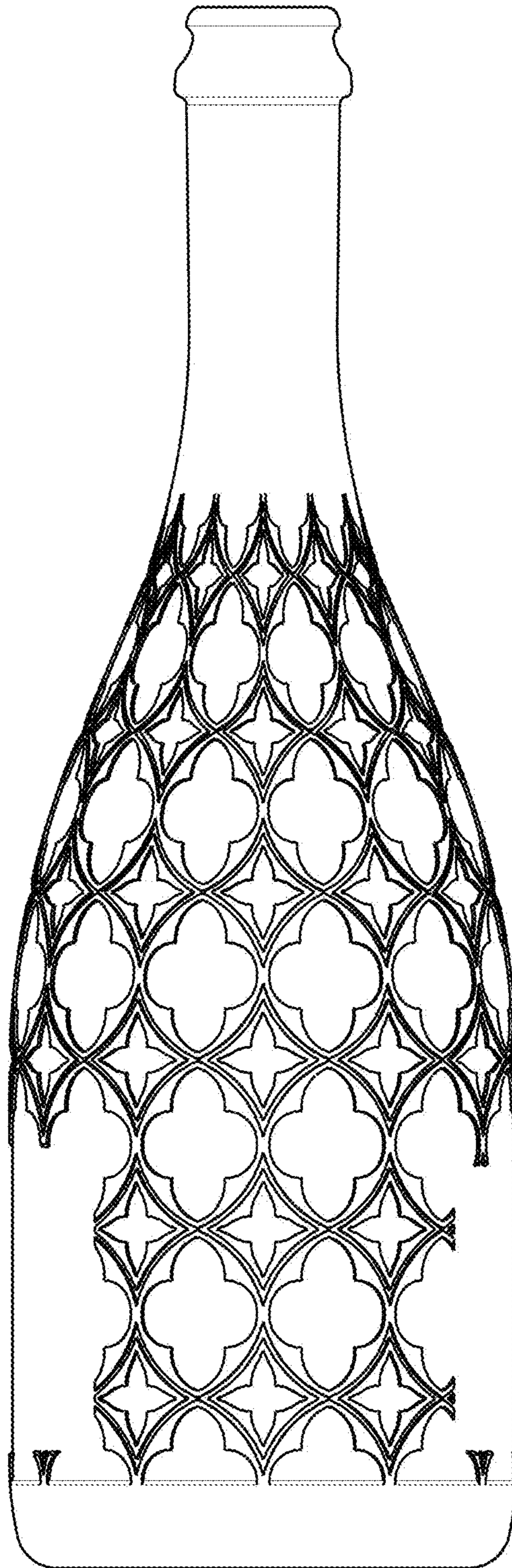

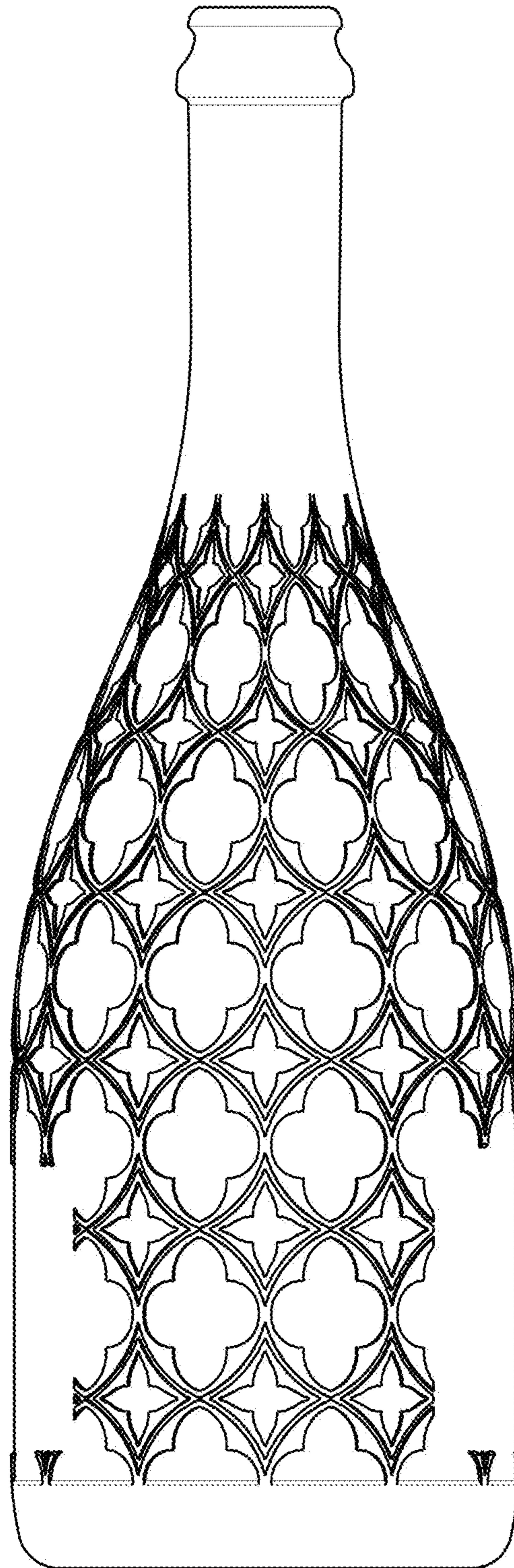

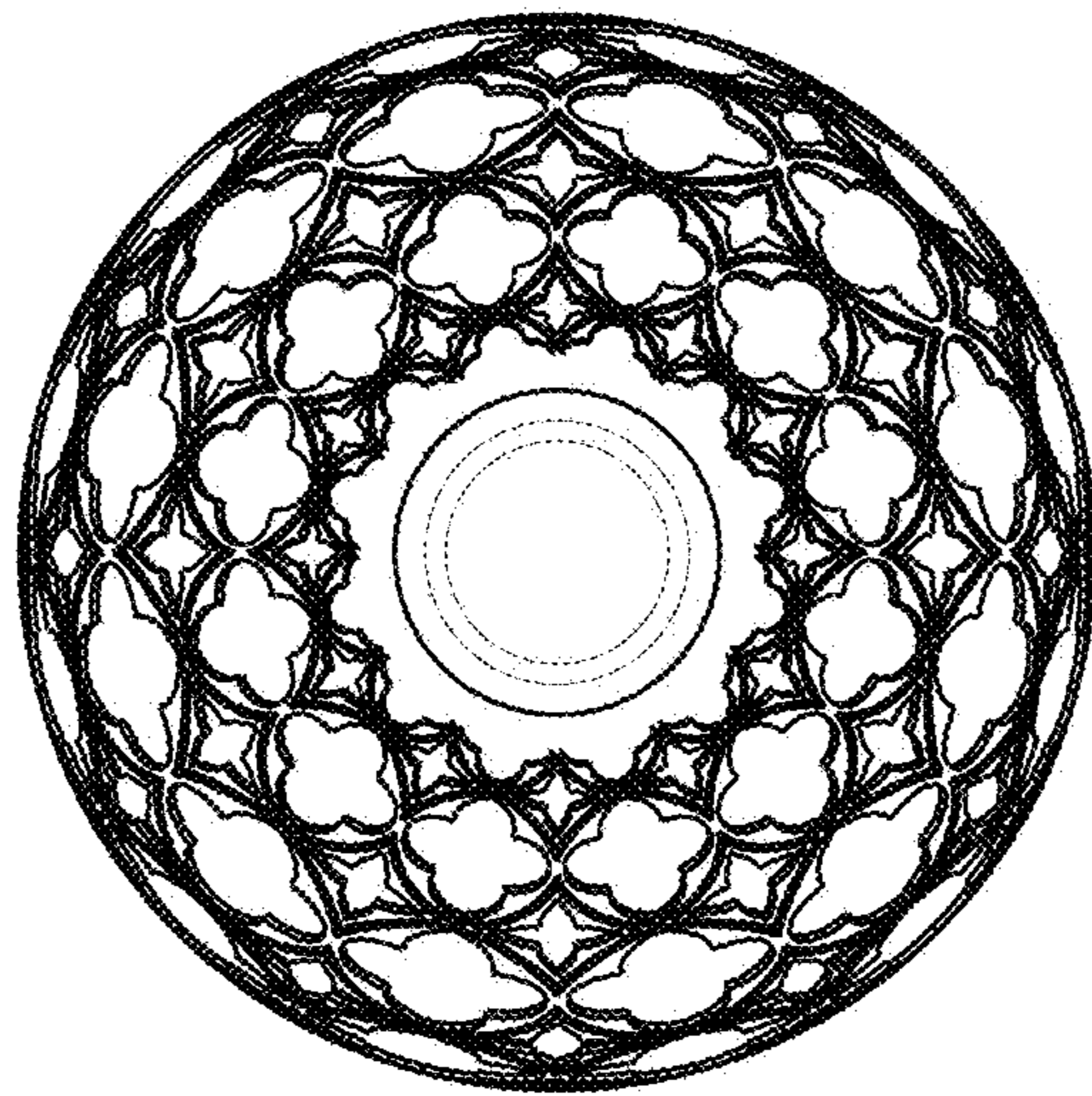

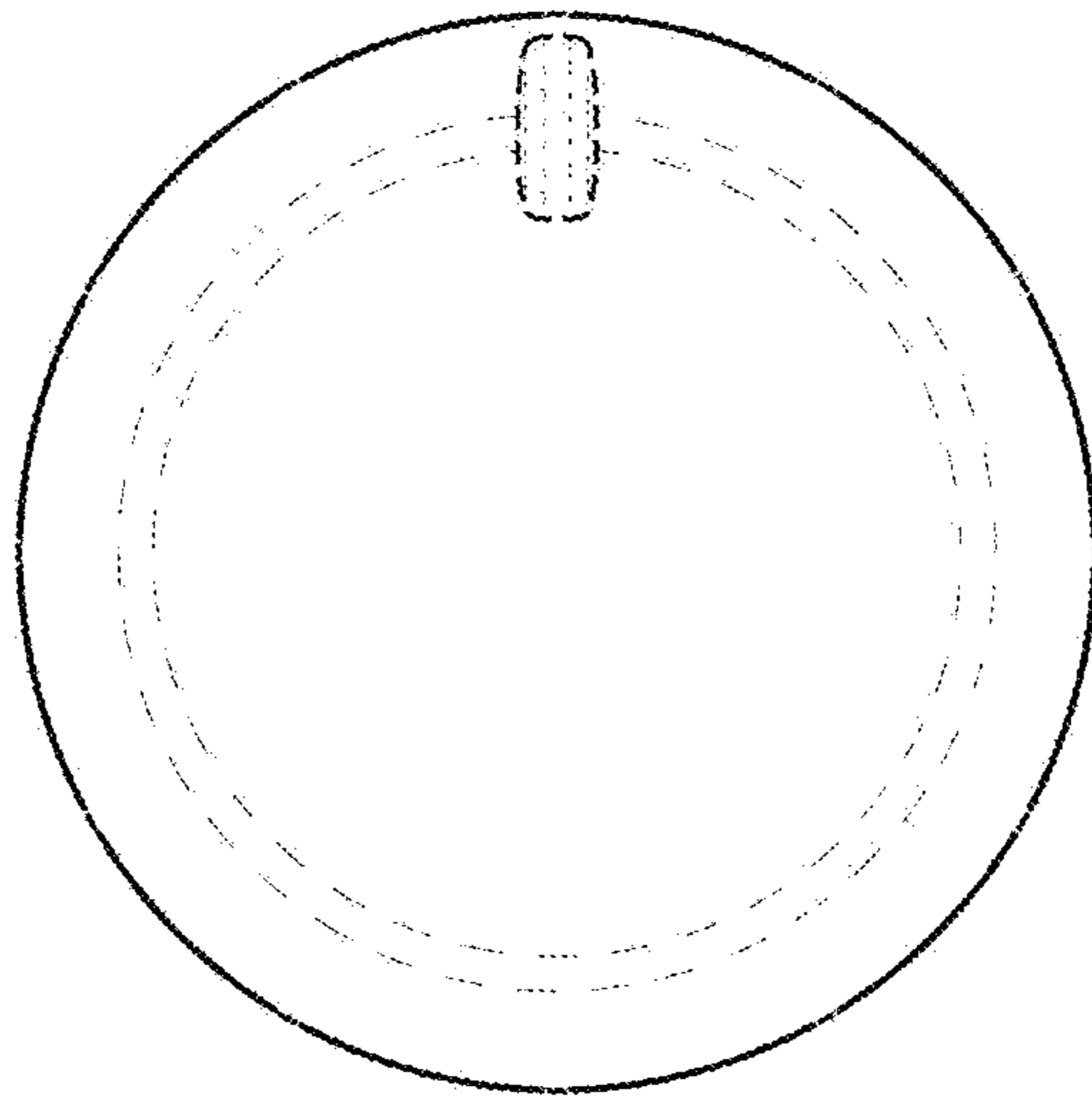
