**DESCRIPTION**

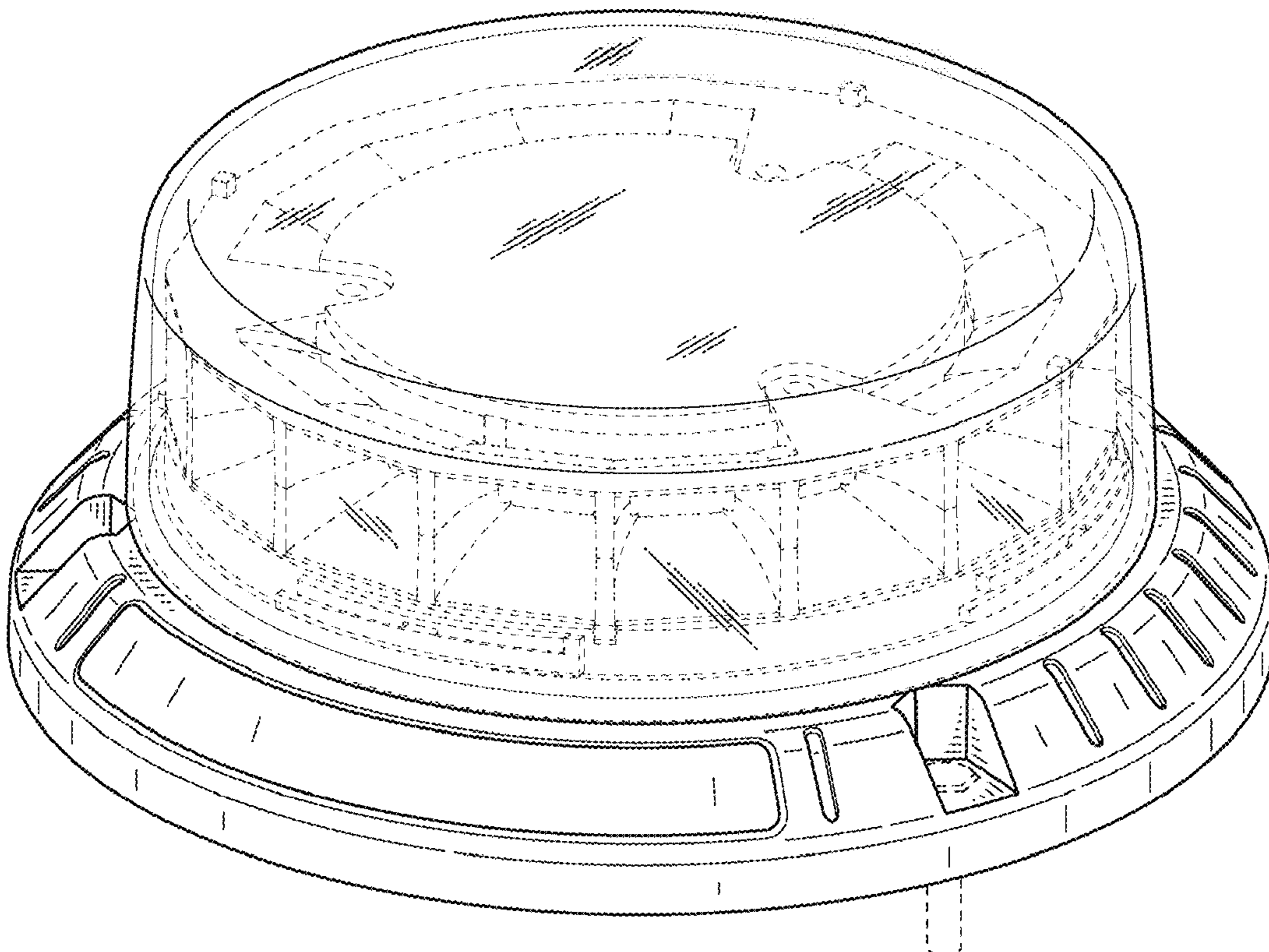
FIG. 1 is a first top isometric view of a beacon;

 In the figures, the broken lines show environmental structures forming no part of the claimed design.

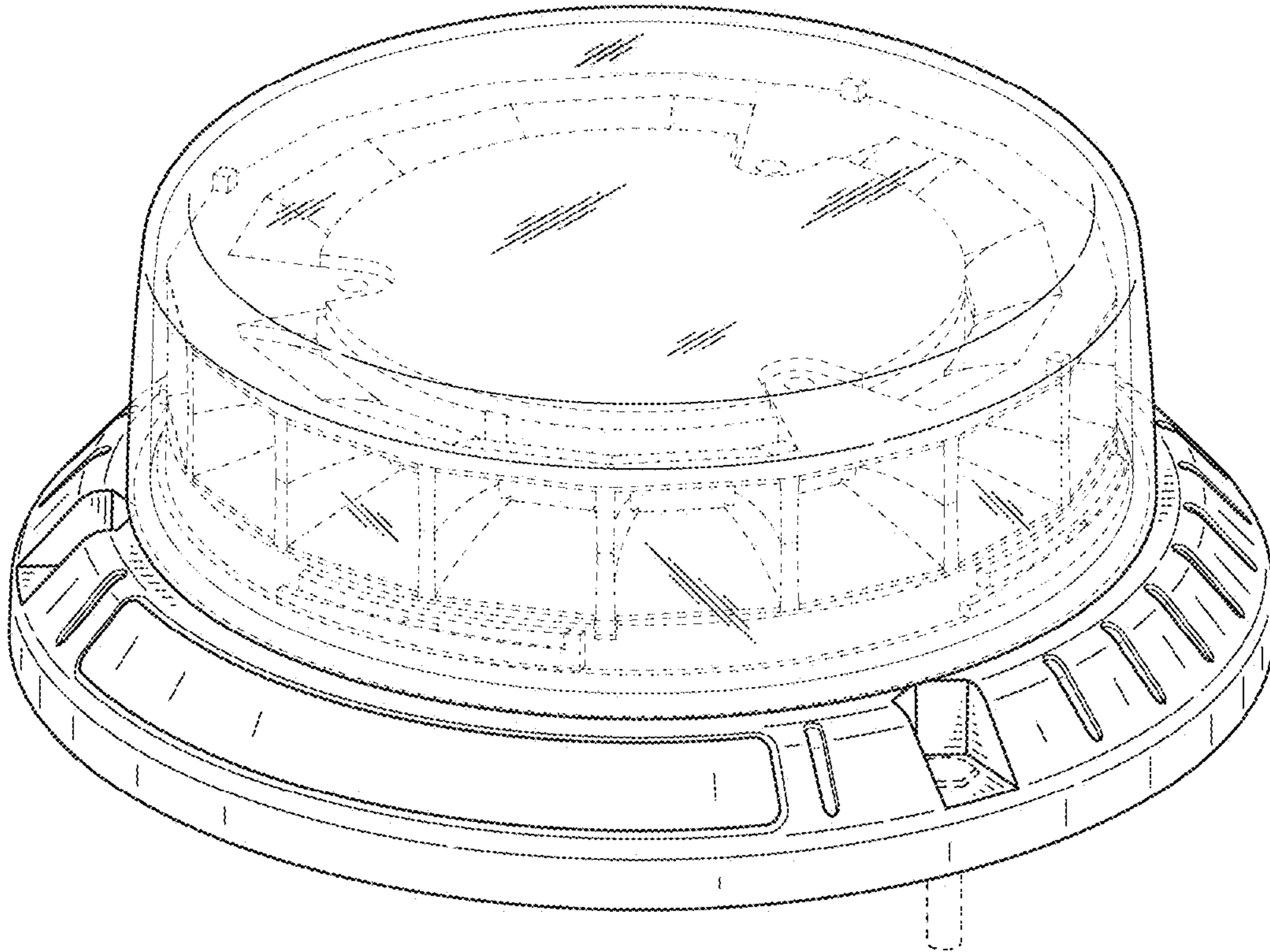

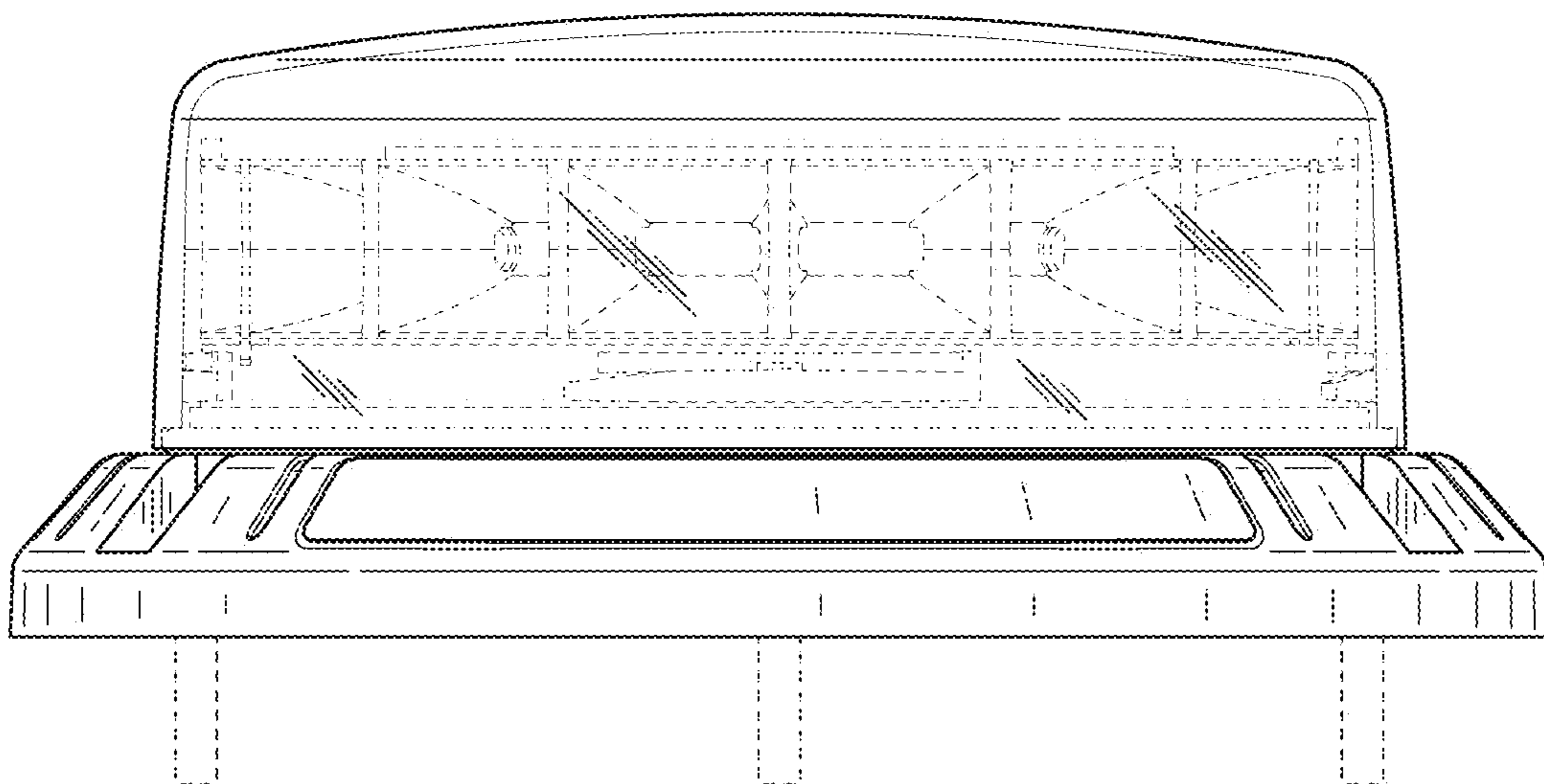

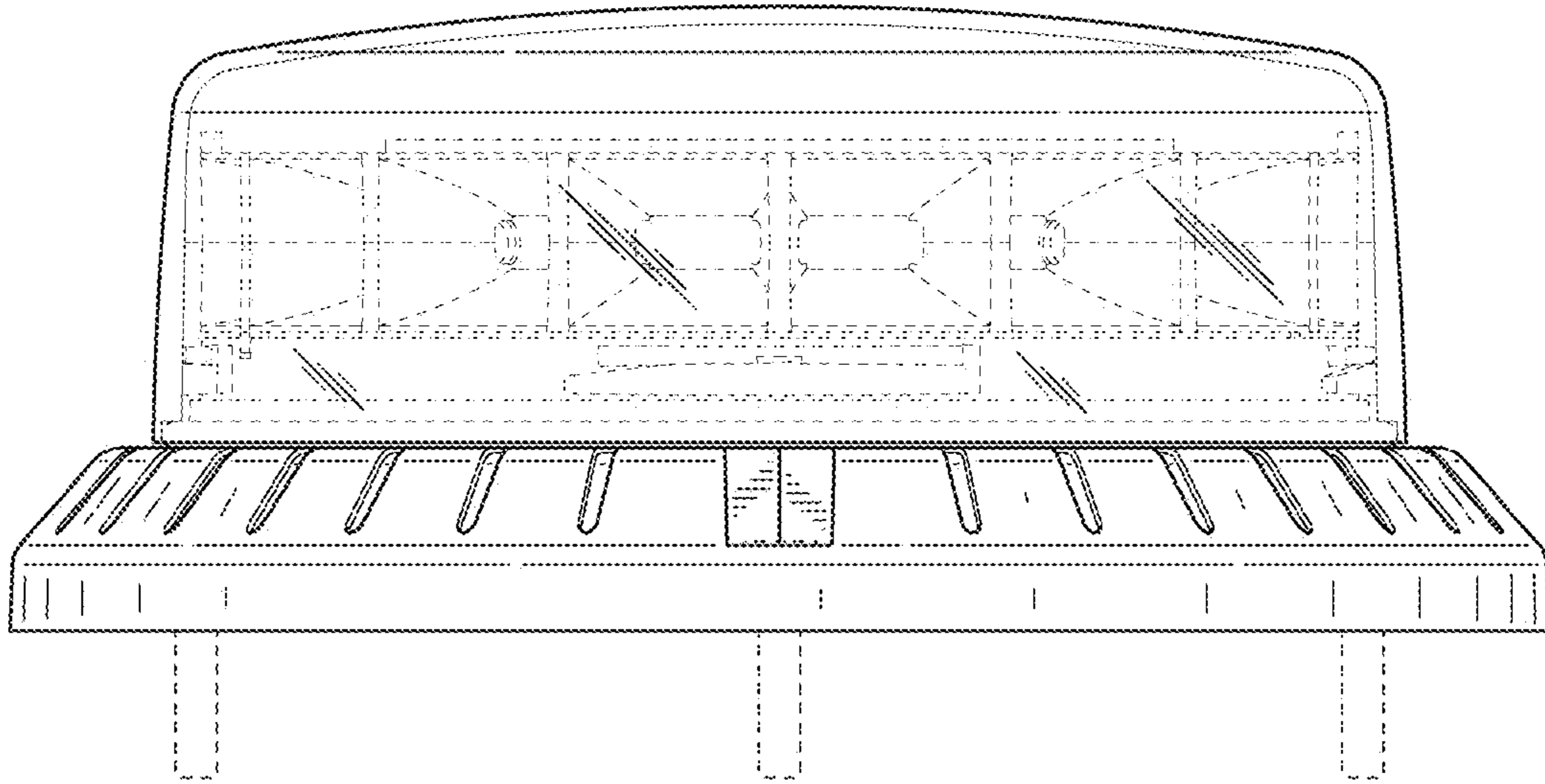

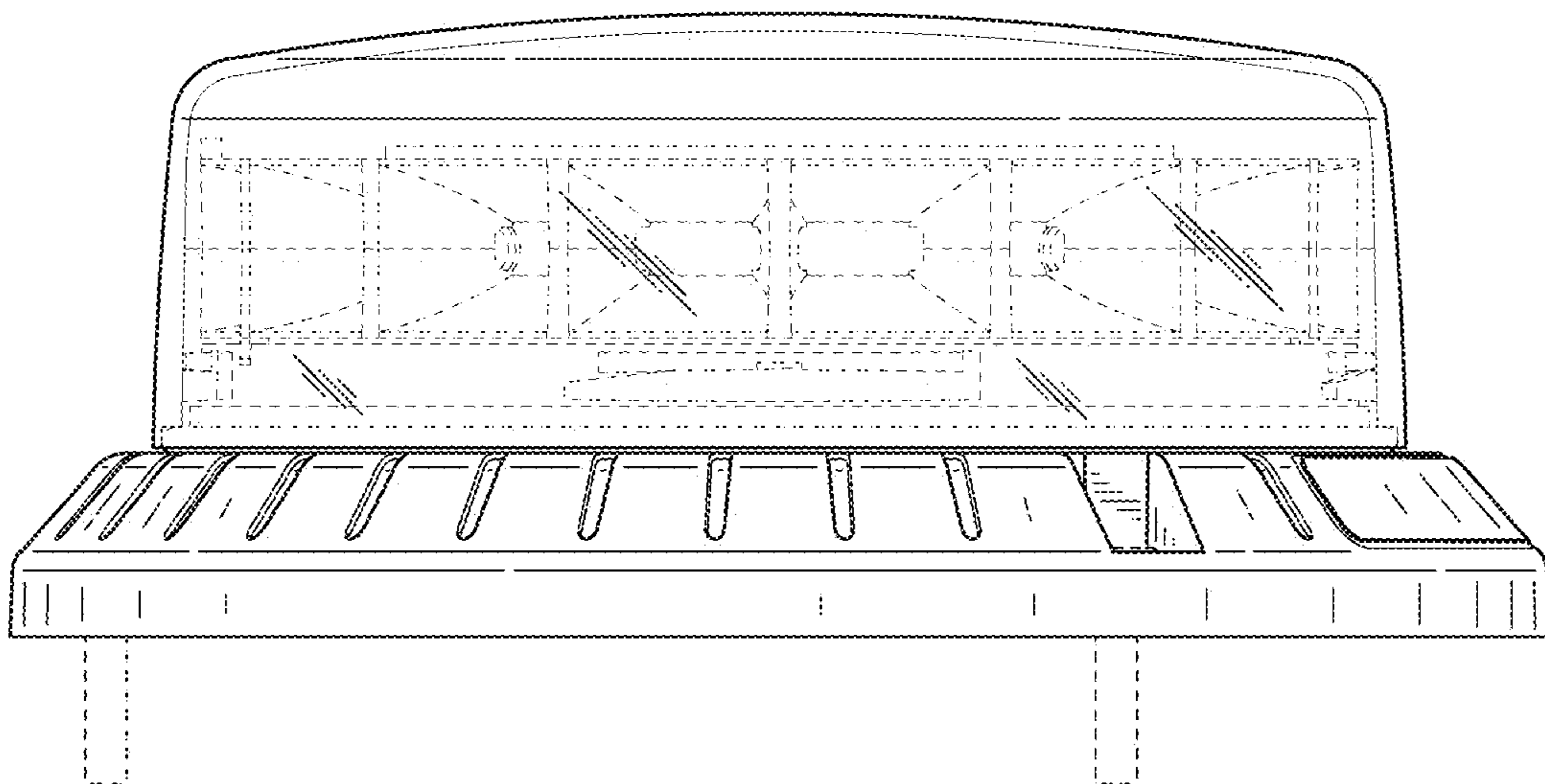

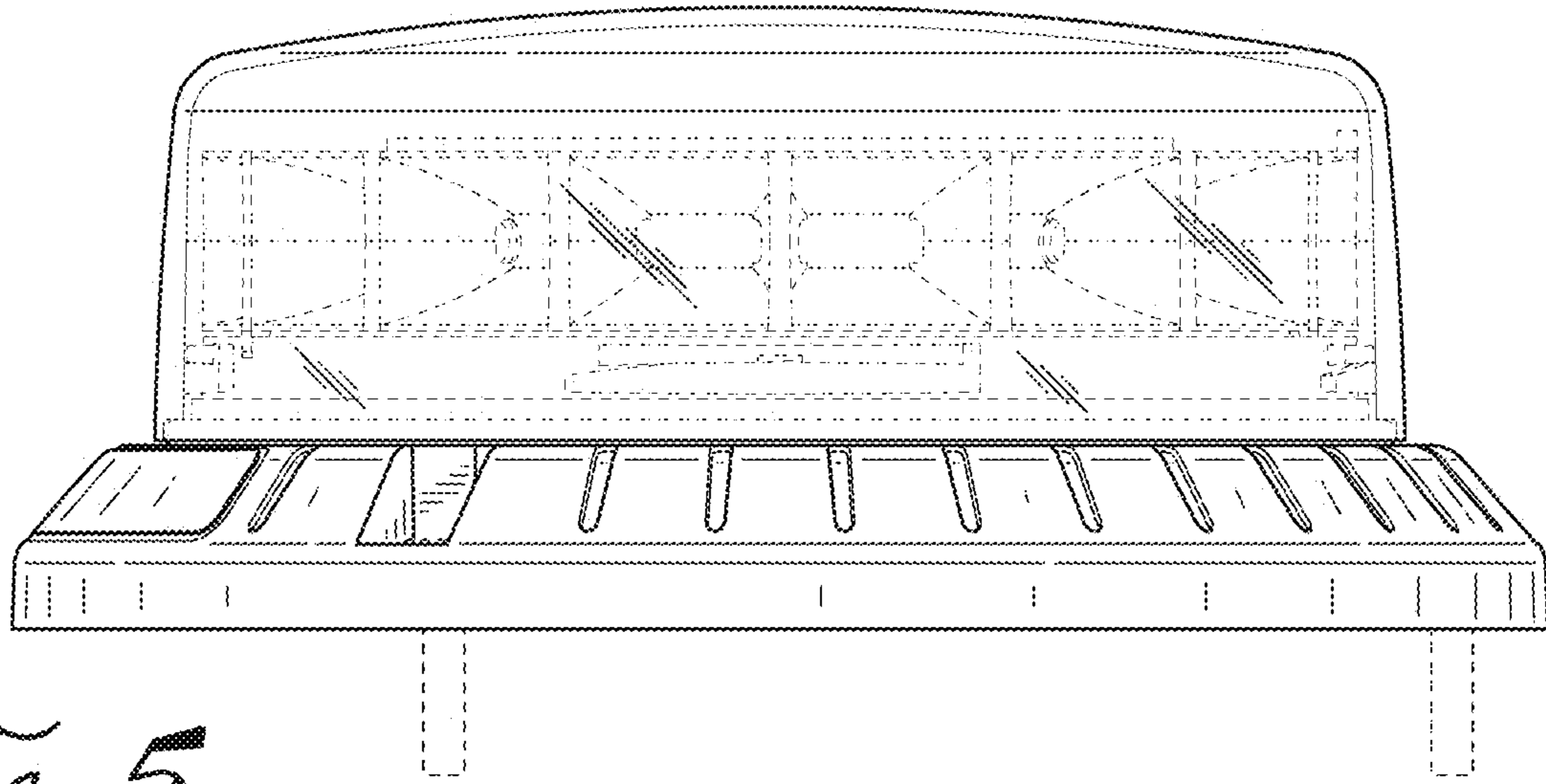




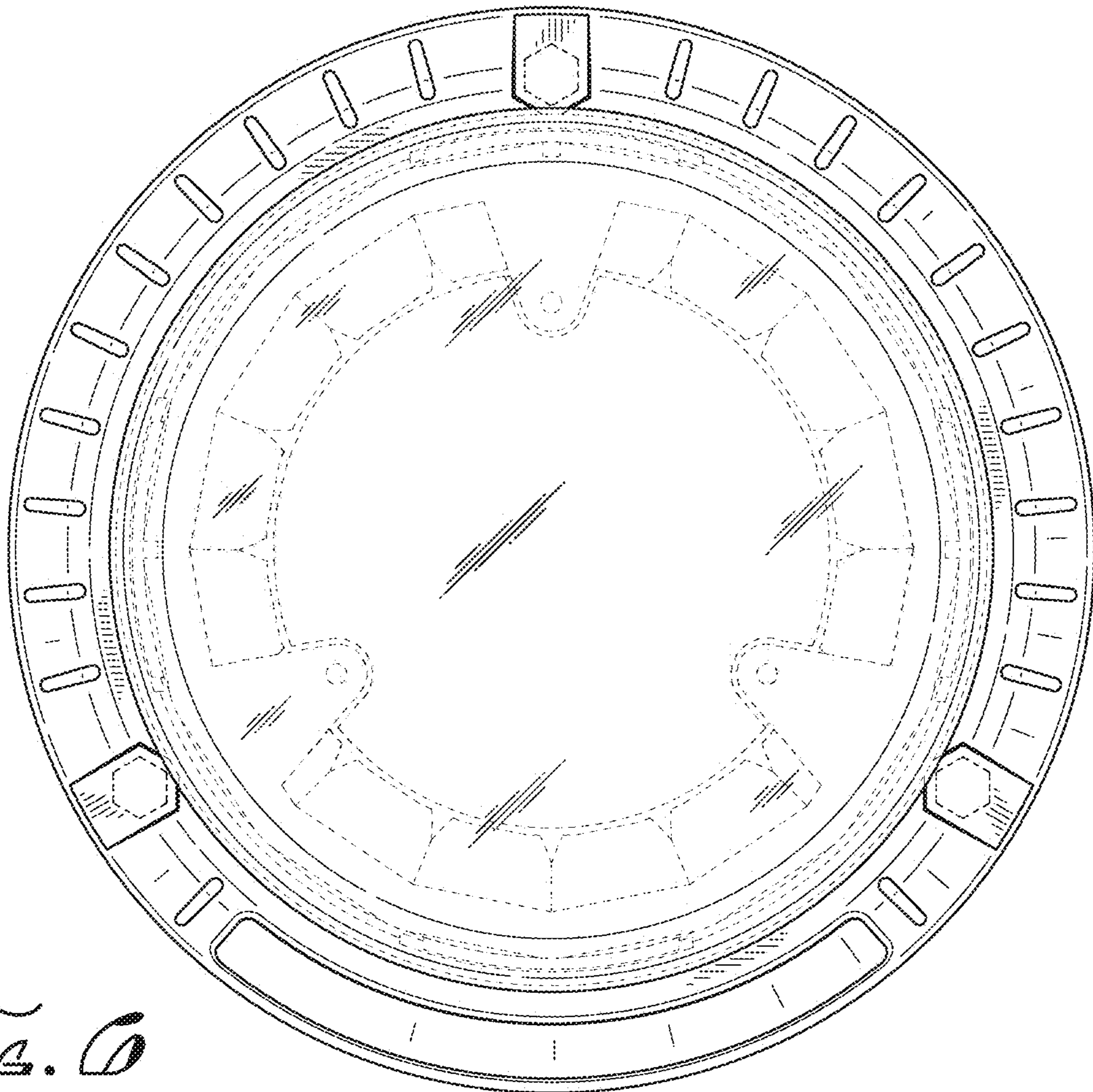
