FIG. 1 is a front elevational view of the figurine of the invention;

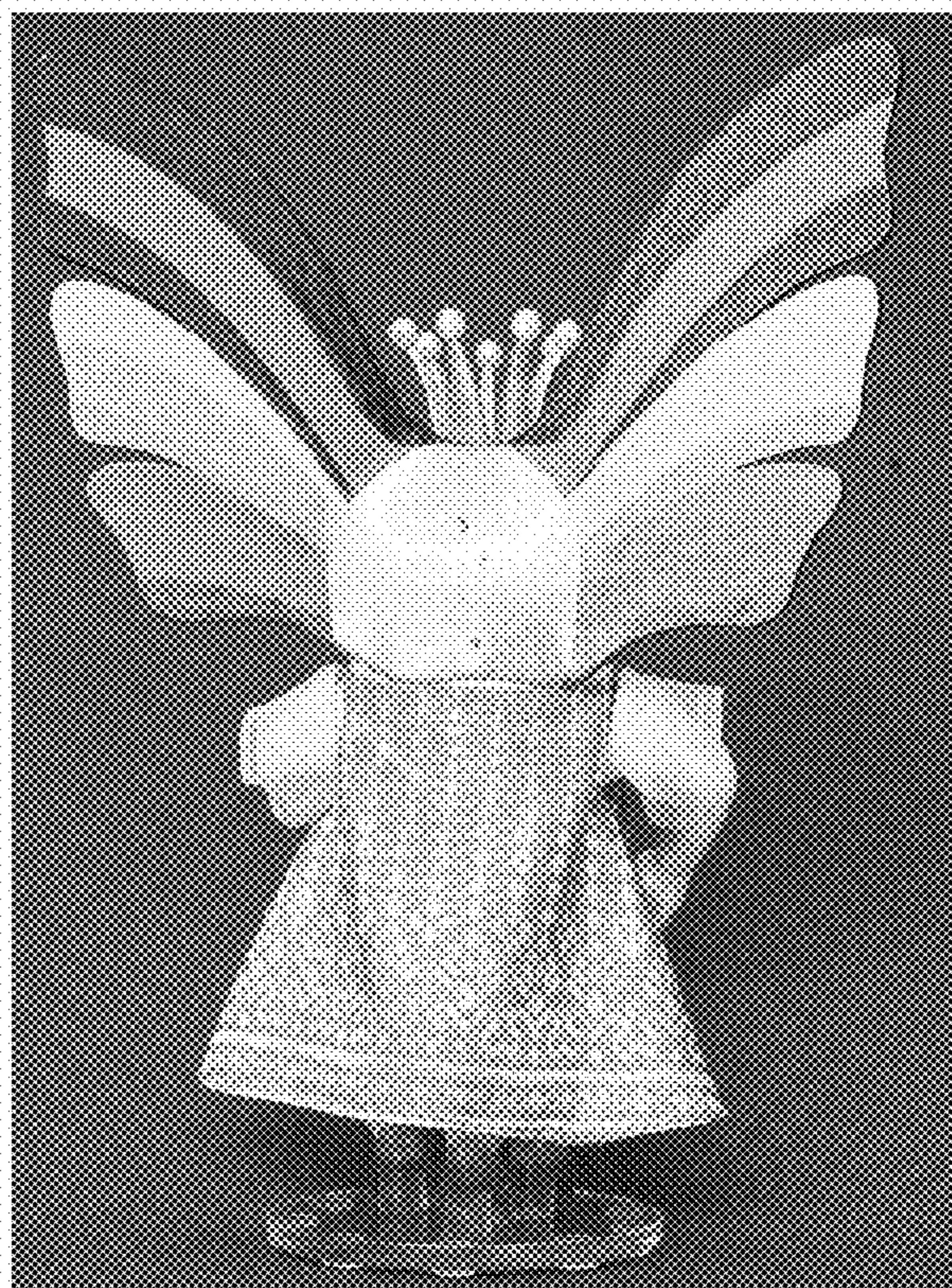
FIG. 2 is a left-side elevational view of the figurine;

FIG. 5 is a back elevational view of the figurine.

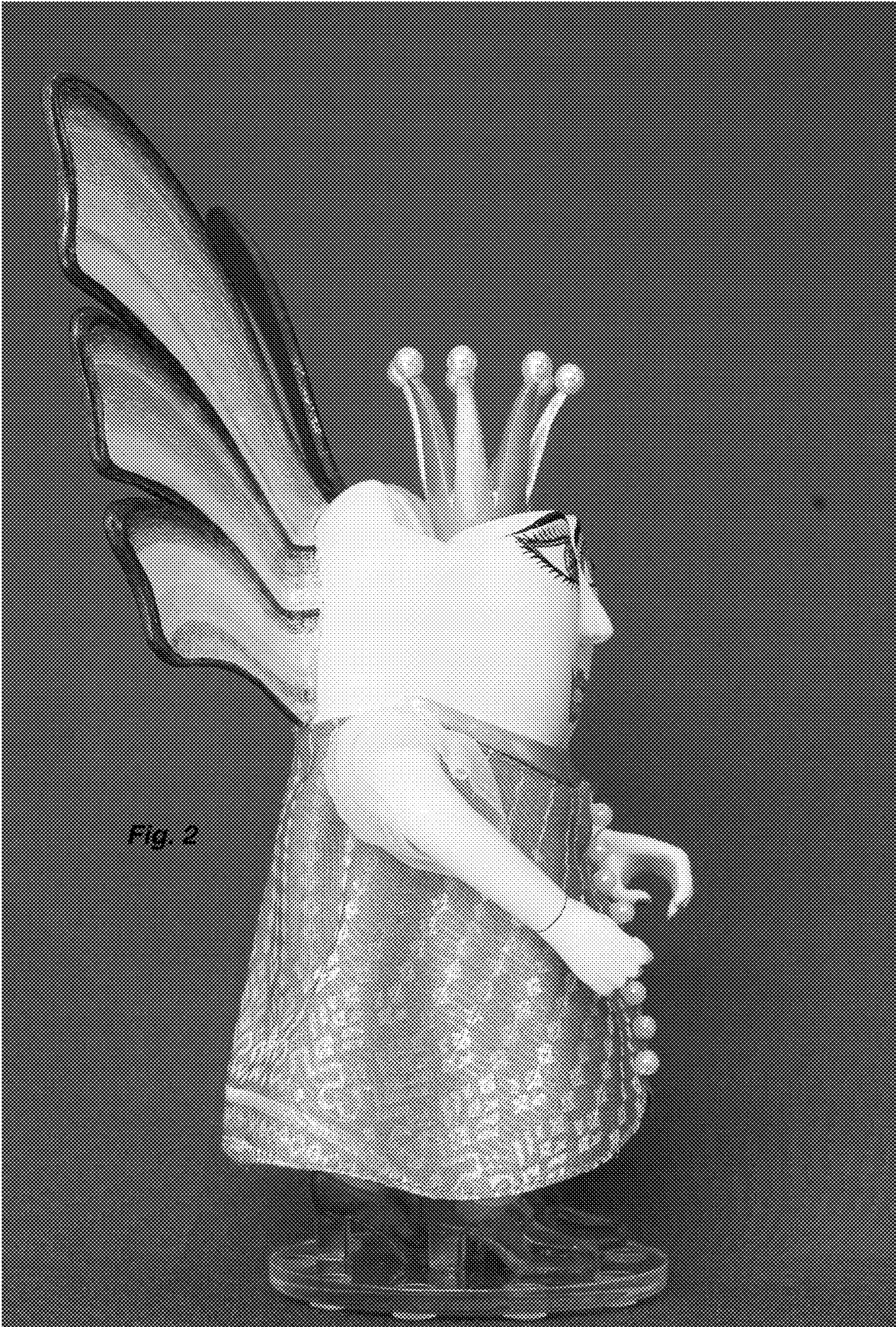

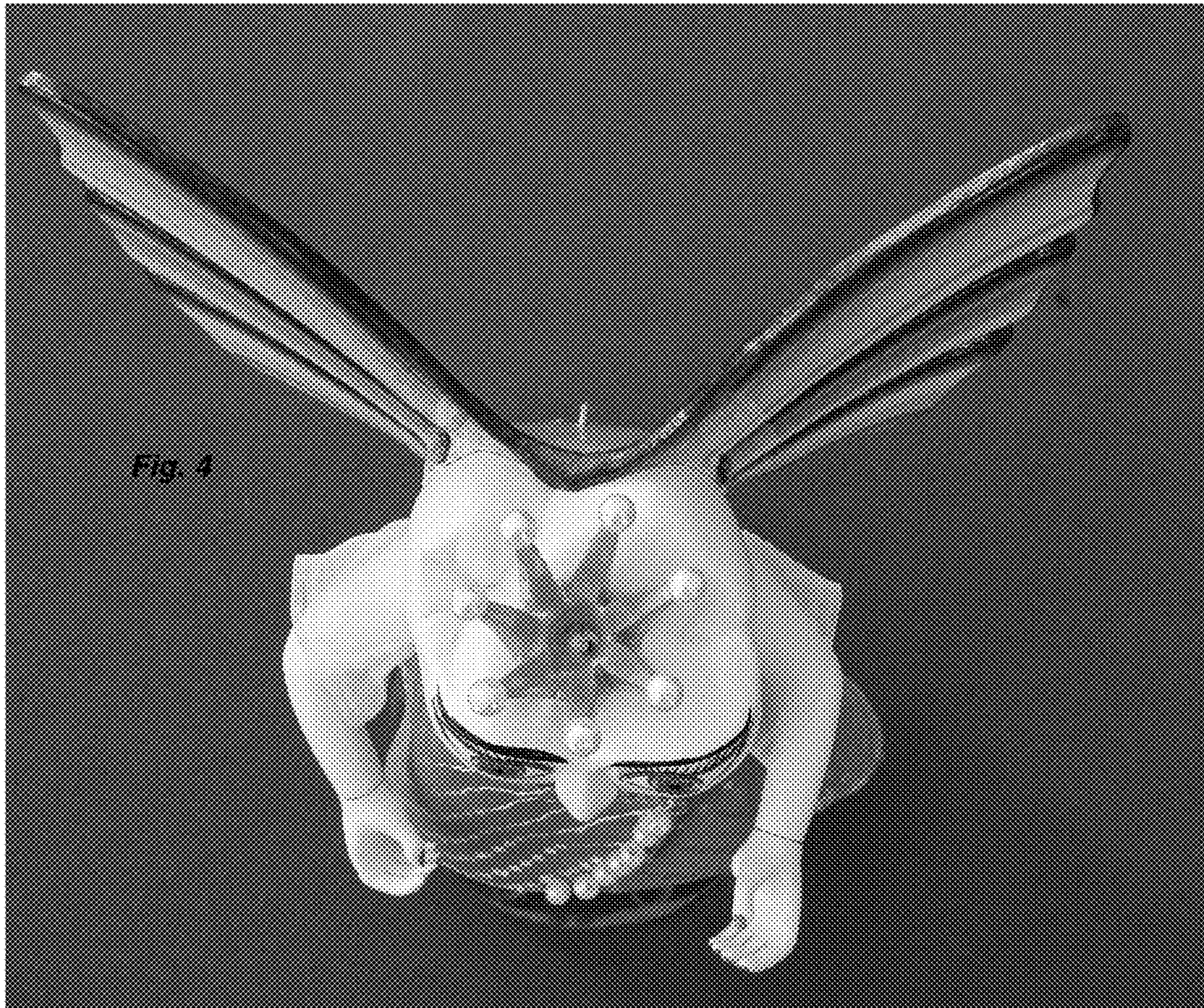














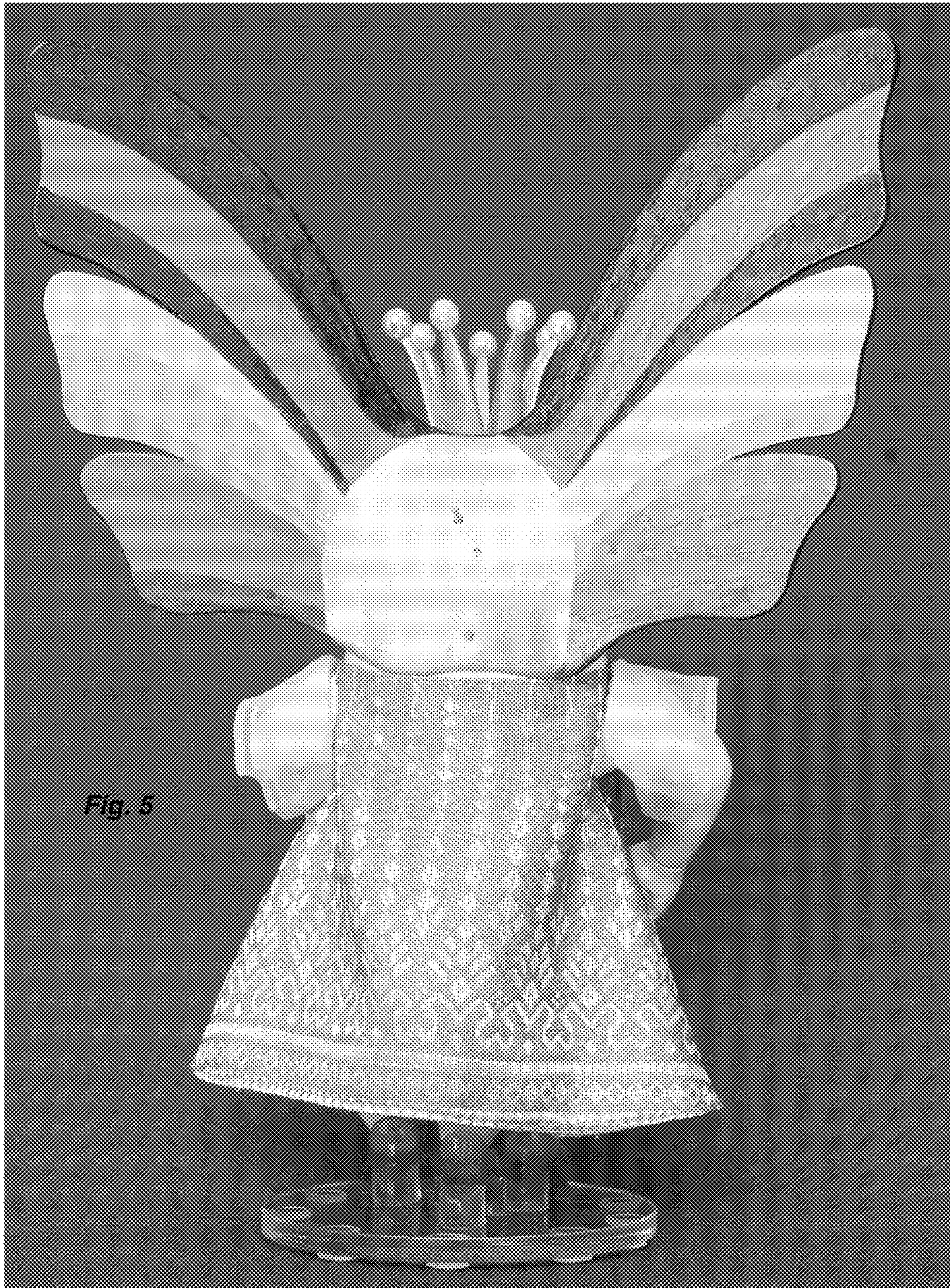
