(57) **CLAIM**

The ornamental design for a display screen or portion thereof with icon for presentation of analyte data, as shown and described.

FIG. 1 shows a front view of a first embodiment of a display screen or portion thereof with icon for presentation of analyte data;

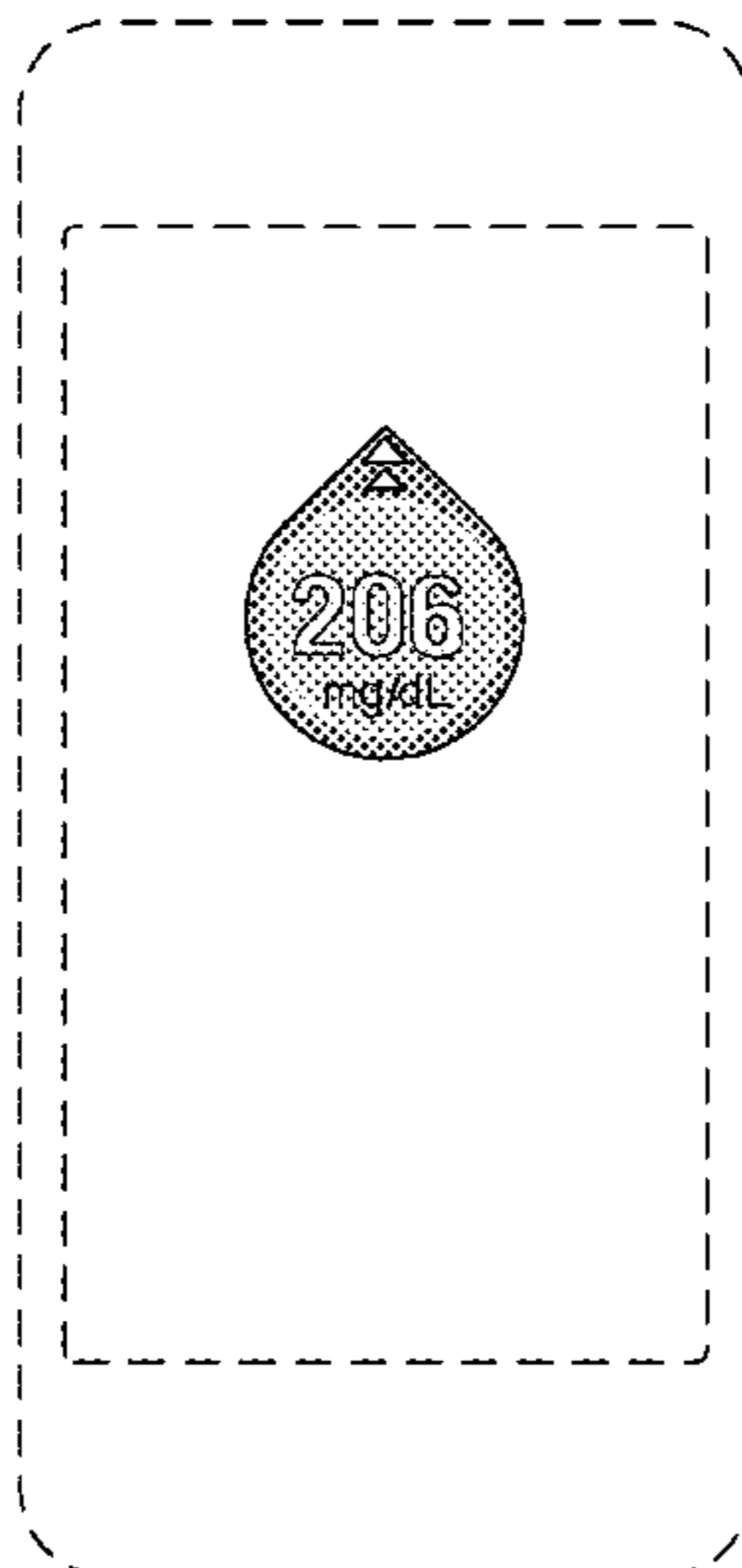
FIG. 2 shows a front view of a second embodiment of the display screen or portion thereof with icon for presentation of analyte data;

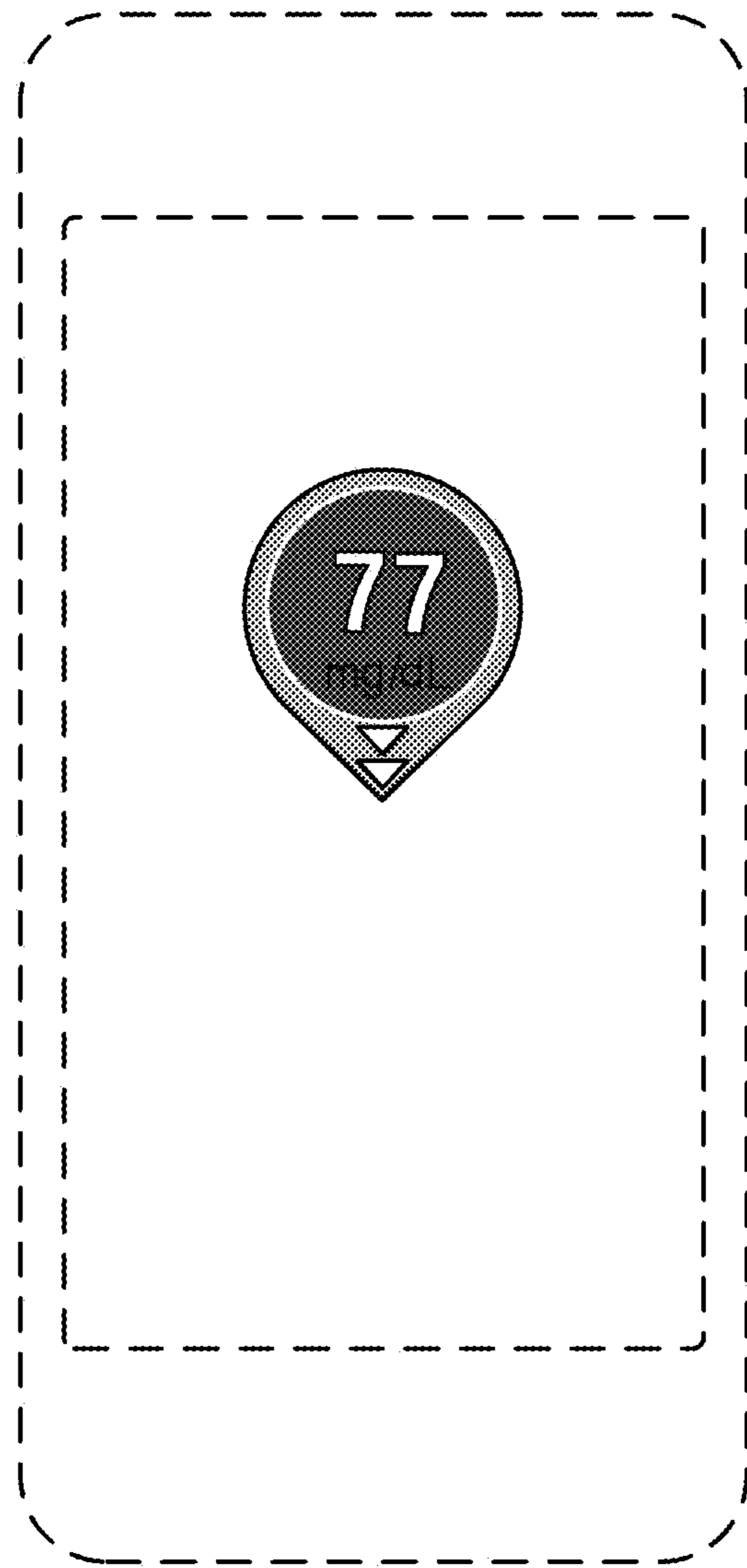

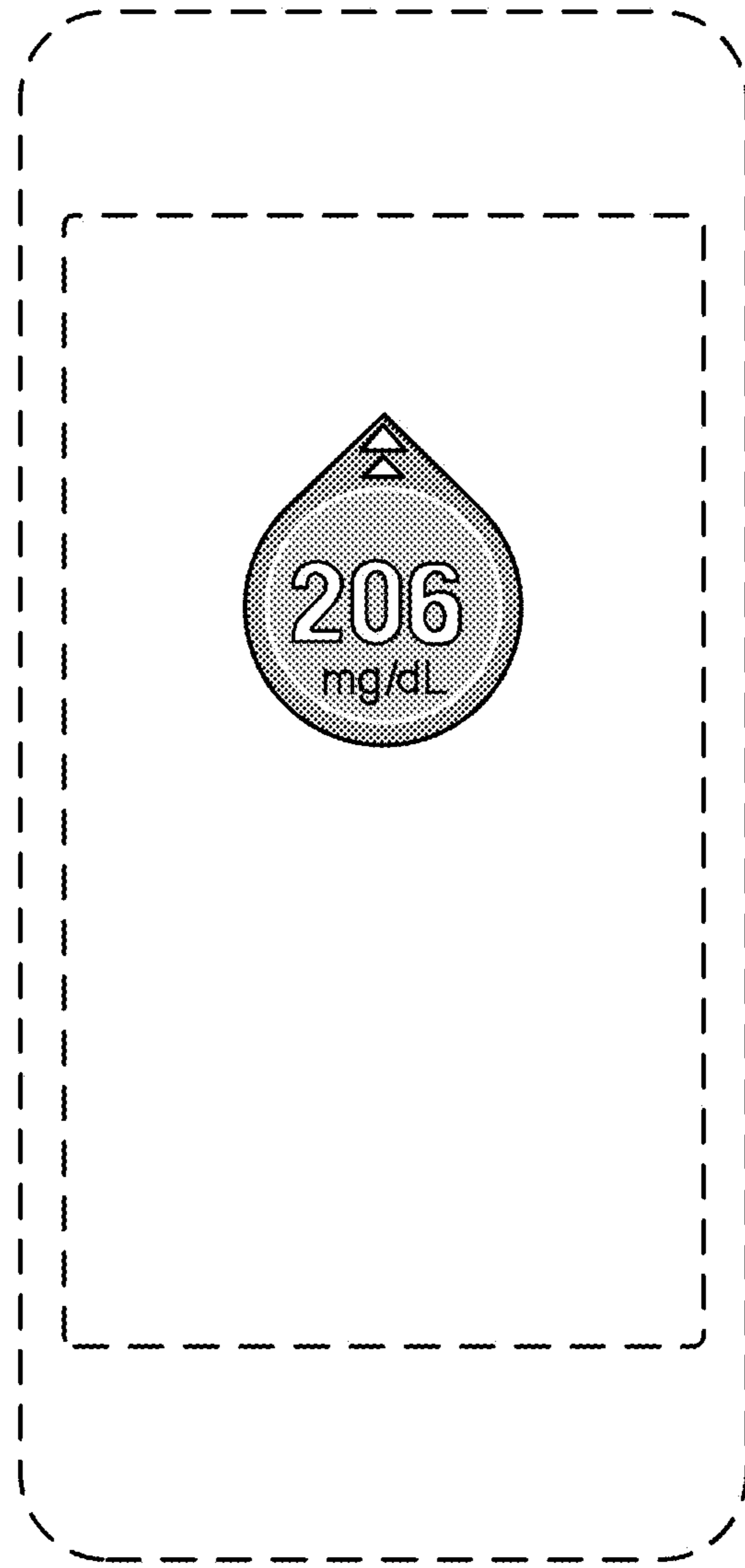

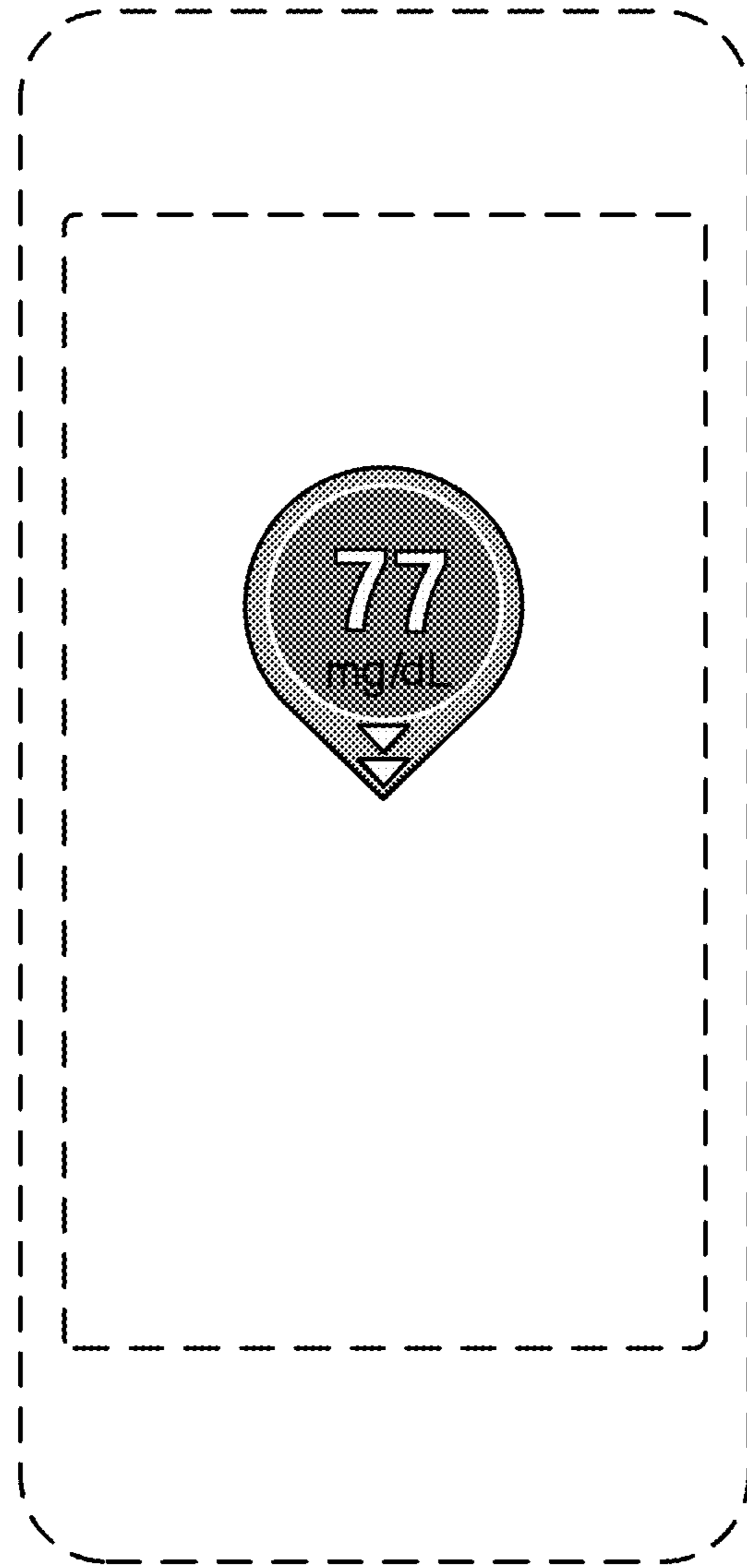

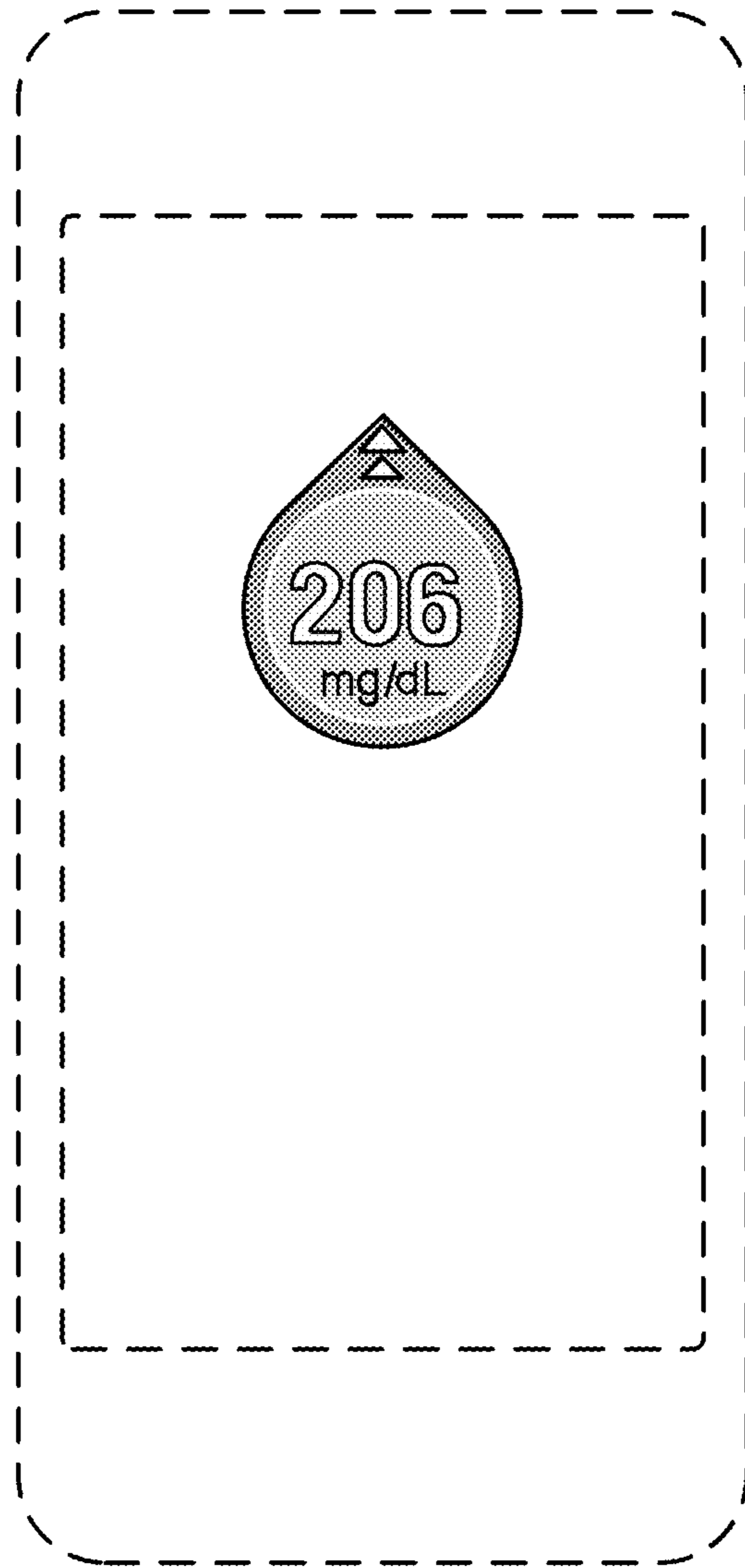
