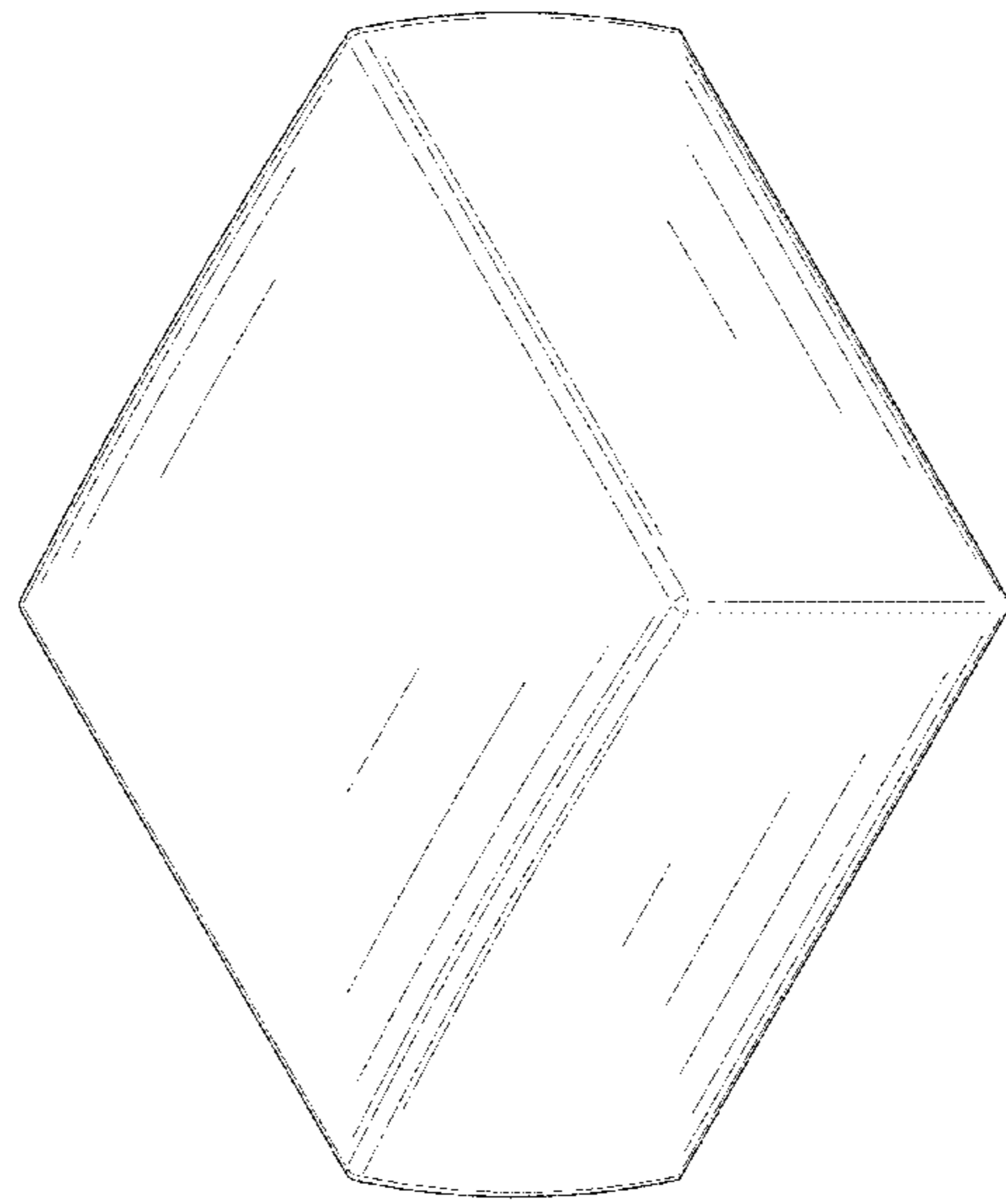

DESCRIPTION
FIG. 1 is a top, left, front perspective view of a vehicle-mounted sign, showing my new design;

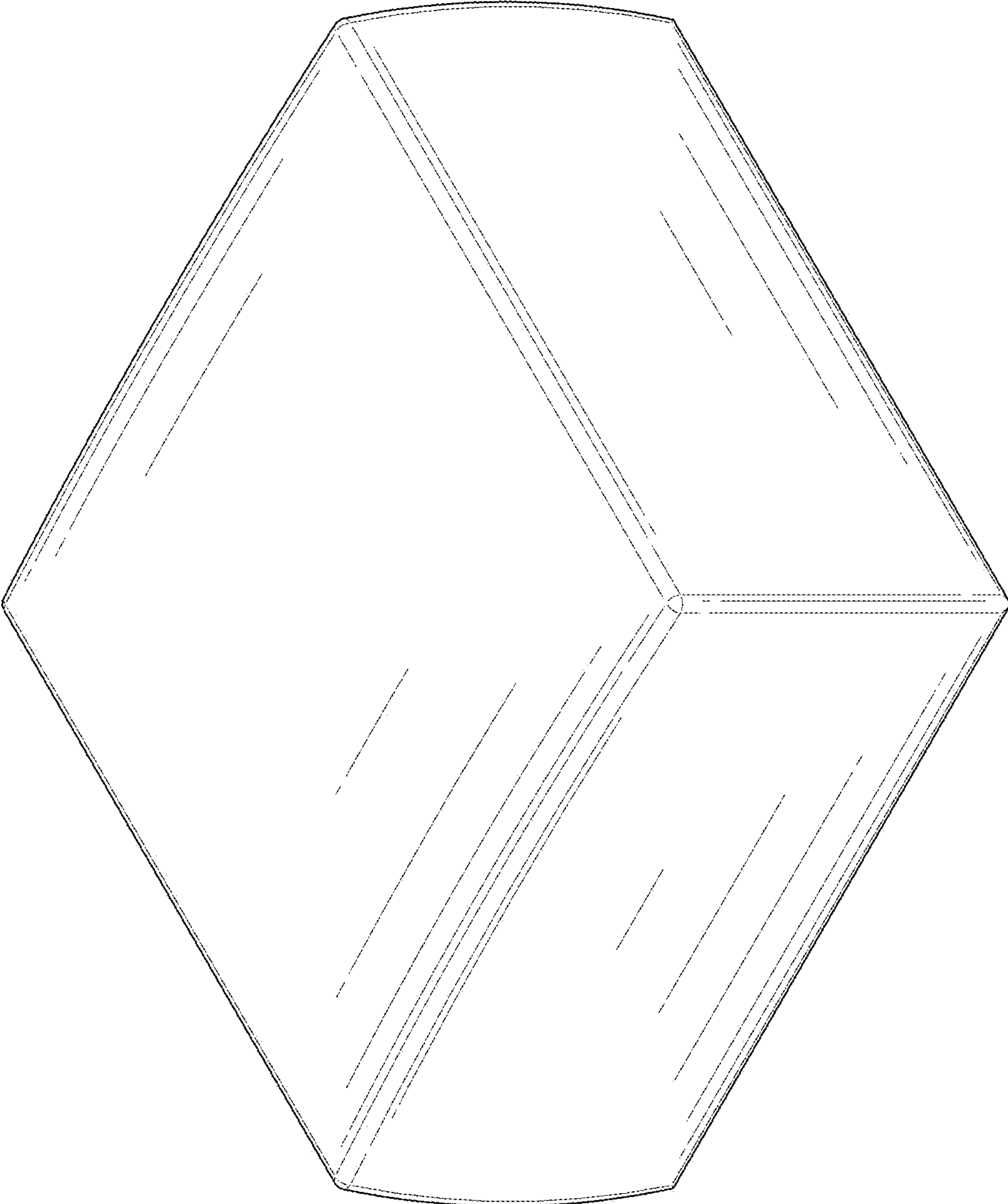

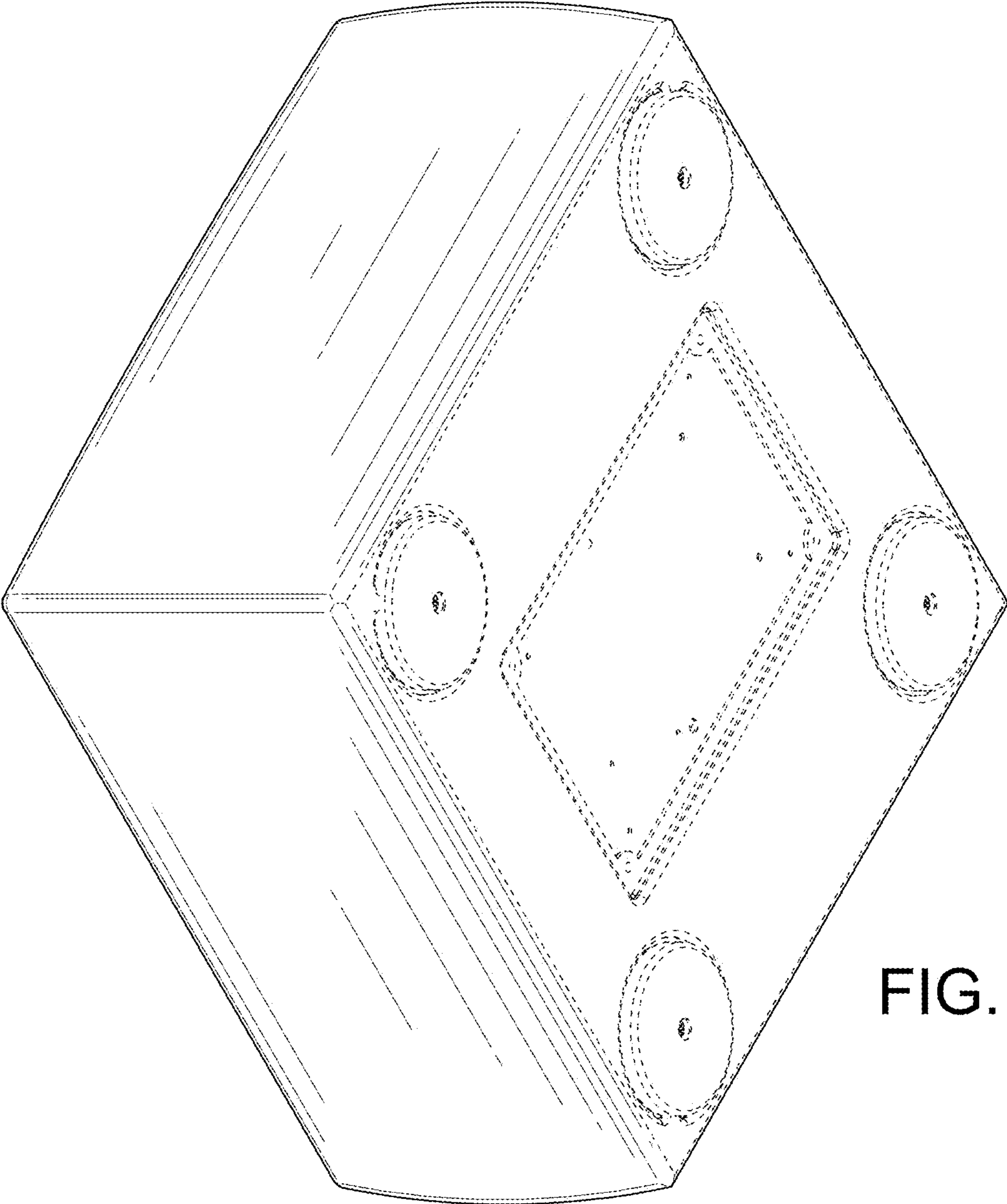

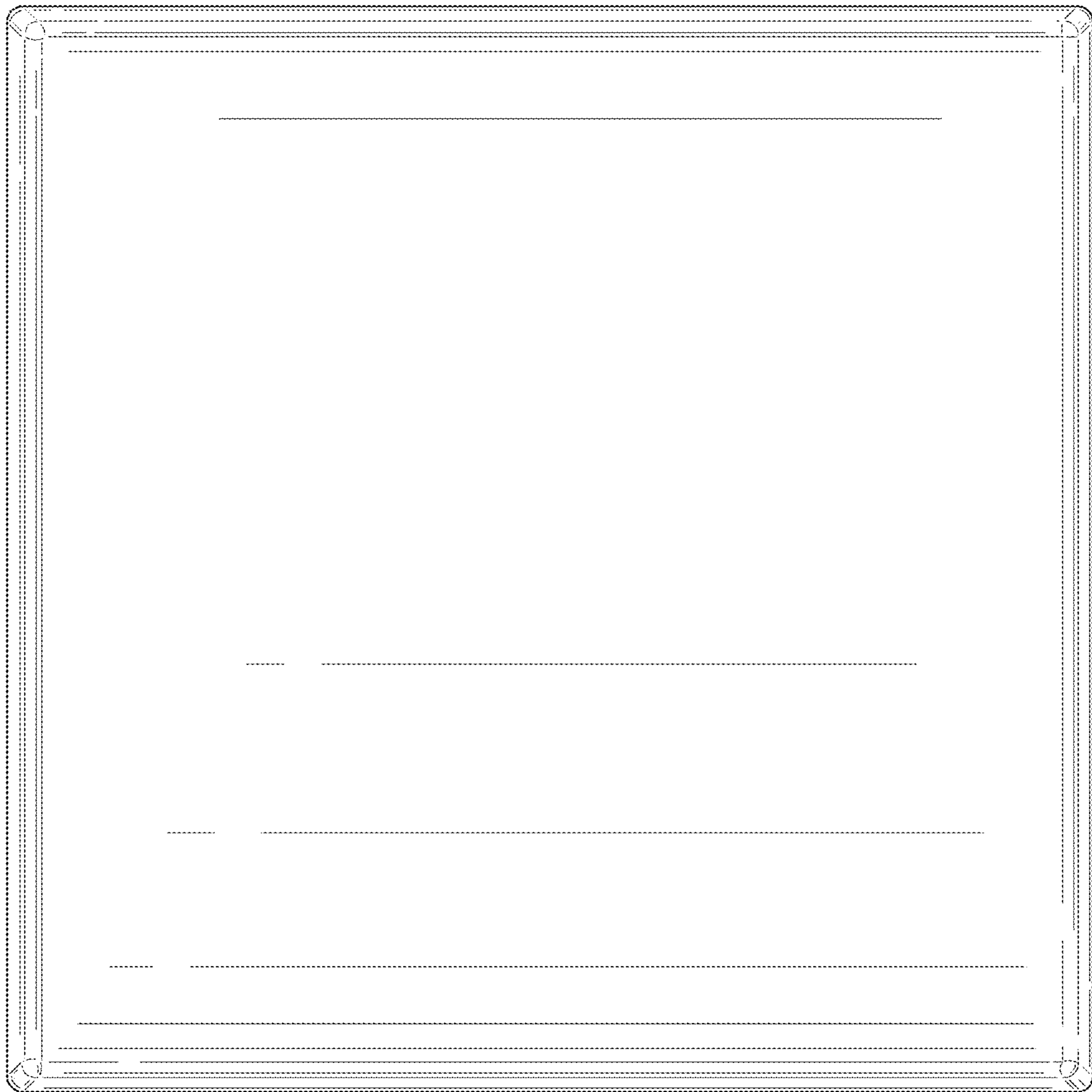

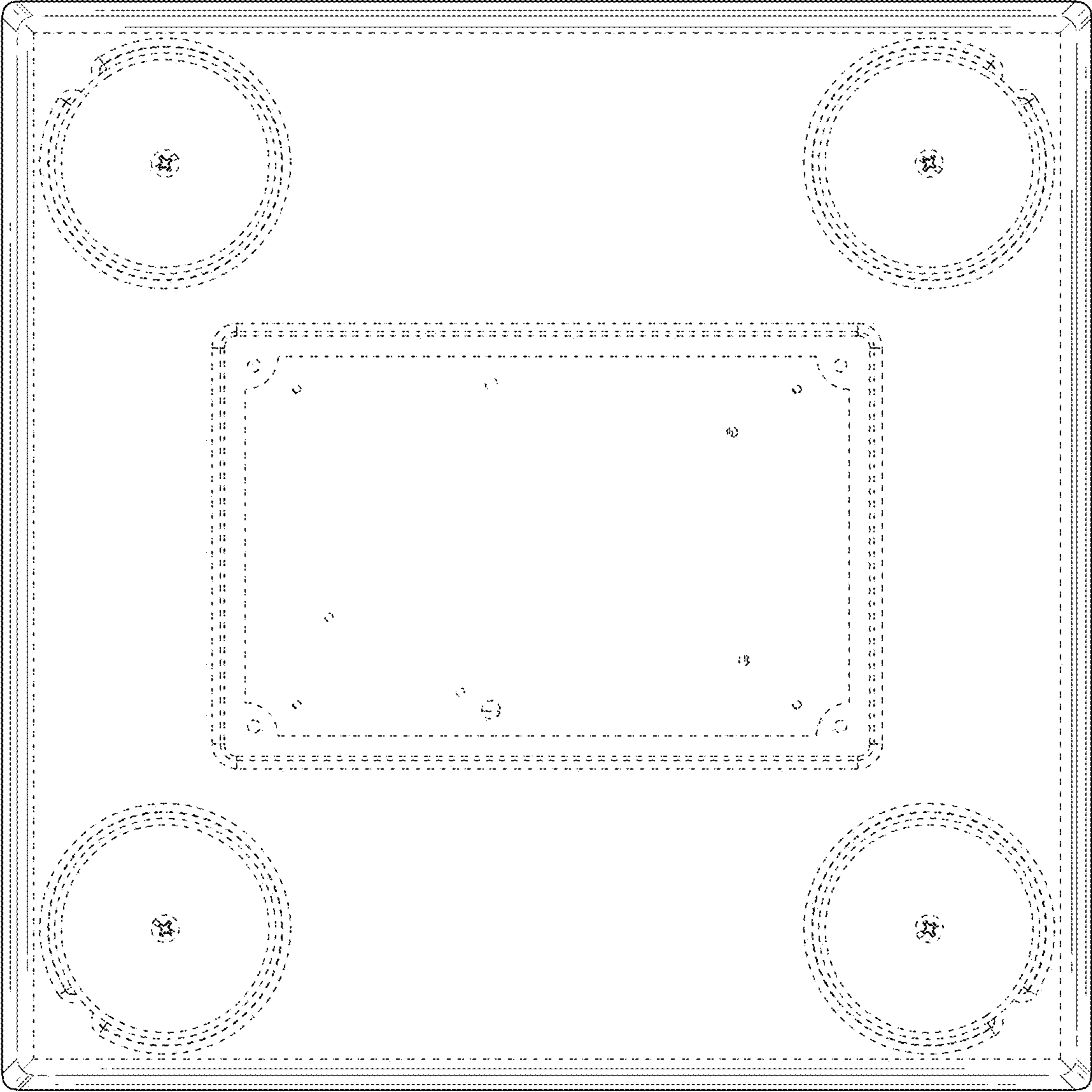

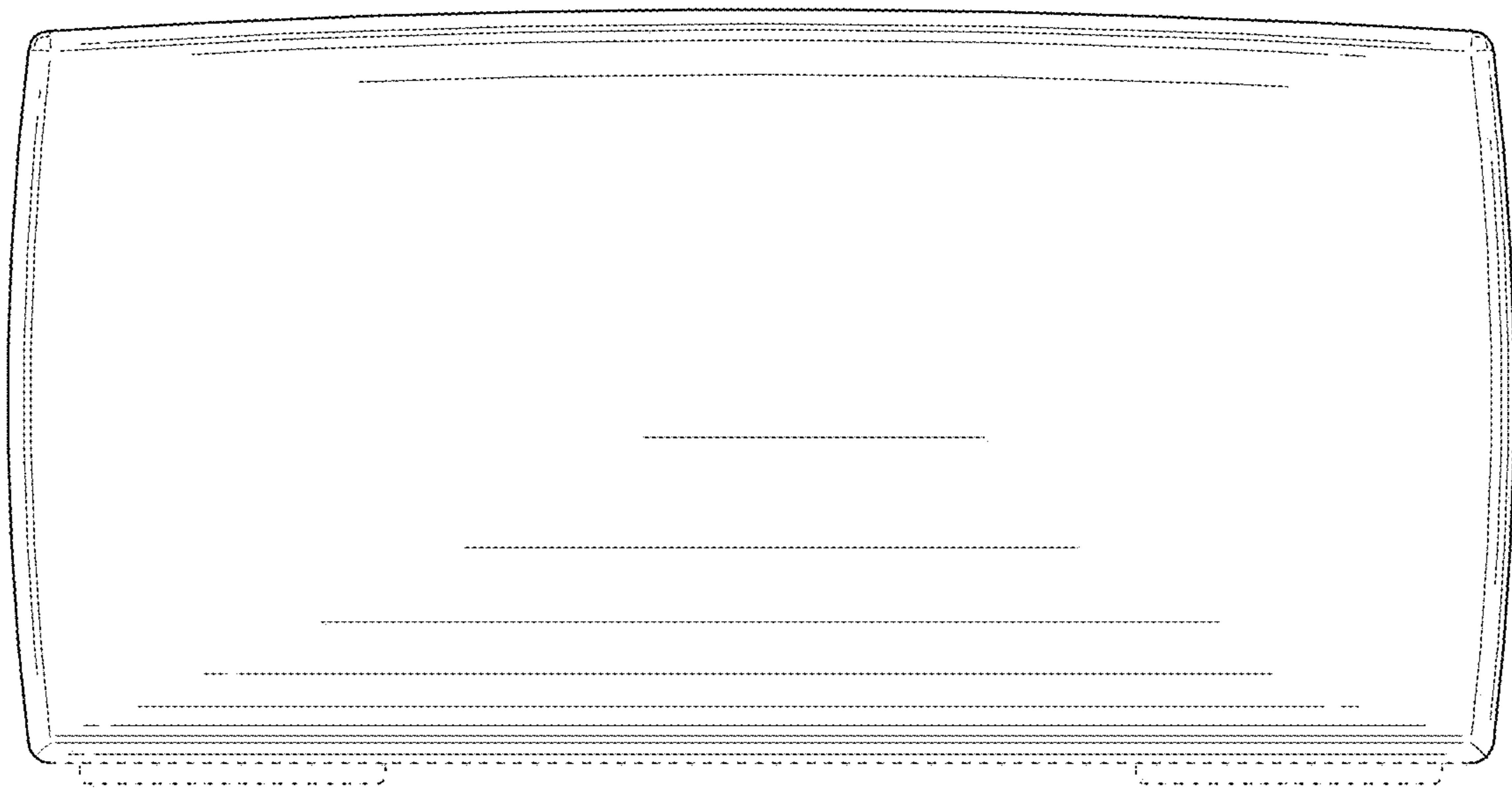

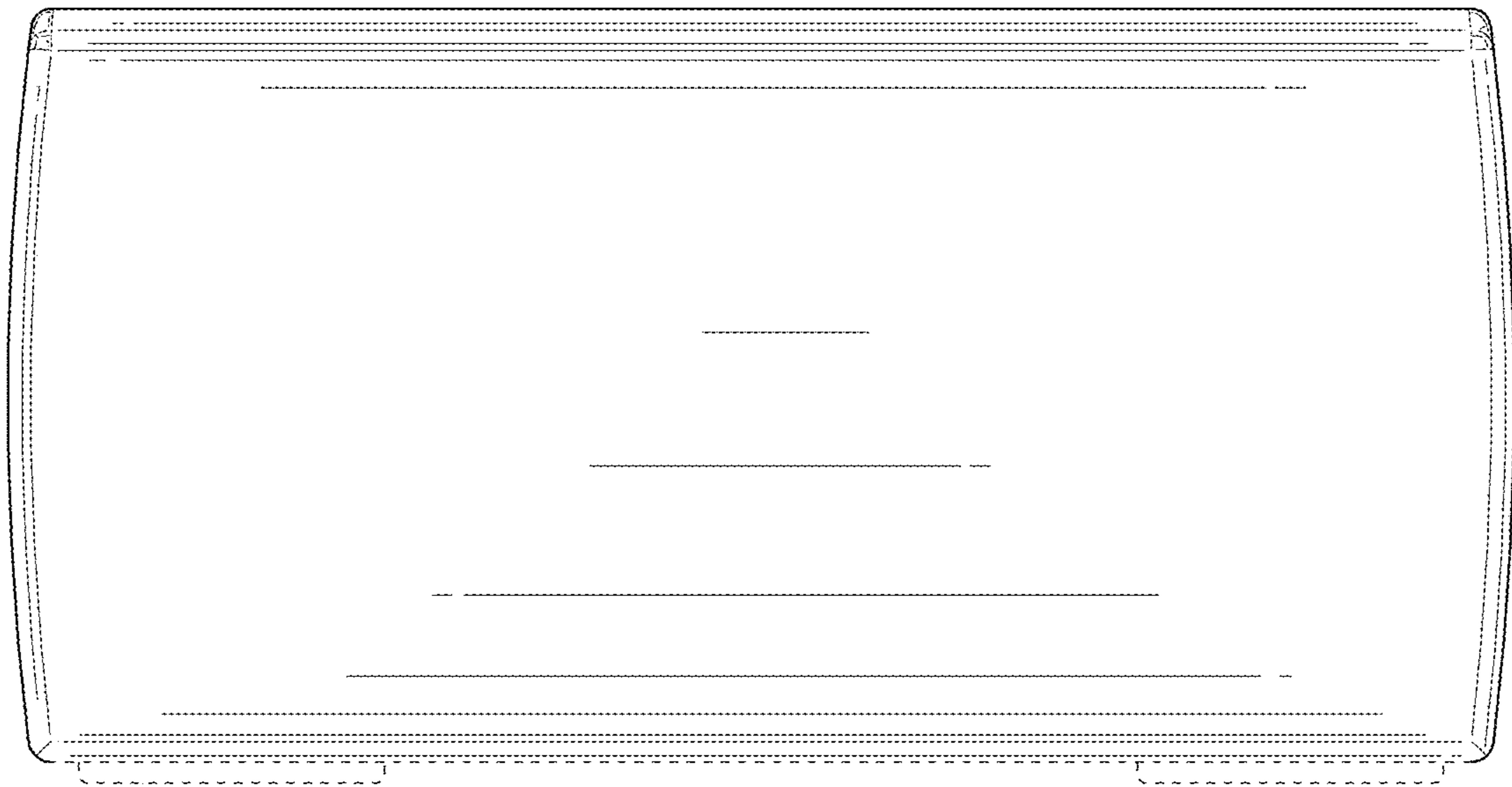

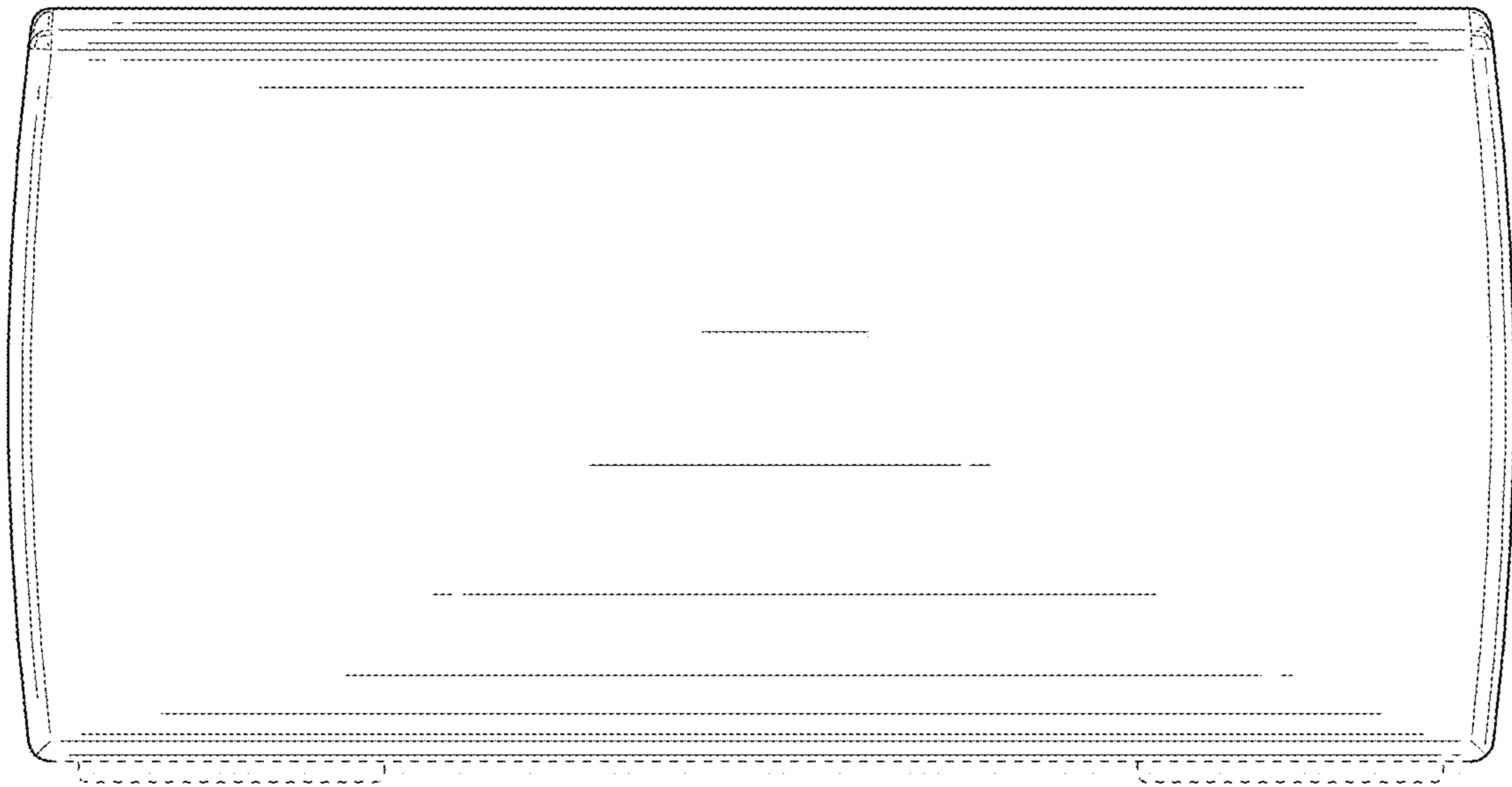
