**DESCRIPTION**

FIG. 1 is a perspective view of a seal showing our new design;

FIG. 2 is a top view thereof;

FIG. 4 is a front elevation view thereof;

FIG. 5 is a right side elevation view thereof;

FIG. 6 is a cross-sectional view thereof taken along lines 6-6 shown in FIG. 2;

FIG. 7 is an enlarged cross-sectional view of a portion thereof taken from area 7-7 shown in FIG. 6;

FIG. 8 is a cross-sectional view thereof taken along lines 8-8 shown in FIG. 2;

FIG. 9 is an enlarged cross-sectional view of a portion thereof taken from area 9-9 shown in FIG. 8;

FIG. 10 is a cross-sectional view thereof taken along lines 10-10 shown in FIG. 2;

FIG. 11 is an enlarged cross-sectional view of a portion thereof taken from area 11-11 shown in FIG. 10;

FIG. 12 is a cross-sectional view thereof taken along lines 12-12 shown in FIG. 2;

FIG. 13 is an enlarged cross-sectional view of a portion thereof taken from area 13-13 shown in FIG. 12;

FIG. 20 is an enlarged cross-sectional view of a portion thereof taken from area 20-20 shown in FIG. 18;

FIG. 21 is a cross-sectional view thereof taken along lines 21-21 shown in FIG. 2;

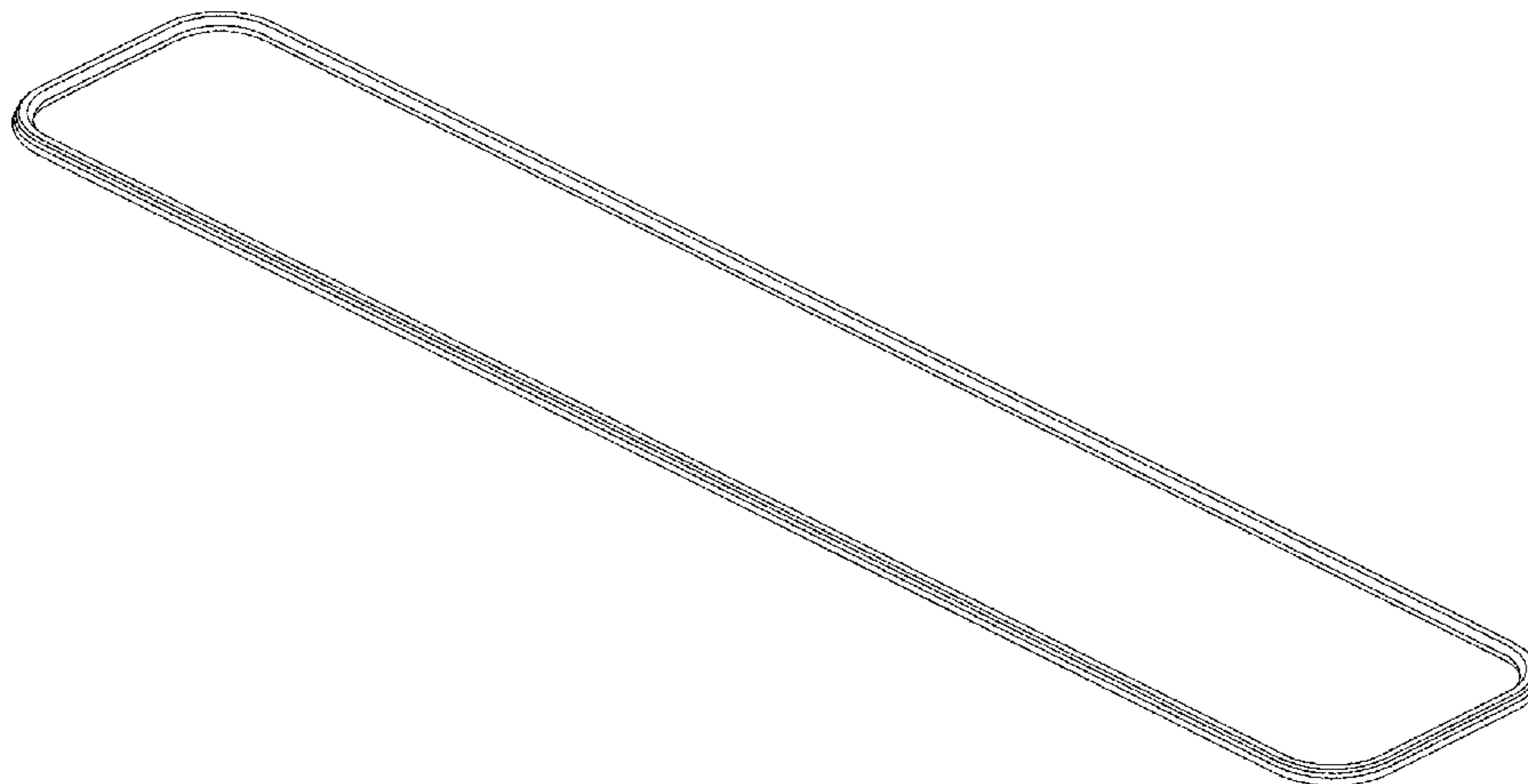

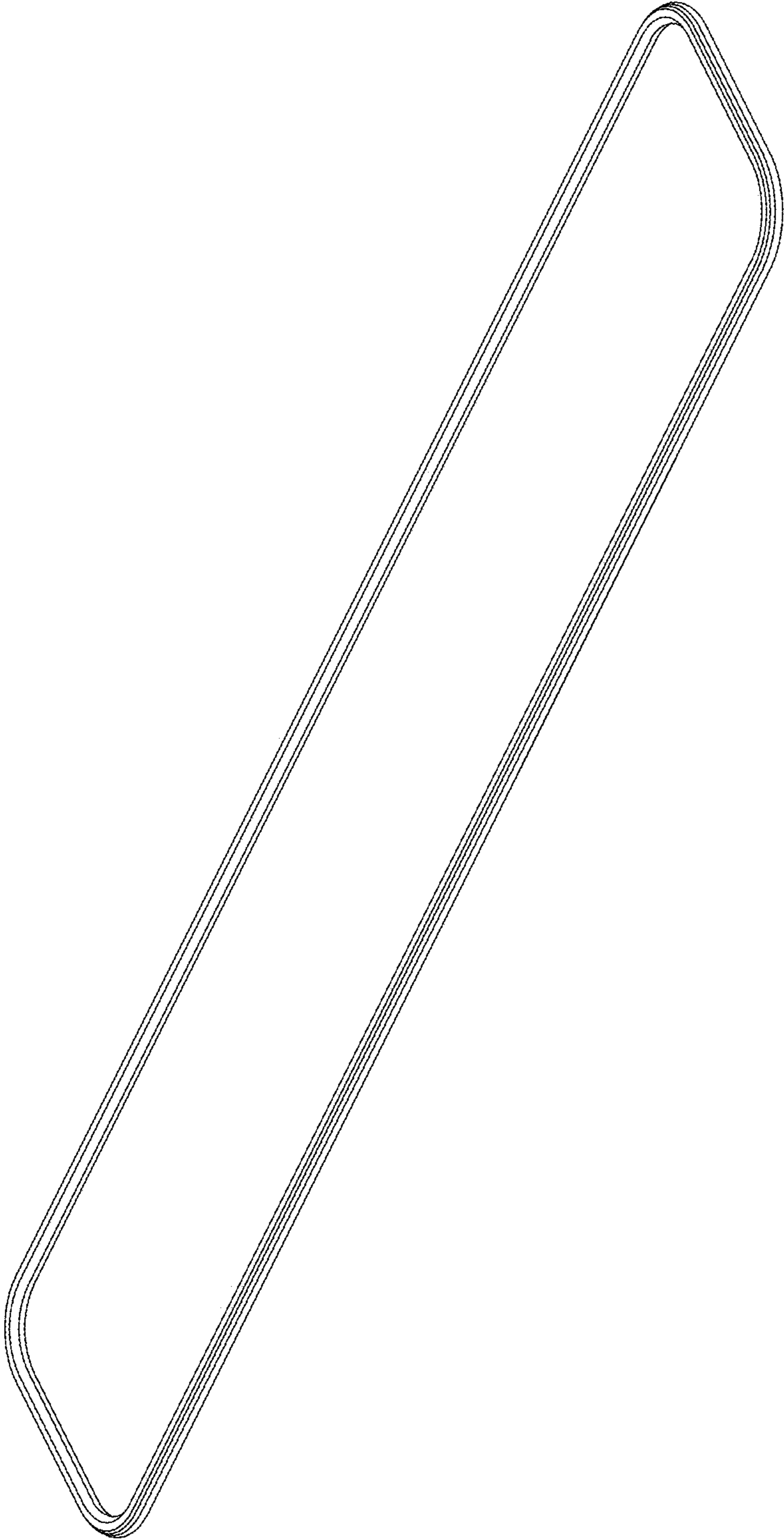

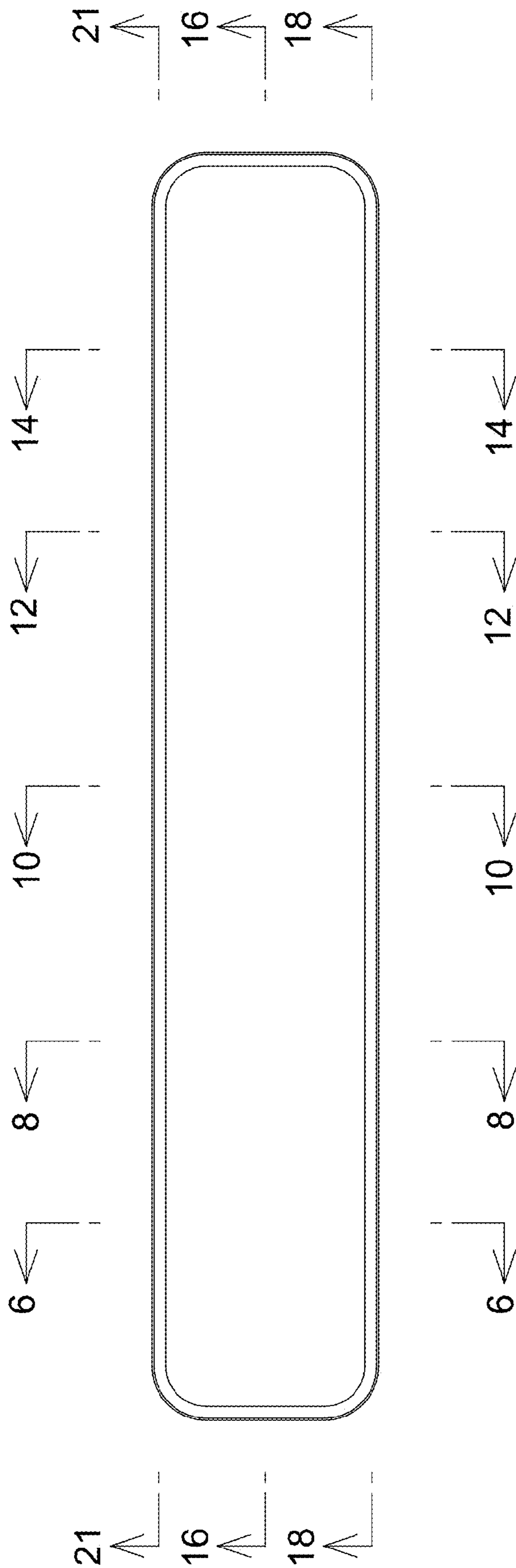

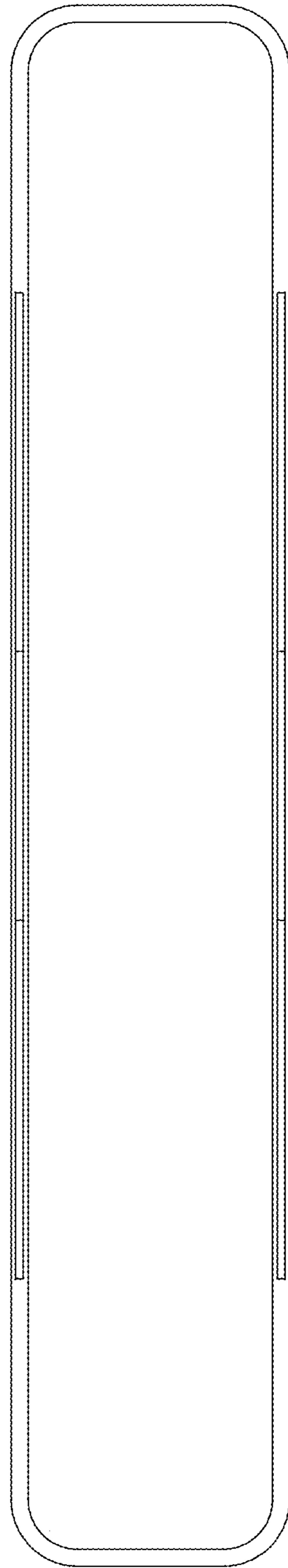

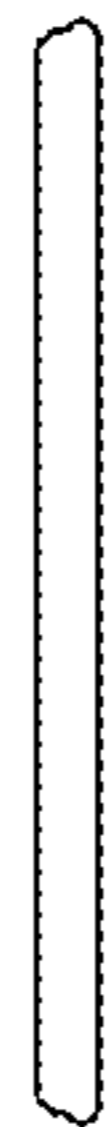

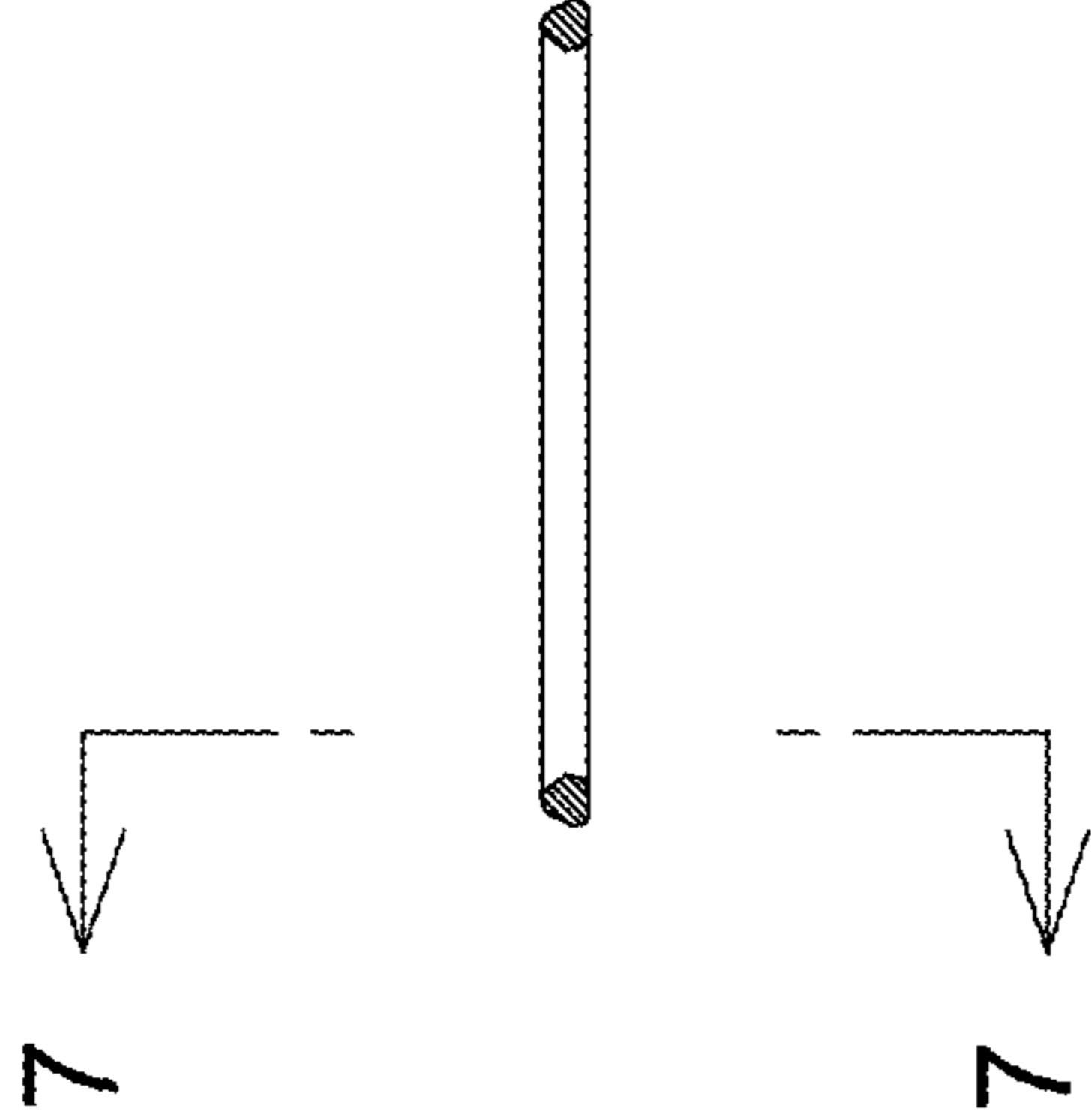

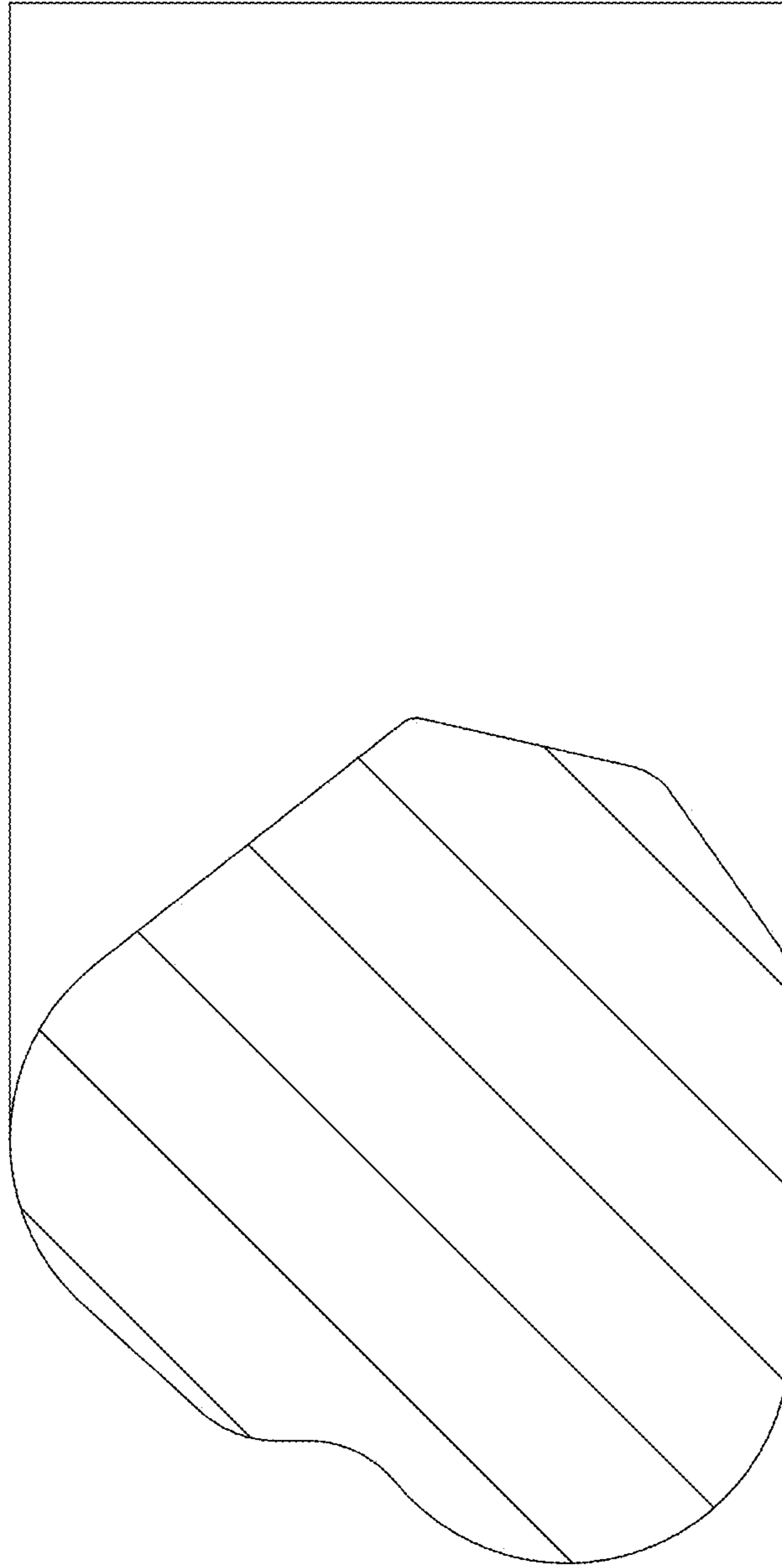

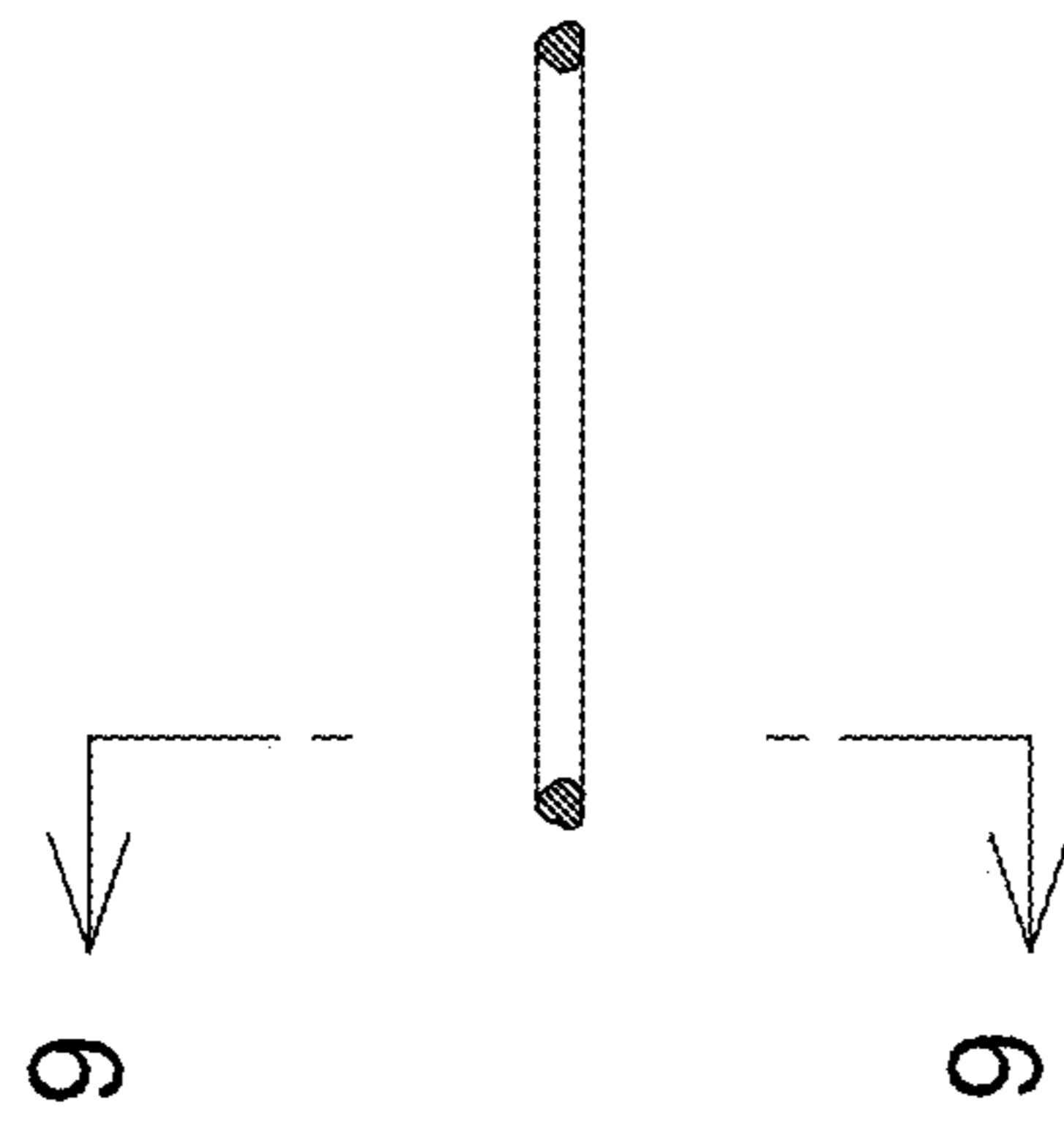

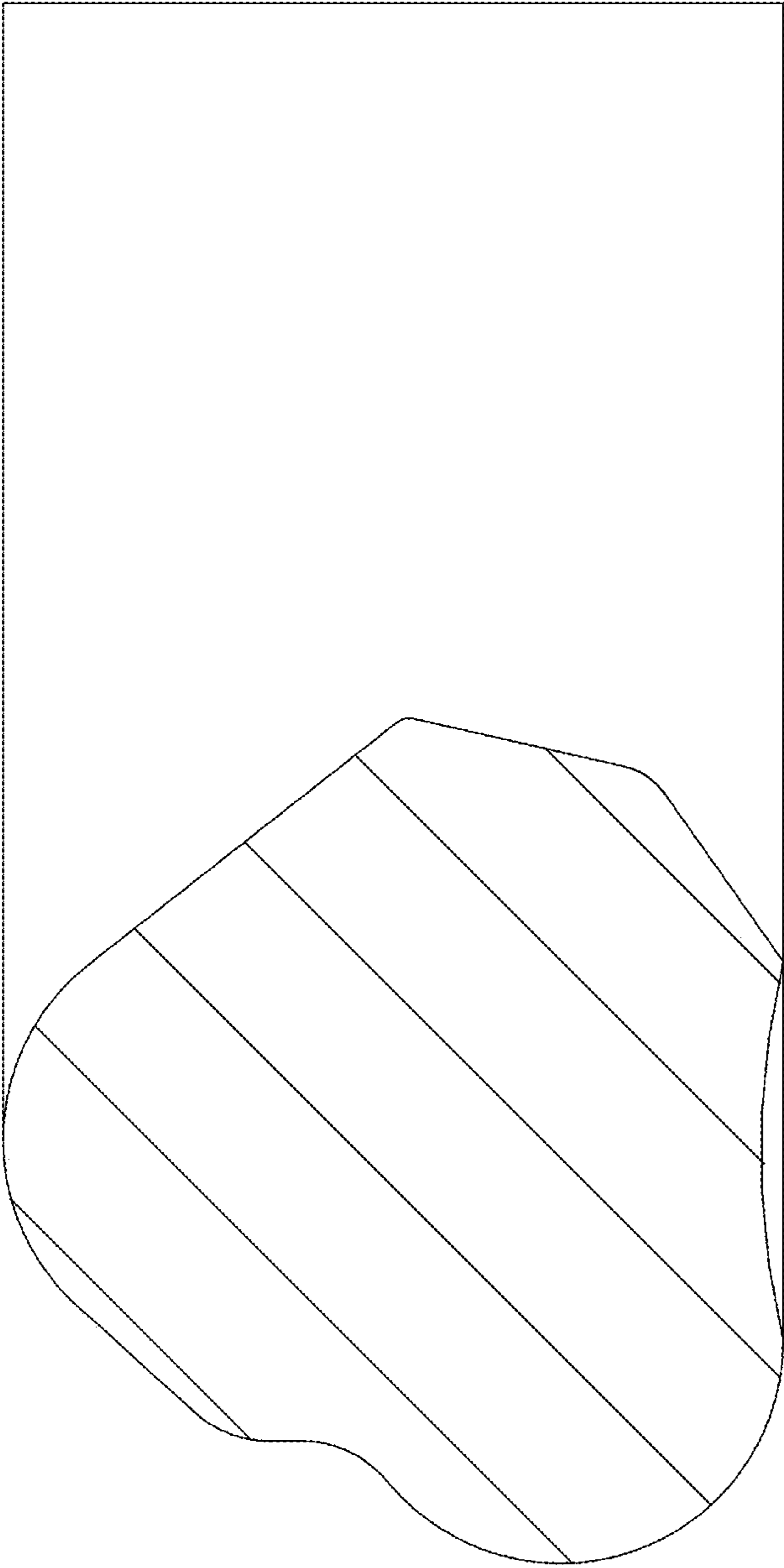

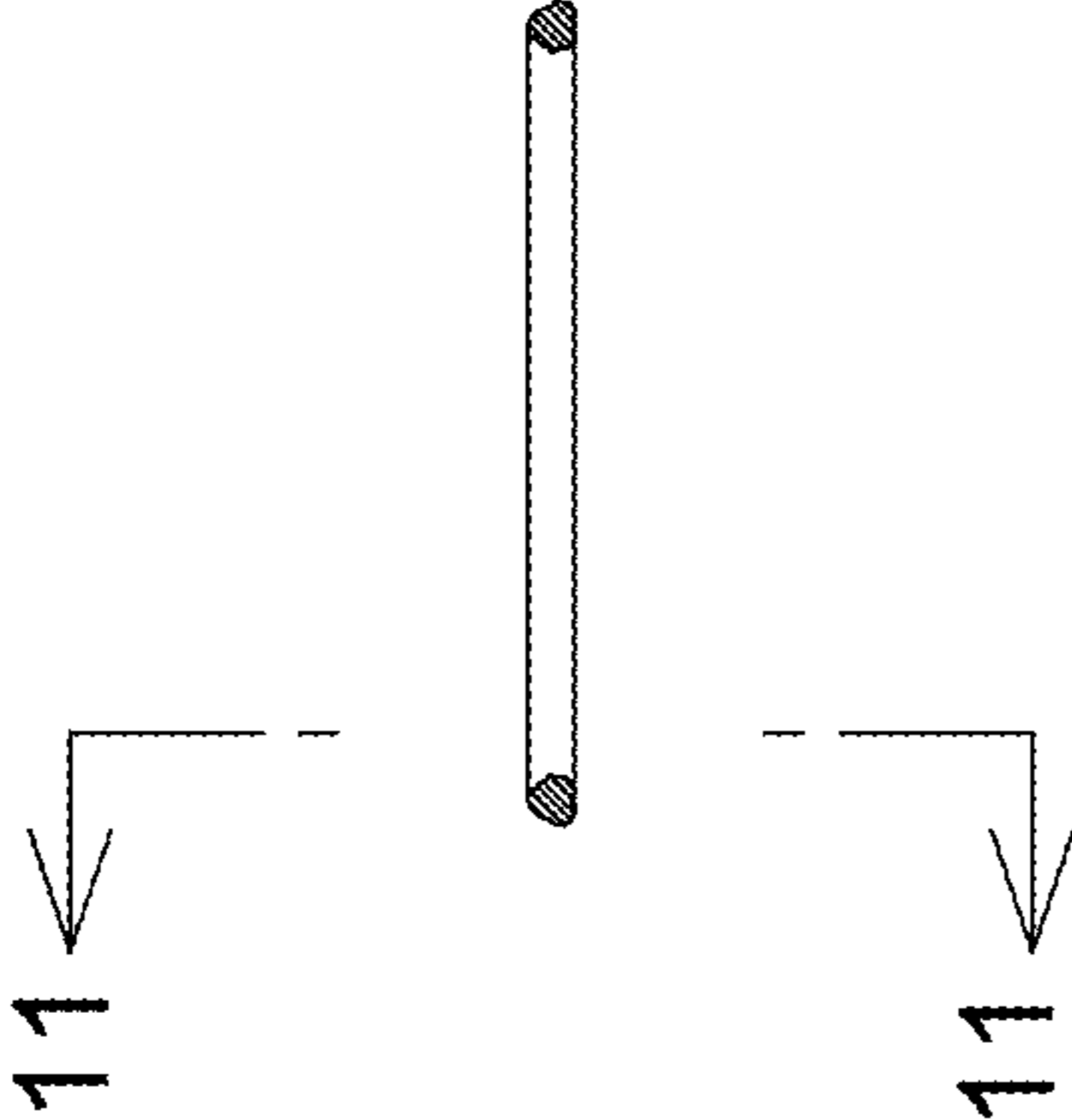

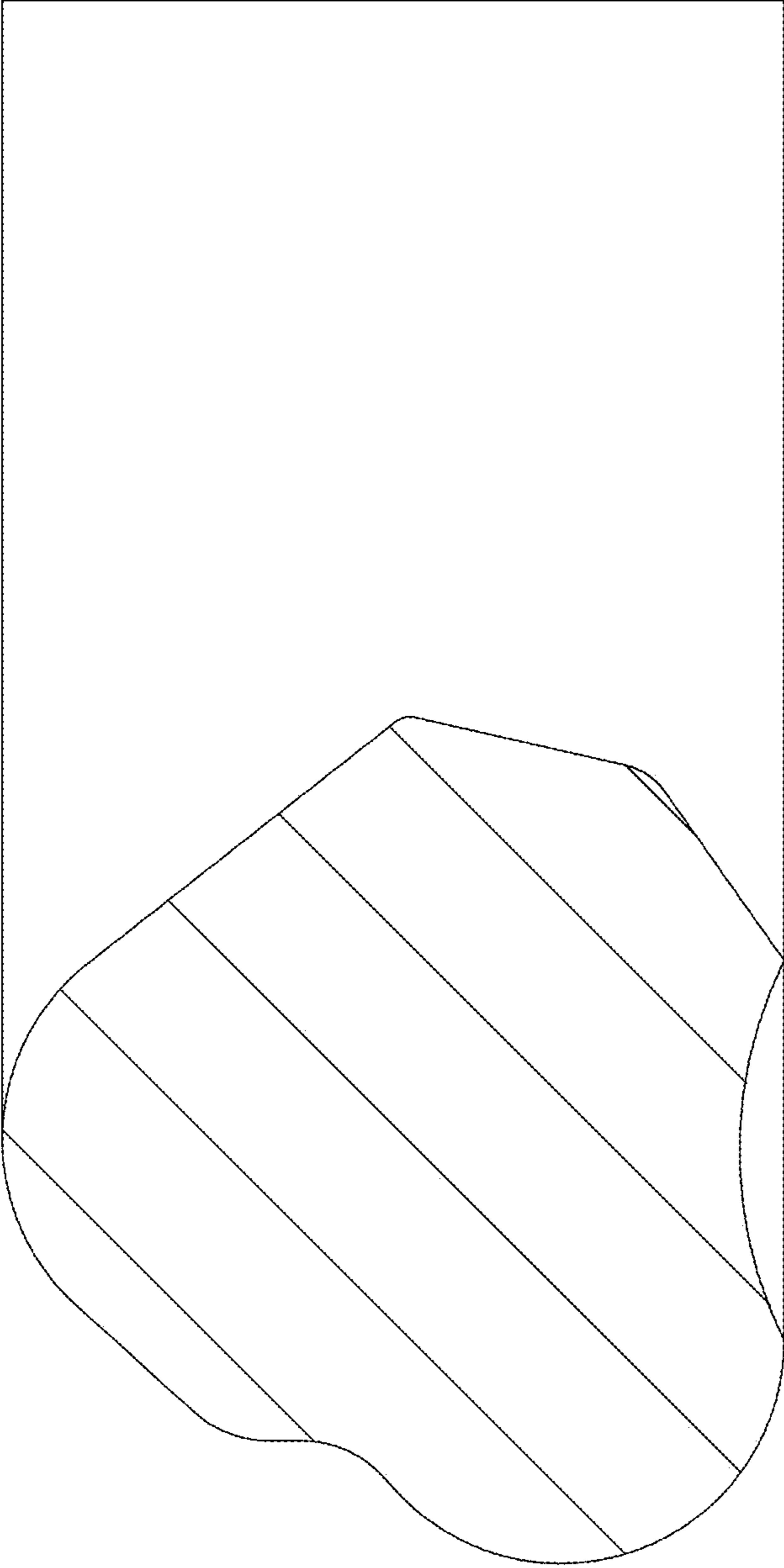

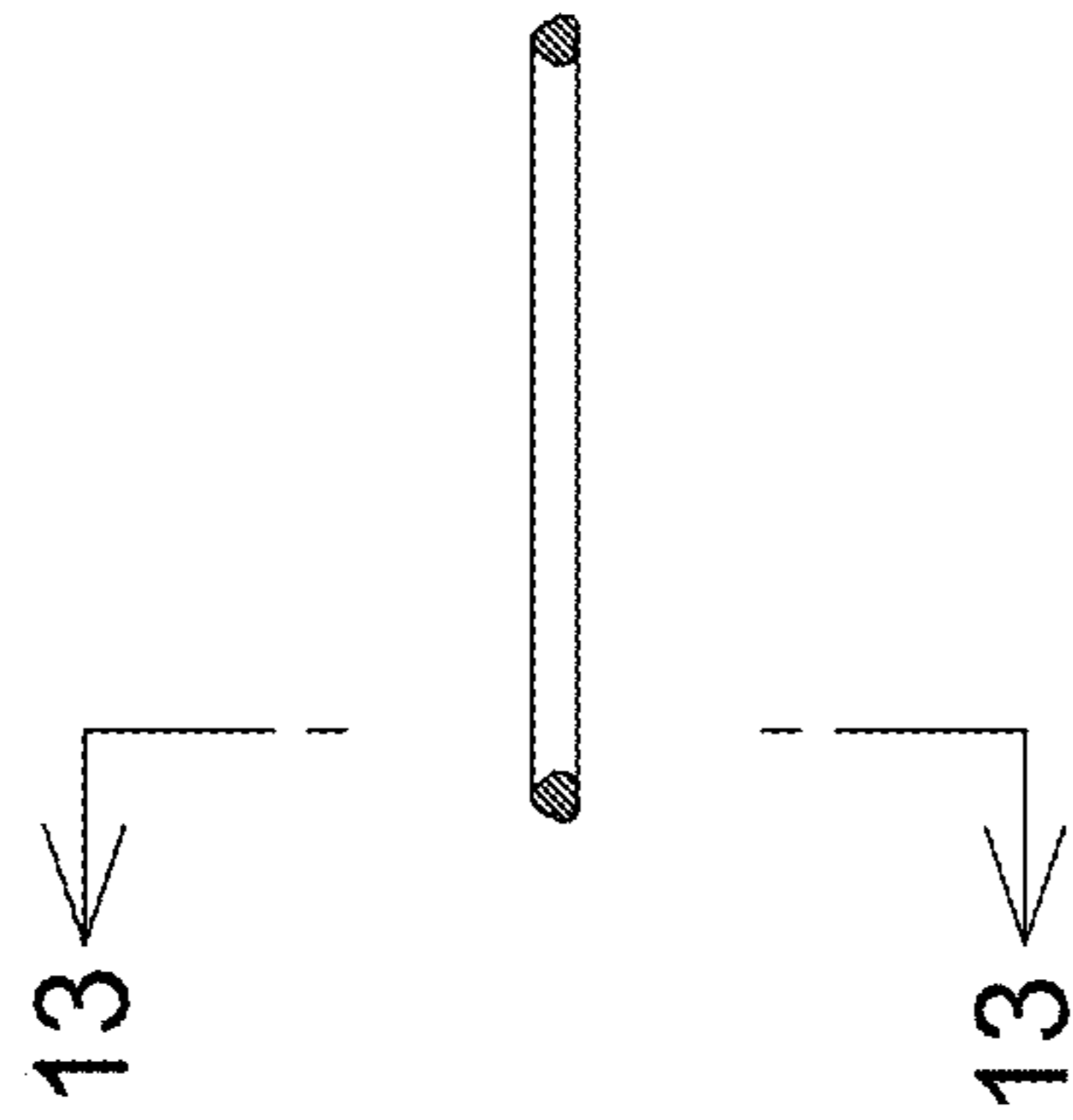

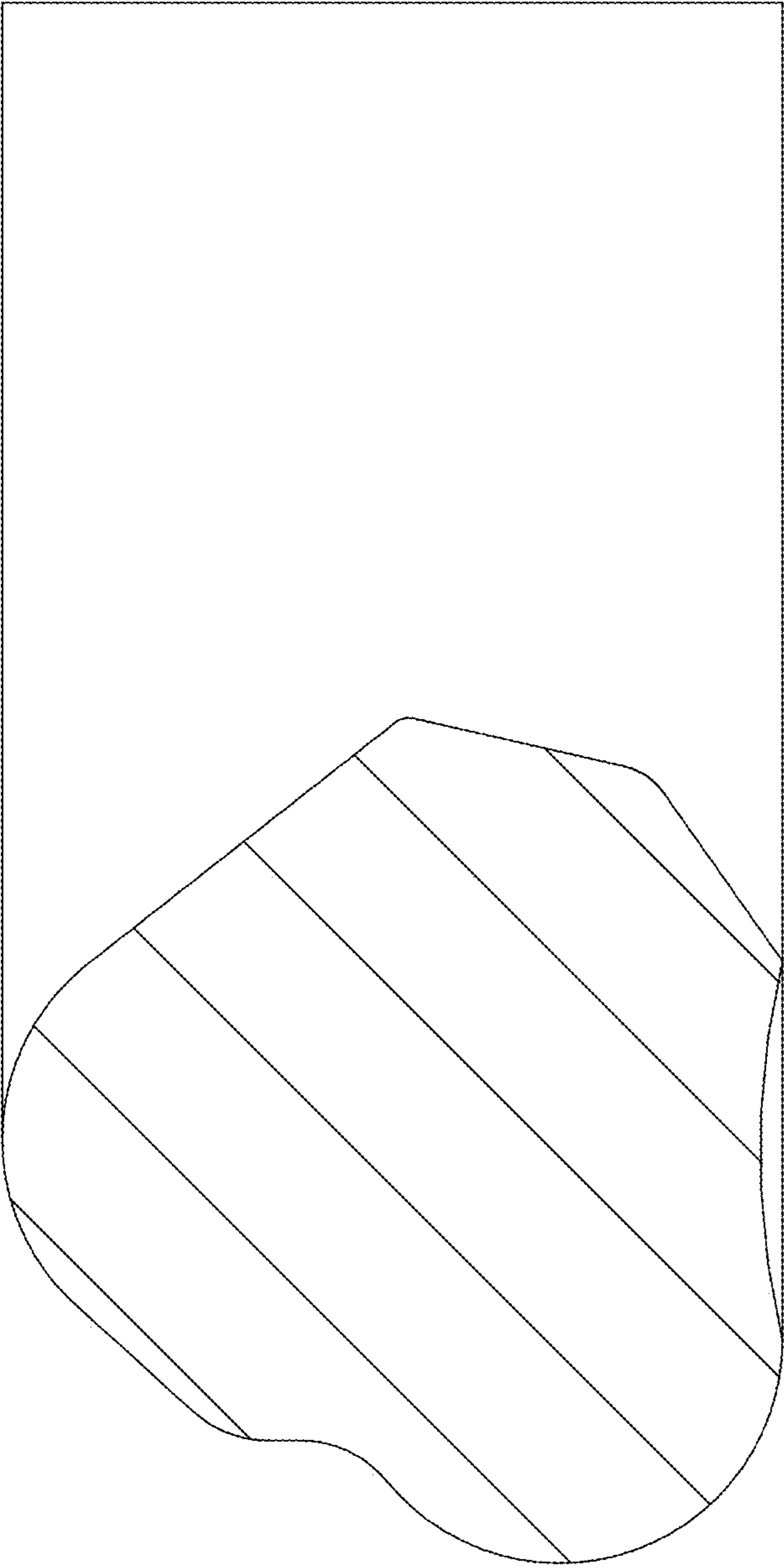

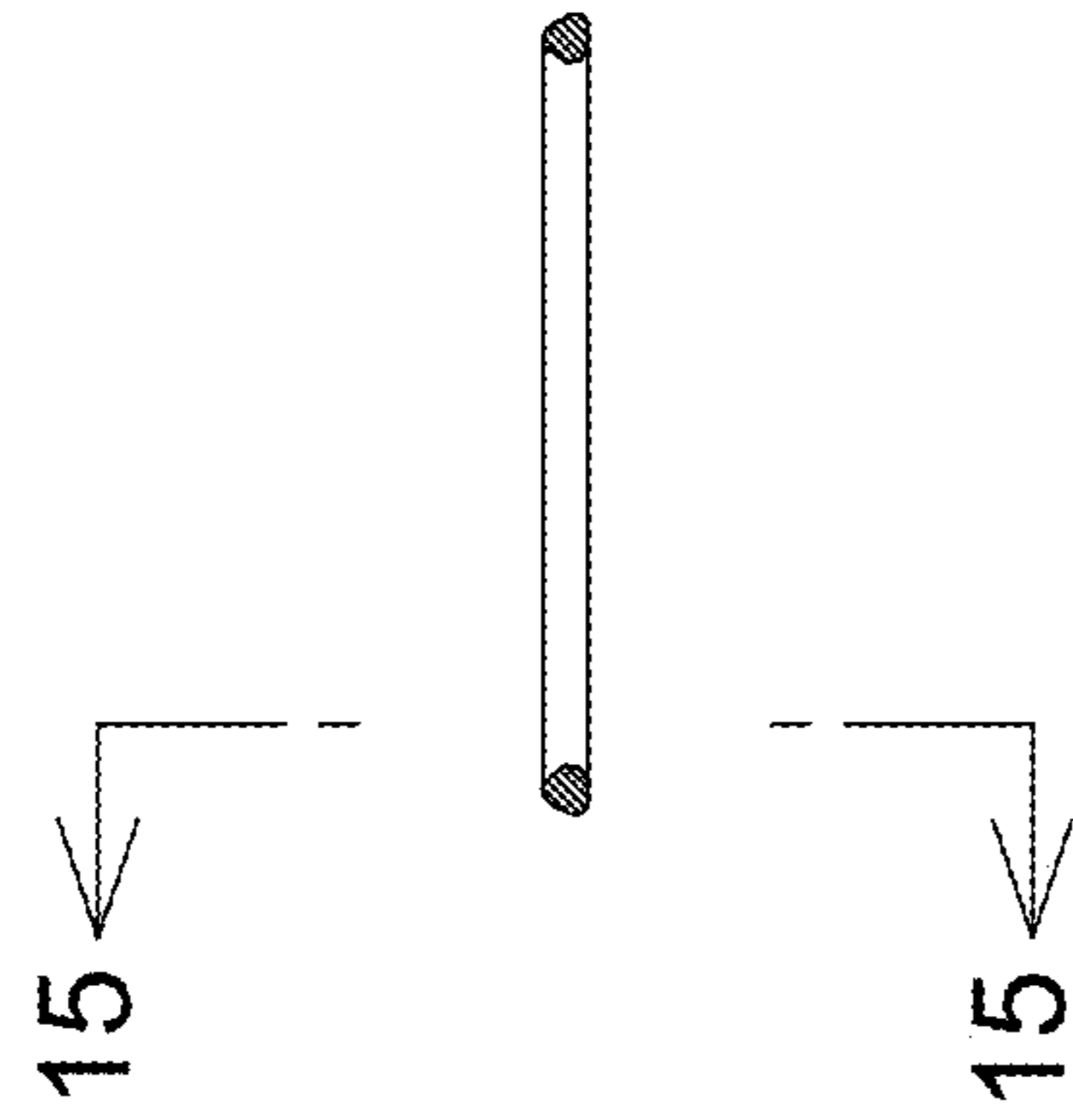

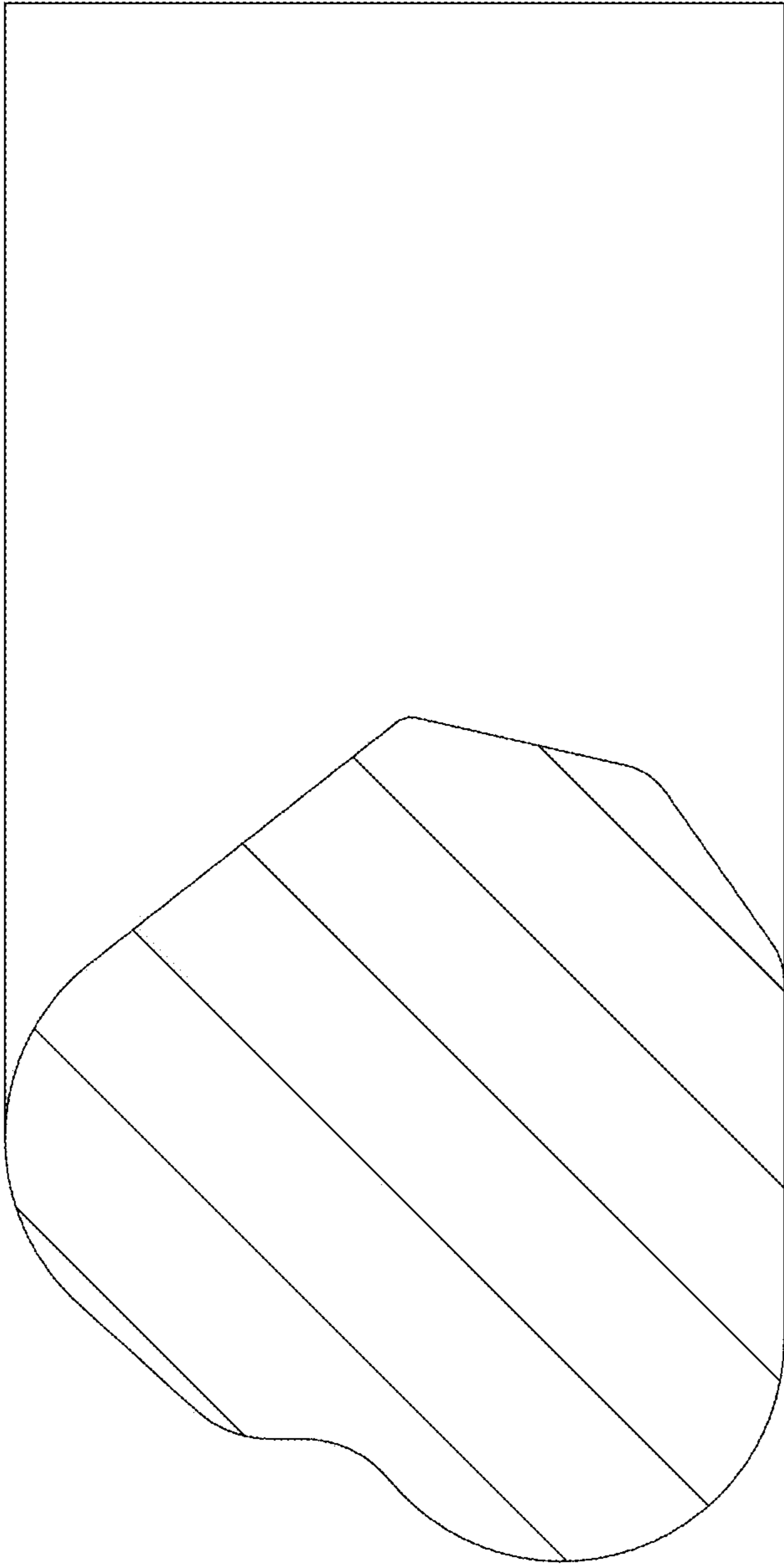

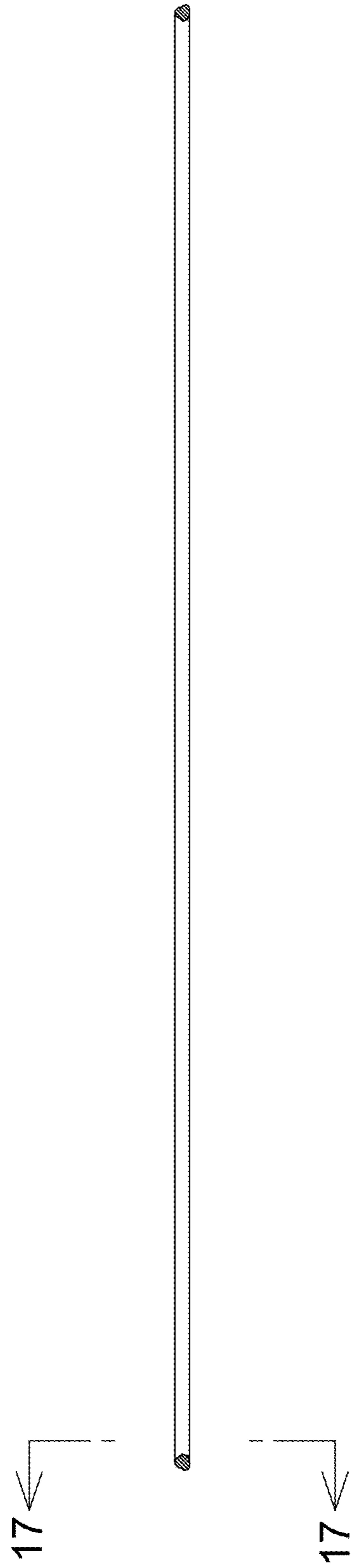

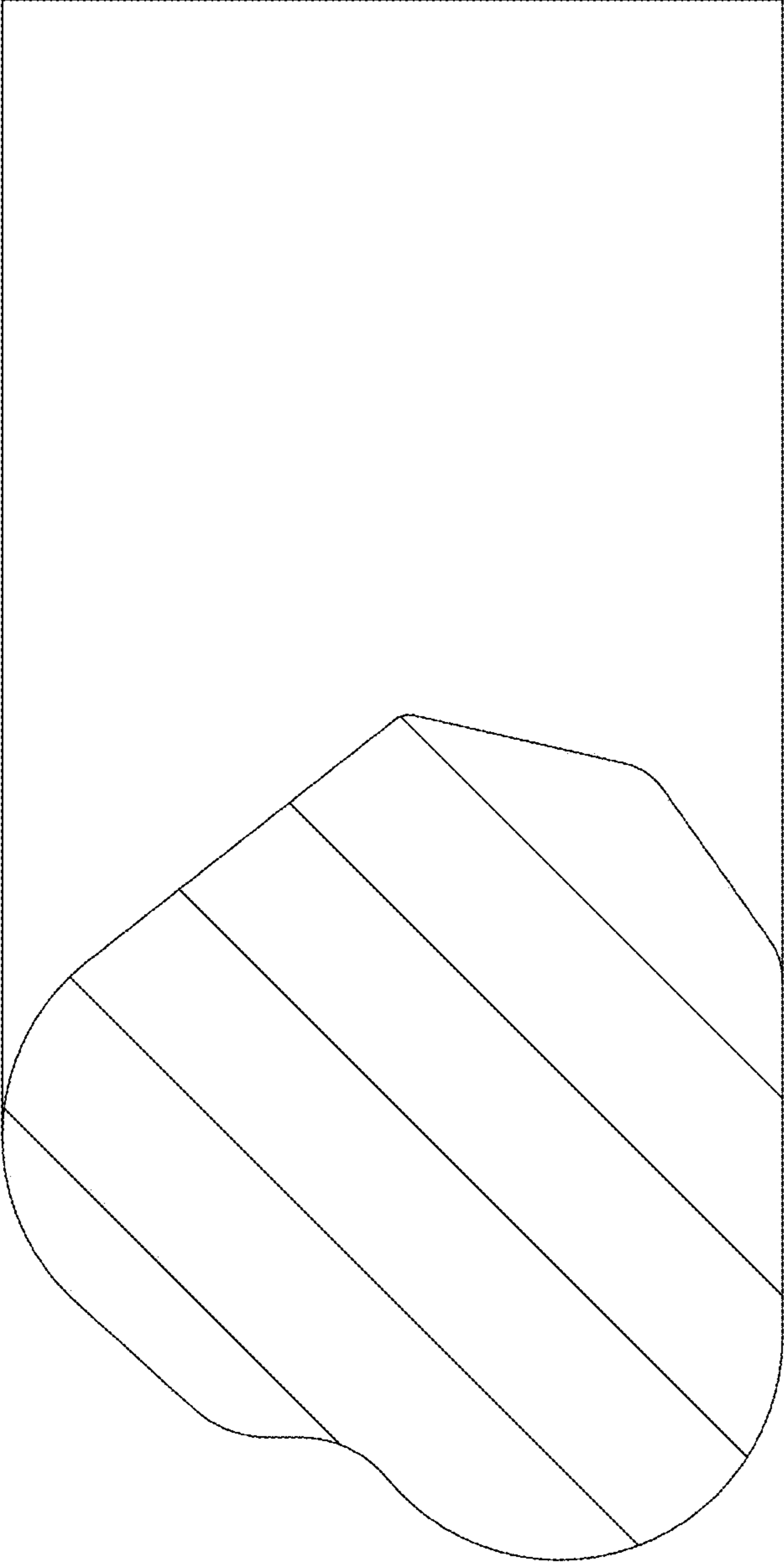

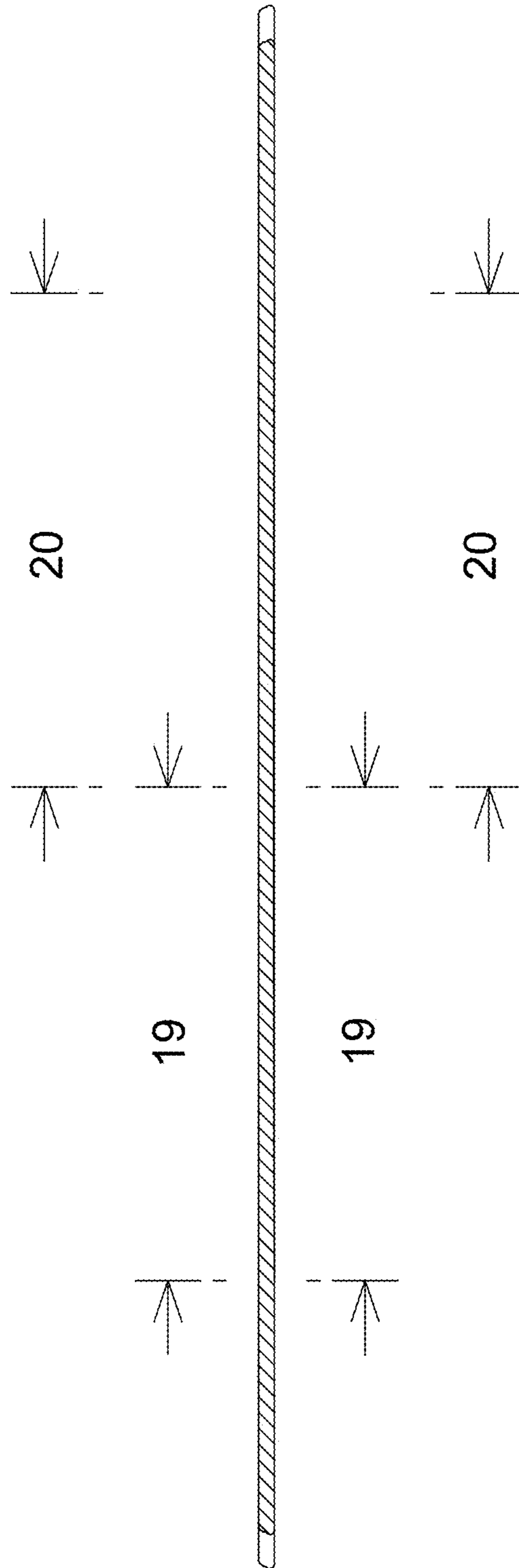

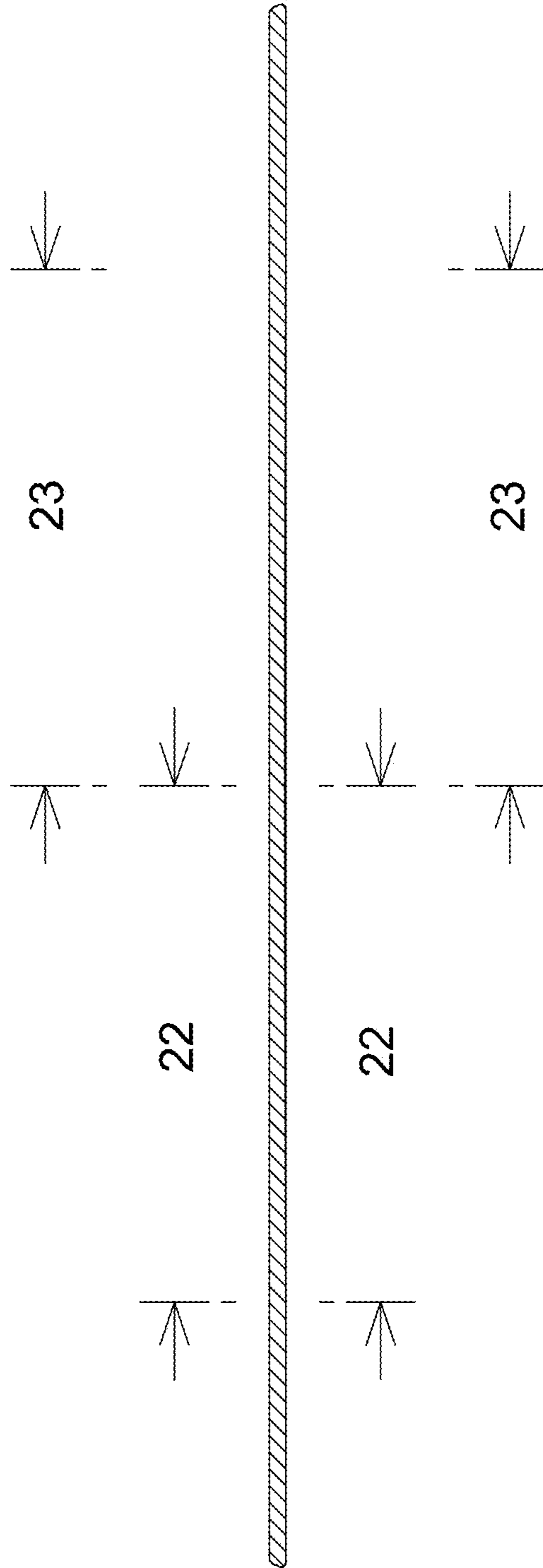
