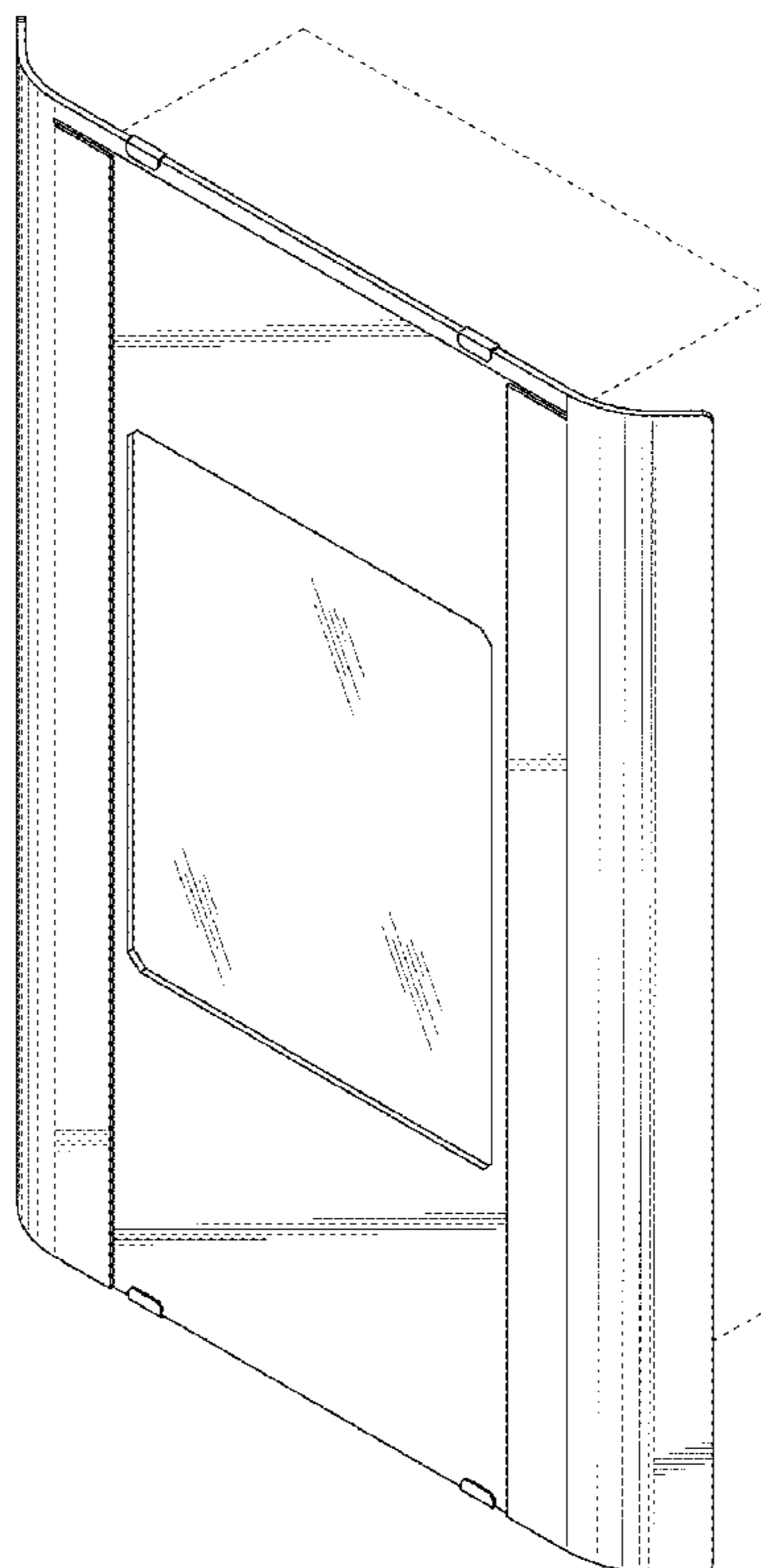
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front-perspective view of a fireplace embodying our new design;
FIG. 2 is a front-side view of the fireplace of FIG. 1;

FIG. 4 is a left-side view of the fireplace of FIG. 1;

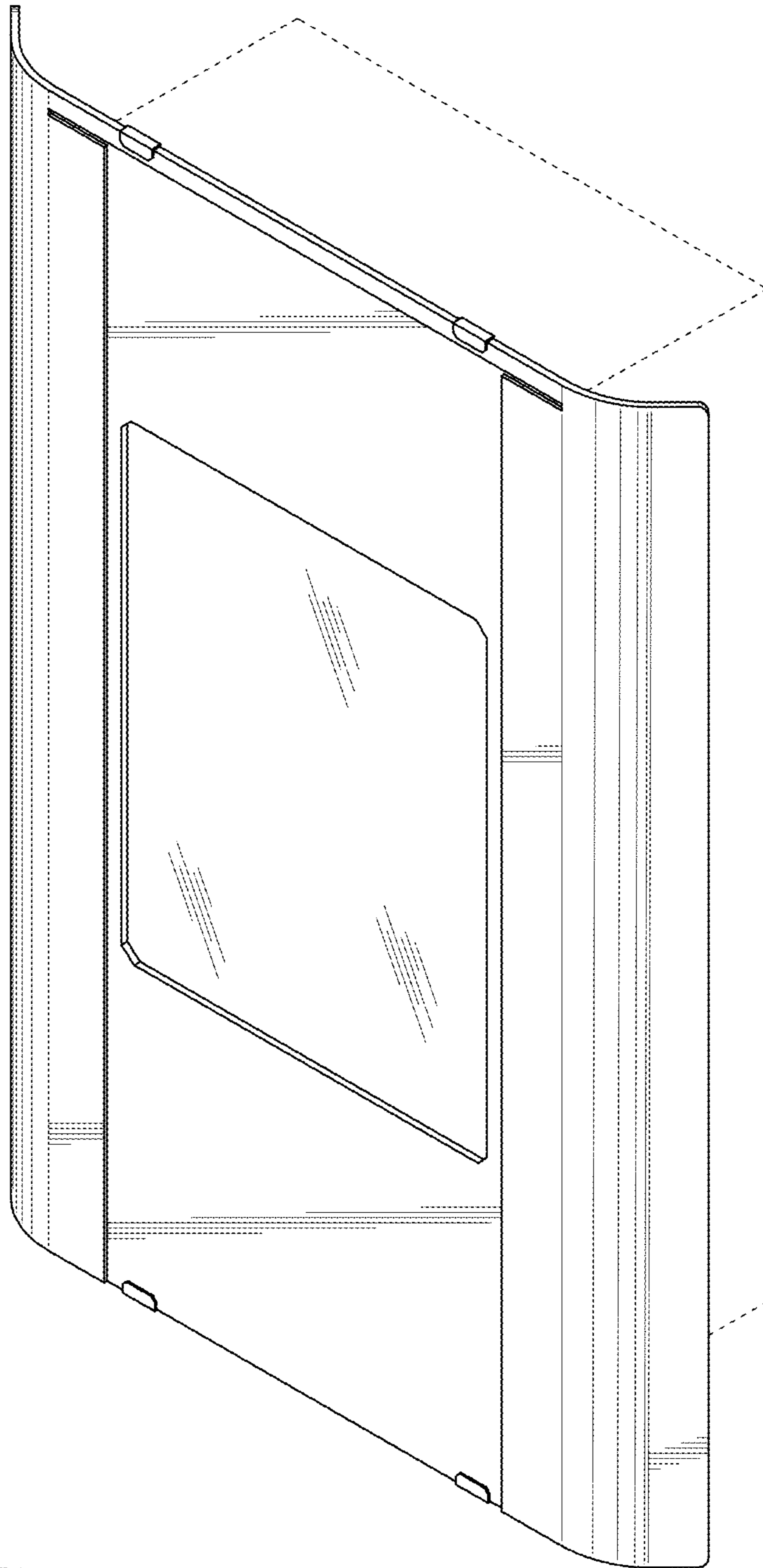

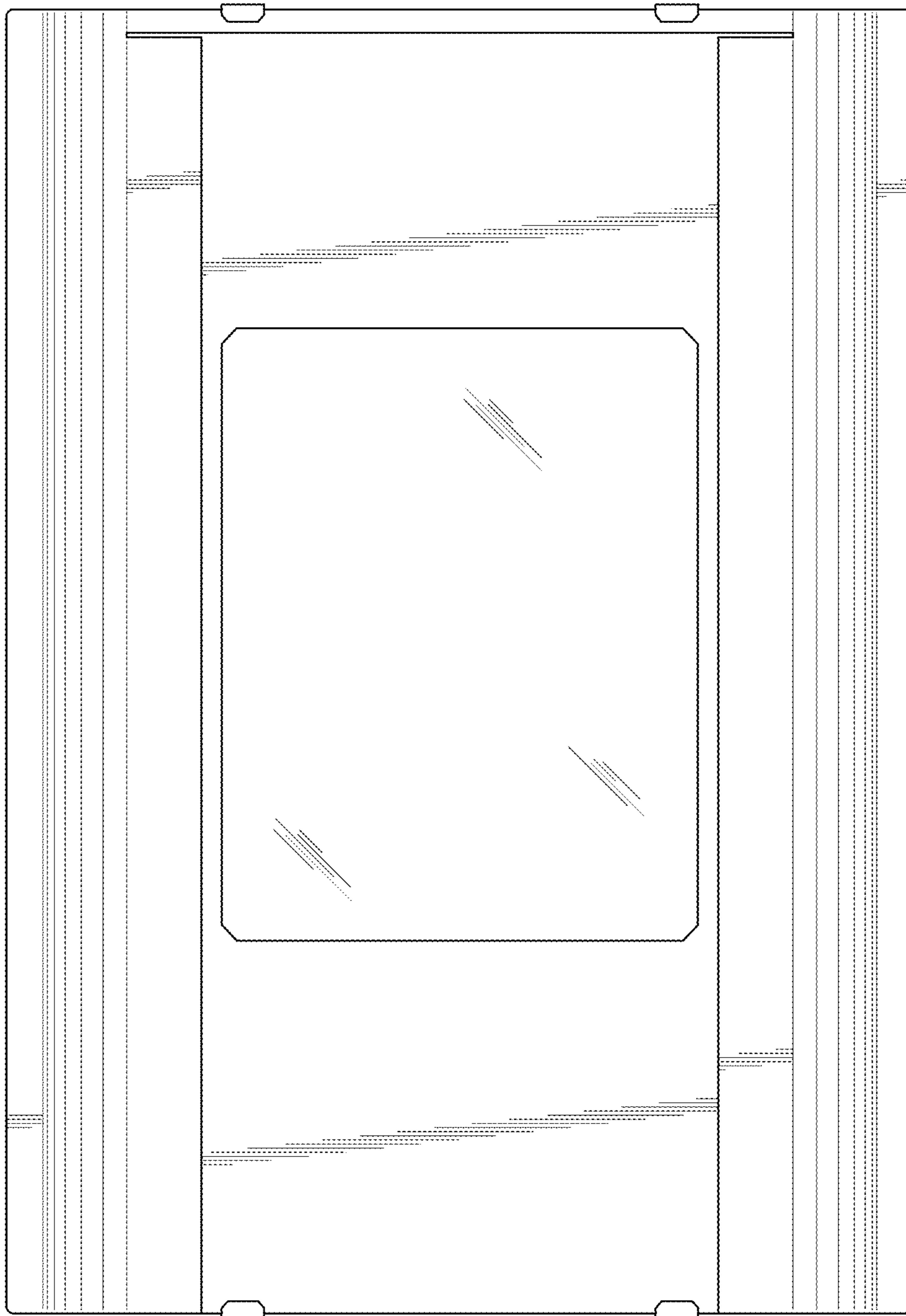

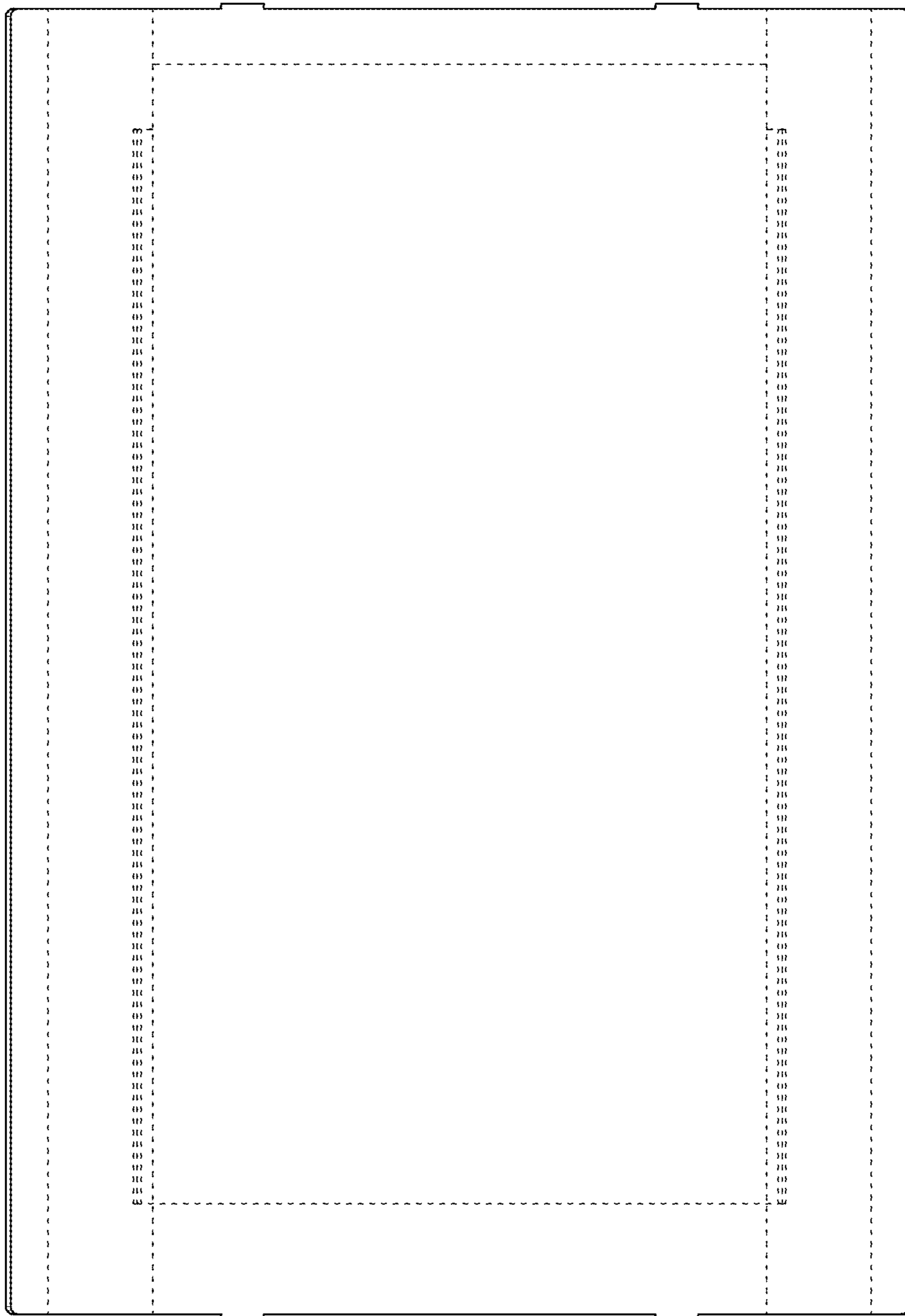

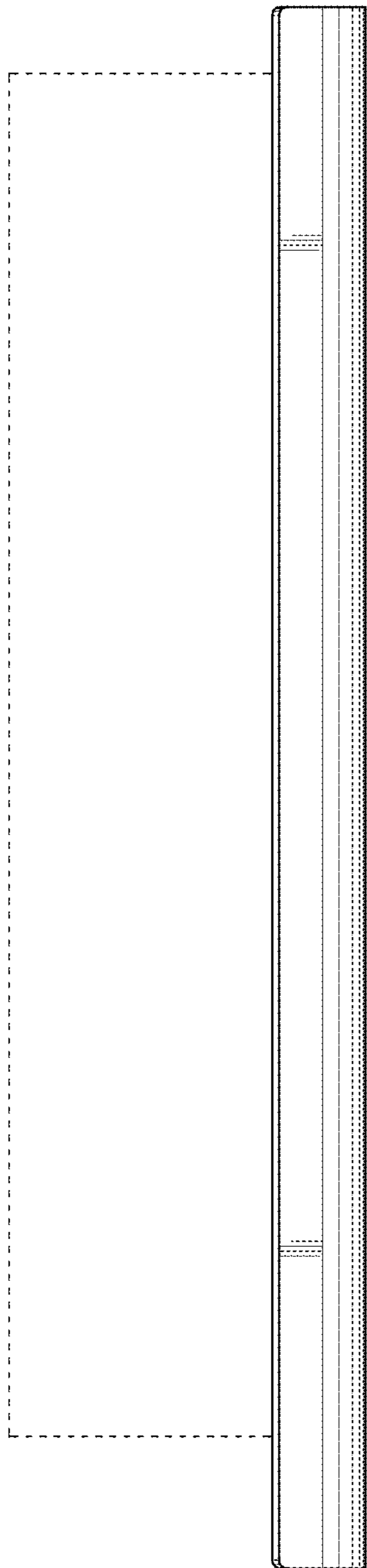

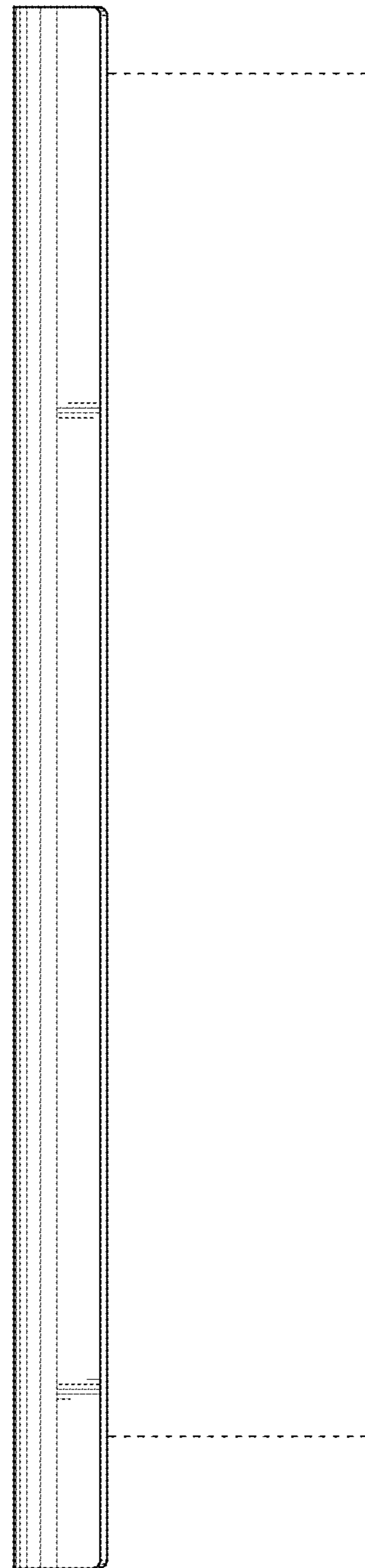

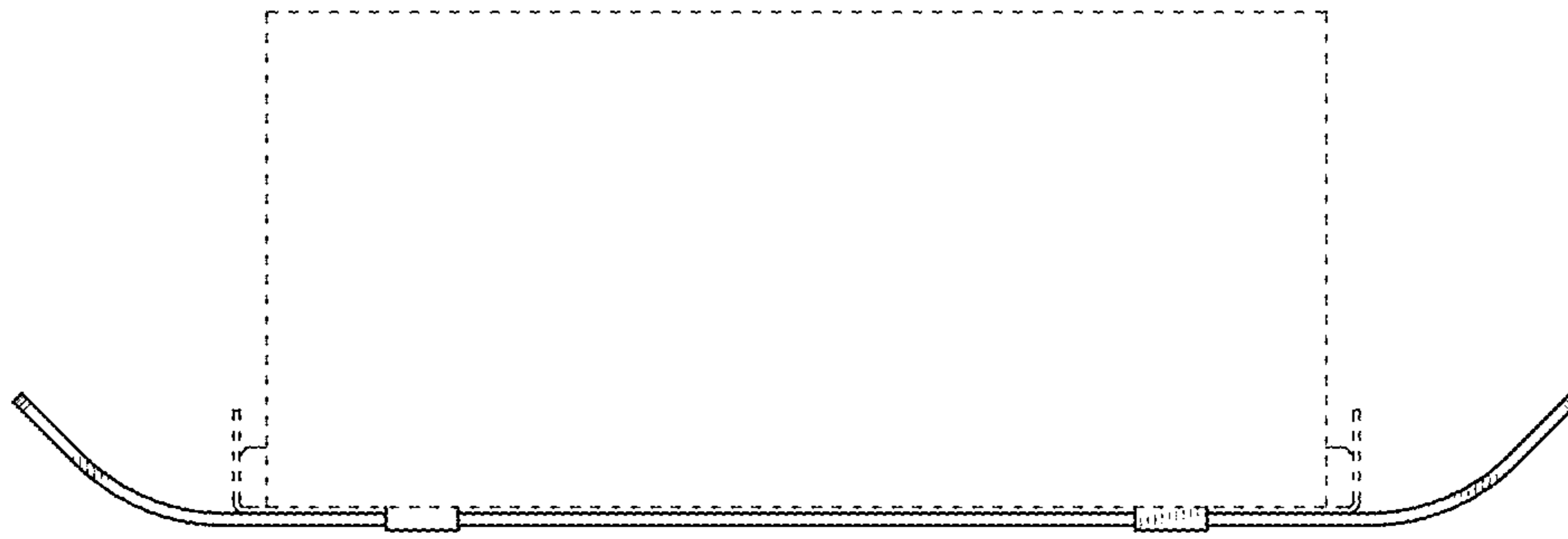

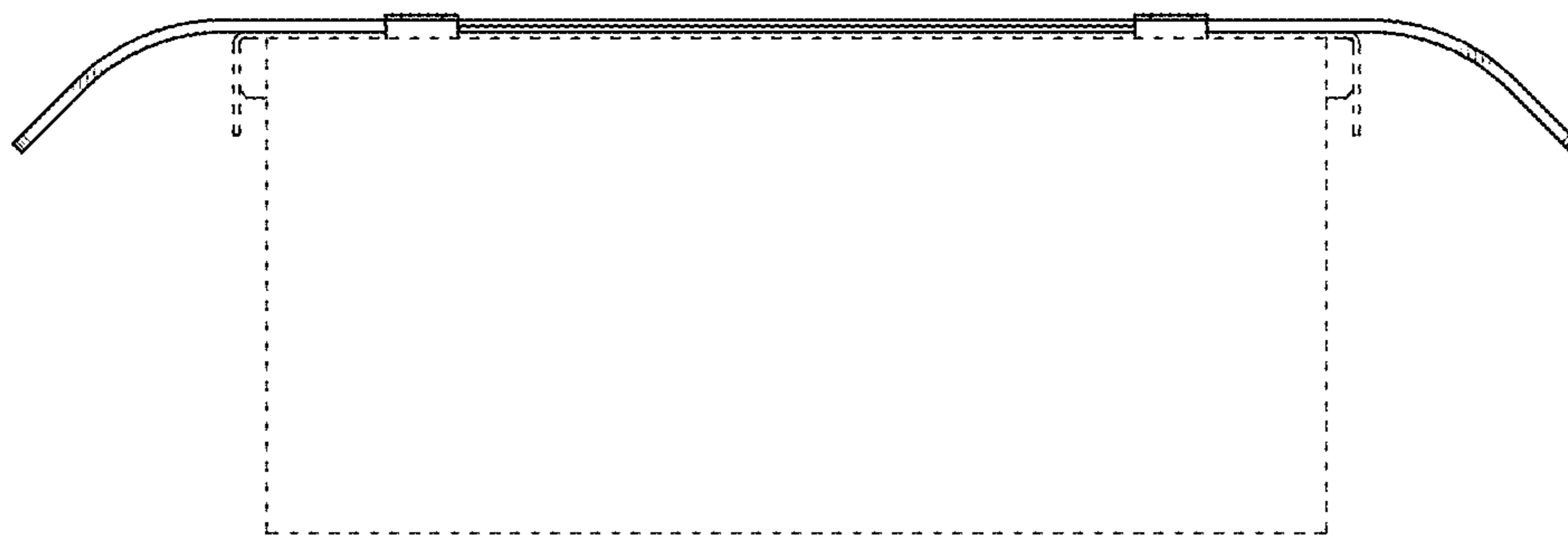
