FIG. 16 is a perspective view of the disposable underwear chassis folded showing a fourth embodiment of the new design.

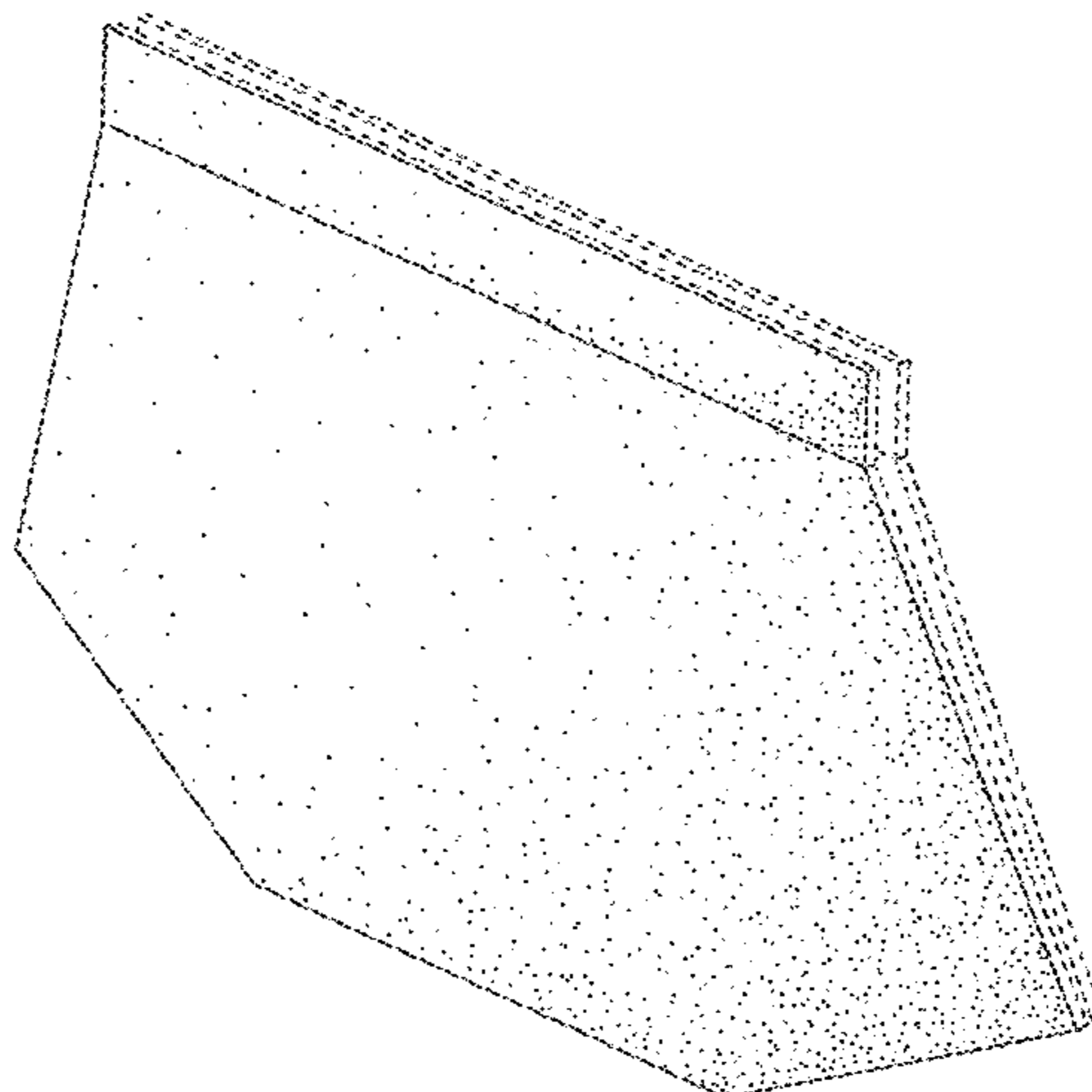
FIG. 17 is a front plan view of the disposable underwear chassis of FIG. 16.

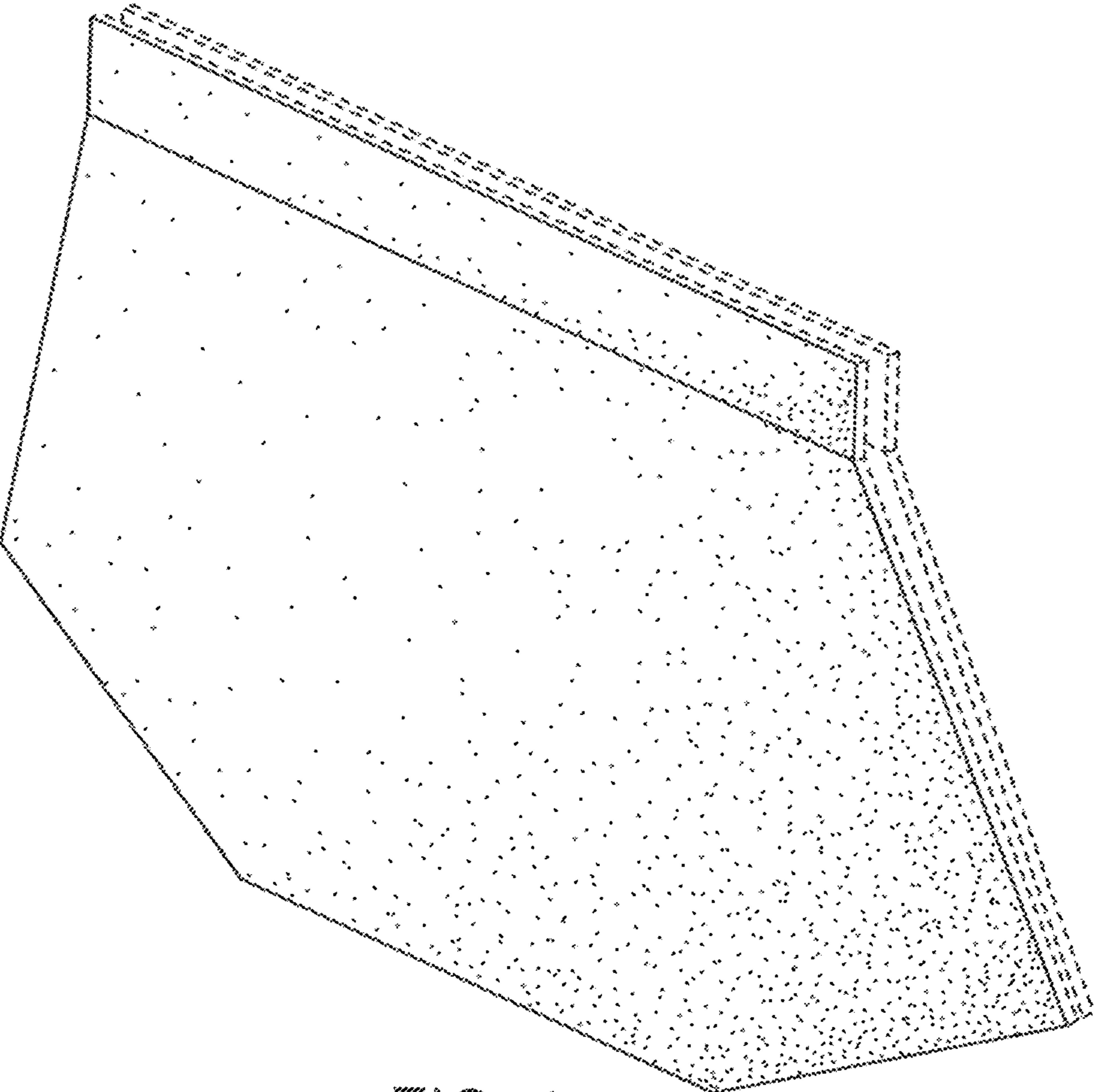

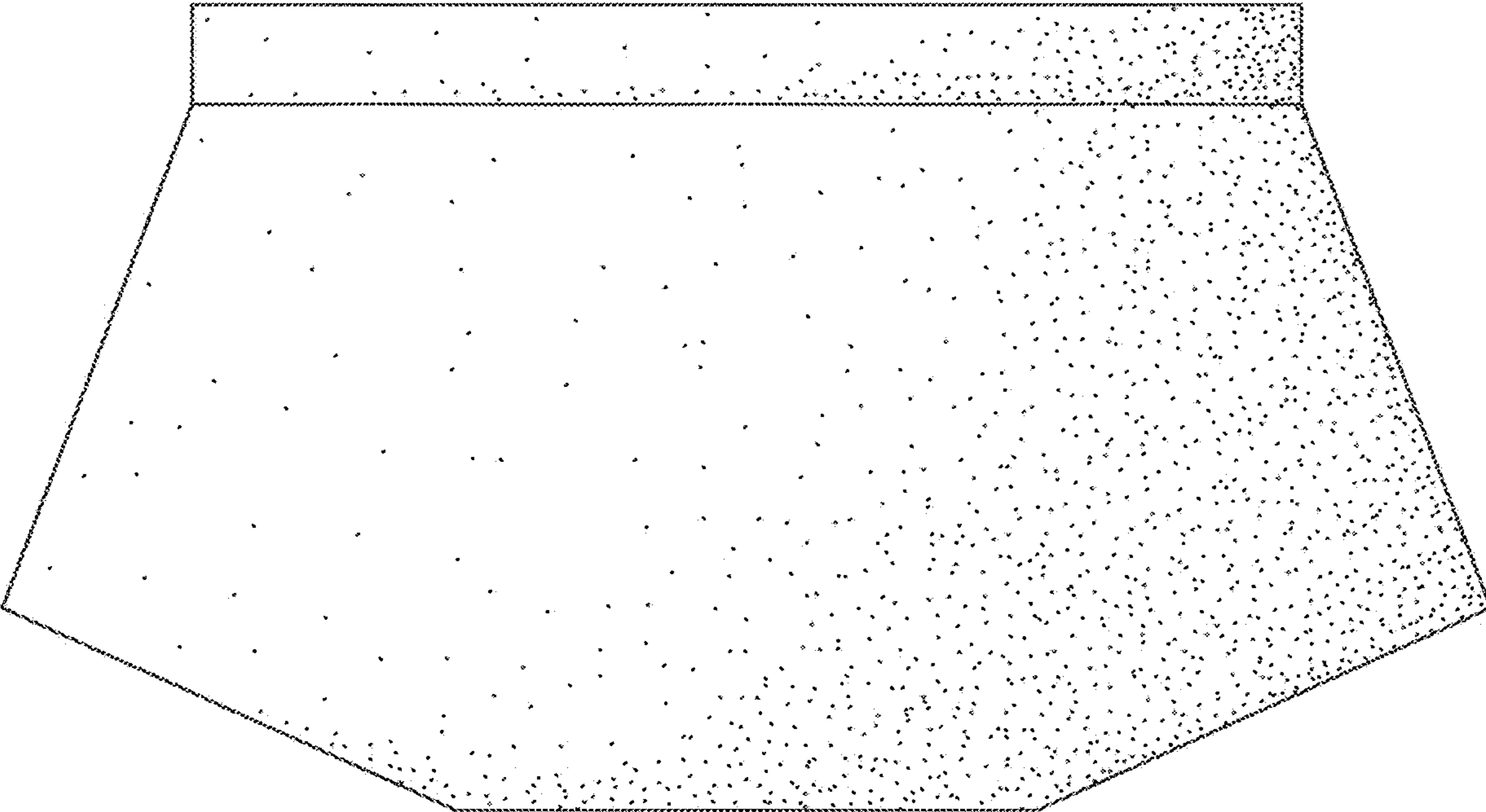

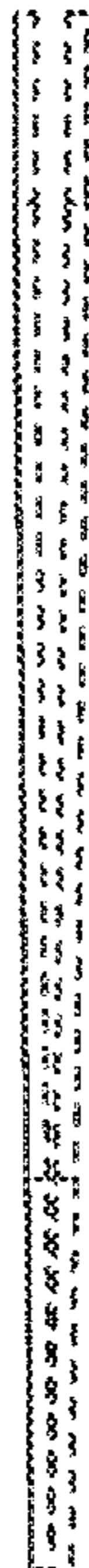

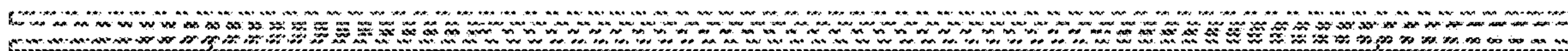

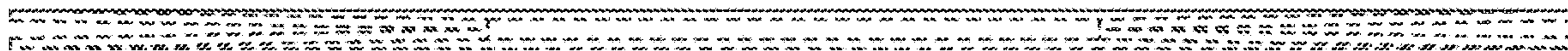

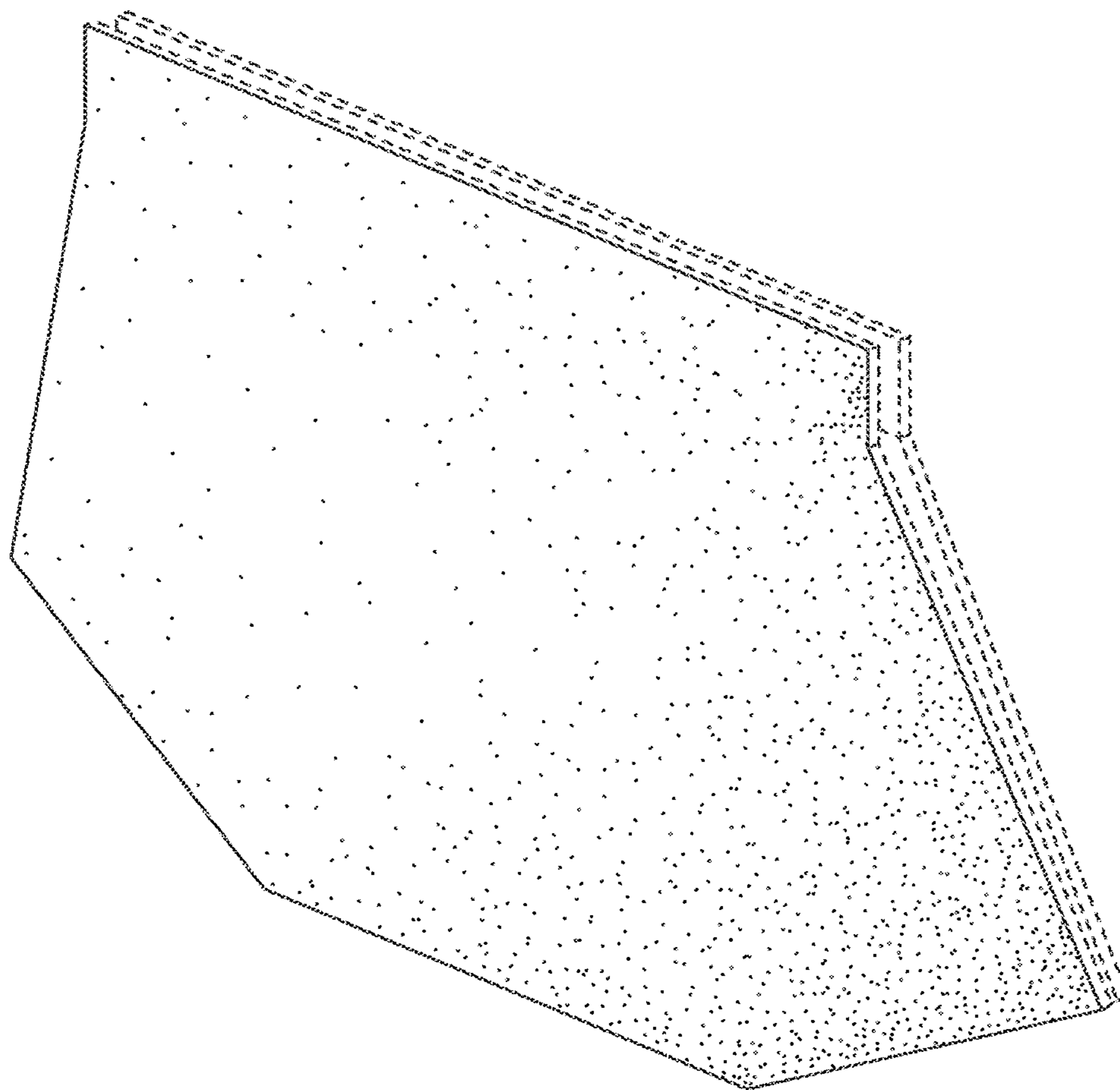

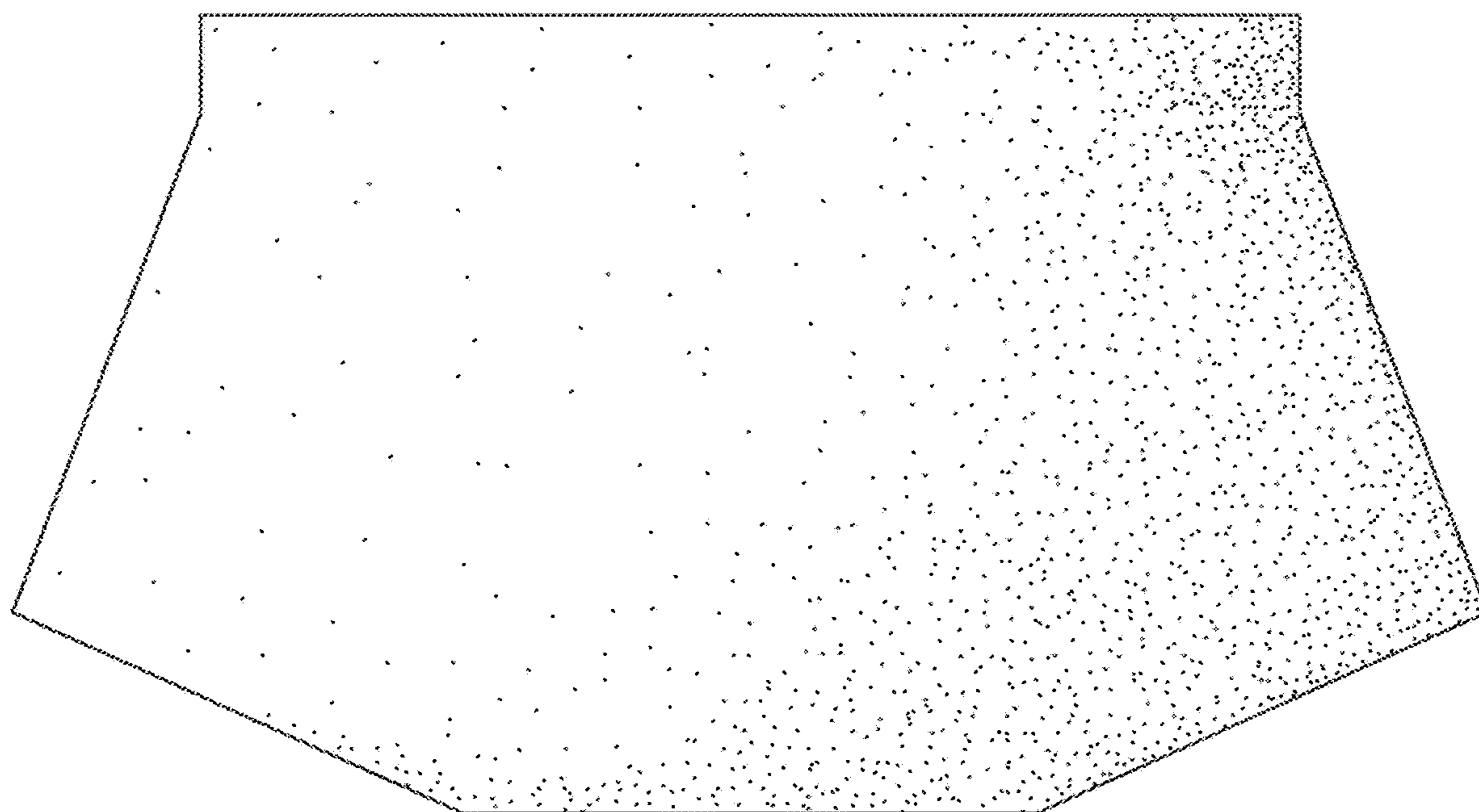

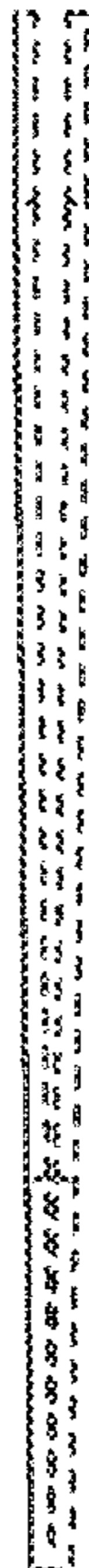

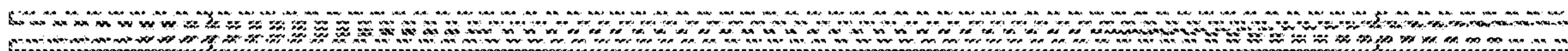

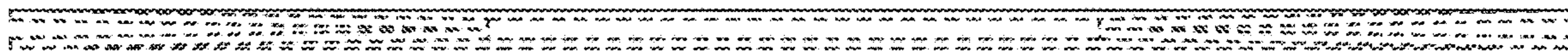

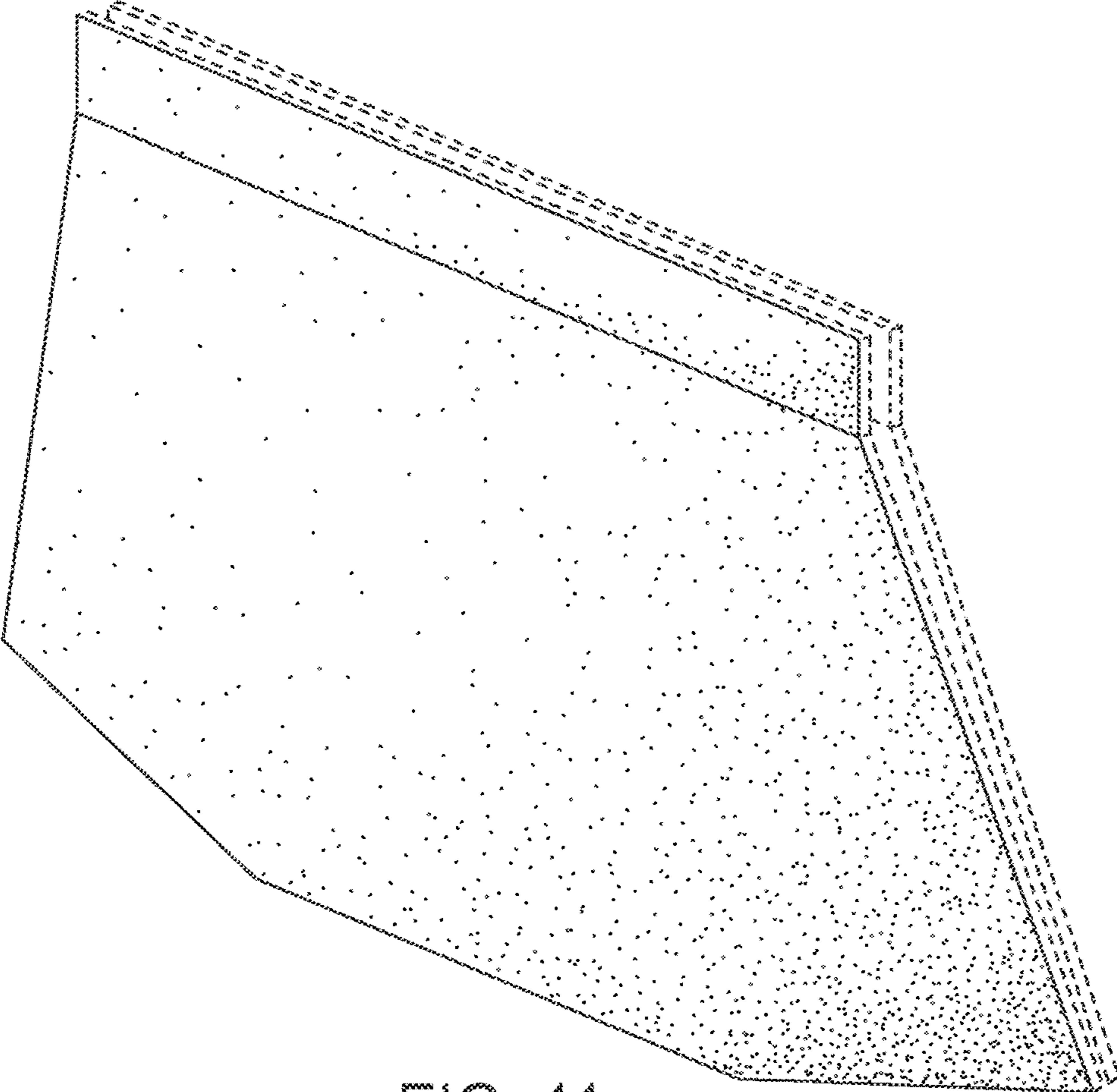

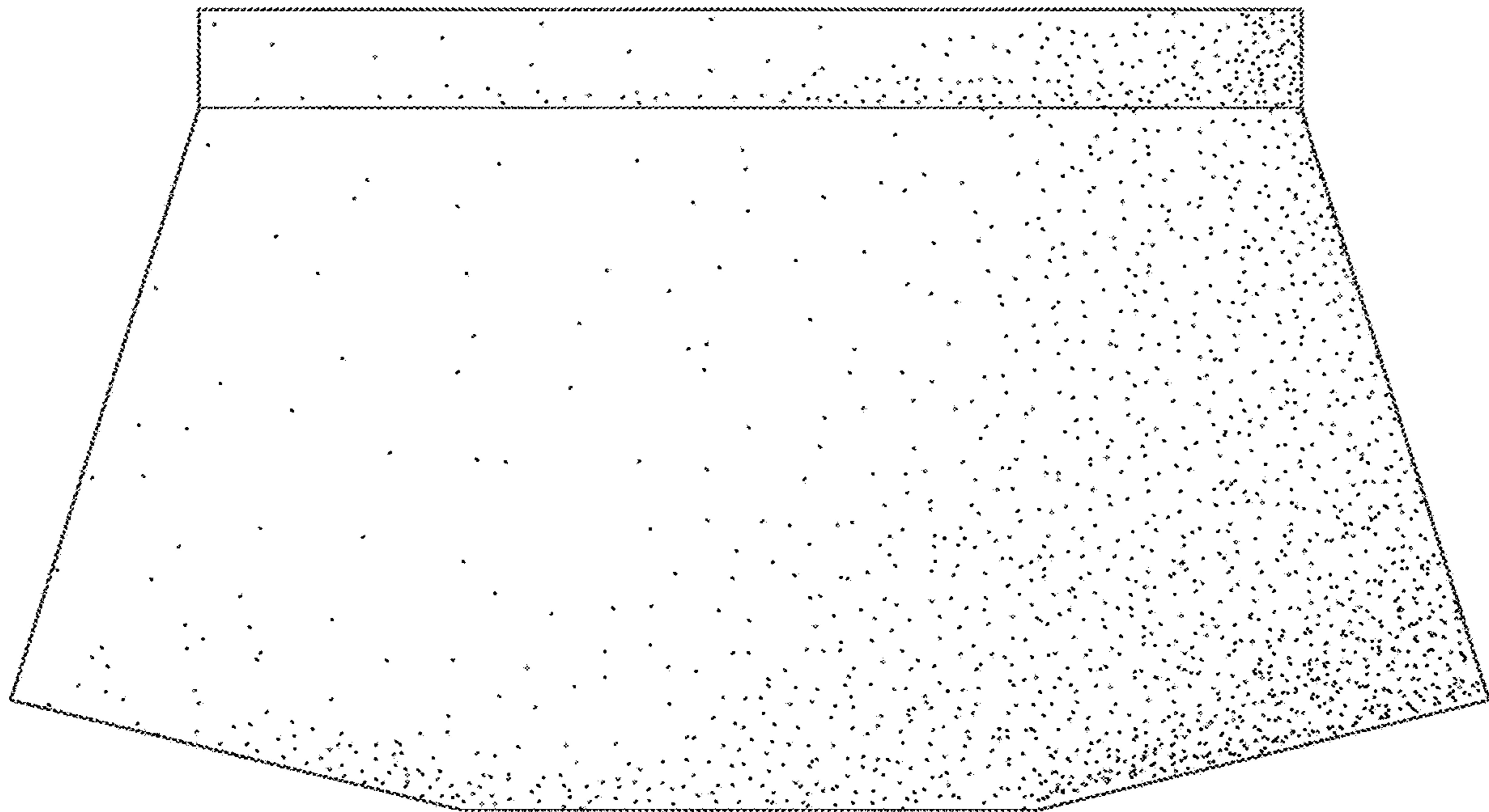

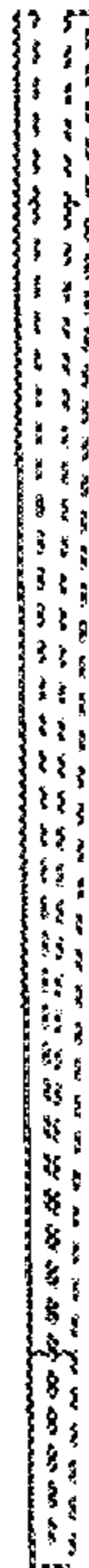

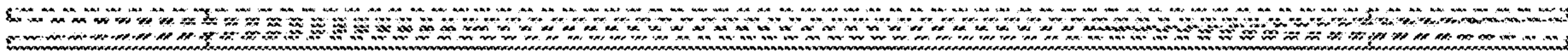

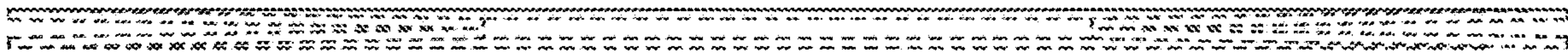

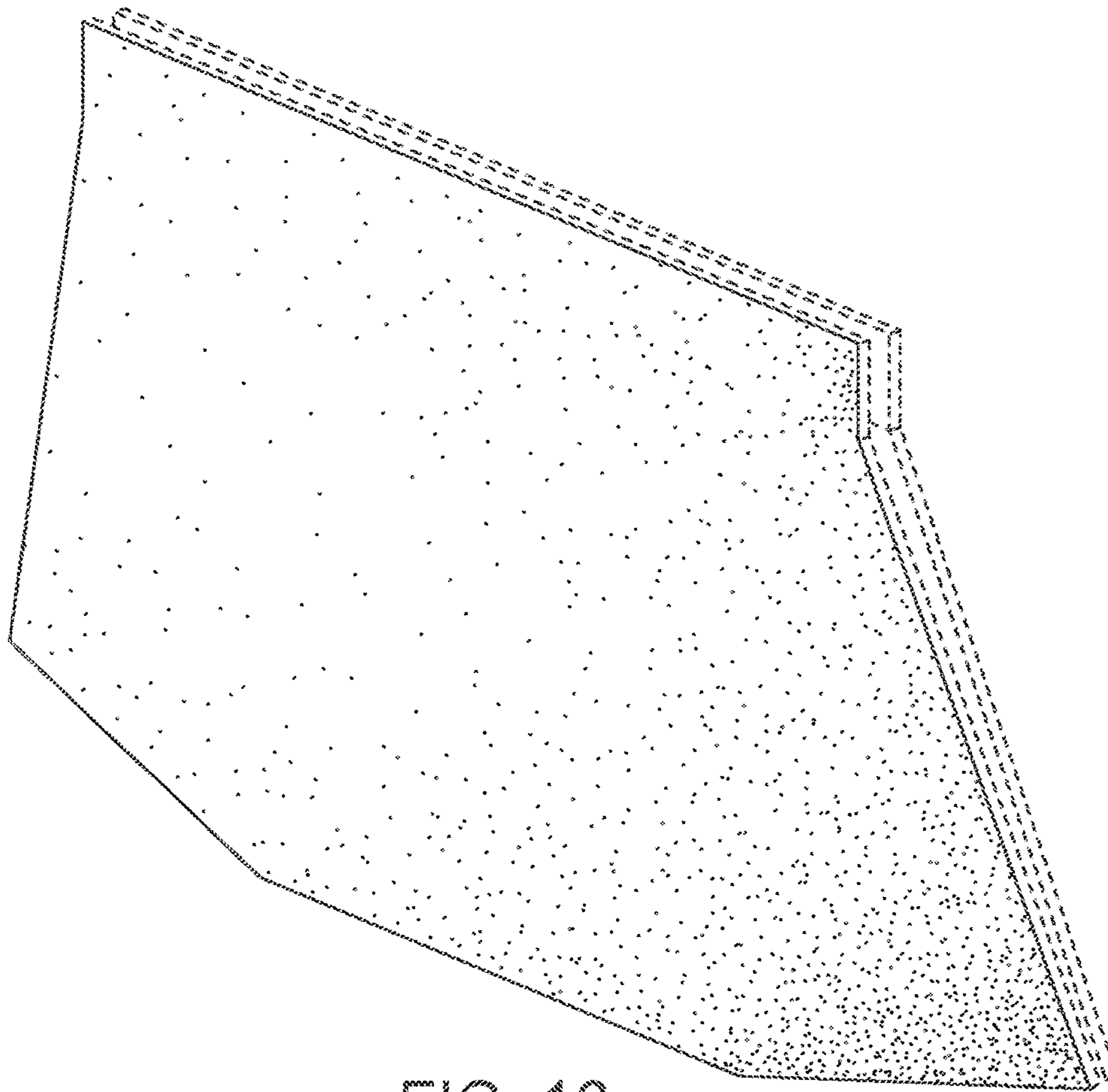

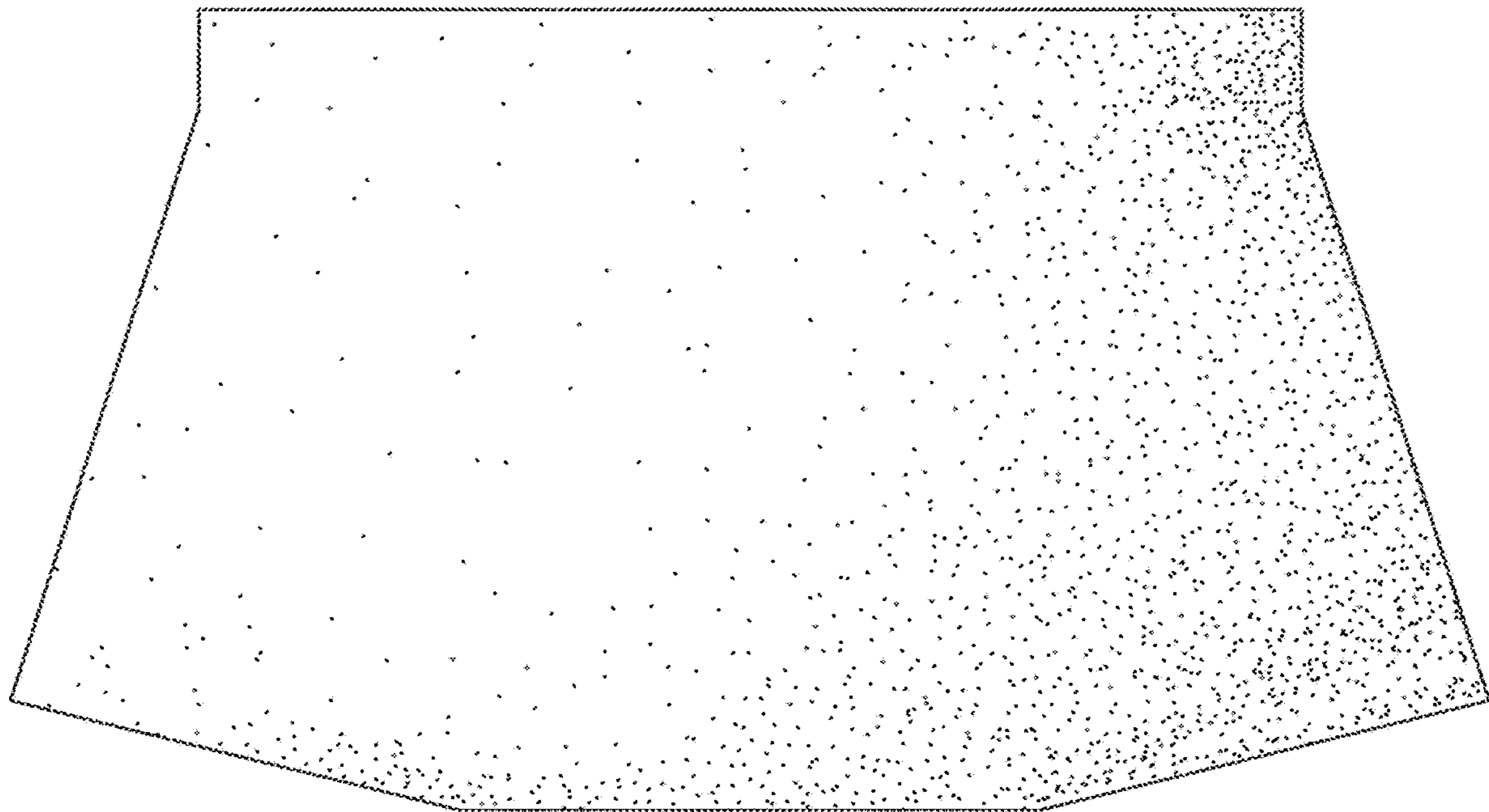

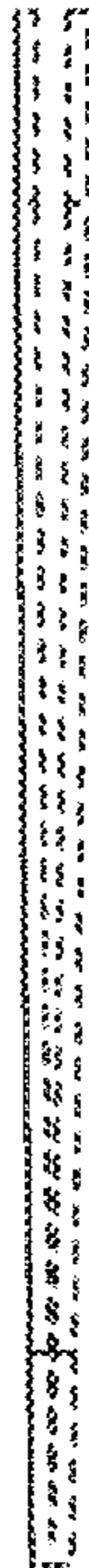

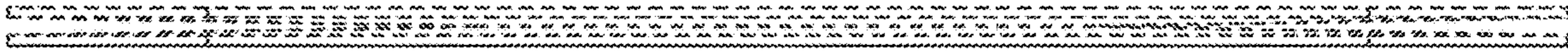

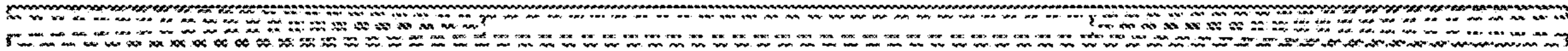
