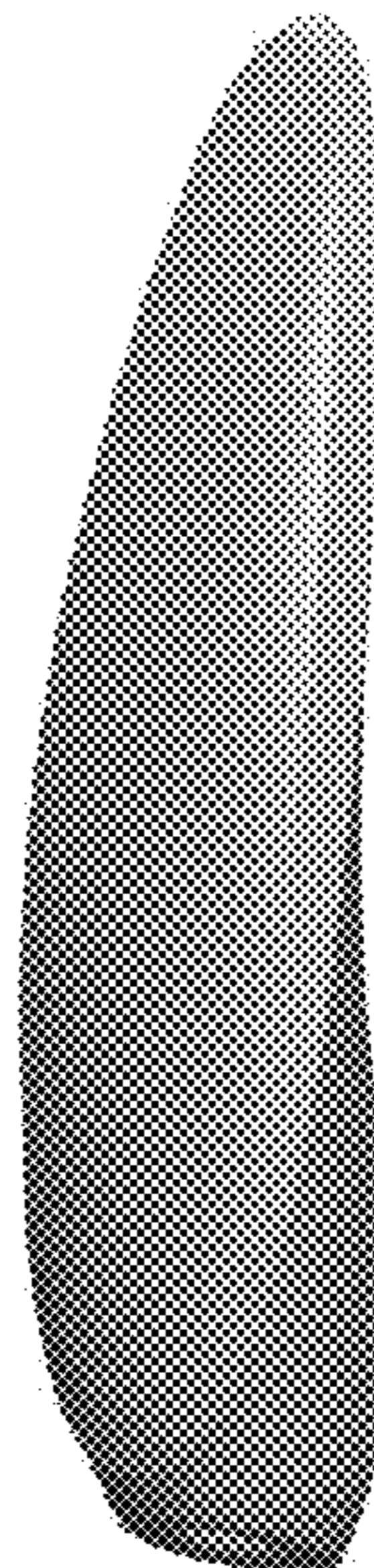
The ornamental design for sex toy, as shown and described.

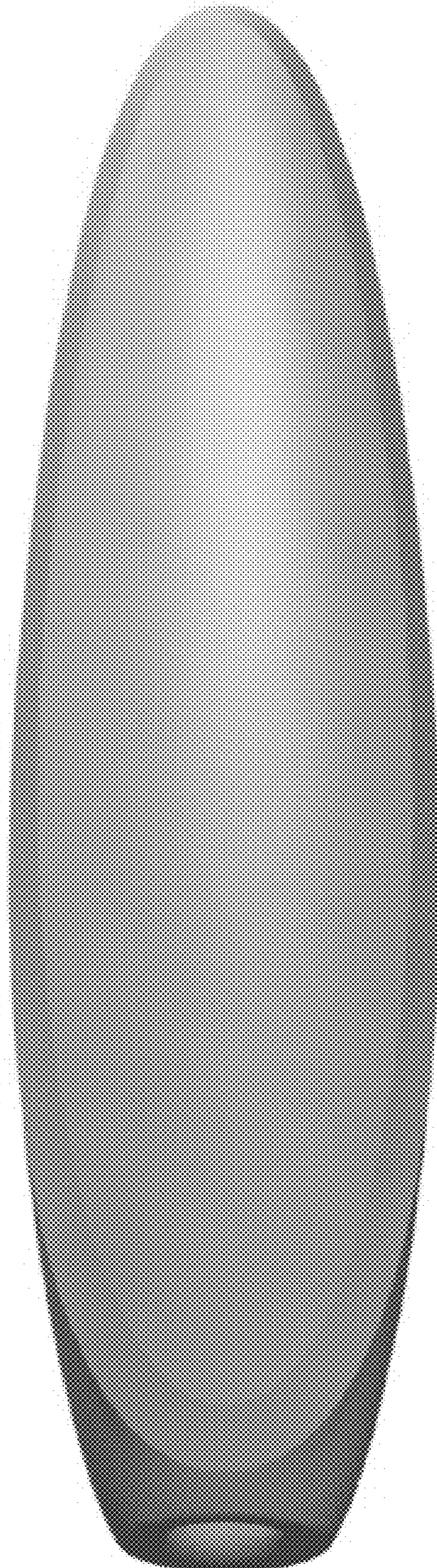

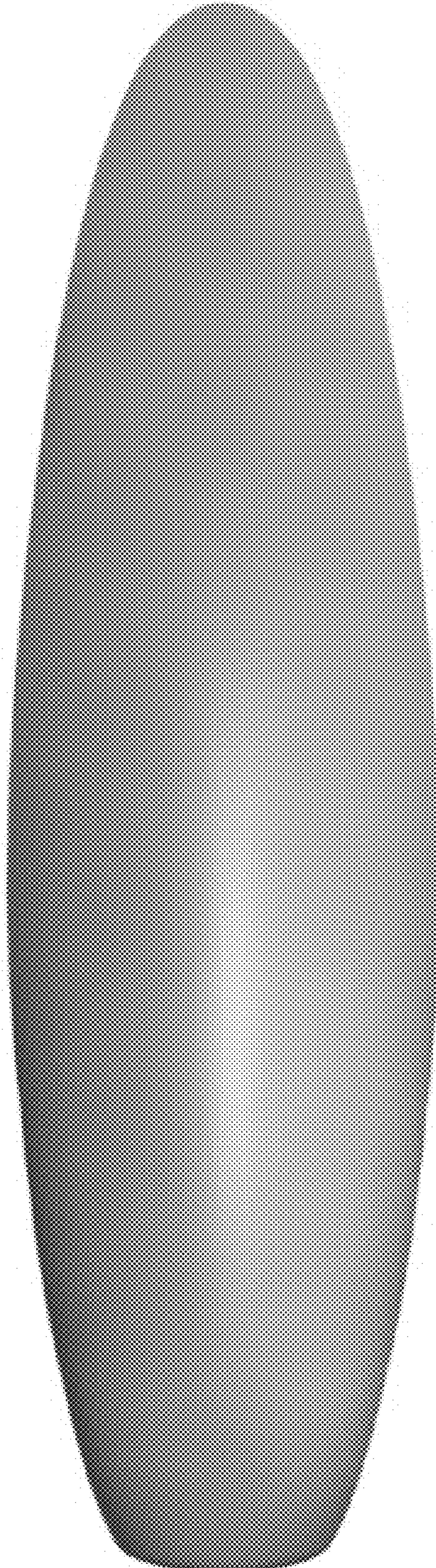

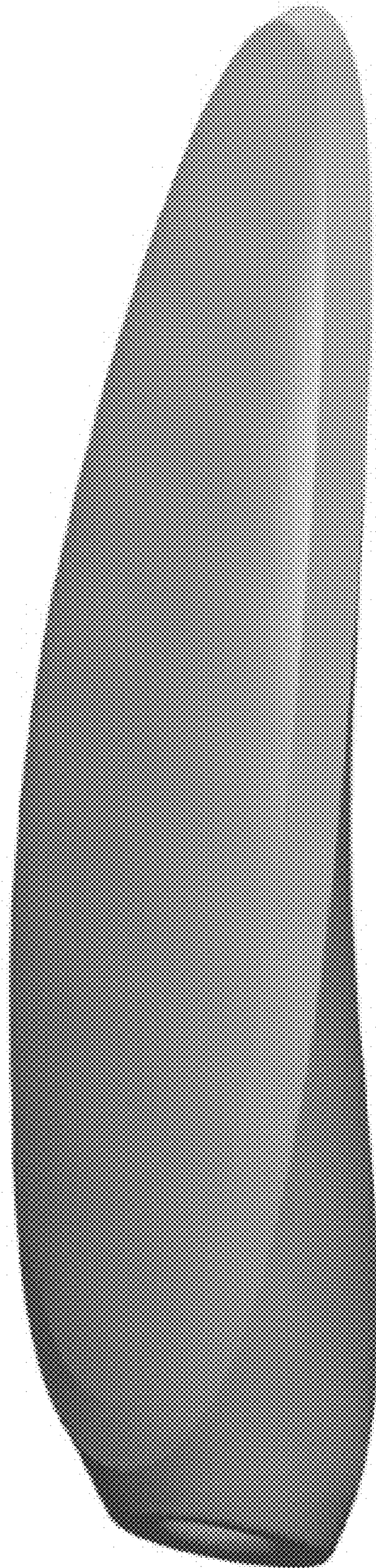

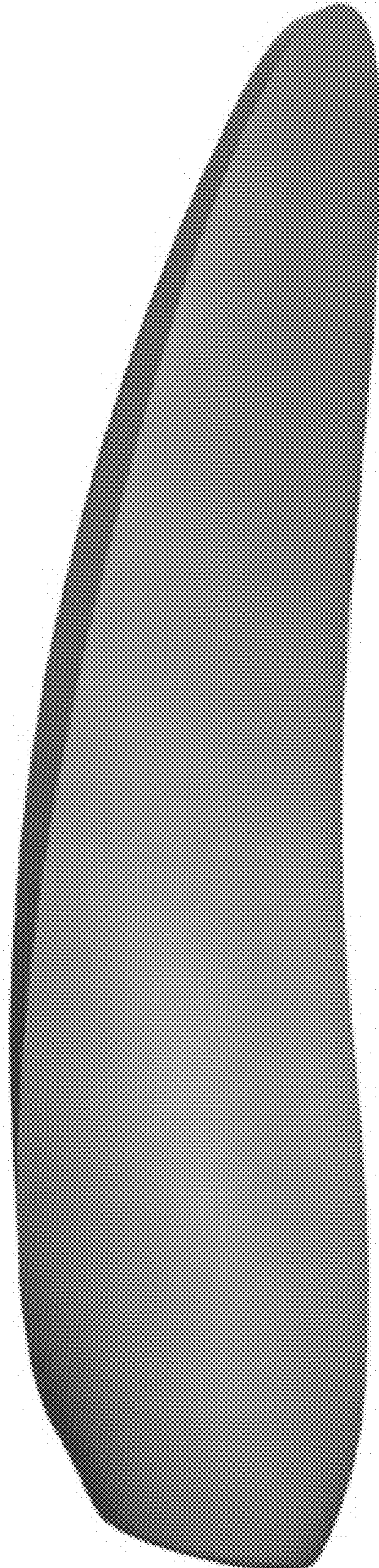

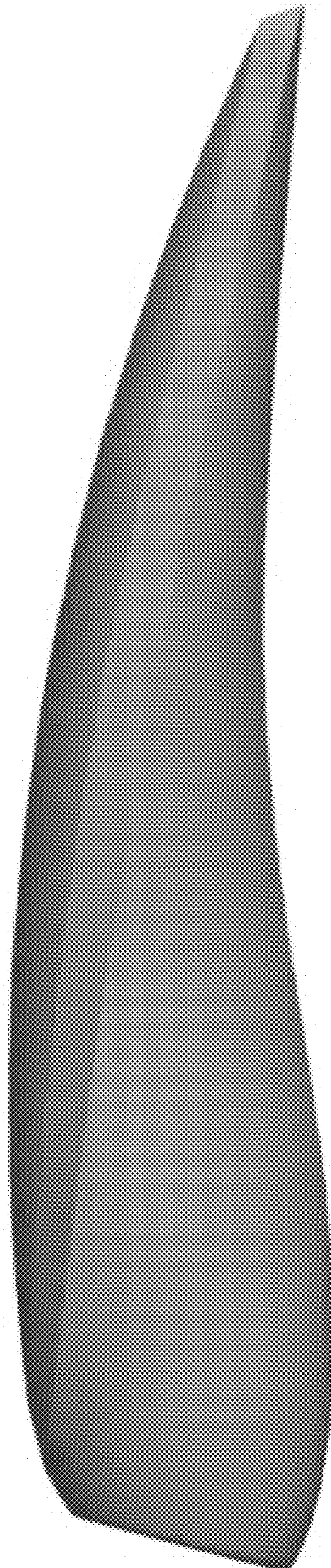
